

1           **Political Economy Analysis of Health Taxes (Tobacco, Alcohol Drink, and Sugar**  
2                           **Sweteened Beverage): Case Study of Three Provinces in Indonesia**

## 24 **Abstract**

25 Efforts to implement health tax policies to control the consumption of harmful commodities  
26 and enhance public health outcomes have garnered substantial recognition globally. However,  
27 their successful adoption remains a complex endeavour. This study takes a problem-driven  
28 political economy analysis (PEA) approach to investigate the challenges and opportunities  
29 surrounding health tax implementation, with a particular focus on sub-national government in  
30 Indonesia, where the decentralization context of health tax remains understudied. Employing a  
31 qualitative methodology by collecting data from a total of twelve focus group discussions  
32 (FGDs) conducted in three provinces—Lampung, Special Region of/*Daerah Istimewa* (DI)  
33 Yogyakarta, and Bali, each chosen to represent a specific commodity: tobacco, sugar-  
34 sweetened beverages (SSBs), and alcoholic beverages—we explore the multifaceted dynamics  
35 of health tax policies. These FGDs involved 117 participants, representing governmental  
36 institutions, non-governmental organizations (NGOs), and consumers. Our findings reveal that  
37 while health tax policies have the potential to contribute significantly to public health,  
38 challenges such as a lack of consumer awareness, bureaucratic complexities, and decentralized  
39 governance hinder implementation. Furthermore, this study underscores the importance of  
40 effective policy communication. It highlights the importance of earmarking health tax revenues  
41 for public health initiatives. It also reinforces the need to see health taxes as one intervention  
42 as part of a comprehensive public health approach including complementary non-fiscal  
43 measures like advertising restrictions and standardized packaging. Addressing these challenges  
44 is critical for realizing the full potential of health tax policies.

## 47 **Introduction**

48 The implementation of health taxes has been successfully adopted in numerous countries and  
49 is a pivotal policy instrument to control the consumption of harmful commodities and improve  
50 public health outcomes(1-5). This approach has been endorsed as one of the "best buys" by the  
51 World Health Organization (WHO) for addressing Non-Communicable Diseases (NCDs) (6-  
52 9). Despite its importance, many countries, particularly low- and middle-income economies,  
53 still struggle to adopt this policy(10). For this reason, global health leaders recently called  
54 attention to the urgent need for research that sheds light on the politics of health tax policy  
55 processes(11).

56 The political economy of a health system shapes policy development and implementation in  
57 important ways(12). Conflicts of interests, poor interagency and multisectoral coordination, as  
58 well as excessive bureaucracy were among the most common challenges to fully  
59 institutionalizing evidence-informed health taxes policy recommendations(13-15). Public  
60 sector decentralization may hinder the health policy adoption due to challenges including  
61 limited shared understanding of health tax objectives among local authorities, political  
62 complexities, and financing issues at the sub-national level, resulting in suboptimal  
63 implementation (14, 16). Indonesia, as one of the largest countries with escalating concerns in  
64 the healthcare sector, primarily due to rising the NCDs epidemic(17-19). The country faces  
65 challenges in health policy adoption, primarily attributed to political contestation, industry  
66 interference, and a rigid bureaucratic system, exacerbated by decentralization(20-23).

## 67 **The current status of health tax implementation in Indonesia**

68 Indonesia has been decentralizing since 2001—nearly 56 years after its independence(24). One  
69 crucial aspect of decentralization is public finance, encompassing various fiscal policy  
70 authorities, such as revenue generation, earmarking, and spending mandates, which has

71 recently undergone reforms through Law No. 1/2022 (25, 26). Regarding health tax policy,  
72 both tobacco and alcoholic beverage taxes have been designed to involve sub-national  
73 governments(27, 28). Specifically for the tobacco tax collected through the Ministry of  
74 Finance, i.e., excise tax, the national government also enacted legislation to establish a tobacco-  
75 tax sharing fund (*Dana Bagi Hasil Cukai Hasil Tembakau/DBHCHT*), with the purpose of  
76 allocation to sub-national leaders based on their levels of tobacco farming production(29).

77 Table provides a summary of the division of roles between the national and sub-national  
78 governments in Indonesia. There are many types of taxes for commodities that fall under  
79 ‘unhealthy’ products category(30): (i) Excise Tax, regulated under Law No. 39/2007, in  
80 conjunction with Law No. 7/2021; (ii) Local Tax, which currently exclusively applies to  
81 tobacco products (as part of other five categories outlined in Law No. 28/2009, which have  
82 been subsequently replaced by Law No. 1/2022); and (iii) Value-Added Tax. In Indonesian  
83 case, health tax is more in line with excise tax, as one of its primary objectives is consumption  
84 control—rather than solely revenue generation.

85 Currently, only two commodities are subject to health tax: tobacco and alcoholic beverages.  
86 Although sugar-sweetened beverages (SSBs) were proposed in 2019, these have not yet been  
87 implemented(31). The national government primarily focuses on tax collection, while the sub-  
88 national government plays a critical role in tax management and allocation. Additionally,  
89 regulations mandate that sub-national governments allocate health taxes for the healthcare  
90 sector, encompassing both promotive and preventive measures(20, 32).

93 With the current practice of health taxation, criticisms have emerged. The health tax initiative  
94 relies heavily on the national government with the Ministry of Finance (MoF) and Ministry of  
95 Health (MoH) as policy champions(23). The reliance on the national government may be  
96 exacerbated by a limited understanding of the objectives of health taxation and complicated  
97 politics implement, particularly among sub-national governments (22, 33). The current practice  
98 prioritizes revenue generation over consumption control, especially for sub-national leaders  
99 who aim to protect revenues (20). Finally, decentralization continues to face several issues,  
100 with one of the most significant being financing despite regulations mandating health tax  
101 allocation for this sector(18, 34, 35). The financing issues include budget insufficiency and  
102 sub-optimal public insurance coverage due to disparities in revenue generation across  
103 region(35).

104 While decentralization becomes central to policy implementation, understanding the sub-  
105 national government behaviour in response to health tax remains important, yet understudied.  
106 This study fills this gap by exploring the political economy of health tax policy implementation  
107 at sub-national level. We selected three provinces to represent three different taxable  
108 commodities: tobacco, alcoholic beverages, and SSBs. The rationale for choosing these diverse  
109 commodities as the focus of the study is to investigate the political economy in light of their  
110 distinct attributes and characteristics. Furthermore, our focus is exclusively on the sub-national  
111 level, as there is an abundance of evidence regarding the political economy of health taxation  
112 in Indonesia at the national level (20, 21, 23, 36-39). The next section will describe the  
113 methodology and analytical approach used in this study, followed by results, and finally  
114 discussion and future recommendation.

## 115 **Material and methods**

### 116 **Study design and case selection**

117 This study is qualitative. We used an extensive case study approach as the information to be  
118 gathered requires in-depth insights and is highly contextual(40). A case study is also more  
119 suitable to answer the “why” and “how” questions which make them more explanatory and  
120 descriptive(41), aligning it with the objectives of this research.

121 The sub-national context is documented at the provincial level, which represents the highest  
122 tier of local government. We choose the provincial level government because it plays an  
123 important role in communicating the central government health policy while simultaneously  
124 hold a discretion over districts’ budgeting process(42). Each province was selected based on  
125 their level of consumption for each commodity (see Appendix S1). Lampung, Special Region  
126 of/Daerah Istimewa (DI) Yogyakarta, and Bali, were chosen for tobacco, SSBs, and alcoholic  
127 beverages, respectively.

## 128 Analytical approach and stakeholders' identification

129 We used a problem-driven Political Economic Analysis (PEA) adapted from Overseas  
130 Development Institute (ODI) framework(14, 15, 43) to guide our analysis. This framework  
131 offers flexibility in analyzing specific policies across a wide spectrum of issues(44, 45). Figure  
132 1 below illustrates our adoption of the problem-driven PEA framework modified from Carriedo  
133 et al., 2021 (15). We adopted the framework by repeatedly aligning it with our problem  
134 statement and findings. We identified the current policy circumstances as a challenge for the  
135 health tax implementation at sub-national level in Indonesia. The structural issues include the  
136 social context and institutional arrangements, while agency issues encompass stakeholders and  
137 incentives. In our analysis of both structural and agency issues, we concentrated on  
138 organizations and institutions, including their roles, relationships, and interactions in the  
139 implementation of health taxation policies at the sub-national government level. Ultimately,  
140 through this analysis, we identified opportunities and barriers and proposed policy actions to  
141 be taken.

144 We identified three relevant categories of participants. The first category is governmental  
145 institutions, which have in-depth information about governmental progress and cross-sectoral  
146 coordination and relationships. For each province, we recruited local government's officer who  
147 are in charge of: (i) public finance; (ii) public health; (iii) human capital development; and (iv)  
148 development planning.

149 The second group comprises non-governmental organizations (NGOs) or experts. The  
150 information gained from these groups can serve as a counterbalance to the governmental  
151 institutions. For each province, the NGOs/experts recruited were from: (i) public health or  
152 economic experts from public/private higher education institution; (ii) local public health or  
153 economic NGOs; and (iii) local faith- or religious-based organizations.

154 Finally, the third group consists of consumers to better understand the social context and  
155 confirm the local government's effort in increasing consumer awareness. Exploring  
156 consumers' opinions also helped us gain more information from their perspective. The  
157 eligibility criteria for consumers to participate were those above the age of consent (18 years  
158 old) who regularly consume the researched commodity. Institutional stakeholders were  
159 recruited through close invitations, while individual (consumer) participants were recruited  
160 through open online invitations.

## 161 **Data collection**

162 Semi-structured (see Appendix S2 for guiding questions) focus group discussions (FGD) were  
163 our primary source of data. This was selected based on our desire to explore a range of views,  
164 while observing the social interaction between participants(46). We conducted four separate  
165 FGDs in each province for each category of participants (see Table 1). Specifically for

166 consumers, we organized FGDs for those aged 30 and above separately from those aged 18 to  
167 30 to understand different behaviour among different age groups. In total, we conducted twelve  
168 FGDs between July and September 2022. Each FGD lasted approximately 120 minutes,  
169 accommodated a maximum of 15 participants, and arranged in a U-Shaped room setting. To  
170 ensure that participants understood the study's context, each FGD began with a presentation by  
171 the researcher. All FGD activities were audio recorded and complemented with researchers'  
172 notes. We reached data saturation at the last FGD and no additional data were collected.

## 175 **Ethical consideration**

176 This study received approval from the Ethical Review Board of Universitas Katolik Indonesia  
177 Atmajaya (Approval No. 00061/III/PPPE.PM.10.05/07/2022) and adhered to the Declaration  
178 of Helsinki(47). Prior to their participation, all individuals signed an informed consent, with  
179 the understanding that any subsequent publications arising from the study would not contain  
180 personal identifiers. To ensure the preservation of confidentiality, throughout this manuscript,  
181 participants are denoted by assigned pseudonyms.

## 182 **Data analysis**

183 We employed framework analysis(48, 49) using the transcribed verbatim from all the audio  
184 records of the FGD. We constructed a matrix to display the participants' arguments against the  
185 PEA framework, from which we derived keywords to align with the themes and sub-themes  
186 outlined in the PEA for each commodity category (see Appendix S3), adopted from Rodríguez  
187 et al., 2023 (14). A cross-member checking was performed to ensure rigorous data analysis  
188 process. The matrix for each commodity was independently developed by at least two  
189 researchers (e.g., KPR, YBAP and AE for alcoholic beverages; NHW, AE, and N Adhani for  
190 tobacco; and N Amalia, NHW, EVA, and MGU for SSBs) based on the verbatim transcript.  
191 The matrix appropriateness for each theme, sub-theme, and categories was iteratively reviewed  
192 by all team members. Regular research meetings were attended by all researchers to critically  
193 assess our findings before reporting the results. Disagreements among members were  
194 discussed, resolved, and managed accordingly.

## 195 **Results**

196 We utilized the PEA framework to structure our findings into three key sections. Firstly, we  
197 provide an analysis of the context surrounding the health tax policy in each province. This  
198 analysis encompasses both structural and agency-related factors. Secondly, we explore and  
199 elucidate the barriers and challenges that are anticipated in the implementation of the policy.  
200 Lastly, we present the recommendations proposed by stakeholders to tackle these identified  
201 issues. In the results section, we compare the characteristics attributed to each commodity,  
202 highlighting how these differences shape the circumstances of each province's case.

### 203 **Structural diagnosis**

204 Structural diagnosis concerns the structural factors that shapes the stakeholders' behaviour(45).  
205 We identified two sub-themes under the domain of the structural diagnosis in our PEA, i.e.,  
206 social context and institutional arrangement.

## 207 **Social context**

208 The social context defines the factors that shape health systems. In our case selection, where  
209 we have chosen cases based on the highest consumption levels for each commodity, this is  
210 closely linked to the underlying factors contributing to high consumption in each province, to  
211 gain a deeper understanding of the necessary policy interventions. Our qualitative analysis,  
212 conducted across three provinces, has identified three recurring keywords or categories. Firstly,  
213 cultural factors emerged as a significant determinant. Our focus group discussions with  
214 consumers and NGOs/experts revealed that high consumption rates are predominantly  
215 influenced by cultural factors, in addition to price-related factors, which underscore the need  
216 for reinforcing health taxes. Remarkably, this pattern holds true across all provinces, despite  
217 variations in the specific commodity category. For example, in Lampung, tobacco consumption  
218 is deeply ingrained in local traditions:

219 *“Tobacco is a cultural item in Lampung during wedding ceremonies.” (NGOs 1,*  
220 *Lampung)*

221 This also applies to alcoholic beverages. Alcohol consumption in Bali is common during  
222 celebrations, ceremonies, or religious activities:

223 *“Most Balinese people have arak (distilled spirit, traditional alcoholic drinks*  
224 *commonly found in Bali) at home for ceremonies, and there are numerous*  
225 *traditional alcoholic beverage producers in Bali. Therefore, owning alcohol in Bali*  
226 *is common. However, it is not consumed regularly; it is more of a by-occasion”*  
227 *(NGOs 1, Bali)*

228 Finally, in DI Yogyakarta, like other provinces, the consumption of sweetened foods and  
229 beverages appears to be commonplace due to the inclusion of sugary ingredients in many

230 traditional food and beverage items. All three products are easily accessible at nearby stores  
231 and come at a affordable price, starting as low as IDR 500 (=USD 0.03):

232 *“A sachet beverage can be as cheap as Rp 500 per pack, relatively inexpensive*  
233 *compared to daily expenses” (Consumer 1, DI Yogyakarta)*

234 A second aspect of the social context is consumer awareness. Our findings indicate that there  
235 may be varying levels of consumer awareness regarding regulated and unregulated  
236 commodities. In the case of regulated items such as tobacco and alcoholic beverages, despite  
237 high consumption rates, consumers are generally aware of the harm associated with these  
238 products, although many remain unaware of the specific purpose of taxing them. Conversely,  
239 in the case of SSBs, which are still unregulated, some consumers lack awareness of the long-  
240 term disadvantages of SSB consumption. As a common case in Asia, this is especially true for  
241 certain types of SSBs marketed as 'healthy,' such as dairy products or probiotic drinks, which  
242 mislead consumers into believing in their health benefits while remaining unaware of the sugar  
243 content:

244 *“In my house, we usually stock up ready-to-drink tea and coffee and consume them*  
245 *up to three times a week. For probiotic drinks, it can be as much as three times a*  
246 *day” (Consumer 2, DI Yogyakarta)*

247 Consumers argued that due to current packaging, it is difficult to easily understand the  
248 nutritional content. Moreover, as there is no age limit for SSBs consumption, unlike tobacco  
249 and alcoholic beverages, parents make consumption decisions for children in their households,  
250 contributing to a relatively high SSBs consumption rate among individuals aged 3 and above.  
251 This common misconception among parents, exacerbates SSBs consumption as it can begin at  
252 an early age and lead to developing unhealthy dietary habits. Additionally, in the case of SSBs,  
253 advertising and packaging are recognized as two significant factors driving their purchase:

254            *“The packaging is attractive, leading to curiosity. As in case for probiotic drinks,*  
255            *[I usually consume] for health” (Consumer 3, DI Yogyakarta)*

256    The third aspect is interlinked with the second factor in that consumer awareness shapes the  
257    social perception of a commodity. Regulated commodities such as tobacco and alcoholic  
258    beverages, which the government has labelled as harmful products, are also viewed negatively  
259    by consumers. Consumers have a stronger inclination to quit or at least reduce their  
260    consumption of these products. In contrast, SSBs, which have never been marketed negatively,  
261    are still seen as relatively normal and harmless commodities. Consequently, the  
262    implementation of health taxes is likely to be more challenging for SSBs compared to tobacco  
263    and alcoholic beverages.

## 264    **Institutional arrangement**

265    In the institutional arrangement, we focus our discussion on the governmental and non-  
266    governmental institutions as well as the rules that shape power dynamics and outcomes, and  
267    the shared understanding between these institutions in adopting the national government  
268    policy. We identified two categories under the institutional arrangements dimension, e.g.,  
269    ideology on the health tax objective and regulation and programs.

270    Firstly, the ideological perspective on the health tax objective concerns the shared  
271    understanding of policy objectives among each institution, with a primary focus on institutional  
272    participants. Majority of the institutions agreed that fiscal measure through health tax is needed  
273    for consumption control, particularly among specific demographic groups, including minors  
274    and lower-income individuals. Nevertheless, some disagreements emerged during these  
275    discussions. Institutions with a vested interest in industry and trade protection expressed  
276    reservations about the concept of health taxes. Their arguments centred on the potential  
277    disadvantages that health taxes could pose to local businesses operating at a micro-to-small

278 scale. This concern is particularly relevant in the case of alcoholic beverages and SSBs, given  
279 that two provinces also host local businesses engaged in the production of these commodities:

280 *“The sugary food and beverage industry is among the most popular in DI*  
281 *Yogyakarta. When Small and Microenterprises (SMEs) are asked to change their*  
282 *products, they will clearly refuse. Therefore, consumers are encouraged to control*  
283 *their intake.” (Dinkes, DI Yogyakarta)*

284 The second aspect of the institutional arrangement pertains to regulations and programs. The  
285 majority of sub-national level institutions argued that the authority for implementing fiscal  
286 measures to control NCDs lies solely with the national government. Sub-national governments  
287 primarily concentrate on the adoption of non-fiscal measures. This is particularly evident in the  
288 implementation of tobacco taxes, where the national government clearly defines the non-fiscal  
289 measures to be adopted by sub-national governments in accordance with Law No. 17/2023 on  
290 Health(50). In tobacco and alcoholic beverages cases, these measures include smoke-free area  
291 (specific for tobacco) and limit or ban advertising.

292 In the case of alcoholic beverages, although advertisements are more prominently visible in  
293 tourism areas, the sale of *arak* by micro enterprises remains prevalent. To address the potential  
294 impact of *arak* production, the Governor of Bali issued Governor Regulation No. 1/2020 on  
295 the Management of Balinese Fermented and/or Distilled Beverages(51). However, the  
296 orientation of this regulation is towards industry development, rather than protecting minors  
297 from alcohol consumption:

298 *“There is Governor Regulation No. 1 of 2020, which aims to be a solution for*  
299 *marginalized Balinese alcoholic beverages [arak]. Many people in Bali used to*  
300 *consume imported beverages. Meanwhile, in Bali, we have our own distinctive*  
301 *Balinese alcoholic beverages, but due to regulations, they seem to be illegal,*

302 *causing traditional drinks to be undermined. [As a result] they are consumed less*  
303 *by our local community, which is unfair. Balinese beverages, distinct to Bali, have*  
304 *become illegal, while imported ones are considered legal." (DinkopUKM, Bali)*

305 In the case of tobacco, even though Lampung has already established local regulations for  
306 Smoke-Free Areas (*Kawasan Tanpa Rokok/KTR*), tobacco advertisements can still be  
307 prominently observed along the main roads. This is compounded by the fact that  
308 microenterprises continue to sell tobacco to minors. Furthermore, the implementation of KTR  
309 itself remains notably weak:

310 *"Many people continue to smoke in places where KTR have been designated. A*  
311 *significant portion of the population remains unaware of the KTR policy, and there*  
312 *are still people who smoke in hospital/health center areas." (NGOs 1, Lampung)*

313 Regarding SSBs, while the fiscal measure has not yet been implemented, the non-fiscal  
314 measures that the sub-national government can take have not been clearly outlined. The  
315 initiative to raise issues related to limiting SSB consumption primarily came from public health  
316 government officials or NGOs/experts responsible for public health. Even in the governmental  
317 institutions responsible for the education sector or women and child empowerment, these  
318 initiatives have not been specifically adopted:

319 *"Educational outreach to schools, especially in high schools and vocational*  
320 *schools, regarding health (the dangers of NCDs) has not specifically addressed*  
321 *SSBs." (Disdik, DI Yogyakarta)*

## 322 **Agency Diagnosis**

323 Agency diagnosis outlines power, incentives, and behavior(43). These three aspects are closely  
324 related to the stakeholders or actors who shape policy implementation. In our case, we are  
325 interested in discussing the main stakeholder's power surrounding the implementation of health



326 taxes at the sub-national level, as well as the factors influencing their behavior (i.e., motives)  
327 and their interactions. While sub-national governments do not have a role in tax collection  
328 itself, they play a strategic role in tax allocation and in assisting national government agencies  
329 in their areas (e.g., the Customs and Excise Office or *Kantor Perwakilan Bea dan*  
330 *Cukai/KPBC*). We have identified two main aspects of agency diagnosis in our case, namely  
331 stakeholders and incentives. See Figure 2 for a summary of the stakeholders, their decision-  
332 making power, and their motives that we have determined from our analysis.

### 333 **Stakeholders**

334 This sub-theme identifies key stakeholders in the implementation of sub-national health taxes,  
335 their roles, and their interactions (see Figure 2). Two topics have been derived from this sub-  
336 theme, i.e., key actors at the sub-national level and the power and relationships between actors  
337 at the sub-national level.

338 The first aspect comprises actors responsible for decision-making at the sub-national level.  
339 Based on our FGD findings, we have identified three categories (see Figure 2, the colour of  
340 each institution differs based on their roles) of actors at the sub-national level who can influence  
341 the adoption of health tax policies. While they may not be exactly the same across all provinces,  
342 they typically share similar sets of institutions/agencies. The first category (yellow coloured)  
343 includes actors responsible for strategic policy development and priority setting. At the  
344 provincial level, this includes the governor, the provincial regional legislative council (*Dewan*  
345 *Perwakilan Rakyat Daerah/DPRD*), the regional secretariat (*Sekretariat Daerah/Setda*), the  
346 regional agency of development planning (*Badan Perencanaan Pembangunan*  
347 *Daerah/Bappeda*), and the regional agency of finance and budgeting (*Badan Perencanaan*  
348 *Keuangan dan Anggaran Daerah/BPKAD*).

349 The second category comprises actors concerned with human capital development (orange  
350 coloured), including the regional department of health (*Dinas Kesehatan/Dinkes*), the  
351 department of education (*Dinas Pendidikan/Disdik*), and the department of child protection  
352 and women empowerment (*Dinas Pemberdayaan Perempuan dan Perlindungan Anak/DP3A*).  
353 Finally, the third category comprises actors in the economic sector (purple coloured), including  
354 the regional department of trade and industry (*Dinas Perdagangan dan*  
355 *Perindustrian/Disperindag*) and the department for cooperative and micro, small, and medium  
356 enterprises (*Dinas Koperasi dan UMKM/DinkopUKM*). In addition to these sub-national  
357 policy makers, there are actors without decision-making roles who interact with them: the local  
358 agency of the Customs and Excise Office—the representative of the Ministry of Finance in  
359 each region—assumes the responsibility for revenue collection and supervision at the local  
360 level, and the local agency of the Food and Drug Authority (*Badan Pengawas Obat dan*  
361 *Makanan/BPOM*), which exercises authority over nutritional value and safety in consumed  
362 products.

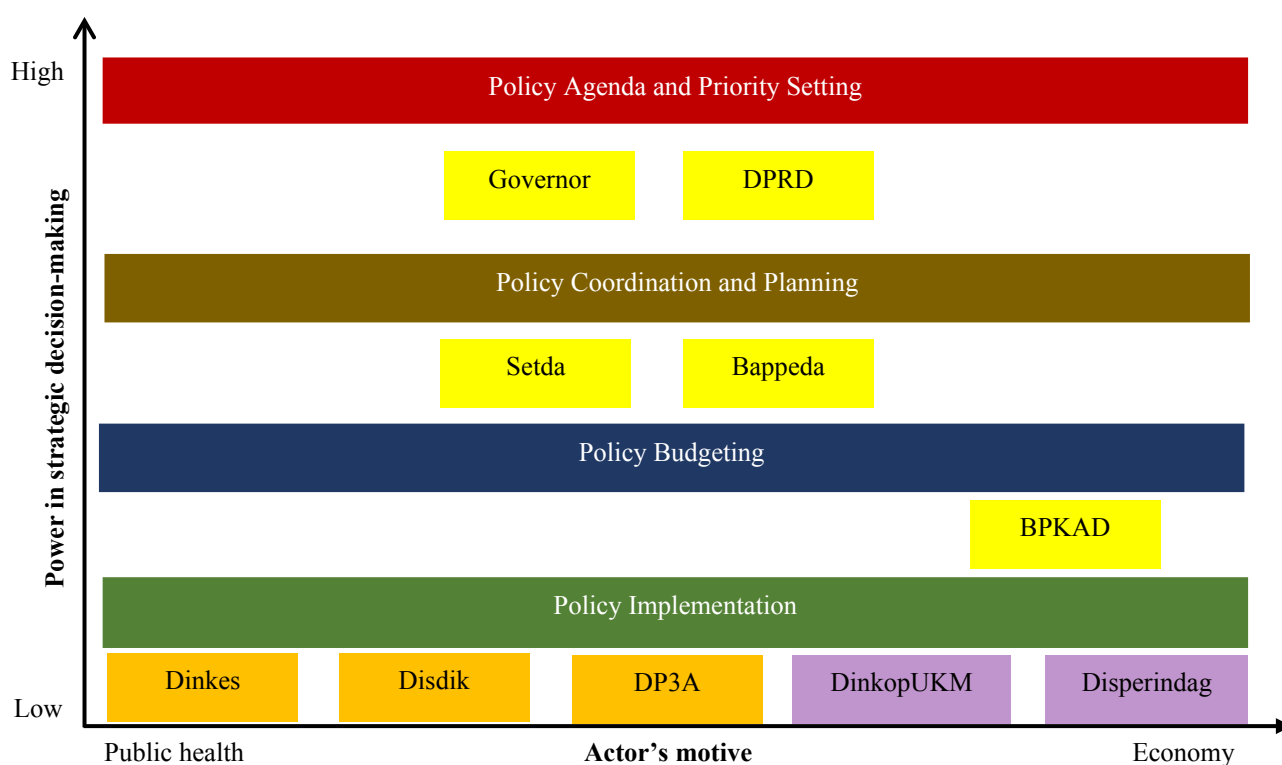
363 The second aspect is the power and relationships between the identified stakeholders. In this  
364 aspect, we identified four categories (see Figure 2). The four categories ranked from highest  
365 position in the strategic decision-making include the policy agenda and priority setting, policy  
366 coordination and planning, policy budgeting, and policy implementation, respectively.

367 The first category of actors holds higher positions in terms of regional decision-making  
368 compared to the other two categories. This is because they have the authority to set policy  
369 targets and priorities, which are then translated into policy planning and budget allocation by  
370 Bappeda in collaboration with BPKAD. Additionally, Setda and Bappeda coordinate and  
371 supervise intersectoral policy implementation. Actors in the human capital development sector  
372 and the economic sector mostly implement policies but can propose programs for prioritization  
373 before the budgeting process. They must provide evidence for why certain programs should be

374 prioritized during the annual budgeting and planning process. Finally, the local KPBC does not  
375 hold a vertical position with other policymakers. However, in terms of implementing its  
376 supervisory role (i.e., eradicating illicit trade), it can collaborate with the sub-national  
377 government.

## 378 **Motives**

379 This sub-theme pertains to the factors that shape the behavior of stakeholders. We have  
380 identified three main keywords that emerged from our analysis in this domain: the actors'  
381 orientation/position towards public health and their incentive to support the health tax policy.  
382 First is the actors' orientation/position towards public health. To illustrate each institution's  
383 objectives, we have created a spectrum of the actors' orientation, ranging from public health  
384 motives to economic motives (see Figure 2). At the implementor level, Dinkes is the main actor  
385 with a public health orientation, along with other actors in human capital development.

386 However, they maintain a relatively neutral stance towards the health tax policy issue since it  
387 is not their core institutional motive, but they actively engage in public health advocacy:

388 *“There are provincial and district programs for child-friendly areas with*  
389 *indicators that include a smoking ban. There are child forums throughout*  
390 *Indonesia that have actively campaigned against smoking with active outreach in*  
391 *schools. DP3A has also conducted anti-smoking campaigns at the neighborhood*  
392 *level, and there are regional regulations supporting smoke-free child-friendly*  
393 *areas. Disdik needs to be involved in raising awareness about the dangers of*  
394 *smoking.” (DP3A, Lampung).*

395 While at the right hindside, for Disperindag and DinkopUKM, the orientation is more towards  
396 economy, in this case industry protection:

397 *“As supporters of MSMEs, we agree because this excise tax applies to large*  
398 *manufacturers. Therefore, it can enable UMKMs to compete with large*  
399 *manufacturers.” (DinkopUKM, DI Yogyakarta)*

400 As for the coordinating bodies, BPKAD's position leans more towards the economic aspect  
401 since their motive is to collect revenue for the regional government. We position Bappeda and  
402 Setda in a more neutral role since they both house units for human capital policy and economic  
403 policy development and primarily function as coordinators:

404 *“This tax serves as an instrument to reduce consumption or circulation. I agree that*  
405 *this tax should increase, especially if there is revenue-sharing. The revenue-sharing*  
406 *from the tax can be used for SMEs in the alcoholic beverage industry and for awareness*  
407 *campaigns to improve the understanding that alcoholic beverages are detrimental to*  
408 *health.” (Bappeda, Bali)*

409 Lastly, political actors like the governor and DPRD are also in a neutral position due to their  
410 political motives, which can change with each election year.

411 Considering each actor's motive, we can also identify their incentives for supporting and  
412 prioritizing the health tax policy. For Dinkes, their main performance indicator focuses on  
413 enhancing public health status, making them staunch supporters of adopting the health tax. In  
414 addition to the potential reduction in unhealthy consumption, this move offers substantial  
415 public health benefits. Furthermore, the public health sector anticipates receiving allocations  
416 from the tobacco tax and expects similar outcomes for other types of health taxes:

417 *“I agree with the health tax and revenue-sharing that can be used to improve the*  
418 *quality and the healthcare sector.” (Dinkes, Bali)*

419 As for DP3A and Disdik, their support is somewhat conditional, hinging on the expectation  
420 that health tax revenue will be allocated to programs that bolster the implementation of health  
421 taxes. These programs could include initiatives to raise public awareness about unhealthy  
422 consumption in educational institutions or to aid women entrepreneurs in developing healthier  
423 product alternatives. These conditions are especially relevant in the case of SSBs, where there  
424 are currently no regulations in place to curb consumption, and public awareness is lacking:

425 *“For health and for the education of children, women, families in rural areas, and*  
426 *SMEs. Because many of the supported families also produce juices and beverages,*  
427 *so they can have better awareness [on the harm of SSBs].” (DP3A, DI Yogyakarta)*

428 Conversely, Disperindag and DinkopUKM are primarily driven by the motive of safeguarding  
429 the local industry. Consequently, their support for health taxes hinges on whether these  
430 measures will protect local businesses. For instance, if the tax structure is tailored to the size  
431 of the industry, if it contributes to industrial development with an export focus, or if, in the case

432 of SSBs, it serves to educate local industries about adopting healthier alternatives, these factors  
433 can influence their support:

434 *“It [health tax] can be used for education and development of MSMEs [in the*  
435 *sector].” (DinkopUKM, DI Yogyakarta)*

436 Regarding BPKAD, their support for the health tax is more pronounced when the tax revenue  
437 can be earmarked for local government revenue, mirroring the structure of the tobacco tax. In  
438 the case of Bappeda, they maintain a more neutral stance toward the incentive, as policy  
439 priorities are subject to a bottom-up discussion, beginning with sector-specific priorities and  
440 later being communicated and decided upon by higher-ranking government entities such as  
441 Setda, the governor, and the DPRD.

## 442 **Way Forward**

443 In this subsection, we delve into the main barriers and opportunities associated with the  
444 implementation of health tax policies at the sub-national level. Recommendations for  
445 addressing these barriers and optimizing opportunities will be discussed in the subsequent  
446 section.

### 447 **Barriers**

448 After conducting the structural and agency diagnosis, we can now identify potential barriers  
449 that may impede the implementation of health tax policies at the sub-national level. Three main  
450 barriers have been identified: a lack of awareness, distrust towards governmental institutions,  
451 and the existence of product substitution.

452 First and foremost is the issue of awareness. As discussed previously in the social context, there  
453 remains a significant lack of awareness among consumers regarding the health risks associated  
454 with the consumption of certain products. This lack of awareness is particularly pronounced in

455 the cases of tobacco and SSBs. Concerning tobacco, the early age at which consumers often  
456 initiate smoking, combined with the addictive nature of tobacco, presents a formidable  
457 challenge in curbing consumption through the imposition of health taxes. While alcoholic  
458 beverages are also considered addictive substances, we do not observe the same patterns of  
459 consumption:

460 *“It is somewhat impossible that Bali has the highest alcohol consumption rate.*  
461 *Most of it is related to traditional and religious purposes (it should be emphasized*  
462 *whether the factors driving this high alcohol consumption are for traditional and*  
463 *religious ceremonies or for recreational purposes and regular consumption).”*  
464 *(NGOs 2, Bali)*

465 Regarding SSBs consumption, the public still lacks a negative perception of these products,  
466 unlike the clear aversion to tobacco and alcoholic beverages. Furthermore, consumers currently  
467 struggle with understanding how to interpret the nutritional information on packaging and  
468 determining a safe sugar intake limit. Consequently, shifting their perspective on these products  
469 and raising awareness about limiting their consumption poses a significant challenge.

470 Secondly, there is an issue of trust in governmental institutions. Both consumers and  
471 institutions share a lack of trust in the government's intent behind imposing health taxes.  
472 Presently, health taxes are predominantly viewed as revenue-generation tools rather than  
473 instruments for controlling consumption:

474 *“I want this tax to be clearly used for a specific purpose. Let's not allow it to be*  
475 *used solely for new political targets just to increase revenue.” (Consumer 3, DI*  
476 *Yogyakarta)*

477 Hence, consumers and institutions driven by the motive of safeguarding local industries still  
478 harbor reservations about the necessity of implementing health taxes, fearing potential harm to

479 the local economy. The absence of transparent policy communication at the sub-national level,  
480 particularly to consumers, regarding the public health benefits of health tax implementation  
481 exacerbates this barrier.

482 Finally, there's the challenge of product substitution and non-commercial consumption.  
483 Consumer substitution toward illicit alternatives represents a potential loss for both public  
484 health and revenue generation:

485 *“I disagree because if the tax is high, it can trigger illicit tobacco due to low*  
486 *supervision in Indonesia. So, it shouldn't be increased continuously; its upper limit*  
487 *should be assessed. The funds for law enforcement need to be increased to improve*  
488 *supervision.” (Bappeda, Lampung)*

489 However, an additional challenge arises from the fact that health taxes are levied on the end  
490 product rather than on the main ingredients of those products. In contrast to alcohol, tobacco is  
491 only taxed at the final product stage. Consequently, we can still observe instances where  
492 consumers purchase tobacco and hand-roll their own cigarettes, a practice known as "linting  
493 dewe." In this scenario, the government has little control over the trade of these self-rolled  
494 cigarettes, and there are no limits on the quantity of tobacco that can be used, in contrast to  
495 commercially marketed products where such limits exist, potentially posing a health risk to the  
496 public:

497 *“I don't agree [with the increase in tobacco tax]. If it's raised, I will still buy, maybe*  
498 *reduce a bit, I can do 'linting dewe' or choose cheaper cigarettes, but still stick to*  
499 *stick my smoking habits.” (Consumer 3, Lampung)*

500 This is also a concern raised by consumers and NGOs/experts regarding the implementation of  
501 taxes on sugar-sweetened beverages (SSBs). Many small-scale SSB manufacturers are  
502 unaware of the sugar content in their products. This lack of awareness extends to homemade



503 SSBs as well, where consumers, lacking an understanding of the potential health risks  
504 associated with excessive sugar consumption, like homemade soy milk, may add as much sugar  
505 as they desire without recognizing the potential health drawbacks:

506 *“Homemade SSBs are actually more risky because there are no [limit] for the*  
507 *sugar doses.” (Consumer 6, DI Yogyakarta)*

508 As a result of health tax implementation, which can lead to higher product prices, consumers  
509 are increasingly inclined to consider more affordable alternatives, including homemade  
510 options.

## 511 **Opportunities**

512 Regarding opportunities, we have identified two primary avenues to bolster the implementation  
513 of health taxes at the sub-national level. The first opportunity lies in garnering public support.  
514 While the lack of consumer awareness presents a challenge, there are individuals with a  
515 heightened awareness of the adverse health effects associated with tobacco, alcohol, and sugar-  
516 sweetened beverages (SSBs) who wholeheartedly endorse the health tax policy, even if they  
517 are consumers themselves. Consumers tend to rally behind policies that promise health benefits  
518 rather than revenue generation motives:

519 *“I agree, because it relates to the non-communicable disease (NCD) prevention*  
520 *program. Because not all of the population is educated yet. If, for example, the*  
521 *price increases, it will compete with healthier food and drinks that are relatively*  
522 *expensive. But it's also necessary to raise the base ingredients of sweetened*  
523 *beverages. It should be supported by education. Previous policies should also be*  
524 *maintained to support the tax.” (Consumer 7, DI Yogyakarta)*

525 The second opportunity centres around engagement with non-governmental organizations  
526 (NGOs). At times, sub-national governments lack the initiative to enhance public awareness,

527 potentially undermining the effectiveness of health tax implementation. Local NGOs and  
528 academic institutions exhibit greater proactiveness in advocacy efforts. This presents an  
529 opportunity because focusing solely on engaging NGOs and academics at the national level  
530 may limit outreach to broader segments of society, especially beyond the Java region.

## 531 **Discussion**

532 Indonesia, as one of the most decentralized nations, has encountered challenges in exercising  
533 local government autonomy, particularly in implementing fiscal autonomy (revenue  
534 generation) and delays in adopting national government regulations(20, 22, 52). Recognizing  
535 the complex nature of health tax implementation not only horizontally among national actors  
536 but also vertically among local actors, we built upon our previous work, specifically focusing  
537 on national-level policy debates on health taxes(53). This extension to the sub-national level  
538 becomes imperative as limited fiscal resources lead sub-national governments to prioritize  
539 curative over preventive or promotive measures in public health(54). Therefore, promoting  
540 health taxes as an additional source of funding for preventive and promotive actions earmarked  
541 for relevant programs in each institution is likely to gain more support from sub-national  
542 governments, as our findings suggest. This insight is especially important as political work to-  
543 date on sub-national health taxes, is limited to a small set of research on SSBs taxes in the  
544 US(55). Our findings also align with previous studies emphasizing the importance of  
545 earmarking health taxes for public health rather than framing them as revenue-generation  
546 tools(56-59). Although, detailing the well-intention of the health tax generation invites  
547 counteractive arguments from anti-tax opposition (55).

548 The same principle applies to policy communication. In Indonesia, policies driven by economic  
549 motives seem less likely to garner public support, whereas those driven by public health  
550 motives have a better chance of gaining popularity. Although more mixed supports suggested

551 that emphasising the revenue streams for wider purposes, such as education initiatives, appear  
552 to be more appealing to voters(55). While recent cross-country work in LMICs has painted a  
553 rather mixed view about which arguments resonate in which settings, our findings are  
554 consistent with previous studies, suggesting that communicating health taxes as an effective  
555 measure to combat NCDs is likely to be publicly acceptable(60-63). However, without  
556 providing a convincing moral case for health taxes that resonates with diverse sets of interests,  
557 these measures might face challenges in the face of competing arguments from opponents(64,  
558 65). Therefore, generating evidence to counter arguments from industry proponents should be  
559 a part of the policy agenda, as public acceptability is likely to be higher when strong evidence,  
560 provided by a credible source, supports a compelling claim(65-67).

561 In addition to allocating funds for promotive and preventive activities, health tax  
562 implementation can be complemented by other fiscal measures that are more applicable for  
563 sub-national governments. This could include subsidies for healthier alternatives, incentives  
564 for cessation(68-70), and regulatory and fiscal support for industries producing healthy  
565 products (71). Furthermore, health taxes often lead industries to reformulate their products to  
566 avoid the tax (72, 73), which could be an important tax design consideration(74). Therefore,  
567 health tax revenue can also be allocated to enable sub-national governments to promote and  
568 ensure proper product reformulation for healthier alternatives by engaging local enterprises.  
569 This is consistent with our finding that institutions with industry protection motives support  
570 health taxes because they can benefit local enterprises, particularly for promoting healthier  
571 alternatives.

572 In addition to fiscal measures, non-fiscal measures are equally important. While the majority  
573 of past studies have shown a negative relationship between health taxes and unhealthy  
574 consumption or NCD prevalence(70, 75-80), anticipating consumers' substitution with cheaper  
575 but equally harmful alternatives is important(68, 81). Therefore, increasing consumer

576 awareness to consciously limit their consumption of unhealthy products should be a priority.  
577 This can be achieved through extensive efforts to promote a healthy lifestyle through mass  
578 campaigns, civil society engagement, and women's empowerment(60, 61, 82-84). Our findings  
579 support the importance of optimizing the engagement of local NGOs and academics, as well  
580 as raising awareness among institutions interested in women's empowerment and children(63),  
581 such as Disdik and DP3A.

582 Another critical non-fiscal measure that should be strongly enforced is a complete ban or strict  
583 limitations on advertising. While regulatory frameworks for tobacco advertising are in place,  
584 lack of local government commitment and weak surveillance systems hinder adoption at the  
585 sub-national level(22, 85). While we found no issues with alcohol advertising, our findings  
586 suggest potential disadvantages of advertising and packaging information for SSBs. Since there  
587 are currently no specific interventions for SSBs, past studies have suggested Front-of-Pack  
588 (FOP) or 'traffic-light' nutritional labeling (86-88). This should be accompanied by extensive  
589 consumer education to increase their understanding of nutritional labeling, as previous studies  
590 have noted a lack of comprehension among consumers(89). Furthermore, in the realm of law  
591 enforcement, the health tax can also be leveraged to impose more stringent penalties, enhance  
592 monitoring efforts, and provide counselling for sellers found illegally selling tobacco and  
593 alcohol to minors.(90-92).

594 Finally, given the cross-sectoral nature of health tax implementation, sub-national and national  
595 governments must share a common understanding of the policy objectives to avoid policy  
596 polarization. With health financing problems being one of the decentralization issues facing  
597 the healthcare sector in Indonesia(35), framing health taxes as a means of health financing will  
598 be crucial to avoid conflicting interests in tax allocation. This should be a clear priority during  
599 the planning process to ensure budget alignment and avoid implementation delays(14, 16, 93).

600 We propose three crucial recommendations for advancing the implementation of health taxes,  
601 applicable to both sub-national and national governments.

602 First and foremost is the aspect of policy communication, which holds paramount importance  
603 in gaining the trust and support of the public. When communicating the health tax policy,  
604 advocates should consider a wider range of arguments in support of health taxes, such as ones  
605 based on health impacts, as opposed to prioritizing just the revenue-generation potential of  
606 these taxes.

607 Secondly, the health tax earmarking should be a key consideration. Even though sub-national  
608 governments may not directly engage in health tax collection, they can actively participate in  
609 the allocation of health tax revenues. Although hard earmarking is subject to a debate, a soft  
610 earmarking which allows a more flexible funding priorities and aligns with decentralization,  
611 can garner greater public and sub-national government support for health taxes.

612 In addition to the health sector, as is currently the case with tobacco, some broader  
613 recommendations for funding allocation includes: (i) enhancing public awareness through  
614 preventive and promotive actions; (ii) supporting industrial development with an export  
615 orientation, especially for alcoholic beverages, which may have unique local specialties  
616 suitable for export; (iii) raising awareness among local small and micro-enterprises to  
617 encourage shifts toward healthier product alternatives, such as product reformulation  
618 (particularly for SSBs); (iv) providing subsidies for healthier alternatives, particularly targeting  
619 lower-income households; and (v) strengthening law enforcement, which includes eradicating  
620 the illicit trade of cigarettes and imposing fines on those who sell alcoholic beverages and  
621 tobacco to minors.

622 Lastly, non-fiscal measures are equally critical alongside fiscal ones. Some significant non-  
623 fiscal measures that deserve prioritization include: (i) implementing bans or limitations on

624 advertising, an area currently under sub-national government authority. This restriction should  
625 also extend to SSBs. Furthermore, the national government should consider reinforcing the  
626 regulatory framework to encourage sub-national governments to adopt this policy; (ii)  
627 enforcing standardized packaging, similar to the tobacco industry, which features easily  
628 recognizable packaging with pictorial health warnings. We propose that this approach be  
629 applied to SSBs as well. The government should contemplate implementing mandatory Front-  
630 of-Pack or 'traffic light' labelling to mitigate consumer confusion; and (iii) launching extensive  
631 promotional campaigns, particularly for SSBs. In the case of tobacco, which has long been  
632 marketed as a 'harmful' product, similar efforts should be directed toward raising awareness  
633 about the health risks associated with SSB consumption.

634 To the best of our knowledge, this is the first attempt to analyze the political economy of health  
635 taxes for three different commodities (tobacco, alcoholic beverages, and SSBs) at the sub-  
636 national level in Indonesia. However, this study is subject to certain limitations. Firstly, it is  
637 constrained by its focus on specific provinces, potentially posing a threat to external validity.  
638 However, we took steps to mitigate this limitation by broadening our sample to encompass  
639 three provinces, each with different commodities under scrutiny. Additionally, the inclusion of  
640 multiple stakeholders from various sectors, including government, non-governmental  
641 organizations, and consumers, provides a more comprehensive perspective that may be  
642 applicable in other settings.

643 Secondly, our study did not involve elected policy actors such as governors or members of the  
644 DPRD. These individuals may offer valuable insights into the political economy of health  
645 taxes. Future research should consider expanding the pool of informants to include these  
646 elected officials, thereby enriching our understanding of the subject.

647 Lastly, our study's scope is limited in terms of SSBs knowledge. This limitation arises because,  
648 at the time of our data collection, the tax on SSBs had not been implemented. Subsequent

649 studies should consider conducting research specifically on SSBs after the implementation of  
650 relevant regulations to provide a more comprehensive analysis of the impact of health taxes on  
651 this particular commodity.

## 652 **Conclusion**

653 This study aims to understand the political economy of health tax policy implementation at the  
654 sub-national level by critically exploring the case of Indonesia as one of the most decentralized  
655 countries. The findings of this study identify lessons learned for countries facing similar  
656 challenges of a complex decentralized decision-making process.

657 Sub-national governments, constrained by limited fiscal resources, tend to prioritize curative  
658 actions over preventive measures. To address this, promoting health taxes as a funding source  
659 for preventive initiatives is crucial, aligning with findings from limited research on sub-national  
660 health taxes. However, counteractive arguments from anti-tax opposition should be anticipated  
661 and addressed through comprehensive communication strategies.

662 Policy communication should emphasize a wide range of arguments, including health impacts,  
663 to gain public support. Earmarking health tax revenues, with a preference for soft earmarking,  
664 allows flexibility and aligns with decentralization principles, garnering greater support.  
665 Recommendations include prioritizing public awareness, supporting industrial development,  
666 and providing subsidies for healthier alternatives. Non-fiscal measures, such as advertising  
667 restrictions and standardized packaging, are crucial. The study, focusing on tobacco, alcoholic  
668 beverages, and SSBs at the sub-national level, acknowledges limitations and suggests future  
669 research directions, emphasizing the need for a comprehensive understanding of health taxes'  
670 political economy.
