35 ABSTRACT

36 Foodborne diseases (FBD) constitute a significant worldwide concern with both health and 37 socioeconomic repercussions. FBD predominantly manifest with gastrointestinal symptoms. 38 Nevertheless, extraintestinal infections and symptoms caused by foodborne pathogens are 39 increasingly being reported worldwide. Furthermore, FBD caused by drug resistant bacteria 40 causing both intestinal and extra-intestinal FBD (EIFBD) has further exacerbated their 41 burden. This review (i) summarizes the status of intestinal foodborne pathogens, (ii) 42 delineates the drivers, highlights the (iii) genomic evidence, and (iv) global significance of 43 EIFBD. Understanding the transmission routes and genomic evolution of the principal 44 bacteria causing extra-intestinal FBD is of paramount importance to fully assess the burden of 45 FBD globally, especially in under-resourced regions of Asia, Africa, and Latin America. 46 Acknowledging EIFBD as an integral part of FBD is critical to reach sustainable 47 development. Integrated strategies considering the One Health approach are requisite if FBD 48 are to be controlled, plus to ensure food safety and security.

53 Impact Statement

Foodborne diseases (FBD) present a global health challenge, with the significant health impact and economic costs. Commonly, these illnesses manifest as gastrointestinal troubles; however, there is an alarming increase in reports of foodborne pathogens causing infections beyond the intestinal tract. The complexity of managing FBD is worsened as various pathogens exhibit resistance to antibiotics, a concern applicable to both intestinal and extraintestinal infections.

This review serves several critical functions: (i) provide a current overview of the pathogens responsible for gastrointestinal FBD, (ii) examine the underlying factors contributing to the proliferation of these diseases, (iii) present insights gleaned from genomic studies, which enhance our understanding of these pathogens.

64 Grasping the mechanisms of pathogen transmission and genetic evolution is essential to 65 accurately evaluate the worldwide impact of FBD. Acknowledging extraintestinal infections 66 as a significant component of FBD is vital for sustainable progress. Combating FBD 67 effectively necessitates a comprehensive "One Health" approach, which integrates the well-

- 68 being of humans, animals, and the environment. Such a strategy is imperative not only for
- 69 controlling FBD but also for ensuring the safety and availability of food resources globally.

70 **INTRODUCTION**

71 Foodborne diseases (FBD) have been defined by the World Health Organization (WHO) as 72 diseases caused by the ingestion of unsafe food contaminated by infectious (including 73 bacteria, viruses, fungi, and parasites) and non-infectious agents (chemicals) (WHO, 2015). In 74 2010, 600 million FBD cases were recorded with 420,000 deaths (WHO, 2015). FBD are a 75 serious global public health threat that manifest mainly with gastrointestinal symptoms such 76 as nausea, vomiting, and diarrhoea (WHO, 2015). These clinical manifestations of some FBD 77 led to the investigation of foodborne pathogens mainly in the gastrointestinal tract (GIT), 78 whilst some foodborne pathogens can also cause extra-intestinal infections such as urinary 79 tract and bloodstream infections, and meningitis (Manges et al., 2019).

80 The most common bacteria causing FBD include diarrhoeagenic Escherichia coli (DEC) 81 (Riveros et al., 2017; Estrada-Garcia & Navarro-Garcia, 2012), Salmonella spp. (Abbott et al., 82 2012; Jüch et al., 2013; Pulford et al., 2019), Listeria monocytogenes (Schlech, 2019), and 83 *Campylobacter* spp. (Chlebicz & Śliżewska, 2018) have all been acknowledged to cause both 84 intestinal and extra-intestinal manifestations. "Non-classical" foodborne bacteria such as 85 extra-intestinal pathogenic E. coli (ExPEC) (Liu et al., 2018), Klebsiella pneumoniae (Davis 86 et al., 2015), Group B Streptococcus (GBS) (Boonyayatra et al., 2020; Simões et al., 2021; 87 Sørensen et al., 2019) and Staphylococcus spp. (Lawal et al., 2021) originating from food 88 and/or food animals have recently been implicated in either human urinary tract infections 89 (UTIs), sepsis, meningitis, or a combination of these diseases, with mild- to life-threatening 90 outcomes. Nevertheless, the scope and burden of extra-intestinal foodborne diseases (EIFBD) 91 caused by these "non-classical" foodborne bacteria are poorly documented worldwide. EIFBD 92 without associated gastrointestinal symptoms are yet to be considered globally, even in the 93 most advanced foodborne disease surveillance systems implemented in high-resource 94 countries which mainly focus on intestinal FBD. This likely leads to an underestimation of the 95 global burden of FBD.

96 Infectious FBD are frequently due to zoonotic transmission of pathogens from food animals 97 or products of food animals (Gerner-Smidt et al., 2019). Foodborne bacteria cause FBD by 98 numerous ways including, but not limited to the (i) production of toxins in food that is 99 subsequently consumed by humans, (ii) production of toxins in the gastrointestinal tract after 100 ingestion, (iii) colonization of the intestinal tract, and (iv) invasion of intestinal epithelium 101 cells (Antunes et al., 2020). Understanding the different mechanisms and drivers of pathogen 102 emergence, spread, and persistence in populations is essential for designing appropriate

prevention and containment measures against infectious diseases (Watkins et al., 2016). The relative abundance of FBD echoes with three main questions: to demonstrate that extraintestinal infections such as UPEC are indeed FBD? Are there genetic evidences of EIFBD globally? Could drug-resistant EIFBD exacerbate the burden of FBD? Therefore, the aims of this review are to: (i) summarize the current trends of intestinal FBD, (ii) delineate the evidence of EIFBD, (iii) describe the genetic evidence of EIFBD, and (iv) outline the global significance of EIFBD, to emphasize data gaps and provide a roadmap for future studies.

110 I. Methods

111 Original articles in French or English which included genetic data characterizing bacterial 112 pathogens associated with extra-intestinal foodborne diseases were searched independently in 113 the MEDLINE database through PUBMED by four authors, PLK, BDD, AM and JRZ. 114 Advanced searches were done using Boolean operators AND, OR, and NOT and the key 115 terms used included: extra-intestinal foodborne disease, foodborne disease, foodborne illness, 116 foodborne urinary tract infections, urinary tract infection, bloodstream infection, bacteraemia, 117 urosepsis, sepsis, meningitis, invasive disease, wound infection, Enterobacteriaceae, 118 Enterobacterales, Escherichia coli, Klebsiella pneumoniae, Staphylococcus, Streptococcus 119 pyogenes (Group A Streptococcus, GAS), Streptococcus agalactiae (Group B Streptococcus, 120 GBS), genotype, virulence, and molecular epidemiology. All relevant articles, English or 121 French, clearly presenting the genetic link between human infections and animal food and/or food animals, published between 1st January 2015 and 29th April 2022 were included. 122 123 Reviews, Case reports, and conference proceedings were excluded.

II. Overview of intestinal foodborne diseases

125 FBD represent one of the major causes of mortality and morbidity in humans with 600 million 126 cases and 420000 deaths in 2010 alone (WHO, 2015). Campylobacter spp., Salmonella 127 enterica, Shiga-toxin E. coli, Shigella spp., and Listeria monocytogenes respectively are the 128 leading predominant bacteria involved in FBD (Crim et al., 2014). Moreover, several reports 129 have described the role of other bacteria such as K. pneumoniae, S. aureus (Ko et al., 2018; 130 Liu et al., 2021), GAS (Karabela et al., 2022), and GBS (Barkham et al., 2018; Tiruvayipati et 131 al., 2021) and that they are transmitted after food consumption, therefore, they should be 132 considered foodborne pathogens. Bacterial contamination can occur at any stage from farm-133 to-the-plate continuum (Founou et al., 2016; Yang et al., 2017). This section provides a 134 general overview of foodborne bacteria and intestinal foodborne diseases (IFBD).

135 *1. Escherichia coli*

136 *Escherichia coli* is a commensal and ubiquitous bacterium that has been involved in numerous 137 cases of intestinal foodborne disease (IFBD) (Hu et al., 2021) mainly through the 138 consumption of contaminated food (Liu et al., 2018). In 2015, the World Health Organization 139 (WHO) published the first estimates of FBD worldwide reporting that *E. coli* caused over 110 140 million cases of FBD resulting in over 63,000 deaths (WHO, 2015). Diarrhoeagenic E. coli 141 (DEC) pathotypes including enteropathogenic (EPEC) and atypical EPEC (lacking the 142 bundle-forming pilus), enterotoxigenic (ETEC), enteroaggregative (EAEC), diffusely 143 adherent (DAEC) entero-invasive (EIEC), and Shiga toxin-producing E. coli (STEC), are 144 important causes of diarrhoea in children, of travellers' diarrhoea (TD), and diarrhoea in 145 immunocompromised patients (Martínez-Santos et al., 2021). STEC can be specifically 146 associated with haemolytic uremic syndrome, while ETEC and EAEC with TD (Cabrera-Sosa 147 & Ochoa, 2020; Jiang & DuPont, 2017).

The foodborne transmission of *E. coli* has been clearly evidenced by its impact on human health (WHO, 2015). A study conducted in South Korea, where the authors performed the molecular characterization of *E. coli* in human stool, environmental and preserved food samples demonstrated that consumption of egg-based foods was associated with atypical EPEC O157:H45 infections with an attack rate of 2.5% (Park et al., 2014).

2. Salmonella spp.

Foodborne *Salmonella* infections contribute substantially to morbidity and mortality worldwide (WHO, 2015). *Salmonella* is of public health concern due to the burden of salmonellosis and frequent reports of AMR. AMR salmonellae are difficult to treat, increasing the number of deaths due to FBD (Chlebicz & Śliżewska, 2018). Misuse of antimicrobials for animal husbandry and in the treatment of infections has impacted the rising incidence of AMR in salmonellosis.

160 Globally, 3.4 million non-typhoidal Salmonella (NTS) infections occur resulting in close to 161 19,000 deaths yearly (Stanaway et al., 2019). In the United States of America (USA), high-162 resolution whole genome sequenced (WGS) revealed close phylogenetic relationships 163 between NTS serovars detected in humans, food animals, and agricultural environmental 164 sources different hosts, indicating the importance of pathogens of animal origin in FBD 165 (Pornsukarom et al., 2018). Likewise, another study carried out in China demonstrated with 166 WGS, that S. Typhimurium isolated from pigs was responsible for a large proportion of FBD 167 although this may not be the case in countries where pork is not eaten (Sun et al., 2020).

169 *3. Campylobacter spp.*

170 Campylobacteriosis is a zoonosis whose main reservoir is the digestive tract of wild or 171 domestic birds, such as poultry, but also other food animals like sheep, cattle, and pigs 172 (Ahmed & Gulhan, 2021). Campylobacter species are usually commensal in animals but can 173 spread to humans directly or indirectly through ingestion of contaminated food or water 174 (Facciolà et al., 2017). *Campylobacter* spp. is one of the most important foodborne pathogens 175 even in high-income countries (Facciolà et al., 2017). In 2010, Campylobacter spp. caused 176 around 96 million FBD cases and 21,500 deaths worldwide (WHO, 2015). The most common 177 species involved in human infections are Campylobacter jejuni and Campylobacter coli 178 (Aksomaitiene et al., 2019). C. jejuni population structures are weakly clonal, resulting in the 179 plasticity of the *Campylobacter* genome. The latter is susceptible to point mutations and 180 genomic instability and can readily take up foreign DNA and an enormously diverse 181 population irrespective of which typing system is used (Newell et al., 2010). Nevertheless, 182 some stable clones of C. jejuni have persisted, and such clones may provide insight on 183 changing trends (Newell et al., 2010).

By genotypically characterising with multi-locus sequence typing (MLST) *C. jejuni* isolates in different sources of isolation (human, chicken, dairy cattle, and wild birds), in Lithuania, Aksomaitiene et al. (2019) showed that from a total of 341 isolates originating from humans, chickens, cattle and wild birds, CC1034 and CC403 sequence types (ST) were found in all hosts demonstrating that cattle and wild birds were the main reservoirs of *C. jejuni* isolated from human infections (Aksomaitiene et al., 2019).

4. Staphylococcus aureus

191 Staphylococcal food poisoning is one of the most common FBD in the world. Approximately 192 241,000 cases of FBD are caused by S. aureus every year in the USA (Scallan et al., 2011). 193 Raw or undercooked food, especially food of animal origin and nasal carriage by food 194 workers are identified as important reservoirs of S. aureus causing FBD (Wang et al., 2017). 195 The ingestion of staphylococcal toxins produced by certain strains is the main cause of 196 disease symptoms (Hennekinne et al., 2012). Some virulence genes such as those encoding 197 for the toxic shock syndrome toxin 1 (TSST-1), exfoliative toxins, and cytolytic toxins are 198 involved in staphylococcal food poisoning (Argudín et al., 2010). In an epidemiological 199 surveillance study in China, 163 S. aureus isolates were analysed by pulse field gel 200 electrophoresis (PFGE) with some isolates originating from foodstuffs such as rice noodles 201 and rice rolls, showing identical profiles with those collected in humans with clinical signs of 202 food poisoning (Liao et al., 2018). Likewise, Lui et al. (2021) performed a genotypic

203 characterisation of S. aureus isolated from animal samples collected at farms and markets in 204 Xinjiang province and demonstrated that meat originating from abattoirs and farms was 205 contaminated with virulent S. aureus. They confirmed the spread of these virulent lineages of 206 S. aureus in the food chain and their involvement in FBD (Liu et al., 2021).

III. **Drivers of extra-intestinal foodborne diseases**

208 A complication of diarrhoeal foodborne diseases is their capacity, in some cases, to become 209 systemic diseases (Hoffmann et al., 2020). Intestinal barriers existing prevent any harmful 210 elements including toxins and bacteria from disseminating to the bloodstream and other 211 organs or tissues (Li & Tan, 2020). Factors that directly or indirectly allow foodborne bacteria 212 to breach this barrier are EIFBD drivers. The drivers of EIFBD include a triad of (i) host 213 susceptibility (ii) genomic diversity within pathogens, and (iii) food contamination, which are 214 known to drive the transmission of pathogenic bacteria to humans as seen in figure 1 below 215 (Antunes et al., 2020). While food contamination can directly or indirectly lead to EIFBD, 216 bacterial pathogenicity, and host susceptibility are favouring factors which might lead to an 217 EIFBD after an IFBD has already been established (Antunes et al., 2020).

218

1. Host susceptibility

219 The main host factor favouring EIFBD is immunosuppression, which increases the host's 220 vulnerability to pathogens (Lund & O'Brien, 2011). One of the main vulnerable groups to 221 infections due to FBP are undernourished children from sub-Saharan Africa and Latin 222 America, their increased susceptibility to diarrhoeagenic pathogens has clearly been 223 established (Acosta et al., 2016; Opintan et al., 2010).

224 Other vulnerable groups include people living with acquired immunodeficiency syndrome 225 (AIDS), people with physiologically impaired immune systems like pregnant women, the 226 elderly as well as individuals on immune suppressive drugs or cancer therapy (Lund & 227 O'Brien, 2011). This vulnerability leads to a reduction of the load of organisms required to 228 cause infectious diseases and, is therefore, easily associated with bacterial dissemination to 229 extra-intestinal sites due to the lowering of host's immune defences which are supposed to 230 prevent this (Lund & O'Brien, 2011). Immunocompromised individuals are thus more prone 231 to have an EIFBD and more severe diseases caused by extra-intestinal dissemination.

2. Foodborne bacteria pathogenicity and diversity

233 Bacteria are subjected to adverse conditions that contribute to their stress, favouring their 234 survival, or acquisition of new traits (Begley & Hill, 2015). These traits are responsible for 235 virulence in foodborne pathogens and differ between species and subtypes (Table 1). The

acquisition of virulence factors involved in pathogenicity and of resistance genes leading to
antimicrobial resistance or exposure to a hostile environment may allow bacteria to become
more virulent, persist in the host by counteracting the innate and adaptive immune responses,

spread to other tissues, and subsequently lead to extra-intestinal infections (Cavestri, 2020).

240 The presence in the human host of foodborne bacteria harbouring antibiotic-resistance genes 241 could favour extra-intestinal dissemination of these pathogens because antibiotics do not 242 eliminate them, and microorganisms could then colonize other niches. For instance, when the 243 host's immune system fails to eradicate antimicrobial-resistant bacteria from the 244 gastrointestinal tract, bacteria might persist within the gut for an extended duration. 245 Consequently, they could breach the intestinal barrier and enter the systemic circulation, 246 potentially resulting in an extraintestinal infection. This is supported by the existence of 247 virulence genes co-located along with antibiotic resistance genes encoded on mobile genetic 248 elements such as plasmids (Beceiro et al., 2013; Singer, 2015). For instance, non-typhoidal 249 Salmonella (NTS) isolated from retail meat were involved in infections in children and those 250 infected with drug-resistant NTS strains were more likely to develop severe sepsis than those 251 with the drug-susceptible Salmonella (Chang et al., 2020).

3. Food contamination

253 In recent years the emergence, dissemination, persistence, and exposure of highly 254 resistant/virulent foodborne bacteria at each step of the food production chain has increased 255 due to the intensification of food production activities in the agricultural and livestock sectors, 256 and large-scale distribution of food products to cope with the global food demand (Founou et 257 al., 2021). This is particularly true in low- and middle-income countries (LMICs) as a result 258 of poor hygiene and sanitation, inadequate handling processes, insufficient safety control 259 measures during operations, poor control of the use of antibiotics as growth promoters, and 260 sub-optimal storage facilities (Founou et al., 2021). Food contamination can occur through 261 direct spread from infected animals or animal excretions, or via contamination with foodborne 262 bacteria on the hands of food handlers (Founou et al., 2021; Founou et al., 2016). Although 263 gastrointestinal disease is usually self-limiting, systemic dissemination may occur if 264 vulnerable patients infected with resistant pathogens are treated with the incorrect antibiotic. 265 The globalization of trade of food products is a major factor contributing to the spread of 266 foodborne pathogens internationally (Tiseo et al., 2020) and AMR pathogens causing both 267 IFBD and EIFBD can cross country/continental borders when contaminated food products are 268 transported from one region of the world to another.

IV. Burden and genetic evidence of extra-intestinal foodborne diseases

272 Foodborne bacteria are now increasingly being recognised in extra-intestinal infections 273 (Riley, 2020), but because of (i) the relatively long incubation period between gastro-274 intestinal tract (GIT) colonization and dissemination to other body systems, (ii) poor 275 understanding of this paradigm by physicians, and (iii) insufficient investigation of the 276 transmission routes associated with invasive infections, it is difficult to ascertain causality in 277 most cases. Nevertheless, some studies provided genetic evidence on EIFBD especially 278 urinary tract infections (UTIs), sepsis, and meningitis, that were caused by E. coli, K. 279 pneumonia, S. saprophyticus, and Group B Streptococcus (GBS) as disclosed below and in 280 Table 2.

281

1. Urinary tract infection (UTI)

282 Urinary tract infections (UTIs) are a serious public health problem and are the most common 283 bacterial infections in women of economically active age worldwide with over 150 million 284 cases yearly (Flores-Mireles et al., 2015). Foodborne bacteria can transiently colonize the 285 human gastrointestinal tract after ingestion (either directly after contact with an 286 infected/contaminated animal or indirectly via food or contaminated surfaces) where they 287 could later spread to the urinary tract (Flores-Mireles et al., 2015). This hypothesis is more 288 plausible and thus more beneficial for bacteria invading the female urogenital tract since 289 women have a shorter urethra than men (Nordstrom et al., 2013). Bacteria can ascend from 290 the lower urinary tract to the ureter and then to the kidneys, causing pyelonephritis. From the 291 kidneys, bacteria can disseminate to the bloodstream, known as urosepsis, a life-threatening 292 condition with high mortality rates of 20-40% (Dreger et al., 2015; Riley, 2020).

1.1.Escherichia coli

294 Uropathogenic E. coli (UPEC) is the single most prevalent uropathogen causing 70-95% of all 295 UTIs (Singer, 2015) and belonging to the broad group of extra-intestinal pathogenic E. coli 296 (ExPEC) having virulence factors enable it to thrive in environments other than the human 297 gastro-intestinal tract including the human urogenital tract (Flores-Mireles et al., 2015). Liu et 298 al. prospectively assessed the role of foodborne E. coli ST131-H22 as an uropathogen using 299 core genome single nucleotide polymorphisms (cgSNP)-based phylogenetic analysis (Liu et 300 al., 2018). E. coli ST131 detected in retail meat (pork and chicken) were closely related to E. 301 *coli* isolates from human clinical samples including urine and blood (Liu et al., 2018). 302 Moreover, human clinical E. coli ST131-H22 strains harbouring the CoIV plasmid, typically

ascribed to avian pathogenic *E. coli*, were more closely related to *E. coli* ST131-H22 strains
from meat sources, in comparison to those strains lacking the ColV plasmid. This suggests
that poultry could be a source of not only intestinal but also extra-intestinal human infections
such as UTI and urosepsis (Liu et al., 2018).

1.2.Klebsiella pneumoniae

Though not acknowledged as a "classical" foodborne pathogen, K. pneumoniae strains 308 309 originating from animals have also been identified in clinical infections. Davis et al., (2015), 310 reported that K. pneumoniae strains, isolated from urine samples of UTI patients, exhibited a 311 high degree of genetic similarity to strains found in retail meat in the USA (Davis et al., 312 2015). The authors analysed 508 retail meat samples (pork, turkey, and chicken) and 1728 313 clinical urine samples from UTIs patients, and the core genome SNP-based phylogenetic 314 analysis of 83 K. pneumoniae isolates from both retail meat and urine samples, revealed five 315 closely related human-meat isolate pairs were genomically closely related (Davis et al., 2015). 316 Furthermore, Davis et al. (2015) study revealed that after testing in a murine sepsis model, the 317 five K. pneumoniae isolate pairs displayed a comparable virulence profile. The authors 318 concluded that the high genetic relatedness and similar virulence profile strongly suggested 319 that UTI-causing K. pneumoniae could likely have an animal origin, emphasizing the need for further consideration of K. pneumoniae in EIFBD (Davis et al., 2015). 320

1.3. Staphyloccus saprophyticus

322 S. saprophyticus is the one of most prevalent Gram-positive uropathogens causing 323 uncomplicated UTIs (Flores-Mireles et al., 2015). De Paiva-Santos et al. after analyzing the 324 virulome of 142 S. saprophyticus isolates collected from cheese, recreational water, and urine 325 specimens of UTI patients found similar virulence gene profiles among the strains from all 326 sources (de Paiva-Santos et al., 2018). Based on these results, the authors surmised the 327 elevated uropathogenic potential of foodborne (cheese-borne) S. saprophyticus isolates (de 328 Paiva-Santos et al., 2018). Likewise, SNP-based phylogenetic analysis of 128 S. 329 saprophyticus isolates causing UTIs and 104 isolates from several sources of the 330 slaughterhouse including from pigs, raw pork meat, and the slaughterhouse environment, 331 workers, and equipment demonstrated that S. saprophyticus causing UTIs was of foodborne 332 origin since the S. saprophyticus isolates from the pig and raw meat clustered together with 333 the UTI patient, and slaughterhouse workers S. saprophyticus isolates (Lawal et al., 2021). 334 Interestingly, all S. saprophyticus isolates from this cluster harboured the antiseptic and 335 disinfectant-resistant gene qacA, its expression favours the persistence of these bacteria on

hands and contaminated surfaces even after disinfection, thus enabling *S. saprophyticus* transmission at the animal-environment-human interface (Lawal et al., 2021).

2. Sepsis and bloodstream infections

340 Group B Streptococcus (GBS) has gained notoriety as the leading cause of neonatal infections 341 and deaths with high mortality rates globally (Seale et al., 2017). Group B Streptococcus has 342 been associated with cattle and more recently with fish and some lineages are considered as 343 foodborne bacteria (Kayansamruaj et al., 2019). Furthermore, some studies have reported 344 indistinguishable and highly related PFGE profiles between bovine, fish, and human GBS 345 isolates (Boonyayatra et al., 2020; Simões et al., 2021; Sørensen et al., 2019). For instance, 346 Simões et al. (2021) found a closely related hypervirulent GBS serotype III/ST17 between 347 isolates from bovine milk and that from a neonate presenting with GBS infection albeit the 348 authors did not specify if the mother was screened for carriage (Simões et al., 2021). Of 349 interest, these GBS isolates not only shared identical MLSTs and similar PFGE profiles but 350 (i) had identical antimicrobial resistance profiles, (ii) harboured the hyper-virulent GBS 351 adhesin (HvgA) gbs2018-C gene, genes encoding for pilus variants PI-1, PI-2a and PI-2b, (iii) 352 possessed DNase activity and (iv) harboured the tetM gene (Simões et al., 2021). The fact that 353 these GBS strains have similar phenotypic, genotypic, and high-resolution phylogenetic 354 characteristics strongly underscores the role of bovine GBS serotype III/ST17 in the 355 vulnerable neonatal and infant population.

3. Meningitis

357 Bacterial meningitis is still a global health problem, associated with high morbidity and 358 mortality worldwide (Bystritsky & Chow, 2022). Considerable progresses have already been 359 made in the diagnosis and treatment of bacterial meningitis caused by frequently incriminated 360 pathogens such as S. pneumoniae, N. meningitidis, and GBS (van de Beek et al., 2021). GBS 361 is among the leading cause of meningitis in newborns who inhale or ingest amniotic fluid 362 before or during delivery (Fischer et al., 2021). Of the ten known GBS capsular serotypes, six 363 (Ia, Ib, II, III, IV, and V) are the most frequent serotypes associated with invasive disease and 364 the clone GBS III/ST17, associated with GBS meningitis (Pellegrini et al., 2022). 365 Kayansamruaj et al. (2019). In a longitudinal study conducted in Thailand and Vietnam the 366 comparison between 21 sequenced GBS genomes by phylogenetic analysis revealed a 367 correlation between the genomes of species isolated from fish and those causing neonatal 368 meningitis in both countries (Kayansamruaj et al., 2019). Barkham et al (Barkham et al., 369 2019) reported that GBS ST283 strains isolated from diseased fishes in Thailand were closely

related to the GBS ST28 strain causing human invasive disease in Singapore (Kayansamruaj
et al., 2019). The above-mentioned studies strongly underline the role of both bovines and
fishes as reservoirs of virulent GBS strains and their contribution to human invasive disease.
They further suggest that a subset of the meningitis cases occurring worldwide might likely
have a foodborne origin.

V. Antimicrobial resistance and extra-intestinal foodborne diseases

Antimicrobial resistance (AMR) is one of the greatest health threats of the 21st century. 376 377 According to the Global Research on Antimicrobial Resistance Project (GRAM) report, 378 antibiotic-resistant bacterial infections were associated with nearly 5 million deaths and were 379 directly responsible for 1.27 million deaths globally, in 2019 (Murray et al., 2022). The global 380 increasing rate of AMR is alarming, and the world is making a day-to-day step into a post-381 antibiotic era. The use of antimicrobials in food animal production as growth promoters, for 382 metaphylactic or prophylactic purposes is further exacerbating this concern (Tiseo et al., 383 2020). Moreover, the global use of antibiotics in food animal production in 2017 was 384 estimated to be 93,309 tonnes and it is expected to rise to 104,079 tonnes by 2030 (Tiseo et 385 al., 2020). More worrisome is that 73% of all sales of antibiotics worldwide including those of 386 clinical importance are for use in the food producing industry (Van Boeckel et al., 2019). 387 Antibiotic use in food-animal production is reportedly known to trigger a selection pressure 388 leading to the rapid emergence and spread of antibiotic-resistant bacteria (ARB) and 389 antibiotic-resistant genes (ARGs) at the animal-human-environment interfaces (Founou et al., 390 2021). AMR is a quintessential One Health issue needing urgent global and multifaceted 391 actions for its containment.

392 It is well known that AMR reduces therapeutic choices, thus causing difficult-to-treat 393 infections or increasing mortality rates (Murray et al., 2022). There is a reported increase in 394 the prevalence of antimicrobial resistance in virulent E. coli, especially E. coli ST131 ExPEC 395 strains isolated from food animals and humans (Singer, 2015). The study conducted by Liu et 396 al. (2018) on E. coli ST131-H22 previously discussed above showed a high level of multidrug 397 resistance (80% for animal sources and 33% for human sources), with some isolates 398 harbouring mobile colistin resistance (mcr) gene (Liu et al., 2018). Resistance to the last 399 resort antibiotic drug, colistin, is of particular concern as resistant bacteria can disseminate 400 from animals to humans (Liu et al., 2018), resulting in difficult-to-treat extra-intestinal 401 diseases with restricted treatment options and associated higher mortality rates.

402 VI. The global significance of extra-intestinal foodborne diseases

403 EIFBD are important threats that should be considered as part of FBD surveillance systems. 404 The pathogen that typically displays the significance of EIFBD are ExPEC group, which 405 causes numerous human health infections globally with both economic and social costs 406 (Manges et al., 2019). Nevertheless, the clinical and socioeconomic impact of ExPEC 407 infections, especially regarding increasing AMR, is underappreciated and neglected (Manges 408 et al., 2019). Extraintestinal pathogenic Escherichia coli have been linked with several 409 environmental reservoirs and transmission routes. One of the major challenges in recognising 410 EIFBD and ExPEC infections as a public health threat is the absence of routine molecular 411 investigation or genomics studies (Manges et al., 2019). In the absence of large-scale, routine, 412 public health reporting, or surveillance systems that consider the One Health compartments, it 413 is not possible to capture information on circulating lineages nor to provide a complete 414 snapshot of the genomic evolution, transmission dynamics, and lineages of ExPEC and other 415 pathogens causing EIFBD.

416 Most of the large-scale genomic studies of ExPEC have been conducted in high income 417 countries of Europe and North America (Manges et al., 2019) revealing the necessity of 418 conducting more studies worldwide, particularly in low-and middle-income countries 419 (LMICs). Thus, data from Asia, Africa and Latin America are scarce despite recent efforts to 420 improve regional capacity to perform genomic analyses, but they are still very expensive for 421 these countries. Understanding the genomic epidemiology of key circulating lineages in these 422 regions is important in order to decipher the transmission routes of foodborne pathogens, 423 predict their likely public health implication, to implement sustainable infection prevention 424 and control (IPC) measures nationally, regionally, and internationally. The importance of 425 these studies was clearly shown by a study conducted in Yucatan, Mexico, which revealed a 426 phenotypic (identical drug resistance profiles) and genetical relatedness by PFGE between 427 NTS isolated from human clinical cases, asymptomatic children of Salmonella, suggesting 428 that dissemination through the food chain occurs (Zaidi et al., 2006).

429 Another important challenge to recognize the significance of EIFBD is the distinction 430 between commensal and pathogenic lineages (Riley, 2020). The high resolution provided by 431 whole-genome sequencing can allow the detection and appreciation of the wide variety of 432 extra-intestinal illnesses caused by foodborne bacteria. However, even when genomic data are 433 available, it is still challenging to clearly define some ExPEC strains and estimate their 434 disease burden as there are no exclusive ExPEC-defining genes as most of these genes are 435 shared with commensal lineages (Sarowska et al., 2019). The global food production and 436 distribution systems coupled with the increasing antimicrobial resistance likely contribute to

higher incidence and associated mortality due to EIFBD (Riley, 2020). In this era marked by
globalization of trade and humans as well as global population growth, it is important to
acknowledge extra-intestinal foodborne bacteria including ExPEC as overlooked "killers", yet

440 potentially important endemic issues especially in LMICs (Russo & Johnson, 2003).

441 Additionally, the role of certain bacterial lineages in the global spread of AMR and antibiotic 442 resistance genes has not been fully established, nor has the overall contribution of resistant 443 EIFBD to the global burden of FBD. Extraintestinal foodborne diseases have traditionally not 444 retained a level of attention commensurate with their contribution to morbidity, mortality, and 445 socioeconomic costs in the past, likely because causative bacteria were highly antibiotic 446 susceptible, consequently, easily eradicated with first-line antibiotic therapy (Ventola, 2015). 447 Unfortunately, the global dissemination of antibiotic-resistant and of highly virulent 448 pathogens has recently changed this paradigm. A retrospective study performed in the USA 449 assessing AMR in E. coli isolated from humans and food animals including pigs, chickens, 450 and cattle revealed an exponential increase in drug resistance over a 42 years-period (1950-451 2002) (Tadesse et al., 2012). Out of the 1,729 E. coli isolates tested against 15 antibiotics 452 during this period, a statistically significant (<0.001) upward trend in resistance was seen for 453 ampicillin, sulfamethoxazole, and tetracycline (Tadesse et al., 2012). Likewise, animal strains 454 displayed increased resistance to 11/15 antibiotics including gentamicin, sulphonamide, and 455 ampicillin. The authors further revealed that the level of multidrug resistance (resistance to 456 three or more classes of antibiotics) increased from 7.2% in 1950 to 63.6% during the 2000s 457 (Tadesse et al., 2012). Furthermore, strains from the ExPEC group have the notorious 458 distinction of harbouring new emerging antibiotic resistance genes (Manges et al., 2019). The 459 WHO estimated that the global burden of FBD due to foodborne bacteria, viruses, and 460 protozoa, particularly NTS and EPEC, caused nearly 600 million cases of infections, 200,000 461 cases of deaths, and these were attributed to 16 million disability adjusted life years (DALYs) 462 in 2010 (WHO, 2015). This burden would be exacerbated by the inclusion of EIFBD. 463 Hundreds of thousands of lives, millions of workdays, and billions of healthcare dollars, are 464 lost every year due to EIFBD (Russo & Johnson, 2003). New treatment and prevention 465 measures for EIFBD are needed to improve outcomes whilst reducing global EIFBD burdens. 466 Vaccine development and deployment strategies targeting foodborne bacteria could also be 467 suboptimal if EIFBD are not considered in population structure and transmission dynamic 468 studies.

469 **Conclusion**

470 Bacterial FBD is a global public health issue with multiple clinical and socioeconomic 471 implications, including escalating AMR. This review focuses on the contribution of EIFBD to 472 the global burden of FBD. It argues that recognizing EIFBD as an integral part of FBD is 473 critical to assessing the true burden of FBD. It also emphasized the instrumental role of 474 genomic and phenotypic (drug-resistance profiles) studies, since several studies have shown 475 genetic relatedness is accompanied by similar drug resistance profiles. Therefore, together the 476 genotypic and phenotypic characterization of isolates from clinical cases and food sources 477 will be pivotal to understanding, detecting, preventing, and containing FBD, and in designing 478 tailored interventions. It further underscores that identifying the transmission routes, the 479 genomic structure, the virulence profiles, and the evolution of the principal circulating 480 lineages, especially in underrepresented regions of Asia and Africa, is of paramount 481 importance to fully assess the contribution of EIFBD to the global burden of FBD. An 482 integrated strategy considering the One Health approach is requisite if we are to address FBD 483 and ensure food safety and security globally.
