Similarly, the research conducted by Pantovic et al. introduces an innovative approach to improving the robustness of CT scan analyses. By integrating synthetically generated data that simulates metal artifacts into the training process, their model demonstrates enhanced capability in accurately identifying crucial surgical landmarks, such as intracranial electrodes. This methodological advancement signifies a crucial step towards overcoming the limitations posed by artifact interference in clinical imaging, paving the way for more reliable surgical planning and outcomes.

These studies collectively signal a growing recognition of synthetic data as a powerful tool in the field of medical imaging and neurosurgery. By simulating deformation trajectories, their approach provides a robust framework for planning and executing neurosurgical procedures, significantly reducing the dependency on immediate intraoperative imaging and the logistical challenges it entails.

Their advocacy for the creation of national synthetic data repositories speaks to the transformative impact such a resource could have on facilitating research across institutional boundaries, eliminating traditional barriers to data sharing.

Concurrently, Khalaf et al. (2023) address a critical aspect of synthetic data generation—the representation of rare subpopulations. Their work acknowledges existing limitations in this area but also highlights the dynamic nature of synthetic data methodologies, which can evolve to incorporate new findings and insights from a broad spectrum of literature. This adaptability ensures that synthetic data can remain a relevant and powerful tool for neurosurgical research, particularly in studies that require nuanced understandings of less common conditions or patient demographics.

The contributions of these studies lay the groundwork for a new paradigm in neurosurgical research, one that leverages synthetic data to bridge the divide between the need for comprehensive, heterogeneous datasets and the imperatives of ethical data use. 3.7 Augmenting visualization with expected appearances

By providing surgeons with a more accurate representation of the operative field, these synthetic visual aids significantly bolster the reliability of intraoperative navigation, ensuring that surgical interventions are both safe and effective.

The implications of this technology extend beyond the immediate enhancement of surgical precision. By improving the fidelity of intraoperative visualization, synthetic data-based frameworks like that of Haouchine et al. (2023) contribute to a broader sense of assurance among surgical teams. This confidence is critical during complex or high-risk procedures, where the margin for error is minimal, and the consequences of inaccuracies can be significant. Moreover, the ability to accurately predict and visualize surgical outcomes facilitates more informed decision-making in the operating room, potentially reducing the incidence of complications and improving patient outcomes.

Moreover, the application of synthetic data in this context emerges as a crucial enabler, allowing for the refinement of models to a degree previously unattainable. It facilitates a deeper understanding of tissue dynamics and deformation patterns, thereby improving the model's predictive capabilities. However, the call for broader validation studies highlights the need for further exploration into the generalizability of these models across varied surgical scenarios and anatomical conditions. Addressing these challenges will require a concerted effort to assess the robustness of these integrative approaches against the backdrop of tissue heterogeneity and the complex rheological properties of brain tissue.

3.9 Mixed reality surgical rehearsal

The advent of patient-specific rehearsal practices has markedly improved the landscape of preoperative planning and training in neurosurgery. Such rehearsals are crucial for refining surgical techniques and enhancing patient safety, yet the reliance on traditional methods like cadaveric simulations has been fraught with challenges, including high costs, limited availability, and a lack of repeatability and realism. In response to these challenges, recent innovations have leveraged mixed reality technologies and synthetic data to create immersive, high-fidelity virtual environments for surgical training.

A notable advancement in this domain is the development of mixed reality models by Coelho et al., which exemplify the potential of combining holographic visualizations with 3D-printed components. These models are tailored to patient-specific anatomies, offering a realistic platform for device manipulation and scenario rehearsal. By integrating digital visualizations with physical components that mimic tissue haptics, this approach facilitates a comprehensive training experience that closely mirrors the complexities of actual surgical procedures. The authors demonstrate that such mixed reality simulations can significantly enhance trainee performance, providing a more effective and engaging learning experience compared to traditional training methods.

The success of these mixed reality simulations lies in their ability to synthesize the benefits of digital efficiency with the tactile feedback of real-world interactions. This hybrid model ensures that trainees can practice surgical techniques in a controlled, repeatable environment without the logistical burdens and ethical concerns associated with cadaveric specimens. Moreover, the use of synthetic data within these simulations allows for a wide range of scenarios to be replicated, from routine procedures to rare

and complex cases, thus broadening the scope of surgical education.

Despite the promising outcomes associated with mixed reality surgical rehearsal, the need for ongoing refinement, particularly in enhancing dynamic feedback mechanisms, remains. Addressing these areas of improvement will further optimize the realism and educational value of these simulations, ensuring that they can accurately replicate the nuances of surgical interventions.

3.10 Patient-specific rehearsal with 3D printing

Neurosurgical interventions demand a precise understanding of patient-specific anatomies, often too complex to be fully grasped through two-dimensional imaging alone. Addressing this challenge, recent technological advancements have harnessed the power of synthetic data to create detailed 3D-printed models that replicate the unique anatomical features of individual patients. These models serve as a bridge between theoretical knowledge and practical application, offering a tangible means for surgeons to rehearse and refine their techniques on patient-specific anatomies before actual surgery.

A pioneering example of this application is the work of Licci et al., who have developed reusable phantom heads designed to simulate various brain tumor scenarios. These models incorporate interchangeable parts that mimic the physical properties of tumors, including texture variations that are customizable to match the specific imaging characteristics of patient cases. By utilizing a comprehensive dataset to inform the variability in tumor presentation, the models achieve a balance between realism and variability, thereby enhancing the educational value of surgical rehearsals.

The introduction of these 3D-printed models into surgical training programs has been met with positive feedback from trainees, who particularly value the opportunity to practice navigating complex cranial structures through transparent access corridors designed into the phantoms. This aspect of the training aids in building confidence and competence in handling a range of surgical scenarios, from routine to highly complex interventions.

The significance of this innovation extends beyond the immediate benefits of enhanced surgical training. By providing a means to visualize and interact with patient-specific anatomies in a controlled setting, 3D-printed models augmented with synthetic data offer a unique opportunity to anticipate and strategize around potential challenges that may arise during actual surgical procedures. This preparatory tool is invaluable in improving surgical outcomes, reducing operative times, and enhancing patient safety.

3.11 Validating training models and metrics

The quest for effective neurosurgical training methodologies increasingly turns towards simulationbased environments, which promise a risk-free setting for developing and honing surgical skills. Central to the utility of these simulations is the establishment of reliable metrics that can accurately measure a trainee's competence, predicting their ability to translate simulated practice into real-world surgical success. The challenge lies in validating these metrics against actual surgical outcomes, a task complicated by the intricate nature of neurosurgical procedures and the ethical implications of direct experimentation on patients.

Innovative research, such as the work conducted by Ahmed et al., showcases the potential of synthetic simulators to bridge this gap. By employing a synthetic aneurysm model for aneurysm clipping rehearsals, the study evaluates the validity of simulation metrics across different levels of surgical expertise. Through detailed motion analytics, significant differences in performance metrics are identified

among novice, intermediate, and expert surgeons, underscoring the simulator's ability to distinguish between varying levels of skill. This differentiation is crucial for the development of a competency-based training framework that can reliably predict a surgeon's readiness for real-life procedures.

Moreover, the findings from such studies underscore the importance of continuous innovation in simulation technology, particularly in the materials and methods used to replicate the physical and physiological characteristics of human anatomy. By enhancing the realism and biofidelity of synthetic models, training simulations can provide even more accurate assessments of surgical skill, further closing the gap between simulated practice and actual operative performance.

The implications of this research extend beyond the validation of training metrics; they also highlight the potential of synthetic simulators as a platform for developing advanced assessment protocols. These protocols could revolutionize how surgical competency is measured and certified, shifting towards a more objective and quantifiable standard that directly correlates with patient outcomes.

3.12 Other applications

The assimilation of synthetic data and artificial intelligence (AI) into neurosurgery heralds a pivotal shift, poised to redefine conventional methodologies spanning from preoperative strategizing to post-operative management. This systematic review amalgamates insights from a curated collection of studies, shedding light on the expanding influence of these innovations in neurosurgical progress, and accentuating their multifaceted impact on the discipline.

In the domain of surgical planning and execution, the pioneering application of synthetic data in assessing optical flow methods, as delineated by Markus Philipp et al. (2021), signifies a substantial advancement. Their endeavors, focused on synthesizing neurosurgical microscope imagery, highlight the indispensable role of synthetic data in algorithmic evaluation and benchmarking. This methodology not only replicates the intricacies of actual neurosurgical settings but also facilitates a detailed assessment of optical flow algorithms, with PWC-Net demonstrating superiority over the Farneback method. Such progress indicates a route towards refining computational instruments, potentially elevating intraoperative precision and impacting patient safety and surgical results positively.

Concurrently, the synergy of AI and connectomics in neurosurgery, explored by Antonio Di Ieva et al. (2021), unveils the potential of deep learning models in transforming brain tumor surgeries. Achieving remarkable accuracy in tumor segmentation and genetic subtype discernment, this integration furthers personalized treatment approaches, thereby significantly enhancing surgical planning accuracy and aligning with the overarching aim of customizing interventions to match individual patient needs, a cornerstone of the precision medicine approach in neurosurgery.

Moreover, the comparative study of synthetic versus autologous dura mater in pediatric neurosurgery by Emir Kaan İzci et al. (2023) offers a discerning view on material selection and its repercussions on postoperative outcomes. This analysis underscores the critical need for judicious material choice, advocating for synthetic data's utility in guiding clinical decision-making and potentially steering innovations in surgical materials to bolster patient results.

Additionally, the foray into synthetic learning for spine surgery by Ethan Schonfeld and Anand Veeravagu (2023) tackles the challenge posed by the scarcity of extensive datasets, attributed to privacy and data sharing restrictions. The creation of SpineGAN for synthetic radiograph generation exemplifies how synthetic data can surmount traditional hindrances, promoting enhanced model training while safeguarding patient confidentiality, indicative of a wider trend towards ethical medical research enhancement through synthetic data and AI.

Lastly, advancements in intraoperative registration techniques by Nazim Haouchine et al. (2023), through the use of AI in synthesizing preoperative expected appearances, mark a significant stride in surgical navigation. This methodological innovation, by bolstering the alignment accuracy between preoperative MRI and intraoperative visuals, not only refines neurosurgical navigation fidelity but also pioneers the integration of AI solutions into real-time surgical procedures, heralding improved patient care standards and safety.

4 Discussion

4.1 Summary of evidence

The systematic review explores the critical role of data in the evolution of neurosurgery, highlighting the innovative applications of synthetic data throughout the surgical process, from preoperative planning to postoperative care. The shift towards personalized medicine is exemplified through the use of patient-specific anatomical models and predictive analytics, enabling surgeons to devise tailored surgical interventions. Intraoperative navigation systems, leveraging multimodal imaging and biomechanical models, provide real-time guidance, improving surgical accuracy and safety by accounting for anatomical shifts during operations. In the postoperative phase, data analytics play a pivotal role in shaping individual recovery plans, signifying a move towards a more data-centric approach in patient management.

The review acknowledges the challenges posed by the limited availability and variable quality of clinical data, presenting synthetic data generation and simulation as viable solutions. Synthetic data stands out for its capacity to mimic real-world data's statistical properties, offering a flexible resource that supports research, training, and the enhancement of surgical procedures, unfettered by the limitations of conventional data sources.

Prominent research, including works by Lindner et al. (2019), Pantovic et al. (2022), Han et al. (2022), and Morin et al., demonstrates the effectiveness of synthetic data in addressing specific neurosurgical challenges—from refining CT scan analysis to improving surgical planning with sophisticated modeling techniques. The utility of synthetic data in generating real-world evidence for retrospective studies and epidemiological research, as shown by Khalaf et al. (2023) and Greenberg et al. (2022), highlights its capacity to reconcile the demand for extensive data with privacy considerations.

Furthermore, the application of synthetic data in surgical assistance and planning, notably through the generation of synthetic CT scans for neuronavigation and the enhancement of surgical visualizations, marks a significant advancement. Innovations such as mixed reality surgical rehearsals and 3D-printed models for patient-specific practice underscore synthetic data's contribution to elevating surgical training and preparation.

Yet, translating these theoretical models into practical applications presents hurdles, such as achieving a balance between the realism and diversity in synthetic data and integrating these technologies into clinical practice. Overcoming these obstacles will require continuous improvement, cross-disciplinary collaboration, and a nuanced approach to ensure the successful integration of synthetic data applications that are both technologically sophisticated and clinically applicable.

4.2 Future directions for research

The burgeoning field of synthetic data science offers promising avenues for revolutionizing neurosurgical practices, touching every aspect of the data value chain—from patient-specific planning to global health trend analysis. While current endeavors have shown significant promise through experimental studies within specialized centers, the broader application of these technologies necessitates a concerted push towards practical, applied uses that directly benefit patient outcomes and public health at large.

A pivotal step in this journey is the development of decentralized, yet responsibly managed, data repositories. As suggested by Pandit et al., such frameworks could vastly improve the scope and quality of analytics at a national level, uncovering population health trends that inform strategic policymaking and resource allocation. However, realizing this potential hinges on overcoming the cultural inertia that currently pervades medical data practices. This calls for a paradigm shift in how medical data is accredited, managed, and utilized, emphasizing skills development and the adoption of new technologies.

Central to achieving this vision is the establishment of data cooperatives, interconnected through standardized APIs, fostering a culture of continuous improvement and collaboration among a wide range of stakeholders. By credentialing these cooperatives, the neurosurgical community can ensure a steady flow of high-quality, standardized data, fueling innovations that directly address patient needs and healthcare challenges.

Moreover, adopting a more inclusive approach to development is crucial for ensuring that the benefits of synthetic data reach all corners of the globe. By amplifying the voices of marginalized communities and incorporating diverse perspectives into the development process, the neurosurgical field can create more representative and effective simulation models. This inclusivity extends to the pooling of learning resources and the propagation of analytics tools that are both locally relevant and globally applicable, ensuring that advancements in synthetic data science translate into tangible improvements in patient care.

4.3 Integration into clinical workflows

The potential of synthetic data to revolutionize neurosurgical practices through high-fidelity simulations and patient-specific planning is increasingly evident. Experimental validations have showcased the capability of these data paradigms to overcome the constraints posed by traditional data sources, offering a glimpse into a future of more informed and accurate surgical interventions. However, the leap from theoretical feasibility to routine clinical application is fraught with hurdles, primarily revolving around the seamless integration of synthetic data technologies into existing neurosurgical workflows.

Illustrative of these challenges are the observations by Haouchine et al., who acknowledge that while their registration algorithms demonstrate promising utility in offline settings, incorporating these technologies into live, image-guided surgical navigation systems—complete with real-time data processing—remains unachieved. This discrepancy between experimental capability and practical usability underscores the necessity of adapting synthetic data tools to fit within the complex ecosystem of surgical hardware and software, ensuring that they enhance rather than disrupt the surgical process.

Similarly, the vision articulated by Greenberg et al. for creating national-scale, aggregated synthetic datasets capable of supporting multicenter trials hinges on the establishment of unified data standards and interoperability protocols. Such an undertaking necessitates not just technological innovation but also a concerted effort to harmonize data structures across diverse healthcare and research platforms, ensuring that synthetic data can be seamlessly integrated and utilized across various settings.

These examples highlight a critical gap in the current trajectory of synthetic data integration into neurosurgery: the need for a multidisciplinary approach that bridges computational science, engineering, and clinical practice. Effective translation of synthetic data technologies into clinical settings requires the active involvement of cross-functional teams dedicated to co-creating solutions that are not only technologically advanced but also attuned to the practical realities of surgical care. This collaborative model, rooted in the principles of Responsible Research and Innovation, is essential for developing tools that are both usable in real-world settings and capable of contributing meaningally to patient outcomes.

Addressing the integration challenge also calls for a reevaluation of existing clinical workflows, identifying opportunities to embed synthetic data tools in a manner that complements and enhances surgical planning and execution. By focusing on creating intuitive, user-friendly interfaces and ensuring compatibility with existing surgical equipment, synthetic data applications can become a natural extension of the neurosurgeon's toolkit.

4.4 Limitations and Challenges

The potential of synthetic data to revolutionize neurosurgical practice is immense, offering unprecedented opportunities for training, rehearsal, and research. Yet, as we delve deeper into its application, the intricacies of achieving an optimal balance between the realism of specific domain features and the diversity of surgical scenarios come to the forefront. A critical examination of existing models reveals areas where current synthetic data generation techniques fall short, particularly in capturing the full complexity of neurosurgical procedures.

For instance, the work by Staartjes et al. highlights a limitation within MRI-derived synthetic CT models, which accurately replicate anatomical shapes but fail to account for variations in bone density—a critical factor for surgical assessments involving drilling. This omission points to a gap in the models' ability to fully prepare surgeons for the tactile experiences encountered during actual procedures.

Similarly, Licci et al. have identified areas for improvement in the realism of tumor simulations within phantom heads, specifically regarding texture cues and the emulation of bleeding. These aspects are vital for accurately representing the heterogeneity of pathological conditions encountered in neuro-surgery. Enhancing these features would not only improve the educational value of such models but also their applicability in planning and rehearsing complex surgical interventions.

These examples underscore the nuanced challenge of designing synthetic data models that accurately reflect the wide range of variables inherent in neurosurgical procedures. The risk of overfitting models to specific scenarios or features—thereby limiting their utility in unfamiliar or varied surgical contexts—highlights the need for a comprehensive approach to synthetic data generation. This approach must incorporate a purpose-driven analysis of requirements, ensuring that models achieve a harmonious balance between case-specific detail and the broader distribution of features encountered across neurosurgical practices.

Addressing these challenges requires a concerted effort to refine synthetic data generation processes, integrating advanced generative techniques that can capture the complexity and variability of the neurosurgical field. By achieving this balance, synthetic data can fulfill its promise as a transformative tool in neurosurgery, enhancing training, planning, and execution of procedures with unprecedented precision and reliability.

From creating detailed simulations of tumor imagery for preoperative planning to facilitating mixed reality environments for surgical training, these innovations are setting new standards for precision and patient-specific care.

Central to the appeal of synthetic data is its ability to generate realistic, detailed proxies for various neurosurgical needs, significantly reducing reliance on real-world datasets, which are often limited in availability and scope. This capability is crucial for advancing neurosurgical practices, offering a rich resource for training, research, and procedural planning. For example, the initiatives by Greenberg et al. to establish national-scale synthetic hospital repositories exemplify the potential to democratize access to comprehensive data sets, enabling more inclusive research and development activities across the neurosurgery community.

These synthetic data solutions not only promise to enhance the accuracy and effectiveness of current neurosurgical protocols but also aim to streamline the integration of artificial intelligence into clinical workflows. By providing a consistent, readily available source of data for AI training, synthetic datasets facilitate the development of robust, deep learning algorithms capable of supporting a wide range of neurosurgical applications, from diagnostic assistance to personalized treatment planning.

However, the journey towards fully realizing the potential of synthetic data in neurosurgery is not without its challenges. Issues such as ensuring representation of rare subpopulations, harmonizing protocols across multiple centers, and seamlessly integrating synthetic data tools into clinical workflows necessitate ongoing refinement and collaboration. Addressing these concerns is essential for fostering the development of synthetic data applications that are not only technologically advanced but also clinically relevant and widely accessible.
