3 **Developing a Motherhood regret scale: An examination of reliability, validity, and association**
4 **with basic attributes**

16 **Abstract**

17 The first objective of this study was to develop a scale that measures the level of regret of becoming a mother among
18 women at various stages of motherhood (child age ranging from unborn to 29 years old) and examine its reliability and
19 validity. The second objective was to explore the effects of participants' basic attributes on the regret of becoming a
20 mother. The study recruited mothers who were pregnant (before birth), mothers of infants (age 0–1), young children
21 (age 2–6), primary school-aged children (age 7–12), and adolescents and young adults (age 13–29). In all, responses
22 from 462 participants (458 women, 4 others; mean age = 37.77 [$SD = 7.03$]; age range = 20–59) were analyzed. As a
23 result, the unidimensional nine-item scale showed an acceptable value for goodness of fit and high reliability ($\alpha = .96$).
24 In addition, we determined the cut-off score to categorize the regret group. Among the participants in the present study
25 ($N = 462$), 31 were classified as the regret group, and they represented the scores at the top 7%. Moreover, regarding the
26 association between the participants' basic attributes and level of regret, we found that “having many children” had a
27 significant negative effect on the predicted level of regret ($\beta = -.19, p < .001$) while “being a single mother” had a
28 significant positive effect ($\beta = .11, p < .05$). Based on these results, we discuss the structure of the scale that was
29 developed and the effect of a mother's attributes on the level of regret to provide insights on the attributes of
30 respondents classified into the regret group.

32 **Introduction**

33 The declining birthrate in Japanese society is becoming increasingly worse. The factors contributing to the declining
34 birthrate are many, including “changes in values toward marriage and giving birth,” “increase in the feeling of

35 responsibility and burden of parenting,” “late marriage, increase in the average age of childbirth, and increase in the
36 number of unmarried people,” and “financial anxiety related to securing funds to cover child-rearing costs” [1,2]. In
37 addition, psychological problems surrounding mothers are on the rise, such as mothers in the child-rearing period
38 becoming more vulnerable to isolation due to the increase in nuclear families brought by the rapid decline in birthrates,
39 the increase in undesired births, postpartum depression associated with parental anxiety, and maternity neurosis caused
40 by the responsibility and pressure of child-rearing [3-6]. Against such trends, the feeling of “regret of becoming a
41 mother” has received more attention in recent years [7].

42 **The regret of becoming a mother**

43 The “regret of becoming a mother” is defined as the inner feeling of regretting becoming a mother [7,8]. In general, the
44 term “regret” is used to indicate the feeling of disappointment over a choice that was not taken at a point in time
45 between the past and present. In contrast, the “regret of becoming a mother” is different on the point that it is an
46 emotional response expressed between the past and present, and the real and imagined [7]. Thus, in this study, we
47 define the “regret of becoming a mother” as the repentant emotional response that emerges between the reality of being
48 a mother and the imaged reality of not being a mother. In our interpretation, this emotional response is not only
49 recognized against the past, when the decision to become a mother was made, but potentially also in the present of
50 being a mother. Moreover, the term “becoming a mother” as we use it in this study refers to the reality of having a child
51 rather than the process of psychological preparation related to whether the mother herself has or does not have
52 awareness of being a mother.

53 Donath [7] reports that today, many women around the world live with this regret. In Japan, NHK [9] conducted a
54 survey with a wide range of mothers in their teens to their 70s; one in three people responded that “there has been a time
55 when they wished they had never become a mother” and that they were aware of their regrets and were worried, but
56 they “cannot talk about it (55%),” reflecting a social environment in which mothers cannot attain help. This suggests
57 that many mothers struggle with emotions that they cannot be open about in the current society and culture but are
58 striving to adapt to the role as mothers. Moreover, the hidden increase in the number of mothers in such a situation
59 contributes to the lack of opportunities to share ways to cope with feelings of regret and to the decline in the appeal of
60 becoming a mother, thus maintaining a vicious cycle that the leads to a low-birthrate society.

61 Therefore, it is necessary to focus on the feeling of “regret of becoming a mother” that is held by many mothers and
62 devise ways to support them. However, current studies on motherhood regret (hereafter, the field) have been limited to
63 sociological accounts of the existence and current situation of regretting mothers [8], and no study has addressed
64 motherhood regret from a clinical psychological perspective for psychological support. Moving forward, it is essential
65 that a support model be presented on how a regretting mother can psychologically and socially adapt to the role of being
66 a mother while having such feelings.

67 **Factors related to “regret of becoming a mother”**

68 To propose ways to support those experiencing regret of becoming a mother, it is necessary to understand what factors
69 are related to regret. Factors related to motherhood regret that can be inferred from previous studies include parenting
70 anxiety and stress. Matsumura et al. [10] report that the lack of time that a mother can spend on herself influences
71 parenting stress, leading to an increase in the burden of child-rearing. Additionally, Noguchi et al. [11] and Shimizu et

72 al. [12] report that children’s unreasonable behavior accompanied with the sense of not being able to control are
73 contributing parenting stressors. Conversely, studies reporting on the positive side of the topic at hand have shown that
74 having multiple people to talk to can reduce parenting anxiety among mothers of young children and that experiencing
75 growth as a parent and the growth of one’s child are factors that increase the sense of happiness in being a parent
76 [13,14]. From the above, it is predicted that the attributes of a mother influence the factors associated with motherhood
77 regret. Thus, it is necessary to examine such relationships broadly.

78 **Trends and issues in previous studies**

79 As mentioned above, trends in previous studies dealing with motherhood regret can be understood as those following a
80 sociological perspective and those following a psychological perspective. In the sociological school of thought, the
81 interest has been on pointing out the social pressure that inhibits people from expressing the regret of becoming a
82 mother and pursuing the creation of a society that is tolerant of the diversity of choices related to childbirth and of
83 mothers who reveal their regrets [7,8]. However, in Japan, only a few psychological studies have approached the issue
84 at hand from a psychological perspective, and it is not clear what factors are associated with the mothers’ regret. As a
85 next step, it is important to clarify the factors related to motherhood regret and examine how it is possible for a
86 regretting mother to adapt socially and psychologically as a mother while having a sense of regret.

87 We identify two problems in the current state of research. First, most of the research on mothers and child-rearing is
88 skewed toward studies targeting mothers of infants. Second, it is not possible to measure the degree of motherhood
89 regret because studies have only measured it by a singular method, such as asking “whether a person regrets [the
90 decision of becoming a mother] or not.” It is expected that a mother’s regret fluctuates along the child’s growth stages

91 and that such fluctuation has continuity. Moreover, it is necessary to measure regret as a matter of degree to examine
92 the factors associated with motherhood regret. Hence, it would be meaningful to develop a scale that can measure the
93 level of regret of becoming a mother by means of question items that target mothers at various child-rearing stages from
94 pregnancy to having adult children.

95 As such, the two objectives of this study are as follows. The first is to develop a scale that measures the level of regret
96 of becoming a mother among women at various stages of motherhood (child age ranging from unborn to 29 years old)
97 and examine its reliability and validity. The second is to explore the effects of participants' attributes on the regret of
98 becoming a mother.

100 **Methods**

101 **Procedures**

102 Data were collected in Japan. The participants were 482 mothers with children of various age groups: before birth,
103 infant (age 0–1), young children (age 2–6), elementary school age children (age 7–12) and adolescents and young adults
104 (age 13–29); of these participants, those with missing answers were excluded from the analysis. In regard to mothers of
105 children aged 15 or older, those who had a score of five or less on the level of memory recollection of the child-rearing
106 period were excluded, and participants with invalid responses to the manipulation check item [15] were excluded as
107 well. Thus, excluding 20 responses in all, responses from 462 participants (458 women and 4 others) were analyzed.
108 The mean age of the participants included in the analysis was 37.77 ($SD = 7.03$, $Range = 20–59$). Participants were
109 recruited using an online service provided by a major Japanese crowd sourcing service administered by Yahoo Japan

110 Corporation (<https://crowdsourcing.yahoo.co.jp/>). This online service matches crowdsourcing workers to requests from
111 clients. For the present study, we posted a Google Forms questionnaire for the purpose of psychological research in the
112 “survey” category of the online forum. The collection of responses was terminated when the number of respondents
113 reached 130 at each applicable time period or at the end of the posting period. We set the target number of responses so
114 that the sample size would be 50 or more for each applicable time period and exceed the minimum sample size (100 or
115 more responses for analysis) required by the analysis software used in this study: IBM SPSS Amos version 2 and IBM
116 SPSS Statistics version 22 [16,17]. Participants were provided with an electronic informed consent at the time of their
117 participation in the survey and were informed beforehand that they could leave the survey at any time. Consent was
118 obtained with the submission of the participant’s survey responses. Participants who responded to the survey received
119 55 Japanese yen (approximately 0.5 US dollars) per each submission through the online service. Responses were
120 collected between June 29, 2023 and July 5, 2023.

121 **Measures**

122 **Sociodemographic variables**

123 Respondents were asked to answer open-ended questions about gender and age, and this was followed by multiple
124 choice questions about the respondent’s attributes. Here, we asked questions that were the same as Donath [8] and that
125 focused on the children’s age group, the number of children, the age of the mother at the time of giving birth, whether
126 they are also a grandmother or not, nationality, religion, highest level of education attained, employment status, marital
127 status, whether they are a single parent, and gender identity. Then, respondents were asked to answer an open-ended
128 question about family composition (their children’s gender and birth order). These items were used to examine the
129 influence of a mother’s attribute on the degree of regret. Hence, to quantify each attribute item, we assigned numerical

130 values to each multiple-choice item in the order in which they were presented. For example, in the question about the
131 “child’s age group,” a higher number indicates that the respondent is a mother to a child in a higher age group. For most
132 or most items, we provided the answer option of “other” and assigned the value “0” to it. However, even if the answer is
133 “Other,” there are cases in which “0” is not assigned. In addition, to quantify the “employment status” item, we based
134 the scale on the degree of involvement in out-of-the-house labor and assigned a score of 1 to “housemaker,” 2 to
135 “seasonal part-time staff,” 3 to “student,” 4 to “contracted labor (fixed-term) ,” and “Temporary employment,” 5 to
136 “self-employed,” 6 to “long-term part-time employee,” and 7 to “full-time employee.” Occupations to which the
137 participant did not fall (e.g., internships) were not assigned a numerical value. All participants in the present survey
138 were Japanese nationals. Please refer to the support file for the scoring of these questions and variables ([S1 Data](#)).

139 **Measurement of the degree of regret of becoming a mother**

140 This is a scale item developed for this study. First, we referenced the interview conducted by Donath [8] and the
141 narrative about the feeling of regret experienced by people who regret becoming a mother to select the language for the
142 scale items. Then, we referenced Ueichi’s [18] Japanese translation of Washburn’s regret scale that measures regret
143 proneness in daily life to select and revise the items’ language so that they reflected the feeling of regret as a mother.
144 We revised and edited these with the help of two researchers and faculty who are certified public psychologists and
145 clinical psychologists, obtaining 23 items. This regret of becoming a mother scale is answered on a 5-point Likert-type
146 scale (*strongly disagree* = 1 to *strongly agree* = 5); the higher the score, the stronger the feeling of regret ([S1 File](#)).

147 **Screening of participants who regret becoming mothers**

148 This was the item used in Donath’s [8] interview study to select participants who regretted becoming mothers. In the
149 present study, we used this for the validity test and to define the cut-off value. Below, we explain the screening and

150 statistical procedures. Donath [7,8] used a two-step procedure for screening. As the first step in the present study, this
151 consisted of a maximum of four items; however, it first required a response to the following three questions: (1) do you
152 regret becoming a mother? (2) if you could go back in time and had the knowledge and experience you have today,
153 would you still choose to become a mother (reverse scoring)? (3) in your opinion, does being a mother have any
154 advantages (reverse scoring)? These were all dichotomous questions that were answered with a “Yes” or “No.”
155 As the second step, those who answered “Yes” to item (3) above, that is, those who responded that “being a mother has
156 advantages” were asked to answer an additional item: (4) in your opinion, do the advantages outweigh the
157 disadvantages (reverse scoring)? This was also a dichotomous question answered with a “Yes” or “No.” Based on the
158 responses to these screening items (responses to up to four items), participants were selected if they indicated “regret”
159 in their responses in three or more items. In the present study, we quantified “Yes” answers with a score of 2 and “No”
160 answers with a score of 1 and then processed the reverse scoring items. Next, following Donath’s [8] screening criteria,
161 statistical processing was performed so that a score of seven or above would identify the respondent as eligible for
162 participation. Respondents who had already passed the screening based on their answers to three items out of the four
163 were not directed to the fourth question. In this case, their answers were processed as indicating “regret” and quantified
164 accordingly to be reflected in their score.

165 **Measurement of regret propensity**

166 We used Ueichi’s [18,19] Japanese translation of Washburn’s regret scale. This scale was designed with the purpose of
167 measuring the extent to which one tends to experience regret [19]. It comprised one factor and 20 items that asked about
168 the degree of regret in daily life situations on a 5-point Likert-type scale (*disagree* = 1 to *agree* = 5); the higher the

169 score, the higher the propensity to experience regret. In this study, we used this for validity check and assumed that the
170 score of this item showed a positive correlation with the degree of regret of becoming a mother.

171 **Measurement of parenting happiness**

172 We used the short version of the Parenting Happiness Scale designed by Shimizu et al. [20], which measures the degree
173 of happiness gained from parenting among mothers of infant children. This scale comprised 13 items and three factors:
174 five items relating to the “joy in parenting” factor that measures the overall joy a mother experiences in day-to-day
175 parenting, four items relating to the “bond with children” factor that measures the feeling of relief a mother experiences
176 from the realization that the mother–child relationship is unshakable through events that occur between the child and
177 mother themselves or others, and four items relating to the “gratitude towards the husband” factor that measures
178 gratitude for the help with childcare obtained from the husband and others. Items about the happiness a mother
179 experiences in parenting were answered on a 5-point Likert-type scale (*disagree* = 1 to *agree* = 5); a higher score
180 indicated a higher level of happiness in parenting. In the present study, we used the total score of the three factors to
181 check for validity and assumed that the score of this scale showed a negative correlation with the degree of regret of
182 becoming a mother.

183 **Item to check the accuracy of recalled memory**

184 We used the parenting happiness scale short form designed by Shimizu et al. [20], which was developed specifically for
185 mothers of infant children. Therefore, participants whose children were aged 15 or older were instructed as follows to
186 check the accuracy of recalled memory. Specifically, the instruction message was “The previous questions included
187 items related the care of infants and young children, so please tell us how well you were able to recall those times” and
188 asked the respondent to answer on a 10-point Likert-type scale (*I could not recall at all* = 1 to *I could recall well* = 10).

189 Respondents who had a score of five or less in this check item were deemed as not having provided a valid response to
190 Shimizu et al.'s [20] scale and were excluded from the analysis.

191 **Measurement of views on motherhood**

192 We used Hanazawa's [21] Motherhood Concept Questionnaire, which asks about the ideals and values of and attitudes
193 toward motherhood. It comprises 27 items, including items that affirm motherhood (18 items), such as "Child-rearing is
194 a job that suits women well, so it is natural for women to do so" and "If you do not bear and raise a child, there is no
195 worth in being born a woman." It also contains items that reject motherhood (9 items), such as "It is better to not have
196 children to enjoy married life" and "It is wrong for mothers to make child-rearing their main reason for living."
197 Respondents were asked to answer their views on motherhood on a 5-point Likert-type scale (*strongly disagree* = 1 to
198 *strongly agree* = 5). For statistical processing, following Hanazawa [21,22], we reverse scored the reject items (9 items)
199 for quantification; thus, a higher score indicated a more positive view toward being a mother. We used this for validity
200 check and assumed that the score of this item has a negative correlation with the degree of regret of becoming a mother.

201 **Identifying bad respondents**

202 We used the Instructional Manipulation Check (IMC) designed by Masuda et al. [15], which is a questionnaire designed
203 to screen bad respondents who answer online surveys on the Internet without reading the instructions. The instruction
204 read, "In online surveys on the Internet, there is a problem of respondents who provide false answers or without reading
205 the questions. Therefore, we apologize for the inconvenience but allow us to verify if you have read this message. To
206 confirm that you have read and understood this message, please proceed without answering the following question (do
207 not select any option)." The respondent was asked to click "Next" without answering the question.

208 **Ethical consideration**

209 Consent to the survey and confirmation of consent was done by responding to an online form (Google Form). After
210 explaining the purpose of the study in the first section of the survey, participants were informed that participation was
211 voluntary, that the survey was anonymous, and that personal information would not be disclosed to any third parties.
212 The survey form was designed so that only participants who agreed to these informed consents could participate in the
213 study. thus, consent for participation was considered obtained from respondents once they had completed and submitted
214 their answers. Response records are designed so that individuals cannot be identified for any reason. However, it is
215 possible to print only the record of consent to the research if necessary. This study was approved by the Tohoku
216 University Graduate School of Education's ethics committee (Approval 23-1-006).

217 **Data analysis**

218 The analysis was performed using the statistical software IBM SPSS AMOS version 22 and IBM SPSS Statistics
219 version 22. First, we conducted a factor analysis of the motherhood regret scale and a correlation analysis to examine its
220 reliability and validity. Next, we defined the cut-off value to apply to the motherhood regret scale using the index of the
221 completed scale and the index of Donath's [8] screening items. Finally, we performed a multiple regression analysis to
222 examine the effect of the participants' attributes on the degree of regret of becoming a mother.

223 Below, we explain the factor analysis. This scale was assumed to represent one factor. Thus, we conducted a single
224 factor confirmatory factor analysis (CFA) to select the items. Here, we used oblique rotation and maximum likelihood
225 extraction. To verify the goodness-of-fit, we analyzed the goodness-of-fit index (GFI), the adjusted goodness-of-fit
226 index (AGFI), the comparative fitting index (CFI), and the root-mean-square approximation error (RMSEA). The cut-

227 off values for acceptable model fit used in this study are as follows: GFI > .90 as acceptable fit, > .95 as good fit, AGFI
228 > .90 as acceptable fit, > .95 as good fit, CFI > .90 as acceptable fit, > .95 as good fit, RMSEA < .10 as acceptable fit,
229 and < .06 as good fit. In the case of insufficient goodness-of-fit, it was assumed that the error correlation was related to
230 the modification index (MI), which indicates the expected change in parameters when a particular specification is
231 included in the model. In other words, in this study, we interpreted that in a model that measures a single concept, when
232 a model specification that causes a high correlation between items occurs, this is reflected in the value of MI. Therefore,
233 when the degree of fit was insufficient, the analysis was performed based on the MI.

234 Next, to assess reliability, we calculated the Cronbach's Alpha Coefficient (α). We followed Oshio's [23] standards and
235 defined an alpha coefficient of $\alpha > .70$ as acceptable internal consistency reliability and $\alpha > .80$ as a high internal
236 consistency reliability.

237 To assess validity, we calculated Pearson's correlation coefficient between the motherhood regret scale parameters and
238 the parameters of other scales. We followed the standards set by Cohen [24] to assess validity and interpreted a
239 coefficient of $r = \pm .50$ as strong, $r = \pm .30$ as medium, and $r = \pm .10$ as weak.

240 Then, we considered the cut-off value to apply in the scale being developed here. We calculated the average score of the
241 motherhood regret scale of screened participants in Donath's [8] study. We expected a difference between the
242 proportions of screened regretful participants in Donath's [8] study and those of the participants who met the cut-off
243 value set for the present scale. Thus, instead of using the minimum score in our motherhood regret scale of Donath's
244 screened participants, we decided to calculate their average score and use this as the feasible cut-off value. Moreover,
245 the NHK study reported that around 30% of mothers had experienced regret [9]; therefore, we considered the proportion
246 of mothers who met the cut-off value for each motherhood stage group.

247 Finally, to examine the effect of the participant’s attributes on the degree of regret of becoming a mother, we performed
 248 multiple regression analysis, in which each attribute item was an independent variable and the degree of regret for
 249 becoming a mother was the dependent variable. The stepwise method was adopted as the analysis method because it has
 250 the characteristic of specifying only the independent variables that show a significant explanation rate for the dependent
 251 variable from among many variables. We assessed multicollinearity following Koshio [23] and confirmed that the
 252 variance inflation factor (VIF) was less than 10.

253

254 Results

255 Transforming variables into scores and assessing reliability and 256 validity

257 Table 1 shows the correlation between the basic statistics for each variable measured and the scale.

259 Degree of regret of becoming a mother

260 This is a scale item created for this study. Based on the confirmatory factor analysis and validity test, this scale
 261 comprises one factor and nine items. Cronbach’s α was calculated to assess reliability, and an α coefficient of .96
 262 indicates high reliability as it sufficiently meets the criteria of $\alpha > .80$ of high internal consistency reliability.

263 Screening items for those who regret becoming mothers

264 This corresponds to the four items used in Donath’s [8] study to select mothers who experienced feelings of regret at the
 265 time of the interview. These were all “Yes” or “No” dichotomous questions and given a score of Yes = 2 and No = 1.

266 The α for the total score was .74, which met the $\alpha > .70$ criteria for acceptable internal consistency, and the reliability of
267 the scale was confirmed. We used this to assess the validity of the motherhood regret scale.

268 **Regret propensity**

269 This is a 20-item scale that measures the propensity of experiencing regret in daily life. The α for the total score was
270 .78, which met the $\alpha > .70$ criteria for acceptable internal consistency, and the reliability of the scale was confirmed. We
271 used this to assess its validity.

272 **Parenting happiness**

273 It is a 13-item scale that measures the degree of happiness that a mother experiences through parenting. The α for the
274 total score was .92, which met the $\alpha > .80$ criteria of sufficient internal consistency, and high reliability was confirmed.
275 We used this to assess the validity of the motherhood regret scale.

276 **View of motherhood**

277 It is a 27-item scale that measures the ideals and values of and attitudes toward motherhood through positive and
278 negative views of it. The α for the total score was .90, which met the $\alpha > .80$ criteria of sufficient internal consistency,
279 and high reliability was confirmed. We used this to assess the validity of the motherhood regret scale.

280 **Validity assessment**

281 We calculated the totals of the regret scale score, Donath's [8] screening items score, regret propensity score, parenting
282 happiness score, and view of motherhood score and calculated the correlation coefficients for each. The results show a
283 significant correlation at the 1% level between each of the variables (Table 1). Specifically, the results showed a
284 significant positive correlation between the degree of regret of becoming a mother and the screening item score ($r = .55$,
285 $p < .01$) and a positive correlation between the degree of regret of becoming a mother and regret propensity ($r = .30$, $p <$
286 $.01$). Furthermore, the degree of regret of becoming a mother had a significant negative correlation with parenting

287 happiness ($r = -.60, p < .01$) and a negative correlation with view on motherhood ($r = -.53, p < .01$); thus, the
288 motherhood regret scale was found to show sufficient validity.

289 **Factor structure of the motherhood regret scale**

290 We performed a one factor confirmatory factor analysis of the original 23-item motherhood regret scale. Table 2 shows
291 the model fit comparison (original 23 items; Table 2, Model 1). In the process of repeating factor analysis, we excluded
292 the items for which the factor loading did not reach .80. In addition, we hypothesized the relationships between items as
293 follows: a positive correlation between item 7 (“I feel being a mother is unbearable”) and item 8 (“if I could, I would
294 like to quit being a mother”), a negative correlation between item 9 (“I believe that I will never be happy as a mother”) and
295 item 16 (“I sacrificed myself to become a mother and this left a scar on me”), and a negative correlation between
296 item 10 (“I believe a life in which I do not become a mother would had been better”) and item 19 (“Becoming a mother
297 was an event that will continue to hurt me throughout my life”). Thus, by drawing a pass based on the modification
298 index, we were able to attain an acceptable degree of goodness-of-fit, and an acceptable degree of consistency was
299 confirmed ($\chi^2 = 111.69, p < .001, GFI = .95, AGFI = .91, CFI = .98, RMSEA = .09$ [90% CI = .07–.11]). Table 2 shows
300 the results of the final factory analysis (9 items after selection; Table 2, Model 2), and Fig 1 shows the model with the
301 acceptable degree of fit.

304 **Considerations for the cut-off value and proportion of participants**
 305 **classified into the regret group**

306 **Cut-off value**

307 We calculated the average motherhood regret score of the screened participants from Donath's [8] study and used this
 308 score as the cut-off value (Table 3). The average score of the screened participants ($N = 26$) was 30.38, and we set the
 309 cut-off value for our scale at 30. Therefore, we classified a score of 30 or higher out of a total possible score of 45 into
 310 the regret group and a score of 29 or less into the non-regret group. In the current study, 31 of the 462 participants (7%,

311 *Range* = 26–53) had a score that falls under the regret category. In contrast, 13 of the 26 screened participants in
312 Donath’s [8] study were classified into the regret group using our scale.

313 314 **Participants classified into the regret group**

315 The proportion of participants identified as the regret group was 7% (*N* = 31, *Range* = 26–53) of the total sample. The
316 breakdown (Top % of each stage, mother's age range) by motherhood stage is as follows. Among pregnant mothers,
317 seven out of 64 (11%, *Range* = 27–42), 3 out of 55 mothers of infants (5%, *Range* = 30–36), 11 out of 131 mothers of
318 young children (8%, *Range* = 26–42), 5 out of 133 mothers of elementary school age children (4%, *Range* = 35–41),
319 and 5 out of 79 mothers of adolescents and young adults (6%, *Range* = 30–53) were classified into the regret group (Fig
320 2).

323 **The influence of attributes on the regret of becoming a mother**

324 Table 4 shows the results of the multiple regression analysis (stepwise procedure) conducted to understand the
325 participants’ attributes and the influence of such attributes on the degree of regret of becoming a mother. In the analysis,
326 we defined the items for participants’ basic attributes as the independent variables and the degree of regret of becoming
327 a mother as the dependent variable. The variance inflation factor was below 10 for all, and multicollinearity was not
328 observed. The results showed that the attribute “having many children” had a significant negative correlation with the

- 329 estimated degree of regret of becoming a mother ($\beta = -.19, p < .001$) and “being a single mother” had a significant
- 330 positive correlation with the estimated degree of regret of becoming a mother ($\beta = .11, p < .05$).

332 Discussion

333 Designing a scale

334 The primary objective of this study was to develop a scale that measures the degree of regret of becoming a mother
335 among women at various stages of motherhood (child age ranging from unborn to 29 years old) and examine its
336 reliability and validity. Below, we discuss the factor structure, reliability and validity of the scale, and cut-off value
337 applied, as well as the characteristics of the item components. For the instrument's structure, we expected the scale to
338 be unidimensional and thus used a one factor confirmatory factor analysis. After the analysis, the original 23 items were
339 refined into 9, and the model showed acceptable fit indices and high reliability. As for validity, we confirmed sufficient
340 validity by verifying that the regret of becoming a mother scale had significant correlations with each scale as
341 hypothesized. Specifically, the results showed that a high degree of regret of becoming a mother is associated with high
342 propensity to experience regret in general in daily life, low happiness from parenting, and low levels of positive views
343 of motherhood. Therefore, it is presumed that those who regret becoming a mother tend to be more likely to experience
344 regret in other aspects of daily life other than motherhood and cannot have positive feelings about parenting and their
345 role as mothers.

346 Next, we explain the cut-off point of the scores. A widely used method to determine the cut-off point is the receiver
347 operating characteristic (ROC) curve analysis, which draws an ROC curve based on the reference value of the scale for
348 which the cut-off point is being determined (the scale being tested) and for other equivalent scales (the test scale). Then,
349 for observations that exceed the reference value in the test scale, the minimum value in the scale being tested is
350 calculated, and this is used as the discrimination threshold. On this point, it was expected that the variation in the scores

351 of Donath's [8] screening items would be large since it is not a statistically tested accurate scale. Hence, it was hard to
352 assume that the scores would be appropriate to set a cut-off value for our scale; in fact, the range of scores for the
353 present scale among Donath's [8] screened participants were wide ranging, from a minimum score of 16 out of 45 and a
354 maximum of 44 out of 45. Therefore, in the present study, we calculated the average score of Donath's [8] screened
355 participants and used this to set a cut-off value of 30. Participants who scored above this threshold represented 7% of
356 the total sample, which concurs with the proportion of people that reported regret (7%) in NHK's [9] report. Thus, it
357 was concluded that we had reached a reasonable cut-off value. In summary, we developed a scale that is
358 unidimensional, with nine items answered on a 5-point Likert-type scale, and with a cut-off value score (30 out of 45) to
359 categorize the regret group.

360 In terms of item content, we were able to design an item asking about the "regret of becoming a mother" that does not
361 depend on the children's age-specific events; therefore, we addressed the issue of skewed participant characteristics in
362 previous studies. The commonality among the items created allows to group them into "pressure of being a mother"
363 (items 7 and 8), "despair and hopelessness in being a mother" (items 9, 16, 12), and "negative emotions when
364 objectively recognizing the fact of being a mother" (items 10, 14, 15, 19). We suspect that such feelings are related to
365 the desire to escape from compliance with the socially expected role as a mother and a negative sense toward
366 motherhood itself. On the other hand, reflecting on the process that common item groups such as "negative feeling
367 towards the decision of becoming a mother" (item 1, 2, 4, 5, 6, 13) and "not being able to love my child" (item 11, 12,
368 20) resulted in being excluded, we suggest that the respondents held a negative view of themselves as mothers, but their
369 regret of the decision in the past is resolved, and the regret they hold is not associated with lack of love toward the child.

The influence of basic attributes on the degree of regret

A second objective of the study was to investigate the effects of participants' basic attributes on the regret of becoming a mother. Results of multiple regression analysis with each attribute item as the independent variable and the degree of regret of becoming a mother as the dependent variable showed that "having a large number of children" was a significant negative predictor of the mother's degree of regret, and "being a single mother" was a significant positive predictor of the mother's degree of regret. Therefore, the greater the number of children, the lower the mother's degree of regret, and being a single mother is associated with a higher degree of motherhood regret.

Based on the above result that a greater number of children is associated with a lower degree of regret, it can be argued that when a mother experiences less regret, she is more likely to decide to have another child. From this perspective, it is suggested that another factor leads to the absence of regret against the reality of being a mother. On the other hand, studies in Japan with child-rearing mothers report that as the number of children increases a mother's concern for not spending enough time with her children and being left with less time for herself [25]. At first glance, such reports suggest that a mother's regret will be higher due to the large number of children; however, the insights from the present study suggest that children bring some sort of positive effect, and overall, an association exists a greater number of children and a low degree of mother's regret. Here, considering studies that focus on the mothers' positive emotions, it is documented that one of the factors increasing parents' sense of happiness in parenting is when they feel their own growth as a parent or their children's growth [13]. Thus, it can be inferred that as the number of children increases, the opportunities to experience growth as a parent and joy from the process of parenting also increase, in turn leading to a

388 lower degree of regret. In the future, it will be meaningful to investigate what child-related factors are associated with a
389 low degree of mother's regret.

390 The results showing the association of being a single mother with a high degree of regret may be an indicator of the
391 harsh reality of a life as a single mother [26]. Nakasono [27] points out that 80% of single mothers are employed, but at
392 the same time, 50% live in poverty, and they are in a condition of being "working poor." Relatedly, Matsumura et al.
393 [10] suggest that the fact that mothers have less time to spend on themselves affects parenting stress and leads to an
394 increase in the burden of child-rearing. In this way, the present situation in which mothers spend most of their time in
395 the labor force, caring for the household, and attending to children has not changed much even after the pandemic and
396 its social effects [26-28]. Moreover, spouse participation in parenting increases mothers' sense of happiness and
397 decreases the burden from child-rearing [2,29]. Furthermore, mothers who build close relationships through
398 interpersonal interactions in the local community experience parenting as fun and thus a lower sense of burden, in
399 addition to showing satisfaction in their daily lives [25]. In summary, the reality is that single mothers have most of
400 their time taken by work, parenting, and other responsibilities as mothers; they have little time for themselves and are
401 missing the opportunity to participate in local community social spaces. Such a reality, in addition to not having the
402 support of a spouse, seems to be associated with high degrees of regret.

403 **Participants classified into the regret group**

404 Below, we consider the participants who were classified into the regret group and their motherhood stages. Among the
405 respondents classified into the regret group in the present scale ($N = 31$), of those who passed Donath's [8] screening (N
406 = 26), the majority ($N = 13$) scored below the cut-off value of 30 and were excluded from the regret group. In addition,

407 the NHK [9] report indicated that one in three (30%) mothers regretted becoming mothers, but our results show that the
408 proportion was 1 in 14 (7%); these differences could be explained by different methods of measurement. NHK's [9]
409 report asked participants whether regret had been "experienced at least once in the past," while our study asked about
410 "mother's regret recognized in the present." Thus, many have had regrets for becoming mothers in the past, but not
411 many mothers currently regret this. In other words, even if a mother had once felt regret, she acquired the means to
412 adapt to this regret over time and the skills to escape from regret and strive for the role of mother.

413 In addition, when examining the data by motherhood stage groups, the proportion of mothers belonging to the regret
414 group ($N = 31$) was the highest. The proportion decreased among mothers of infants and increased among mothers of
415 young children; subsequently, the proportion decreased among mothers of elementary school age children and increased
416 among mothers of adolescents and young adults. According to such trend, mothers' regret increases between children's
417 transition from infancy to early childhood and between elementary school age to adolescence/adulthood. What this
418 pattern shows is correspondence with the rebellious phases observed along the developmental stages of a child. In the
419 present study, early childhood is the first rebellious period, and adolescence/adulthood the second; these are periods
420 when a mother experiences changes in her sense of control in parenting. Studies examining sense of control among
421 mothers of infants have reported that children's unreasonable behavior is a factor that leads to parenting stress in
422 mothers [11] and that the sense of inability to control the children is an element that explains parenting stress in mothers
423 [12]. Therefore, it is suggested that changes in regret are related to a mother's own sense of control; in fact, during
424 pregnancy, the mother cannot control her own body in the same way she used to before the pregnancy due to the
425 changes in her body. When a child transitions from infancy to early childhood, they start moving around at their own
426 will and verbally expressing their will, making it hard to control their behavior.

427 Next, in the transition from childhood to adolescence/adulthood, the child becomes more independent psychologically,
428 and the relationship with the mother also changes. Therefore, a mother may experience regret during periods when a
429 change in the sense of control in respect to the mother's body, the child's behavior, and the psychological realm occurs.
430 However, since the present study is limited to the measurement of regret, we look forward to future studies examining
431 the factors related to changes in regret.

432 **Limitations of the study**

433 This study has several limitations. First, we should consider the sample. Although data were collected from a wide
434 range of people using the Internet, it is highly likely that the participants in our study had sufficient time to take part in
435 the survey and were in an emotionally stable condition to answer about the regret of being a mother. Future studies
436 should examine a wide range of factors related to living conditions, such as financial situation, weak ties to supportive
437 networks for performing the role as a mother, and being a single mother, and investigate how these factors influence the
438 regret of being a mother.

439 Next, only using the motherhood regret scale does not provide insights into the causes and factors related to regret. For
440 instance, the reasons and factors related to regret may be different for mothers who show the same score but are in
441 different stages of motherhood. In the future, it will be necessary to examine what factors constitute regret in each
442 motherhood stage.

443 Last, although we discussed our thoughts about the proportion of the regret group by each motherhood stage, since we
444 used cross-sectional data, it is not possible to examine how individuals progressed through the changes in regret. In the
445 future, it is recommended to collect and examine data longitudinally through such methods as case studies.

446

447 **Conclusion**

448 As stated above, this study was able to explain the factor composition, reliability, and validity of the “Motherhood
449 Regret Measurement Scale” despite its limitation. Moreover, it showed the relevance of the mother’s attribute on the
450 degree of regret. Our study is the first in Japan to focus on motherhood regret from the perspective of clinical
451 psychology and quantitatively demonstrate its relevance.

452 The body of research on family, parenting, and mothers’ mental health is growing. Against this backdrop, our study
453 contributes to a greater understanding, acceptance, and support of the regret that many mothers face by making it
454 possible to quantitatively measure its degree within a sociocultural context where support is often overlooked.

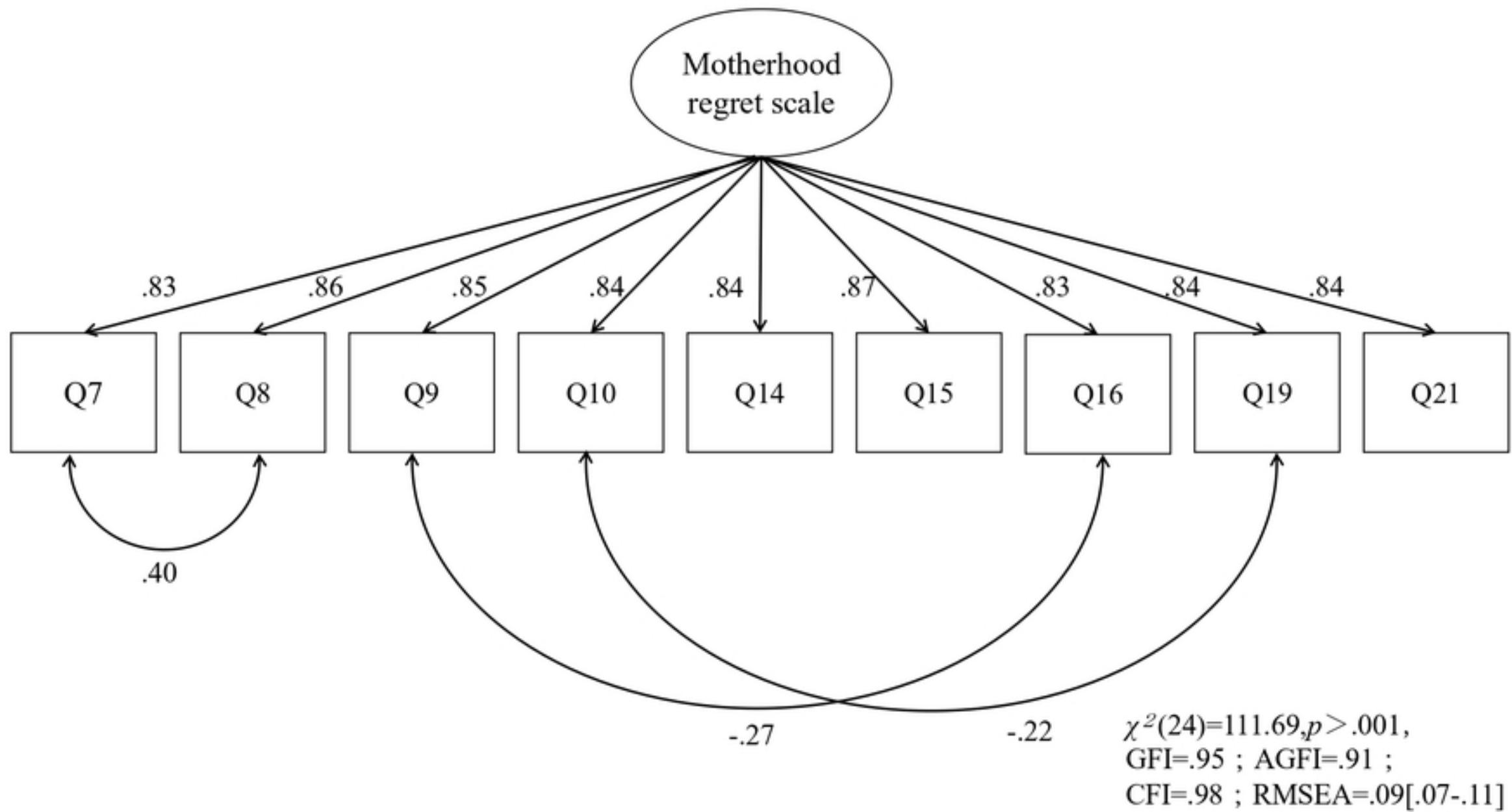
