Alcohol use and the pre-exposure prophylaxis continuum of care among men in rural South Africa

Abstract

Introduction

Despite freely available HIV pre-exposure prophylaxis (PrEP), HIV incidence among young men in South Africa is high. There is conflicting evidence around the association between alcohol use behaviors and PrEP utilization. We explore the impact of alcohol use on PrEP initiation and continuation among South African men.

Methods

We performed a secondary analysis of data from a trial that included men aged 16-29 randomly selected from a demographic surveillance site in KwaZulu-Natal. All participants were referred to HIV and sexual health services, where those who were HIV negative and sexually active were offered oral PrEP. Alcohol consumption was assessed at monthly visits and categorized as: non-drinking (0), low/moderate risk drinking (1-5), and high/very high-risk drinking (6-12) based on AUDIT-C criteria. Primary outcomes were PrEP initiation and PrEP continuation defined as refilling prescriptions for ≥3 months. We fitted logistic regression models, adjusted for potential clinical and demographic confounders, to estimate relationships between PrEP initiation/continuation and reported alcohol use.

Results

Of the 325 men in the analytic cohort, the average age was 22.9 years (SD 3.6) and 131 (40%) had high/very high-risk alcohol consumption (AUDIT-C score ≥6). Men with the highest risk alcohol use also reported more frequent condomless sex (89%, vs 68% in no alcohol group). We found the greatest uptake of PrEP among the high/very high-risk alcohol group (46/131, 35%), followed by the low/moderate-risk group (17/53, 32%) and the no alcohol group (25/141, 18%). Those with high-risk alcohol use remained more likely to initiate PrEP compared to the no alcohol group in multivariable models adjusted for confounders (aOR 2.44 95% CI 1.29-4.60; p-value 0.006). Overall, only 30% (26/88) of men remained on PrEP at 3 months. Men with high/very high-risk drinking had similar PrEP continuation at 3 months compared to men who reported no alcohol use (aOR 1.02 95% CI: 0.28-3.86, p=0.98).

Conclusions

High-risk alcohol use is common among men in rural South Africa and associated with increased PrEP initiation. However, PrEP continuation was low overall, and similar across all levels of alcohol use. Hazardous alcohol use should not discourage PrEP implementation efforts to engage and retain young men.

Introduction

South Africa continues to face one of the highest global burdens of HIV, with more than 8.45 million people living with the disease [1]. Notably, young men in the province of KwaZulu-Natal continue to experience the dual burden of HIV incidence and poor engagement with the HIV care cascade [2-5]. In attempts to mitigate transmission, various interventions such as male circumcision and treatment as prevention have been instituted [6, 7]. However, these methods have not led to the elimination of HIV in KwaZulu-Natal. This underscores the critical need for the development and implementation of more effective prevention strategies, including for young men.

Oral pre-exposure prophylaxis (PrEP) was approved in South Africa in 2016 and its implementation has seen over 880,000 individuals initiated on the regimen [8]. However, most PrEP implementation programs have focused on adolescent girls, young women, sex workers, and men who have sex with men, leaving a noticeable gap in access for heterosexual men [9-11]. Whereas men are now included in expanded PrEP access as part of the South African National Strategic Plan for HIV, TB, and STIs, their uptake of PrEP remains alarmingly low [12-15]. This gendered difference in PrEP uptake mirrors the broader gender disparity in healthcare engagement across Southern Africa [4, 16-18]. For example, in Eswatini men were nearly three times less likely to initiate PrEP than women [15]. Compared to women, men are less likely to engage in care, remain in care, and adhere to medical recommendations, with few men taking HIV preventive healthcare measures like PrEP [19]. Among heterosexual men, reasons for PrEP refusal include misperceptions about HIV as a curable disease, underestimation of personal risk, apprehensions about pill adherence, and stigma [14, 15].

Central to the questions surrounding PrEP utilization is the role of alcohol consumption. Alcohol is frequently used with other risky behaviors, heightening HIV transmission by impairing judgment and leading to unprotected intercourse, multiple sexual partners, and sex while under the influence [20, 21]. In South Africa, alcohol consumption is widely reported, particularly among men: the 2018 Global Status Report ranked South Africa as having one of the most concerning patterns of alcohol consumption, with the nation leading in reported use within Africa [22]. More than 70% of men who reported alcohol use engaged in heavy episodic drinking [22]. In various contexts, alcohol use has been found to be both a facilitator and barrier to PrEP utilization [21]. While some research suggests that men report alcohol use and condomless sex as motivators for seeking PrEP initiation [12, 21], others have found alcohol consumption might reduce the willingness to use PrEP [23]. In sub-Saharan Africa, female sex workers and those in serodiscordant relationships expressed concerns over the perceived toxic effects when mixing alcohol, often consumed before sexual activities, and PrEP [24]. Nonetheless, there is no evidence

to suggest significant interactions between alcohol and PrEP [25]. Individuals who drink alcohol may represent crucial targets for PrEP due to their association with risky sexual behaviors. However, the relationship between high-risk alcohol consumption and PrEP dynamics among men in South Africa remains largely unexplored.

In this study, we leveraged data from a longitudinal HIV prevention study in rural KwaZulu-Natal, South Africa to assess the interplay between alcohol consumption, PrEP initiation, and PrEP continuation among young men. We hypothesized that individuals who report high-risk alcohol use may be more likely to initiate PrEP, but less likely to continue the preventative therapy compared to individuals who report no or low risk alcohol use.

Methods

Study population and procedures

We analyzed data from the Isisekelo Sempilo study, which was an open-label 2x2 randomized factorial trial that was conducted from March 2020-August 2022 in South Africa. The study evaluated the effectiveness of various referral mechanisms for linkage to care for HIV prevention services [26]. In brief, participants included men and women aged 16-29 years in Africa Health Research Institute's Health and Demographic Surveillance Site (HDSS) in the uMkhanyakude district of KwaZulu-Natal [27]. The HDSS was used to randomly select 3000 participants, stratified by gender, from a primarily rural, economically disadvantaged, and high HIV prevalence region.

Potential participants were approached at their homes and invited to participate in the study. All enrolled participants, after being randomized to one of the four study arms, were provided with barcoded referral slips and an appointment to attend one of the youth friendly study clinics within the HDSS for HIV prevention and sexual reproductive health (SRH) services. The four arms of the study differed by referral pathways and included 1) the enhanced standard of care arm where participants attended one of the study clinics without additional referral pathways 2) the enhanced standard of care arm as above with peer navigator support [28] 3) home-based self-collection of samples for sexually transmitted infection (STI) testing with referral to study clinics to receive results and SRH services, and 4) combined peer navigator support and home-based STI specimen collection with referral to study clinics. All clinic attendees were offered HIV testing and SRH services, including education on PrEP. If participants were HIV seronegative, sexually active, and interested in oral PrEP, they were provided with one month's supply of generic tenofovir disoproxil fumarate and emtricitabine (TDF/FTC). Participants also completed questionnaires on sociodemographic measures, alcohol consumption behaviors over the preceding 30

days, and sexual behaviors. Participants were requested to visit the study clinics at one month, followed by every 3 months for HIV re-testing, adherence counseling, safety monitoring, and PrEP refills while taking PrEP. Clinic attendance was recorded through scanned barcodes on referral slips. If participants didn't have their slips, an algorithm utilizing demographic details was used to identify them.

Study definitions

Our primary exposure of interest was self-reported alcohol use behavior. We ascertained alcohol use using a standardized questionnaire which queried whether 1) respondents had ever consumed an alcoholic drink in their life; 2) the number of days they had consumed alcohol over the last 30 days and 3) the number of days they had consumed 5 or more drinks over the last 30 days. We mapped the question responses to the validated Alcohol Use Disorders Identification Test-Consumption (AUDIT-C) questionnaire and categorized alcohol use as: no alcohol use (AUDIT-C score 0), low/moderate-risk alcohol use (AUDIT-C score 1–5), high/very high-risk alcohol use (AUDIT-C score 6-12).[29, 30] These scores align with prior literature showing increased risk for alcohol use disorder with increasing AUDIT-C scores [31]. For men with repeat AUDIT-C scores obtained at follow up visits, the maximum AUDIT-C scores were used for analyses.

Our primary outcomes of interest were 1) PrEP initiation and 2) PrEP continuation among those who initiated PrEP. Participants were offered oral PrEP at each clinic visit if they had negative HIV rapid testing and were considered at risk for HIV according to the South African screening guidelines [32]. Therefore, persons who declined HIV testing, had positive HIV testing, or who were not sexually active were excluded from our PrEP-eligible cohort. PrEP continuation was defined as receiving on time PrEP refill prescriptions from the study clinics at or beyond 3 months of the PrEP initiation date. We use the terms continuation and persistence synonymously, as defined by the World Health Organization [33]. As the highest drop off for PrEP usage is after one month [10, 34, 35], we extended our outcome to be 6 months in sensitivity analyses. Additionally, we evaluated the number of HIV seroconversions among all men in our cohort at the 12-month end-line study visit.

We considered smoking, drug use, sexual behavior, and socioeconomic status as potential confounders or mediators of the relationship between alcohol use and PrEP initiation or continuation in regression models. Participants who reported current or past smoking history were characterized as ever smokers. Reported drug use was defined as "none", "cannabis", or "club drugs/other". Participants reported number of sex partners within the last year, ranging from 0, 1, 2-4, or >5 partners.. Sexual behaviors including 1) knowledge of sexual partner's HIV status, 2) reported sex while using alcohol or drugs, and 3) recent

condomless sex within 3 months were all defined as binary variables. Socioeconomic status was estimated using household asset ownership data collected within the HDSS annual surveys to generate a relative wealth index, as developed by Filmer and Pritchett [27, 36].

Statistical Methods

For the purposes of our analyses, we included only men with completed alcohol data at baseline. We first described participants' characteristics stratified by alcohol use categories and explored differences between groups using Kruskal-Wallis testing. To explore the associations between alcohol use and PrEP initiation among eligible men, we fitted logistic regression models, with and without adjustment for potential confounders. The following covariates were included: age, socioeconomic status, knowledge of partner's HIV status, male circumcision, and number of clinic visits. Reported sex while using alcohol or drugs, recent condomless sex, and number of sexual partners were not included as covariates in primary models as these were considered to be on the causal pathway. Further, drug use and smoking demonstrated collinearity with alcohol use and were not included in the final models. We then conducted a survival analysis with the Kaplan-Meier estimator to compare the duration of PrEP use, stratified by alcohol use categories, and performed a log-rank test to compare differences in PrEP continuation. Participants were considered to have discontinued PrEP 30 days after their last filled prescription or if they reported a specific stop date. We then fitted logistic regression models with the outcomes of PrEP continuation at 3 months and 6 months, with and without adjustment for age, socioeconomic status, knowledge of partner's HIV status, and male circumcision. Men were excluded from the primary analysis if they did not have complete alcohol data obtained at the study clinic visits. However, in sensitivity analyses, we included men with completed alcohol data obtained at the 12-month end-line study survey. Statistical analyses were conducted in Stata (Version 17, StataCorp, College Station, Texas, USA).

Ethical considerations

The institutional review boards approved the Isisekelo Sempilo study at the University of KwaZulu-Natal Biomedical Research Ethics Committee (BREC/00000473/2019) and University College London Research Ethics Committee (5672/003). Written informed consent was obtained from participants aged 18-29 years; written assent was obtained from participants aged 16-17 years, with written consent from their parents or guardian.

Results

Sample characteristics




Figure 1: Analytic cohort

Of the randomly selected men within the catchment area (n=1,500), 847 men (56%) were enrolled in the Isisekelo Sempilo study (**Figure 1**), of whom 528 (62%) attended a study clinic at least once. We excluded 203 men due to missing alcohol data (n=107), positive HIV testing (n=20), declined HIV testing at every study visit (n=29), or report that they were not sexually active (n=47), leaving 325 men eligible for PrEP in the analytic cohort (**Figure 1**). The average age of participants was 22.9 years (SD 3.6), with older ages among high/very high-risk alcohol use groups (24.4 years versus 21.6 years in no alcohol group, p<0.001) (**Table 1**). Of the 325 men, 40% (141) had high/very high-risk alcohol consumption behaviors (AUDIT-C score ≥6). Socioeconomic status and male circumcision rates were comparable across the three alcohol use groups. Men with the highest risk alcohol use reported greater condomless sex (89.3%, vs 68.1% in no alcohol group, p-value<0.001), and having more than 5 sexual partners in the last year (16.0%, vs 5.0% in no alcohol group, p-value=0.003). Knowledge of sexual partner's HIV status was reported by approximately one third of participants (total group 35.4%, n=115/325).

Association between alcohol use and PrEP initiation among eligible men

We found the greatest uptake of PrEP among the high/very high-risk alcohol use group (46/131, 35%), followed by the low/moderate risk group (17/53, 32%) and the no alcohol group (25/141, 18%) (**Figure 2**). In univariate analyses, high/very high-risk alcohol use was positively associated with PrEP initiation compared to no alcohol use (OR 2.64 95%CI 1.50-4.65, p=0.001) (**Table 2**). In multivariable models adjusted for demographic and clinical confounders, the high/very high-risk alcohol group remained

significantly more likely to initiate PrEP compared to the no alcohol group (aOR 2.44 95% CI 1.29-4.60; p-value 0.006). Men in the low/moderate alcohol use group also initiated PrEP more frequently than men who do not drink alcohol (aOR 2.20 95% CI 1.03-4.71, p=0.041). In sensitivity analyses, we included men with completed alcohol data obtained at the 12-month end-line survey. Therefore, 75 of the 107 men initially excluded were part of our sensitivity analyses; we found similar relationships persisted between alcohol use and PrEP initiation (Supplemental Figure 1, Supplemental Table 1).

Association between alcohol use and PrEP continuation among men who initiated PrEP




Figure 3: Kaplan-Meier analysis of PrEP continuation among men. The Kaplan-Meier estimates of PrEP continuation among men illustrate the survival probabilities across the three alcohol groups. The median PrEP continuation time was 30 days in the no alcohol group, 44 days in the low/moderate-risk alcohol group, and 53 days in the high/very high-risk group. However, there is no statistical difference in PrEP continuation rates over time among these groups as indicated by a log-rank p-value of 0.501.

Out of the 88 participants who initiated PrEP, 83 discontinued PrEP within the 12-month study observation period. The median duration of PrEP use was 30 days for the no alcohol group, 44 days for the low/moderate risk alcohol group, and 53 days for the high/very high-risk alcohol group (**Figure 3**, **Table 3**, log rank test p-value=0.570).

Twenty-four percent (6/25) of the no alcohol group, 18% (3/17) of the low/moderate risk group, and 37% (17/46) of the high/very high-risk group remained on PrEP at 3 months, respectively. In multivariable models, we found no significant association between the alcohol use groups and 3-month PrEP continuation when compared to the no alcohol group (high/very high-risk group aOR 1.02 95% CI: 0.28-3.86, p=0.980; low/moderate risk group aOR of 0.41 95% CI: 0.07-2.21, p=0.298) (**Table 2**). By the 6-month time point, 18 of the 88 participants (20%) remained on PrEP, with no differences in continuation based on alcohol consumption (**Table 2**).

Three men seroconverted during the 12-month study period. Among these, two reported high/very high-risk alcohol use behaviors, while the third reported no alcohol use. Notably one of the individuals in the high/very high-risk alcohol group denied sexual activity and therefore was not encouraged to take oral PrEP. The individual with no alcohol use declined PrEP. The third participant did initiate PrEP on his second clinic visit, however, did not return for follow up despite attempts made by the study team. He was found to have seroconverted at the 12-month end-line study assessment.

Discussion

In one of the first studies examining alcohol and PrEP use in southern Africa, we found men reporting high/very high-risk alcohol use were significantly more likely to initiate PrEP than men who do not drink alcohol. This observation echoes findings from other studies suggesting that men engaging in riskier behaviors, such as hazardous alcohol consumption, perceive themselves to be at higher risk of HIV acquisition and therefore may be more inclined to start PrEP as a preventive measure [12, 14]. However, irrespective of alcohol use, we observed a sharp decline in PrEP continuation rates – a trend observed in other studies noting substantial PrEP discontinuation within a month of initiating treatment [10, 31, 34]. Reassuringly, men with the highest risk alcohol use showed similar continuation with oral PrEP as those who do not consume alcohol. Our results highlight the relationship between alcohol use, perceived HIV risk, and PrEP utilization, demonstrating that high risk alcohol use should not be a perceived barrier to PrEP provision in rural South Africa. On the contrary, given their reporting of high-risk sexual activities, it's essential to prioritize engaging men, especially those who consume alcohol, in safe sexual practices and HIV prevention methods to curb the HIV incidence in the region.

Hazardous alcohol use has been hypothesized to affect every aspect of the PrEP care continuum, however, to date, the evidence, largely from the United States, has been mixed regarding alcohol use and PrEP initiation [21]. Qualitative studies have described alcohol use as a perceived deterrent for PrEP initiation, due to concerns about potential toxicity when it is used concurrently with alcohol [23, 24]. By contrast, our study among young South African men found alcohol use as a facilitator to initiating PrEP. These results are consistent with those of a study conducted in Buffalo City, South Africa in which men with heavy alcohol use were more likely to initiate the preventative therapy [12]. Such data imply that men who engage in high-risk alcohol use also recognize their associated risk of HIV acquisition, justifying the use of preventative therapy. Thus, strategies to engage these individuals should be amplified.

Evidence for the relationship between alcohol use and PrEP effective use and continuation is also mixed. Two prospective studies, including one in Uganda and Kenya among serodiscordant couples, observed a decrease in PrEP adherence and continuation with hazardous alcohol use [37, 38]. In contrast, recent studies indicate that those reporting alcohol consumption often show better adherence, supported by biomarkers confirming medication compliance [39, 40]. An illustrative example comes from a South African study involving pregnant and post-partum women where 1 in 3 women reported hazardous alcohol use. At 3 months, 58% of women were reportedly still using PrEP and alcohol use correlated with higher odds of PrEP continuation (aOR 1.54, 95% CI 1.16-2.06) [40]. In our study, while there was a

higher inclination towards initiating PrEP among the high-risk alcohol group, continuation rates remained largely uniform irrespective of alcohol use. This aligns with a U.S. study among men who have sex with men, which found no differences in dried blood spot tenofovir diphosphate levels between those who used alcohol and club drugs and those who did not use substances [41]. In our study, although the median discontinuation time was marginally longer for the high/very high-risk alcohol group, it remained less than two months, indicating a general challenge in sustained PrEP usage. Thus our data suggest that the decision to initiate doesn't translate to continued usage, and that barriers to PrEP maintenance, such as potential side effects, societal stigma, and lack of healthcare access, continue to exist for men, regardless of their alcohol consumption [21, 42].

Our results also shed light on the complex relationship between sexual behaviors and alcohol use. Men with the highest alcohol use reported frequent condomless sex and multiple sexual partners, reflecting the intersectionality of risk behaviors. A holistic approach, which addresses these interlinked behaviors comprehensively rather than separately, might generate more effective intervention results. To this end, creating interventions that directly address the barriers men face regarding preventative therapy could be pivotal for enhancing PrEP uptake and sustained use. For example, a community-based PrEP delivery program, which engaged men for PrEP at local bars in rural South Africa, demonstrated potential feasibility of this approach to engage a traditionally hard-to-reach demographic of young men [43]. Of the 136 men deemed eligible for PrEP outside of local bars, 27% completed clinical evaluation and initiated PrEP [43]. While a 27% initiation rate of PrEP is low, it is consistent with the PrEP initiation rate in our cohort and falls within the range of other prospective cohorts conducted across southern Africa [44-47].

Strengths and Limitations

Our study has several strengths. We used a longitudinal study design, targeting young men without bias towards the gender of their sexual partners, and drew participants with a community-based engagement approach randomly selected from a Health and Demographic Surveillance Site in rural South Africa [27]. There were also important limitations. Firstly, PrEP continuation was defined by the act of refilling PrEP prescriptions at the study clinics, thereby lacking comprehensive data about how men were taking PrEP. For future studies, measuring tenofovir drug levels could offer more nuanced information regarding effective usage of the medication. Additionally, a substantial proportion of the cohort had missing alcohol data at the baseline study visit. This limitation was addressed by leveraging the endline AUDIT-C scores obtained on 70% of the men initially excluded in sensitivity analyses. Further, the AUDIT-C questions deviated from the standard approach, capturing monthly alcohol consumption rather than the conventional

12-month timeframe. Our study, while one of the first in southern Africa to focus on alcohol use and PrEP utilization, was small, particularly for measuring differences in PrEP continuation. The self-reported nature of the alcohol consumption and sexual behavior data might introduce recall and social desirability bias [48, 49]. Moreover, our findings from the rural KwaZulu-Natal context may not be generalizable to other regions or countries with different cultural and healthcare landscapes. Lastly, although our focus was on alcohol use, other factors such as mental health, interventions tailored to men's sexual health, and access to peer support can also influence PrEP initiation and continuation and should be explored in future studies.

Conclusions

Understanding the relationship between alcohol use and PrEP utilization is essential for creating effective interventions, particularly in the context of South Africa where heavy alcohol use and HIV transmission remain high. We found that men with high-risk alcohol use were more likely to initiate PrEP, but that PrEP continuation was universally low across all alcohol use levels. Our data suggest that offering PrEP to at-risk men who use alcohol is feasible, but that current PrEP delivery models are not achieving high levels of PrEP utilization in any groups of men. Rather, addressing PrEP continuation may require a multifaceted strategy with supportive, stigma-free environments, and minimal barriers to accessing prescriptions so all can access and sustain HIV preventive care.
