Orphanhood and caregiver death among children in the United 1 States due to all-cause mortality 2000-2021: A Modeling Study 2

50	Question: What are U.S. trends in all-cause and cause-specific orphanhood and caregiver death
51	among children <18?

- 53 **Findings**: From 2000-2021, orphanhood and caregiver loss incidence and prevalence increased
- 54 49.2% and 8.3%, respectively. By 2021, 2.9 million children (4% of all children) were affected.
- 55 Populations disproportionately affected by orphanhood included 1.7 million adolescents ages 10-17;
- 56 6.5%, 4.8%, and 3.9% respectively of non-Hispanic American Indian/Alaska Native, non-Hispanic
- 57 Black, and non-Hispanic White children; and children in New Mexico, Southern and Eastern States.
- 58 Drug overdose was the leading cause of orphanhood during the COVID-19 pandemic.

60 **Meaning**: Evidence-based programs and policies are needed to prevent orphanhood and support

61 these bereaved children.

67	Importance: Deaths of parents and grandparent caregivers linked to social and health crises
68	threaten child wellbeing due to losses of nurturance, financial support, physical safety, family
69	stability, and care. Little is known about the full burden of all-causes and leading cause-specific
70	orphanhood and caregiver death beyond estimates from select causes.
71	
72	Objective: To estimate 2000-2021 prevalence and incidence trends of all-cause orphanhood and
73	caregiver death among children <18, by cause, age, race/ethnicity, and state.
74	
75	Data Sources: National Center for Health Statistics (NCHS) birth, death, race/ethnicity, and
76	population data to estimate fertility rates and identify causes of death; 1983-1998 ICD-9 causes-of-
77	death harmonized to ICD-10 classifications; 1999-2021 ICD-10 causes-of-death; CDC WONDER for
78	state-specific estimates; and American Community Survey for grandparent population estimates.
79	
80	Data extraction and synthesis: We extracted U.S. population-level death, birth, population size,
81	race, and ethnicity data from NCHS and attributed to each deceased individual the average number
82	of children left behind according to subgroup-specific fertility rates in the previous 0-17 years. We
83	examined prevalence and incidence of orphanhood by leading causes-of-death, including COVID-19,
84	the leading 5 causes-of-death for 1983-2021, and additional leading causes for ages 15-44. We
85	extended these to obtain state-level outcome estimates.
86	
87	Main outcome measures: National incidence and prevalence of orphanhood and caregiver death
88	from 2000-2021, with orphanhood by year, parental cause-of-death and sex, child age,
89	race/ethnicity, and state.
90	
91	Results: From 2000-2021, orphanhood and custodial/co-residing grandparent caregiver loss annual
92	incidence and prevalence trends increased 49.2% and 8.3%, respectively. By 2021, 2.9 million
93	children (4% of all children) had experienced prevalent orphanhood and caregiver death.
94	Populations disproportionately affected by orphanhood included 5.0% of all adolescents; 6.5%, 4.8%,
95	and 3.9% respectively of non-Hispanic American Indian/Alaska Native, non-Hispanic Black, and non-
96	Hispanic White children; and children in New Mexico and Southern and Eastern States. Parental
97	death due to drug overdose during 2020-2021 surpassed COVID-19 as the leading cause of incident
98	and prevalent orphanhood during the COVID-19 pandemic.

- 100 Conclusions and Relevance: Policies, programs, and practices aimed at orphanhood prevention,
- 101 identification, and linkage to services and support of nearly 3 million bereaved children are needed,
- 102 foremost prioritizing rapidly increasing overdose-linked orphanhood.

111 Introduction

112 Deaths of parents and co-residing/custodial grandparent caregivers, in the context of 113 intersecting social and health crises, threaten child wellbeing¹ due to losses of nurturance, financial support, housing, and care.²⁻⁴ Orphanhood (death of one or both parents)^{5,6} and caregiver loss 114 115 (death of co-resident/custodial grandparents) are considered Adverse Childhood Experiences 116 (ACEs),^{7,8} and may have enduring consequences that persist well into adulthood.⁹⁻¹² ACE's are 117 associated with increased chronic stress and lifelong risks of mental health illness, suicide, posttraumatic stress disorder, violence, insecure housing,¹³ and chronic and infectious diseases.^{14,15} 118 119 These impacts often lead to ongoing needs for mental health, parenting, educational, and economic 120 support for affected children, and for foster care or adoption services for children bereft of care.¹⁵

121 In the United States, mortality data informs public health prevention and response policies 122 according to leading causes-of-death.¹⁶ However, one disproportionately affected population often remains largely invisible – those children left behind by adult deaths.^{2,6,17} One exception are children 123 124 experiencing COVID-19-associated orphanhood, where real-time incidence estimates¹⁸⁻²⁰ led to 125 policies to support children, including recommendations in the National COVID-19 Pandemic Preparedness Plan²¹ and investments in some states,²² such as financial, bereavement, and mental 126 127 health support for bereaved children and surviving caregivers. These established frameworks raise 128 the possibility that new standards of care can be extended for any child experiencing orphanhood, 129 regardless of cause.²³

130 To inform evidence-based, compassionate prevention and response strategies for affected 131 children and families, understanding the numbers, time-trends, causes, locations and disparities in 132 all-cause orphanhood is essential. Reports show COVID-19 excess deaths caused a surge in 133 orphanhood and caregiver death, affecting over 10.5 million children globally.²⁴ In the U.S., the 134 pandemic was linked to increased challenges including substance use, economic crises, mental 135 health distress, and may have been linked to deaths due to overdose, suicide, and excessive alcohol 136 use.^{25,26} Though reports have described the U.S. orphanhood burden related to HIV,²⁷ maternal 137 cancers,²³ COVID-19,¹⁵ and child bereavement,²⁸ up-to-date estimates on all-cause orphanhood do 138 not exist.

140 Therefore, we estimate prevalence, incidence, and trends from 2000-2021 in all-cause 141 orphanhood and caregiver death among children in the U.S. We further characterize leading causes 142 of orphanhood and caregiver loss and identify whether the compound crises of the COVID-19 143 pandemic and drug overdose epidemic in 2020 and 2021 were associated with escalating 144 orphanhood. We aim to identify populations disproportionately affected, by age, race/ethnicity, and 145 state, to strengthen evidence-based response strategies. Our findings can contribute to identifying 146 children at risk among population subgroups and geographic areas, and to targeting effective 147 prevention and protection programming for affected children and parents/caregivers. 148

- 149 Methods

151 **Overview**

We adapted methods from Hillis et al¹⁹ to estimate the magnitude of orphanhood and 152 153 caregiver loss among children ages 0-17 from all causes of deaths, according to Guidelines for 154 Accurate and Transparent Health Estimates Reporting (GATHER). We extracted subgroup-specific 155 individual live birth and death data from National Center for Health Statistics (NCHS), along with 156 population size estimates. We then attributed to each deceased individual the average number of 157 children orphaned using subgroup-specific fertility rates in the previous 0-17 years. Our outcomes 158 were orphanhood incidence and prevalence from 2000 through 2021, disaggregated by year, child 159 age, and sex, race/ethnicity, cause-of-death of the deceased parent (numbers and percent of child 160 population). We extended these estimates to include loss of co-residing/custodial grandparent 161 caregivers, and state-level estimates of incidence and prevalence of orphanhood and grandparent 162 caregiver loss (Supplementary Text (ST) S1, Fig. S2). We calculated 95% uncertainty intervals around 163 estimates using bootstrap resampling (ST S1).

165 National mortality data

166 We extracted mortality data of U.S. residents by underlying cause-of-death from NCHS Vital 167 Statistics for 1983-2021.²⁹ The World Health Organization (WHO) defines underlying cause-of-death as "the disease or injury which initiated the train of events leading directly to death, or the 168 circumstances of the accident or violence which produced the fatal injury".³⁰ Mortality records²⁹ 169 170 were mapped and aggregated to one of 53 caregiver loss causes-of-death that are closely related to the 52 rankable causes-of-death in the NCHS 113 cause-of-death list³¹, or `Other' caregiver loss 171 172 cause-of-death (ST S1). Cause-of-death classifications changed with the Tenth Revision of the

173 International Classification of Disease (ICD-10), and we harmonized 1983-1998 cause-of-death data 174 to ICD-10 classifications to avoid discontinuities in orphanhood estimates from 1998-1999 (ST S1). 175 Our cause-specific analyses for orphanhood estimates focused on leading causes of death in 176 2021: COVID-19, drug overdose, the remaining top five causes-of-death overall (heart disease, 177 cancer, unintentional injuries, cerebrovascular diseases, chronic lung disease), and any additional 178 causes of death in the top five for men and women ages 15-44 (suicide and homicide), as these ages 179 include those more likely to be parents. We used a hierarachical approach for classifying cause of 180 death; therefore, we consistently excluded drug overdose from each of these three categories: 181 suicide, homicide, and unintentional injuries. Race and ethnicity in death certificates are typically 182 reported by next of kin. We converted data that were incrementally reported by multiple races to 183 standardised race categories (Table S7). 184 185 National orphanhood estimates 186 To estimate the number of children each death leaves behind, we obtained age, race, and ethnicity data of fathers and mothers from NCHS live birth records.^{29,31} We used corresponding 187 188 1990-2021 population sizes³² to calculate annualized age- and sex-specific national-level fertility 189 rates by standardised race/ethnicity categories (ST S1). Before 1990, we assumed fertility rates of 190 1990 because population sizes by race/ethnicity were unavailable before 1990, and report 191 corresponding sensitivity analyses (ST S2). 192 193 Incidence 194 We estimated annual incidence of orphanhood for a given year among children by 195 multiplying the number of cause-specific deaths among adults stratified by sex, race/ethnicity, and 196 five-year age bands in each year 1983-2021, with the expected number of children aged 0-17 born to 197 each adult, with the corresponding characteristics in the same year. Calculations were performed by 198 race/ethnicity groups and then aggregated to U.S. totals due to correlations between mortality and

- fertility rates by race/ethnicity (ST S1). Age of child was attributed by considering fertility rates in
 each of the current and preceding 17 years, after adjustment for pediatric survival probabilities
- 201 (Table S4).

202

203 Prevalence

We estimated annual prevalence of orphanhood among children in any given year in 2000-205 2021 by cumulatively summing incidence estimates by one-year age of child in the current and 206 previous 17 years, excluding children who would have since turned 18; calculations of orphanhood

207 prevalence for 2000-2015 required including annual orphanhood incidence estimates for 1983-1999, 208 in order to include the cumulative prior 17-year risk for experiencing prevalent parental death. We 209 removed duplicate orphanhood counts by adjusting for those who had lost both parents (ST 1, Table 210 S5). Incidence and prevalence rates were calculated relative to child population sizes in the 211 corresponding year. 212 213 National grandparent caregiver loss 214 We estimated annual incidence of children losing grandparent caregivers in 1983-2021 by 215 multiplying the number of cause-specific deaths in each year in adults aged 30 years and above 216 stratified by sex and race/ethnicity with the corresponding proportions of adults co-residing with 217 their grandchild(ren) and providing some or all basic needs for grandchild(ren), using U.S. Census 218 American Community Surveys (ACS) 2010-2021 data (ST S1).³³ We assumed only one child was 219 affected by each grandparent caregiver death. We also developed estimates for the age of children 220 affected (Fig S21). 221 222 State-level orphanhood and grandparent caregiver death estimates 223 We generated state-level estimates of cause-specific incidence and prevalence of 224 orphanhood and caregiver death for 2021, using data from CDC WONDER.^{34,35} (ST S1). State-level 225 orphanhood and caregiver death were calculated as above, with exceptions for male fertility rates 226 for 2005-2015 (ST S1). We developed correction factors to adjust for bias resulting from data not 227 stratified by race and ethnicity (ST S1). 228 229 **Results** 230 231 All-cause orphanhood and caregiver loss 232 In 2021, we estimate 498,249 (95% CI, 496,938-499,639) childr experienced incident 233 orphanhood or caregiver death from any cause (0.72% of children, Table 1, Fig. S2). Most children 234 lost a parent (81.6%), while the remainder lost a grandparent caregiver (18.4%). Before the COVID-235 19 pandemic, incidence of orphanhood, and of orphanhood/caregiver loss (combined) increased 236 rapidly from 2000 to 2019 by 11.4% and 11.7%, respectively (Table 1). Through the pandemic, 237 incidence of orphanhood, and of orphanhood/caregiver loss (combined) increased further from 2019 238 to 2021 by 39.5% and 33.6%, respectively. Prevalence of orphanhood, and of orphanhood/caregiver 239 loss decreased slightly by 2.4% and 0.9% from 2000 to 2019, then increased by 10.1% and 9.3% 240 during the period spanning the pandemic years (2019 to 2021). In 2021, we estimate 2,966,008

241 (95%Cl, 2,963,030-2,968,931) children experienced prevalent orphanhood or caregiver death,

- representing 4.0% of all children.

244 Cause-specific trends

245 From 2000-2021, orphanhood caused by drug overdose increased markedly, as did 246 orphanhood due to COVID-19 between 2019-2021. Orphanhood due to suicide decreased until 2010 247 and subsequently increased. Orphanhood due to unintentional injuries and homicide decreased 248 until 2019, then increased until 2021; orphanhood due to diseases of the heart remained relatively 249 unchanged until 2019, then increased. Only orphanhood due to malignant neoplasms consistently 250 decreased from 2000-2021. By 2021, both incidence and prevalence of orphanhood due to fatal 251 injuries – including drug overdose, suicide, homicide, and unintentional injuries (e.g. motor vehicle 252 crashes) – exceeded orphanhood due to chronic diseases (Fig 1A, B and Table S1). Orphanhood 253 caused by drug overdose rose substantially from 2012-2019, then jumped sharply during 2020-2021 254 (Fig 1C). From 2000-2019, orphanhood incidence due to drug overdose increased from an estimated 255 0.015% of children in 2000, to 0.06% in 2019, 0.085% in 2020 after the pandemic onset, and 0.09% 256 in 2021. Drug overdose was the leading cause of orphanhood incidence and prevalence in 2020 and 257 2021, surpassing both chronic diseases and COVID-19 (Fig 1C, D). The disproportionate impact of 258 fatal injuries on orphanhood was evident in 2021, with drug overdose contributing 17.5% to 259 orphanhood incidence, yet only 3.1% to adult mortality (Fig 1E); similarly, unintentional injuries, 260 suicide, and homicide contributed 8.3%, 5.0%, and 3.7% to orphanhood, versus 3.6%, 1.2% and 0.7%, 261 respectively, to adult deaths.

263 Disparities by age and race/ethnicity

From 2000-2021, children ages 10-17 years were 5.4 times more likely than children ages 0-4 to experience prevalent orphanhood (Fig 2A, Table S2). By 2021, orphanhood prevalence among ages 10-17 was 5.0%, affecting 1,704,671 children. Substantial disparities across race and ethnicity occurred, accentuated by the COVID-19 pandemic. By 2021, orphanhood affected 6.5% of non-Hispanic American Indian or Alaska Native children, 4.8% of non-Hispanic Black children, 3.9% of non-Hispanic White children, 1.7% of Hispanic children, and 1.9% of non-Hispanic Asian children (Fig 2C).

Causes underpinning these disparities differed by parental race/ethnicity and sex (Fig 2D,
Table S3). Among non-Hispanic American Indian or Alaska Native children, leading causes of
maternal orphanhood in 2021 were, in order, COVID-19, drug overdose, and chronic liver disease
and cirrhosis; while leading causes of paternal orphanhood were chronic liver disease and cirrhosis,

unintentional injuries, and diseases of the heart – all of which increased as causes of orphanhood
since 2000. Among non-Hispanic Black children, leading causes of maternal orphanhood were
COVID-19, diseases of heart, and drug overdose; while paternal orphanhood was primariy caused by
diseases of heart, drug overdose, and homicide. In non-Hispanic White children, drug overdose
deaths among fathers increased substantially over the past two decades; in Hispanic children,
COVID-19 deaths among fathers predominated. In non-Hispanic Asian children, primary causes of

- 281 orphanhood were heart disease, malignant neoplasms, and COVID-19.

283 State-level Estimates

284 In 2021, 33 states had >3% of all children experiencing prevalent orphanhood; Southeastern, 285 Northeastern, Southern Border, and Midwest states were most affected (Table 2, Fig. 3, and Tables 286 S4-S6). California, Texas, and Florida had the highest numbers of children experiencing orphanhood 287 incidence and prevalence in 2021. West Virginia and New Mexico had the highest incidence (0.8-288 0.9%) and prevalence rates (4.5-5.0%) of orphanhood in 2021. Injury-associated parental deaths – 289 including overdose, suicide, and/or unintentional injury – were among the top two causes of 290 orphanhood prevalence in 47 states (Table 2). Drug overdose was the leading cause of orphanhood 291 prevalence in 30 states, particularly affecting Southeastern, Southwestern, Southern Border, and 292 Midwest states, and Southwestern States with large American Indian and Alaska Native populations. 293

294 **Discussion**

295

296 Over the past two decades, prevalence of all-cause orphanhood and caregiver death 297 decreased slightly until 2019 and then increased markedly during 2020-2021 with intersecting 298 crises of the overdose epidemic and COVID-19 pandemic.^{36,37} Parental death due to drug overdose 299 was the leading cause of orphanhood incidence and prevalence during the pandemic. By 2021, 300 over 2.9 million children – 4.0% of all children in the U.S. – had lost a parent or caregiver in their 301 lifetime. Populations disproportionately affected by orphanhood included over 1.7 million 302 adolescents ages 10-17 years (1 of every 20 adolescents); and children of non-Hispanic American 303 Indian or Alaska Native, non-Hispanic Black, and non-Hispanic White race/ethnicities 304 (approximately 1 of 15, 1 of 20, and 1 of 25 children, respectively). Orphanhood prevalence was 305 highest in West Virginia, New Mexico, Mississippi, Louisiana, and Kentucky, affecting 1 of every 25 306 children. Compared to previous cause-specific reports (an estimated 97,376 children orphaned by HIV/AIDS (1998),²⁷ 157,183 by maternal cancers (2020),²³ and 218,800 by COVID-19 in 2020-307 308 2022³⁸), data on all-cause orphanhood and co-residing grandparent caregiver death are over ten 309 times greater, quantifying the full burden.

311 By 2021, orphanhood incidence and prevalence due to fatal injuries (drug overdose, suicide, 312 homicide, and unintentional injuries), exceeded those linked to chronic diseases. Together, injuries 313 and chronic diseases accounted for over half of all children orphaned. Fatalities due to injuries and 314 chronic diseases among minoritized populations, are more common among younger adults still 315 caring for children. For 47 states, drug overdose, suicide, and/or unintentional injuries were 316 among the top two causes of orphanhood. Although drug overdose deaths were increasing before 317 2020, pandemic-linked increases of these deaths exceeded those forecasted; and the pandemic appeared to increase drug overdose risk.^{39,40} The evolving nature of drug supply, including the 318 319 proliferation of illegally made fentanyl and resurgence of stimulants such as methamphetamine, 320 has affected almost every state.^{41,42} By 2021, our data show drug overdose contributed 17.5% to 321 orphanhood compared to 3.1% to mortality; establishing comprehensive care programs for 322 children orphaned due to drug overdose could better mitigate the long-term negative effects that 323 these children are disproportionately facing. 324 Our findings reveal social and health disparities in orphanhood rates and leading caregiver

325 causes-of-death between age, sex, and racial/ethnic groups, and across geographies. These results 326 can inform and contextualize prevention and response programming for children affected by 327 orphanhood. For non-Hispanic American Indian or Alaska Native persons, for example, alcohol-328 related deaths were a leading cause, while non-Hispanic Black populations showed homicide among 329 fathers as a leading cause. Many of these disparities are related to historical racism and derived 330 practices that foster inequitable access to housing, education, and employment. Populations most 331 affected in different states may have been exposed to such inequalities.⁴³ In parts of the 332 northeastern and midwestern U.S., rising unemployment, limited access to health and social services 333 during the pandemic, increased access to a more lethal supply of illicit drugs or availability of other 334 substances such as alcohol particularly among affected white men, may be linked to drug overdose emerging as the top cause of incident orphanhood in these regions.⁴⁴ Circumstances of parental 335 death influence grief-related psychopathology in surviving children,⁴⁵ and evidence-based responses 336 337 can improve short- and long-term outcomes.^{9,11,12} It is paramount to keep children in their families, 338 whenever possible. This requires ensuring bereaved families receive support, and those needing 339 kinship or foster care are served rapidly.⁴⁶ Child resilience after parental loss can be strengthened by 340 programs and policies that promote safe, stable, and nurturing relationships and environments, and 341 that address childhood adversity, including preventing violence and abuse.⁴⁶ 342

343 Despite serious risks for bereaved children,⁴⁷ timely, multifactored responses using an age-344 and life-stage approach may restore hope and build resilience.⁴⁸ As grief is an immediate reaction 345 that can extend years after parental loss, healing and support are urgent needs for children, who 346 may be less equipped to recover than adults, particularly when the loss is sudden and unexpected.^{11,27} The governor of Utah⁴⁹ and others⁵⁰ have called for the addition to the death 347 348 certificate of a checkbox to identify children living in the home of the deceased, so that bereaved 349 children can be linked to support and services. Such responses typically provide parenting, 350 economic, and education support, and are consistent with the WHO INSPIRE package for ending violence against children.^{51,52} 351

352

353 Our study has several limitations. First, cause-specific estimates of children experiencing 354 orphanhood and caregiver deaths are derived from mortality statistics on underlying causes-of-355 death, and may be underestimates⁵³ for causes associated with erroneous or incomplete reporting, 356 uncertainty in the chain of events preceding death, or coding limitations - such as for COVID-19, drug 357 overdose, or suicide.⁵⁴ Second, as we attributed only one child per grandparent caregiver death, our 358 estimates of grandparent caregiver loss are minimum estimates. Third, we assumed current 359 mortality is unrelated to historic fertility for years before 1990, and sensitivity analyses suggest this 360 may lead to inaccuracies in orphanhood prevalence estimates until 2007 (ST S2). Fourth, publicly 361 available state-specific data were partly suppressed due to small counts; therefore, we cannot 362 exclude bias in state-specific orphanhood estimates. Finally, to characterise orphanhood prevalence 363 in 2000-2021, we had to consider vital statistics since 1983 and consolidate changes in cause-of-364 death and race/ethnicity coding. Our sensitivity analyses, including detailed comparisons of NCHS 365 death data to CDC WONDER vital statistics for each of the 21 years' calculations (ST S2), suggest our 366 incidence and prevalence estimates are robust, and should be interpreted as minimum estimates of 367 orphanhood and caregiver death.

368 In conclusion, evidence-based policies and programs that provide healing and support for 369 nearly 3 million children and adolescents in the U.S. who have experienced orphanhood and 370 caregiver loss are urgently needed to reduce longterm negative affects of this adverse childhood 371 experience. This is especially relevant given unprecedented rates of drug overdoses, increasing the 372 possibility that children who are living in a household where a parent or caregiver is negatively 373 affected by substance use, may also experience the loss of a parent.^{52,55} Evidence highlights three 374 essential components of orphanhood prevention and response that effectively promote their 375 recovery and resilience: (1) prevent death of parents and caregivers through timely prevention and 376 treatment of leading causes of death and ensured access to affordable compassionate health and

- 377 mental health care for all; (2) prepare families to provide safe and nurturing alternative care; and (3)
- 378 protect children affected by orphanhood and vulnerabilities, through grief and mental health
- 379 counseling, and parenting, economic, and educational support that can be contextualized and
- 380 delivered at scale.^{19,56}

²¹ S1 Extended methods

This Supplementary Text describes the data sources and statistical methods used to estimate cause-specific incidence and prevalence of orphanhood and grandparent caregiver loss among U.S. residents between 2000 and 2021. Our methods are overall similar to Hillis et al. [2021b,a], and extended here to estimate the magnitude of children aged 0-17 years experiencing the death of one or both parents from all causes or the death of a grandparent caregiver from all causes.

The United Nations International Children's Emergency Fund (UNICEF) defines orphanhood as children 27 experiencing the death of one or both parents UNAIDS, 2009. As in Hillis et al. 2021a, we considered 28 mothers of age 15-66 years and fathers of age 15-94 years so the maximum ages of parents at birth of a child 29 were respectively 49 and 77 years. Mortality data were recorded among U.S. residents, and for this reason, 30 orphanhood estimates are restricted to children of U.S. residents. Grandparents play indispensable roles as 31 caregivers for children United States Census bureau, 2021, Pew Research Center, 2013, US Census Bureau 32 2023b, Sowden et al., 2021, Ellis and Simmons, 2014. We further considered to provide minimum numbers of 33 children who lost a grandparent caregiver, defined as the death of a grandparent caregiver aged older than 30 34 years living with children in the same household. Mortality data were recorded among U.S. residents, and so 35 grandparent caregiver death estimates are also restricted to children of U.S. resident grandparent caregivers. 36 In Hillis et al. 2021a, we previously stratified grandparent caregivers based on the care they provided into 37 primary grandparent caregivers who were either the guardians of children or co-resided and provided for 38 basic needs of children, as well as secondary grandparent caregivers who co-resided and provided for some 39 needs of children, following the characterizations of Ellis and Simmons 2014. Here, we report throughout 40 the sum of primary and secondary grandparent caregiver loss (Supplementary Fig. S1). 41

⁴² S1.1 National-level NCHS mortality data by rankable causes of death, 1983-2021

We obtained line-list mortality data on U.S. residents from the NCHS Vital Statistics portal for each year from 1983 to 2021 National Center for Health Statistics, 2023. Data were collected from 1983 onwards because the corresponding children who lost a caregiver in 1983 at age 0 were of age 17 in 2000, and so entered our estimation of orphanhood prevalence in 2000. For each mortality record we retained year of death, the corresponding codes of the underlying cause-of-death (ICD-9 code and 282 cause recode before 1999; ICD-10 code and 113 cause recode after 1999), and demographic data of the decedent including sex, age at death, and information on race and Hispanic origin National Center for Health Statistics, 2022].

Information about the race and Hispanic origin of decedents in death certificates is typically reported by the 50 surviving next of kin, or on the basis of observation in the absence of an informant Rosenberg, 1999. Race 51 and Hispanic origin were reported in different formats across the study period Ingram et al., 2003, which 52 we mapped to standardized race and Hispanic origin categories as described in Supplementary Table S7 53 Specifically, we grouped individuals of Hispanic origin and all individuals of non-Hispanic origin by their race. 54 i.e. 'Hispanic', 'Non-Hispanic American Indian or Alaska Native', 'Non-Hispanic Asian or Pacific Islander', 55 'Non-Hispanic Black', 'Non-Hispanic White', and we refer to the resulting categories as "standardized race 56 & ethnicity" for simplicity. The underlying cause-of-death is defined by the World Health Organization (WHO) as 'the disease or 63 injury which initiated the train of events leading directly to death, or the circumstances of the accident 64 or violence which produced the fatal injury' World Health Organization, 2016. For 1983-1998, underlying 65 causes-of-death were in the data classified with the Ninth Revision of the International Classification of 66 Diseases (ICD-9) World Health Organization, 1977, and grouped further into 282 selected causes of death, 67 termed '282 cause recode' National Center for Health Statistics, 1979. The only one addition to our causes when taking this approach was 'Homicide excluding drug overdose'. Supplementary Table S9 summarises our aggregation of the 53 rankable causes-of-death into these seven leading caregiver loss cause-of-death groups and 'Other' caregiver loss causes-of-death. The 'Other' caregiver loss causes-of-death comprise the remaining 46 rankable caregiver loss causes-of-death and any other causes-of-death that are not included in the NCHS 52 rankable causes-of-death.

We then mapped and aggregated line-list mortality records to the 53 rankable caregiver loss causes-of-death.
This was done by mapping the 1983-1998 line list data using the 282 recodes to the 52 NCHS rankable
causes-of-death as described in National Center for Health Statistics, 1988 on page 282ff and page 290ff.

A in Curtin SC, 2023, and subsequently mapped the NCHS 52 rankable causes-of-death to the 53 rankable caregiver loss causes-of-death based on Supplementary Table S9.

Next, we aggregated line-list death records to annualised death counts by the 53 rankable caregiver loss 117 causes-of-death for each year in 1983-2021, as well as by sex, age band (15-19, 20-24, 25-29, 30-34, 35-39, 118 40-44, 45-49, 50-54, 55-59, 60-64, 65-69, 70-74, 75-79, 80-84 and 85+ years) and standardized race & ethnicity 119 of the decedent. Data on race and ethnicity were not available for 1983, and for this year we attributed 120 mortality counts to standardized race categories according to the age-, sex- and cause-of-death-specific 121 standardized race compositions in 1984. To harmonise cause-of-death data from 1983-1999 to the ICD-10 122 cause-of-death classifications and avoid discontinuities in our orphanhood estimates from 1998 to 1999, we 123 used where available the comparability ratios in Table 1 of Anderson et al., 2001. Thirteen comparability 124 ratios of rankable causes of death were not provided in Anderson et al. 2001 when underlying estimations 125 were considered imprecise, and in these cases we set the comparability ratios to 1. To calculate fertility rates and attribute children experiencing orphanhood to decendents between 1983 to 130 2021, we required for our approach to estimating orphanhood live births data from before 1983 because 131 the children who lost a caregiver in 1983 at age 1-17 years were born between 1966-1982. However due to 132 limitations in publicly available population size data, we only considered in the central analysis live births 133 data from 1990 and assumed constant fertility rates before 1990. We investigated the sensitivity of our 134 orphanhood estimates to this assumption using live birth records since 1980 together with corresponding 135 population size estimates, and found that orphanhood prevalence estimates since 2008 were not affected 136 by our assumptions on historic fertility, while in the sensitivity analysis orphanhood prevalence estimates 137 for 2000-2007 were slightly lower due to overall lower fertility rates in the 1980s (Supplementary Text S2). 138 Line-list live births with demographic data on both mothers and fathers were available and downloaded from 139 the NCHS Vital Statistics portal for each year between 1969 to 2021 National Center for Health Statistics 140 2023. We considered only live birth records to U.S. resident mothers for consistency with the mortality data 141 available. Information on residency status of fathers was not available, and we assumed fathers were also U.S. 142 residents in the retained birth records associated with U.S. resident mothers. For each live birth, we retained 143 year of birth, the age of mothers and fathers, and information on race and Hispanic ethnicity National 144 Center for Health Statistics, 2023 145

Age of mothers and fathers was reported by single year of age. Following Hillis et al. [2021a], we considered live births to women aged 15-49 years and men aged 15-77 years, to match the mortality data of women aged 15-66 years and men aged 15-94 years. In total, less than 0.01% of line-list records were removed from further analysis because parent were outside of these age ranges. Age information was mapped to 5-year age bands 15-19 years, ..., 45-49 years for mothers and age bands 15-19 years, ..., 50-54 years, and 55 years

and older (55 + years) for fathers.

Information about the race and Hispanic origin of mothers and fathers was between 1969-2021 reported in different standards due to the revision of the U.S. certificates of live births on race in 1989 and 2003 National Center for Health Statistics, 2006. Information on the race of mothers and fathers is publicly available since 1969, and information on their ethnicity since 1978. For 1978-2021, we mapped available information on race and ethnicity to the same standardized race & ethnicity categories used to stratify the mortality data, according to the mapping described in Supplementary Table S10.

Next, we aggregated line-list live birth records to annualized live birth counts to mothers (in age bands 159 15-19, ..., 45-49 years) and fathers (in age bands 15-19, ..., 55+ years) for each year in 1969-1977, and stratified further by standardized race & ethnicity categories for each year in 1978-2021. Before 1985, data reporting was incomplete for some U.S. states and we used NCHS sampling weights reported in each year (see Appendix A of National Center for Health Statistics [1978)) to extrapolate reported live birth counts to state populations. Supplementary Fig. S6 illustrates the aggregated annual live birth counts by mothers and fathers and standardized race & ethnicity categories since 1978.

S1.3 National-level population size data, 1990-2021 165

To calculate fertility rates, we further required population size data of U.S. residents in the age-, sex- and 166 standardized race & ethnicity categories of the live births data. We obtained from the CDC WONDER 167 Vintage bridged-race postcensal & ethnicity population size estimates for each year in 1990-1999 and 168 2000-2020 CDC, 2021a, and single race population size estimates for 2021 CDC, 2021b. Data were 169 extracted by 5-year age bands (15-19 years, ..., 70-74 years) and single years of age from 75 to 77 years, and 170 data for individuals aged 55-77 years were summed into a single age band as required for the purposes of 171 our analyses. Race-specific population size estimates were aggregated to the standardized race & ethnicity 172 categories in Supplementary Table S11.

We calculated age-, sex- and standardized race & ethnicity-specific fertility rates in each year in 1990-2021 for women in one of the age bands $a \in \{15 - 19, \dots, 45 - 49\}$ years and men in one of the age bands $a \in \{15 - 19, \dots, 55 - 77\}$ years according to

where the number of live births and population sizes in each strata are denoted by $B_{y,a,s,r}$ and $P_{y,a,s,r}$ respectively. Calculations were done for each of the five standardized race categories 'Hispanic', 'Non-Hispanic American Indian or Alaska Native', 'Non-Hispanic Asian or Pacific Islander', 'Non-Hispanic Black' and 'Non-Hispanic White'. In the central analysis, we assumed the same fertility rates in each year in 1966-1989 as in 1990, and considered alternative assumptions in several sensitivity analyses (see below). Supplementary Fig. S7 shows the calculated U.S. fertility rates by standardized race & ethnicity.

¹⁸⁸ Mortality rates were calculated in analogy to Eq. (1). We found correlations by standardized race & ethnicity ¹⁸⁹ between fertility and mortality rates that changed primarily by age of mothers and fathers, and less so over ¹⁹⁰ calendar years (Supplementary Fig. S8 for women); findings were similar in men. These correlations prompted ¹⁹¹ us to estimate national-level incidence and prevalence of orphanhood by standardized race & ethnicity and

¹⁹² then sum the standardized race & ethnicity-specific estimates to obtain national-level estimates.

We estimated the number of children who newly experienced orphanhood in year $y, y = 1983, \dots, 2021$, from the population-level mortality records of U.S. residents in year y and the number of children each decedent

¹⁹⁶ was expected to leave behind. Our approach follows the methods described in [Hillis et al., 2021a, Unwin ¹⁹⁷ et al., 2022, with modifications to account for causes-of-death.

where y ranges from 1983 to 2021, the single year of age of mothers ranges from $a \in \{15, \ldots, 66\}$ years, the single year of age of fathers ranges from $a \in \{15, \ldots, 94\}$ years, the standardized race & ethnicity categories are as described before, and $b = 0, 1, \ldots, 17$ years. Due to the correlations between standardized race & ethnicity specific fertility and mortality rates, we calculated Eq. (3) for each standardized race & ethnicity. In Eq. (3), we assumed that population-level fertility rates are not correlated with population-level mortality rates, which may lead to upwards or downwards bias in orphanhood estimates that we explored in several sensitivity analyses (see below). We also assumed that parents and their children have the same standardized race & ethnicity.

Since orphanhood considers children who experienced the death of their mother, father or both, we are 214 interested in the sum of Eq. (3) for both mothers and fathers, but need to subtract children who lost their 215 other parent in the previous b-1 years, or who lost their other parent in the same year y. where for ease of readability we have suppressed y, s and r, and ${}_{n}P_{a}$ and ${}_{n}D_{a}$ are respectively the estimated population sizes and observed death counts by the end of the corresponding calendar year in each 5-year age band a' = [a, a + 5). The intermediate quantities in (4) are the approximated (unknown) mortality probability density function ${}_{n}f(x)$ at age midpoint x and (unknown) survival function S(a) up to age a, that can be expressed in terms of the age-specific mortality rate ${}_{n}q_{a}$, the proportion of individuals alive at age a and who die before reaching age a + n in the corresponding calendar year. Eq. (7b) subtracts the children who lost in year y a parent due to cause c and the other parent due to any 239 cause, which are counted twice in Eq. (7a). Without line-list family data and working from individual-level 240 live birth and death statistics, the two terms $O_{y,a',s,r,b,c}^{\text{new-double}}$, $O_{y,a',1-s,r,b,c}^{\text{new-double}}$ are not identical and for this reason we 241 subtracted the average of both. Eq. (7c) subtracts the children who already lost the other parent in previous 242 years. In our previous studies on COVID-19 associated orphanhood, we did not consider the possibility of 243 reinfection with COVID-19 and for this reason did not subtract children who already lost the other parent 244 due to COVID-19 in previous years in these studies Hillis et al., 2021a. ²⁶⁵ S1.6 Estimates of national-level grandparent caregiver loss, 1983-2021

We estimated the number of children who newly experienced grandparent caregiver death in year y, $y = 1983, \ldots, 2021$ from the population-level mortality records in year y of U.S. residents aged 30 years and above (30+), and assuming that each decedent who is estimated to have been a grandparent caregiver leaves a minimum of one grandchild behind. Our approach follows the methods described in [Hillis et al.] 2021a, with modifications to estimate the age of children who experience the death of a grandparent caregiver.

Starting from 2010, the American Community Survey (ACS) Ellis and Simmons, 2014 collects data on
the total number of adults aged 30+ years living with grandchildren of age 17 or under in the U.S., and
proportions of these by sex, and separately by bridged-race and Hispanic origin United States Census bureau,
274 [2021].

For each year $y = 2010, \ldots, 2021$, we estimated the number of adults aged 30+ years living with grandchildren of age 17 or under for each sex and standardized race & ethnicity by multiplying totals and proportions made available by the ACS. We then divided these numbers with the respective population size estimates to estimate sex- and standardized race & ethnicity-specific proportions of adults aged 30+ years who live with their grandchildren of age 17 or under, which we denoted with $\gamma_{y,s,r}$. For $y = 1983, \ldots, 2009$, we assumed that $\gamma_{y,s,r}$ is the same as in 2010. We further assumed that each grandparent caregiver leaves upon death a minimum of one child behind (corresponding to Eq. (2)) and estimated the minimum number of grandchildren who newly experienced grandparent caregiver death in year $y = 1983, \ldots, 2021$, with a U.S. resident grandparent caregiver aged 30+ years, sex s and standardized race & ethnicity category r who died of leading cause c by

The ACS surveys did not collect data on whether both grandparents are alive and live with their grandchildren of age 17 or under, and for this reason we did not adjust Eq. (12) further for loss of other grandparents. We investigated in Sensitivity analyses our assumption that $\gamma_{y,s,r}$ was approximately constant from 1983 to 2010 using longitudinal United Nations Population Division data on Households and Living Arrangments of Older Persons for the U.S., which suggested that the proportion of older persons who live with children or who are the primary caregivers of children has in the U.S. remained fairly constant since 1990 (Supplementary Fig. S23).

To estimate the minimum number of children who experienced grandparent caregiver death in their lifetime, we additionally need disaggregations of Eq. (12) by single year of age b = 0, ..., 17 years. For the central analysis, we assumed that the age composition of $G_{y,s,r,c}^{\text{new}}$ is the same as the age composition of children who lost parents older than 30 years,

where $O_{a',s,r,b,c}^{\text{new}}$ are obtained from Eq. (7) by summing over the years $y = 2000, \ldots, 2021$, and c is one of the leading caregiver loss causes-of-death. Supplementary Fig. S9 shows that the age compositions of children who lost parents older than 30 years differ across causes-of-death while they are relatively stable across standardized race & ethnicity. It is plausible that the age composition of $G_{y,s,r,c}^{\text{new}}$ may differ from the age composition of children who lost parents older than 30 years, and we explored alternative approaches to Eq. (13) in sensitivity analyses; none of these had a considerable impact on our overall estimates.

³⁰³ S1.7 Uncertainty quantification in national estimates

This section describes how we derived uncertainty intervals in the national-level estimates of orphanhood 304 incidence and prevalence (Eqs. (711)) and grandparent caregiver loss (Eq. (13)). To capture uncertainty, 305 we followed the same phenomenological approach as in Hillis et al., 2021a, and added Poisson noise around 306 mortality, natality, and population size data for all year, sex, age, standardized race & ethnicity, and 307 cause-of-death strata. We generated 10,000 Poisson noise data sets, and in terms of the uncertainty in 308 mortality data, additionally considered uncertainty related to the harmonization of causes-of-death counts 309 from 1983-1999 to the ICD-10 classification to avoid discontinuities in orphanhood estimates between 1998 310 and 1999. Specifically, we resampled the comparability ratios 10,000 times, assuming these were normally 311 distributed with the standard deviations reported in Table 1 of Anderson et al., 2001 where available, and 312 multiplied these ratios with the Poisson noise mortality data. Then, we repeated orphanhood incidence and 313 prevalence estimates on each data set, and calculated 2.5% and 97.5% quantiles to generate 95% uncertainty 314 intervals around central estimates. 315

 $_{316}$ In the ACS data, we accounted for uncertainty in the estimated number of adults aged 30+ years living $_{317}$ with grandchildren and in the attribution to sex, and standardized race & ethnicity groups using published

uncertainty ranges. The ACS provides for each of their published estimates margins of error that correspond 318 to 90% confidence intervals. We converted the 90% margins of error into standard deviations and bootstrap 319 re-sampled the available totals and separate proportions 1,000 times assuming normal distributions around 320 their central estimates and the corresponding standard deviations, multiplied the bootstrap resampled totals 321 and proportions, and then divided by the corresponding population sizes. Across years, we found these 322 sources of uncertainty amounted on average to 95% bootstrap intervals on the order of $\pm 0.79\%$ of the 323 central estimate of the number of Hispanic women aged 30+ years who live with grandchildren, $\pm 8.23\%$ 324 among Non-Hispanic American Indian or Alaska Native women, $\pm 1.93\%$ among Non-Hispanic Asian women, 325 $\pm 0.97\%$ among Non-Hispanic Black women and $\pm 0.69\%$ among Non-Hispanic White women; and similarly 326 for men. We similarly generated 10,000 resampled data sets, repeated grandparent caregiver loss incidence 327 and prevalence estimates on each data set, and then calculated 2.5% and 97.5% quantiles to generate 95%328 uncertainty intervals around central estimates. 329

³³⁰ S1.8 Estimates of state-level orphanhood, 2021

To guide policy at the state level, we further estimated orphanhood and grandparent caregiver loss in each 331 of the 50 U.S. states and District of Columbia. We focussed on estimating the number of children who 332 newly experienced orphanhood (incidence) and the number of children who experienced orphanhood in their 333 lifetime (prevalence) in each state in 2021, by the leading caregiver loss causes-of-death (see Supplementary 334 Table S9). To obtain state-level orphanhood prevalence estimates for 2021, as before we had to accrue 335 and age state-level orphanhood incidence estimates from 2004, and to obtain state-level fertility rates from 336 1987. Overall, we proceeded analogously as for the national estimations, but obtained data from CDC 337 WONDER CDC, 2023 as state-level mortality data were not publicly available from NCHS from 2005 338 onwards National Center for Health Statistics, 2023. Counts below 10 were suppressed in CDC WONDER 339 and for this reason we performed all estimations without stratification by standardized race & ethnicity. We 340 adjusted for data suppression, and known biases in this approach that are due to correlations in mortality 341 and fertility rates across standardized race & ethnicity. We note these are modelled adjustments and we 342 cannot exclude that this resulted in bias in state-specific orphanhood estimates. 343

We extracted annual death counts by state, sex, age bands $(15 - 19 \text{ years}, \ldots, 95 - 99 \text{ years}, > 100 \text{ years})$, and cause-of-death (ICD-10 113 Selected Causes of Death) from the CDC WONDER mortality portal CDC 2023 from 2005 to 2021; and combined these data with the previously described, cause-specific NCHS mortality data sets from 2004 for which information on the state of residence of the decedent was publicly available. Throughout, we focused only on the eight leading caregiver-loss causes of death chronic liver disease and cirrhosis, COVID-19, diseases of the heart, drug overdose, homicide excluding drug overdose, malignant neoplasms, suicide excluding drug overdose, and unintentional injuries excluding drug overdose. For the leading caregiver-loss causes of death, the average discrepancy in the state-, sex-, age-, and cause-of-death-specific data from CDC WONDER was, when aggregated to national-level and compared to the corresponding NCHS mortality data, 22.9% among women and 13.5% among men. As a first step, we imputed suppressed entries with a value of 2, which resulted in average discrepancies of 6.80% among women and 2.53% among men. To account for these discrepancies, as a second step, we adjusted the state-level

where y in 2005 to 2021, a' denotes the age band of the parent, s the sex of the parent and c the leading 344 caregiver loss cause-of-death of the parent, and $D_{y,a',s,c}$ are the national-level deaths derived from the line-list 345 NCHS data in Eq. (3), and $D_{y,a',s,l,c}$ are the state-specific deaths derived from CDC WONDER for each 346 of the 50 U.S. states and District of Columbia, indexed by l. The suppression adjusted, cause-specific, 347 state-level mortality counts matched the cause-specific, national-level mortality counts well, except when all 348 deaths $D_{y,a',s,c,l}$ were entirely suppressed across all states, which was the case for deaths due to homicide in 349 women aged 55 years or older (Supplementary Fig. S10, compare pink versus blue). Overall, these suppression 350 adjustments did not noticeably change the contribution of causes-of-death to mortality, because the majority 351 of death counts were not suppressed when the data were aggregated to leading caregiver loss causes-of-death 352 (Supplementary Fig. S11). 353

We next extracted live birth counts for mothers by state and age bands $(15-19, \ldots, 44-49 \text{ years})$ from the 354 CDC WONDER natality portal CDC WONDER, 2022 from 2005 to 2021; and combined these data with 355 the previously described NCHS live birth data sets from 1987 to 2004 for which information on the state 356 of residence of mothers was available. We proceeded analogously for fathers using the age bands 15 - 19, 357 \dots , 44 - 49, 50 - 54, 55+ years from 2016 to 2021, as natality records were not available by demographic 358 characteristics of fathers from 2005 to 2015. Data suppression was not an issue for the stratifications required 359 to estimate orphanhood: for the years 2005-2021, the average discrepancy in the CDC WONDER and NCHS 360 natality data sets was 0.026% for mothers and 0.032% for fathers (as compared to male NCHS live birth 361 data with ages up to 77 years). To compute fertility rates at the state level, we further extracted age-362 and sex-stratified annual population size estimates for each state from 1987 to 1989 from the NIH National 363 Cancer Institute Surveillance, Epidemiology, and End Results (SEER) database National Cancer Institute 364 2023; and CDC WONDER from 1990 to 2021 CDC, 2021c, 2022. State-level fertility rates were calculated 365 as in Eq. (1) when live births counts were available, but without stratification by race & ethnicity. For 366 mothers, live birth counts were not publicly available for women aged 44-49 years in several years and 8 367 states (Alaska, Delaware, Montana, North Dakota, South Dakota, Vermont, West Virginia and Wyoming), 368 and in these cases we interpolated state-specific fertility rates with locally estimated scatterplot smoothing 369 (LOESS) as implemented in the R stat package version 4.2.3 with span argument 0.85. For Wyoming, no 370 data were publicly available after 2019 and so interpolation was not possible and we used 2019 values. For 371 fathers, live births counts were not publicly available from 2005 to 2015, and for these years we estimated 372 state-specific fertility rates with LOESS with span argument 0.85, and using NCHS data from 2000 to 2004 373 and CDC WONDER data from 2016 to 2020 (Supplementary Fig. S12). 374

We then estimated state-specific incidence and prevalence of orphanhood from the suppression-adjusted state-level, cause-specific mortality counts and partially imputed fertility rates as outlined in Eqs. (7,11), with one modification. As described above the state-level mortality and fertility data were not disaggregated by race & ethnicity. To account for potential bias arising from correlations in mortality and fertility rates across race & ethnicity, we compared the national-level estimates of the number of children who newly

experienced orphanhood in (9) to the state-specific estimates with the correction factors

Overall, the correction factors $\nu_{y,s,c}$ tended to be close to one, except for Homicide excluding drug overdose in women and 'Other' caregiver loss causes-of-death (Supplementary Fig. S13). We then adjusted the state-specific estimates as follows,

We estimated the number of children who newly experienced grandparent caregiver death in year y, $y = 2004, \ldots, 2021$ from the state-level mortality records in year y of U.S. residents aged 30 years and above (30+), and assuming that each decedent who is estimated to have been a grandparent caregiver in each state

leaves a minimum of one grandchild behind. Overall, we proceeded as for the national-level estimation of 388 grandparent caregiver loss as ACS also published state-specific data on adults aged 30+ years who live with 389 grandchildren of age 17 or under United States Census bureau, 2021. For each year $y = 2010, \ldots, 2021$, 390 we calculated the expected number of adults aged 30+ years who live with their grandchildren of age 17 or 391 under by multiplying the corresponding total co-resident numbers with the sex-specific proportions for each 392 state; and then divided these with corresponding population sizes to obtain the corresponding proportions 393 $\gamma_{u.s.l.}$ Overall, these proportions were considerably more uncertain than in the national-level analysis due to 394 smaller ACS sample sizes (see below). For $y = 2004, \ldots, 2009$, we assumed that $\gamma_{y,s,l}$ is the same as in 2010. 395 We further assumed that each grandparent caregiver leaves upon death a minimum of one child behind 396 (corresponding to Eq. (2)) and estimated the minimum number of grandchildren who newly experienced 397 grandparent caregiver death in year $y = 2004, \ldots, 2021$, with a U.S. resident grandparent caregiver aged 398

To estimate the minimum number of children who experienced grandparent caregiver death in their lifetime in each state, we additionally need disaggregations of Eq. (17) by single year of age b = 0, ..., 17 years. For the central analysis, we assumed that the age composition of $G_{y,s,l,c}^{\text{new}}$ is the same as the age composition of children who lost parents older than 30 years in the same state,

⁴⁰⁸ S1.9 Uncertainty quantification in state-level estimates

This section describes how we derived uncertainty intervals in the state-level estimates of orphanhood incidence and prevalence (Eqs. (711)) and grandparent caregiver loss (Eq. (13)). Overall, the approach here is similar to the national-level uncertainty analysis.

We added Poisson noise around state-specific mortality, natality, and population size data for all year, sex, age, and cause-of-death strata. We generated 10,000 Poisson noise data sets, repeated orphanhood incidence and prevalence estimates on each data set, and then calculated 2.5% and 97.5% quantiles to generate 95% uncertainty intervals around central estimates.

To estimate grandparent caregiver loss, we accounted for uncertainty in the estimated number of adults aged 416 30+ years living with grandchildren by U.S. state using published uncertainty ranges. The ACS provides 417 for each of their state-specific estimates margins of error that correspond to 90% confidence intervals. We 418 converted the 90% margins of error into standard deviations and bootstrap re-sampled the available totals 419 and separate proportions 10,000 times assuming normal distributions around their central estimates and the 420 corresponding standard deviations, and then multiplied the sampled totals and proportions. As expected 421 given available ACS sample sizes, across years we found that uncertainty in the proportions $\gamma_{y,s,l}$ was in 422 some states considerably larger than for the national race & ethnicity-specific analysis, with 95% bootstrap 423 intervals of up to $\pm 13.5\%$ of the central estimates (Supplementary Fig. S15). We similarly generated 10,000 424 resampled data sets, repeated grandparent caregiver loss incidence and prevalence estimates on each data 425 set, and then calculated 2.5% and 97.5% quantiles to generate 95% uncertainty intervals around central 426 estimates. 427

S1.10 Estimates of racial & ethnic groups impacted by leading causes of caregiver loss in U.S. states, 2021

Characterizing the racial & ethnic groups of children that are impacted by orphanhood and grandparent 430 caregiver loss at state-level is challenging due to limits in publicly available data. We focused on estimating 431 and comparing 2021 orphanhood and grandparent caregiver loss prevalence rates by standardized race & 432 ethnicity in the 10 U.S. states with highest orphanhood prevalence rates and for the primary (first-ranked) 433 caregiver-loss cause-of-death only, West Virginia ('Drug overdose'), New Mexico ('Drug overdose'), Mississippi 434 ('Unintentional injuries'), Louisiana ('Drug overdose'), Kentucky ('Drug overdose'), Tennessee ('Drug overdose'), 435 Alabama ('Diseases of heart'), Oklahoma ('Unintentional injuries excluding drug overdose'), Ohio ('Drug 436 overdose') and Florida ('Drug overdose'). Throughout, we obtained publicly available data from CDC 437 WONDER CDC, 2023 from 2005 onwards National Center for Health Statistics, 2023 and adjusted for 438 data suppression, but note these are modelled adjustments and we cannot exclude that this resulted in bias 439 in state-specific orphanhood estimates. 440

Annualized live birth counts were extracted as described for the state-level analysis for 2005 to 2019, but now 441 also stratified by bridged-race and Hispanic origins, and then combined with NCHS live births data from 442 1987 to 2004. For 2020-2021, live birth counts to women were not available by bridged-race at state-level. 443 Analogously, annual death counts for the leading caregiver loss causes-of-death were compiled as described 444 above for 2005 to 2021, and stratified into the standardized race & ethnicity categories in Supplementary 445 Table 57, and then combined with the NCHS mortality data sets from 2004. Suppressed values were imputed 446 by 1 and adjusted further for suppression as in Eq. (14). We followed previous criteria on data reliability 447 and excluded from consideration for each state those race & ethnicity groups that had more than two age 448 bands with fewer than 20 live birth counts Mathews and Hamilton 2019. Supplementary Table S6 lists the 449 corresponding strata as 'small populations', and also describes the average completeness of live birth records 450 for the years 1995-2004 when directly comparable line-list live birth records were also available from NCHS. 451 For the remaining year-state-sex-race & ethnicity strata, we considered the corresponding mortality data for 452 the leading caregiver-loss cause-of-death. Again, we excluded from consideration those standardized race & 453 ethnicity groups that had more than two age bands with fewer than 20 death counts Mathews and Hamilton 454 2019. Supplementary Table S6 lists the corresponding strata as 'small death counts', and also describes 455 the average completeness of death records for the years 1999-2004 when directly comparable line-list death 456 records were also available from NCHS. Supplementary Fig. 516 illustrates the state and standardized race 457 & ethnicity specific live birth data from CDC WONDER, the line-list live birth data from NCHS and the 458 state and standardized race & ethnicity specific live birth data for the three states with highest orphanhood 459 prevalence rates in 2021. Similarly, Supplementary Fig. \$17 illustrates the state and standardized race & 460 ethnicity specific mortality data from CDC WONDER for the primary caregiver loss cause-of-death, the 461 line-list live death from NCHS and the adjusted state and standardized race & ethnicity specific mortality 462 data for the three states with highest orphanhood prevalence rates in 2021. Population-size estimates for each 463 state were obtained from the CDC WONDER population size portal for 1990 to 2021 CDC, 2021c, 2022 464 by bridged-race, and converted to the standardized race & ethnicity categories described in Supplementary 465 Table S11 466

We estimated race & ethnicity- and state-specific incidence and prevalence of orphanhood as outlined in Eqs. (7,11), except that female race & ethnicity- and state-specific fertility rates in 2020-2021 were as assumed to be as in 2019 due to limitations in publicly available data. To investigate estimation accuracy, we compared the resulting sum of the race & ethnicity- and state-specific orphanhood incidence estimates to the previous state-specific orphanhood incidence estimates (Supplementary Fig. S18). For Alaska and Oklahoma, the sum of the race & ethnicity- and state-specific orphanhood incidence estimates was more than 20% below the state-specific orphanhood incidence estimates attributable to the leading caregiver loss

474 cause-of-death. Supplementary Table S6 lists these states as 'large discrepancy in estimates'. The table

477 S2 Sensitivity analyses

Sensitivity in mortality data. In the central analysis, we derived mortality counts by year, sex, age 478 band, standardized race & ethnicity and caregiver loss causes-of-death from NCHS line-list mortality records 479 from 1983 to 2021. Aggregate mortality counts are also available from CDC WONDER CDC [2023] from 480 1999 to 2021. We extracted data from the NCHS Vital Statistics portal because this allowed us to use the 481 same data source across all years, bypass data suppression, and incorporate uncertainties in standardized 482 race & ethnicity reporting. The CDC WONDER mortality counts allowed us to check our in-house data 483 aggregations, if we obtain data from CDC WONDER at coarser population strata. For this purpose, we 484 extracted annual death counts by sex, and age bands (15-19 years, \ldots , 95-99 years, >100 years) from the 485 CDC WONDER mortality portal CDC 2023 from 2000 to 2021. The overall mortality counts that we 486 aggregated from the NCHS line list data were identical with the CDC WONDER mortality data without 487 cause-of-death stratification. Secondly, we extracted annual death counts by sex, age bands (15-19 years, 488 ..., 95-99 years, >100 years) and cause-of-death (ICD-10 113 Selected Causes of Death) from the CDC 489 WONDER mortality portal CDC 2023 from 2000 to 2021, without stratification by race & ethnicity. We 490 then compared the mortality counts from the two data sources for each year and the leading caregiver loss 491 causes-of-death (Supplementary Fig. S19). We found that across years, the maximum discrepancy in the 492 CDC WONDER counts relative to the NCHS mortality counts was 0.0068% in women and 0.0057% in men, 493 which reflected data suppression especially due to homicide excluding drug overdose in women, and overall 494 indicated consistency of our data with that from CDC WONDER. 495

Sensitivity in live births data. In the central analysis, we derived live birth counts by year, sex, age 496 band, and standardized race & ethnicity from NCHS line-list natality records from 1969 to 2021. Aggregate 497 live birth counts are also available from CDC WONDER CDC WONDER [2022] from 1995 to 2021. We chose 498 to extract data from the NCHS Vital Statistics portal because this allowed us to use the same data source 499 across all years. The CDC WONDER live birth counts allowed us to check our in-house data aggregations. 500 For this purpose, we extracted annual live birth counts from the CDC WONDER natality portal for women 501 by age bands 15-19 years, ..., 45-49 years from 2000 to 2021, and separately for men by age bands 15-19 years, 502 ..., 55+ years from 2016 to 2021 without stratification by race & ethnicity, which avoids data suppression. 503 We then compared the live birth counts from the two data sources for each year and found that both data 504 sets matched across all years. 505

Sensitivity in national-level orphanhood estimates to assumptions on historic fertility rates. In 506 the central analysis, we assumed that male and female fertility rates by age and standardized race & ethnicity 507 were in 1966-1989 constant and as in 1990 (Supplementary Fig. S7). This assumption was made because 508 population size data stratified by detailed race categories (more than three categories) were not publicly 509 available before 1990. Considering that age- and sex-specific live births data were available by race & ethnicity 510 since 1978, we estimated in this sensitivity analysis the historic composition of population sizes by race & 511 ethnicity in 1980-1989, and then updated the corresponding fertility rates and national-level orphanhood 512 incidence and prevalence estimates. More specifically, we considered time trends in the proportion of each 513 race & ethnicity in each 5-year age band and both sexes in the U.S. intercensal population size estimates 514 in 1990 to 1995 (Supplementary Fig. S20A), and extrapolated these with linear models backwards in time 515 to 1980-1989. We do not think that this estimation approach resulted in accurate estimates of population 516 sizes, but rather that this approach conveys possible sensitivities in our orphanhood estimates. We identified 517

minor sensitivities to national orphanhood prevalence estimates up to 2007, with no impact on incidence and prevalence estimates for recent years (Supplementary Fig. S20).

indicated consistency of our data with that from CDC WONDER.

Sensitivity in national-level orphanhood estimates to potentially correlated fertility rates. In 520 the central analysis, we assumed that population-level fertility rates were not correlated with population-level 521 mortality rates. We considered in sensitivity analyses possible deviations from this assumption that might 522 lead to upwards bias in our central estimates. For example, a person who died in year y may have experienced 523 poor health in the preceding years $y = 1, y = 2, \dots$ and in this case may also have been less likely to mother or 524 father a child in years $y, y = 1, y = 2, \ldots$ We modelled this possibility through four scenarios of dampened 525 fertility rates close to individual death events. Specifically, we considered cumulative logistic adjustment 526 factors that dampened fertility rates to either zero or half of the corresponding population-level, year-, age-, 527 sex-, and standardized race & ethnicity-specific fertility rates in the year of death y. We also considered 528 sensitivity analyses so that the onset of lower fertility rates preceded the year of death y by 1 or 3 years as 529 shown in Supplementary Fig. S21A. We found that orphanhood incidence estimates were up to 8.4% lower 530 than in the central analysis, and orphanhood prevalence estimates were up to 15% lower than in the central 531

analysis (Supplementary Fig. S21B). It is also possible that our central orphanhood estimates might be biased downward. For example, women experiencing premature death are more likely economically disadvantaged and in turn are more likely to have had reduced access to contraceptives and corresponding higher fertility rates Price et al., 2013, or earlier sexual debut resulting in higher cumulative fertility until death. It is also possible that overall, at population-level, there is no strong correlation between fertility and mortality rates especially as the lag between birth and death events is typically relatively large, and in the absence of data we have opted for this middle approach in the central analysis.

Sensitivity in national-level grandparent caregiver loss estimates to assumptions on the age of children experiencing loss of a grandparent caregiver. In the central analysis, we considered in Eq. (13) as a proxy to the age composition of children experiencing grandparent caregiver loss the age composition of children experiencing orphanhood. Calculations were done independently for each leading caregiver loss cause-of-death. We performed two analyses to characterise the sensitivity of this approach to

national-level grandparent caregiver loss estimates. First, we repeated calculations using as proxy the age
 composition of children experiencing orphanhood across all causes of caregiver loss, i.e.

Second, we used data from the 'Topical survey' of the National Survey of Children's Health (NSCH) 546 Census Bureau, 2023a, filtered to respondents reporting to be grandparents and living with at least one 547 child in the household. Respondents were asked to report on demographic characteristics including the age 548 and race & ethnicity of one randomly selected child. We pooled these data across six years from 2016 to 549 2021 to characterise the age composition of children who live with grandparents due to small sample sizes in 550 each survey after filtering (approximately 2,500 grandparents per survey round). Supplementary Fig. S22A 551 compares the age compositions used in the central analysis to those in the two sensitivity analyses. The 552 comparison of the grandparent caregivers prevalence estimates are shown between the central estimate and 553 two sensitivity analyses by age of child in Supplementary Fig. S22B. We found that grandparent caregiver 554 incidence estimates deviated by up to $\pm 0.028\%$ and $\pm 0.032\%$ of the central estimate in the two sensitivity 555 analyses due to the rounding numbers, respectively. Additionally, in the two sensitivity analyses, grandparent 556 caregiver prevalence estimates were respectively 12.0% fewer and 13.6% higher than in the central analysis. 55

Sensitivity in national-level caregiver loss estimates to assumptions on historic numbers of grandparent caregivers. In the central analysis, we assumed that the proportion of adults aged 30+ years who live with their grandchildren of age 17 or under (denoted $\gamma_{y,s,r}$) was the same in the years $y = 1983, \ldots, 2009$ as in 2010. This assumption was made because data were not available prior to 2010. To investigate the implications of this assumption, we considered longitudinal United Nations Population Division data on Households and Living Arrangments of Older Persons for the U.S. since 1960 United ⁵⁶⁴ Nationa Population Division 2022. These data indicate that the proportion of older persons who live with
 ⁵⁶⁵ children or who are the primary caregivers of children has in the U.S. remained fairly constant since 1980
 ⁵⁶⁶ (Supplementary Fig. S23), and for this reason suggests that our assumptions on the historic number of

⁵⁶⁷ grandparent caregivers is unlikely to have a substantive impact on caregiver loss estimates.
