51 Background

Seasonal influenza has an estimated global reach of 3 to 5 million infections with 290 000 to 650 000 52 influenza-related deaths yearly. Despite its efficacy in reducing morbidity and mortality, influenza vaccination 53 54 rates remain low globally and in South Africa. Youth between the ages of 18-34 years are not prioritised for influenza vaccines although influenza surveillance in South Africa shows that individuals aged 19 to 44 55 present the highest asymptomatic episodes and the lowest medically attended illness. This creates an 56 57 opportunity to investigate if and how vaccine demand can be created in the absence of clear imperatives to 58 vaccinate. Enhancing perceptions of, bolstering confidence in, and fostering uptake of vaccination relies heavily on the efficacy of yearly influenza vaccination initiatives, personalized education tailored to specific contexts, active community involvement, consistent vaccine availability, and easily accessible, cost-free distribution channels at the local level.

101 Introduction

102 Globally seasonal influenza causes an estimated 3-5 million infections, and 290 000-650 000 deaths annually [1, 2]. Estimates for influenza burden of disease are limited in Africa; however, hospitalisation and mortality 103 are higher in low- and middle-income countries (LMICs) than in high-income countries (HICs) [3, 4]. In South 104 Africa, an estimated 6 000-11 000 people die from influenza every year, with approximately half of these 105 deaths in the elderly, and people living with HIV [5]. Seasonal outbreaks of influenza pose challenges to the 106 healthcare system, leading to increased hospitalizations, outpatient visits, and strain on healthcare resources 107 108 [6]. Vulnerable populations, including the elderly, young children, pregnant women, and individuals with 109 underlying medical conditions are at highest risk of severe infection [7].

111 While non-pharmaceutical interventions can play a role in decreasing influenza infections, vaccination is 112 deemed pragmatic and endorsed by the World Health Organization (WHO) as the recommended method for preventing seasonal influenza [1]. Overall vaccine efficacy to prevent influenza infection ranges from 40-113 60%, with higher vaccine efficacy (82%) in reducing severe illness and hospitalization [8, 9]. Therefore, the 114 115 influenza vaccine is especially recommended for those who have chronic illnesses, those who are pregnant, and the elderly [10-12]. Influenza vaccination campaigns typically prioritize these groups during the influenza 116 117 vaccination season [7, 13]. An estimated annual cost of \$111.3 million is incurred by the government, while out of pocket costs incurred by the patient were reported to be \$40.7 million [17]. Individuals are at risk 123 124 of financial loss due to absence at work and missed opportunity for those who are self-employed [18]. Despite recommendations, seasonal influenza vaccine uptake, in the most vulnerable groups, is low in LMICs, 125 including South Africa [19]. Accessibility, lack of knowledge and risk perception have been cited as the most 126 127 significant barriers to vaccination in South Africa [20].

129 Despite the demonstrated effectiveness of vaccines in significantly reducing morbidity and mortality of affected individuals, youth are less proactive in health-seeking behaviours due to low risk perception, are not 130 131 necessarily encouraged to vaccinate for influenza and other infectious diseases [9, 21-23]. For COVID-19, youth were not initially prioritised for vaccination roll-out yet they might have been in contact with vulnerable 132 133 populations [24, 25]. Additionally, evidence suggests that low vaccination rates are in part due to low health-134 seeking behaviours among youth. Health-seeking behaviours are the actions involved in achieving and 135 maintaining a healthy condition. [26, 27]. Various factors, both individual and related to healthcare providers, 136 can influence young people's healthcare-seeking behaviours [28].

137

138 Targeted health promotion interventions can increase health-seeking behaviour and uptake of vaccination [29]. 139 Influenza surveillance shows that individuals aged 19 to 44 present the highest asymptomatic episodes and the lowest medically attended illness [14, 30]. Studies undertaken in sub-Saharan Africa have shown that 140 leveraging community involvement in immunization programs positively contributes to vaccine confidence 141 142 and uptake [31, 32]. In the case of HIV, for example, awareness campaigns to lower the burden of HIV and AIDS epidemics in Southern African countries have proven vital in reducing the rise of disease [33]. The use 143 of television series to promote positive sexual health and prevent HIV effectively engaged the youth by 144 challenging old models of education [34]). The use of social media campaigns have also been increasingly 145 146 used to promote behaviour change [35, 36], while sparking debate, especially when considering the abundance 147 of false and misinformation [37]. It is vital to consider the significance of social media to improve vaccine 148 uptake in LMICs.

150 Promoting health care through various platforms and to youth in LMICs may improve uptake of vaccination. communications researchers, community influence and engagement practitioners, and marketing and 153 154 communication strategists, we aim to:

155

156 (1) Evaluate the impact of influencer's online, offline, and in collaboration, on influenza vaccine uptake, with

a specific focus on young people, and assess the additional value added by social media engagement; 157 (2) To design and implement an integrated communications strategy centred around community influencers 158

and social media to increase the uptake of influenza vaccines, particularly among younger populations who 159 160 are likely unemployed, partially or informally employed and living in Soweto, South Africa;

(3) To explore motivations and barriers to health priorities, and to influenza vaccination, through the use of 161 micro-influencers both online and offline in Soweto, South Africa. 162

163

164 The outcomes of the project will include increased influenza vaccination rates at the local healthcare clinics linked to campaign interventions, alongside an improved attitude towards the importance of vaccination in the 165 target audience - this will be assessed using the Vaccine Confidence Index scale [38] and measured against the 166 most recent Vaccine Confidence Index data from South Africa [39]. Additionally, the project will provide 167 important health systems-strengthening recommendations which could potentially be implemented within 168 current infrastructure. 169

171 **Materials and Methods**

172 **Research Design**

The primary research aim uses a prospective mixed methods study design including qualitative and 173 quantitative data collection, to assess the effects of community and social media interventions to increase 174 influenza vaccination uptake among youth in Soweto. South Africa. During the intervention phase, surveys 175 will be conducted among clinic attendees accepting as well as declining influenza vaccination within the study 176 177 clinics.

178 Study setting

179 The study is conducted in Soweto (South-Western Townships) which is a congregation of 29 townships within the Johannesburg Metropolis in South Africa [40]. Soweto is one of the poorest areas of Johannesburg with 180 high rates of youth unemployment which is at 46.3% among the 15-34 year age group [41] 181


The Bambisana Project leverages the Soweto Health Demographic Surveillance System (HDSS), led by Wits 184 VIDA since 2017 and part of the Child Health and Mortality Prevention Surveillance programme (CHAMPS). 185 provides access to longitudinal health and demographic data for specific enumerated areas of Soweto and the 186 South of Johannesburg, since 2017[42]. The study population includes young adults 18-34 years from four 187 HDSS economically marginalised and geographically distinct Soweto communities: namely Phiri/Senaoane 188 and Mapetla, Mofolo and Meadowlands, Thulani, and neighbouring Thembelihle. Adults (18 years and older), 189 living in these clusters or accessing clinic services in the five study clinics (Senaoane Clinic. Mofolo 190 Community Health Centre, Meadowlands Zone 2 Clinic, Siphumlile Clinic, and Thembelihle Clinic) are 191 deemed eligible for the study. The HDSS communities were included as below (Table 1): 192

199 **Community engagement**

The Bambisana [an isiZulu word – which means to work together] study leverages active, long-standing, 200201 dynamic community-level relationships and partnerships in accessing community insights at the household local clinic level. The Wits VIDA social behavioural sciences team has longstanding relationships through 202 and Community Advisory Boards (CAB) and extensive community engagement in support of health research 203 204 objectives throughout Soweto. CAB members are individuals residing in the HDSS enumerated areas who 205 have been identified as active citizens in their communities. There are standing quarterly CAB meeting with the study team and members, however, these often increase in relation to shifting project activities. 206Consultations span project development, implementation, and community feedback sessions at the end of data 207collection, analysis and interpretation. 208

210 Formative qualitative data collection

The qualitative component includes 16 focus group discussions (FGD) stratified by age group (18-24, 25-34), sex (male and female) and community (two per cluster). These approaches aim to gather contextual data essential for understanding the factors influencing young people's decisions regarding influenza vaccination, including both motivators and barriers.

Study staff will purposively select and recruit young people for FGDs and key stakeholders/influencers from the community for key informant interviews (KIIs). FGD recruitment will be iterative until data saturation is achieved [43]. All study participants will be recruited through the Community Advisory Board members who work with HDSS communities. Trained and experienced qualitative researchers fluent in local languages spoken in Soweto and Thembelihle (including isiZulu and Sesotho) will conduct the qualitative research using the participants' language of choice. Intervention 228

229 The intervention will be delivered through a public health messaging campaign in targeted clusters or 'subplaces' in Soweto, leveraging micro-influencers to provide information and motivate positive attitudes for 230 231 vaccination without mandate in currently unvaccinated populations. The aim of the campaign is to create a 232 behavioural change action: to go to your local clinic to get vaccinated. This has the secondary aim of 233 highlighting the extent to which such interventions might be possible on wider issues of public health in the 234 future. Secondary to this is the desire to investigate the value-add of social media targeting over wider forms 235 of engagement, such as that which occurs in communities offline.

236 The campaign will be timed with points when the clinic is well supplied and prepared for such a public drive. 237 The project will mitigate against the risk of potential vaccine shortages by making vaccine donations to partner clinics. The study will centre around the 2023 national influenza vaccination drive in 2023. Vaccines are 238 239 generally provided in very short and sporadic supply to the local community clinics, so supplying vaccines is also part of the objective to make community-level impact as part of the project. 240

241 The intervention will be implemented after community engagement discussions have been conducted to obtain 242 information which would be used to design the messaging and communication strategy. Surveys will be 243 administered prior to, during, and following the communication interventions to establish baseline, midline, 244 endline measures for evaluating the intervention's impact. This will help assess the effectiveness of four and 245 distinct approaches aimed at boosting influenza vaccine uptake among youth across clinics in four diverse 246 HDSS clusters.

- 1. Standard of care: Vaccine made available with standard government promotional activity without 247 248 support from the project (i.e., based on standard government drive).
- 249 2. Social media: Social media campaign to highlight availability and drive to get vaccinated pushed to the target audience. 250
- 251 3. Micro-influencers on and offline: The social media campaign will be amplified through a coordinated effort by micro-influencers in their online and offline networks. 252

257 1) Social media campaign to highlight availability and drive to get vaccinated pushed to the target 258 audience (under 35s) in four distinct geographic areas

259 Utilizing Meta platforms Facebook and Instagram, along with other relevant social media channels identified through community engagement and marketing insights, we will disseminate information through static 260 images, carousel posts, and video posts to promote the availability of, education around, and motivation to get 261 vaccinated. Paid advertising on Meta will target people aged 18-34 in two of the four distinct geographic study 262 263 clusters.

264

2) Micro-influencers on and offline: The social media campaign will be amplified through a coordinated 265 effort by micro influencers in their online and offline networks 266

267 We will use community influencers - people with traditional influence such as community leaders, religious leaders, elders, and key business leaders - to amplify our social media campaign. They will engage their online 268 offline networks in coordination with our social media campaign to promote vaccine availability and 269 and 270 encourage vaccination.

273 3) Offline micro-influencers: Non-social media focused; offline micro-influencer led engagement within 274 communities

- In these communities, our community influencers will focus only on offline engagement and will be 275 276 specifically instructed to not do anything on social media. Using interpersonal conversations, and small-scale
- community events to share the importance of vaccines, they will encourage people to get vaccinated. 277
- 278

279 **Quantitative Data Collection**

Quantitative data collection will include five survey data points as outlined below. 280

surveys will be developed using the REDCap software, a computer-assisted survey platform with built-in 281 282 data encryption [44]. All surveys will be completed using dedicated study tablets which means participants would not be required to use their own internet data. Additionally, we will use a data-free survey completion 283 284 option. The survey links would also be sent to participants who wish to complete the surveys on their own 285 devices. There will be no data costs to participants for completing the assessments. Participants will be reimbursed ZAR 50 airtime towards their time. 286

A) Household surveys include two time points of data collection, a pre- and post-test design, as described 287 below. 288

289 Sampling

Households were chosen through a simple random sampling method, and eligible participants were enrolled 290 291 as follows: a minimum of 800 adult men and women aged 18 years and above, with 400 designated for the 292 pre-test and 400 for the post-test. At least 100 households with index participants aged 18-34 years will be approached per community. Non-index participants, include other adults in the households who are aged 18-293 294 34, 35-49 and 50 years and older who will also be invited to complete surveys.

Pre-test and post-test surveys: Using a random sample of households having youth participants (18-34 years) 295 296 generated from the HDSS database, adults will be approached in their households to complete a 15 minute online pre-test assessment survey to measure: socio-demographics (age, gender, food security, potential loss 297 298 of income), knowledge of influenza vaccines and benefits, health beliefs and sources of health information (social media, television, radio, friends and family), and vaccine confidence[45]. The same households will 299 be invited to participate in the post-test household survey. The post-test household survey will be conducted 300 301 after the study campaign intervention.

- B) Clinic surveys include data collection with vaccinators and those who declined vaccination as 303 described below: 304

Vaccinated: All adults 18+ years, who received an influenza vaccination will be approached as such numbers 305 may vary as this depends on who elects to vaccinate. However, a total of at least 400 (n=100 per community) 306 youth (aged 18-34) participants who go to the intervention clinics will be purposively approached to complete 307 a post vaccination assessment. The study team will work closely with healthcare workers at public health 308 clinics in the study communities. Healthcare workers will refer patients after having received the influenza 309 vaccine, on site at the clinics. These participants will be invited to complete a brief survey using the same 310 measures as specified for the pre-test survey. The data will be covered as part of the project expenses. There 311 will be no data costs to participants for completing the assessments. Participants will be reimbursed ZAR 50 312 313 airtime towards their time.

Additional measures will assess: motivations for influenza vaccines, where participants heard/learned about 315 this or other drives for the influenza vaccination, if participants had seen any online messaging driving them 316 to get the influenza vaccine or been exposed to specific community engagement activities, and whether it had 317

influenced their decision to vaccinate, and online impressions, for example, video views rates (dependent on 318

319 final campaign strategy and media mix) and their impact on vaccinations in that region. Uptake of influenza vaccines will be tracked in the four clusters across the study period. 320

321 322 **Clinic attendees who decline vaccination** will also be approached to complete surveys. These participants will be 18+ years. Healthcare workers will refer patients who were offered vaccination as part of their clinic 323 324 attendance but who declined vaccination. Those participants who agree to participate will be invited to complete a brief survey to understand reasons for declining vaccination. The survey measures will include: if 325 326 and where participants heard/learned about this drive for the influenza vaccination, if participants had seen 327 any online messaging driving them to get the influenza vaccine or been exposed to specific community engagement activities, and whether it had influenced their decision to vaccinate. 328

329 330 As with all the surveys, the data costs will be covered as part of the project expenses. There will be no data 331 costs to participants for completing the assessments. Participants will be reimbursed ZAR 50 airtime towards 332 their time.

- C) Oualitative evaluation

335 Additional FGDs, including 10-12 participants per FGD, will be conducted: 8 mid-way through the 336 intervention (during vaccination season) and 8 post-intervention. These FGDs will be mixed gender and will 337 be stratified by age group (18-24, 25-34), and community (two per cluster). Key informant interviews (KII) 338 (n=20) with key influencers including, religious leaders, traditional healers and youth leaders, as well as other 339 influencers that may identified through community engagement and communications activities.

342 **Oualitative data preparation and analysis plan**

343 Qualitative data will be analysed using a Framework Analysis approach. Framework thematic analysis provides a highly systematic method of categorizing and organizing data according to key themes, concepts 344 345 emergent categories in grids or matrices [46]. The coding will follow a combined approach, i.e. both deductive based on our hypothesized themes and inductive (data-driven) to allow for emerging themes. The 346 analysis will allow us to further refine the domains and will help identify sub-themes. Each transcript will be 347 348 coded in Dedoose, a qualitative data analysis software by at least two researchers and assessed for consistency 349 in coding of the first 5 transcripts [47]. The research team will convene to review the initial codes and apply general categories that will make up the analytic framework. Any coding disagreements will be discussed until 350 351 agreement is reached. This analytical framework will then be applied to the remaining transcripts.

353 We will use descriptive statistics to describe study variables including: knowledge of influenza vaccines, 354 experiences of influenza vaccine, stigma and vaccine confidence. Data will be analysed overall and stratified by community cluster. Frequencies will be 356 357 determined for categorical measures whereas means (standard deviation) and medians (interquartile ranges) 358 will be determined for continuous measures. Pairwise comparisons of categorical measures between communities will be evaluated by Chi-square or Fisher's exact test as appropriate; Similarly, pairwise 359 continuous measures will be analysed by the two-sample t-test, if satisfying normality distribution conditions 360 or the Wilcoxon Mann-Whitney test, if non-normal. Normality will be assessed by the Shapiro-Wilks method. 361 Drivers of knowledge, stigma and experiences of influenza vaccines will be determined by logistic regression 362 for binary outcomes and linear regression for continuous outcomes. Multivariable analysis will be done to 363 adjust for potential confounders. Model fit statistics will be assessed on all multivariable regression models to 364 ensure the validity of the findings. Data analyses will be conducted using SAS Enterprise Guide 7.15 [48]. 365

367 **Ethics statement**

All research procedures were approved by the University of the Witwatersrand Human Research Ethics 368 Committee (Medical) (M230254) and the local Department of Health. Participants were reimbursed ZAR 50 369 370 airtime for the surveys and ZAR 150 for the FGDs and the KIIs.

371 **Bias correction**

372 While the study is designed to focus on four relatively distinct geographic areas, due to the nature of social 373 media and health-seeking behaviours in the broader community of Soweto, it is possible that members from 374 the intervention communities may interact with those not receiving the intervention. While potential 375 interaction cannot be prevented entirely, research questions for all participants will include questions about 376 exposure to intervention components and other potentially similar national or localised campaigns. In addition, a phased delivery of the interventions to ensure the offline intervention is not biased by the online intervention 377 378 should help mitigate this.

It is also possible that those exposed to the intervention(s) may seek to be vaccinated in clinics that are not 379 380 included in the study's geographically defined target-areas. An effort will be made to collaborate with the

381 Department of Health to broadly understand influenza vaccinations during the campaign season, in broader 382 Soweto and areas where residents typically seek healthcare. Vaccine and vaccination sentiments broadly in

383 Soweto and South Africa will also be tracked during the course of the project for context and monitoring of

384 potential risk.
