91 92	Background: Identification and assessment of modifiable risk factors for dementia is a public health
93	priority in Canada and worldwide. We investigated the prevalence and population attributable fraction
94	(PAF) of 12 potentially modifiable risk factors for all-cause dementia in middle-aged and older
95	Canadians.
96	Methods: We conducted a cross-sectional study of data from the Comprehensive cohort of the
97	Canadian Longitudinal Study on Aging, a national sample of 30,097 individuals between the ages of 45
98	and 85 at baseline (2011-2015). Risk factors and associated relative risks were taken from a highly cited
99	systematic review published by an international commission on dementia prevention. We estimated the
100	prevalence of each risk factor using sampling weights to be more generalizable to the Canadian
101	population. Individual PAFs were calculated both crudely and weighted for communality, and combined
102	PAFs were calculated with methods reflecting both multiplicative and additive interaction assumptions.
103	Analyses were additionally performed stratified by household income and were repeated at CSLA's first
104	three-year follow-up (2015-2018).
105	<b>Results:</b> The most prevalent risk factors at baseline were physical inactivity (63.8%; 95% Cl, 62.8% –
106	64.9%), hypertension (32.8%; 31.7% – 33.8%), and obesity (30.8%; 29.7% – 31.8%). The highest crude
107	PAFs were for physical inactivity (19.9%), traumatic brain injury (16.7%), and hypertension (16.6%). The
108	highest weighted PAFs were for physical inactivity (11.6%), depression (7.7%), and hypertension (6.0%).
109	We estimated that the 12 risk factors combined accounted for 43.4% (37.3%-49.0%) of dementia cases
110	assuming weighted multiplicative interactions and 60.9% (55.7%-65.5%) assuming additive interactions.
111	There was a clear gradient of increasing prevalence and PAF with decreasing income for 9 of the 12 risk
112	factors.
113	Interpretation: The findings of this study can inform individual and population-level dementia

114 prevention strategies in Canada, focusing efforts on risk factors with the largest impact on the number

115	of dementia cases. Differences in the impact of individual risk factors between this study and other
116	international and regional studies highlight the importance of tailoring national dementia strategies to
117	the local distribution of risk factors.

### 120 Introduction

121 Dementia is a clinical syndrome marked by typically progressive cognitive decline, affecting memory,

122 perceptual-motor skills, language, mood, behaviour, and the ability to perform activities of daily living <sup>1–</sup>

123 <sup>3</sup>. In Canada, the number of people living with dementia was estimated to be 597,000 in 2020 and is

124 expected to increase to 1.7 million by 2050<sup>4,5</sup>. The increase in the number of individuals living with

125 dementia will also greatly affect families and care partners who provide extensive hours of unpaid care<sup>5</sup>.

126 Total health system and out-of-pocket costs for dementia care in Canada are currently estimated to be

127 \$10 billion and the rising number of individuals living with dementia will have a substantial effect on

128 health and social care systems<sup>4,5</sup>. Effective treatment options for dementia are limited, placing an

129 emphasis on the importance of prevention<sup>1,5</sup>. The effectiveness of prevention strategies, however, is

130 dependent on identifying and understanding potentially modifiable risk factors associated for dementia

131 as well as their prevalence and distribution within a population<sup>5</sup>.

132The 2020 report of the Lancet Commission on dementia prevention, intervention, and care133identified 12 potentially modifiable risk factors<sup>6</sup>: less education, hearing loss, traumatic brain injury134(TBI), hypertension, excessive alcohol consumption, obesity, smoking, depression, social isolation,135physical inactivity, air pollution, and diabetes. They estimated that each risk factor accounted136individually for between 2.0% to 22.0% of dementia cases and together accounted for 40% of dementia137cases worldwide<sup>6</sup>. The distribution of modifiable risk factors for dementia has been has been examined138in detail in other countries to inform national and regional public health strategy<sup>6-8</sup>. - 140 factors being highlighted in Canada's national dementia strategy<sup>9</sup>. In addition, while lower socio-
- 141 economic status is associated with increased dementia incidence, little work has examined how the
- 142 prevalence of modifiable risk factors for dementia varies by income<sup>10</sup>.
- 143 The objective of this study is to examine the prevalence and impact of potentially modifiable risk
- 144 factors for dementia in Canada based on data from the Canadian Longitudinal Study on Aging (CLSA).
- 145 Our specific aims are to estimate 1.) the prevalence of 12 potentially modifiable risk factors for all-cause
- dementia in the Canadian middle-aged and older adult population and 2.) the proportion of dementia
- 147 cases attributable to each risk factor, i.e. the population attributable fraction (PAF), alone and in
- 148 combination. Secondarily, we will examine how the distribution of these risk factors varies by household
- 149 income.

#### 151 Methods

- 152 Setting and study type
- 153 We conducted a cross-sectional study of middle-aged and older adults in Canada.

#### 154 Data Sources

155The Canadian Longitudinal Study on Aging (CLSA) is a national, stratified sample of 51,338156Canadian residents between the ages of 45 and 85 at baseline recruitment (2011-2015). Participants in157CLSA were recruited via three sampling frames (the Canadian Community Health Survey, random-digit158dialing, and provincial health registries). The CLSA is comprised of two cohorts, Tracking and159Comprehensive. This study uses data only from the Comprehensive cohort as the calculation of all 12160risk factors of interest is not possible on the Tracking cohort. Comprehensive cohort participants161(n=30,097 at baseline) were randomly selected within proximity of 11 data collection sites in 7 provinces

162 (Newfoundland and Labrador, Nova Scotia, Ontario, Quebec, Manitoba, Alberta, British Columbia) with

163	data collected in-person during home interviews and at the data collection sites. The methodology and
164	sampling strategy of the CLSA has been fully described elsewhere $^{11,12}$ . Air quality data were collected
165	and provided by the Canadian Urban Environmental Health Research Consortium and Health Canada
166	and linked to participants by postal code and interview date <sup>13</sup> .
167	
168	Study participants
169	We included all Comprehensive cohort participants at baseline (2011-2015) and follow-up 1
170	(2015-2018). At the time of recruitment CLSA participants had to be able to complete interviews in
171	English or French and be able to participate in the study on their own. Residents of the three Canadian
172	territories, First Nations reserves, or institutions; full-time members of the Canadian Armed Forces; and
173	individuals unable to consent due to cognitive impairment were excluded from baseline recruitment.
174	
175	Participant characteristics
176	To characterize the study sample, we extracted self-reported data on demographics, income,
177	number of chronic conditions, and general health. Income measures were based on total household
178	income and categorized as implemented in the CLSA: less than \$20,000, \$20,000 - \$49,999, \$50,000 -
179	\$99,999, \$100,000 - \$149,999 and \$150,000 or higher <sup>14</sup> .
180	
181	Modifiable risk factors for dementia
182	The definitions for the 12 modifiable risk factors associated with all-cause dementia were guided
183	where possible by the 2020 Lancet Commission Report, other published work on modifiable risk factors
184	for dementia, and the 2020 Canadian federal air quality guidelines <sup>6,7,15,16</sup> . The specific definitions for the
185	risk factors are listed in Table 1. A comparison of these definitions with similar studies can be found in
186	Supplemental Table S1. All definitions except for air quality, hearing loss, and obesity were defined using

187	CLSA self-report interview data. Air quality was based on national land-use regression models and
188	satellite-derived measures <sup>17–21</sup> . Hearing loss was calculated using pure tone audiometry. Obesity was
189	calculated using in-person BMI measurements. The relative risks associated with each risk factor were
190	taken from the meta-analyses reported by the Lancet Commission <sup>6,22</sup> .
191	Statistical Analysis
192	We constructed a descriptive profile of CLSA Comprehensive cohort participants at baseline,
193	summarizing demographics, socioeconomic factors, and health status variables by measures of
194	frequency, central tendency, and dispersion. In the primary analysis, the prevalence and 95% confidence
195	interval of each modifiable risk factor was calculated with the use of sampling weights, which were
196	designed to generalize to the target population of Canadian middle-aged and older adults. CLSA
197	sampling weights were calibrated using age, sex, and education (within geographical regions) <sup>23</sup> . Within
198	each calculation, individuals with missing data were removed on a per factor basis. For 10 of the risk
199	factors, the proportion of missing values was minimal, ranging from 0% to 0.63%. Missingness was
200	somewhat higher for physical inactivity (4.4%) and hearing loss (5.0%).
201	The crude PAF for each risk factor was estimated by Levin's formula <sup>24</sup> . Additionally, following
202	the methodology introduced by Norton et al., we produced weighted PAFs to account for overlap
203	between risk factors <sup>25</sup> . We generated communality weights by conducting principal component analysis
204	on the tetrachoric correlation matrix of the 12 risk factors, extracting only components with eigenvalues
205	> 1. The communality for each risk factor, which represents the degree to which it overlaps the other
206	risk factors, was calculated as the sum of the squared factor loadings. The corresponding weight for
207	each risk factor, representing the factor's uniqueness, was the complement of the communality.
208	We calculated two combined PAFs with different assumptions regarding the form of interactions
209	between risk factors. The first is a widely-used method developed by Norton et al. that multiplicatively
210	combines the individual communality-weighted PAFs <sup>6,7,25</sup> . This method was developed to yield more

211	plausible estimates of PAFs involving multiple risk factors than other methods that multiplicatively
212	combined crude PAFs <sup>25,26</sup> . The second method of calculating a combined PAF assumes additive
213	interactions between risk factors and has been suggested as an alternative to the communality-
214	weighted multiplicative approach <sup>26</sup> . A technical appendix with all formulae can be found in
215	Supplemental Table S2. We derived confidence intervals for all PAFs using a two-step bootstrapping
216	approach to account for uncertainty in both the risk factor prevalence and relative risk estimate <sup>26</sup> . In this
217	process we first generated 10,000 replicate samples with replacement and then within each replicate
218	we parametrically sampled relative risks for each risk factor based on their reported confidence
219	intervals.
220	We repeated all analyses within household income categories. We reported the prevalence
221	and combined PAFs within each category of income and plotted the prevalence by income to facilitate
222	comparison. Data were analyzed using the R programming language with the packages "survey" and

# 235 Results

236	The baseline CLSA Comprehensive cohort included 30,097 participants and was 50.9% female
237	(Table 2) The median age was 62 years with first and third quartiles of 54 and 71 years. A small
238	proportion of participants (8.1%) resided in rural areas. The participants were primarily white only
239	(94.4%), followed by multiple identities (1.5%), South Asian only (0.9%) and Black only (0.7%). A small
240	proportion (5.6%) of the sample reported an annual household income below \$20,000, 22.6% reported
241	between \$20,000 and \$49,999, 35.2%, between \$50,000 and \$99,999, 19.6% between \$100,000 and
242	\$149,999, and 17.0% reported an annual household income of \$150,000 or above. While nearly all
243	participants (91.8%), reported having at least one chronic condition, over half (61.5%) of participants
244	reported their general health to be "Excellent" or "Very Good" and only 1.3% reported that it was
245	"Poor".
246	Prevalence of risk factors
247	Using sample-weighted proportions, physical inactivity was the most prevalent risk factor
248	(63.8%; 95% Cl, 62.8% – 64.9%) followed by hypertension (32.8%; 31.7% – 33.8%), obesity (30.8%; 29.7%
249	– 31.8%) and traumatic brain injury (23.9%; 22.9% – 24.8%) (Table 3). Smoking (9.6%; 8.9% – 10.3%),
250	excessive alcohol consumption (11.4%; 10.8% - 12.0%), and hearing loss (15.7%; 14.9% – 16.5%) were
251	the least common risk factors in the Canadian middle-aged and older adult population.
252	Populational attributable fractions
253	Physical inactivity (19.9%; 9.2%-29.6%), hypertension (16.6%, 4.9%-28.9%) and TBI (16.7%,
254	11.4%-22.3%) had the highest crude PAFs (Table 3). Conversely, air pollution (1.7%; 1.3% -2.1%),
255	excessive alcohol consumption (2.0%; 0.7-3.4%), and smoking (5.4%; 1.5%-10.3%), had the lowest crude
256	PAFs. In the principal component analysis, we extracted five factors with eigenvalues > 1, representing
257	60% of the total variation. The communality values for each risk factor varied from 42% to 82%.
258	Accounting for overlap between risk factors, the weighted PAFs indicated that physical inactivity (11.6%;

259	5.4%-17.1%), depression (7.7%; 5.0%-10.7%), and hypertension (6.0%; 1.8%-10.4%) were associated
260	with the most dementia cases while excessive alcohol consumption (0.4%; 0.1%-0.6%), air pollution
261	(0.8%; 0.6%-1.0%), and smoking (2.1%; 0.6%-4.0%), were responsible for the fewest cases. The
262	combined PAFs were 43.4% (37.4%-49.0%) by the weighted multiplicative method, and 60.9% (55.7%-
263	65.5%) by the additive method.
264	
265	Variation in risk by income
266	The lowest income group exhibited the highest point prevalence for all risk factors except
267	excessive alcohol consumption and hypertension (Figure 1; Table 4). There was a consistent gradient of
268	decreasing prevalence and both PAFs (both crude and weighted) across increasing income categories for
269	9 of the 12 risk factors: less education, hearing loss, obesity, smoking, depression, social isolation,
270	physical inactivity, diabetes, and air pollution (Figure 1). Using the weighted multiplicative combined
271	PAF, we estimate that the 12 risk factors accounted for 58.7% of dementia cases in the lowest income
272	group but only 31.8% in the highest income group. The combined additive PAF was 71.3% in the lowest
273	income group and 51.2% in the highest group (Table 4).
274	Sensitivity Analysis
275	The risk factor prevalences and PAFs were broadly similar at follow-up 1 compared to baseline
276	(Table 5). Air pollution dropped from 19.0% at baseline to 13.1% at follow-up 1. Physical inactivity was
277	still the most prevalent risk factor with the highest crude and weighted PAFs. As with the baseline
278	analysis, hypertension and TBI had the next highest crude PAFs, followed closely by obesity. The order of
279	the weighted PAFs changed slighted in follow-up 1 compared to baseline as obesity had a higher
280	weighted PAF than hypertension. The combined PAFs were similar between baseline and follow-up 1.
281	Avoiding the use of sampling weights noticeably lowered the prevalence estimates of low
282	education, smoking, and air pollution (Table S3). However, the top three risk factors by prevalence and

283	PAF remained the same regardless of weighting, and the multiplicative weighted combined PAF (40.5%)
284	and additive combined PAF (59.2%) were also similar. Analysis stratified by sex also yielded largely
285	similar results (Table S4). Males had a higher prevalence of TBI (29.4% vs. 18.8%) and social isolation
286	(20.2% vs. 15.1%) while females had a higher prevalence of depression (21.7% vs 15.1%).
287	Discussion
288	We examined the prevalence and population attributable fractions of 12 potentially modifiable
289	risk factors for dementia in the Canadian middle-aged and older adult population using data from the
290	Canadian Longitudinal Study on Aging. We found that the prevalence of risk factors varied between 9.6%
291	and 63.8%, with physical inactivity the most prevalent risk factor and smoking the least prevalent.
292	Depending on assumptions regarding the interaction of risk factors, we estimated that between 43.4%
293	and 60.9% of dementia cases among Canadian middle-aged and older adults could be attributed to
294	these 12 risk factors. Nine of the 12 risk factors demonstrated clear gradients across income categories,
295	with higher prevalences of risk factors at lower incomes.
296	Our work employs a similar methodology to other global and regional studies <sup>6–8</sup> ; however, a
297	novel aspect of our work is that we were able to perform all calculations, except relative risk estimation,
298	within a single national sample. We also used a bootstrapping approach to calculate confidence intervals
299	for PAFs that account for variation in both the prevalence of risk factors and in the relative risks, an
300	improvement over other studies that accounted only for variation within the relative risks <sup>7</sup> or did not
301	calculate confidence intervals <sup>6</sup> . Despite using a similar methodology, the prevalence and PAFs produced
302	in this study exhibit key differences from those in 2020 Lancet Commission report. While we found the
303	risk factors responsible for the most dementia cases in Canada to be physical inactivity (wPAF=11.6%),
304	depression (7.7%), and hypertension (6.0%), the Lancet Commission identified hearing loss (8.2%), less
305	education (7.1%), and smoking (5.2%) as the most impactful risk factors. Differences in prevalence
306	estimates, a result of different target populations and possibly in the definition of risk factors, are largely

307 responsible for the differences in the weighted PAFs. For example, physical inactivity had just a 11.0% 308 prevalence in the Lancet Commission report, compared to 63.8% in our study and 62.8% in a similar 309 study of adults in the United States <sup>7</sup>. Other Canadian research supports the high prevalence of physical 310 inactivity we measured in this study<sup>29</sup>. The notable differences in individual PAFs between our study and 311 other international and regional studies are meaningful as they indicate that there are important 312 regional differences in risk factor distribution that can guide the composition and focus of national 313 dementia strategies.

314 Despite the difference in individual PAFs, the combined PAFs we estimated were similar to those 315 from studies conducted in other jurisdictions. The weighted multiplicative PAF for the 12 risk factors from our study (43%) was highly similar to that of Livingston<sup>22</sup> (40%) and Lee<sup>7</sup> (41%). Additionally, our 316 317 additive combined PAF (61%) is similar to a global estimate (56%)<sup>26</sup>. The differences between the 318 magnitude of the weighted multiplicative and additive combined PAFs are meaningful and ultimately 319 rooted in strong assumptions of the form of interactivity of risk factors within individuals. Interactions 320 between multiple risk factors for dementia is highly complex and the form of the interactions likely vary by each distinct set of risk factors present<sup>26,30,31</sup>. While we believe these combined PAF estimates are 321 322 useful benchmarks, we have limited evidence on how multiple modifiable risk factors for dementia 323 interact with each other and more research on dementia risk factor interaction could improve future 324 estimation of their combined impact.

The results of this study can be used to inform dementia prevention strategies in Canada. Owning to its high prevalence, physical inactivity had the largest PAF, both crude and weighted. Depression had the second highest weighted PAF, a result of its high relative risk and relatively lower correlation with other risk factors. Depression and dementia have a complex and likely bidirectional relationship, but consensus is that depression is an independent risk factor for dementia that could be targeted for intervention<sup>32,33</sup>. Hypertension had the third highest weighted PAF, although this was

331	meaningfully different from obesity, which had a similar prevalence, relative risk, and communality as
332	hypertension. TBI notably had one of the highest crude PAFs, but relatively lower weighted PAF due to a
333	higher communality value. While our study highlights the risk factors with the greatest impact overall,
334	effective prevention requires a combination of individually tailored and population-level interventions.
335	Evidence supports the effectiveness of individualized, multi-domain interventions to reduce risk factors
336	for dementia <sup>34</sup> . Yet many of the most impactful risk factors have structural etiologies which call for a
337	population-level approach to address <sup>35</sup> .

338 Notably, we demonstrated gradients of increasing risk with decreasing income across 9 of the 12 339 modifiable risk factors. This is concordant with observations of a higher incidence of dementia among 340 lower income households and higher combined PAFs of risk factors in lower income countries<sup>36,37</sup>. The 341 etiology of the relationship between socio-economic status and dementia risk is likely multifaceted and 342 related to multiple behavioural, social, cultural, occupational, and environmental mechanisms. The 343 consistently higher prevalence of dementia risk factors in lower income groups suggests that social-344 economic disparities in dementia incidence are unlikely to be resolved by a prevention focus on single 345 factors. Policies to address the socio-economic disparities directly may be more effective. Future work 346 should further investigate the relationship between socio-economic status and dementia, particularly 347 the degree addressing material deprivation may reduce the prevalence of dementia risk factors and 348 incidence of dementia.

349 Limitations

350 Our study is primarily based on self-reported data, which while common in this field of research 351 may introduce recall and social desirability biases. Compared to the target population, the 352 Comprehensive CLSA cohort was whiter, healthier, and wealthier<sup>11</sup>. However, our use of sampling 353 weights calibrated by education partially addresses this limitation. Individuals with cognitive impairment 354 significant enough to prevent them from giving informed consent were excluded from the CLSA at

355	baseline, and this may have resulted in underestimation of the prevalence of some risk factors. With
356	respect to the PAF calculations, the relative risks used were calculated from an international systematic
357	review and are not specific to Canada. While we strove to algin our risk factor definitions with previous
358	work, the Lancet Commission report from which the relative risk were taken used data from multiple
359	sources and did not always have a single, specific definition.
360	
361	Conclusion
362	We examined the prevalence and population attributable fractions of 12 potentially modifiable
363	risk factors for dementia and estimated that they accounted for between 43.3% and 60.9% of dementia
364	cases among middle-aged and older adults in Canada. Accounting for overlap between risk factors, the
365	factors with the highest overall impact on dementia cases were physical inactivity, depression, and
366	hypertension. The differences in the impact of individual risk factors observed between this study and
367	other international and regional studies highlight the importance of tailoring national and regional
368	dementia strategies to the local distribution of risk factors.
