

1 **Evaluation of a participatory approach to stratifying**  
2 **neighbourhoods across the Tanzanian city of Dar es**  
3 **Salaam in terms of income by comparing with latent**  
4 **profile analysis of deprivation based on national census**  
5 **data.**

## 18 **Abstract**

19 Studying geographic heterogeneities in the characteristics of city neighbourhoods, such as  
20 population income and deprivation, has been a common practice in urban health studies for  
21 tailored and targeted interventions, especially in highly developed and diversified cities.  
22 While a range of different approaches has been applied to classify different parts of towns  
23 and cities, participatory stratification approaches (PSAs) have become popular despite their  
24 subjective basis because of their affordability, simplicity and practicality, all of which allow  
25 them to be frequently updated. While more objective statistical approaches, such as latent  
26 profile analysis (LPA), can also be used to stratify neighbourhoods using formal socio-  
27 economic and demographic data, these rely on the availability of rich datasets and advanced  
28 analytical capacities that are not always available in low and middle-income countries. This  
29 study assessed a PSA to stratify neighbourhoods across the Tanzania city of Dar es Salaam in  
30 terms of income, by comparing it with a complementary LPA using national census data from  
31 2012 to stratify them in terms of deprivation. A consultative community-based workshop was  
32 used for the PSA, while 15 selected deprivation indicators from the census data were used to  
33 profile them using LPA. While the PSA allocated neighbourhoods to five income strata, six  
34 clear deprivation strata could be distinguished by LPA. A strong positive correlation was  
35 observed between the stratum identified by the LPA and that obtained through the PSA ( $\rho =$   
36  $0.739$ ,  $p < 0.0001$ ). Furthermore, paired comparison of the two sets of correlation coefficients  
37 between each deprivation indicator and the stratum assigned by each stratification approach  
38 revealed no difference ( $V = 33$ ,  $p\text{-value} = 0.1354$ ), confirming that the two approaches  
39 yielded very similar patterns of stratification., Also, the two approaches yielded broadly  
40 comparable cartographic pictures of the city, depicting similar spatial distribution of wealth  
41 and poverty. Overall, this evidence indicates that subjective community knowledge and lived

- 42 experience may be invaluable for understanding the built environment and for mapping out
- 43 pockets of poverty and affluence at fine scales with minimum resources.

## 44 **Introduction**

45 More than half of the world's population now lives in towns and cities [1]. While Africa and  
46 eastern and southern Asia have been urbanized most rapidly, the pace of urbanization in these  
47 regions is expected to slow over the coming decade [2]. Meanwhile, limited government  
48 investment in urban planning has contributed to more extensive and overcrowded informal  
49 settlements, where approximately 47% of the world's 4.3 billion urban dwellers live [2]. In  
50 Tanzania, for instance, it has been estimated that more than 75% of settlements have been  
51 informally developed [3]. Indeed, Dar es Salaam is the largest city in Tanzania, where >75%  
52 of the population live in informal settlements with highly heterogeneous wealth distribution  
53 [4]. Several historical studies on the early development of what is now the old city centre of  
54 Dar es Salaam have rationalized the distribution of settlement patterns in terms of colonial  
55 planning processes, which were heavily influenced by residential segregation policies. During  
56 the colonial era, the city was planned in a way that segregated people by race and income,  
57 with affluent neighbourhoods located near the city centre and along the Indian Ocean  
58 (Europeans and Indians) and the less affluent near and around the city centre (black Africans,  
59 referred to in that era as natives) (Brennan & Burton, 2007). The evident pattern in the city  
60 demonstrates that a significant portion of its development has unfolded through informal  
61 processes [5]. Informal settlements tend to be situated either within formal areas or near  
62 them, aligning with the contextual reality of the city's historical evolution. This historical  
63 development trajectory has contributed to an uneven distribution of neighbourhood attributes  
64 in terms of income and affluence, a disparity that persists today. However, despite the  
65 inclination to attribute these disparities solely to colonial influences, a more thorough  
66 investigation challenges this prevailing narrative. Contrary to the common assumption that  
67 the current state of Dar es Salaam, beyond the old city, is a direct result of colonial planning

68 [6], in fact, it emerged from limited planning, especially during the city's rapid expansion  
69 from the 1970's onward [7]

70 While both formal and informal settlements co-exist side-by-side in cities, they exhibit  
71 varying neighbourhood characteristics. Urban neighbourhoods constantly evolve at very fine  
72 scales, resulting in a myriad of spatial, sociodemographic, economic, and cultural diversities  
73 coexisting within relatively small, but nevertheless, very heterogeneous geographic areas.  
74 This vibrant evolutionary process is particularly dynamic in unplanned, informal settlements,  
75 catalyzing different types of disparities, such as health inequality, social division, exclusion,  
76 segregation, which are typically assessed in terms of income inequality or socioeconomic  
77 deprivation, [8] . Despite the conceptual differences in how income and deprivation are used  
78 to assess the two-sided coin of poverty and wealth (Box 1), either may be just as readily  
79 applied to surveying the distribution of inequalities across urban areas.

**Box 1. Summary of the conceptual and methodological distinctions between *income inequality* and *socioeconomic deprivation*.**

**Income inequality:** The concept of *income inequality* specifically targets the unequal allocation of income among individuals or households within a given population. Surveyed indices of income inequality express the disparity between the earnings of the wealthiest and the poorest members of society in semi-quantitative terms, often employing statistical summary measures, such as the Gini coefficient or income quintiles [9].

**Socioeconomic deprivation:** On the other hand, *socioeconomic deprivation* refers to disadvantages that a person or group face in an inequitable manner [10]. Such disadvantages can be linked to geographic factors, such as living in a certain neighbourhood or community, or other factors like housing and built environment quality. These disadvantages can take various forms, such as limited access to job opportunities, education, healthcare, and other basic needs. Essentially, it describes the relative absence of power that certain individuals or groups have over their economic and social

circumstances [11]. This can perpetuate a cycle of poverty, marginalization, and exclusion, leading to increased social inequality and decreased opportunities for upward mobility [12]. Semi-quantitative measures of socioeconomic deprivation often involves use multidimensional indices to account for these diverse factors affecting well-being [9].

81 For the first time within the context of internationally agreed development goals, the 2030  
82 Agenda aims to reduce inequality based on income [13]. While efforts are being made to  
83 bridge the gap between rich and poor [14, 15], there is still insufficient investment in  
84 methodologies for socioeconomic profiling of urban neighbourhoods [16]. In response to that  
85 methodological need, this study set out to evaluate a subjective participatory stratification  
86 approach (PSA) to classifying neighbourhoods across the Tanzanian city of Dar es Salaam in  
87 terms of income, by comparing it with an objective latent profile analysis (LPA) of  
88 deprivation based on national census data (Box 2).

**Box 2. Summary of the relevant evidence base and methodological considerations that informed the formulation of the study design.**

**Participatory Stratification Approaches (PSA):** Participatory stratification approaches involve active, collaborative engagement and involvement of participants who are residents of the study area in question [17, 18]. These participants may sometimes be influential or authoritative stakeholders, in the research investigation or decision-making process. PSA can be used to understand socioeconomic, geographical inequalities and the hierarchical arrangement of social groups within a given society or system, and is especially useful where socio-economic classes are distributed very unevenly among people within a population [19, 20], forcing people with comparable socio-economic characteristics to reside in similar spatial localities [21]. However, it is essential to recognise the subjective nature of PSA, which can be influenced by relative income assessments within the social

circles or communities of individual participants, drawing from lived experiences and personal knowledge [22-24]. Nonetheless, such subjective impressions of individual members within a community can yield qualitative insights that complement objective quantitative measurements, thus enriching an understanding of the broader economic landscape within cities [25, 26].

**Latent Profile Analysis (LPA):** A more objective way to understand such socioeconomic strata within in urban spatial and administrative subunits, is through statistical analysis of more structured empirical data from surveys of the major drivers and consequences of such heterogeneities. Specifically, LPA is a statistical method used to identify unobserved subgroups, or latent class or profiles within a sample of observed entities, based on similar patterns observed variables [27]. LPA has been sometimes referred to as an advanced model-based clustering approach, due to its ability to use different fit statistics to select the best profile, class, or cluster. Over the last decade, LPA has become more widely applied as an alternative to previously existing methods for identifying clusters (eg. K-means clustering, Hierarchical clustering, Fuzzy C-means clustering, and Partitioning Around Medoids), due its flexibility in model criterion selection, such as variance and covariance estimation, and the objectivity of its best fit model selection procedures [28-31]. LPA of detailed data from the 2012 national Population and Housing Census (PHC) for Tanzania was therefore adopted as the gold standard objective statistical methodology, with which the PSA was compared and contrasted as a means to assess the advantages and disadvantages of the latter relative to the former.

## 90 **Methods**

### 91 **Ethics statement**

92 This research was conducted as part of Centre for Sustainable, Healthy, and Learning Cities  
93 and Neighbourhoods, supported by funding from UK Research and Innovation (UKRI)  
94 through the Economic and Social Research Council (ESRC) under the UK Government's

95 Global Challenges Research Fund (GCRF) with project reference (ES/P011020/1). Ethical  
96 clearance for the study, a component of the Sustainable Cities project at Ifakara Health  
97 Institute (IHI), was granted by the Institutional Review Board of the Ifakara Health Institute  
98 (IHI/IRB/NO: 26-2018) and the Medical Research Coordinating Committee at the National  
99 Institute for Medical Research in Tanzania (NIMR/HQ/R.8a/Vol. IX/2954). Verbal consent,  
100 in accordance with the approved protocols, was obtained from all human participants.

### 107 **Geographical context and study data**

108 Dar es Salaam is the largest city in Tanzania, located on the Indian Ocean coast (Fig 1). The  
109 city had a population of approximately 4.4 million in 2012 but currently has approximately  
110 5.4 million inhabitants, distributed across an administrative area that has remained constant at  
111 1,590 km<sup>2</sup> [32]. It is also the port in Tanzania, contributing substantially to the national  
112 economy and served as a government administrative centre before *de facto* relocation to the  
113 official capital, Dodoma, was practically implemented in 2016 [33].

120 The study reported herein used Tanzania's 2012 Population and Housing Census (PHC) data  
121 from the National Bureau of Statistics of Tanzania (NBS) to generate variables which were  
122 considered likely to represent deprivation in the study context (S1 Table). The data is  
123 presented via administrative units, starting from regions down to districts, wards (*kata*) and  
124 neighbourhoods (*mitaa*, literally translated as *streets* but actually means a larger, formalized  
125 administrative area with defined boundaries, rather than just a road and structures built along  
126 it). The data from PHC primarily consisted of socio-demographic information such as gender,  
127 age, disability, marital status, citizenship, place of residence, education status, migration  
128 patterns, economic activities, fertility rates, general and maternal mortality rates, and  
129 enrolment in social security programs. Other data include household with members who are  
130 living in diaspora, food and cash crops cultivation, and information about asset ownership  
131 and housing conditions. The current study used data aggregated at the neighbourhood level  
132 (Fig 1C), the finest scale freely available to the public upon request for research purposes to  
133 derive deprivation indicators based relevant variables in the PHC (S1 Table). The dataset  
134 included 452 neighbourhoods from three districts that comprised Dar es Salaam at the time  
135 (Fig 1A)

136 Neighbourhoods in Dar es Salaam city are unevenly distributed, with Kinondoni District  
137 having the highest number of neighbourhoods, while Ilala has the lowest number of  
138 neighbourhoods (Table 1). In terms of population, Kinondoni also has the highest share of  
139 residents living in this district, while Ilala is the least. However, from a historical perspective,  
140 Ilala stands as the most well-established district, comprising neighbourhoods with a rich  
141 legacy that dates back over a century. On the other hand, most parts of Temeke were  
142 relatively new and were experiencing rapid growth and development at the time.

## 145 **Study design**

146 Based on considerations of the relevant methodological literature (Box 2), the current study  
147 sought to assess a subjective participatory stratification approach (PSA) to classifying  
148 neighbourhoods in terms of income level by comparing it with an objective statistical  
149 approach using latent profile analysis (LPA), to stratify neighbourhoods in terms of  
150 deprivation based on socioeconomic data from the 2012 PHC in the Tanzania city of Dar es  
151 Salaam. While the income which is referred by the PSA is inherently subjective and based on  
152 the lived experiences and knowledge of the city's residents, the LPA of deprivation strata in  
153 quantitative terms is a more objective socioeconomic metric derived from formal ways of  
154 living standards, conditions, and education at the neighbourhood level [34].

155 **Participatory stratification approach (PSA)**

156 The PSA involved active participation of community members and professionals in the  
157 stratification of Dar es Salaam neighbourhoods into different income strata. This one-day  
158 workshop, carried out on Friday, 22<sup>nd</sup> March 2019, from 09:00 AM to 17:00 PM at Ifakara  
159 Health Institute offices in Mikocheni, Dar es Salaam, involved 50 people, specifically five  
160 residents from each district recommended by the neighbourhood leaders, two town planners  
161 from each district, three community development officers from each district (Table 1), five  
162 practicing town planners from the private sector, two urban and regional planning lecturers  
163 from Ardhi University and 13 Ifakara Health Institute scientists working in urban projects in  
164 Dar es Salaam. The task started by collectively agreeing on the number of income strata to  
165 which the city's neighbourhoods should be assigned. Then, each of the 452 neighbourhoods  
166 were assigned to a respective stratum by each individual participant, following which a  
167 consensus was established through group discussion to collectively agree on the stratum it  
168 was finally assigned to (Fig 2). Although the task fundamentally relied on the participants  
169 knowledge and lived experience of the city, some other complementary sources of  
170 information, such as satellite images, were also used to facilitate the process of informed  
171 debate and consensus building.

175 independently assigning neighbourhoods to one of five different income strata and sharing  
176 their assignation using sticky pad notes. Panels C and D show how the assignations of  
177 individual participants were collated and compared as basis for group discussion, by  
178 assembling such sticky notes on a flip chart. Panels E and F illustrate how the investigators

179 then facilitated collective consensus building among the participants, based on group  
180 discussions to compare and contrast their different neighbourhood assignments to specific  
181 strata, and then reach final agreement for each neighbourhood.

## 182 **Latent profile analysis (LPA)**

183 Deprivation profiles were identified as unobserved variables (latent profiles), which were  
184 distinguished based on the observed values for relevant socioeconomic variables in the  
185 neighbourhood-level PHC data. The first step of the LPA was the identification of the most  
186 appropriate recorded variables. Based on the data and context, 15 variables in the PHC data  
187 that were intuitively to expected to be closely associated with deprivation were identified.  
188 These included education indicators such as; *proportion completed any school level*,  
189 *proportion educated to university level*, *proportion educated to secondary level*, literacy and  
190 language proficiency; *proportion of literate*, *proportion of English literacy*, economic factors;  
191 *proportion of potentially economically active individuals*, *proportion enrolled in social*  
192 *security*, *proportion household with members in diaspora*, social and legal indicators;  
193 *proportion with registered birth certificate*, demographic factors; *average household size*,  
194 *proportion of female*, *proportion of single head households*, and health and mortality  
195 statistics; *proportion with disability*, *proportion of death caused by diseases*, and *crude death*  
196 *rate*. Different indicators from the census data were used to derive these variables (S1 Table)  
197 for participating respondents or households, aggregated at neighbourhood level. To provide a  
198 standardised way to compare different quantities while allowing for more accurate and  
199 meaningful comparisons between variables in predicting outcomes or estimate probabilities,  
200 almost all variables were transformed into proportions, except for household size and crude  
201 death rate which were presented in their actual metrics units.

202 Descriptive statistics of the selected variables can be found in Fig 3, which shows prior  
203 expected general distribution of income and poverty across three study districts at the time,  
204 which are consistent with the actual existing situation in the city.

207 **deprivation derived from the 2012 national census data, distributed across three study**  
208 **districts at the time.** Horizontal lines within the violin plots represent the first, second and  
209 third quartiles, or the 25%, 50% (median), and 75% quantiles. The units for most of these  
210 variables are proportions of participating respondents or households, aggregated at  
211 neighbourhood level, the only two exceptions being household size and crude death rate.

212 Using the selected 15 variables from the neighbourhoods, LPA was used to profile  
213 neighbourhoods into statistically distinct strata.

214 Depending on the nature of data, different six LPA models structures can be used which  
215 range from simple to complex, determined by how variance and covariance are treated and  
216 whether relationships between variables are considered, thus affecting model parsimony and  
217 complexity [35]. In model selection process, Pearson's rank correlation test was employed to  
218 quantify the level of correlation to inform optional specification of model assumption and  
219 maximize model performance. In addition, the correlations between variables can help with  
220 the interpretation of the resulting latent profiles, as such, if two variables exhibit high level of  
221 correlation it can suggest that these two variables may be driving the occurrence of profile  
222 and provide insights into the nature of the profile. Broadly speaking, a correlation coefficient  
223  $\rho \geq +/- 0.4$  and p value  $\leq 0.05$  was considered as an indication of strong correlation [36]. The  
224 Pearson's rank correlation analysis revealed that a significant correlation existed among ten  
225 out of the fifteen variables ( $p \leq 0.05$ ), (S2 Fig and S3 Fig). Hence, from the six tidyLPA  
226 models structures proposed by Rosenberg *et al.* [29], model structure six with varying  
227 variances and covariances was selected. It is the most complex model, so while it allows for  
228 the estimation of variances and covariances across profiles without constraints, potentially  
229 providing a deeper understanding of the relationships between the variables, it is also less  
230 parsimonious.

231 The LPA modelling was performed using R version 4.2.0 and RStudio version  
232 2023.03.0+386 with the *tidyLPA* package. *tidyLPA* acts as an interface to the *mclust* package  
233 and provides the functionalities to estimate the commonly specified models used in the  
234 analysis, with different parameters depending on model complexity according to the  
235 structural forms developed by [35]. Seven criteria were used for best fit model selection:

236 Log-Likelihood (LogLik), Akaike Information Criterion (AIC), Difference in AIC values  
237 ( $\Delta$ AIC), Consistent Akaike Information Criterion (CLC), Kullback-Leibler Information  
238 Criterion (KIC), Sample-Size Adjusted Bayesian Information Criterion (SABIC), and  
239 Entropy (Average Uncertainty or Randomness in Latent Class Assignments). Across the  
240 existing LPA literature, it has been widely reported that selection of the best fit model with  
241 the most informative number of distinct profiles remains a challenging task [37].  
242 Correspondingly, to validate the model optimization based on the fit statistics, an analytic  
243 hierarchy process (AHP), as proposed by [38] which helps in determining the correct number  
244 of profiles in a model based clustering was used.

245 Two approaches were used to interpret and assign meaning to each profile from the selected  
246 best fit model in relation to deprivation. Firstly, the distribution of the variables was plotted  
247 against every profile in a dot and violin plot. Secondly, using z-score or scaled mean of each  
248 variable on each profile. While median centre data around the second quartiles or 50%  
249 quantiles, z score means centre data around zero because the scaling involves standardizing  
250 each observed variable to have mean of zero and standard deviation of one ( $\mu = 0, \sigma = 1$ ),  
251 [39]. In the context of LPA, scaled means are often reported as part of the model output along  
252 with other fit statistics. Often, scaled means may have negative value due to scaling even  
253 though latent variable has only positive values, however, this does not necessarily indicate  
254 that the underlying construct is negative [40]. This helps in comparing the relative positions  
255 of the means across variables with different scales or variances, as well as for interpreting the  
256 magnitude and direction of the differences between the means of different profiles.

257 In LPA, after numbering profiles by ranking them according to their order of score, it is  
258 always a task to the investigators to interpret and assign their intuitive meaning [41]. The  
259 ranked deprivation profiles were then each interpreted and assigned to named ranked

260 deprivation stratum. The LPA deprivation strata were then compared to the results from the  
261 PSA using a non-parametric statistical correlation test (Spearman's rank correlation test), to  
262 assess the strength and direction of the relationship between the ranked strata from the two  
263 approaches. Further analyses were performed to cross validate the PSA income strata by  
264 plotting values using violin and dot plot for the same PHC variables used in broken down by  
265 PSA stratum. To test statistical significance difference between the two approaches, a  
266 Wilcoxon signed-rank test, was applied using to compare the correlation coefficient of the  
267 Spearman's correlation ( $\rho$ ) obtained by PSA and LPA.

268 Additionally, using the ranked results from the two approaches, neighbourhood income and  
269 deprivation strata from PSA and LPA, respectively, were mapped using ArcGIS Pro 3.1.2, to  
270 understand and compare stratification of the city neighbourhoods by the two approaches in  
271 terms of comparative spatial distribution. In spatial comparative analysis, ground truthing  
272 evidence of the existing conditions in the selected neighbourhoods, specifically, housing  
273 density and quality of buildings, using in situ ground photographs and satellite images, were  
274 used to provide further descriptive insights into the meaning of the results.



## 275 Results

### 276 Latent profile identification

277 The best fit profile model identified by LPA of the census data was with 6-profiles: The  
278 goodness of fit consistently decreased as the number of profiles modelled increased, while  
279 entropy increased with a 98% classification quality reached for this final optimal 6-profile  
280 model that was the last one to converge (Table 2). These model optimization results were  
281 confirmed using the AHP approach [38], which also indicated that the model with 6 profiles  
282 was optimal based on the fit statistics in Table 2. The results, therefore, suggested that six  
283 clear deprivation strata could be identified based on census data, as compared to the five  
284 income strata obtained from the participatory stratification approach.

285 Table 2: Comparison of model fit statistics from different models with different numbers of  
286 profiles using the tidyLPA complex model structure 6 with varying variance and covariance  
287 [29], which were then evaluated using an Analytic Hierarchy Process (AHP) [38] in the  
288 selection of the best fit model.

### 290 Interpreting the underlying meaning of identified latent profiles.

291 From the dot and violin plots in Fig , the value distributions of the most important individual  
292 indicators of deprivation show that ranking the numbered LPA profiles based on these same  
293 variables, yields an order of 2, 1, 3, 4, 5 and 6 for the profile numbers assigned by the LPA

294 best fit model (Table 2). Correspondingly, these were respectively assigned the following  
295 stratum names; *Highly Deprived*, *Deprived*, *Moderately Deprived*, *Moderately Affluent*,  
296 *Affluent*, and *Highly Affluent* (Table 3). To further examine and query these profile  
297 assignments based on variable value distributions, a calculated scaled mean for each variable  
298 was used (Fig 5), consistent with other LPA studies that assigned interpreted profile  
299 meanings [28, 42-44]. These scaled means for each variable within each stratum confirmed  
300 the same apparent profile order (Table 3) for most variables, as ranked from the most  
301 deprived to the most affluent (Fig 5).

316 **in standard deviation units instead of the original metric. Scaling transforms the latent**  
317 **variable to have mean of zero and standard deviation of one ( $\mu = 0, \sigma = 1$ ). Negative means**  
318 **do not imply negative values of the actual metric, but rather reflecting normalization around**  
319 **zero by the scaling process.**

320 Based on the above interpretation of the LPA identified profiles, six assigned deprivation  
 321 strata could be resolved from the census data (Table 3). On the other hand, however, the  
 322 results from participatory stratification approach revealed five income classes (Table 4) with  
 323 *low income stratum* accounting for a remarkably low percentage of neighbourhoods while the  
 324 *medium income stratum* had the highest.

### 332 **Comparison of PSA with LPA of the census data**

333 The results of the spearman rank correlation test shows that there is a strong positive  
 334 correlation ( $\rho = 0.739$ ,  $S = 4015865$ ,  $p < 0.001$ ) between the stratum identified by the LPA of  
 335 census data and the results of the PSA (Fig ).

340 The same variables used to stratify the neighbourhoods by LPA yielded distribution of values  
341 that were just as consistent with their income stratum as determined by the PSA (7) as they  
342 were with their deprivation stratum as determined by the LPA (Fig and Fig 5).

351 Further analysis of Spearman's rank correlation tests between each variable from the census  
352 data and stratum rank as determined by each of the two different stratification approaches can  
353 be seen in 8. A Wilcoxon signed-rank test to compare these two sets of correlation  
354 coefficients in a paired manner revealed no difference between the two approaches ( $V = 33$ ,  
355  $p\text{-value} = 0.1354$ ), indicating that the two approaches yielded very similar patterns of  
356 stratification.

364 Overall, the two stratification approaches yielded relatively similar cartographic pictures of  
365 wealth and poverty distribution across the city (Fig ). High income, highly affluent  
366 neighbourhoods are mainly located in or around the city centre and along the coast to the  
367 north, while low income, deprived neighbourhoods are generally distributed along the  
368 outskirts of the city. The distribution pattern of the medium income stratum, as determined by  
369 PSA, corresponds well with the moderately deprived and moderately affluent strata identified  
370 by LPA. Focusing on the city centre and areas immediately around it, the results reveal  
371 patches of low income and deprived neighbourhoods located near high income and highly  
372 affluent neighbourhoods, forming a pocket of poverty running from central Ilala into Temeke  
373 District. However, in the western direction this pocket of deprived, medium income

374 neighbourhoods is enclosed by moderately deprived, mixed medium and high-income  
375 neighbourhoods.

376 The overall distribution, on the other hand, shows that most of the neighbourhoods classified  
377 by PSA as medium income in Fig A, such as Msimbazi Bondeni and Kigogo Kati, have been  
378 classified as deprived neighbourhoods by LPA in Fig B. Many of these neighbourhoods are  
379 found in the same pocket of deprived neighbourhoods described above that cuts across all  
380 three districts but mostly sits in northern Temeke.

386 Looking at the heterogeneous settlement patterns of these neighbourhoods sheds light on how  
387 they were classified differently by the two different methods (Fig and Fig ). For example, the  
388 varying density and quality of the buildings in Kigogo Kati illustrated in Fig shows that,  
389 while participants in the PSA stratification process considered the mixed housing qualities  
390 and density that are clearly visible in panel A to be a reasonable basis for classifying it as  
391 medium income, LPA averaged out the diversity existing at fine scale within the  
392 neighbourhood and consequently classified it simply as being deprived.

396 Kigogo Kati was classified as medium income by participatory stratification approach (PSA)  
397 (Fig A), but as deprived by statistical latent profile analysis (LPA) of national census data  
398 (Fig B). As mapped out in panel A, blocks of high-quality buildings (yellow bordered panels,  
399 B, C, F, K, M, N and P), are contrasted with blocks with generally poor quality housing (blue  
400 bordered panels D, E, G, H, I, J and L) in the same neighbourhood.

401

402 Additionally, while the example in Fig outlines the spatial distribution of different building  
403 qualities within the same neighbourhood, similar variability is clearly noticeable within some  
404 other neighbourhoods. For example, Fig illustrates part of the Msimbazi Bondeni  
405 neighbourhood, where two housing blocks with obviously different building qualities are  
406 found in the same neighbourhood, which has been classified as medium income by PSA but  
407 deprived by LPA. Moreover, these two blocks with obviously different mean housing density  
408 and quality lie at opposite sides of a steep topographic incline (Fig A and B), with the denser  
409 informal settlements with generally smaller, poor quality housing being found in the flood-



410 prone valley to the north of it , while the carefully constructed apartment blocks and planned  
411 housing developments (Fig D and E) were all found approximately 20 meters uphill to the  
412 south. Indeed, as one walks southward along the transect depicted in Fig 7A and B, from the  
413 valley up the hill onward along a relatively flat plateau, a clearly noticeable shift is observed  
414 in building quality with elevation (Fig , panel D and E).

420 (LPA) of national census data (Fig B). As mapped out in Panel A, blocks of high-quality  
421 buildings (yellow bordered panels, C, E, F and K) uphill and to the south of a steep  
422 topographic gradient (Panel B) are contrasted with downhill blocks to the south where high-  
423 density settlements have generally poor-quality housing (blue bordered panels D, G, H and I).  
424 Panels A and B illustrate how building quality changes with elevation, with the vertical axis  
425 in panel B projecting elevation above sea level, while the horizontal axis represents the  
426 distance southward along the red vector in panel A.

427 Although there are some differences between the two approaches in the distribution patterns  
428 of income and deprivation across neighbourhoods, with very few being classified as purely  
429 low income by PSA (Table 4), the geographic distribution of poverty displayed by the two  
430 approaches (Table 3 and Table 4) nevertheless follow a similar pattern (Fig ).

## 433 Discussion

434 This study contributes to a growing area of research demonstrating similarities and  
435 differences in the results obtained through quite different methodological approaches to  
436 neighbourhood stratification. The use of LPA has provided valuable insights into the  
437 classification of neighbourhoods, particularly in the assessment of deprivation profiles. The  
438 results demonstrate LPA's ability to identify statistically distinct discrete neighbourhood  
439 deprivation profiles using socioeconomic data, while highlighting its limitation in missing out  
440 the complex realities existing at a finer spatial scales within neighbourhoods. This, however,  
441 is just one facet of the broader challenge posed by profiling deprivation using aggregated data  
442 at the level of the neighbourhoods in which people live, especially in diversified cities like  
443 Dar es Salaam. Furthermore, through cross-validation of the two approaches, both  
444 statistically and spatially, the results of the PSA yielded very similar patterns of heterogeneity  
445 as the LPA, in terms of the distributions of variable values and neighbourhood classifications,  
446 respectively. Furthermore, PSA proved capable of elucidating several hidden factors relying  
447 on perceived and lived understanding of poverty, which were easily missed by LPA (**Fig 0**  
448 **&Fig 1**). Akin to many participatory approaches [17, 20, 45-49] relying on the subjective  
449 perspectives of contributing participants, the PSA developed in this study, proved to be cost-  
450 effective and user-friendly. In contrast, while statistical analyses of formally collected data,  
451 such as the LPA approach described herein, have the advantage of being objective, they are  
452 also time-consuming, data-intensive and require advanced analytical skills.

453 Nevertheless, the subjectivity of participatory approaches has been confirmed by the  
454 numbers of neighbourhoods attributed to each income stratum. While PSA classified only 4%  
455 of the city's neighbourhoods as typically low-income (Table 4), LPA classified 22% as  
456 highly deprived neighbourhoods (**Table 3**). On the other hand, PSA classified 44% of the

457 city's neighbourhoods as medium income, indicating a bias away from extreme classification  
458 assignments. The surprisingly low frequency with which neighbourhoods were classified as  
459 low income by PSA participants implies the subjectivity of the approach, as even some small  
460 pockets of better housing in a neighbourhood known to be generally very poor often  
461 prompted participants to classify it as medium income.

462 Furthermore, these PSA results seem incompatible with those of previous studies indicating  
463 widespread that large African cities accommodate large deprived populations[50, 51]. .

464 Additionally, the observation that PSA classified some of the neighbourhoods as medium  
465 income while LPA classified them as deprived, requires consideration of the fundamentally  
466 different strengths and weakness of these two complementary approaches. A possible  
467 explanation for this apparent bias of PSA towards moderate stratum assignment may well lie  
468 in the diversity existing at fine scales within neighbourhoods. Such fine-scale heterogeneities  
469 can easily be missed by the objective statistical approaches but captured, and perhaps  
470 subjectively over-represented, by the qualitative understanding of the city obtained through  
471 the lived experiences of the PSA participants, wherein even very small differences in housing  
472 quality and infrastructures within neighbourhoods were considered in the stratification. For  
473 example, the small blocks of high quality, low density housing that are highlighted in yellow  
474 bordered panels in Figs 10 and 11 resulted in these neighbourhoods being classified as  
475 medium income, despite being well known as poor neighbourhoods (Fig and Fig ). Also, the  
476 confirmatory stage of the consensus building process in the PSA workshop, resulted in  
477 participants providing supplementary justification for their initial income stratum assignment,  
478 taking into consideration additional factors that varied across coarser scales than income *per*  
479 *se*, such as physical accessibility, closeness to the valley, road condition, roof age and  
480 building density. These intuitive considerations, and ability of the PSA to accommodate

481 them in a flexible manner, differentiates the fine-scale lens of PSA from the coarser analysis  
482 of the LPA, which unavoidably blurs such heterogeneities within neighbourhoods.

483 Such mixed contexts at fine scales might also help explain some of the more puzzling  
484 outliers in Fig , because the nuanced, intuitive and holistic basis of the PSA could result in it  
485 being subjectively influenced by the most obvious features and characteristics of a  
486 neighbourhood in a disproportionate manner, whereas the LPA relies on an objective  
487 representation of the area as a whole. Nevertheless, the two approaches yielded statistically  
488 equivalent results, even though an intuitive conceptual rationale was used in selecting the  
489 quantitative deprivation indicators used for LPA, while qualitative participants knowledge  
490 were used in PSA. Hence, the two alternative approach can be applied to complement each  
491 other and in different scenarios with different application requirements for stratifying  
492 neighbourhoods [52].

493 This study study contributes to the growing area of research by demonstrating  
494 methodological similarity and differences existing in neighbourhood stratification. It  
495 complements the existing literature on economic inequality and urban segregation [33, 53-  
496 59], which relies for the most part on statistical analysis of empirical data. Furthermore, it  
497 suggests that this more subjective participatory approach, which exploits community  
498 knowledge of the location, lived experiences and local expertise, could be used in the future  
499 without any such data-intensive statistical approaches to validate it. Overall, this study  
500 provides clear evidence that cost-effective PSA methodologies could have a variety of  
501 practical applications, such as services planning and local tailoring of urban interventions.

502 While this research reassuringly presents neighbourhood-level income and deprivation  
503 profiles, respectively assessed through a subjective PSA and an objective LPA of formal  
504 socioeconomic data, some important study limitations are worth mentioning. For example,

505 the certainty of the findings may be somewhat limited by the fact that, at the time of this  
506 study, there were no more recent census data available than those from the 2012 PHC, so the  
507 results obtained with the two methods cannot be considered exactly contemporaneous.  
508 Similarly, the retrospective *post hoc* examination of heterogeneities within neighbourhoods  
509 (**Fig** and **Fig** ) relies on images of contemporary Dar es Salaam, which has obviously  
510 changed somewhat since the time that the PSA was conducted and the PHC data used for  
511 LPA were collected.

512 Moreover, the absence of data relating to variables like employment, household incomes,  
513 neighbourhood incomes, property ownership, and living conditions (including housing,  
514 water, and electricity) restricted our ability to establish a conclusive relationship between  
515 income and living standards on one hand and deprivation on the other. These factors are  
516 traditionally utilized as indicators for assessing deprivation across various geographical and  
517 poverty dimensions. Consequently, future studies should explore alternative poverty  
518 indicators and incorporate updated data when accessible.

519 Additionally, the study used area-based data aggregated at neighbourhood level, which was  
520 the finest administrative scale made available to the investigators, so the stark heterogeneities  
521 that clearly exist within individual neighbourhoods (**Fig 0** and **Fig 1**), are obviously blurred  
522 around the neighbourhood average income by the LPA and cause underrepresentation of the  
523 lowest income neighbourhoods by PSA (**Fig** ). Correspondingly, further research is needed to  
524 similarly compare subjective PSAs with objective statistical stratification based on formal  
525 survey data at finer scales, which in the context of Dar es Salaam, for example, could relate to  
526 ten cell unit housing clusters. Other avenues for future research can also include studies on  
527 how the built environment influences income and deprivation, and how the physical  
528 geography of the landscapes those human settlements are built upon affects patterns of  
529 income, access to services, health and wellbeing among residents.

## 530 **Conclusion**

531 The purpose of this study was to evaluate a PSA to stratifying neighbourhoods across the  
532 Tanzanian city of Dar es Salaam in terms of income, by comparing with LPA of deprivation  
533 based on national census data. The findings revealed the potential of both LPA and PSA  
534 methods and set a precedent for their further application as complementary approaches to  
535 neighbourhood classification. With reference to PSA, this study highlights ample room for  
536 advancing our understanding of the complex relationships between poverty, location, and  
537 socio-spatial dynamics in urban settings. To achieve a more comprehensive perspective, we  
538 recommend moving beyond reliance on relatively coarse geographic units for aggregating  
539 large-scale datasets. Instead, we propose adopting a finer-grained approach that can capture  
540 previously overlooked social, economic, physical, and environmental factors at the very fine  
541 scales they can vary across. Overall, such methodologies may be valuable, not only for policy  
542 makers, but also for urban planning practitioners and researchers who seek a deeper  
543 understanding of the diverse dynamics occurring within towns and cities across various  
544 scales. These findings confirm that subjective PSA methodologies offer more affordable and  
545 practical alternatives to conventional objective statistical analyses of formal survey data, with  
546 which to obtain detailed geographic information to inform decision-making and planning in  
547 towns and cities all across low and middle-income countries.

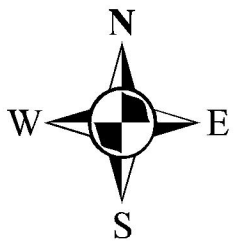

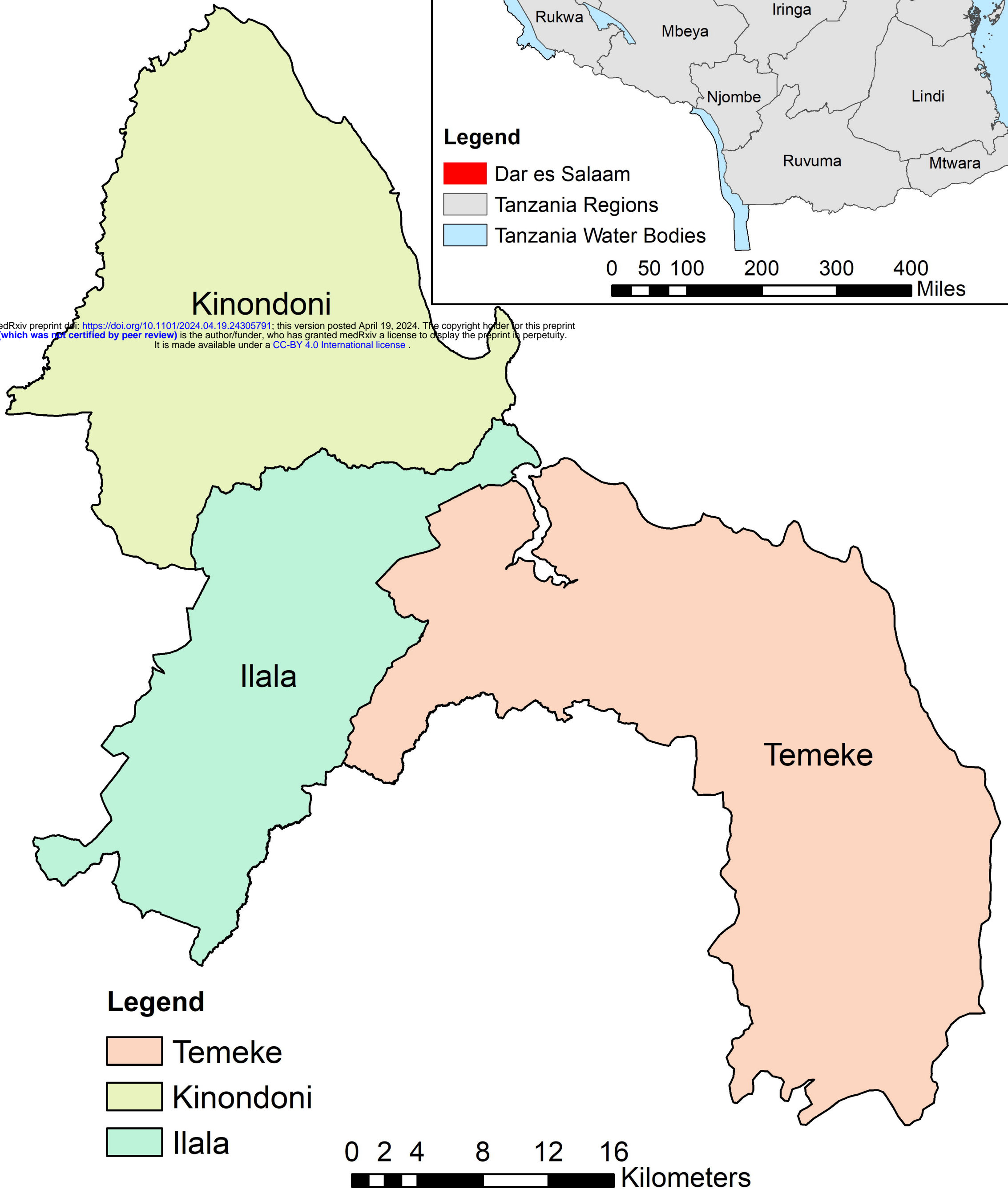

724 **neighbourhood level, the only two exceptions being household size and crude death rate.**

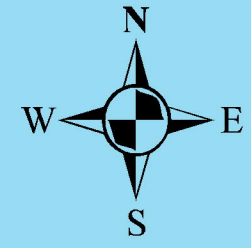
