48 Background

49 Associations between violent victimisation and psychiatric disorders are hypothesised to be 50 bidirectional, but the role of violent victimisation in the aetiologies of psychiatric disorders and 51 other adverse outcomes remains unclear. We aimed to estimate associations between violent 52 victimisation and subsequent common psychiatric disorders, suicidal behaviours, and premature 53 mortality whilst accounting for unmeasured familial confounders.

55 Methods and Findings

56 Using nationwide registers, we identified a total of 127,628 individuals born in Finland (1987-

57 2004) and Sweden (1973-2004) who had experienced violent victimisation, defined as either



75 Conclusions

- 76 Improving clinical assessment, management and aftercare psychosocial support could potentially
- 77 reduce rates of common psychiatric disorders, suicidality and premature in individuals
- 78 experiencing violent victimisation.

80	People diagnosed with psychiatric disorders are at least twice as likely as the general population to
81	be violently victimised (1-3). This finding has been consistently replicated across several
82	victimisation outcomes, including self-reports (1), police reported events (4,5), assaults requiring
83	medical care (6,7), and homicidal deaths (8). Although it is commonly hypothesised that
84	associations between common psychiatric disorders and violent victimisation are bidirectional in
85	nature, few studies have rigorously examined whether exposure to violent victimisation
86	contributes to the development of common psychiatric disorders and suicidal behaviours.

88	Two key methodological limitations are present in previous work that has considered violent
89	victimisation as a risk factor for psychiatric disorders. First, violent victimisation has been

97	with genetic factors accounting for around 20-40% of the variance (11,12). These findings are
98	expected, as victimisation is also associated with a vast array of risk factors that are at least
99	moderately heritable, including low cognitive abilities (13), personality traits (14), and violent
100	perpetration (15). As these risk factors are implicated in the aetiologies of common psychiatric

126 National Registers

A unique personal identification number is assigned either at birth or upon immigration to all
Finnish and Swedish residents, thus enabling accurate linkage across various national social and

137	(THL), and the National Patient Register, maintained by the Swedish National Board for Health
138	and Welfare, contain information on inpatient hospitalisation episodes (Finland: 1969-2020,
139	Sweden: 1973-2020) and specialist outpatient care (Finland: 1998-2020; Sweden: 2001-2020).
140	Diagnoses were classified according to the Finnish and Swedish versions of the International
141	Classification of Diseases (ICD) from the eighth to tenth revisions. Data on mortality dates,
142	including the primary and contributing causes of death, were extracted from the Causes of Death
143	Registers of each country, which utilised the same ICD classifications as the hospital data. Data
144	on sociodemographic factors, including emigration dates, were retrieved from a series of
145	population administrative registers maintained by Statistics Finland and Statistics Sweden.

147	Using these registers, we identified 1,090,641 individuals born in Finland between 1987 and 2004,
148	and 3,269,545 individuals born in Sweden between 1973 and 2004. Individuals who could not be

157 provided in **eTable 2**; diagnostic validity of the examined measures is discussed in **eText 1**).

159 Common psychiatric disorder, suicidal behaviours, and premature mortality

The following common psychiatric disorders were investigated as outcomes: depression, anxiety, personality disorders, alcohol use disorders, and substance use disorders. The measures of alcohol and substance use disorders also included deaths attributable to these conditions. We additionally investigated suicidal behaviours, encompassing both non-fatal self-harm and completed suicide, as well as premature mortality, defined consistent with the literature as any death prior to the age of 65 years (19). We further included pre-existing measures of the psychiatric disorders and self-harm.

168 Control groups

169 We matched each index person experiencing violent victimisation with up to ten individuals from 170 the general population without such experiences throughout the follow-up by sex and birth year. 171 These control individuals were required to be alive and residing in Finland or Sweden at the time 172 of the first violent victimisation event of the index person. We also matched each index person 173 with their biological full-siblings who had not experienced violent victimisation to account for 174 unmeasured shared familial confounding. In these analyses, we included all siblings and adjusted 175 for sex and birth year differences using statistical covariates. If multiple siblings in a given family 176 had experienced violent victimisation, we matched them with all their unaffected co-siblings in 177 separate strata (19). 181 By comparing outcome rates between differentially exposed siblings, we accounted for time

182 invariant and unmeasured familial confounders shared between the siblings, including an average

183 of half of their co-segregating genes and their shared childhood environments (20). The extent to

228	A total of 127,628 individuals had experienced violent victimisation in Finland and Sweden at a

median age of 21 years, with men accounting for 69% of the group (Table 1; eTables 4-5).

230 When compared to age and sex-matched controls (n=1,276,215), those who experienced violent

231 victimisation were more likely to come from backgrounds characterised by low family income, a

232 single mother household, and parents with a history of psychiatric disorders and violent crime 233 convictions at offspring birth (Table 1).

285	First, we found that people who experienced violent victimisation had considerably elevated rates
286	of common psychiatric disorders, suicidal behaviours and premature mortality compared to age
287	and sex matched individuals in the general population (median rates: 17.3 vs 6.1 events per 1000
288	person-years). Expressed as relative risks, those who had experienced violent victimisation had at
289	least a three-fold increased risk of the examined outcomes compared to the general population
290	controls. Following more rigorous adjustments for an extensive set of measured confounders

309 Third, individuals with a history of psychiatric disorders and self-harm, but no experience of 310 violent victimisation, had a three to four-fold increased risk of experiencing the examined 311 outcomes compared to their siblings lacking such experiences. 346 There are some limitations. 358 discharge dates, these dates do not reflect the actual onset of psychiatric disorders but rather
359 diagnosis dates. Consequently, determining the temporal sequence of events is not entirely

360 straightforward. Furthermore, patients with assault-related injuries may have a higher likelihood 361 of referral to psychiatric services compared to the general population, which could lead to 362 inflated rates of diagnosed psychiatric disorders in this group. To mitigate the risks for such 363 biases, we initiated the follow-up period up to two years after the initial victimisation event in 364 complementary sensitivity tests and found that the results were commensurate with the main 365 findings. This time lag strengthens the argument that the associations are unlikely due to reverse 366 causation bias or solely attributable to earlier referrals to psychiatric services. 370 Third, while the sibling-comparison design is effective in controlling for shared unmeasured 371 familial confounders, it does not address the impact of non-shared confounders (20). For this 372 reason, some findings could be explained by residual genetic confounders that are not shared 373 between siblings. However, we note that the observed within-family associations remain 374 substantial. We also measure a number a previously suggested non-genetic confounders not 375 shared between siblings, but observed in our data. Adjustments for such factors, such as low 376 family income and having a single mother at birth, also increase the credibility of our findings. It 377 is nevertheless important to note that sibling-comparison estimates may underestimate causal 378 effects in the presence of misclassification bias, shared mediators, and sibling carryover effects 379 (32,20). Future studies may benefit from triangulating our findings with alternative genetically 380 informative research designs (33).

382 The generalisability of our findings is supported by two findings. First, rates of psychiatric

383 disorders are similar across Western European countries (34), and self-reported violent

384 victimisation rates in Finland and Sweden were closely aligned with the global average during the

385 period 2003-2004 (2.2%-3.5% vs. 3.1%) when the last international comparison was conducted

386 (35). Second, the country-specific associations in the present study were not systematically387 different from one another.

388

389 Our findings underline the importance of routinely considering how to prevent and manage 390 victimisation risk in mental health services, and also the role of general hospital and emergency 391 medicine to address mental health and re-victimisation. This will entail assessing risks in a 392 structured and consistent way, which will enable stratification, allocation of additional resources 393 to individuals at elevated risks, and potentially collaborative risk management with patients. 394 Furthermore, research exploring the optimisation of trauma-based interventions could potentially 395 reduce risks of post-victimisation risks of common psychiatric disorders and premature mortality. 396 This includes investigations into tailoring therapies to specific populations and settings and 397 evaluating the long-term effectiveness of existing approaches. Public health strategies can further 398 broaden the scope beyond individual interventions, fostering closer collaboration with social 399 services and criminal justice, and advocating for public policies targeting systemic factors like 400 alcohol and substance use, which contribute to wider societal victimisation risks. 401 402 In summary, in this large cohort study, we found that individuals who experienced violent 403 victimisation were at least twice as likely as their unaffected siblings to be diagnosed with 404 common psychiatric disorders, to engage in suicidal behaviours, and to die prematurely. These 405 risks remained elevated over two years post-victimisation, suggesting that mental health services 406 should review how they assess and manage subsequent risks of adverse outcomes. 407
