24 **Background:** Sodium reduction is a cost-effective measure to prevent noncommunicable

25 diseases. The World Health Organization (WHO) established a target of a 30% relative reduction

26 in mean population intake of sodium by 2025. The Pan American Health Organization (PAHO)

27 published sodium reduction targets for packaged foods in 2015, expanding and updating the

targets in 2021 to help Member States with its efforts in reducing population sodium intake.

29 **Objective:** This study examined the current sodium levels in packaged foods among five

30 countries in the Americas and monitored cross-sectional and longitudinal compliance with the

31 sodium targets from 2015 to 2022.

- 32 **Methods:** Food labels were systematically collected from the main supermarkets in five
- 33 countries in the Americas region in 2022. Sodium levels per 100g and per kcal for collected food
- 34 labels in 16 PAHO categories and 75 subcategories were analyzed and compared against the
- 35 Updated Regional Targets. Further analysis of three countries that have longitudinal data for
- 36 2015-2016, 2017-2018 and 2022 was conducted to compare sodium per 100 g against the 2015

37 PAHO Targets.

- 38 **Results:** A total of 25,569 food items were analyzed. Overall, *'processed meat and poultry'* had
- the highest sodium levels, although there were large variations within categories. 47% and 45%
- 40 of products met the sodium per 100g and per kcal 2022 targets, respectively. Peru had the highest
- 41 compliance, whereas Panama had the lowest for both targets. Among Argentina, Costa Rica and
- 42 Peru, the proportion of foods meeting the 2015 PAHO lower targets were 48, 53 and 61% for
- 43 2015-2016, 2017-2018 and 2022, respectively.
- 44 **Conclusions:** This study showed that around half of the examined foods met their respective
- 45 sodium targets and there have been small improvements in compliance over time. Further efforts
- 46 are required to reach the WHO's global sodium reduction goal by 2025, such as implementation
- 47 of mandatory sodium reduction targets and front-of-pack labelling regulations.

48 1. Introduction

49 Hypertension is one of the major risk factors for cardiovascular diseases (CVDs) and it has been

50 estimated to account for 10.8 million deaths globally in 2019^{1,2}. The number of adults with

51 hypertension has been increasing in the past few decades, with more than 1 billion adults

52 affected by hypertension in 2019, globally³. It has been well demonstrated that excessive

53 consumption of sodium is a significant causal risk factor for the development of hypertension

54 and reducing dietary sodium can have a favorable effect on the cardiovascular system⁴. The

- 55 World Health Organization (WHO) published a guideline in 2012 recommending less than 5g of
- salt (2g of sodium) intake per day for adults⁵. However, the global average salt intake in 2019

was estimated to be more than double the recommendation at 10.8g of salt (4.3g of sodium) per day^1 .

60 In 2013, WHO established an action plan that included reducing salt intake by 30% by 2025 and

all 194 Member States signed up⁶. A series of interventions had been proposed, including

62 reformulation of foods to contain less sodium, establishing public food procurement policies to

63 limit foods high in sodium, using front-of-package labelling that inform consumers of high

64 sodium products and using mass media campaigns to reduce sodium intake⁷. However, a report

65 released in early 2023 showed that the world is off-track to achieve this global target, with only

66 5% of countries (Brazil, Chile, Czech Republic, Lithuania, Malaysia, Mexico, Saudi Arabia,

67 Spain and Uruguay) implementing at least two mandatory and comprehensive sodium reduction

- 68 policies and all WHO sodium-related 'best buys'¹.
- 69

70 To support the Americas region in accomplishing the global target, the Pan American Health

71 Organization (PAHO) published a set of regional sodium reduction targets (2015 PAHO targets)

in 2015 for 18 food categories that were commonly sold in the region⁸. In 2019, a study

73 examined the sodium levels in packaged foods sold in 14 Latin American and Caribbean

74 countries (LAC) according to the 2015 PAHO targets. The study found 82% compliance with the

- regional target and 47% compliance with the lower and stricter targets⁹. The regional target level
- 76 was the maximum level (mg/100g) or upper limit, whereas food manufacturers were encouraged

to reach the lower target level that is reflective of the average level in reference countries⁸. A

- 178 later study published in 2021 showed that compliance with regional targets increased from 83%
- to 89% from 2015-2016 to 2017-2018 among four Latin American countries ¹⁰. Therefore,

80 PAHO updated the targets in 2021 to set stronger regional sodium reduction targets for 2022 and

81 2025 (2022 and 2025 PAHO targets) which are similar to the 2015 PAHO lower targets, and it

82 further categorized foods into 16 main categories and 75 subcategories^{11,12}. Similarly, WHO

83 published global benchmarks, defined as the lowest maximum value for each subcategory from

84 existing national or regional targets, for sodium levels in foods across different food categories¹³.

85 However, there has been no further follow-up study monitoring sodium levels in packaged foods

86 in the Americas since 2018. Thus, the objectives of this study were to 1) examine the current

sodium levels among five countries in the Americas (Argentina, Canada, Costa Rica, Panama,
and Peru), as well as monitor compliance with the Updated Regional Sodium Reduction Targets

for 2022; and 2) monitor the progress of sodium reduction among three Latin American countries

- 90 that have longitudinal data.
- 91

92 2. Methods

Monitoring sodium content in packaged foods sold in the Americas and compliance with the PAHO 2021 regional sodium targets

- 93 This cross-sectional study was conducted using data from five countries: Argentina, Canada,
- 94 Costa Rica, Panama, and Peru. Data from the Nutrition Facts table (NFt) (n=44,570) were
- 95 collected in supermarkets in Argentina (n=4,340), Costa Rica (7,402), Panama (n=1,509) and
- 96 Peru (n=5,378) between March and August 2022. The Food Label Information Program for Latin
- 97 America and Caribbean countries (FLIP-LAC) was used for data collection and analyses. FLIP-
- 98 LAC is a smartphone-based technology and web database, and the methodology was developed
- by The University of Toronto (U of T)¹⁴. The Canadian data (n=25,941) were extracted from the
- 100 Food Label Information and Price (FLIP) database collected in 2020¹⁴.
- 101
- 102 Foods were classified into 16 major categories and 75 subcategories described in the Updated
- 103 PAHO Regional Sodium Reduction Targets¹². The updated PAHO target categorization was
- individually completed by each country team and the U of T research team validated the results
- and resolved discrepancies with country team members. The sodium content was standardized
- 106 into mg/100g and mg/kcal where data were available. Foods excluded from the analyses included
- duplicated items, foods that could not be categorized under the PAHO categories (n=19,001),
- and foods that have 0 kcal were additionally excluded from the mg/kcal analysis, due to
- mathematical restrictions (n=387). Summary statistics were calculated for food products by food
- 110 categories and by country. The sodium level was compared against the Updated PAHO Regional
- 111 Sodium Reduction Targets (**Appendix A**) to determine the proportion of foods that met or
- 112 exceeded the target level set for 2022.
- 113
- 114 Since three countries in this study had baseline data from 2015-2016 and 2017-2018, categorized
- 115 under the 2015 PAHO targets, a further sub-analysis was conducted by categorizing the foods
- 116 collected in 2022 from Argentina, Costa Rica and Peru into the 2015 PAHO target categories (18
- 117 food categories)⁸. Sodium levels were compared against the 2015 PAHO regional (upper) target
- 118 level as well as the lower target level. Proportion of foods meeting the regional targets was
- 119 compared among the three timepoints. All analyses were conducted with R studio (5.12.10) and
- 120 Microsoft Excel (2016).
- 121
- 122 **3. Results**
- 123 After exclusions, this study included a total of 25,569 items across 16 PAHO sodium reduction
- main categories and 75 subcategories (Argentina n=2,515, Canada n=15,268, Costa Rica
- 125 n=3,875, Panama n=1,121, and Peru n=2,790).
- 126

127 3.1 Sodium levels per 100g and per kcal by PAHO categories

- 128 Of the 23,663 foods that had sodium per 100g available, *'processed meat and poultry'* and
- 129 'sauces, dips, gravy, and condiments' had the highest median sodium levels per 100g (both at
- 130 800mg/100g), followed by 'fats and oils' (720mg/100g) (Table 1). The variations within
- 131 categories were high, particularly among 'sauces, dips, gravy and condiments' (SD =
- 132 5,733mg/100g), 'processed fish and seafood' (SD = 972mg/100g) and 'processed vegetables,
- 133 *beans and legumes* ' (SD = 599mg/100g). There were variations between the median sodium
- 134 levels between countries, with the largest variation within 'sauces, dips, gravy, and condiments',
- 135 'soy products and meat alternatives' and 'processed meat and poultry'. The lowest variation
- 136 between countries was within 'fresh or dried plain pasta and noodles', 'processed fish and
- 137 *seafood*' and 'ready-made foods'.
- 138

- 139 Of the 23,236 foods that had sodium per kcal data available, 'sauces, dips, gravy, and
- 140 condiments', 'soups' and 'processed vegetables, beans, and legumes' have the highest median
- sodium level per kcal of 7.8mg/kcal, 6.0mg/kcal and 5.1mg/kcal, respectively (Table 2). The
- 142 lowest median sodium levels per kcal were among 'fresh or dried plain pasta and noodles'
- 143 (0mg/kcal), 'granola and energy bars and nut butters/spreads' (0.5mg/kcal) and 'cakes, biscuits,
- 144 *pastries, and sweet breads*' (0.7mg/kcal). The largest variations between countries were found
- among 'sauces, dips gravy and condiments', 'soups' and 'soy products and meat alternatives.
- 146 Variation within category was highest among 'sauces, dips, gravy, and condiments'
- 147 (SD=41.4mg/kcal), 'processed vegetables, beans and legumes' (SD=20.2mg/kcal) and 'soups'
- 148 (SD=17.8mg/kcal).

- 150 <u>3.2 Proportion of foods meeting the 2022 PAHO regional sodium targets by categories and</u>
 151 country
- 152 Overall, 11,037 of 23,663 (47%) analyzed foods met their respective 2022 PAHO sodium targets
- 153 (mg/100g). Peru and Argentina had the highest proportion of compliance (52% and 50%,
- respectively), whereas Panama had the lowest (36%) (Fig 1). By food category, the highest
- proportion of products meeting the regional target was among 'ready-made foods' (77%),
- 156 'processed meat and poultry' (53%) and 'cheese' (50%). The lowest proportion of foods meeting
- 157 the regional target was among 'bread products' (30%), 'granola and energy bars and nut
- 158 *butters/spreads* ' (37%) and '*processed fish and seafood*' (41%). The largest variation between
- 159 countries was observed in 'soy products and meat alternatives' (range: 28% to 85%) and 'soups'
- 160 (range: 31% to 54%) (**Table 3**).

- 162 Fig 1. Proportion of products meeting the updated 2022 PAHO Sodium Targets by country163
- 164 With respect to the PAHO targets for sodium levels per kcal, 10,304 of 23,000 (45%) foods met
- 165 their respective sodium targets (mg/kcal). Peru had the highest proportion of compliance (52%),
- 166 followed by Costa Rica (48%), whereas Panama only had 37% compliance (**Table 4**). By
- 167 category, the highest proportion of products meeting the regional target was among *'savoury*
- snacks' (71%), 'soups' (67%) and 'corn derivatives' (67%). The lowest proportion of foods
- 169 meeting the regional target was among 'bread products' (31%), 'cheese' (35%) and 'ready-made
- 170 *foods* ' (35%). The largest variation between countries was observed in 'soy products and meat
- 171 alternatives' (range: 33% to 80%) and 'fresh or dried plain pasta and noodles' (range: 16% to
- 172 55%) (**Table 4**).

- 174 <u>3.3 Changes in the proportion of foods meeting the old 2015 PAHO sodium targets</u>
- 175 The longitudinal analysis included a total of 10,571 foods, of which 2,915 foods were from the
- 176 2015-2016 collection, 3,241 foods were from the 2017-2018 collection, and 4,415 foods were
- 177 from the 2022 collection (countries: Argentina, Costa Rica, and Peru) across 18 2015 PAHO
- sodium food categories (Fig 2). Overall, the proportion of foods meeting the 2015 PAHO sodium
- regional target among the three countries was 82, 88 and 90% for 2015-2016, 2017-2018 and
- 180 2022, respectively (**Fig 2A**). The proportion of foods meeting the 2015 PAHO lower targets were
- 181 48, 53 and 61% for 2015-2016, 2017-2018 and 2022 (**Fig 2B**). There was an increase in the
- proportion of items meeting the regional targets, with a 9, 9 and 5% increase from 2015-2022 for
- 183 Argentina, Costa Rica, and Peru, respectively (**Fig 3**).

192 4. Discussion

193 This study provides an up-to-date assessment of sodium levels in packaged foods sold in five

194 countries in the Americas, after the publication of the Updated PAHO Regional Sodium

- 195 Reduction Targets in 2021¹². The results showed that the proportion of foods meeting the older
- 196 2015 PAHO sodium regional targets has gradually increased from 82% to 90%. However, the
- 197 progress is slow and there still needs to be improvement in compliance with the Updated Sodium
- 198 Reduction Targets. Further accelerated actions are needed for the achievement of sodium
- reduction goals. These data shed light into the progress in different countries in the Region
- 200 towards the current sodium reduction interventions aligned with recommendations from the
- 201 WHO's SHAKE technical package for sodium reduction ¹⁵ and other initiatives to reach the 2025
- 202 global target of a 30% relative reduction in mean population intake of sodium.
- 203

Processed meat and poultry and *'sauces, dips, gravy, and condiments* have the highest median
 sodium levels per 100g. This result is consistent with the previous regional study⁹ that showed a
 similar median sodium level for *'processed meats'* and a lower median sodium level in
 'sauces/condiments'. In addition to the sodium level by weight, sodium density (mg/kcal)

- accounts for the variation in energy consumption and has been shown to be more strongly
- associated with blood pressure than total intake¹⁶. Our results show that '*sauces, dips, gravy, and condiments*', '*soups*' and '*processed vegetables, beans, and legumes*' had the highest sodium
- density. These results are expected, as these food categories have lower energy density. Overall,
- the results also showed large variations within food categories, suggesting that lower sodium
- 212 options are available among different foods and showing the technical feasibility of reducing
- sodium levels in these categories. This is important, as it highlights the importance of combining
- other strategies, such as front-of-pack labels to help consumers identify lower sodium options,
- social marketing campaigns to encourage consumers to select lower sodium foods, marketing
- 217 restrictions to products with high sodium contents and nutrition standards for foods and
- 218 beverages available in schools and other settings, to disincentivize consumption of such
- 219 products. However, the high average and median sodium levels in many categories also
- suggested that governments need to encourage sodium reduction at the manufacturer level
- 221 through food reformulation by setting mandatory sodium reduction targets for key food
- 222 categories.
- 223
- 224 When examining the compliance in 2022 with the updated regional targets, almost half of the
- analyzed foods met their respective sodium targets (mg/100g). This proportion is the same as the
- previously reported compliance (47%) with the 2015 lower target (which is lower, if not the
- same, as the 2022 regional target)⁹, suggesting a small increase in the number of foods meeting
- the targets or the introduction of new low sodium alternative products. The compliance rate
- between countries was similar, except for Panama (36%). However, this needs careful
- 230 interpretation due to the different stages at which each country is in its efforts to reduce sodium.

231 On examination of the longitudinal progress of Argentina, Costa Rica and Peru, there was an 8%

increase in compliance when compared to the 2015 regional target (82% to 90%) and an 13%

increase when compared to the 2015 lower target (48% to 61%). While this may indicate some

- progress, it remains insufficient to achieve the target of a 30% relative reduction in mean
- population intake of sodium by 2025. Therefore, stronger measures and greater compliance withthe set targets are needed.
- 237

238 These five countries each have national-level policies supporting sodium reduction. For example,

Argentina included sodium maximum levels for certain food groups by passing Act 26905 in

240 2014 and there were education campaigns and restaurant policies to reduce sodium intake¹⁷.

241 There was also ongoing monitoring of Argentina's sodium content in foods. Studies in 2017-

242 2018 and 2022 showed that over 90% and 94% of surveyed food products, respectively,

complied with the national sodium reduction law^{18,19}. However, this suggests that the current local limits are too lax compare with the regional targets and require further adjustment; and the

necessity to include sodium source food groups that are currently not included, such as cheese

246 and puff pastries²⁰.

247

248 While Costa Rica has a voluntary sodium reduction strategy to reduce sodium levels in some key

food categories , progress has been monitored continuously^{21–23}. A study published by Vega-

250 Solano et al. in 2019 showed 87% compliance with the voluntary national sodium targets. In the

251 case of Peru, there is no specific national sodium reduction strategy in place; however, Peru

implemented 'high in' FOPL regulations in 2019 that requires foods exceeding established
 thresholds for nutrients of concern (i.e., sugar, saturated fat, trans fat, and sodium) to display a

 253 thresholds for nutrients of concern (i.e., sugar, saturated fat, trans fat, and sodium) to display a 254 'high in' symbol²⁴. This law could indirectly motivate food industry to reformulate products to

avoid a 'high in' symbol, as already seen in Peru and other countries^{25,26}. Canada published a

voluntary sodium reduction guideline for prepackaged foods in 2012 and updated the targets in

257 $2020^{27,28}$. Evaluations of this initiative have shown minimal progress over time, with only 14%

of food categories meeting sodium reduction targets in 2017²⁹. Panama has recently launched a

- 259 national plan to reduce sodium intake $(2022-2025)^{30}$.
- 260

261 Overall, these interventions aiming to reduce sodium intake by encouraging food reformulations 262 could have important public health impacts, as several simulation studies found that an important 263 number of CVDs could have been prevented or delayed if the reformulation targets or sodium guidelines would have been met^{31-34} . Worth noting that mandatory policies have shown to be 264 265 more effective than voluntary initiatives^{35,36}. For instance, a recent evaluation in South Africa, one of the fewest countries with mandatory sodium levels for key food categories, showed a 266 reduction in salt intake of 1.15 g/day during the first phase of the program (2015-2019), a 267 268 significant reduction in population-level sodium intake, while other voluntary initiatives in

countries like Brazil and Canada have shown only modest results in meeting sodium reduction

- targets^{29,37}. Given the slow progress in meeting regional sodium reduction targets, our results
 highlight the importance of establishing and monitoring effective and feasible mandatory sodium
- 271 Inginight the importance of establishing and monitoring effective a272 reduction targets to prevent diet-related NCD deaths.
 - 273

274 This study has both strengths and limitations that should be considered when interpreting our

findings. Variations in sampling sizes among countries could potentially influence the overall

study results. Therefore, a detailed examination of variations within each country at the

- subcategory level would be necessary, although out of the scope of this analysis. However, we
 do provide results of progress relative to the PAHO targets, at the major category level for each
- country. Furthermore, the data in this study were based on Nutrition facts table (NFt)
- information, with a permitted variation margin of 20% when reporting nutrient values in NFts.
- Additionally, several products per country were excluded due to the absence of sodium level
- declarations on food labels, as some countries within the region lack mandatory nutrient values
- declaration. Regional comparison at different time points was limited to only three countries.
- including other countries in future analyses will provide a more comprehensive assessment at the
- regional level. However, this regional analysis benefited from the utilization of common
- methodologies across countries (e.g., data collection, data cleaning, and analysis). Additionally,
- several quality assurance measures were performed including food category categorization and
- validation, outlier check and Atwater validation. Furthermore, prices of products were not
- included in this study. To ensure the decrease in sodium content is not driven by the lower
- sodium products that might be higher in price (which likely will not target the majority of
- 291 population), future studies should also consider including sales-weighted average sodium levels
- to account for the actual sales of foods sampled.

294 **5.** Conclusion

- 295 Overall, this study provides an ongoing surveillance of the sodium content in package foods sold
- in five countries in the Americas, under key food categories of the Updated PAHO Regional
- 297 Sodium Reduction Targets. Around half of the examined foods met their respective sodium
- targets and there has been some improvement in the compliance overtime, although the
- reductions have been modest at best. Further efforts are required to reach the WHO's global
- 300 sodium reduction goal by 2025, such as implementation of national mandatory sodium reduction
- 301 targets, reformulation guidelines, FOPL regulations, marketing restrictions, social marketing
- 302 campaigns, and nutrition standards in schools and other settings, among others. Moreover, there
- 303 is a need to transform the food systems and promote a healthy diet based on unprocessed or
- 304 minimally processed foods, rather than ultraprocessed foods.
