1 Association of 25-OH Vitamin D Levels With In-Hospital

2 Mortality: A cross-sectional, observational study of the MIMICIV

15 Abstract

- 16 The relationship between 25-OH Vitamin D3 and hospital death continues to be a topic of
- 17 controversy. At present, the available evidence regarding the relationship between 25-OH
- 18 Vitamin D and hospital death is inadequate. Therefore, we conducted a cross-sectional study
- 19 involving 197 sepsis-3 participants from MIMIC-IV. Basic information, laboratory indicators, NOTE: This preprint reports new research that has not been certified by peer review and should not be used to guide clinical practice.

20	underlying Disease, therapeutic medications and tools, disease score were obtained from all
21	participants. Serum 25-OH Vitamin D was collected on Intensive Care Unit (ICU) admission,
22	and inpatient mortality were analyzed. The logistic regression, fitting curve and interaction
23	effects were utilized to substantiate the correlation of serum 25-OH Vitamin D with inpatient
24	mortality. Furthermore, interaction and subgroup analyses were evaluated for the consistency
25	of these correlations. A total of 197 patients were included in the analysis, with an average
26	age of 59.8 years and 43.1% male. The mean 25-OH vitamin D level in the cohort was 21
27	ng/mL. We observed no significant association between higher 25-OH vitamin D levels and
28	increased inpatient mortality rates. The in-hospital mortality did not differ among patients
29	vitamin D deficiency, insufficiency and sufficiency group (15.7% vs 17.4% vs 24.5%,
30	p=0.417). A multivariable adjusted logistic regression model showed that vitamin D levels
31	could not predict in-hospital mortality (OR 1.02 95% CI: 0.98~1.05, p=0.342, Model 3). In
32	conclusion, 25-OH vitamin D detected upon ICU admission was not associated with in-
33	hospital mortality in patients with sepsis.

35 Introduction

36 Sepsis is a serious condition caused by the body's abnormal response to an infection,

37 resulting in life-threatening organ dysfunction(1). It is a leading cause of death in intensive

care unit (ICU) patients, and its mortality rates have increased to over 30% due to factors

39 such as global aging, invasive surgeries, immunosuppressant usage, and the rise of antibiotic-

40 resistant bacteria(2). To address this, it is crucial to study the factors that impact sepsis

41 mortality in order to reduce the mortality rate.

42 Vitamin D, a fat-soluble hormone, plays a crucial role in regulating calcium and phosphorus

43 levels, maintaining bone and cardiovascular health(3), and boosting immunity(4).

44	Vitamin D is an essential nutrient for humans that was discovered in 1921. In addition to
45	regulating calcium and phosphate metabolism, it is important for immunity, endothelial
46	function, and antimicrobial activity(5). Previous related studies have evaluated the
47	relationship between vitamin D deficiency and mortality risk in patients with sepsis. A two-
48	center observational study said that 25-OH vitamin D deficiency prior to hospital admission
49	is a significant predictor of sepsis in the critically ill, which has an increased risk of mortality
50	following critical care initiation(6). While, a prospective multicentre observational study
51	illustrated that 25-OH vitamin D deficiency detected upon ICU admission was not associated
52	with 90-day mortality in patients with severe sepsis(7).
53	It is unclear whether lower serum 25 (OH) D predicts poor outcome in sepsis. Therefore, we

It is unclear whether lower serum 25 (OH) D predicts poor outcome in sepsis. Therefore, we aimed to conduct an association analysis of the MIMIC data to comprehensively assess the relationship between serum 25 (OH) D and the risk of in-hospital mortality in adult patients with sepsis.

57 Materials and Methods

58 Data Source

59 We performed a retrospective cohort study using the Medical Information Mart for Intensive Care (MIMIC-IV) (version 2.2)(8,9), which is a large publicly accessed database. The use of 60 61 this database has been approved by the Massachusetts Institute of Technology and the Institutional Review Board of Beth Israel Deaconess Medical Center (BIDMC, Boston, MA, 62 USA). One of the authors, Yaotang Wang, accomplished the National Institutes of Health's 63 64 web-based course "Data or Specimens Only Research" (Record ID: 59979404) and "Conflicts 65 of Interest"(Record ID: 59979406) and was approved to access the database to extract data. To protect patient privacy, all data were de-identified. Thus, informed consent was waived by 66

the ethical committee of the Beth Israel Deaconess Medical Center. This study is described in
conformity to the strengthening the Reporting of observational studies in Epidemiology
(STROBE) statement and was managed to conform to the tenets of the Declaration of
Helsinki.

71 Study Population and Variable Extraction

The total number of patients in the MIMIC-IV included 299,712 individuals from 2008 to 72 73 2019, of which 73,181 were admitted to the ICU. Among them, 25647 patients with sepsis-3 were selected based on definition(10). Patients >18 years were initially enrolled in this study, 74 and only data for the first hospitalization and ICU stay were collected for patients. Meanwhile, 75 patients without serum 25-OH-VitaminD after ICU admission who stayed in the ICU were 76 77 excluded. Thus, only 197 patients were included in this study after further excluding covariates with missing values(Figure 1). The first test serum 25-OH-VitaminD after ICU 78 79 admission was extracted as the interest variable and the major exposure factor in this study. All variables in this study were extracted from the MIMIC-IV database using Structured 80 Query Language (SQL) with PostgreSQL. Demographic variables, including age, sex, 81 ethnicity and marital status, were obtained. Clinical severity on admission was examined 82 using the APACHE II score and SOFA score. Vital signs in this study also included, such as 83 temperature, heart rate, respiratory rate (RR), and percutaneous oxygen saturation (SpO2). 84 Comorbidities, including myocardial infarction, congestive heart failure, chronic pulmonary 85 disease, renal failure, diabetes without complication, diabetes with complication and renal 86 disease and malignant cancer, were also included for analysis based on the recorded ICD-9 87 and ICD-10 codes from the database. Laboratory variables, including hematocrit, platelet 88 89 count, white blood cell (WBC) count, anion gap, bicarbonate, sodium, potassium, glucose, chloride, creatinine and blood urea nitrogen (BUN), were obtained within the first test after 90 ICU admission. The details of the missing value are shown in Table 1. 91

92 **Outcomes**

93 The primary endpoint was hospital inpatient death, which was defined by patient survival94 status at the time of hospital.

95 Statistical analysis

- 96 Continuous variables were described as means±standard deviation (SD) or as median
- 97 interquartile ranges (IQR), and categorical variables were described as percentages. We used
- 98 Fisher's exact and Chi-square tests or the Kruskal-Wallis test to examine the statistical diff
- 99 erences among three groups—the deficient serum 25-OH-VitaminD (AG <19.9ng/ml),
- 100 insufficient serum 25-OH-VitaminD(20ng/ml≤25-OH-VitaminD<30ng/ml) and sufficient 25-
- 101 OH-VitaminD(> 30ng/ml)groups(11). We used multivariate logistic regression models to
- 102 evaluate the relationship of serum 25-OH-VitaminD and inpatient mortality. Restricted cubic
- spline analysis was used to describe the non-linear association between serum 25-OH-
- 104 VitaminD and inpatient mortality.
- 105 Baseline variables that were considered clinically relevant or had a change in effect estimate
- 106 of >10% were chosen as confounders. In Model I, the covariates were adjusted for
- 107 age,gender,temperature,SpO2,marital status,potassium. As for adjusted model, the covariates
- 108 were additionally included with mycardial infraction, diabetes with complications and

109 vasopressors post.

110 Furthermore, interactions and stratified analyses were conducted using

111 age,gender,temperature,SpO2,marital status,potassium,mycardial infraction,diabetes with

- 112 complications and vasopressors post, as previously described. For the missing data, we
- directly excluded them. All results were expressed as odds ratios (OR) with a 95% CI, and a
- p-value of <0.05 was considered significant. All analyses were performed using the statistical

- software packages R 3.3.2 (http://www.R-project.org, The R Foundation) and Free Statistics
- 116 software version 1.9.2 (Beijing, China)(12).

117 **Results**

118 Baseline Characteristics of Subjects

- 119 In total, 216 of the 25647 sepsis-3 patients who received 25-OH-VitaminD measurement
- 120 were included in this study (Figure 1). Excluding those with missing some covariates, a total
- 121 of 197 people were included in the final study. Among them, there were 85 males and 112
- 122 females, and the mean age was 59.8 ± 16.9 . The distribution of the baseline population
- 123 characteristics according to serum 25-OH-VitaminD levels in tertiles is described in Table 2.
- 124 The patients with sufficient serum 25-OH-VitaminD levels (≥30ng/ml) were found to have a

125 higher age and bicarbonate, a lower anion gap and creatine level.

127 Association between 25-OH Vitamin D Levels and inpatient mortality

Table 2 presents the results of the multivariable logistic regression analysis examining the 128 129 association between 25-OH-VitaminD and inpatient death. A high 25-OH-VitaminD wasn't associated with an increased risk of inpatient death (Per 1 unit: OR=1.02, 95% CI=0.98~1.05, 130 P=0.342), after adjusting for potential confounders (Table 2, all adjusted model). When 25-131 132 OH-VitaminD was divided into three tertiles, multivariable-adjusted regression odds ratio (95% CIs) of 25-OH-VitaminD associated with based on 25-OH-VitaminD of group1 and 133 group2 was 0.76 (95% CI=0.29~1.99, p=0.574), and 0.75 (95% CI=0.25~2.23, p=0.601) 134 when comparing the 25-OH-VitaminD sufficient group, respectively (Table 2, all-adjusted 135 136 model).

137	Evidence from the estimated dose-response curve indicated a linear relationship between 25-
138	OH Vitamin D and risk of inpatient death (Figure 3, P for non-linearity =0.176, restricted
139	cubic spline analyses adjusted for multiple variables, and the highest and lowest 0.5% was
140	trimmed for each 25-OH Vitamin D measure.)

141 Subgroup Analysis

142 Subgroup analyses were performed to evaluate the association between serum 25-OH

143 Vitamin D levels and inpatient mortality (Figure 4) among subgrs. Based on the variables

144 tested, an association between higher serum 25-OH Vitamin D level and inpatient mortality

145 was observed in different subgroups (age ,gender,anion gap, sofa score and vasopressor post)

146 (p > 0.05 for all).

147 Discussion

Vitamin D is involved in the inflammatory response and in the regulation of the body's 148 immunity. There are many conflicting research opinions on the correlation between vitamin D 149 and sepsis mortality, with some studies suggesting that lower vitamin D levels are associated 150 with increased mortality in sepsis patients. However, there have been other studies that have 151 found no significant effect of vitamin D supplementation on survival in sepsis patients. 152 153 Therefore, while there are some studies that support an association between vitamin D and sepsis mortality, this is an area where further research is needed to draw definitive 154 conclusions. 155 The mechanism by which vitamin D deficiency is associated with sepsis death may be due to 156 an increased susceptibility to sepsis caused by the dysfunction of immune cells as well as 157

barrier cells(13). On the other hand, the reduction of 1,25 (OH) 2D3 at the tissue level may

reduce the body's ability to regulate autoimmunity and affect the expression of antimicrobial

peptides(14), affect the body's innate immune regulation, and further increase the sepsissusceptibility(15).

Two meta-analyses from 2014 and 2015 suggested that vitamin D deficiency increased 162 susceptibility for sepsis(16,17). A prospective study of 88 patients showed that low serum 163 vitamin D level on admission (<8.1 ng/mL) was associated with increased 28-day mortality 164 in sepsis, and multivariate COX regression analysis showed that vitamin D concentrations 165 166 < 8.1 ng/mL (p=0.01) and septic shock (p=0.02) were associated with increased mortality in sepsis. The hazard ratio for 28-day mortality with a vitamin D level <8.1 ng/mL was 1.95 167 168 (95% CI 1.15 – 3.29, p=0.01, and the mean survival of patients with vitamin D levels <8.1 ng/mL was 9 days (median 6 days), while those with vitamin D levels of 8.1 ng / mL had a 169 170 mean survival of 14 days (median 10 days)(18). A study of the role of 1,25-dihydroxyvitamin 171 d3 in experimental sepsis showed no regulation of vitamin D in lipopolysaccharide-induced sepsis(19). A study of 116 cases on the relationship between vitamin D and COVID-19 172 inflammation storm showed that high-dose vitamin D is considered a promising treatment to 173 inhibit cytokine storms in COVID-19 patients, and is associated with better clinical 174 175 improvement and less adverse outcomes(20). An observational study showed that 107 critically ill adult patients with sepsis reported vitamin D deficiency in 93.5% of patients, and 176 53.3% of them showed extremely low 25 (OH) D flow concentration (7 ng/mL), specifically, 177 178 extremely low 25 (OH) D flow concentration and higher mean SAPS 2 score were independent predictors of sepsis-related mortality(21). 179 Compared with the previous study, our study reached a different conclusion, our results show: 180 in multivariate regression analysis, in vitamin D sufficient group, insufficient group, and lack 181 182 group, unadjusted model, model 1 and full model respectively, shows that VD and in-hospital

is neither dangerous nor protective factors, and model OR changes between each group, themodel is robust.

Although most studies showed a significant inverse association between vitamin D level and 186 mortality, there are also previous studies consistent with our findings. A single-center 187 prospective study showed that vitamin D was not associated with in-hospital mortality(22). 188 An additional prospective study of 461 people analyzing the association of 25 (OH) D and 189 1,25 (OH) D with sepsis mortality also showed that vitamin D did not predict death in 190 patients with sepsis(23). 191 192 In addition, the epidemiological results of our study showed that the total number of 25-OH-VitaminD (<19.9) and 25 (2025-OH-VitaminD <30) (51%, 23%) and 49 (30 25-OH-193 194 VitaminD) in the adequacy group 49 (24%). The mortality rate in the VD deficiency group 195 was 15.7% versus 24.5%, respectively. The difference between 25-OH-VitaminD deficiency 196 was insignificant (15.7VS17.4% VS 24.5%, p=0.417). Accordingly, a prospective observational study conducted by Konlawij Trongtrakul et al had expressed that among septic 197 198 patients the total number of 25-OH-VitaminD deficient (<20 ng/mL) and non-deficient (≥20 199 ng/mL) was 110, or 83,27 (75%, 25%, respectively). The mortality rate in the VD deficient and non-deficient groups were 16% versus 4%, respectively. The total number of patients 200 (<12 ng/mL) (12 ng/mL) was 53,57, respectively, mortality in the VD deficiency group was 201 202 23% versus 4% in the non-severe deficiency group, respectively, 30-day in-hospital mortality was not significantly higher in the vitamin D deficiency group (16% vs 4%, p=0.18), but the 203 difference between the severe deficiency group and the non-severe group was significant 204 (23% vs 4%, p=0.02)(25). Compared with the similar studies, the vitamin d deficiency 205 206 groups in the two studies showed similar mortality (15.7% VS 16%), but not in deficiency (20 ng/ml) (10% VS 4%). In our study, the population in the vitamin D non-deficiency group, 207

208 mortality was higher than that in the other study populations and no significant relation209 among tertiles were found.

The reasons for the above results may be as follows: First, the sepsis patients admitted to ICU 210 are in critical condition, and after a period of poor treatment effect, they eventually develop 211 212 critically ill. As a result, most of the patients are in bed or semi-bed state, with insufficient light, poor diet and decreased absorption capacity. Second, most of the patients in ICU were 213 214 septic shock. On the first day of admission, after a large amount of fluid resuscitation treatment, dilutional factors led to the relative reduction of vitamin D. The underlying causes 215 216 for these findings could be: Initially, patients with sepsis in the ICU are in a critical state, and following a phase of ineffective treatment, they ultimately become critically ill. Consequently, 217 a majority of the patients remain in a bed or semi-bed condition, suffering from inadequate 218 219 lighting, a substandard diet, and reduced absorption ability. A majority of ICU patients 220 experienced septic shock. Upon initial hospital admission, following extensive fluid resuscitation, factors causing dilution resulted in a noticeable decrease in vitamin D levels. 221 Additionally, the observational design of the study meant that its findings could only indicate 222 a correlation, not a direct cause-and-effect link. Thirdly, there could be complicating 223 elements that the multivariate regression analysis overlooked. 224 Overall, our study produced negative results, probably because the vitamin D and sepsis 225 and related covariates in MIMIC-IV database, only 197 people, sample size factors, of course, 226 227 there are bias in retrospective cohort study, further for the large sample population and multicenter study, look forward to further clarify the correlation between vitamin D and 228 sepsis patients mortality, hope early detection of sepsis patients and reduce the incidence and 229 230 mortality of severe patients.

231 Conclusions

In conclusion, vitamin D deficiency at ICU admission was not associated with in-hospital
 mortality in sepsis patients.
