- 22 Introduction Despite the evidence that fatherhood has a long-term positive and protective 23 effect on men's health, there is also evidence that fatherhood in the perinatal period can be 24 complex and demanding. The challenging nature of fatherhood during the perinatal period
- 25 can be further compounded by the experience of preterm birth. Preterm birth, defined as a
- 26 birth occurring before 37 weeks of gestation, has been identified as a risk factor for
- 27 maternal stress, anxiety, depression and post-traumatic stress. It can be hypothesised that
- 28 preterm birth is also a risk factor for fathers mental health; however, as no attempt has
- 29 been made to systematically review studies that have examined preterm births and father's 30
- mental health during the perinatal period it is currently not known how common or
- 31 significant the impact of a preterm birth is on father's mental health during this life stage.

- 33 The aim of the systematic review will be to critically appraise the empirical evidence that
- 34 examined preterm birth and father's mental health during the perinatal period.
- 35 Design
- 36 Systematic review
- 37 Methods
- 38 The review will be guided by the PRISMA reporting process. Electronic databases Medline,
- 39 CINAHL, the Cochrane Library, PsycARTICLES, PsycINFO, Psychology and Behavioural Sciences
- 40 Collections will be searched to identify studies that meet the inclusion criteria. Studies that
- 41 researched preterm birth during the perinatal period will be included if fathers mental health
- 42 was the principal focus of the research, if fathers mental health was in the title and/or aim of
- the study or if fathers mental health was an outcome or dependent variable. Data will be
- 44 extracted and presented in narrative form including tables and figures.

52 Introduction

- 53 The perinatal period, which covers the time when a man's partner becomes pregnant through
- to the first year after birth is marked by significant change and the absence of routine [1].
- 55 While most of these changes are expected and welcome, others can be unanticipated [2].
- 56 Despite the evidence that fatherhood has a long-term positive and protective effect on men's
- 57 health, there is also evidence that fatherhood in the perinatal period can be complex and
- 58 demanding [3]. Fatherhood, even when desirable and planned, can be challenging [4]. The
- 59 challenging nature of fatherhood during the perinatal period can be further compounded by
- 60 the experience of preterm birth (PTB) [5].
- 61 PTB, defined as a birth occurring before 37 completed weeks of gestation, is a major perinatal
- health problem and the leading cause in perinatal morbidity and mortality worldwide [6,7].

The PTB rate is estimated at 11% or 15 million annually worldwide, [6], with a prevalence
varying from 4% to 18% [6].

65 Preterm birth is one of the most common reason for admission to a neonatal intensive care 66 unit (NICU) and means the start of an emotional, difficult and stressful period for parents [5]. Preterm birth has been associated with symptoms of depression, anxiety and post-traumatic 67 68 stress [8]. A recent meta-analyse found a higher risk for adverse mental health outcomes for 69 mothers of preterm infants [9]. Preterm birth has also an impact on the mental health of 70 fathers [10]; however, as no attempt has been made to systematically review studies that 71 have examined preterm births and father's mental health during the perinatal period it is 72 currently not known how common or significant the impact of a preterm birth is on father's 73 mental health during this life stage.

To date, research examining paternal perinatal mental health has primarily focused on depression, with less attention given to stress and anxiety [1]. More recently, there has been a shift towards focusing on stress and anxiety, the evidence suggests all three are highly correlated [11]. Other areas of mental health that have received little attention regarding fathers during the perinatal period include Post Traumatic Stress Disorder (PTSD), Obsessive Compulsive Disorder (OCD), and Substance Use [1].

80 Reported rates of adverse paternal perinatal mental health outcomes are significant; 81 however, they are likely to be under representative of the true prevalence as there is a 82 gendered context in men underreporting mental health symptoms, leading to 83 underdiagnoses [1]. Despite the potential of underreporting the prevalence rates represents 84 a significant public health concern. To date, systematic reviews have been completed on 85 paternal perinatal stress, and anxiety a depression with prevalence rates reported between

86 6% to 68.8%, 2.4% to 51% and 8.4% respectively. [11, 12, 13]. Risk factors associated with 87 adverse paternal perinatal mental health have also been investigated. Philpott [1] suggests 88 that understanding risk factors helps identity fathers who are likely to develop adverse mental 89 health outcomes during the perinatal period and the evidence suggests that adverse 90 outcomes can relate to personal, maternal, infant, relationship, socioeconomic and 91 environmental factors. One such risk factor is having a preterm birth/infant [10]. To date, no 92 attempt has been made to systematically review studies that have examined preterm births 93 and father's mental health during the perinatal period; therefore, it is currently not known 94 how common or significant the impact of a preterm birth is on father's mental health during this life stage. 95

A systematic review will give a better understanding of the impact that preterm birth has on
father's mental health during this life stage and will help identify risk populations of fathers,
inform service planning and lead to more targeted interventions to support fathers. It will also
provide researchers with an opportunity to identify areas where future research is needed.
Given the lack of clarity around the current knowledge and the potential impact of preterm
birth on father's mental health, a systematic review is both timely and warranted.

To our knowledge, no systematic review to date has summarized the evidence from studies
assessing PTB and adverse paternal mental health outcomes during the perinatal period.
Therefore, the aim of this systematic review was to identify, critically evaluate and summarise
studies that explored PTB and paternal mental health during the perinatal period.

The objectives for this review will be to identify a) what paternal mental health outcomes have been assessed; b) how paternal mental health outcomes were measured; c) the levels/prevalence of paternal mental health outcomes; d) the impact of paternal mental

109 health outcomes in relation to their health and social relationships and e) interventions and 110 strategies used to manage paternal mental health outcomes. We hypothesize that the 111 association between preterm birth and adverse mental health of fathers during the perinatal 112 period will be confirmed, but methodological differences among the studies might impact on 113 the results.

114 Methods

115 Study design

- 116 A systematic review of peer reviewed literature with respect of paternal mental health
- 117 during the perinatal period, if possible a meta-analysis, will be performed in accordance
- 118 with the Preferred Report Items for Systematic Reviews and Meta-analyses (PRISMA)
- 119 statement. The PRISMA protocols (PRISMA P) checklist [16] was used to prepare this
- 120 protocol (S1 table).
- 121 Eligibility criteria and information sources
- 122 Inclusion and exclusion criteria are listed in table 1. Electronic searches of literature will be
- 123 carried out using the following databases: Medline, CINAHL, the Cochrane Library,
- 124 PsycARTICLES, PsycINFO, Psychology and Behavioural Sciences Collections. No date limit will
- 125 be applied to the searches.

127 Search strategy

128 Search terms to be used are listed in table 2. The search strategy will include the Boolean

- 129 terms "OR"/ "AND" and truncation (*). Phrase searching ("") will also be used. Keywords
- 130 and search terms are demonstrated in Table 2.

133 Study selection

134 Relevant studies will be identified through electronic database searching, which utilizes the 135 search terms. The relevant studies from the databases will be exported to Covidence and 136 the duplicates will be removed. Two independent researchers (LP and IT) will initially screen 137 the title and abstracts of the studies. The studies will be removed if they do not fit the 138 inclusion criteria. After that, the full text of the remaining studies will be reviewed by two 139 independent researchers (LP and IT) to choose the studies for the review. If there are any 140 discrepancies, a third researcher (TT) will assess the studies to make the final decision. The 141 study selection will be regulated and exhibited using a PRISMA flow diagram (Fig 1).

142 Quality appraisal and risk of bias assessment

The methodological quality of the included studies will be assessed by two researchers (EvD and FD'n) using the Joanna Briggs Institute (JBI) critical appraisal checklist for systematic review and research synthesis [15] and reported as per the Preferred Reporting Items for Systematic Reviews and Meta-analyses (PRISMA) [14]. Discrepancies will be resolved through mutual discussion and agreement. Considering the type of studies that will be included, various tools for assessing the risk of bias will be utilised.

149 Data collection

One author (LP) will extract the relevant data from the studies: author name and country, year of publication, study aim, study setting, study design, participant details and recruitments, type of adverse mental health outcome, findings and limitations. Another author will independently cross-check data extraction (IT). Discrepancies will be resolved by consensus. The data extraction tables are presented in Tables 1 (characteristics of each study) and Table 2 (findings and limitations of each study). Data analysis will be descriptive. If the

- 156 nature of the included studies allows, a meta-analysis will be undertaken. If the criteria for a
- 157 meta-analysis are not met (i.e., heterogeneity in research designs, interventions, and
- 158 outcome measures among studies) a narrative synthesis of the findings will be undertaken.

163 Data synthesis

- 164 The abstracted data from the selected studies will be synthesized and presented according
- to the primary aim and objectives of the review. Extracted data from eligible studies will be
- 166 presented in evidence tables and a narrative synthesis will provide a summary of the
- 167 prevalence of adverse paternal mental health related to preterm birth in the perinatal
- 168 period, the contributing factors to adverse mental health outcomes, the measurement tools
- 169 used to assess adverse mental health outcomes, the time point/s when adverse mental
- 170 health outcomes were measured during the perinatal period and what
- 171 interventions/strategies are available for fathers to manage and address adverse mental
- 172 health outcomes.

175 Ethics and dissemination

The review will not require ethical approval and the findings will be published in a peer reviewed journal using the PRISMA guidelines and presented orally at an International research conference.

179 Discussion

- 180 Fatherhood can be complex and challenging [4], in particular when experiencing a PTB [5].
- 181 PTB has been associated with symptoms of depression, anxiety and stress [8] However,
- 182 systematic reviews about the impact of PTB on father's mental health are lacking.
- 183 Therefore, this review aimed to identify, critically evaluate and summarize studies that
- 184 explored PTB and paternal mental health and wellbeing during the perinatal period,
- 185 including outcomes, measuring instruments, prevalence, impact and interventions. The
- 186 rigorous and transparent methodology of this systematic review will result in a better
- 187 understanding of the potential impact of PTB on fathers' mental health and lead to more
- 188 targeted interventions to support fathers during this life stage.
