27 Abstract

28 **Objective**

- 29 Prelacteal feeds disrupt early breastfeeding initiation and exclusive breastfeeding and increase the
- 30 risk of childhood illnesses and under-five mortality. Despite its negative health outcomes, prelacteal
- feeding prevails in Papua New Guinea (PNG). This study aimed to investigate the factors associated
- 32 with prelacteal feeding among women in PNG.

33 Design and setting

- 34 A population-based cross-sectional study based on Demographic and Health Survey data
- 35 Setting
- 36 Papua New Guinea
- 37 **Participants**
- 38 A total weighted sample of 4399 women was included in the study.
- 39 Main outcome measures
- 40 Prelacteal feeding, modeled using multivariable logistic regression.
- 41 **Results**
- 42 About 10% (95% CI: 9 to 11) of women provided prelacteal feeds to their infants in PNG. The most
- 43 frequently reported prelacteal feed was plain water (71.7%), followed by grains (eg, noodles)
- 44 (47.1%), dark green leafy vegetables (42.1%), and soup (39.7%). Women with no formal (AOR 1.4,
- 45 95% CI: 1.0 to 3.0) or primary education (AOR 1.5, 95% CI: 1.0 to 2.9), from the Islands region
- 46 (AOR 2.3, 95% CI: 1.5 to 3.5), who had a cesarean section (AOR 4.1, 95% CI: 2.4 to 7.2), and who
- 47 had given birth at home or in the village (AOR 3.7, 95% CI: 2.1 to 6.8) had higher odds of
- 48 providing prelacteal feeds. No statistically significant association was found between immediate
- 49 newborn skin-to-skin contact after birth and prelacteal feeding.

50 Conclusion

- 51 Our study underscores the role of sociodemographic and healthcare system factors in prelacteal
- 52 feeding. Strengthening healthcare providers' capacity to increase mothers' awareness of optimal

- 53 breastfeeding and promote more health facility births is warranted. Comprehensive breastfeeding
- 54 education should also be promoted at antenatal clinics and during outreach healthcare activities.

56 Strengths and limitations of the study

- The rigor of the methodological approach and representativeness of the survey render its results
- and recommendations generalisable to the country.
- The study's findings, based on appropriate estimation adjustments and sample design, are
- 60 representative of female population in PNG; thus could guide policy development and design
- 61 for effective infant and child feeding interventions.
- The study's cross-sectional nature means that a temporal relationship cannot be established
- 63 between the outcome and independent variables.
- Prelacteal feeding was assessed based on the maternal self-report, which might have resulted in
- desirability bias; mothers may be less likely to report that they have provided prelacteal feeds
- 66 while knowing its adverse outcomes.
- The DHS did not collect some important information, such as maternal beliefs, misconceptions,
- 68 knowledge, attitudes, and practices towards breastfeeding, which could impact prelacteal69 feeding in this context.

71 Introduction

- 72 Breastfeeding and human milk are the normative standards for infant feeding and nutrition, offering
- numerous short- and long-term health benefits for both mother and child [1]. Improving
- breastfeeding rates could potentially save over 800 000 children under five globally every year [2].
- 75 Breastfeeding has been proven to decrease childhood diseases such as respiratory tract infections,
- otitis media, diarrheal diseases, undernutrition, and childhood obesity [2–5]. Also, breastfeeding has
- the potential to prevent approximately 20 000 deaths from various diseases such as breast cancer,
- 78 diabetes, obesity, and cardiovascular diseases [2,4]. Thus, early initiation of breastfeeding within

the first hour after birth, exclusively until six months, and continuing up to two years of age ishighly recommended [6].

81 82	Despite the multiple benefits of breastfeeding, not all infants worldwide receive early, exclusive, or
83	continued breastfeeding. Only 37% of infants under five are exclusively breastfed in low- and
84	middle-income countries (LMICs) [2,7], while inappropriate feeding practices account for two-
85	thirds of malnutrition-related deaths during the first 24 months of life [8]. Delays in breastfeeding
86	initiation within the first hour of birth can disrupt exclusive breastfeeding and increase the odds of
87	prelacteal feeding, including neonatal mortality [9,10].
88 89	Prelacteal feeding, which is the provision of any food or liquid to an infant before breastfeeding is
90	established during the first three days [11], has been shown to interrupt breastfeeding initiation and
91	impede exclusive breastfeeding [12–14]. It can also be detrimental to breastfeeding and harmful to
92	health, as it deprives infants of valuable nutrients and antibody-rich colostrum and exposes them to
93	the risk of infection [15–18]. Studies have shown that the type of prelacteal feed given to the
94	newborn is predominantly associated with sociodemographic and economic factors (eg, education,
95	occupation, income), maternal health care service utilization, mode of birth, place of giving birth,
96	breastfeeding education, and unskilled birth attendants [16,19–21]. Other factors such as poor
97	breastfeeding knowledge, breastfeeding problems, maternal illness, delayed initiation of
98	breastfeeding, and social and cultural norms are factors associated with prelacteal feeding [22-25].
99 100	Additionally, prelacteal feeding predisposes infants to pathogenic factors, creating physiological
101	disruptions in the immature gastrointestinal systems, leading to infantile diarrhoea, and affecting
102	infants' development [18,26]. However, despite its consequences, it remains a prevailing nutritional
103	malpractice and a risk indicator for infant morbidity and mortality in LMICs [27]. A population-
104	based analysis of 57 participating countries found that prelacteal feeding remained prevalent in
105	I MICs, with Asia having the highest providence (nearly 600) compared to other regions (<100)

LMICs, with Asia having the highest prevalence (nearly 60%) compared to other regions (<40%)

106 [28]. Similarly, recent studies in the Asia-Pacific, such as Bangladesh, Nepal, and Pakistan, showed

107	high prelacteal feeding rates (29%, 30.2%, and 32%, respectively) [29-31]. Such forms of
108	supplementation can be particularly deleterious in settings where poverty or resource scarcity can
109	impede nutritional potential.
110 111	PNG, a linguistically diverse country, has a strong breastfeeding culture, with an estimated
112	breastfeeding rate ranging from 62% to 85% among children aged less than 24 months [32,33].
113	Prior studies further indicated a high prevalence of early initiation of breastfeeding in the remote
114	settings of Madang (36%) and Gulf (69%) provinces [34,35]. Despite this evidence, a recent DHS
115	finding revealed that 40% of women in PNG delayed breastfeeding initiation within the first hour
116	after birth [36]. Similarly, only about 50% of children aged 6 to 8 months from urban and rural
117	locations in six provinces were fed complementary foods in the country [33]. Suboptimal
118	breastfeeding practices have been associated with maternal age, lack of breastfeeding knowledge
119	and support, poor antenatal education, place and type of birth, poor skin-to-skin contact, and
120	sociocultural norms [25,34,36–38].
121 122	There is therefore evidence that suboptimal breastfeeding and the introduction of prelacteal feeds
123	are common in PNG [25,34,37,38]. However, little is known about factors that may influence
124	prelacteal feeding at the population level. There is also insufficient evidence to determine whether
125	PNG women are aware of the risks associated with prelacteal feeding, such as gastroenteritis and
126	respiratory infections. To bridge the knowledge gap and create successful breastfeeding-targeted
127	interventions, further research is required. Hence, this study aimed to assess factors associated with
128	prelacteal feeding in PNG. The study's results could offer valuable insights for developing
129	innovative strategies to enhance infant and young child feeding and health in the country.

131 Methods

132 Data source and sampling

133 This study used a child dataset from the PNGDHS, a cross-sectional, two-stage cluster sampling 134 study representing the entire country from October 2016 to December 2018. The survey used the 135 census units (CU) list from the 2011 PNG National Population and Housing Census as the sampling 136 frame. Stratification of the sample was achieved by two categories: urban and rural areas, resulting 137 in 43 sampling strata, except for the National Capital District, which had no rural areas. Samples of 138 CUs were selected independently in each stratum in two stages. The first stage involved the 139 selection of 800 CUs, which was done through probability proportional to CU size. The second 140 stage involves the selection of 24 households from each cluster through probability random 141 sampling, resulting in a total sample size of approximately 19200 households. The selected sample 142 consisted of 17505 households. Of the 18175 women identified in the interview households, 15198 143 completed the interviews (84% response rate). The survey used three sets of validated 144 questionnaires to collect data: a household questionnaire, a woman's questionnaire, and a man's 145 questionnaire. The dataset used in this study included all the relevant information on child health 146 from all three questionnaires. Furthermore, the study population for this study was restricted to 147 mothers who had given birth in the last three years to enable comparability with the existing 148 literature and minimize recall bias [39]. Women who had never been pregnant were excluded from 149 the analysis. A total weighted sample of 4399 women with complete information about the 150 variables of interest was included in the final analysis. Details of methodology, sampling design, 151 pretesting, training of field workers, and household selection are in the final report [32].

153 **Study variables**

154 The outcome variable for this study was prelacteal feeding. Women were asked during the survey:

155 "In the first three days after birth, was (child's name) given anything to drink or eat other than

breast milk?" Their responses were coded as "1" for "yes" if the child was given anything other

157	than breast milk or "0" for "no" if prelacteal feeds were not given. Prelacteal feeding is described as
158	any food or liquid given before the onset of lactogenesis II, that is, the onset of copious breast milk
159	secretion occurring within four days of birth [40]. Infant feeding included plain water as the most
160	commonly reported, juices, powdered milk (non-breast milk), infant formula, fruits (papaya and
161	mango), meat products (eggs, chicken, lamb, and fish), vegetables and tubers (potatoes and
162	cassava), and others [32].
163 164	The independent variables were sociodemographic characteristics, which included maternal age,
165	marital status, education status, occupation, wealth index, region, and place of residence, and
166	frequency of mass media access, which included reading a newspaper or magazine, listening to the
167	radio, and watching television. Maternal health service use variables included the number of
168	antenatal visits in pregnancy, mode of birth, and place of birth. Child-related factors comprised the
169	child's birth order, perceived birth size, birth weight, initiation of breastfeeding, and newborn skin-
170	to-skin contact immediately after birth.

172 Statistical analysis

173 Analyses were limited to participants with complete data for the variables of interest using IBM 174 SPSS for Windows, Version 26.0 (IBM Corp., Armonk, NY, USA). The sample was weighted 175 using the primary sampling unit variable, stratification variable, and weight variable to restore its 176 representativeness and get a better estimate throughout the analysis. Descriptive statistics were used 177 to analyze the sociodemographic characteristics of participants, while inferential statistics were 178 employed for generalization to the entire population through bivariate and multivariate analysis. All 179 the variables, whether significant in the chi-square test or not were included in a multivariable 180 analysis to determine their collective associations with HIV testing. All the analyses were 181 performed using the Complex Sample Analysis procedure which was deemed necessary to adjust 182 for sample weight, and multi-stage

- sampling [41]. Adjusted odds ratios (AORs) with 95% confidence intervals (CIs) were reported. A
- 184 $p \leq 0.05$ was considered statistically significant.

186 Patient and public involvement

187 Patients and the public were not involved in the study.

188 **Results**

189 Characteristics of the participants

- 190 **Table 1** presents the characteristics of the participants. A total of 4399 women were included in the
- 191 study. The mean maternal age of the respondents was 28.9 years (SD = 6.9). About half (50.4%)
- 192 had completed primary education, and most were not working (69.8%). In terms of mass media
- 193 exposure, over two-thirds of women never read a newspaper or magazine (67.2%), listened to the
- radio (69.7%), or watched television (80.2%).

197 Maternal and child-related factors

Table 2 presents maternal and child-related factors. The majority of women had at least one

antenatal visit during their pregnancies (72.8%) and gave birth in a public health facility (59.6%).

200 Regarding child-related factors, over one-third of the infants (38.1%) had a birth order of four or

201 more. Most weighed \geq 2500 g at birth (82.7%) and also half (46.2%) were introduced immediately

- to newborn skin-to-skin contact after birth with their mothers. About a quarter (25.1%) delayed
- 203 initiation of breastfeeding for more than an hour of birth.

208 Prevalence of prelacteal feeding

209	Table 3 shows the proportion of the type of prelacteal feeds given to newborn infants in PNG. A
210	total of 433 [9.6% (95% CI: 9 to 11)] weighted proportion] women introduced prelacteal feeds to
211	their infants other than breastfeeding in the first three days after the birth. The most frequently
212	reported prelacteal feed was plain water (71.7%), followed by grains (eg, noodles) (47.1%), dark
213	green leafy vegetables (42.1%) and soup (39.7%).

216 Factors associated with prelacteal feeding in PNG

217	Table 4 shows factors associated with prelacteal feeding in PNG. In the bivariate analysis,
218	educational level, occupation, wealth index, frequency of mass media access (eg, newspaper, radio,
219	and television), region, place of residence, mode of birth, place of birth, and birth weight were all
220	statistically significantly associated with prelacteal feeding. Women with no formal (AOR 1.4; 95%
221	CI: 1.0 to 3.0) or primary education (AOR 1.5, 95% CI: 1.0 to 2.9), from the Islands region (AOR
222	2.3, 95% CI: 1.5 to 3.5), had a cesarean section (AOR 4.1, 95% CI: 2.4 to 7.2), and who had given
223	birth at home or in the village (AOR 3.8, 95% CI: 2.1 to 6.8) had higher odds of providing
224	prelacteal feeds. However, secondary education (AOR = $0.9, 95\%$ CI: 0.5 to 1.8), the Highlands
225	(AOR 0.9, 95% CI: 0.6 to 1.4) and the Momase region (AOR 0.6, 95% CI: 0.4 to 1.1) were
226	protective factors of prelacteal feeding. No statistically significant association was found between
227	immediate newborn skin-to-skin contact after birth and prelacteal feeding ($p = 0.772$).
