33 ABSTRACT

34 Background Adverse early life exposures might negatively affect foetal and infant development, 35 predisposing children to obesity. We aimed to systematically identify and evaluate risk factors for 36 childhood obesity in preconception, pregnancy, and infancy, and assess their potential as targets 37 for future prediction and prevention strategies.

Methods This systematic review (PROSPERO, CRD42022355152) included longitudinal studies from selected electronic databases published between inception and August 17th, 2022, identifying maternal, paternal, or infant risk factors from preconception until infancy for childhood obesity between 2 and 18 years. Screening and data extraction was performed through standardized extraction forms. We assessed risk factor quality on modifiability and predictive power using a piloted criteria template from ILSI-Europe-Marker-Validation-Initiative.

44 **Findings** We identified 172 observational and 5 intervention studies involving n=1.879.971 45 children from 37, predominantly high-income, countries. 59%, 25% and 16% of studies measured 46 childhood obesity between 2- <6 years, 6-10 years, and >10 -18 years respectively. Average 47 reported childhood obesity prevalence was 11.1%. Pregnancy and infancy risk factors were mostly 48 studied. We identified 59 potential risk factors, 24 of which were consistently associated with 49 childhood obesity risk. Higher maternal prepregnancy weight (n=28/31 positive associations from 50 31 studies, respectively), higher gestational weight gain (n=18/21), maternal smoking during 51 pregnancy (n=23/29), higher birth weight (n=20/28), LGA (n=17/18), no breastfeeding (n=20/31), 52 and higher infant weight gain (n=12/12) were the strongest risk factors, which may aid in 53 prediction or be targets for prevention. Level of evidence was generally moderate due to unreliable 54 exposure measurement, short follow-up/loss-to-follow up, and risk of confounding.

64 **INTRODUCTION**

65 Childhood obesity is a major public health challenge.¹ Childhood obesity rates have rapidly 66 increased over the past decades and continue to rise worldwide.² Childhood obesity is related to 67 increased risks of non-communicable diseases, including hypertension, diabetes, depression from 68 childhood onwards and premature mortality in adulthood, leads to a reduced quality of life and 69 large economic and societal burden .³⁻⁵

70 Accumulating evidence suggests that high susceptibility to obesity might already originate in 71 early life.^{6,7} The Development Origins of Health and Disease (DOHaD) hypothesis states that in 72 the early stages of human development, individuals are particularly vulnerable to an adverse 73 environment.^{8,9} During preconception, egg cell maturation and sperm production occur. After 74 conception, foetal life and early infancy are characterized by rapid cell division, organ 75 development, and rapid growth. These stages define the blueprint of later health and disease; thus, 76 adverse exposures during these critical developmental periods might predispose an individual to 77 an increased risk of obesity in later life. As the prevalence of childhood obesity continues to rise, 78 systematic identification of early-life risk factors for childhood obesity is urgently needed to enable 79 development of improved prevention strategies with better early prediction of childhood obesity 80 risk and potential novel modifiable targets for interventions at an individual and population level. 81 Therefore, we conducted a systematic review to first identify risk factors for childhood obesity 82 in the preconception period, pregnancy, and infancy, thereby covering the critical first 1000 days 83 of life. Second, we aimed to assess quality of potential crucial early-life risk factors for prediction 84 of childhood obesity risk and as potential modifiable targets for future prevention strategies.

85 METHODS

86 Systematic review protocol development

87 This study was part of a large collaborative effort to perform a systematic review of risk factors in 88 the first 1000 days of life for the development of various childhood cardiometabolic disorders. We 89 developed a systematic review protocol to comprehensively include and evaluate individual 90 research studies reporting on risk factors and noninvasive biomarkers during preconception, 91 pregnancy and infancy for the development of various child and adolescent cardiometabolic 92 disorders. For this study, we aimed to identify longitudinal observational or intervention studies 93 that focused on association studies or prediction studies for early risk factors for childhood obesity 94 between 2 and 18 years.

95 Risk factors and noninvasive biomarkers of interest, hereafter also referred to as "risk 96 factors," included sociodemographic factors, lifestyle factors, physical factors, environmental 97 factors, pregnancy-related factors, and noninvasive biomarkers. We were interested in risk factors 98 in mothers, fathers and offspring obtained during the crucial periods, preconception, pregnancy, 99 and infancy until 2 years, together covering the first 1000 days of life. The outcome of interest 98 was self-reported, physician or researcher-diagnosed obesity.

102 Data sources, search strategy, and screening criteria

We registered our search strategy and systematic review protocol to PROSPERO CRD42022355152. We developed search terms for Medline, EMBASE, Web of Science, SCOPUS and Cochrane CENTRAL (**Text S1**) for eligible citations published in English language through August 17th, 2022. We included prospective and retrospective longitudinal observational studies identifying factors of incident offspring outcomes of interest. We excluded cross-sectional

108 studies and studies among diseased populations only. We also included interventions prospectively 109 comparing treatment effects on the outcome. Exclusion criteria comprised studies with outcomes 110 before the age of 2 years, studies reporting only intermediate phenotypes or continuous traits, or 111 studies that only assessed endpoints outside of the cardiometabolic outcomes of interest. 2 112 independent reviewers screened at the title and abstract level. For accepted citations, 2 independent 113 reviewers screened the full manuscripts. Conflicts at all screening stages were resolved by a third 114 reviewer. Conflicts that were not resolved by the third reviewer were discussed in the full group. 115 All screenings were conducted in the Covidence online systematic review tracking platform.

117 Data extraction and synthesis of results

We developed and piloted a data extraction template for eligible manuscripts, which included manuscript information, study level details and design, population enrolment and characteristics, exposure and outcome ascertainment and diagnosis criteria, and age at offspring outcome assessment. We classified exposures in 8 broad categories: (i) parental lifestyle factors, (ii) parental physical factors, (iii) environmental factors, (iv) pregnancy-related factors,(v) birth anthropometrics,(vi) feeding patterns, (vii) infant anthropometrics, and (viii) cord blood biomarkers.

126 **Risk of bias assessment for quality and synthesis**

We assessed quality of each study using the Joanna Briggs Institute (JBI) critical appraisal tools for cohort studies, case-control studies, and randomized controlled trials (RCTs).¹⁰ For cohort and case-control studies, we assessed quality based on 11 and 9 items, respectively that evaluated population recruitment, exposure and outcome ascertainment, confounding, statistical

methodology and follow-up. For the RCTs, we evaluated 11 items that assessed selection and allocation, intervention, administration, outcome ascertainment, follow-up, and statistical analysis. JBI items were categorized as, 'Yes,' 'No,' 'Unclear,' or 'Not applicable' following established guidelines. Any uncertainty in assessment was further discussed by the full research team. Studies with overall scores of 50% or less on questions answered with 'Yes', 50% until 70% questions answered with 'Yes', and 70% or more questions answered with 'Yes', were considered low, moderate and high quality, respectively.

139 Quality assessment of risk factors for prediction and prevention

140 We took forward those risk factors we considered consistently associated with childhood obesity 141 for quality assessment. We defined a consistently associated risk factor as a risk factor for which 142 over 50% of studies reported an association in the same direction, in at least 2 studies of moderate 143 or high quality. We developed and piloted a criteria template for risk factor quality assessment based on the ILSI Europe Marker Validation Initiative (Table S1).¹¹ Early life risk factors were 144 145 scored on their methodological aspects, reflection of the study objective, prediction, and 146 modifiability. Risk factors were scored by 3 independent reviewers at 4 different levels based on 147 the criteria: very strong, strong, medium, and low. Conflicts were discussed in the full group until 148 consensus was reached. Risk factors, which scored strong or very strong on prediction (65% of 149 studies reported an association in the same direction in at least five moderate or high quality 150 studies; >80% of studies reported an association in the same direction in at least five moderate or 151 high quality studies, respectively) and strong or very strong on modifiability were considered to 152 be most the most useful risk factors for prediction and prevention strategies. Modifiability was 153 based on two components: theoretically modifiable and findings from intervention studies. If a risk

factor scored strong or very strong on theoretically modifiable (risk factor is modifiable on individual level and implementation of modifications in daily life is complicated or easy, respectively) and low on intervention studies (No intervention studies have been conducted, or no potential effect of modification has been found), it was considered strong. Very strong on modifiability was considered if a risk factor scored strong or very strong on theoretically modifiable scored and at least medium on intervention studies (There is some evidence of potential effect of intervention on the outcome, but literature is controversial, or higher respectively).

161 **RESULTS**

162 Study selection and participant characteristics

Figure 1 shows 35584 publications were identified for screening through searches of selected electronic databases. After removing 17974 duplicates, 17610 publications were subjected to title and abstract screening by 2 independent reviewers. 16059 publications were found to be irrelevant, and 1551 publications underwent full text screening. 177 studies met the inclusion criteria and were included in this review.

- 168 165 were observational studies, 7 were case-control studies and 5 were intervention studies 169 (**Table 1**). Studies were performed between 1970 and 2022. Sample sizes varied from 50 to 155411 170 participants, leading to 1879971 children included in the final study sample. 59% of studies 171 measured childhood obesity between 2 to 6 years, 25% between 6 to 10 years, and 16% between 172 10 and 18 years. **Figure 2A** shows that studies included data from 37 different countries, 173 predominantly high-income countries. The average reported prevalence of obesity was 11·1%, 174 which ranged from 0·9% in Peru to 19·6% in Finland (**Figure 2B**).

176 Risk factors for childhood obesity in preconception

We identified 34 observational studies and no RCTs that assessed 6 risk factors associated with childhood obesity in the preconception period ((**Figure 3A₁&3B₁, Table S2**). Maternal physical factors were most frequently studied. 19 observational studies reported that higher maternal preconception weight was associated with an increased risk of childhood obesity, whereas 3 observational studies¹¹⁻¹³ found no association. Samples sizes varied from 205 to 5156. All identified studies showed that maternal prepregnancy overweight or obesity was associated with a higher risk of childhood obesity. Only 1 study¹⁴ reported paternal overweight or obesity as risk

factor for childhood obesity. 4 observational studies¹⁵⁻¹⁸ focused on the associations of maternal lifestyle factors during preconception with childhood obesity risk. 2 observational studies^{15,16} showed that maternal smoking in the preconception period was associated with an increased risk of childhood obesity, whereas no associations with the risk of childhood obesity were reported for maternal preconception diet^{15,17} or physical activity^{15,18}.

190 Risk factors for childhood obesity during pregnancy

We identified 135 observational studies and 2 RCTs that assessed 46 different risk factors during pregnancy (**Figure 3A₂&3B₂, Table S2**). Most frequently studied characteristics were birth characteristics and parental lifestyle factors. Most risk factors were assessed in mother and child. Only 4 studies reported paternal data^{13,19-21}.

195 The most commonly reported risk factor was birthweight, assessed continuously, with 20^{12,14,19,22-38} of 28 observational studies reporting that a higher birthweight was associated with a 196 higher risk for childhood obesity, and 17^{20,39-54} of 18 observational studies identifying large for 197 198 gestational age (LGA) as a risk factor for childhood obesity. For small for gestational age (SGA) at birth, findings were less consistent. 4 observational studies^{31,55-57} identified SGA as a risk for 199 childhood obesity, however, eight observational studies^{11,39,49,52,53,58-60} reported that SGA was 200 201 associated with a lower risk of childhood obesity. Most observational studies assessing gestational age^{12,29,61-63} at birth and or pre- and late-term birth^{26,64-66} reported no evidence for higher risk for 202 203 childhood obesity. 29 observational studies focused on parental physical factors. The majority 204 investigated the association of (excessive) maternal gestational weight gain with childhood obesity, 14^{26,37,51,60,61,66-74} of 16 observational studies reported an increased risk of childhood 205 206 obesity associated with higher gestational weight gain.

207 Most studies on pregnancy complications have focused on mode of delivery and gestational diabetes. Within 14^{51,52,61,75-85} out of 22 studied populations, caesarean section (CS) was identified 208 as a risk factor for increased childhood obesity. 7 observational studies^{11,38,66,77,86-88} and 1 RCT⁸⁹ 209 210 reported no association between CS and childhood obesity. Gestational diabetes was identified as risk factor for childhood obesity in 12 out of 21 observational studies^{49,61,78,90-98}. 211 25^{11,14,16,26,29,32,36,51,52,66,78,99-112} out of 31 observational studies showed that maternal smoking 212 213 during pregnancy was associated with a higher risk for childhood obesity. 10 observational studies^{23,107,108,111,113-118} and 1 RCT¹¹⁹ on maternal diet during pregnancy reached no consensus on 214 215 the association with childhood obesity, partly because of the diversity of diets investigated. No 216 consistent evidence was found for maternal age, socioeconomic status, ethnicity, parity, 217 employment, relationship status, maternal or paternal education, and paternal age as risk factors for childhood obesity. Lower household income^{13,52,120} was reported within 3 out of 4 studies as 218 219 risk factor for obesity in childhood.

Only 3 publications^{114,121,122} explored different cord blood biomarkers in relation to childhood obesity. Risk factors were fatty acids¹¹⁴, leptin and adiponectin¹²¹ and differences in metabolomics¹²², and no consensus on associations with childhood obesity was reached.

224 Risk factors for childhood obesity during infancy

We identified 76 observational studies and 3 RCTs that assessed 7 different exposures during infancy (**Figure 3A₃&3B₃**). The most frequently studied characteristic was feeding pattern. All risk factors were assessed in the child. $20^{11,32,36,39,54,60,66,70,78,123-133}$ out of 30 observational studies on breastfeeding reported that a breastfed child had lower risks of obesity as compared to a nonbreastfeed child. Furthermore, 15 observational studies^{13,26,63,99,102,124,131,134-141} reported that longer

breastfeeding duration was associated with less childhood obesity, however 2 RCTs^{142,143} and 13 observational studies^{12,23,33,62,104,129,132,144-149} did not report an effect of the duration of breastfeeding on childhood obesity. All 16 observational studies^{12,29,45,51,52,58-60,65,150-156} focusing on body mass index (BMI) or weight gain during infancy reported that higher BMI or weight gain was associated with a higher risk of childhood obesity.

236 Risk of bias assessment for quality and synthesis

Level of evidence was generally scored as moderate quality, mainly due suboptimal assessment of the exposure or outcome, inadequate blinding of participants and researchers in RCTs, high risk of residual confounding, short duration of follow-up, and high loss-to-follow up (**Figure 4**). 6% of included studies was of low quality, consisting of 1 RCT and 10 cohort studies. **Supplemental figures 1A-C-- 3A-D** show the detailed bias assessments for all included studies based on the JBI checklist.

244 Quality assessment of risk factors for prediction and prevention

245 In total, we identified 24 risk factors consistently associated with childhood obesity, which 246 included: maternal prepregnancy/pregnancy weight/overweight/obesity (hereafter maternal 247 prepregnancy and pregnancy weight status), prepregnancy/pregnancy smoking, caesarean section, 248 gestational diabetes, antibiotic use, education, household income, sleep duration, gestational 249 weight gain/excessive gestational weight gain (hereafter maternal gestational weight gain), 250 environmental chemical exposure, paternal prepregnancy/pregnancy weight/overweight/obesity, 251 continuous foetal growth, birthweight/high birthweight/LGA, breastfeeding/duration of 252 breastfeeding, milk formula content, infant BMI/weight/and BMI/weight gain.

We evaluated these risk factors for their potential for prediction and prevention strategies (Figure S4). In preconception, only maternal weight status scored very strong on its predictability and strong on modifiability. In pregnancy, maternal smoking, weight status, gestational weight gain, and birthweight/LGA scored strong or higher on prediction and modifiability. In infancy, only breastfeeding and infant BMI/weight change scored strong or very strong for their potential as predictor and to be modifiable on individual level.

259 **DISCUSSION**

260 In this systematic review, we identified 172 observational and 5 intervention studies from 37 261 countries that studied risk factors for childhood obesity in the first 1000 days of life. Most studies 262 were performed in high-income countries and focused on identification of risk factors in 263 pregnancy. 24 risk factors were consistently associated with the risk of childhood obesity. Higher 264 maternal prepregnancy weight, higher gestational weight gain, maternal smoking during 265 pregnancy, higher birthweight, LGA, no breastfeeding, and higher infant weight gain were the 266 strongest risk factors for childhood obesity and need to be considered in future prediction or 267 prevention strategies. Overall level of evidence was generally moderate due to unreliable 268 measurements of exposures, short follow-up duration and loss to follow-up, and risk of residual 269 confounding.

270 This current review provides the most comprehensive, systematic, up-to-date information 271 on family-based risk factors for childhood obesity from preconception until infancy, thereby covering the full first 1000 days of life.¹⁵⁷ Due to the large heterogeneity between studies, we 272 273 could not perform meta-analyses. Despite increasing awareness on the importance of the 274 preconception period for offspring health, only a remarkable low number of studies focused on 275 risk factors in this potential critical period. Maternal prepregnancy weight status was consistently 276 associated with childhood obesity, but no consistent effects were found for other maternal lifestyle 277 factors. The transgenerational effects of increased maternal prepregnancy weight on childhood 278 obesity risk poses a major public health concern, as obesity often progresses into adulthood, 279 subsequently causing increased risks for the next generation.² Only 1 publication focused on 280 paternal factors and reported that higher paternal prepregnancy BMI was associated with a higher 281 childhood obesity risk. Adverse paternal sociodemographic and lifestyle factors have already been

shown to be associated with adverse pregnancy outcomes.¹⁵⁸ Animal studies have shown that these
paternal factors also increase the risk of childhood obesity, with the strongest effects for paternal
obesity, but also for paternal hyperglycaemia and paternal smoking.¹⁵⁹

285 As expected, pregnancy was the most studied period for risk factors for childhood obesity. 286 Most studies focused on maternal and foetal risk factors. Suboptimal maternal gestational weight 287 status and gestational weight gain were consistently associated with the risk of childhood obesity. 288 Gestational diabetes and gestational hypertensive disorders tended to be associated with a higher 289 risk of childhood obesity, but this was not consistent in moderate to high quality studies. Indeed, 290 a previous individual-participant-data meta-analysis among 160757 mother-offspring pairs from 291 European and North-American birth cohorts, also reported that no effect of gestational diabetes or 292 gestational hypertensive disorders was present on childhood obesity after adjustment for maternal prepregnancy BMI.¹⁶⁰ A higher birthweight and LGA were strong risk factors for childhood 293 294 obesity, whereas associations for SGA and preterm birth were inconclusive. Children born SGA 295 may be constitutionally small or have suffered from intra-uterine foetal growth restriction. 296 Differences in this pathophysiology may partly explain these inconsistent findings.¹⁶¹ A lower 297 household income and lower maternal and paternal education level tended to be associated with a 298 higher risk of childhood obesity, but only inconsistent in less than 5 studies of at least moderate 299 quality. As these findings are less consistent, generalizability is more difficult. Possibly, these 300 effects are more country-specific and influenced by community and social support practices per 301 region. Several moderate and high quality studies reported an association between CS and a higher 302 risk for childhood obesity. All were observational studies, and the only included RCT did not 303 support that association, suggesting that residual confounding may play a role in these observed 304 associations. Maternal antibiotics during pregnancy was associated with childhood obesity in 50%

of studies, but the number of studies was low, and associations were only found in females¹⁶², or not in all investigated age groups^{163,164}, so no generalized conclusion can be drawn. No consistent associations were present for maternal or paternal age, ethnicity or parity.

308 In infancy, infant weight gain and feeding patterns were mostly studied with regards to the 309 development of childhood obesity. Strongest associations were present for higher infant weight or 310 BMI gain with higher risks of obesity. The infant period reflects the greatest proportional weight 311 gain in postnatal life and might be a critical period for development of energy balance mechanisms. 312 Early exposure to excess and dysfunctional fat mass might trigger the development of metabolic changes in childhood.¹⁶⁵ Additionally, early weight gain may reflect the beginning influence of a 313 genetic predisposition to overweight.¹⁶⁶ Being breast-fed and a longer duration of breastfeeding 314 315 were associated with lower risks of childhood obesity within the majority of reported observational studies. The only two intervention studies^{142,143}, did not identify a significant association between 316 317 the duration of breastfeeding and childhood obesity. Causality between the protective role of 318 breastfeeding on development of childhood obesity can therefore not be properly determined based 319 on these findings. It is remarkable that we identified no studies on the role of different components of breastmilk and only 3 studies on differences in infant formula composition.^{125,137,167} 320

Our findings are important from an etiological perspective and provide novels insights to improve prediction and prevention strategies from the start of life onwards. Improved risk selection from early-life onwards is crucial to enable more targeted delivery of prevention strategies. Prevention strategies focused on improving these identified early-life risk factors from a clinical and population perspective is needed targeting those families at higher risk of offspring obesity, preferable integrated with implementation studies to evaluate risk selection, intervention effects

and optimize delivery methods. The first 1000 days of life offer an are unique opportunity for
 prevention, because of parental motivation and contact with the health care system.^{168,169}

329 Our systematic review also identified major areas for further research. First, studies were 330 conducted in mainly high-income, countries. To increase global generalizability, more studies 331 should be performed in low- and middle income countries, in which the rise of childhood obesity 332 is most rapidly increasing and prevalence of identified risk factors may vary as compared to higher 333 income countries.² Second, we only identified few studies in preconception and infancy, whereas 334 both periods are increasingly recognized as critical periods for childhood obesity development.¹⁷⁰ 335 Additionally, limited number of studies focused on paternal factors, environmental factors, 336 metabolomics, and genetic factors. Evidence is increasing on the role of environmental exposures 337 in human health, and investigation of their role in development of childhood obesity is warranted, 338 as they are ubiquitous and represent an opportunity for governmental and political intervention. 339 The field of omics is expanding rapidly, and further insight in the value of metabolomics and 340 genomics for prediction of childhood obesity is of interest. Third, our findings are mainly based 341 on observational studies, and causality cannot be established from observational evidence.¹⁷¹ 342 Quality assessment showed many studies were at risk of residual confounding. We identified only 343 5 intervention studies, which included childhood obesity as outcome. 1 RCT investigated the role 344 of maternal low glycaemic index diet during pregnancy¹¹⁹, 2 RCT's investigated the duration of breastfeeding^{142,143} and 1 RCT investigated the difference between infant formula with high 345 protein and low protein¹⁶⁷. Especially in pregnancy, maternal lifestyle interventions have been 346 347 conducted in RCTs, but these studies often did not include childhood obesity as a primary or 348 secondary outcome and suffered from high attrition. Our systematic review underlines the urgent 349 importance of well-designed intervention studies targeting parental lifestyle from preconception

onwards with longer follow-up of the offspring and inclusion of clinical cardiometabolicoutcomes.

353 CONCLUSION

We showed that 24 risk factors in early life are consistently associated with a higher risk of childhood obesity. Higher maternal prepregnancy weight and gestational weight gain, maternal smoking during pregnancy, higher birthweight and large-size-for-gestational-age-at-birth, no breastfeeding, and higher infant weight gain are most strongly related to childhood obesity risk. These findings are relevant for early life risk prediction and insight into the strongest potential modifiable factors from a clinical, governmental, and industrial perspective.







Figure 2. World map of the included studies

B. Reported childhood obesity prevalence per country






Figure 3A. Number of positive, negative, and null associations for each identified exposure in all included publications

3A₃. Infancy





Figure 3B. Number of positive, negative, and null associations for each identified exposure within only moderate to high quality publications










Figure 4. Risk for bias in different domains*
