35 ABSTRACT

36	BACKGROUND: Intracerebral hemorrhage (ICH) has a high mortality rate, and even if
37	patients survive, they are likely to have severe disability. Body mass index (BMI) is
38	associated with ICH risk, and extremely low and high BMIs are associated with the site of
39	ICH, which affects functional decline. However, few reports exist on ICH-related functional
40	decline and BMI. This study aimed to clarify the relationship between BMI and stroke-related
41	disability of patients with ICH.
42	METHODS: Patients with ICH registered in the Japanese Registry Of All Cardiac and
43	Vascular Diseases Diagnosis Procedure Combination (JROAD-DPC) database from April
44	2016 to March 2020 were included. BMI was defined according to the World Health
45	Organization Asia-Pacific classification. Functional disability was assessed using the
46	modified Rankin Scale (mRS). ICH-related functional decline was defined as an increase in
47	mRS score at discharge compared with that of the pre-stroke assessment.
48	RESULTS: This study included 155,211 patients with ICH whose median age was 72.0 years
49	and mean BMI was 22.3 kg/m ² . The ratio of patients with ICH who experience functional
50	decline was 74.9%. The spline curve between BMI and ICH-related functional decline was
51	U-shaped, revealing that the Normal to Obese I BMI groups (BMI: $22.2-30.4 \text{ kg/m}^2$)
52	exhibited reduced odds ratios for ICH-related functional decline. Hospitalization cost and
53	BMI showed similar U-shaped patterns, with a BMI of 25.0 kg/m ² as the lowest point,

54	regardless	of age	group.

55	CONCLUSION	: In patients with ICH, those with both extremely low and high BMIs were				
56	more likely to experience functional decline after ICH onset, which resulted in increased					
57	hospitalization c	osts. To reduce ICH-related functional decline, patients should be managed at				
58	a normal to sligh	tly obese BMI.

74 INTRODUCTION

75 Epidemiology of Intracerebral Hemorrhage

76 Stroke is the second leading cause of death worldwide, with 12 million strokes and 101 million prevalent cases in 2019.¹ Over the past 30 years, the numbers of onsets of stroke, 77 deaths, and prevalent cases have increased around the world,¹ making the investigation of 78 effective strategies against stroke an important issue. Intracerebral hemorrhage (ICH) is the 79 second most common form of stroke (27.9%).² The mortality rate for ICH is higher than that 80 for ischemic stroke, and even if patients survive, they are more likely to have severe 81 disability.² In fact, only 35% of patients with ICH had a favorable physical outcome at 30 82 days after onset,³ and only 41% of patients who experienced ICH were independent in 83 activities of daily living (ADL) at one year after ICH onset.⁴ Disability-adjusted life-years 84 due to stroke are also increasing.¹ Improvement of stroke-related disability and reintegration 85 into society after ICH are also important issues. 86 87

88 Relationship Between ICH and Body Mass Index

Body mass index (BMI) has been associated with ICH risk.^{5,6} In general, obesity causes
increased mortality or morbidity of cardiovascular disease in patients with ischemic stroke
and ICH.^{7–9 10} However, several reports have shown that the obesity paradox leads to lower
mortality in overweight and obese patients with ICH.^{8,11,12} Whether obesity is advantageous

93 for patients with ICH remains controversial.

94	The American Heart Association supposed the ideal BMI to be $<25 \text{ kg/m}^2$. ¹⁰ However,
95	there are regional differences in BMI, and the Asian population tends to have a lower
96	BMI. ^{13,14} In Japanese people, a BMI of about 22 kg/m ² is associated with the lowest
97	incidence of obesity-related diseases, and the Japan Society for the Study of Obesity defined
98	the standard weight for Japanese people as weight equivalent to a BMI of 22 kg/m ^{2} . ¹⁵
99	Extremely low BMI ($<18.5 \text{ kg/m}^2$) and high BMI ($>30.0 \text{ kg/m}^2$) are associated with the site
100	of ICH. ^{16,17} Symptoms and degree of functional impairment vary depending on the site of
101	hemorrhage. ^{18,19} It remains unclear what range of BMI results in the fewest stroke-related
102	symptoms in Japanese patients with ICH.

104 **Objective**

In patients with ischemic stroke, BMI has been reported to be associated with stroke-related disability,⁸ and although ICH is more likely to cause severe disability,² the relationship between BMI and stroke-related disability of patients with ICH is poorly documented and unclear. In the present study, we hypothesized that patients with higher BMI would likely experience functional decline after ICH. The study aim was thus to clarify the relationship between BMI and functional decline in Japanese patients with ICH. As a secondary outcome, we also examined the relationship between BMI and hospitalization costs in patients with

115 **METHODS**

116 Study Design

117	This was a retrospective cohort study based on the Japanese Registry Of All Cardiac
118	and Vascular Diseases Diagnosis Procedure Combination (JROAD-DPC) database. The
119	JROAD-DPC database targets data on cardiovascular or cerebrovascular disease patients
120	treated in facilities affiliated with the Japanese Circulation Society. ²⁰ The JROAD-DPC
121	database contains the following data: unique hospital identifier, patient age, sex, primary
122	diagnoses, comorbidities, drugs, devices, diagnostic and therapeutic procedures, length of
123	stay, and discharge status. The International Statistical Classification of Diseases and Related
124	Health Problems 10th Revision (ICD-10) was used for primary diagnosis and comorbidity in
125	the JROAD-DPC database. ²⁰ The study was carried out in accordance with the Declaration of
126	Helsinki ²¹ and was approved by the Kobe University Institutional Review Board (Approval
127	No. B210052).
128	The inclusion criterion was hospitalization for ICH from April 2016 to March 2020.

- 129 Exclusion criteria were (1) age <20 years old, (2) length of hospital stay <3 days, (3) no
- 130 emergency admission, (4) hospitals with <10 beds, (5) hospital death, and (6) no brain

131	rehabilitation during hospitalization. The ICD-10 divided ICH into six groups: subcortical
132	(I610), cortex (I611), brainstem (I613), cerebellum (I614), intraventricular (I615), and other
133	types.
134	
135	Variables
136	We collected data on the following variables: age, sex, hospital code, hospital scale,
137	hospitalization days, hospitalization cost, disposition, comorbidities (hypertension, diabetes
138	mellitus, dyslipidemia, congestive heart failure, stroke, Charlson Comorbidity Index score), ²²
139	smoking, treatment (drainage, evacuation, shunt), complications (pneumonia, urinary tract
140	infection [UTI], bedsores), level of ADL at admission and discharge, and pre-stroke modified
141	Rankin Scale (mRS) score and mRS score at discharge. The drainage, evacuation, and shunt
142	treatment data were collected using the billing codes in reception data. ADL were assessed
143	with the Barthel index, ²³ which was done immediately after admission. We defined hospital
144	scale as small: <100, medium: 100–500, and large: >500 beds. Hospitalization costs were
145	converted into US dollars based on the exchange rate on January 10, 2024 (one US\$=145
146	Japanese yen).
147	
148	BMI and Classification

149 BMI was calculated by dividing body weight by the square of the height (kg/m^2) .

150	According to the World Health Organization (WHO) Asia-Pacific classification, ¹³ we divided
151	participants into five BMI groups at admission, as follows: Underweight (BMI \leq 18.5 kg/m ²),
152	Normal (18.5 kg/m ² < BMI \leq 23 kg/m ²), Overweight (23 kg/m ² < BMI \leq 25 kg/m ²), Obese I
153	(25 kg/m ² < BMI \leq 30 kg/m ²), and Obese II (30 kg/m ² \leq BMI).
154	
155	Modified Rankin Scale
156	The primary outcome was ICH-related functional decline. ²⁴ The mRS is the most frequently
157	used assessment tool for stroke-related disability ^{25,26} as a measure of outcome in stroke
158	studies. ²⁷ The mRS score ranges from 0 (no symptoms at all) to 6 (dead), with a higher score
159	indicating increased disability. In the JROAD-DPC database, pre-stroke mRS was assessed
160	for stroke-related disability before the onset of stroke, ^{28,29} and the mRS was used again for
161	patient assessment just before discharge. If the mRS score at discharge was higher than the
162	pre-stroke mRS score, we regarded this as indicative of ICH-related functional decline.
163	
164	Statistical Methods
165	Statistical analysis was conducted using the software R version 4.3.2. ³⁰ Continuous variables
166	are expressed as median [interquartile range] and categorical variables as number (%).
167	Initially, a comparative analysis between the BMI groups by Asia WHO classification was
168	conducted with ANOVA for continuous variables and by chi-square test or Fisher's exact test

169	for categorical variables and included missing values for several variables. Next, multiple
170	mixed-effect logistic regression analysis was conducted for ICH-related functional decline as
171	the dependent variable with the hospital code as a random intercept. Independent variables in
172	the developed model were as follows: age, sex, BMI, hospital scale, smoking, ICH type,
173	hypertension, diabetes mellitus, dyslipidemia, congestive heart failure, stroke, treatment
174	(drainage, evacuation, shunt), complication (pneumonia, UTI, bedsores), and pre-stroke mRS
175	score. We excluded missing values of the model variables and a pre-stroke mRS score of 5 as
176	a further increase in mRS score to 6 would mean hospital death. The odds ratio (OR) of the
177	outcome referenced normal BMI, large hospital scale, subcortical ICH, and pre-stroke mRS
178	score=0. Finally, we created restricted cubic spline models based on the logistic regression
179	analysis results for ICH-related functional decline. The spline models involved explanatory
180	variables of the model. In addition, spline models were also created with hospitalization costs
181	as the objective variable for patient ages 75 or over and under 75 years. The explanatory
182	variables were based on the model.

184	
185	RESULTS

186 **Overall Trends**

187 There were 222,318 patients with ICH admitted to the affiliated hospitals from April 2016 to

188	March 2020.	Among these	patients, 6	57.107	who met th	ne exclusion	criteria as	s shown in	Figure

189	1 were excluded. Thus, the final analysis included 155,211 patients with ICH.
190	Overall, the median age was 72.0 [61.0, 81.0] years old, the female ratio was 44.8%,
191	and the mean BMI was 22.3 [19.8, 25.1] kg/m ² . Among the BMI groups, Normal comprised
192	the greatest ratio of patients (38.1%), followed by Obese I (17.5%), Overweight (15.9%),
193	Underweight (13.2%), and Obese II (5.3%). The ICH types included subcortical (78.1%),
194	cortex (1.2%), brainstem (5.7%), cerebellum (8.6%), and intraventricular (2.4%). ICH-related
195	functional decline occurred in 74.9% of the patients with ICH. The percentage of patients
196	with a pre-stroke mRS of 0 was the highest at 56.5%, and that of patients with a mRS of 4 at
197	discharge was highest at 32.4%. The median number of hospitalization days was 26.0 [17.0,
198	39.0], and hospitalization costs were \$8800 [\$5879, \$13,929] (Table 1).
199	

200 Comparison by BMI

Lower BMI was associated with higher age and female ratio. In addition, patients with lower BMI had a longer number of hospitalization days, higher hospitalization costs, and a lower rate of home discharge. Among ICH types, subcortical ICH remained the most common in all BMI groups, and brainstem ICH was more common in patients with a higher BMI. Coronary risk factors such as hypertension, diabetes mellitus, dyslipidemia, and smoking were more prevalent at a higher BMI, whereas complications such as pneumonia, UTI, and bedsores

207	occurred more frequently in patients with a lower BMI. A pre-stroke mRS score of 0 was the
208	most common in each BMI group (42.1–70.8%). The rates of ICH-related functional decline
209	for each BMI group were Underweight (70.4%), Normal (73.8%), Overweight (75.0%),
210	Obese I (75.8%), and Obese II (76.3%). Patients with lower BMI had a higher percentage of
211	mRS score of 5 (e.g., Underweight: 31.0%, Obese II: 13.6%) at discharge.
212	
213	Odds Ratio of ICH-Related Functional Decline
214	The multiple mixed-effects logistic regression analysis was conducted on patients with
215	complete data (n=115,179). The analysis revealed that the OR of ICH-related functional
216	decline was lower in the Overweight and Obese I groups and higher in the Underweight and
217	Obese II groups, with the Normal group as a reference (Table 2). The OR of ICH-related
218	functional decline was lowest in the Overweight group (OR: 0.90, 95% CI: 0.85-0.94). ICH-
219	related functional decline was likely to be observed in patients with subcortical ICH, some
220	treatments (drainage, evacuation, shunt), and complications (pneumonia, UTI, bedsores). The
221	adjusted R ² value of this multiple regression model was 0.48. The spline curve for BMI and
222	the OR of ICH-related functional decline was U-shaped, with BMI 25.4 kg/m^2 as the lowest
223	point (Figure 2). The range of BMI of 22.2–30.4 kg/m ² had an OR of <1 for ICH-related
224	functional decline. Outside of this BMI range, the OR for a declining mRS tended to increase
225	in patients with a lower BMI (Underweight).

227 Hospitalization Costs

228	The spline curves for	or BMI and hos	pitalization costs revealed	that individuals aged 75	years or

- older incurred higher hospitalization costs than the overall median of \$8,801. The curves
- exhibited U-shapes for both age groups of patients: those 75 years or older and those under
- 231 75 years. Notably, both curves reached their lowest points at a BMI of 25.0 kg/m² (Figure 3).

234 **DISCUSSION**

235 Key Results

236	The present study included 155,211 patients with ICH. The distribution of ICH types was as
237	follows: subcortical (78.1%), cortex (1.2%), brainstem (5.7%), cerebellum (8.6%), and
238	intraventricular (2.4%). ICH-related functional decline occurred in 74.9% of the patients with
239	ICH. Multiple mixed-effects logistic regression analysis revealed that the OR of ICH-related
240	functional decline was lower in the Overweight and Obese I groups. The spline curve for the
241	OR of ICH-related functional decline exhibited a U-shape, with a BMI of 25.4 kg/m^2 as the
242	lowest point. The BMI range of 22.2–30.4 kg/m ² had an OR of <1 for ICH-related functional
243	decline. These results differed from our hypothesis that patients with a higher BMI would
244	experience ICH-related functional decline. Additionally, the spline curve for hospitalization

245	costs displayed U-shapes with BMI 25.0 kg/m ² at the lowest point for both age groups of 75
246	years or over and under 75 years.

248 Generalizability

249	Compared to a Japanese DPC study that did not include data from the JROAD-DPC database,
250	the distribution of BMI followed a trend similar to that observed in the present study. ³¹ We
251	also confirmed that patients in the higher BMI group tended to be younger, more were male,
252	had a higher smoking prevalence, and were more likely to have hypertension and diabetes
253	mellitus. ³¹ Despite the low home discharge rate of 26.9% in the present study, a nationwide
254	U.S. database study of inpatients with ICH similarly reported a home discharge rate of
255	approximately 20%. ³² Therefore, when considering patients with ICH, their characteristics do
256	not differ significantly from those observed in other database studies. ^{31,32}
257	Compared to the Japan Stroke Data Bank report (n=9,741), the present study enrolled
258	more patients with ICH (n=155,211), ³³ and although the age of patients in the present study
259	was slightly older, the ratio of woman was not significantly different. Lobar ICH, such as
260	subcortical ICH, was greater than that in previous studies, and a similar trend of patients with
261	higher BMI being likely to have more lobar ICH was also observed. As in the previous
262	study, ³³ the mRS at discharge was higher in the present study groups with extremely low and
263	high BMI. The present study supported the findings of these previous studies, with the

additional finding that BMI was associated with ICH-related functional decline in a larger
number of ICH cases.

266	In the present study, a pre-stroke mRS score of 0 was the most common (56.5%), which
267	aligns with a generally similar trend observed in a previous study showing that pre-stroke
268	mRS score of 0 accounted for 51% of the total. ³⁴ The pre-stroke mRS score serves as a
269	valuable tool for clinicians in treatment planning and delivery. ³⁴ At discharge, an mRS score
270	of 4 (moderately severe disability) was the most common. Another study also reported the
271	same score as being the most frequent mRS score at discharge, except for the mRS score of 6
272	(death). Over the one-year follow-up period, 34% of all patients showed functional
273	improvement and shifted to mRS scores of 0-3.35 While many patients with ICH experience
274	significant improvement, often from very severe disability, during the first three months,
275	functional progress across the disability spectrum occurs from 3 to 6 months after the onset. ³⁵
276	The mean length of hospitalization in the present study was 26.0 days, with limited follow-up
277	carried out after the onset of ICH. Although post-discharge follow-up data were unavailable
278	in this study, continuing rehabilitation and other interventions to enhance function after
279	discharge remain crucial.
280

281 Interpretation

282 The present study revealed that individuals with a slightly higher BMI (ranging from 22.2 to

283	30.4 kg/m ²) had a lower OR for functional decline in the patients with ICH, similar to the
284	concept of the obesity paradox observed in mortality studies. ³⁶ In stroke patients, stress-
285	related neuroendocrine and autonomic activation, inflammatory cytokines, increased oxygen-
286	free radical load, and systemic hormonal changes collectively contribute to an overall
287	catabolic state. ³⁷ Obese patients may be better equipped to tolerate such nutritional
288	disturbances due to greater fat and muscle mass metabolic reserve. ¹² Additionally, another
289	potential mechanism underlying the obesity paradox is resistance to unintended weight loss
290	after ICH. ¹² Patients with ICH are more susceptible to long-term weight loss compared to
291	patients with ischemic stroke. ³⁸ Conversely, low BMI negatively impacts the resumption of
292	oral intake in stroke patients. ICH patients with low BMI may experience insufficient nutrient
293	intake, leading to further weight loss and hypercatabolism. ³⁹ We speculate that with their
294	greater metabolic reserve, overweight to obese patients may possess a physiological
295	advantage against functional decline as indicated by the mRS.
296	Intraventricular ICH is more likely to result in functional disability after discharge.
297	Conversely, subcortical and cerebellar ICH have exhibited an OR of 0.26 for disability. ^{3,4}
298	Therefore, the impact of different ICH sites on functional impairment is significant. ICH can
299	be categorized into lobar ICH (isolated to the cortex) and deep ICH (such as in the
300	brainstem). Extreme low or high BMI has been associated with an increased risk of deep
301	ICH. ^{16,17} In our study, cerebellar hemorrhage was more common in the Normal and

302	Overweight groups, and the OR for ICH-related functional decline was lower in these groups.
303	Conversely, the other BMI groups were associated with deeper ICH, including
304	intraventricular and brainstem hemorrhages. Therefore, depending on the BMI at onset,
305	trends may emerge regarding the site of ICH and the degree of functional disability. The BMI
306	of patients should be managed to ensure that they maintain a BMI within the Normal to
307	Obese I WHO categories and not those of the Underweight or Obese II categories
308	The overall median cost of hospitalization of ICH patients in this study was \$8,800,
309	which aligns with findings from a previous Japanese study reporting \$8,301.40 The spline
310	curves indicate that hospitalization costs were \$500 to \$2,000 higher for individuals aged 75
311	or over than for those under 75 years, regardless of BMI. Additionally, the spline curve
312	exhibits a U-shape, similar to that for ICH-related functional decline, suggesting that
313	preventing functional decline in patients with ICH may lead to reduced hospitalization costs.
314	
315	Strengths and Limitations
316	The strength of the present study lies in it being the first, to our knowledge, to examine the
317	transition of functional decline before and after the onset of ICH with a focus on BMI. The
318	spline curves revealed that the Normal to Obese I groups at admission were associated with
319	favorable outcomes regarding functional decline and hospitalization costs. However, the
320	present study also has several limitations. First, the JROAD-DPC database includes only

321	facilities participating in the Japan Circulation Society (JCS). The number of facilities
322	treating cerebrovascular disease that have joined the JCS is less than that of the facilities for
323	treating heart disease. Thus, whether the present study reflects the real world in Japan
324	requires consideration. Second, ICH and comorbidities were evaluated using the ICD-10,
325	which may have latent selection bias. In addition, we could not consider the presence of ICH
326	histories nor the amount and extent of hemorrhage in ICH, which affects the prognosis. Third,
327	rehabilitation is a major part of patient care, and its intervention significantly impacts
328	functional transition after the onset of stroke. ⁴¹ Therefore, consideration should be given to
329	the fact that the present study was limited to only those patients who underwent
330	rehabilitation, which could affect the primary outcome. Finally, stroke-related disability was
331	assessed by the mRS. However, the mRS has been criticized for its poor reproducibility, score
332	grades that are not proportional to each other, its emphasis on motor function rather than
333	cognitive or social function, and less consideration of other symptoms in neurological
334	severity, such as state of consciousness and sensory function. ²⁶ In addition, as we could not
335	use the pre-stroke mRS to assess the patients' pre-stroke disability directly, the assessments
336	were based on the collection of information on functional status and living conditions of the
337	patients before the onset of ICH. Although the present study used the JROAD-DPC database,
338	further research is needed using detailed data on ICH in clinical practice.

340 CONCLUSION

341	This study represents the first examination of the relationship between BMI and stroke-
342	related disability (measured by the mRS) following the onset of ICH. The final analysis
343	included 155,211 patients with ICH, of whom 74.9% experienced functional decline.
344	Notably, unlike our hypothesis, the analysis revealed that individuals in the Normal to Obese
345	I BMI groups (with a BMI range of 22.2–30.4 kg/m^2) exhibited reduced ORs for ICH-related
346	functional decline. Furthermore, the spline curves showed that hospitalization costs followed
347	U-shaped patterns, with a BMI of 25.0 kg/m^2 as the lowest point, regardless of age group.
348	Similar to findings in mortality studies, the obesity paradox concept may also apply to
349	functional decline after ICH, underscoring the importance of appropriate BMI management
350	of patients at risk for stroke.


494 Figure 3. BMI spline curves for hospitalization cost.
