29 Abstract

Background: -We live in multifaceted, dynamic and interconnected world in which the 30 importance of physical, mental, and social wellbeing has not been well emphasized. Given the 31 intricate nature of life, it is clear that mental health is essential to the welfare of people, 32 communities, nations, and the entire planet. The main tactic to address unmet mental health 33 needs has been to integrate psychiatric treatment into primary care, however this approach has 34 35 been ineffective, and psychiatric services have been concentrated in Ethiopia and other major cities in sub-Saharan Africa. This study aimed to assess the perceived levels of mental health 36 37 service accessibility and associated factors among psychiatric outpatients at Amanuel mental specialized hospital, Addis Ababa, Ethiopia, 2024. 38

Objective: To assess the perceived levels of mental health service accessibility and associated
factors among psychiatric outpatients at Amanuel Mental Specialized Hospital, Addis Ababa,
Ethiopia, 2024.

42 **Methods**:-Institution-based cross-sectional study were employed from 03 January, to 03 43 February 2024. A total of 415 participants were participated. A systematic sampling technique 44 was used. Binary logistic regression model was fitted to identify the factors associated with 45 service accessibility. Adjusted odds ratio (AOR) with 95% confidence interval (CI) and p-value 46 less than 0.05 during multivariable logistic regression were used to declare the factors associated 47 with the outcome variable.

Results: - The perceived level of mental health service accessibility was 10.4%; 95% CI: (7.5%,
25. 9%).Service accessibility was associated with urban resident [(AOR = 3.563, 95% CI: (1.065, 11.9155)], and Medication access [(AOR = 2.604, 95% CI: (1.220, 5.555)].

51 **Conclusions and recommendations**: - The study observed that the prevalence of perceived 52 service accessibility was found to be low in this study. Availability of medication and urban 53 resident are the factors associated with perceived level of mental health service accessibility. 54 There is a need to have proper coordination and cooperation among various mental health service 55 providers.

58 Introduction

Access to health care has a significant impact on overall health at all stages of life. With 59 adequate use of health services, health problems can be detected and diagnosed earlier so that 60 they can be treated more proactively. This, in turn has a positive effect on chronic diseases and 61 life expectancy. Most healthcare systems around the world emphasize minimizing barriers to 62 citizens' access to healthcare, but many barriers systematically impede such a goal. Some 63 important barriers are related to the fact that services are not sufficiently accessible, physically 64 65 available, or reasonably priced(1). Lack of access to and use of mental health services remains particularly visible in low- and middle-income countries (2). 66

According to the World Health Organization (WHO), mental health is defined as a state of well-67 being in which each person realizes their potential, is able to cope with normal life stresses, is 68 able to work productively and fruitfully, and is able to participate in their community (3). Thus, 69 mental health is an integral part of health, including various activities that are directly and 70 indirectly related to the promotion of mental well-being, the prevention and treatment of mental 71 72 health disorders, and the rehabilitation of people with mental health problems (4). Although mental health disorders are known to be one of the greatest burdens of disability, with an 73 estimated 37% of all healthy life years lost due to mental health disorders, it is recommended 74 that mental health services be available at every possible level, mainly in communities and 75 medical facilities(5). 76

Global burden of disease studies indicate that more than 5 percent of disability-adjusted life years (DALYs) and up to 15.7 percent of disability-adjusted lives (YLDs) worldwide are related to mental health problems (6,7). Despite the global upward trend in mental illness, this problem has not been properly treated as a physical illness and is largely neglected in many parts of the

world, especially in low and middle-income countries (LMIC). This deficiency results in the
limited, inadequate and inequitable provision of MH services(8), and would widen the care gap.
This growing gap causes many health, social, and economic problems (9). Research has shown
that the main barriers to providing MH services are information systems (10,11), financial and
resource barriers(12), a lack of evidence-based policy and practice, and prevention, integration,
and structural barriers(13).

In Ethiopia, neuropsychiatric disorders are estimated to account for 5.8 percent of the disease 87 burden (14). Depression accounts for about 6.5 percent of illnesses (15). Mental health disorders 88 89 accounted for about 11 percent of cases, mostly in rural areas. Schizophrenia and depression are among the ten most severe illnesses (16). It is often more difficult for people with mental health 90 problems to access mental health services due to various attitudinal and structural barriers (7). To 91 reduce treatment, many countries have taken the initiative to integrate mental health services into 92 primary health care (17). Despite efforts to increase access to mental health services, treatment 93 rates for mental illness remain low in LMICs. Low treatment rates may be due in part to a 94 number of barriers to integration, including limited resources and low public demand for mental 95 health services (18). Integrating psychiatric care with primary care, a key strategy to address 96 97 unmet mental health needs, has remained inadequate, and psychiatric services are concentrated in large cities in sub-Saharan Africa. It is no different in Ethiopia, where the majority of care is 98 provided by the Amanuel Mental Hospital, the country's only psychiatric hospital, located in 99 Addis Ababa. Despite the development of several regional psychiatric units, there is evidence of 100 limited use of services in the wider community (19). Therefore, this study is aimed to assessing 101 the levels of mental health services accessibility and associated factors among psychiatric 102 outpatients of Amanuel mental specialized hospital. 103

104 Method and materials

105 Study area, design, and period

An institution based cross-sectional study was conducted from 03January to 03February 2024 in 106 Amanuel Mental Specialized Hospital, Addis Ababa, Ethiopia. It is found in the capital city, 107 which is the only specialized hospital that gives service for several years on mental health and 108 related cases. The hospital has 239 beds including 11 private wing beds and 23 emergency beds, 109 and also it has 13 outpatient departments (OPDs). On average, 10,320 patients receive the 110 111 service per month, and the majority of patients stay in the hospital with their family members. The hospital is also playing a pivotal role as a continuous professional development center for 112 psychiatric professionals of different levels. 113

114 **Population**

All patients attending the psychiatric outpatient department of Amanuel mental specialized hospital were the source population. And all patients who attended at a psychiatric outpatient department, during the study period were the study population. All patients attending psychiatric outpatient with an age of 18 years and above were included in the study on the other hand, Patients who were critically ill and unable to respond were excluded.

120 Sample size determination and sampling technique

121 The sample size was calculated using a single population proportion formula, taking into account122 the following assumptions:

Level of significance (α) =5% (at a confidence level of 95%), marginal error d=5% and P=0.5
(since there was no published research conducted in levels of mental health service accessibility).
The Z value is 1.96 (n=sample size, P=proportion and d=marginal error). The sample size was

126 384. By considering 10% non-responses, the total sample size was 423.Systematic sampling 127 technique was used to select representative samples of patients who had follow up at the 128 outpatient department of Amanuel Mental Specialized Hospital. The first participant was 129 selected by lottery method, then continued by every 23 intervals (k). The data were collected 130 from every 23 other patients on follow up.

131 Data collection techniques, variable measurement, and quality control

Structured Interviewer-administered questionnaire was used to collect the data. The 132 questionnaire was prepared in English, translated to local language Amharic and translated back 133 to English to ensure its consistency. The questionnaire includes socio-demographic 134 135 characteristics, structural barriers, community barriers, provider/service user barriers, and healthcare related factors. Service accessibility was the dependent variable in this study and was 136 operationally defined as services that are provided in a timely, continuous manner, develop close 137 to the community and taking into account individual needs and preferences. Patients' diagnosis 138 139 and medication was taken from the patients' medical record. We were also calculating Cronbach alpha (α) to check the reliability of measuring tool (VIF=0.97). One-day training on the basic 140 techniques of data collection was given to data collectors and supervisors before the actual data 141 collection period. Two Master of Science who had prior data collection experiences and 142 143 knowledge of Amharic and Afan-Oromo language was recruited for data collectors and supervisors, respectively. Data collectors were also briefed on each item included in the data 144 collection tool. The data collectors were observed daily, and the completed questionnaires were 145 checked daily by the supervisor and the principal investigator. We pre-tested the questionnaire 146 on 5% of the sample at Eka kotebe general hospital before the actual data collection period. The 147 necessary modification was done based on the pre-test findings. 148

149 Data processing and analysis

Coded and verified data were entered into a computer using EPI Data version 3.1 and imported 150 into Statistical Package for Social Sciences (SPSS) Windows software version 21. Descriptive 151 statistics such as frequency, percentage, mean, and median were calculated and presented using 152 tables and graphics. Binary logistic analysis was performed to determine each explanatory 153 variable, and variables with a p-value less than 0.25 in the bivariate analysis were entered into 154 the multivariate analysis. A multivariate logistic regression analysis was performed to determine 155 156 if there was statistically significant relationship between explanatory variables and outcome variables. P values less than 0.05 were considered statistically significant, and the strength of 157 158 associations was reported as adjusted odds ratio with 95% C.I.

- 175 Socio-demographic factors of respondents
- 176 A total of 415 respondents participated in this study yielding a response rate of 98%. Male study
- participants accounted for 58.6 %. The majority (38.6%) of the respondents were 26-35 years
- 178 old. Most (47%) of study participants were married by marital status. Regarding the residents,
- 179 88.2% of the respondents were from urban. Of the total study participant, 29.6% participants
- 180 were private employees (Table 1).

183 Perceived level of mental health Services accessibility

- 184 The perceived level of mental health service accessibility was 43(10.4%; 95 %CI: 7.5, 13.5).
- 185 Among the study participants, 89.6% had perceived level of service non-accessibility.

186 Community factors

- 187 Among the respondents (71.3%) had received stigma from the community. Regarding the way;
- the community treated mentally ill patients, 288(69.4%) were maltreated by the community. The
- 189 majority of the respondents, 216(52%), were lived in communities with low economic status

195 Health facility factors

The majority 341(82.2%) of the study participants reported that the health facilities lack capacity
to give mental health services. Among the participants, 357(86%) patients perceived that their
nearby health facilities lack medications to treat mental illness (Table 3).

205 Structural factors

The result of this study showed that most (56.6%) of the participants perceived that there was structural stigma for mental health. About 73.5% of the respondents were lack services accessibility due to lack of priority for mental health (Table 4).

- 226 Of the respondents 285(71.1%) of them reported that they did not visit there nearby health
- facility due to lack of patient involvement in the treatment process. Majority 53.7% of the
- respondents did not access mental health services because of self-stigma. (Table 5)

245 Factors associated with perceived mental health service accessibility

We did binary logistic regression analysis in order to find the candidate variables for 246 multivariable logistic regression analysis. And variables with p-value less than or equal to 0.25 247 were fitted to multivariable logistic regression analysis. In the bi-variable logistic regression 248 249 analysis; sex, Resident, Stigma, Maltreatment, Traditional healers, lack of capacity, service nonavailability, lack of medication, lack of good relationship, lack of acceptance, lack of patient 250 involvement, dissatisfaction, low scale-up and self-stigma were found to be a candidate variable 251 252 for multivariable logistic regression. In the final model, factors significantly associated with perceived service accessibility were resident and medication access. While variables like age, 253 254 marital status, occupation, support structure, economic status of the community, board support, 255 structural stigma, lack of priority, national policy, lack of patient involvement, lack of selfesteem, lack of self-help group, were not significantly associated with service accessibility. 256

In multivariable logistic regression analysis, Resident and Medication were significantly associated with perceived service accessibility. The odds of perceived mental health service accessibility among service users of urban residents were **3.563** (AOR: **3.563**, **95**%CI: **1.065**, **11.915**) higher compared with Rural residents.

The odds of perceived service accessibility among respondents who had medication access were
262 2.604 times [(AOR=2.604, 95% CI: (1.220, 5.555)] higher compared with counterparts(Table 6)

275 Discussion

The present study was conducted in Amanuel Mental Specialized Hospital, and it presents mental health service users' perception of service accessibility and the barriers to utilizing mental health services. Accordingly, the perceived level of mental health service accessibility among mental health service users in Amanuel Mental Specialized Hospital was 10.4%. The predictors of perceived service accessibility in this study included Resident and Medication availability.

The perceived level of mental health service accessibility among patients attending outpatient departments in Amanuel Mental specialized hospital was 10.4%. This data was much lower than the national healthcare access and quality index for Ethiopia 2019 (33 %) that was presented by the national data management center for health (NDMC). This could be due to mental health care service barriers including lack of mental health policy, limited professionals and financial resources, stigma and discrimination towards mental health problems and its treatment.

288 This finding revealed that the odds of perceived service accessibility among urban residents were 289 almost four times higher compared to rural residents. The findings suggest that a large proportion 290 of patients travel long distances to access mental health care, primarily located in the country's 291 capital, Addis Ababa, and this may prevent many people from accessing mental health services. 292 This finding is consistent with previous research in Nigeria, which showed that long waiting 293 times and long distances to access mental health services are barriers to service use, especially 294 among rural populations (20). Another study showed that depressed patients living 30 to 60 295 miles away from psychiatric health services were less likely to receive therapy compared to those who were living within shorter distances(21). Another study found that depressed patients who 296

lived 30 to 60 miles from psychiatric health services were less likely to receive treatment thanthose who lived a shorter distance(22)

In the present study, availability of medication was significantly associated with perceived mental health service accessibility; the odds of perceived mental health service accessibility among respondents who had medication access were nearly three times more likely compared to counterparts. Offering free psychiatric medication to psychiatric patients and their inclusion in the health insurance was recommended by some psychiatrists as a way of increasing mental health services utilization and access in Sudan. Health insurance coverage as a successful policy to improve patient's access to psychiatric medications was suggested by policymakers in the previous study in Sudan(23). Furthermore, increasing the availability of essential psychiatric medications was recommended by the WHO(24) to strength mental health system in Sudan. This is not different in Ethiopia. The Ethiopian government implements community based health insurance system to increase the utilization of health services and reduced the incidence of catastrophic health expenditure.

321 Strength and Limitations of the Study

The study addressing adequate sample size. To the best of the researcher's knowledge this is the first study to assess the perceived service accessibility among mental health service users were the strength of the study. The study has been restricted only to mental health service users in Amanuel Mental Specialized Hospital. Since this is a cross-sectional study it does not show the casual relationship between service accessibility and mental health was the limitations of this study.

328 Conclusions

The study observed that the prevalence of perceived mental health service accessibility was 329 found to be low in this study. Availability of medication and urban resident are the factors 330 associated with perceived level of mental health service accessibility. There were many barriers 331 332 to utilizing the services. There is still lack of awareness of mental health and mental health issues, and services have not yet reached those in need. The service needs to reach the 333 communities, especially the remote areas. Appropriate coordination and collaboration between 334 different mental health service providers is necessary. To improve the utilization of mental health 335 services, a periodical evaluation must be carried out. 336
