34 Abstract

35 South African adolescents are at-risk for HIV infection. Understanding the factors 36 influencing sexual decision-making is crucial for developing effective HIV prevention 37 strategies. We conducted a qualitative study with adolescents and caregivers in Rustenburg, 38 South Africa to explore individual and interpersonal factors that influence adolescent sexual 39 decision-making. Focus Group Discussions (FGDs) were conducted in English and Setswana 40 with 17 adolescents (13 females and 4 males) and 19 caregivers (17 females and 2 males) 41 between April and July 2018. Thematic analysis revealed that while adolescents had access to 42 sexual education from various sources, where the knowledge does not translate into healthy 43 sexual decision-making. A contributing barrier was the lack of effective communication and 44 support between caregivers and adolescents in discussing topics related to sexual activity. 45 Although adolescents expressed a strong need to be understood and supported by caregivers regarding their sexual activity, there was perceived distrust, judgemental attitude from 46 47 caregivers, poor role models of a father figure, and the traditional taboo of having these 48 discussions with caregivers. While female adolescents and female caregivers discussed 49 sensitive matters, this type of communication was limited with adolescent males. Male

50	adolescents were uncomfortable communicating with either caregiver, fearing caregiver
51	judgemental attitudes and being misunderstood. Female caregivers perceived male caregiver
52	roles to be absent and non-engaging when it came to adolescent education and support in
53	sexual matters. Caregivers desired to support their children, yet they seemed to doubt their
54	skills. Communication tools and guidance on how adolescents and caregivers could
55	communicate about sensitive matters could create enabling environments for adolescents to
56	make informed, healthy decisions regarding their risky sexual behaviours. To address
57	adolescent intention-behaviour gap, future interventions could consider gain-framed
58	messaging within intervention packages to promote healthy sexual choices.

84 Introduction

85

86 The HIV burden among sub-Saharan African (SSA) adolescents is a significant public health 87 concern with adolescent girls and young women (AGYW) aged 15-24 years accounting for 88 63% of new HIV infections in the region (1). In South Africa, AGYW are particularly vulnerable having an HIV acquisition rate three times higher than their male counterparts (2). 89 90 This vulnerability is exacerbated by various factors including sexual relationships with older 91 men, gender inequalities, social norm discriminatory practice, poverty, deprived autonomy, 92 and risk for abuse and violence (3–5). Although adolescent boys and young men (ABYM) are 93 at lower risk for HIV acquisition, there is a growing need to include ABYM in HIV 94 prevention discussions (1,4). The socioecological model (SEM) provides a framework for understanding the multiple
levels of interactions that could influence adolescent sexual decision-making (15–18).
Applying the SEM to explore the perspectives of adolescents and others in their social
ecology can provide valuable insights into the complex interplay of factors shaping
adolescent sexual decision-making (16,18,19). While there are several studies on adolescent

122	sexual behaviour and behavioural interventions, there is a dearth of information on

134	This qualitative project was embedded in a parent observational prospective study that took
135	place at the Aurum Rustenburg Research Centre, South Africa. Rustenburg is one of the
136	fastest growing cities in the Northwest Province with an approximate population of 562,031,
137	where platinum mining is the dominant industry (20). Adolescents between the ages of 12-19
138	years constitute 14.6% of the population and have a high prevalence of HIV (2,21,22).

159 FGD guides (attached S1 and S2) were used to explore the adolescent and caregiver 160 knowledge of sexual and reproductive health, and factors contributing to sexual and 161 reproductive health behaviour. The guides included topics to understand where adolescents 162 accessed sexual and reproductive health education, individual and interpersonal influences on 163 adolescent sexual and reproductive health decisions, perceptions of the age adolescents could 164 become or decide to be sexually active, and recommendations which could encourage 165 adolescents to speak honestly about their sexual behaviours. Research assistants OM and TM 166 (graduate education), female and male respectively, were the facilitators and note takers. 167 They were trained by an experienced post-doctoral investigator (CCM) before data collection. 168 During each FGD, CCM or FM added in facilitation in a supervisory role to facilitators OM 169 and TM. Facilitators and note takers (OM, TM, FM and CCM) had professional relationships 170 with participants and their caregivers, which ended post the main study conclusion.

172	During screening into the main study, adolescents completed an interviewer-administered
173	socio-demographic and sexual behaviour questionnaire. Caregivers completed an abbreviated
174	interviewer administered socio-demographic questionnaire only. We used data from the
175	socio-demographic questionnaires to describe our participant pool for this study.
176	
177	Data Analysis
178	All FGDs were digitally-recorded, transcribed verbatim and translated to English (where
179	necessary) prior to analysis by OM and TM. Following each FGD and after the debrief
180	sessions, the digital recordings were reviewed to revise the probes and monitor the saturation
181	of themes. FM conducted a quality check of the transcripts. De-identified English transcripts
182	and debrief notes were also reviewed before data analysis and included in the codebook.
183	NVIVO software Version 14 was used for the analysis (24). For the analysis, HM used a
184	thematic approach that included deductive and inductive approaches to derive the themes.
185	Through inter-rater reliability (YWM and CCM), we reached an agreement on the coding and
186	emerging patterns. Discrepant codes were dropped during the analysis. Emerging themes
187	were further discussed and finalised during virtual meeting discussions with the research
188	team. We applied a 32-item checklist (attached S3), the Consolidated Criteria for Reporting
189	Qualitative Research (COREQ), to ensure comprehensive reporting of qualitative data (25).

206	Descriptive characteristics of participants
207	Seventeen adolescents (13 females and 4 males) participated in the FGDs, with median age
208	17-years (Interquartile range (IQR) 16-18 years). Most adolescents (n=13) attended senior
209	secondary school. Nine females and one male reported being in a relationship with a steady
210	partner/s, where only the females reported being sexually active. Five (55.6%) of these nine
211	females reported multiple heterosexual sexual relationships with older partners up to four
212	years older than them. Sixteen (94.1%) adolescents reported alcohol use, at a minimum once
213	per month.
214	
215	Seventeen female and 2 male caregivers with a median age of 37 years (IQR 34-46 years)
216	took part in the FGDs. Thirteen were unemployed, with twelve reliant on family or
217	spouse/partner financial assistance. All caregivers had about 2 to 5 child dependents per

218 household. Among the 17 female caregivers, seven were married, and seven were in a steady

- 219 non-cohabitating relationship. Thirteen caregivers had their first child before they were 21

222 Qualitative findings

228 Individual level factors influencing sexual decision-making

229	Adolescents received information on sexual behaviour and how to make sexual decisions
230	from school, friends, partners, television and social media that were confirmed in responses
231	from the caregivers.
232	"sexting whereby you text your partner, talking about those thingsI learned mostly about
233	these things at school and from friends when they tell you that they saw this and that on TV
234	and also from cellphones [smart phone device] and Facebook." Female, 15-17 years old, not
235	sexually active.
236	
237	"Social media influences us because on Facebook you see other children who are
238	younger than you posting naked pictures of themselves then you ask yourself why are
239	you not posting naked pictures of yourself when you older than themSo that
240	influences you to grow up." Male, 15-17 years old, not sexually active.
241	
242	"On the TV a lot of the times we seethey watch sexual movies on the TV right. So
243	that's the thing that encourages them to end up being a part of that thing". Female
244	caregiver, 31-35 years old, single with steady partner.
245	
246	However, adolescents and caregivers perceived that there is a gap in translating the
247	knowledge of sexual behaviour into healthy sexual decisions that limit the risk of HIV
248	infection or pregnancy.

250	"They know about risky behaviour It is just that they are hard-headed".
251	Female, 18-19 years old, sexually active, single with multiple partners.
252	
253	"I don't think that all adolescents know because if they knew they wouldn't engage in
254	unprotected sexbecome pregnant when they are young, they are getting HIV".
255	Male caregiver, 46-50 years old, married.
256	
257	Reaching a certain age milestone informed adolescent decision-making on sexual activity.
258	Adolescents had polarized views though, where some preferred younger age associating this
259	with the onset of puberty while others preferred waiting until adulthood.
260	"15 years because a lot of things would have changed on your body, like the eggs in a
261	women's' body.", Male, 15-17 years old, not sexually active, no partner.
262	
263	"I think at 12 because at 12 you starting to be matured. For puberty starting."
264	Female, 18-19 years old, sexually active, and has a single partner.
265	
266	"a person should start having sex at the age of 21, because 21 you are mature
267	enough, you are able to take right decisions when coming to sex." Female, 18-19
268	years old, sexually active, single partner.
269	
270	Alcohol use was perceived to promote engagement in high-risk sexual activity, voluntarily
271	and involuntarily, reducing the ability to make informed healthy decisions.

272	"Risky behaviour according to my understanding, is like when we go out with friends
273	and have fun and start behaving in a way that we start drinking and not seeing the
274	outcomes" Female, 18-19 years old, sexually active, multiple partner relationship.
275	
276	"some girlswhile they are sitting there at the taverns with the guys, the girl would
277	go to the toilet and the other guys will put a drug in the girls drink. Then the girl
278	drinks it coz (because) she has no idea of what they put inside of her drink. Whatever
279	they put inside of your drink, drugs you and you become easily influenced into doing
280	anything that they want you to do."
281	Male, 15-17 years old, not sexually active.
282	
283	Poverty and the need for financial support were highlighted as other factors influencing the
284	decision to engage in risky behaviours.
285	"Sometimes what leads some adolescents to sexual activities is that you get that at
286	home they are in need of something so the girls get forced to turn to older men for
287	financial supportwhich leads them to sexual activities." Female, 18-19 years old,
288	sexually active, single with multiple partners.
289	
290	"They take them to be "stupid" than they end up falling in that trap, and again
291	Sometimes you get {that] the young girls hang out with us older men, and we give
292	them money." Male caregiver, 46-50 years old, married.
293	
294	Relationship level factors influencing sexual decision-making

295	Female adolescents believed a female caregiver, being the same gender would identify with	
296	them. In contrast, some female adolescents shared their greater comfort in communicating	
297	with their male caregiver. Others expressed comfort in talking with siblings.	
298	"I prefer to talk to my mother [she] is a woman, and she will understand." Female	
299	18-19 years old, sexually active, in a single partner relationship.	
300		
301	"I honestly speaking I trust my father and I can talk to him about anythingWe have	
302	a very close relationship. My mother can't keep a secret, but my father can." Female,	
303	18-19 years old, sexually active, in a single partner relationship.	
304		
305	"Sister. I cannot to talk to my mother or my father." Female, 18-19 years old, sexually	
306	active, in a single partner relationship.	
307		
308	Female caregivers described how the role of a male caregiver or a father figure can create	
309	barriers to communication between adolescents and caregivers. Female caregivers believed	
310	that male caregivers ignored their supportive role in favour of fulfilling personal desires. In	
311	contrast, male caregivers may feel it is futile to reach out to sons because sons tend to	
312	develop closer bonds with female caregivers.	
313	"is just that in most cases men are ignorant he comes home tired, reads	
314	newspaper, watch news and sleeps or is at the gym. I am the one that is always with	
315	the children". Female caregiver, 41-45 years old, married.	
316		
317	"With fathers it is not that easy even if they are boys they are close to their mothers	
318	[agreement by other caregivers] they are even scared to talk to us". Male	
319	caregiver, 46-50 years old, married.	

321	While caregivers expressed their desire to support their children, many adolescents were	
322	resistant to this type of engagement due to concerns citing trust, confidentiality, and feelings	
323	of being misunderstood. Male adolescents expressed difficulty in speaking with both male	
324	and female caregivers, fearing caregiver judgemental attitudes and being misunderstood.	
325		
326	"We must be open We have to be free but not too much right? We have to try to talk	
327	to them our parents did not talk to us So nowadays, we have to teach the right	
328	things". Female caregiver, 46-50 years old, married.	
329		
330	"I do not talk with them, because they are going to think that you have already started	
331	having sex at a young age." Male, 15-17 years old, not sexually active.	
332		
333	"I do not talk to them because like they won't understand what I'm going through".	
334	Male, 15-17 years old, not sexually active.	
335		
336	However, some caregivers and adolescents avoided discussions on sexual behaviour due to	
337	the historically taboo nature of talking about sex or other sensitive topics with minors.	
338	"Our parents were hiding things from us, we just lived in the dark. Today if you	
339	tell a child something, they will say "yes in your times". So, we should find a balance	
340	and not put too much pressure We must try to keep up with their times." Female	
341	caregiver, 46-50 years old, married.	
342		
343	"according to my culture at my age I cannot talk to my parents about sexI	
344	prefer to talk to my friend because she broke her virginity before me, and she never	

345	told me to do the same. I decided to break my virginity. When she gives me advice, I
346	will listen and see for myself if it is right or wrong." Female, 18-19 years old,
347	sexually active with a single partner.

349	Adolescents and caregivers expressed interest in improving communication on sexual		
350	activity and engaging in risky sexual behaviour discussions, to improve sexual decision-		
351	making. Some caregivers shared techniques they were able to use to improve communication		
352	"I think there should be a study for parents, and they should be educated on how to		
353	communicate with their kids they still have that mentality of saying you cannot talk		
354	about sex with your child". Female, 18-19 years old, sexually active, and in multi-		
355	partner relationships.		
356			
357	" when a child wants to talk to you, they must not be scared to talk to you must		
358	have a friendship for example I hugged my child and told her that it is a mistake I		
359	am trying to bring her close to me I do not shout The child must not be afraid to		
360	talk to you as the parent". Female caregiver, 46-50 years old, married.

362 **Discussion**

363

Making good choices is the foundation for healthy sexual decision-making. Through our
qualitative investigation conducted in South Africa, we found that adolescents had adequate
knowledge of sexual behaviour but do not translate this knowledge into healthy choices. In
this resource-limited setting, poor communication between adolescents and caregivers
emerged as a dominant barrier that limited the type of support that caregivers could provide
to their adolescents to help them with healthy decision-making. While caregivers knew of the

370 benefits of communicating and supporting their adolescents to make healthy sexual decisions, 371 they doubted their communication ability. Communication tools and guidance on how 372 adolescents and caregivers could communicate about sensitive matters could create enabling 373 environments for adolescents to make informed, healthy decisions regarding their risky 374 sexual behaviours. This study supports previous reports highlighting the importance and 375 strengthening of caregiver engagement with adolescents in healthy sexual decision-making, 376 providing a supportive attitude, being able to monitor adolescent behaviour, and improving 377 family dynamics where both caregivers serve important roles to protect adolescents from 378 engaging high-risk sexual behaviours (11–14,19,26). 379

380 Adolescents and caregivers had contrasting views on their ability to communicate about 381 sexual topics. Some reflected on the healthy relationships they had built in supportive roles. 382 Others believed this was simply not possible or uncommon practice due to the traditional 383 taboo nature in discussing sexual topics with children. Adolescents expressed limited 384 caregiver trust, caregiver judgemental attitudes and being misunderstood as common barriers 385 in engaging with caregivers. Caregivers knew the benefits of being more supportive but felt 386 helpless as they lacked the knowledge and ability to engage in sexual behaviour discussions 387 with their adolescents. Similar findings have been reported, amplifying the need 388 strengthening caregiver intervention (12–14,27). A South African study identified that increased positive caregiving and caregiving supervision were protective factors to adolescent 389 390 engaging in HIV risk behaviours (28). Further, caregiver support could enhance adolescent 391 self-efficacy and improve self-esteem toward healthy sexual decision-making (19). 392 393 The lack of support from male caregivers within the family was another factor contributing to

394 a breakdown in communication. The role male caregivers provide is increasingly being

395 challenged, shifting from the stereotypical breadwinner role, to being supportive and 396 understanding toward their adolescent children (13,14,29). Other male caregivers, including 397 uncles, brothers, grandfathers, or other adult males also have an important supportive role to 398 serve (29). In our study, male caregivers desired to provide more support to their adolescents 399 yet seemed insecure in this role. Reframing the stereotypical male caregiver role, towards 400 empowering men to be understanding and supportive toward their children could address this 401 barrier (26,29). Given adolescent boys expressing a lack in reaching out to either male or 402 female caregiver, amplifies the need to intervene for adolescent boys to improving healthy 403 decision-making.

404

405 An intention-behaviour gap where translating knowledge on sexual behaviour to making 406 healthy sexual decisions was another key barrier (30). While adolescents have various 407 knowledge resources, their knowledge does not always translate to healthy sexual decision-**408** making. Using gain-framed messages to emphasize the benefits of engaging in certain 409 behaviours could aid in healthy choices (31). Reaching adolescents through television and 410 social media (32), has potential in propagating gain-framed messaging through these media to 411 motivate healthy sexual decision choices. This strategy is widely becoming accepted and has 412 been demonstrated to be successful in reducing sexually transmitted infections (31,33). Using 413 television and social media could be beneficial in providing accurate information for both 414 adolescents and caregivers, augmenting future adolescent-caregiver interventions in the 415 promotion of healthy sexual decision-making (32).

416

417 Our study was limited to participants who were already accessing services as participants in a
418 research setting, and an unequal representation of both male adolescents and caregivers. We
419 also did not include the perspectives of external stakeholders such as community leaders,

policy makers, and potential influential role models within the community. Thus, this study is
restricted in its ability to capture the perspectives of the broader community, including other
adolescents and caregivers, and the findings should be considered within this limited scope.
Despite these limitations, our study has strengths in that it highlights how vital caregiver-
adolescent communication could be in informing healthy sexual decision-making among
adolescents who are at high-risk for HIV. This study is among a few studies highlighting the

427 perspectives of adolescents and their caregivers that influences adolescent sexual decision-

428 making and provides valuable insights into strategies that could be applied in future

429 adolescent behavioural interventions.

431 Conclusions

432 This qualitative study uses a person-centred approach, and provides valuable insights into the 433 individual and interpersonal factors influencing adolescent sexual decision-making in 434 Rustenburg, South Africa. The study highlights the critical role of caregiver-adolescent 435 communication in promoting healthy sexual decision-making. The findings underscore the 436 importance of implementing targeted, culturally relevant interventions that address the 437 barriers to effective communication between adolescents and caregivers. Interventions should 438 include a sexual education and skill package to equip both male and female caregivers to 439 engage in conversations on sexual behaviour. The study as well highlights the potential in **440** including gain-framed messaging within intervention packages to address the intention-441 behaviour gap, enabling adolescents to translate knowledge towards healthy sexual choices. 442
