1 Effectiveness of Pasteurization for the Inactivation of H5N1

2 Influenza Virus in Raw Whole Milk

22 Abstract

23 Highly pathogenic avian influenza (HPAI) clade 2.3.4.4b H5Nx viruses continue to 24 cause episodic incursions and have been detected in more than 12 taxonomic orders 25 encompassing more than 80 avian species, land and marine mammals, including recent 26 detections in dairy cattle. The HPAI H5N1 spillover to these important livestock species creates a new interface for human exposure and raises food safety concerns. Presence 27 of H5N1 genetic material in one out of five retail pasteurized milk samples in the USA 28 has prompted the evaluation of pasteurization processes for the inactivation of influenza 29 viruses. Our study examined whether pasteurization could effectively inactivate HPAI 30 31 H5N1 inoculated raw whole milk samples. We heated 1 mL of non-homogenized cow's milk samples to attain an internal temperature of 63°C or 72°C and spiked with 6.3 log 32 EID₅₀ of clade 2.3.4.4b H5N1 virus. Complete inactivation was achieved after incubation 33 34 of the H5N1 spiked raw milk at 63°C for 30 minutes. In addition, complete viral inactivation was observed in seven out of eight replicates of raw milk samples treated at 35 72°C for 15 seconds. In one replicate, a 4.56 log reduction was achieved, which is 36 about 1 log higher than the average viral quantities detected in bulk tanks in affected 37 38 areas. Therefore, we conclude that pasteurization of milk is an effective strategy for mitigation of risk of human exposure to milk contaminated with H5N1 virus. 39

42 **1. Introduction**

43 The spread of HPAI H5Nx viruses bearing clade 2.3.4.4b hemagglutinin (HA) and their variants generated by reassortment with low pathogenicity avian influenza viruses 44 45 (LPAIVs) remain the major causes of large-scale HPAI outbreaks in domestic poultry and wild birds worldwide (Youk, et al. 2023, Alkie, et al. 2022). They have also caused 46 multiple spillover infections into mammals resulting in mass die-offs in the Americas 47 48 (Rimondi, et al. 2024, Alkie, et al. 2023). However, naturally occurring HPAI infections in ruminant livestock have never been reported before 2024. The fast spread of HPAI virus 49 50 in dairy cows, as well as sustained transmission among dairy herds in 13 states in the 51 USA since March 2024 indicates wider host ranges of HPAI clade 2.3.4.4b H5N1 viruses (FDA.). The detection of infectious virus in milk samples obtained from infected 52 dairy cows indicate the potential risk of accidental introduction of H5N1 virus into the 53 human food supply. Although human foodborne infection with H5N1 virus has not been 54 confirmed to date, exposure to contaminated milk in mice and cats resulted in severe 55 56 and fatal infections (Guan, et al. 2024, Burrough, et al. 2024).

57 Dairy milk is usually sold pasteurized, and the sale of raw milk is not permitted in some jurisdictions like Canada (Health Canada.). Based on the understanding of viral 58 structure and previous studies on pasteurization of eggs and human milk (Chmielewski, 59 60 et al. 2011, Swayne and Beck. 2004, Pitino, et al. 2021), it is assumed that pasteurization of milk would be effective against H5N1 viruses, but recent studies have 61 demonstrated a range of results (Cui, et al. 2024, Schafers, et al. 2024, Kaiser, et al. 62 63 2024, Guan, et al. 2024). Also, studies performed using other viruses have demonstrated that certain milk components such as fat globules and casein micelles 64

65 may protect viruses against heat treatment (Tomasula, et al. 2007). Although traces of H5N1 genomic materials have been detected in about 20% of retail dairy samples that 66 were sampled in USA supermarkets, infectious H5N1 viruses have never been isolated 67 68 from retailed pasteurized dairy products to date (FDA.). With the ongoing rapid virus evolution and spread of H5N1, more dairy farms could be infected in the USA and 69 70 potentially in other countries. Should raw milk from infected asymptomatic cows 71 accidentally enter the processing chain for human consumption, pasteurization can be 72 an effective treatment to inactivate the H5N1 virus. In the current study, we simulated 73 pasteurization processes typically used by the dairy industry on unpasteurized and 74 unhomogenized raw milk inoculated with H5N1 clade 2.3.4.4b at titers that have been reported in the affected farms (Spackman, et al. 2024). 75

76 2. Materials and Methods

77 2.1. Heat inactivation at 63°C for 30 minutes

78 The temperature combination of 63°C for 30 minutes represents a vat or bulk pasteurization treatment sometimes used in commercial dairy processing plants. Firstly, 79 80 fresh bulk raw milk obtained from a dairy farm in Manitoba, Canada was treated for 1 hr 81 at room temperature with a cocktail containing antibiotics and antifungals (streptomycin, 82 penicillin, vancomycin, nystatin and amphotericin) (Sigma-Aldrich) to prevent any harmful effects of bacteria on the embryonated chicken eggs used to test the 83 84 infectiousness of HPAI H5N1 virus. The sterility of the milk samples from bacteria was 85 confirmed by inoculating into Columbia Blood Agar Base medium and monitored daily for bacterial growth. The entire procedure was conducted in a biosafety level 3+ (BSL-86 87 3+) facility at the National Centre for Foreign Animal Disease (NCFAD) in Winnipeg,

88 Manitoba. Nine-hundred and ninety microliters milk (990 µL) each was placed in four 1.5 89 mL Eppendorf tubes and was heated in a water bath to attain an internal temperature of 63°C. The temperature was monitored using the Applied Biosystems Thermal Cycler 90 91 Temperature Verification System (Model 4500). The raw milk in all four tubes was spiked with 10 µL of clade 2.3.4.4b H5N1 virus, recapped and treated for 30 minutes. 92 93 The virus was designated as A/Turkey Vulture/Ontario/FAV473-3/2022 having a stock titer of 1 X 10^{8.3}EID₅₀/mL isolated from Canada and archived at NCFAD. The final virus 94 95 concentration before heat inactivation was calculated at 6.3 log₁₀EID₅₀. Tubes were then placed on ice to cool down their contents. The contents of three of the four tubes were 96 97 inoculated through the allantoic route into 9-days-old embryonated specific-pathogen-98 free (SPF) chicken eggs (ECEs) following the standard protocol described in the Manual 99 of Diagnostic Tests and Vaccines for Terrestrial Animals (World Organisation for Animal 100 Health. 2023)(n = 5 eqgs/tube and 200 μ L per eqg) and incubated at 37°C. The fourth tube (replicate 4) was serially diluted (10-fold) and inoculated into ECEs (n = 5 101 102 eggs/dilution) to determine the log reduction of the virus following treatment at 63°C for 103 30 minutes. Allantoic fluid was collected from each dead or live embryo during the first 104 and second passages in ECEs and checked by hemagglutination assay using the 105 standard protocol described above (World Organisation for Animal Health. 2023) to 106 confirm the presence of infectious avian influenza viruses. The temperature of three 107 non-spiked milk samples heated at 63°C and kept on ice were recorded every minute 108 until reaching 4°C.

109 2.2. Heat inactivation at 72°C for 15 seconds

110 The temperature combination of 72°C for 15 seconds represents a high temperature 111 short time (HTST) pasteurization treatment commonly used in commercial dairy 112 processing plants. This heat inactivation experiment was conducted in two independent 113 trials conducted on different days. The raw milk was treated with the antibiotic cocktails 114 as described above. The heating of raw milk to attain an internal temperature 72°C was 115 conducted in a heating block (Eppendorf Thermomixer model R) and the temperature 116 was monitored using an electronic temperature probe inserted into two tubes containing 117 raw milk samples (temperature control) when the first and last experimental samples 118 were spiked and heat-treated. The heating block temperature was increased to 76°C to 119 attain internal milk temperature of 72°C based on the Applied Biosystems Thermal 120 Cycler Temperature Verification System reading. Ten microliters (10 µL) of virus were 121 spiked into the raw milk when the internal temperature of the milk reached 72°C and 122 after 15 seconds of incubation, the lid of the Eppendorf tube was recapped and placed 123 on ice to cool. This procedure was performed to remove possible impact of the 124 temperature ramp up, which would not be experienced in a commercial pasteurization 125 process where nearly instantaneous changes in temperature are experienced by fluid 126 milk passing through small diameter tubing or pipe. The procedure of spiking of the 127 virus into the raw milk, amount and concentration of virus and ECE inoculation procedures were the same for the 63°C for 30 minutes treatment protocol. All four 128 129 tubes in each trial were then tested in embryonated ECE as described above.

The gradual temperature decline on ice was recorded in three non-spiked milk samplestreated as mentioned above.

132 **3. Results**

133 The allantoic fluids from dead and live chicken embryos were collected separately (without pooling) at the end of the 1st and 2nd passages and were individually checked 134 135 for HA activity. Complete H5N1 virus inactivation was achieved in all milk samples (four 136 replicates) treated at 63°C for 30 minutes. No HA activity was detected in any of the allantoic fluid harvested from live embryonated eggs during the first and second 137 138 passages. Moreover, allantoic fluid collected from embryonated eggs that died of non-139 specific causes (likely from injections of 200 µL milk) was negative for any HA activity. In 140 addition, complete viral inactivation was achieved in 7 out of 8 replicates treated at 72°C 141 for 15 seconds and no infectious virus was recovered in ECE in either passage. A 4.56 142 log reduction in virus titers was achieved in the eighth replicate. We observed that milk 143 treated at 72°C for 15 seconds underwent progressive temperature decline (Figure 1) 144 when kept on ice, mimicking the pasteurization and chilling processes in the processing 145 plants. Within one minute on ice, milk treated at 72°C dropped to 56°C and after 5 146 minutes, the temperature reached 25°C (Figure 1). A similar temperature decline trend 147 was observed for the milk treated at 63°C. Therefore, we can conclude that 148 pasteurization of milk at the two standard heat treatments used by industry can 149 effectively inactivate clade 2.3.4.4b H5N1 viruses in raw milk that may have incoming 150 viral titres of approximately 4.5 and 6 \log_{10} EID₅₀.

151 **4. Discussion**

The spillover and transmission of HPAI A(H5N1) clade 2.3.4.4b virus to dairy cows in the USA and the regular detection of infectious virus in raw milk obtained from infected cows point to the potential risk of human exposure to the virus as a result of the handling or ingestion of raw milk and dairy products. Since spring of 2024, various

regulatory agencies in the US and Canada have tested retailed pasteurized milk samples for the presence of HPAI H5N1 viruses and evaluated the associated health risks. Studies in the USA have shown the presence of H5N1 virus genetic fragments often in significant concentrations in pasteurized retail milk samples, however, follow up tests failed to detect any infectious H5N1 virus (FDA.). This prompted public health officials to declare that consumption of pasteurized retail milk was safe (FDA.).

162 While the knowledge of general viral behaviour for influenza A viruses, and previous 163 data (Chmielewski, et al. 2011, Swayne and Beck. 2004, Pitino, et al. 2021) allows for a 164 sound extrapolation that pasteurization would likely be effective to inactivate HPAI clade 165 2.3.4.4b H5N1 virus in milk from dairy cows, the detection of this virus in this species and matrix is a new phenomenon. As we did not have access to any milk or milk 166 products from dairy cows naturally infected with HPAI virus, we conducted an 167 168 independent study by inoculating H5N1 virus into milk samples to evaluate the 169 efficiency of standard pasteurization treatments in Canada in inactivation of H5N1 virus. 170 Although we used a benchtop method for heat inactivation, the pasteurization, and 171 cooling steps performed simulate the commercial pasteurization process, which was tested in the recent H5N1 inactivation study using a modified continuous flow 172 173 pasteurizer method (Spackman, et al.)

We observed that heat treatment at 63°C for 30 minutes effectively inactivates H5N1 virus present in the milk, as supported by all recent published literature (Cui, et al. 2024, Schafers, et al. 2024, Kaiser, et al. 2024, Guan, et al. 2024). The combination of inoculation of ECEs and confirmation of live viruses using the HA assay is considered the most sensitive method of detection for this virus, compared to cell culture assays.

Thus, we can conclude that the standard vat pasteurization at 63°C for 30 minutes
guarantees virus inactivation and food safety.

Heat treatment of milk samples inoculated with H5N1 viruses at 72°C for 15 seconds 181 resulted in complete virus inactivation in 7 out of 8 replicates and a significant reduction 182 183 of infectious virus in the remaining replicate. This finding is consistent with recent reports where residual levels of infective viruses were detected in naturally 184 contaminated milk upon treatment at 72°C for 15 seconds (Guan, et al. 2024, Kaiser, et 185 186 al. 2024). Two other recent studies assessing the effectiveness of milk pasteurization to 187 inactivate influenza virus found that treatment at 72°C for 15 seconds was effective in 188 fully eliminating infectivity below the limit of detection (Schafers, et al. 2024, Cui, et al. 2024). In one of the two studies, the total volume of inoculated milk for each treatment 189 was only 10 µL, which is a small volume compared to the present study (Cui, et al. 190 191 2024). Together, these existing published reports of heat inactivation of influenza 192 viruses in milk employed PCR thermocyclers and relatively smaller milk volume.

193 A final point of comparison relates to the speed of temperature changes for treated 194 samples in order to best mimic real-life scenarios. In the PCR thermocyclers heating 195 and cooling setup, milk treated at 72°C can instantly cool within seconds (Cui, et al. 196 2024). In our heat treatment and chilling protocols, we sought to mimic the refrigeration 197 processes of pasteurized milk in dairy processing plants, creating a gradual decline in 198 milk temperature during refrigeration which may still inactivate residual H5N1 viruses. In 199 the modified continuous flow pasteurizer study to examine the effectiveness of HTST 200 inactivation method, the H5N1 inoculated milk was preheated at 40°C. An additional 201 heating for 9 seconds at 72°C before a HTST pasteurization could have an additive

effect on virus inactivation (Spackman, et al. 2024). Herein we observed complete inactivation of H5N1 virus in 7 out of 8 replicates at 72°C for 15 seconds, and 4.56 log reduction in one of the replicates, which is one log greater than the mean quantity of infectious virus detected in raw milk from bulk storage tank of naturally contaminated samples (Spackman, et al. 2024).

207 The experimental studies conducted by inoculating known concentrations of viruses into milk do not fully reflect the actual commercial milk pasteurization and refrigeration 208 209 processes, yet experiments which simulate pasteurization and gradual chilling steps do 210 provide valuable evidence that H5N1 viruses can be effectively inactivated. Although 211 there is no evidence of foodborne transmission of HPAI H5N1 virus to humans, our data 212 suggest that the pasteurization of milk could effectively mitigate the risk of human 213 exposure to live virus, and subsequent infections should the foodborne route be proven. 214 Also, a longer treatment at low temperature scheme is a more effective method of H5N1 215 inactivation in dairy products during unprecedented large scale HPAI outbreaks in dairy 216 COWS.
