21 Abstract

22 Anxiety is highly prevalent among college communities, with significant numbers of students, 23 faculty, and staff experiencing severe anxiety symptoms. Despite this high prevalence, many 24 individuals remain untreated due to barriers such as time, stigma, waitlists, and cost of services. 25 Digital mental health interventions (DMHIs), including Cognitive Bias Modification for 26 Interpretation (CBM-I), offer promising solutions to enhance access to mental health care, yet 27 there is a critical need to evaluate user experience and acceptability of DMHIs. This study used 28 a mixed methods approach to gather feedback from users of the first trial of a mobile application 29 called "Hoos Think Calmly" (HTC), which offers brief CBM-I training to reduce negative 30 interpretations and increase flexible thinking in response to stressors commonly experienced by 31 students, faculty, and staff at a large public university. Following the parent trial 32 (https://osf.io/36grh/) gualitative data was collected through semi-structured interviews from a 33 subset of participants (n=22). Thematic analysis revealed five main themes: Effectiveness of the 34 Training Program; Feedback on Training Sessions; Barriers to Using the App; Use Patterns; 35 and Suggestions for Improvement. Feedback highlighted the importance of greater content 36 relatability and personalization, while also identifying forgetfulness and not understanding the 37 intervention format or rationale as barriers to using the program. Participants tended to use the 38 program at routine or scheduled times rather than during specific moments of stress or anxiety 39 and relied heavily on the app's notification system. Suggestions for improvement focused on 40 incorporating progress tracking, offering greater customization options, and integrating more 41 diverse training content. Additionally, biweekly user experience questionnaires sent to all 42 participants in the active treatment condition (n=134) during the parent trial showed most 43 participants reported the program to be slightly to somewhat helpful in reducing or managing 44 their anxiety or stress. Findings highlight the importance of understanding users' experience and 45 iterative DMHI development.

46 Author Summary

47 Effective digital mental health interventions can help address the high levels of reported anxiety 48 in college communities. These interventions can be used to reduce the barriers to accessing 49 mental health services and promote flexible thinking to reduce the harmful impacts of anxiety. 50 Despite evidence supporting the effectiveness of various DMHIs, their impact is often hindered 51 by high attrition rates alongside low engagement. In this study, we gathered mixed-methods 52 feedback data on a new DMHI called Hoos Think Calmly to assess individual user experiences 53 that may impact engagement. Our goal is to better understand participants' evaluation of HTC 54 and to gather feedback on how to enhance acceptability of the program in future iterations. Data 55 was collected through feedback interviews and user experience questionnaires. We found that 56 participants perceived HTC to be somewhat effective at reducing or managing their anxiety, but 57 also noted barriers to ongoing use. Our study provides helpful insights into app use patterns, 58 barriers to engagement, and general suggestions for improving DMHIs.

59 Introduction

60 Background

61 Anxiety disorders are highly prevalent among college communities. A 2023 study indicated that 62 41.8% of college students and 38.6% of faculty and staff had experienced symptoms consistent 63 with severe or extremely severe anxiety over the past week [1]. Despite these alarmingly high 64 rates, many individuals in need of mental health services remain untreated [2]. Some of the 65 most common barriers to receiving mental health services among college students are access, 66 time, and stigma. Accessibility barriers specifically include lengthy weight times, the cost of 67 services, and perceived lack of options [3,4]. Similarly, university faculty reported stigma and 68 lack of support as their main barriers to receiving mental health care [5]. In light of these barriers, there has been increased interest in digital mental health interventions 69 70 (DMHIs). DMHIs provide mental health support via technologies like web-based or mobile

71 platforms and have the potential to expand treatment delivery options and enhance access to 72 mental health care [6]. Studies show DMHIs may be particularly effective at reducing 73 depression, anxiety, and stress outcomes in academic settings [7,8]. 74 The use of Cognitive Bias Modification for Interpretation (CBM-I) is a mechanistic intervention 75 that may be an effective component of treatment for anxiety [9-11], given extensive research 76 showing that selective threat interpretations are common among individuals high in anxiety [12]. 77 CBM-I is a type of training designed to modify threat-focused cognitive biases related to 78 interpretation processes (i.e., assigning threatening meanings to ambiguous situations). CBM-I 79 training typically involves presenting participants with ambiguous scenarios or stimuli and 80 encouraging them to interpret them in a more positive or benign manner. Through repeated 81 practice and reinforcement, the aim is to help individuals develop more flexible patterns of 82 interpretation that are not so rigidly negative, which is expected to then reduce anxiety. 83 Although there is evidence supporting the effectiveness of various DMHIs, such as online CBM-I 84 training (including at our team's MindTrails website; [13-15]), their impact is hindered by high 85 attrition rates alongside low engagement [16-18]. Better ways to overcome these common 86 limitations of DMHIs need to be better understood. A 2021 review found that participants' 87 engagement with DMHIs increased when users found the content appealing, perceived the 88 program to be a good fit, and experienced perceived changes in their mental health [19]. Thus, 89 we need to understand what makes content appealing and a good fit to users. Research on 90 DMHIs tends to rely on quantitative metrics to evaluate outcomes, which are very valuable but 91 limited in their ability to contextualize data and assess individual user experiences that may 92 impact engagement. This points to the value of also using gualitative approaches to help 93 design, evaluate and improve DMHIs [20-22]. For instance, gualitative methods can be used 94 during the post-trial phase of pilot studies to gain insight into users' acceptance of and feedback 95 on DMHIs [23]. This feedback can be especially valuable to guide improvements for future 96 versions of a DMHI.

97 **Objective**

- 98 The objective of this study is to collect feedback from participants in the first trial of a mobile
- 99 application called "Hoos Think Calmly" (HTC) to evaluate acceptability and gain a deeper
- 100 understanding of their experiences and suggestions for improvement. HTC is designed to
- 101 increase flexible thinking in response to stressors commonly experienced by students, faculty,
- 102 and staff at a large public university through brief ~5 minute interventions (microdoses) of CBM-I
- 103 training delivered by mobile phone to university community members. Study design and
- analysis plans were preregistered on Open Science Framework [24].

105 Methods

106 Ethics approval and consent to participate

- 107 This study was approved by the Institutional Review Board for Social and Behavioral Sciences
- 108 (IRB-SBS) at the University of Virginia. All participants provided written informed consent via an

109 electronic consent form prior to enrollment and participation.

110 Strategies to understand and mitigate bias: Reflexivity and credibility

- Our team acknowledges that we bring biases in favor of HTC, having grants that fund the
 program and prior tests of the parent program MindTrails that demonstrated efficacy in reducing
 anxiety [13-15]. It is likely that these factors may predispose us towards interpreting the current
- 114 findings more positively.

To bolster methodological integrity, we employed several credibility strategies. Two of the initial coders on the research team were individuals not involved in the data collection process to help mitigate biases and allow for fresh perspectives [25]. Likewise, we established an intercoder reliability score exceeding 0.80 on a subset of interviews before proceeding with general coding to increase coding consistency. Throughout the analysis, the lead author attended a recurring journal club focused on best practices in qualitative research. During this time, the lead author also spent time examining personal judgements and beliefs to better understand how biases

might influence the research process and outcomes. We encouraged peer examination, and
colleagues were asked to give feedback on our research methodology and procedures. An audit
trail was kept of all edits made to the codebook throughout the analysis process to help
establish confirmability and trustworthiness of data [see 26]. This study was reported using the
Standards for Reporting Qualitative Research (SRQR) guidelines [27] (S1 Text).

127 Intervention

128 In the parent randomized control trial (RCT), n=134 participants assigned to the active treatment 129 condition were notified to complete two microdose sessions per day over a 6-week period. Prior 130 to beginning a microdose session, participants completed a pre-intervention survey in which 131 they reported their current mood (and completed a very brief imaginal exercise depending on 132 their anxiety level) and selected a specific stressor domain for targeted training. Domain options 133 included academics/work/career development, social situations, romantic relationships, 134 finances, physical health, mental health, family and home life, and discrimination. The content of 135 the training scenarios was modified to match common situations encountered for the different 136 groups (e.g., to capture fears of negative evaluation, the undergraduate group would read about 137 giving a class presentation while the staff would read about presenting at a staff meeting). Post-138 intervention surveys were also administered to assess changes in mood and provide additional 139 resources and tips for emotion regulation and application of the CBM-I learning to daily life. At 140 the end of the day, participants were instructed to complete a nightly survey inquiring about their 141 mood and ability to think flexibly throughout the day. During this survey, participants had the 142 option to pre-select notification times for the next day's microdose sessions. 143 A microdose session consisted of ~ 5 minutes of CBM-I training that aimed to reduce rigidly 144 negative thinking patterns associated with anxiety. Training scenarios could consist of 10 CBM-I 145 short scenarios (this occurred in the majority of sessions), or 1 long scenario, or 1 write-your-

146 own scenario (except for the Discrimination domain, which did not include CBM-I; see 26). The

147 variation was included to reduce repetitiveness and to introduce different tasks to increase

148 flexible thinking and the personal relevance of training. A short scenario was typically three 149 sentences in length and consisted of an emotionally ambiguous story that raised a potential 150 threat but was then resolved when the user completed the final word in the last sentence. The 151 emotional resolution was reinforced through a subsequent comprehension question (see Figure 1). A long scenario was the same as a short scenario except it also included a range of 152 153 thoughts, feelings, or behaviors that could occur in a particular situation to help with seeing 154 multiple different perspectives. Users were then prompted to write down their own thoughts that 155 could be helpful in that situation. The write-your-own scenario invited participants to craft their 156 own short CBM-I scenario based on a personally relevant anxiety-inducing situation. Users were then tasked with resolving the scenario in a positive or non-threatening way and coming up with 157 158 reasons for why the chosen resolutions could be likely to occur. Figure 1 displays a screenshot 159 of the app's homepage, domain selection page, and a short scenario example. More details on 160 the intervention are available via Open Science Framework [28, 29].

163 Study Procedures and Data Collection

164 This study used quantitative and qualitative approaches to understand user experience and 165 acceptability of the HTC mobile health (mHealth) platform. Data was collected via 166 questionnaires and semi-structured interviews. Four biweekly user experience questionnaires 167 were administered to all participants assigned to the treatment condition throughout their study 168 participation. The first three questionnaires were administered every two weeks during the 6-169 week study period, and the final questionnaire was administered at the 8-week mark as a post-170 study follow-up. In addition to survey questionnaires, a subset of participants who took part in 171 the 6-week pilot RCT to test the HTC mobile application were selected to participate in a user 172 feedback interview. The selection process involved purposive sampling based on group 173 assignment, study progress, and time passed since enrollment. Participants who were assigned 174 to the treatment condition and had completed at least 3 microdose sessions were randomly 175 selected to participate in a feedback interview. 176 The interview selection process was initiated by inviting participants with the closest study 177 enrollment date to the time of recruitment and moving backwards until our target accrual 178 number was met. We aimed to complete approximately 20 interviews based on norms in the 179 literature for papers with similar goals [30, 20] and also due to practical considerations. A total of 180 89 interview invites were sent to faculty members, staff members, graduate students, and 181 undergraduate students, and 22 interviews were completed using a semi-structured interview 182 guide (S2 Text). Participant characteristics are provided in Table 1.

193 Analysis

194 Following our pre-registration [21], interview data was analyzed using thematic analysis as

195 outlined by Braun and Clarke [31]. All interviews were transcribed using Descript audio

196 transcription service [32]. Each transcript was then checked against the original audio recording

197 by a member of our research team. This was for the purpose of ensuring transcription accuracy

and enhancing team familiarity with the data. During transcript review, team members noted

199 initial themes found in the data.

200 After all interview transcripts had been reviewed, preliminary codes were discussed, and an

201 initial codebook was created. We then used an iterative coding process, allowing for continual

addition or deletion of codes to align with our data. To most effectively capture context and

203 meaning, text was coded at the "level of meaning", allowing a code to encapsulate a line,

sentence, or paragraph [33]. Interviews were coded using Delve qualitative data analysis

software [34]. Four coders were trained by conducting inter-coder reliability (ICR) tests. Inter-

206 coder reliability was measured using Krippendorff's alpha, a measure of reliability in content 207 analysis [35]. We underwent six rounds of ICR testing and reached an ICR rating of 0.83. Each 208 round of testing involved independent coding of the same transcript by each coder, followed by 209 comparison and discussion of coding differences. Transcripts from different participant groups 210 (faculty, staff, graduate, and undergraduate) were selected for each round of ICR testing to 211 ensure representation of the entire data set [36]. Changes were made to the codebook 212 throughout this process. Each codebook iteration, including the final version, can be found on 213 Open Science Framework [37]. After an inter-coder reliability score greater than 0.80 had been 214 established, official coding of the transcripts commenced. Due to prolonged ICR training, only 215 two of the four trained coders were available for the official coding process. Given time 216 constraints and the high ICR rating, deviations were made to the preregistration, with each 217 transcript being coded by one of the two remaining coders instead of undergoing double coding. 218 Weekly meetings were held to address coding challenges and refine the codebook. The lead 219 author served as a moderator to help resolve disputes or provide clarification on coding issues. 220 Thematic saturation was attained after analyzing 15 transcripts and was determined when no 221 additional codes could be added to the codebook [38]. The final codebook consisted of 47 main 222 codes (not including sub-codes) that were grouped into 10 themes. An initial thematic map was 223 created to visualize the codes and their relationships. Of those 46 codes, 13 appeared in 50% 224 or more interviews. A revised thematic map was created using the 13 most saturated codes, 225 and 5 main themes were assigned (S1 Fig.). The full list of codes and definitions can be found 226 in the codebook. Survey data was analyzed using descriptive statistics, including frequency 227 counts and percentages.

228 **Results**

The results are categorized based on the 5 themes found in Table 2, along with examples of deidentified illustrative quotes. Considering the primary research goal for this paper was

- 231 learning users' impressions and suggestions from the qualitative feedback, and the survey data
- 232 was included for triangulation purposes, we decided prior to the quantitative analyses to only
- examine those survey questions that aligned with the qualitative themes. Survey data are
- reported in Table 3.

242 Theme 1: Effectiveness of Training Program

243 Application of New Coping Strategies

Of the interview participants, 50% (11/22) expressed an ability to effectively apply new coping

strategies (e.g. flexible thinking) that they learned from the program to their real-life situations.

246 There was this scenario that is about the advisor frowning in front of you and that

247 *instinctively made me think that I did something wrong or what I said is something*

stupid, but the answer was that people frown when they think about something, and that

248

249	scenario really helped me to think differently when I present my work in front of other
250	people or in front of advisors. [Grad 13]
251	Perceived Changes in Stress or Anxiety
252	In addition, 64% (14/22) of interview participants discussed the program's impact on their stress
253	or anxiety. The majority of those participants (8/14, 62%) expressed an overall positive change
254	in symptoms, stating a reduction in their stress or anxiety levels.
255	It [the program] definitely did helpI immediately go to the worst case scenario, so I
256	thought it helped like in the heat of the moment for me to redirect my train of thought to
257	somewhere that's more productive and less doomsday. [Undergrad 35]
258	Some of those participants (5/14, 38%) reported no change to their stress or anxiety while using
259	the app.
260	This just didn't do anything for me. It just added another thing in my day that I had to
261	think about and take care of that didn't feel like it was giving me anything back.
262	[Undergrad 39]
263	Additionally, two participants (2/14, 14%) expressed a negative change in symptoms, reporting
264	an increase in their stress or anxiety levels from use of the app.
265	Some [scenarios] seemed to cause me to worry more about things. Like I understand
266	that it's like guiding you through stressful situations and it's not always gonna have a
267	positive outcome for everything, but some of them were a little bit like, Ooh, that's kind of
268	scary to think about. [Undergrad 28]
269	It is worth noting that one participant reported experiencing both positive and negative changes
270	in their stress or anxiety levels. Therefore, there are a total of 15 responses indicating positive,
271	negative, or no change, out of the 14 participants who commented on the program's impact.
272	Additionally, a survey questionnaire was sent to all participants at the 2nd, 4th, 6th, and 8th
273	week marks of their study participation to assess the effectiveness of the HTC program in

- 274 reducing their anxiety. A total of 225 responses were received (participants submitted
- 275 responses on multiple occasions, hence the greater number of responses than participants),
- with the most common response (97/225, 43%) being that HTC was somewhat helpful at
- 277 reducing their anxiety (see Table 3).
- 278 Theme 2: Feedback on Training Sessions

279 Relatability

- 280 Out of the 22 interview participants, 95% (21/22) discussed the relatability of the training
- scenarios. Among those 21 participants, approximately half (11/21, 52%) noted that the training
- scenarios resonated with their own experiences and feelings.
- 283 I thought they were really [applicable], and sometimes I would even laugh because they
- 284 would be so accurate that I'm like, yeah, I went through that like last week or so. [Grad
- 285 49]
- 286 And I thought especially for academics, the situation or the stories that were there were
- 287 quite relatable. Like I thought, yeah, this is exactly what I'm feeling right now or what I'm
 288 stressed about right now. [Grad 35]
- Two thirds of participants (14/21, 67%) indicated that they sometimes did not find the trainingscenarios relatable.
- 291 I felt like the demographic was younger than I am. It was a lot of you've got a new baby,
- 292 you've got a young child, or you've got parents who disapprove of what you're doing. My
- 293 parents are dead. This is not a thing I'm thinking about now... It just tended to not be
- 294 applicable to me. [Faculty 8]
- 295 There were times where I thought, oh, this doesn't relate to me at all, and why am I
- 296 taking time to do this? [Staff 39]

297 Notably, 4 participants mentioned finding the training scenarios to be relatable at times while not 298 at others, accounting for the 25 responses among the 21 participants. Additionally, it is worth 299 mentioning that all 3 faculty interview participants found the training scenarios to be unrelatable. 300 Similar trends were observed in the user experience questionnaire. Participants were asked to 301 evaluate the relatability of the stories as well as the believability of the stories' endings at the 302 2nd, 4th, and 6th week marks of their study participation, resulting in a total of 209 responses. 303 The majority of participants provided responses within moderate ranges for both questions, with 304 36% (76/209) finding the stories somewhat relatable and 32% (67/209) finding the endings 305 somewhat believable (see Table 3). On average, faculty members tended to rate the scenarios 306 as less relatable and the endings as less believable compared to the other participants. 307 Repetitiveness 308 Among the interview participants, 54% (12/22) found the training sessions to be repetitive. In 309 certain aspects, repetition was intentionally incorporated into HTC as a way to give users 310 repeated practice in thinking more flexibly and exposure to different scenarios. However, some 311 found the repetitive writing style of the scenarios resulted in predictable outcomes, reducing the 312 effectiveness of the training sessions. 313 But at some point it just became very repetitive and instead of getting something out of 314 it, I just saw a pattern and how to fix it. [Undergrad 46] 315 Others experienced boredom due to the repetition of similar stories and themes. 316 There were only so many scenarios or stories. And even though they were still very 317 much applicable to my life, I could anticipate what those stories were gonna be and I just 318 got bored. [Grad 35] 319 Length 320 Of the interview participants, 82% (18/22) commented on the length of the training sessions. 321 Each microdose session consisted of 10 CBM-I scenarios, along with pre-and post- intervention

322	questionnaires. Researchers estimated that completing one microdose session would require
323	roughly 5-10 minutes. Among the 18 participants that discussed session length, the majority
324	(13/18, 72%) found the training sessions to be an appropriate length, although some expressed
325	a preference for shorter sessions on occasion.
326	I would've liked for it to be shorter, but at the same time I can understand that the longer
327	you're thinking about it, the more realistically and detailed you can imagine your
328	situation. And with this topic, you really kind of should be spending a little bit more time
329	on it than you want to. So I think it was an appropriate length, even though at times it
330	was not fun. [Staff 41]
331	I thought they were a good length because I didn't have to worry about starting one and
332	not being able to finish it. [Undergrad 35]
333	However, 28% (5/18) of participants that discussed length considered them too long, potentially
334	impacting engagement.
335	The session was just a bit long and I think maybe that was one reason that kept me from
336	doing it as often. I just dreaded doing it because maybe it was too long. [Grad 26]
337	For comparison/triangulation, a survey question regarding session length was administered to
338	all participants during their 2nd week of study participation. Participants were asked how they
339	felt about the session length and 92 responses were received with 50% (46/92) of participants
340	indicating that the sessions were of the right length and 45% (41/92) of participants indicating
341	that the sessions were too long (see Table 3).
342	Write-your-own
343	Of the interview participants, 64% (14/22) of interview participants provided feedback on the
344	write-your-own scenario prompt. Some participants enjoyed the write-your-own scenario
345	because it gave them a chance to apply their learning to real life situations.
346	I think that was my favorite part because it kind of forced me to think a little more deeply
347	about the modules I was doing rather than just answering the questions. [Undergrad 35]

348	Conversely, others found the write-your-own scenario to be frustrating because it took too long
349	or felt redundant. Additionally, concerns about privacy surfaced, particularly among faculty and
350	staff members, regarding inputting personal stories into the app.

- 351 Crafting my own stories just irritated me...the homework aspect of it felt icky. But then
- 352 also I didn't really want to because this is where I work. I didn't want to put scenarios in
- 353 there...I think the exercise of thinking through my own scenarios would've been helpful
- 354 *if it wasn't writing them into the app.* [Staff 39]
- 355 Theme 3: Barriers to Using the App

356 Lack of Understanding of Intervention Format or Rationale

357 Among the interview participants, 55% (12/22) expressed a lack of understanding of how to

engage with the training sessions or the purpose of the intervention. Participants were given the

359 flexibility to choose when and how many training sessions they completed on a given day,

360 although it was recommended that they complete at least 2 microdose sessions. However,

361 some participants found the structure of the app and study expectations to be ambiguous.

362 Similarly, some participants were confused about the nature of the CBM-I training and did not

understand the purpose of the tasks they were being asked to complete or how to engage withthe stories.

365 And at least at the beginning of the study I was like, what am I required to do? What are 366 the tasks for today? [Grad 52]

367 And so the very first survey, which was kind of longer, I thought, wait, is this like a

368 reading comprehension survey? Like I really didn't know what it was. And so I would

- 369 read the scenario and then it would say essentially, what do you think would be
- 370 happening next? And I'm like, I don't know. [Faculty 8]

371	After each training scenario, participants were asked questions about the story and were
372	supposed to answer based only on information given in the scenario. The purpose of this was to
373	practice thinking in new ways about different situations. However, some participants found it
374	unclear whether they were expected to answer questions based on information given in the
375	story or based on their current experiences. This lack of understanding led some to feel
376	confused when their answers were marked as incorrect.
377	I just do not understand why it would say wrong when both of them [answer choices]
378	could be logical, and even sometimes I chose one that seemed like the thing that I would
379	make happen or that was happening in my life, and it'd be wrongwhy am I being told
380	I'm wrong? [Faculty 1]
381	Forgetfulness
382	Of the interview participants, 55% (12/22) cited forgetfulness as a reason for not using the app.
383	I would usually just forgetI'm like already stressed out and then I'd scroll past it [the
384	app], and I'm like, oh my god, I've forgotten to do that. [Undergrad 25]
385	Although the app did send push notifications, some participants encountered issues receiving
386	notifications, which contributed to forgetfulness.
387	If I don't get the notification on my phone and if I'm out, I'm not going to remember this.
388	[Grad 31]
389	Some participants who mentioned not using the app due to forgetfulness expressed a
390	preference for different types of notifications, such as calendar reminders rather than push
391	notifications.
392	It would've been better and more useful if it [reminders] would just populate [in my phone
393	calendar] because I live or die by what's in my calendar. And if it's not on my calendar, I
394	forget because there's just so much that's going on all day long. [Staff 39]

395 Theme 4: Use Patterns

396 Used Routinely

- 397 Of the interview participants, 68% (15/22) used the app as part of their daily routine. These
- individuals found it most helpful to stick to a consistent schedule of using the app at the same
- time every day, rather than varying the time day by day or using the app specifically during
- 400 moments of stress or anxiety.
- 401 I mostly did it at the same time each day just because of how my schedule works.
- 402 [Faculty 8]
- 403 I would do it in the morning, and then right before I went to bed. I don't really remember
- 404 doing it specifically if I was super anxious about something [Grad 41]
- 405 Used When Reminded
- 406 Similarly, 50% (11/22) of interview participants used the app because they received a
- 407 notification or reminder.
- 408 I also liked that the app would send reminders, like you could set the time for every day
- 409 that it would send reminders and as someone who also has been diagnosed with ADHD,
- 410 like that's the only way I can get work done is if I have reminders. [Grad 35]
- 411 I liked the feature where you could set a reminder to do them [training sessions] because
- 412 that was like how I remembered to do it most days. [Undergrad 28]
- 413 Chosen Academics/Work/Career Development Domain
- 414 Participants also shared which stressor domain they used most often. Of the 8 domains to
- 415 choose from, 82% (18/22) of interview participants stated they found the academics/work/career
- 416 domain to be most important.
- 417 I feel like I chose the work one most of the time because that is honestly where most of
- 418 my anxiety comes from. [Staff 45]

- 419 I tried to hit them all [domains], but the biggest source of stress in my life did happen to
 420 be graduate school...And so the graduate school one is definitely where I focused. [Grad
- 421 11]
- 422 Theme 5: Suggestions for Improvement

423 Feature Suggestions

Of the interview participants, 86% (19/22) suggested additional features to improve the apps
functionality or enhance engagement. Among those participants, some suggested a progress
tracking feature that would allow them to view their pending and completed tasks.

- 427 If you want people to take three surveys a day or something, you can show like a little
- 428 Domino's pizza loading bar and be like, you've already done 33%, you have two more
- 429 *left.* Or like a checkbox or something for people to tangibly be like, yeah, I did this. [Staff
- 430 41]

431 One thing that I just kind of thought of is I used the Duo Lingo app to help me to practice

432 my French, and it tells me how well I've done recently. And if I have a streak of days in a

433 row, it lets me know, hey, you've got this many days in a row. And it wasn't always clear

434 to be able to see what my activity [in the HTC app] had been recently. [Faculty 4]

435 Others focused more on enhancing the customization and personalization of the app through

tailored scenario content, adjustable training lengths, and flexible notifications. For example,

437 some participants noted that certain scenario content was not relatable to their specific life

438 stage.

I don't know if you can collect some sort of information on the individual who's taking it,
but a lot of times, it [the scenarios] would be something like, you're going on a Tinder
date, and I'm married with two kids. That's pretty hard for me to imagine. [Staff 41]
Consequently, these participants often suggested personalizing the content by filtering
scenarios specific to their demographic to enhance relevance.

- 444 If there was some way to like screen participants and tailor the questions, I don't know,
- 445 but if it was tailored to something that was more relatable to each participant, I feel like
- 446 they could get more out of this program. [Undergrad 46]
- 447 Additionally, some expressed a desire to customize the length of the training sessions.
- 448 I hoped it was longer when I had a bad day. And I hoped it was shorter when I was
- 449 having a busy day. Maybe it can be helpful if I can adjust the length. [Grad 13]
- 450 Lastly, some participants suggested enhancing the notification system and expressed wanting
- 451 more customizable notification preferences, including frequency and delivery method.
- 452 I wish that just the average number of notifications was a little lower. And maybe people
- 453 can opt into more or opt out of more. [Faculty 4]
- 454 Maybe something that should be integrated is emails along with the notifications...if
- 455 you're on your computer and not on your phone, maybe the different notifications would

456 *help.* [Grad 41]

457 **Domain Suggestions**

458 Finally, 73% (16/22) of interview participants suggested additional domains or ways to improve 459 the existing ones. Of those 16 participants, 4 (25%) provided specific suggestions to improve 460 the discrimination domain. The discrimination domain differed from the other 7 domains in that it 461 did not provide specific scenarios for CBM-I training. Instead, it provided tools and resources 462 for: 1) reporting discrimination or harassment, 2) self-care and wellness, 3) allyship (supporting 463 others who have experienced discrimination, marginalization, or harassment), 4) community 464 support, and 5) activism. Some participants appreciated how this domain was set up, while 465 others mentioned wishing that this domain offered CBM-I training, similar to the other domains. 466 I think I clicked on the discrimination topic one time...but it just brought me straight to 467 links for like resources. So I think expanding that topic could be good because with more 468 and more DEI conversations and stuff like that, people get really uncomfortable talking 469 about it. So I think having something more in that area, like the resources were good and

470 I'm grateful that they were there, but I think having something similar where you could
471 kind of work out your ideas there too. [Staff 41]

- 472 But if I click that category, then it shows that there's like this, this, and this kind of
- 473 resource, rather than showing up the scenarios like it did for the other categories, and I
- 474 felt that a little unhelpful...for instance, I always struggle to think that my English is not a
- 475 problem, and that's also true, but like sometimes when I speak some wrong sentences, I
- become very small and start to be very conscious about that. But people around me are
- 477 more likely to be friendly and do not really care about that. So I hope there was some
- 478 scenarios that helped me think that like all of their reactions are not really a
- 479 discrimination. I don't, I know it can be very tricky, like it can be the app justifying there's

480 no discrimination, but still I want something that can help or support mentally. [Grad 13]

- 481 Others suggested additional resources and tools within the discrimination domain that they
- 482 wished were provided. This included adding resources specific to political and religious
- 483 discrimination.
- 484 The discrimination that I faced that made me go on was political discrimination...So I
- 485 went on there to see if I could get any help with that. But the resources I don't think were
- 486 really applicable to me in that sense. [Grad 26]
- 487 I don't know if you guys had something about religion...I think that's an important aspect.
 488 Maybe that could go with the discrimination. [Grad 49]

489 Additional content recommendations were proposed for other domains. These include

- 490 incorporating more scenarios tailored to an older demographic, such as addressing anxiety
- 491 related to retirement, making friends later in life, dealing with a child's college rejection, coping
- 492 with the loss of a family member, or managing the estate of a deceased parent.
- 493 In addition to suggestions made to the existing domains, other participants provided
- 494 suggestions to add new domains, such as a domain specific to international students.

495 I don't recollect right now but I don't know if there was a separate section that was
496 directed towards international students...because there's so many international students
497 and we have like our own set of problems, which sort of loosely relate to discrimination,
498 but then also being homesick, being away from family, which weren't there. [Grad 35]

499 **Discussion**

500 This study used mixed methods to explore users' experiences with the HTC platform and collect 501 feedback on acceptability and ways to improve the app, which may also inform future designs of 502 DMHIs more broadly. Qualitative data was collected via user feedback interviews and 503 quantitative data via user experience questionnaires. Specifically, user experience questions 504 regarding the effectiveness of the training program, the relatability of the training scenarios, and 505 the length of the training sessions were analyzed to help validate and enrich the gualitative 506 results (see Table 3). Results showed that the quantitative findings aligned with the qualitative 507 data as the majority of both survey and interview participants found the program to be at least 508 slightly or somewhat helpful in reducing or managing their anxiety or stress. Similarly, both 509 survey and interview data yielded varied opinions on the relatability of the stories and found the 510 length of the training sessions to either be an appropriate length or slightly too long. Overall, 511 results supported the acceptability of the program.

512 Among those who did not perceive the HTC program as effective, there seemed to be a gap in 513 the relatability of content and alignment with needs/goals, potentially influencing their perceived 514 efficacy. For example, some participants expressed not experiencing significant stress or 515 anxiety prior to using the app, which could explain their limited observations of changes in their 516 stress levels. Given participants were not required to meet a specific anxiety threshold to join 517 the study, it is possible that other participants had similar experiences, though the mean 518 baseline OASIS score indicated significant anxiety on average (a score of 8 is typically 519 considered a clinical cutoff where most users would meet criteria for an anxiety disorder

520 diagnosis and our sample mean was ~6.5). Moreover, one participant reported having other 521 mental health conditions outside of anxiety that the app is not targeted to treat. Some 522 participants also reported a lack of comprehension regarding the intervention's purpose, and a 523 few stated they downloaded the app expecting it to be more meditative in nature. These findings 524 underscore the importance of providing a clear introduction to the program's format and 525 rationale during enrollment, allowing the user to understand the overall structure of the app and 526 determine if it is a good fit for them. However, it is important to note that HTC does provide 527 written and video explanations regarding the program rationale, learning goals, and ways to use 528 the app during the first training session. This raises questions about whether users are 529 effectively absorbing the introductory content or if changes are needed to present the program 530 overview more effectively. Further work is encouraged in this area. 531 While many users did report perceived benefits from the program, gualitative interviews were 532 conducted with an emphasis on gathering feedback for future app versions. Therefore, this 533 discussion primarily centers on suggestions to enhance future iterations of HTC and DMHIs 534 more broadly. For example, offering explicit instructions on program expectations and guidelines 535 for recommended use in multiple places may enhance user engagement, given this information 536 seems to be readily missed or skimmed. Consistent with prior qualitative research, insufficient 537 task explanations have been shown to deter users from continuing with digital health 538 interventions [39]. Therefore, it is essential to present instructions clearly, and it may help to use 539 various mediums [40]. HTC incorporates text-based and video instructions; to enhance clarity 540 regarding task expectations, our users specifically suggest implementing a daily progress 541 tracker, which could include gamification elements that might increase user motivation and 542 engagement [41] while also clarifying what tasks need to be completed each day. 543 Consistent with other studies, our findings also suggest increasing app personalization would be 544 particularly beneficial in the context of CBM-I scenario content, as some users expressed 545 dissatisfaction with the relatability of the stories [42, 43]. Given CBM-I relies on users imagining

546 themselves in various situations to promote more flexible thinking, creating more personally 547 relevant content may enhance users' ability to engage with the exercises more effectively. 548 Therefore, we suggest future research should explore increasing personalization by using 549 demographic information to filter content based on factors such as age, relationship status, and 550 occupation, or assessing the types of interactions or places where each person tends to 551 experience anxiety, or the particular unhelpful interpretations they tend to make. We would also 552 like to highlight that despite our efforts to recruit faculty members, engaging them proved 553 challenging, resulting in a small sample size for this study. However, it is worth noting that all 554 three faculty participants indicated that the study content was not relatable. Therefore, we 555 believe increasing app personalization may be especially beneficial for this demographic. 556 Along with desiring personalized training content, users also value flexibility and autonomy, 557 particularly expressing a desire for more customizable notification and content delivery options. 558 Notifications are of particular importance given a main barrier reported to engaging with the 559 HTC platform was forgetfulness. Additionally, many participants reported using the program 560 specifically when reminded and appreciated that HTC allowed them to schedule push 561 notifications at specific times. To further enhance notification customization, we recommend 562 offering users a range of delivery options such as push notifications, emails, or calendar 563 reminders. Other research has shown that sending notifications containing tailored messages 564 may increase engagement [44].

565 Similarly, some participants expressed the desire to customize content type and length. For 566 example, the HTC program provided three CBM-I training scenario types: long scenarios, short 567 scenarios, and write-your-own scenarios. Some participants reported receiving a write-your-own 568 training scenario, but not having the time or bandwidth to complete it at the moment, leading 569 them to close the app entirely. They wished for the option to skip or choose certain scenario 570 types as needed. Additionally, some participants expressed a desire to customize the length of 571 microdose sessions, stating that sometimes they wanted to complete more or fewer than 10

training scenarios in one session. Although allowing participants to customize the type and
length of training sessions may increase app engagement and user satisfaction, there is a
concern that increasing customizability of training scenario type and length may sacrifice
program effectiveness. Further work is needed to determine the best balance between
increasing training flexibility and maintaining intervention effectiveness (e.g., ensuring users
complete an adequate dose of training).

578 Last, offering more diverse training content is likely important for increasing engagement and 579 accessibility. Research indicates that repetitive training content can lead to boredom and 580 disinterest [45, 43]. Incorporating a wider variety of scenario content and formats, including 581 those suggested by users, such as scenarios relevant to international students, may improve 582 acceptability and adherence. We recommend continuing to involve users in the co-design 583 process for future iterations of HTC, particularly to develop more relevant scenarios for 584 marginalized communities. This approach ensures that the content remains engaging and 585 inclusive [46].

586 Overall, our findings suggest that HTC is viewed as somewhat acceptable and effective at 587 reducing stress and anxiety, and we provide suggestions for increasing user engagement and 588 app satisfaction across HTC and other mHealth platforms. To enhance engagement, we 589 recommend implementing a robust notification system and providing clear instructions on study 590 tasks and app use expectations through interactive modules and progress trackers. Additionally, 591 we recommend further personalizing content and increasing customizable features to boost 592 user satisfaction and adherence. Lastly, we emphasize the importance of involving users in the 593 co-design process of DMHIs to ensure content remains relevant and meaningful to the intended 594 audience.

595 Limitations

Several limitations should be considered in interpreting this interview and survey feedback. In
some cases, individual qualitative interviews of participants took place a few months after their

initial use of the intervention. This gap may have biased participants' reflections regarding their
experience with HTC or its effectiveness. To address this, future iterations of the intervention
could schedule post-treatment interviews more promptly after the completion of the program to
gather participants' more immediate impressions of the program, as well as some interviews
later to determine longer term impacts of the program.

603 Furthermore, while the sample size is consistent with related studies in the literature [20, 30], it 604 likely does not sufficiently represent the experience of all participants, especially considering the 605 potential for sampling biases among the subset of users who agreed to take part in the post-606 intervention interviews. Moreover, we did not screen users for elevated anxiety before 607 participation, so some participants did not meet a standard cutoff for clinical anxiety. This could 608 skew participants' perception of the app's effectiveness if they do not struggle with anxiety or if 609 they struggle with a different mental health condition that the app is not targeted to treat. In the 610 future, screening for individuals who are high in trait, social, or generalized anxiety could provide 611 a more appropriate sample to study the program's effectiveness (though we also value letting 612 users choose whether they believe the program is something they want and need, as we did in 613 the current study). We also did not require participants to stop other interventions while using 614 HTC; this was done to increase external validity but we do not know how the experience of 615 using HTC varies based on whether it is used on its own or as an adjunct to other forms of care. 616 Finally, while the coders had varying levels of familiarity with HTC and considered diverse 617 perspectives in the interviews, there is a possibility of reflexivity within the coding process.

618 Conclusions

We collected qualitative interview data and quantitative survey data to better understand user experiences of the HTC platform and suggestions for its improvement. Themes that appeared in over half of the interviews regarding the effectiveness of HTC included an ability to apply new coping strategies in daily life and a perceived change in anxiety levels post-treatment. The most common response indicated that HTC was somewhat helpful at reducing anxiety. There were
