29 Abstract

Identifying bacterial transmission pathways is crucial to inform strategies aimed at curbing the spread of pathogenic and antibiotic-resistant bacteria, especially in rapidly urbanizing low- and middle-income countries. In this study, we assessed bacterial strain-sharing and dissemination of antibiotic resistance across humans, domesticated poultry, canines, household soil, and drinking water in urban informal settlements in Nairobi, Kenya. We collected 321 samples from 50 households and performed Pooling Isolated Colonies-seq (PIC-seq) by sequencing pools of up to five Escherichia coli colonies per sample to capture strain diversity, strain-sharing patterns, and overlap of antibiotic-resistant genes (ARGs). Bacterial strains isolated from the household environment carried clinically relevant ARGs, reinforcing the role of the environment in antibiotic resistance dissemination. Strain-sharing rates and resistome similarities across sample types were strongly correlated within households, suggesting clonal spread of bacteria is a main driver of dissemination of ARGs in the domestic urban environment. Within households, E. coli strain-sharing was rare between humans and animals but more frequent between humans and drinking water. E. coli contamination in stored drinking water was also associated with higher strain-sharing between humans in the same household. Our study demonstrates that contaminated drinking water facilitates human to human strain sharing and water treatment can disrupt transmission.

58 Introduction

59 Bacterial enteric infections cause 9.2% of annual deaths worldwide in children under five.^{1,2} Bacterial infections can 60 trigger acute gastrointestinal illness, while asymptomatic infections are associated with child growth faltering.^{3,4} The 61 incidence and disease burden of bacterial infections are highest in rapidly urbanizing low- and middle-income 62 countries (LMICs),⁵ where over 50% of the urban population lives in informal urban settings with limited access to 63 safe drinking water, sanitation, and appropriate hygiene (WASH) infrastructure.⁶ Furthermore, in these informal urban 64 settings, families often engage in small-scale animal husbandry within confined spaces, increasing the risk of 65 zoonosis.^{7,8} The high prevalence of infectious diseases in urban informal settlements, coupled with a lack of regulated 66 antibiotic use, promotes both the emergence of new antibiotic resistance gene (ARGs) variants through the 67 proliferation of antibiotic resistant bacteria and the spread of antibiotic resistance between bacterial strains via horizontal gene transfer.^{6,9} A recent meta-analysis of fecal metagenomes from 26 countries¹⁰ identified a higher 68 69 abundance of ARGs in urban areas in Africa and South-East Asia compared to rural areas.

71 Enteric pathogens are transmitted to humans by direct contact with infected hosts or via exposure to fecally-72 contaminated environments.¹¹ Exposure to animals has recently garnered attention as a risk factor for enteric infections 73 in LMICs with reports of strain-sharing between humans and domestic or wild animals that are in close proximity.^{12,13} 74 The previous studies have mainly focused on examining bacterial strain sharing between humans and animals,^{14,15} 75 without investigating the environmental exposure pathways through which transmission occurs.¹⁶ However, humans 76 are regularly exposed to environmental microbiota through consuming drinking water, hand-to-mouth contact with 77 soil, and inhaling soil dust.^{7,14} Understanding transmission pathways across humans, animals, and the environment, 78 along with their spatial range, is important to determine how bacterial transmission could be interrupted and the scale 79 at which interventions need to be implemented.¹⁷

The epidemiological study of bacterial transmission has traditionally been conducted by sequencing whole genomes of individual isolates selectively cultured from each host.¹⁹ Sequencing individual isolates has the advantage that it can facilitate the comparison of complete genomes at high-resolution, using metrics such as core genome multilocus sequence typing (cgMLST)²⁰ or core genome single nucleotide polymorphisms (cgSNP).²¹ However, due to the labor

85 and cost burden of culturing and sequencing isolates, studies often include only one isolate per sample, potentially 86 missing a diverse population.^{7,12} Sequencing of DNA extracted directly - metagenomics - can describe the diversity 87 of complex microbial communities without a culture step. Several software tools have been recently developed for 88 tracking strains within metagenomes even when they are present at low relative abundance within a complex 89 community.^{22,23} However, reconstructing accurate sequences of ARGs and placing them within their genomic context 90 is often challenging due to low sequencing coverage and high heterogeneity, which can confound assembly.^{24,25} In 91 addition, ARGs are often carried on plasmids, which makes linking these ARGs to their host organisms challenging.²⁶ 92 Plate-sweep metagenomics is a recent intermediate approach between isolated colonies and metagenomics that 93 includes a culture step to select for target viable organisms of interest from a sample followed by sequencing the total 94 biomass from the plate. While the overall microbial complexity of a sample is reduced, sequencing effort can still be 95 wasted as most selective media is not species specific.^{18,27}

97 In this study, we aimed to elucidate bacterial strain-sharing and ARG dissemination between humans, domesticated 98 animals, and the household environment. Given its ubiquity and role as a common human commensal as well as 99 clinically important and often antibiotic resistant pathogen, we selected *Escherichia coli* as the target organism.^{28,29} In 100 order to capture strain diversity within each sample and achieve high depth of sequencing coverage, we pooled up to 101 5 presumptive E. coli isolates cultured from the same sample prior to sequencing. Herein, we call our approach "PIC-102 seq" (Pooling Isolated Colonies-seq). Leveraging matched sample sets of human stool, poultry cloacal swabs, canine 103 feces, stored drinking water, and soil from 50 households in low-income informal settlements in Nairobi, Kenya, we 104 used PIC-seq to determine strain sharing patterns. In addition, we reconstructed the resistomes of pooled E. coli 105 isolates at the sample level to explore the role of strain dissemination versus horizontal gene transfer in the spread of 106 ARGs.

108 **Results**

109 Characteristics of enrolled households

Poultry-owning households (n=50) were enrolled in the study across two subcounties (Dagoretti South: n=25 and Kibera: n=25) in Nairobi, Kenya. In Kibera, all households collected drinking water from chlorinated piped water, as confirmed by chlorine residual testing at the tap during the study. In contrast, water sources in Dagoretti South varied,

with households collecting water from boreholes (44%; 11/25 households), piped water (44%; 11/25 households), and
water tanks (12%; 3/25 households), none of which underwent chlorination (Supplementary Table 1). Additional
household-level water treatment of the collected water was slightly more common in Kibera (24%; 6/25 households)
than in Dagoretti South (12%; 3/25 households).

118 Households from Dagoretti South and Kibera had similar wealth indices, as determined by household assets including 119 availability of electricity, TV, mobile phone, and a stove (Supplementary Table 2). Urban informal settlements in 120 Kenya are often organized into compounds consisting of households sharing a common courtyard, which may include 121 a shared latrine. Households in Dagoretti South were more likely to have latrines inside their compound (76%; 19/25 122 households) compared to Kibera (20%; 5/25 households), where the majority relied on public facilities located >5 123 meters away outside of the household compound (64%; 16/24 households) (Supplementary Table 3). The purpose for 124 poultry ownership across both subcounties was primarily nutrient provision via meat (Dagoretti South: 88%, 22/25 125 households; Kibera: 92%, 23/25 households) and eggs (Dagoretti South: 88%, 22/25 households; Kibera: 68%, 17/25 126 households), or for income generation (Dagoretti South: 44%, 11/25 households; Kibera: 80%, 20/25 households) 127 (Supplementary Table 4). Over half (56%; 28/50 households) of respondents reported allowing poultry and canines 128 into the household (Supplementary Table 4). Study staff observed less animal feces near household soil sampling 129 areas in Dagoretti South (24%; 6/25 households) than in Kibera (48%; 12/25 households).

131 Strain identification of colonies by sample type

132 A total of 321 samples (132 human stool, 111 poultry cloacal swabs, 17 canine feces, 22 stored drinking water, and 133 39 household soil) were successfully collected at the 50 enrolled households, and from each sample, up to 5 isolates 134 were pooled togser for PIC-seq. A total of 1,516 colonies were included. Each sample pool was sequenced and 135 analyzed with StrainGE²² to estimate the number of strains present in each sample, and their corresponding 136 representative genomes, using a database of 2.496 *Escherichia* and *Shigella* reference genomes, clustered at 99% k-137 mer similarity (Methods). We identified 800 total strains that corresponded to 299 unique representative reference 138 strains (Fig. 1A). The identified reference strains encompassed 279 Escherichia coli, 1 Escherichia albertii, 6 139 Escherichia fergusonii, and 13 strains within the genus Shigella (Fig. 1B). Out of the 13 identified Shigella strains, 11 140 were assigned to Shigella flexneri, and the remaining two were assigned to Shigella dysenteriae and Shigella sp...

142 The number of identified strains in each sample was compared to assess sample strain diversity across sample types. 143 Stored drinking water had significantly lower counts of strains compared to other sample types, and household soil 144 had significantly higher strain counts than human stool (Supplementary Fig. 1A); no other significant differences were 145 observed. We then investigated how distinctively strains are distributed within sample types, based on their 146 representative reference strains. To account for different sample sizes of each sample type, we subsampled an equal 147 number (n = 10) of samples with 1,000 iterations and compared the number of unique reference strains (Supplementary 148 Fig. 1B). Of all sample types, household soil samples exhibited the highest number of unique reference strains while 149 stored drinking water samples exhibited the lowest. The number of unique reference strains from poultry cloacal swabs 150 and canine feces was greater than from human stool samples. In human stool, the number of unique reference strains 151 increased with age (Supplementary Fig. 1B). 152 153 We compared the phylogroup compositions of the representative reference E. coli strains identified across sample 154 types. Phylogroup A was the most abundant with 31.4% to 46.4% of all identified strains across all sample types 155 (Supplementary Fig. 2). The next most common phylogroup was B1, although its frequency among strains identified 156 from humans was noticeably lower (17.2%) than in other sample types (30.4% - 37.1%). Phylogroups B2 and D were

found to be enriched in humans (phylogroup B2: 12.3%; phylogroup D: 11.7%), stored drinking water (phylogroup 158
B2: 8.6%; phylogroup D: 11.4%), and B2 in canine samples (6.3%), compared to other sample types (phylogroup B2:

159 0.3% - 0.9%; phylogroup D: 3.4% - 4.8%). Additionally, S. flexneri was more frequently found among the strains

160 from poultry (7.5%) and canine (4.2%) samples, compared to other sample types, which ranged from 0% to 2.6%.

168 Prevalence of *E. coli* pathotypes and *Shigella*

To examine the prevalence of *E. coli* pathotypes across sample types, we investigated the presence of known virulence genes on the assembled contigs for each sample (Methods). Humans carried the most diverse pathotypes of *E. coli*, with Enteroaggregative *E. coli* (EAEC) (13.6% of human samples) and Enteropathogenic *E. coli* (EPEC) (7.6%) most frequently detected (Fig. 2). EAEC and EPEC were also frequently detected in canine feces (EAEC: 5.9% and EPEC: 5.9% of canine samples). In poultry cloacal swabs, EAEC (1.8% of poultry samples), EPEC (0.9%), and Enterotoxigenic *E. coli* (ETEC) (0.9%) were detected. In stored drinking water, EAEC (4.1% of drinking water samples) was the only pathotype detected while household soil had more diverse pathotypes present including EAEC

- 176 (7.7% of soil samples), ETEC (7.7%), and EPEC (2.6%). Diffusely adherent *E. coli* (DAEC) and Enteroinvasive *E.*
- 177 *coli* (EIEC) were not detected in any of the samples. We also determined the prevalence of *Shigella* across samples,
- 178 which was highest in poultry cloacal swabs (19.0% of poultry samples), followed by canine feces (11.8% of canine
- samples), household soil (10.3% of soil samples), and human stool (6.1% of human samples) (Fig. 2). No Shigella
- 180 strains were detected in stored drinking water.

187 Strain-sharing patterns

We examined strain-sharing patterns across humans, poultry, canine, soil, and stored drinking water *within* and *between* households. Sample pairs with strains with over 99.95% average callable nucleotide identity (ACNI) by StrainGE were considered to share strains based on previous benchmarking,²² and the average strain-sharing rate (the average strain-sharing events/total possible pairs in each household or household pair) *within* or *between* households were compared across different sample type pairs. *Within* households, strain-sharing was most frequent between the same host type (human-human rate: 0.19 cases per sample pair; poultry-poultry rate: 0.15 per sample pair) with rates significantly higher than the rates *between* households (human-human rate: 0.0051, p < 0.001; poultry-poultry rate:

195 0.0023, p < 0.001) (Fig. 3). Direct human-animal strain-sharing was nearly absent; a strain shared between human and 196 poultry was detected in just one household, with the rates observed between households not significantly different 197 from within households. Strain-sharing with environmental sources (human-stored water rate: 0.065; poultry-soil rate: 198 0.038) was frequently observed within households and at significantly higher rates than between households (human-199 stored water rate: 0.00030, p < 0.001; poultry-soil rate: 0.0024, p = 0.0048). Additionally, the strain-sharing rate 200 between stored drinking water and soil within households (rate: 0.053) was significantly higher than between 201 households, where no strain-sharing was detected (p < 0.001). Unlike within households, where strain-sharing was 202 most common between human and stored drinking water, significantly higher than that between human and animal (p 203 = 0.027), human-stored drinking water strain-sharing was one of the lowest *between* households (rate: 0.00030) (Fig. 204 3 and Supplementary table 5).

215 Contaminated drinking water facilitates human-human strain sharing

216 In Kibera, households had access to piped chlorinated drinking water. We observed poorer water quality in Dagoretti 217 South; 52.0% of households (13 out of 25) in Dagoretti South had E. coli contamination in stored drinking water while 218 37.5% of households had E. coli-contaminated water in Kibera (9 out of 24) (Fig. 4A). We hypothesized that 219 chlorinated water could reduce human-drinking water strain-sharing within households. Indeed, we observed less 220 human-drinking water strain-sharing in Kibera (rate: 0.049) than Dagoretti South (rate: 0.080) although the difference 221 was not statistically significant (Fig. 3). Given that humans within households share the same drinking water source, 222 contaminated stored drinking water may play a role in strain-sharing between humans within households. Indeed, 223 human-human strain-sharing was observed in 42.9% (9/21) of the households with E. coli-contaminated stored 224 drinking water, compared to just 19.2% (5/26) of the households without E. coli contaminated water (Fig. 4B). The 225 human-human strain sharing (rate: 0.32) within households with E. coli-contaminated stored water was significantly 226 higher than households with clean water (rate: 0.090, p = 0.026) (Fig. 4B). No other strain-sharing sample type pairings 227 showed significant differences when households were stratified by stored water contamination (data not shown). 228 Further, we observed identical strains being shared across more than one human and stored drinking water in two 229 households (Household ID: 051 and 084), lending evidence for strain-sharing between humans through the 230 consumption of contaminated stored drinking water (Fig. 4C).

239 **PIC-seq outperforms metagenomics**

240 We additionally evaluated the performance of PIC-seq in investigating E. coli strain-sharing patterns by comparing 241 the results with metagenome sequence data generated without the culture enrichment step. As part of another study, 242 total DNA was extracted from a subset of matched human stool samples in this study (110 samples) and sequenced. 243 StrainGE detected a slightly lower number of strains across the total metagenome samples (230 strains) vs. the 244 corresponding PIC-seq samples (248 strains). Further, while the PIC-Seq approach detected strain-sharing in 50 245 sample pairs, strain-sharing was detected in only 7 metagenomic sample pairs (5 pairs overlapping between the two 246 approaches), possibly due to insufficient coverage depth for detecting genomic substitutes in E. coli between samples 247 (Supplementary Fig. 3).

249 Distribution of clinically relevant ARGs across humans, animals, and the environment

250 To investigate ARG transmission, we examined the distribution and diversity of ARG variants based on the assembled 251 contigs for each sample type. To assess if long-read sequencing provided higher resolution insights into ARG 252 transmission, we benchmarked using simulated pooled E. coli datasets on contigs assembled from Oxford Nanopore 253 Technology long reads versus Illumina short reads (Supplementary methods). While contigs assembled from long 254 read data consistently generated longer contigs than those from short reads across all simulated datasets - in terms of 255 the proportion of the recovered genome fraction, the length of the largest alignment, and N50 - they exhibited the 256 lowest accuracy in their sequence identity to the original genomes (Supplementary Fig. 4). Hybrid assembly utilizing 257 both short and long reads marginally improved contig length but resulted in lower accuracy compared to short-read 258 assemblies. Thus, we opted to analyze ARGs using only contigs assembled from short reads. Additionally, we 259 benchmarked our assembly approach, which uses reference-based binning before de novo assembly to reconstruct 260 resistomes, against sole de novo assembly (Supplementary Methods). Our approach significantly outperformed sole 261 de novo assembly, reconstructing 81.6% to 89.2% of the original resistome compared to just 15.1% to 27.8% 262 (Supplementary Fig. 5).

We grouped all identified ARGs on the contigs into clusters based on their nucleotide sequences at 100% identity and compared the number of unique ARG clusters observed in each sample type. Similar to strain diversity patterns, household soil had the highest number of unique ARG clusters (median: 266) and stored drinking water the lowest (median: 152) (Supplementary Fig. 6). No significant difference was observed between humans (median: 200.5) and animals (poultry median: 231; canine median: 238).

We investigated the diversity and distribution of high-risk ARGs, classified as Rank I ARGs by Zhang *et al.*³⁰, across our sample types. Rank I ARGs refer to gene families that have been reported to be significantly enriched in humanassociated environments, associated with gene mobility, and are known to be present in ESKAPE pathogens (*Enterococcus faecium, Staphylococcus aureus, Klebsiella pneumoniae, Acinetobacter baumannii, Pseudomonas aeruginosa*, and *Enterobacter* sp.). Humans had significantly higher numbers of Rank I ARG clusters conferring resistance to the drug classes of beta-lactam and macrolide-lincosamide-streptogramin (MLS) than poultry, while Rank I ARG clusters of trimethoprim and quinolone were found to be higher in poultry (Supplementary Fig. 7). We

277 assessed ARG mobility in our samples based on adjacency to mobile genetic elements (MGEs); if ARGs were 278 associated with contigs under 5000 bp, they were determined to have ambiguous mobility (Methods). For ARGs where 279 mobility could be determined, an average of 64.2% of ARGs within Rank I ARG clusters were predicted to be mobile, 280 except for *mdtE*, where none of ARGs within the clusters were predicted to be mobile (Fig. 5 and Supplementary 281 Table 6). Prevalence of ARG clusters across humans, animals, and the environment was similar, with several ARG 282 clusters prevalent in all sample types. aph(6)-Id, which confers resistance to the antibiotic class of aminoglycoside, 283 had the largest cluster size and was the most frequently present in all groups, including in 41.2% of canine samples. 284 Among β -lactamase genes, a *bla*_{TEM-1} cluster was the most prevalent in all groups, with detection in 51.4% of poultry 285 samples. Another β -lactamase gene cluster found in all sample types was *bla*_{CTX-M-15}, which confers resistance to third 286 generation cephalosporins (Fig. 5). Its prevalence was comparable in humans (20.5%), canines (23.5%), and 287 household soil (15.8%); it had lower prevalence in poultry (4.5%) and stored water (5.3%). We identified several other 288 ARG clusters in all sample types; genes conferring resistance to trimethoprim (dfrA), MLS (mphA), and quinolone 289 (*qnrS*) were prominent. We also observed widespread presence across all samples of the bacitracin resistance gene 290 *bacA*, a peptide antibiotic, and the *tolC* gene, associated with multidrug resistance as part of the efflux pump system.

297 Strain-sharing disseminates ARGs

To investigate whether spatial proximity is associated with similarity in ARG profiles, sample resistomes were compared *within* versus *between* households. Resistome similarity closely mirrored strain-sharing rates, with significantly higher resistome similarity *within* households compared to *between* households for human-human, poultry-poultry, human-water, and water-soil (Supplementary Fig. 8). In addition, poultry-canine pairs shared

302 significantly higher resistome similarity *within* households than *between* household when stratified by predicted
 303 mobility (Supplementary Fig. 8).

304

305 To further investigate the influence of strain-sharing on resistome composition, we performed a correlation analysis 306 between mean strain-sharing rates and mean resistome similarities between sample types (Fig. 6). We hypothesized 307 that if ARGs are not specific to certain strains due to frequent horizontal gene transfer and are already prevalent among 308 samples, a weak correlation between strain-sharing rates and resistome similarities would be expected. Both non-309 mobile and mobile resistome similarities were strongly correlated with strain-sharing rates within households (non-310 mobile vs. rate: Spearman's r = 0.86; p = 0.0003 and mobile vs. rate: Spearman's r = 0.89; p = 0.000097), suggesting 311 frequent strain-sharing within households was a strong factor for sharing similar resistomes (Fig. 6). However, no 312 significant correlation was observed between households, presumably due to the insufficient number of strain-sharing 313 events to affect mean resistome similarities. A bootstrapped analysis revealed different correlation coefficient 314 distributions within versus between households (Supplementary Fig. 9).

320 Discussion

321 Here, we observed high rates of *E. coli* strain sharing between humans and stored drinking water *within* households

322 compared to *between* households, suggesting the importance of drinking water as a transmission route of bacterial

323 strains to humans.^{31,32} E. coli contaminated drinking water was associated with higher human-human strain-sharing

324 rates in households and we captured instances of the same strain shared between humans and water in the same 325 household. Frequent strain exchange between drinking water and humans could explain the similarities in phylogroup 326 profiles of strains between humans and stored drinking water, including the comparable proportion of phylogroups 327 B2 and D.³³ Our results are consistent with bacterial strains ingested through water consumption readily colonizing 328 the human gastrointestinal tract.^{34,35} We observed lower levels of human-water strain-sharing rates and stored drinking 329 water E. coli contamination in Kibera compared to Dagoretti South (although not statistically significant), suggesting 330 access to chlorinated water in Kibera disrupted strain-sharing via drinking water.³⁶ Water quality data collected by the 331 parent study documented significantly lower levels of stored drinking water E. coli contamination in Kibera (22.6%)³⁷ 332 compared to Dagoretti South (68.2%) with a larger set of households (120 households) (Fisher's exact test; p value < 333 0.001).³⁷ A previous randomized controlled trial of community-wide passive chlorination of drinking water in urban 334 Bangladesh found a 23% reduction in 7-day child diarrhea prevalence, suggesting the effectiveness of chlorinated 335 water in disrupting bacterial transmission.³⁶ Considering the complex bacterial transmission routes in densely 336 populated urban informal settings,⁸ our findings highlight chlorinated drinking water as a key strategy to disrupt 337 household strain-sharing.

338

339 It has been hypothesized that domestic animal exposure increases the risk of zoonosis.^{31,38} While we rarely observed 340 direct zoonotic sharing events in our study population, we documented that poultry-soil stain sharing was more 341 frequent within households compared to between households. In our urban study context, rare poultry-human strain 342 sharing within households could be explained by infrequent exchange of strains between humans and soil (Fig 3). 343 Previous research in rural and/or urban regions of Kenya,³⁹ Bangladesh,^{31,40} and India⁴¹ has indicated that exposure to 344 domesticated animals increases environmental fecal bacteria contamination, evidenced by the higher prevalence of 345 animal versus human fecal markers in soil and drinking water. Given that environment-associated strain-sharing rates 346 with humans or animals were significantly higher within households versus between households, our findings highlight 347 the critical role of the environment in bacterial transmission. A few human-animal strain-sharing events were observed 348 between households at a rate not significantly different from that within households, consistent with a previous study 349 in Kenya, which found that sharing between humans and livestock was not confined to the same households.¹³ Taken 350 together with previous evidence, our results suggest that human-animal strain-sharing can occur at the community 351 scale.

353 Our results are consistent with clonal spread of bacteria being the main driver shaping resistomes of pooled E. coli 354 strains. ARG variants associated with MGEs have the potential for horizontal gene transfer, which would result in 355 overlapping ARGs between non-identical or phylogenetically distant strains. In our study, the significant correlation 356 of mobile (and non-mobile) ARG similarity with strain-sharing rates between samples within households, indicates 357 that close proximity strain-sharing had a greater influence on resistome similarities than ARG exchange via horizontal 358 gene transfer. This observation aligns with a previous study in Kenya,⁴³ where the multilocus sequence type of *E. coli* 359 isolates from humans, domestic animals, and wild animals best explained the variance of the mobile ARG assemblages 360 among them. Within households, human-water pairs showed higher resistome similarity (due to clonal transmission) 361 than human-animal pairs, underscoring the role of frequent bacterial strain-sharing in ARG spread. Between 362 households, where strain-sharing events were rare, no correlations were observed between resistome similarities and 363 strain-sharing rates across sample types.

364

365 Environmental sample resistomes possessed many high-risk ARGs.³⁰ Rank I ARG variants within environmental 366 samples had similar or even higher diversity than human and animal hosts across antibiotics classes, and our results 367 suggest new ARG variants can be transferred to humans and animals through drinking water and consumption of soil 368 particles. ARGs like *bla*CTX-M-15, conferring resistance to third-generation cephalosporins, were detected consistently 369 across all sample types. Use of antibiotics could then exert selection pressure in the gut enriching these ARGs. 370 Quinolones and trimethoprim have been reported to be widely used by poultry farmers in Nairobi, Kenya, and this 371 would explain the higher number of Rank I ARG clusters of these antibiotics observed in poultry compared to humans.^{44,45} Beta-lactam antibiotics have also been reported for use in animals in Nairobi;⁴⁴ however, the observed 372 373 higher diversity in humans could be attributed to frequent human consumption of these antibiotics.⁴⁶ Prevalence of 374 plasmid-mediated ARGs like $bla_{\text{TEM-1}}^{47}$ and aph(6)-Id⁴⁸ across all sample types corroborated that certain ARGs and 375 MGEs would be more prone to dissemination.⁴⁹ Our profiling of ARG mobility was not always possible due to 376 insufficient contiguity of partial genomic segments assembled from short reads. Oxford Nanopore sequencing technology, which generates longer sequences has the potential to identify the genomic context of ARGs.⁵⁰ In our 377 378 benchmarking, however, the contigs assembled with short reads in this study outperformed those with long reads in 379 their sequence accuracy (Supplementary Fig. 4). Hybrid assembly, leveraging both short and long reads, has been

380 suggested as an alternative approach with better assembly quality,⁵¹ however, the improvement in sequence contiguity 381 and accuracy for hybrid assembly was marginal in our benchmarking.

382

383 Our results demonstrate the value of PIC-seq for examining strain sharing and the prevalence of ARGs. PIC-seq 384 demonstrated higher performance in capturing more strain-sharing events (50 sharing events) compared to those 385 identified through traditional metagenomic sequencing (only 7 sharing events) in a subset of matching stool 386 metagenomes sequenced for another study (Supplementary Fig. 3). Further, our integration of additional de novo 387 assembly with reference-based binning assembly enabled the recovery of ARGs located in genomic regions of pooled 388 organisms that differed from reference genomes, outperforming sole de novo assembly (Supplementary Fig. 10). 389 ARGs recovered from unbinned reads were mostly associated with MGEs, such as plasmids and genomic islands, 390 which can circulate among strains via horizontal gene transfer.⁵² While these ARGs could not be tied to a specific 391 strain, we were able to better capture the resistome of pooled isolates from each sample. Compared to sequencing of 392 single isolates or sequencing the entire microbiome for strain tracking, our approach offers a distinct advantage in that 393 it allows for simultaneous capture of strain identity and sensitive detection of ARGs with genomic context. PIC-seq 394 is a scalable method for examining strain-sharing patterns that could be replicated for other bacterial species.

395

396 Methods

397 Study sites and sample collection

To investigate *E. coli* strain-sharing between humans, domesticated animals, and the environment, 50 poultry-owning households with at least one child under the age of 5 years were enrolled in two subcounties, Dagoretti South (n = 25) and Kibera (n = 25), in Nairobi, Kenya, during June – August 2019. One household was enrolled from each compound that owned poultry. Written informed consent was obtained from each adult participant prior to stool sampling and child assent and parental written consent were obtained for each child participant. A household survey was performed along with the sample collection to collect demographic information and household characteristics including water, sanitation, and hygiene access and practices.

405

406 Each household was visited twice for the sample collection. During the first visit, we collected up to 3 poultry cloacal 407 swabs (depending on the number of poultry present), one canine fecal sample, one household soil, and one stored

408 drinking water sample from each household. A trained veterinary student administered the poultry cloacal swabs and 409 placed them in storage tubes filled with Cary-Blair transport medium, kept in a cooler for transport to the lab. To 410 collect canine feces, the top layer of fresh feces from the center of the pile was transferred into a 50 mL centrifuge 411 tube with a sterile plastic scoop. For household soil collection, a 30 cm x 50 cm square area closest to the entrance of 412 the household was marked, and the top layer of the entire surface of the marked area was scraped with a sterile 413 disposable plastic scoop. Approximately 150 g of soil was collected and transferred into a 500 mL sterile Whirlpak 414 bag. The stored water within each household was collected by withdrawing 350 mL of the water from the bottom of 415 the storage container with a sterile serological pipette. The water was then transferred into a 500 mL sterile Whirlpak 416 bag containing 10 mg of sodium thiosulfate. All samples were immediately placed in a cooler filled with ice and 417 transported to the Kenya Medical Research Institute (KEMRI).

418

419 Approximately 1 week from the initial visit, households were revisited to collect human stool from one household 420 member in the following three age groups: child aged 0 - 4 years, child aged 5 - 14 years, and adult aged 15 years or 421 older. A stool collection kit was provided during the first visit, which included a 50 mL plastic pot with a sterile scoop 422 for each member with instructions on how to collect the sample. Caretakers were instructed to collect feces on 423 aluminum foil, then, using sterile gloves and scoops, to transfer the feces to the plastic pot for collection. The primary 424 caretaker of each household was informed by mobile phone one day prior to the revisit to collect stool from the 425 previous night or the morning of the revisit day. If stool samples were not available on the visit day, households were 426 revisited up to three times to collect the remaining stool samples. After pick-up, the received stool samples were placed 427 in a cooler filled with ice and transported to KEMRI.

428

The study received ethical approval from the Kenya Medical Research Institute (KEMRI) Scientific and Ethics Review
Unit (12/3823) and the Tufts Health Sciences Institutional Review Board (13205). Additionally, a research permit was
granted by the Kenyan National Commission for Science, Technology, and Innovation.

432

433 **Pooling Isolated Colonies for sequencing (PIC-seq)**

Here we describe our method of pooling presumptive isolated *E. coli* colonies for sequencing (PIC-seq). *E. coli*colonies were first cultured from the collected samples within 6 hours of sample collection. A sterile swab was inserted

436 into 1 g of each collected human stool and canine feces sample, and the swab was streaked on Tryptone Bile X-437 glucuronide (TBX) agar plates. Poultry cloacal swabs were directly streaked on the agar plates. Household soil and 438 stored water samples were membrane filtered and cultured on TBX. Collected soil was first screened through 2 mm-439 pore mesh sieves to remove rocks and leaves, then 5 g were homogenized with 50 mL of distilled water. After allowing 440 soil particles to settle for 1 minute, 100 μ L of supernatant was diluted with 10 mL of distilled water and vacuumed 441 through a 0.45- μ m membrane filter, and plated. 100 mL of stored water was directly filtered, then plated on TBX. All 442 plates were incubated overnight (18 – 24 hours) at 44 °C.

443

Post incubation, up to 5 presumptive *E. coli* colonies (blue-green color) were selected from each agar plate for pooling. The selected colonies from each plate were transferred into a single 2 mL tube containing 1 mL of Luria-Bertani (LB) medium. The pooled *E. coli* colony cultures were incubated overnight (18 hours) at 37 °C with shaking at 200 rpm. After incubation, 100 μ L of the cultures were mixed with 1 mL of 30 % glycerol-70% Tryptone Soy Broth (TSB) solution and stored at – 80 °C. The samples were then shipped on dry ice to Tuft University (Medford, MA).

449

Pooled isolates were thawed on ice and inoculated into 5 mL of fresh TSB medium with a sterile inoculating loop. The cultures were incubated overnight at 37 °C with 200 rpm shaking, then 1.5 mL of the culture was pelleted by centrifugation at 5,000 x g for 10 min. The DNA was then extracted from pellets using DNeasy PowerSoil Pro Kit (Qiagen, Hilden, Germany) following the protocol provided by the manufacturer. The concentration and purity of the extracted DNA were measured by a Qubit 4.0 Fluorometer (Thermo Fisher Scientific, Waltham, MA), a sequencing library was prepared using Nextera XT kit (Illumina, San Diego, CA), and shotgun sequencing was performed on Illumina NovaSeq 6000 (Illumina) with target sequencing depth of 1.5 Gb at the Broad Institute (Cambridge, MA).

457

458 Identification of *E. coli* strains and calculation of household-wise strain-sharing rates

The quality of raw sequence reads was examined using FastQC,⁵³ and low-quality reads were filtered out using Trimmomatic v0.39⁵⁴ with parameters set to LEADING:3, TRAILING:3, SLIDINGWINDOW:4:15, and MINLEN:70. The subsequent reads were used for the identification and comparison of *Escherichia* strains using the software StrainGE v1.3.3, the software specifically designed for accurate calling and comparison of strains in the complex metagenome data based on k-mer comparison, bypassing assembly process.²² The database for StrainGE was

464 constructed using the complete genome sequences (2,496 genomes) of the genus of *Escherichia* or *Shigella* 465 downloaded from NCBI RefSeq database on August 20, 2022, by using the built-in database construction pipeline 466 ('ncbi-genome-download', 'kmerize', 'kmersim', 'cluster', and 'createdb'). The reference genomes in the database 467 were clustered if they shared 99% of their k-mer content with a Jaccard similarity over 0.90, and to minimize 468 redundancy, only the representative genome sequences of each cluster were retained, resulting in a final set of 885 469 genomes.

470

471 After strain identification, we utilized StrainGR, the second module of StrainGE, to call sequence variants among 472 samples.²² Sequence reads were aligned to the genomes of the identified strains in each sample using bwa mem v0.7.17 473 with default parameters.⁵⁵ For sample pairs with the same reference strain, the average callable nucleotide identity 474 (ACNI) and gap similarity were calculated based on the callable regions, using 'call' and 'compare' command in 475 StrainGR.²² The threshold for defining the same strain was set to > 99.95% ACNI.

476

477 The strain-sharing rates between sample types were calculated, using the results from StrainGR. Within each 478 household, we normalized the number of sample pairs sharing the same strain by the total number of combinations 479 between the certain sample types. We then computed the average rates based on the rates from all households for 480 comparison. For strain-sharing rates between different households, we normalized the number of sample pairs with 481 the same strain by the total number of possible sample pairs, between all combinations of different households. We 482 then calculated the average rates from these inter-household rates for comparisons between certain types of samples. 483 Stored water samples without E. coli contamination were included in calculating water-related total number of possible 484 pairs.

485

486 Phylogeny and phylogroup of detected *E. coli* strains

To infer the phylogenetic relationships among the strains identified from the samples, we utilized the reference genome sequences included in the StrainGE database. Prokka v1.14.5 was used to annotate genes, with the genus parameter set to *Escherichia*.⁵⁶ The core genes that exist in 99% of all reference genomes were identified using Roary v3.13.0.⁵⁷ The concatenated core gene alignment was generated using MAFFT, and SNP-sites v2.5.1⁵⁸ was used to extract the alignment regions with single nucleotide polymorphisms (SNPs) to reduce the size of the alignment. The reduced

- 492 alignment was uploaded to CIPRES Science Gateway v3.3⁵⁹ (www.phylo.org), and a maximum likelihood tree was
- 493 constructed using RAxML v8.2.12⁶⁰ with the nucleotide substitution model set to GTRGAMMA with 500 bootstraps.
- 494 *E. coli* phylogroup was predicted using ClermonTyping v20.03⁶¹ with default parameters.
- 495

496 Annotations of antibiotic resistance genes and mobile genetic elements

497 The integrated assembly pipeline, which combines reference-based binning and *de novo* assembly, was used to 498 generate contigs for ARGs and mobile genetic elements (MGEs) annotation (Supplementary Fig. 11). Plasmid 499 sequences were assembled from sequencing reads using metaplasmidSPAdes v3.15.4⁶² with default parameters. 500 Subsequently, the original reads were aligned and binned to the set of the assembled plasmid sequences and the 501 reference genomes of strains identified through StrainGST, using mSWEEP v.2.0.0²⁷ and mGEMs v.1.3.0¹⁸ with 502 default parameters. For each reference strain, the reads binned to their genome sequences were individually assembled 503 de novo using metaSPAdes v3.15.4⁶³ with default parameters. The sequence reads that did not align to any sequences 504 were separately assembled *de novo* using metaSPAdes. The gene-coding sequences in the assembled contigs were 505 predicted using Prodigal v2.6.3⁶⁴ with default parameters. The translated amino acid sequences of the predicted gene-506 coding sequences were annotated using DIAMOND blastp v2.0.14.15265 against the Comprehensive Antibiotic 507 Resistance Database (CARD) v3.2.4⁶⁶ with the parameters set to '--id 90', '--min-orf 25', and '--query-cover 80'. The 508 annotations with the highest bitscore for each gene-coding sequence were retained for the downstream analysis.

509

510 To predict the mobility of ARGs, we examined the presence of any MGEs in the flanking regions of the annotated 511 ARGs. We extracted up to 5000 base pairs from both upstream and downstream of ARGs on the contigs using a 512 custom bash script. The mobileOG-pl pipeline was then used to annotate MGEs with mobileOG-db release beatrix-513 1.6 as the reference database,⁶⁷ which is a manually curated database that includes sequences from eight different 514 databases (ICEBerg, ACLAME, GutPhage Database, Prokaryotic viral orthologous groups, COMPASS, NCBI 515 Plasmid RefSeq, immedb, and ISfinder), along with homologs of the manually curated sequences. ARGs with 516 identified MGEs in their flanking region were presumed to be mobile, while those without MGEs were categorized as 517 non-mobile. In instances where the contig length was insufficient (< 5000 base pairs) to detect MGEs in the flanking 518 region, the mobility of these ARGs was considered ambiguous.

520 Identification of pathogenic *Escherichia* and *Shigella* strains

521 The identification of pathogenic E. coli strains was inferred based on the presence of pathotype-associated virulence 522 genes detected in the assembled contigs for each sample. These virulence genes were annotated from the contigs using ABRicate, in combination with the Virulence Factor Database (VFDB) (download in May, 2023).⁶⁸ The presence of 523 524 different E. coli pathotypes was based on the detection of the following gene sets: agg, aat, and aai for 525 Enteroaggregative E. coli (EAEC); eae and bfp for Enteropathogenic E. coli (EPEC); elt and est for Enterotoxigenic 526 E. coli (ETEC); stx for Enterohaemorrhagic E. coli (EHEC); afa and drg for Diffusely adherent E. coli (DAEC); and 527 ipa for Enteroinvasive E. coli (EIEC).⁶⁹⁻⁷¹ Presence of Shigella was additionally investigated based on StrainGST 528 results.

529

530 Statistical analysis

531 All statistical analyses in this study were carried out using R version 4.2.1.72 The differences in mean strain-sharing 532 rates were compared using a nonparametric permutation test, with 1000 iterations of resampling. Resistome similarity 533 was estimated by Jaccard similarity of ARG cluster compositions, defined as the number of unique ARG clusters 534 shared divided by the total number of unique ARG clusters from both samples. The pairwise Mann-Whitney U test 535 was used for comparing resistome similarities between sample types, using the 'wilcox.test' command from the 'stats' 536 package in R.72 All p-values were adjusted accordingly using Benjamini-Hochberg correction. Finally, the correlation 537 analyses among strain-sharing and resistome similarity patterns were performed using Spearman's rank correlation 538 method, as implemented in the 'cor.test' function from the 'stats' package in R.72
