1 Abstract

Objectives: The objective of this review was to evaluate the diagnosis and treatment of advanced and delayed sleep-wake phase disorders (ASWPD, DSWPD), both forms of circadian rhythm sleep-wake disorders (CRSWDs) using both human reviewers and ChatGTP to summarize relevant content.

6 Methods: PubMed-Medline, EbscoHost, and Web of Science were searched for peer reviewed 7 articles. Original research articles published in English were searched for full-text studies. 8 Studies that reported quantitative data on ASWPD and DSWPD diagnosing tools and treatment 9 options in individuals of all ages were assessed. We assessed ChatGTP 4.0's capacity to 10 extract and summarize data from these studies and evaluated it alongside human reviewers.

Results: Our review of 49 articles on CRSWD from the past 20 years found that 91% focused on DSWPD. The most common diagnostic tools were the MEQ, MCQ, Pittsburgh Sleep Quality lndex, and Epworth Sleepiness Scale, with primary methods including actigraphy and dim-lightmelatonin-onset. Melatonin, often combined with light therapy and CBT, was the predominant treatment. ChatGPT-4.0 facilitated the review process with about 92% accuracy but required manual oversight for optimal results.

Conclusions: Our review identified key diagnostic tools, such as MEQ and MCQ surveys, and common treatment options for ASWPD and DSWPD, including melatonin, light therapy, and CBT. The findings underscore the need for comprehensive and individualized treatment approaches for CRSWDs, with a particular focus on expanding research on ASWPD and increasing data representation across age groups. While ChatGPT shows potential in streamlining data extraction for CRSWDs, it still requires human oversight to ensure accuracy.

27 Introduction

28 Circadian rhythm sleep-wake disorder (CRSWD) is a condition that occurs when an individual's 29 internal sleep-wake schedule (i.e., biological clock) is out of sync with the natural light-dark 30 cycles.^{1,2} This misalignment can occur because of the body's inability to entrain to the 24-hour 31 light-dark cycle or misalignment between one's internal time and that of the external environment.³ CRSWDs often involve difficulty falling asleep, waking up too early or being 32 33 unable to fall back to sleep once awake resulting in insomnia-like symptoms or excessive davtime sleepiness.² Individuals who suffer from CRSWDs have shifted physiology and 34 35 sleep/wake timing. Thus, CRSWDs can harm mental and physical health, as well as daily 36 functioning.

38 The etiology of CRSWDs is complex and often involves both genetics and environmental 39 factors.⁴ There are six main types of CRSWDs namely, advanced sleep-wake phase disorder (ASWPD),² delayed sleep-wake phase disorder (DSWPD),⁵ irregular sleep-wake type disorder, 40 41 non-24-hour sleep-wake disorder⁵ which is most often associated with blindness, jet-lag type, 42 and shift-work disorder. Of these CRSWDs, ASWPD and DSWPD have demonstrated genetic susceptibility,⁶ with DSWPD accounting for most cases (3.3-4.6%)⁷ and being common among 43 44 adolescents and youth while ASWPD is relatively rare affecting nearly 1% of individuals in 45 middle to older age groups.

Patients with DSWPD tend to fall asleep very late and have delayed wake times compared with conventional times, which may result in chronic sleep insufficiency and daytime impairment due to differences between the "timing" of the world and the physiology.⁷ In contrast, patients with ASWPD tend to go to sleep and wake up early, often resulting in conflicts with evening social activities. In some cases, this syndrome may be caused by an inherited genetic disorder (i.e., it has a family tendency, FASWPD).² Clinical diagnosis of CRSWD involves self-reported and

53 objective methods such as dairies, questionnaires, sleep logs, dim light melatonin onset,⁸ and 54 accelerometry tools such as actigraphy,⁹ and occasionally polysomnograms during a clinical 55 visit.¹⁰ Also, treatment of CRSWD consists of sleep scheduling, behavioral modifications and 56 education, timed melatonin administration and bright light exposure, and refraining from 57 stimulating activities before bedtime.²

58

59 To date there is no consensus on the tools to clinically diagnose and treat CRSWD, leading to 60 more misdiagnosis and treatment heterogeneity of ASWPD and DSWPD. Comparison of tools 61 and treatment outcomes from individual studies is complicated by the use of inconsistent 62 diagnostic and treatment criteria and the use of evening and morning chronotypes as proxies for 63 DSWPD and ASWPD, respectively. The cause of ASWPD and DSWPD is unknown but may be 64 related to genetics, underlying physical conditions, and a person's behavior. This makes it 65 difficult to diagnose and treat ASWPD and DSWPD, however, having a universally accepted 66 approach to diagnosing and treating these CRSWDs would reduce opportunities for 67 misdiagnosis. Additionally, this would enable a meta-analysis of ASWPD and DSWPD studies 68 to be performed comparing diagnosis and treatment outcomes.

70 This systematic review aimed to provide comprehensive evidence of the tools used to diagnose 71 and treat ASWPD and DSWPD. Furthermore, use this evidence to create a comprehensive chat 72 engine review incorporating information from the various studies into a single tool, which can be 73 used to improve diagnosis and treatment of ASWPD and DSWPD. This was achieved by using 74 ChatGPT, a form of generative AI that lets users enter predefined prompts about ASWPD and 75 DSWPD to receive human-like text, expediting data extraction and summarization. Furthermore, 76 the dialogue format of ChatGPT makes it possible to test for accuracy, refine prompts and 77 answer follow-up questions.

79 Methodology

81 **Protocol**

A protocol was developed according to guidelines outlined in the 2020 Preferred Reporting Items for Systematic Reviews and Meta-Analyses (PRISMA) statement.¹¹ The research protocol was prospectively registered with the international Prospective Register Of Systematic Reviews (PROSPERO) in 2020 under registration number CRD566998. The PRISMA checklist is presented in the online supplemental file S1.

88 Study selection and eligibility criteria

Eligibility criteria were established and agreed upon by all authors based on the concepts of population intervention and outcome. Studies that met the following criteria were considered eligible for inclusion in this systematic review:

- Participants, male and female, clinically and self-reported to suffer from ASWPD and
 DSWPD.
- 94 2. All age groups, from children to older adults
- 95 3. Self-reported or clinically diagnosed ASWPD and/or DSWPD.
- 96 4. Treatment and/or behavioral therapies for individuals with ASWPD and/or DSWPD.
- 97 5. Before the search strategy implementation, it was agreed by all authors (LK, JL, EA) that
- 98 journal articles with full-text original prospective and/or retrospective studies published in
- 99 English would be included.
- 100 Exclusion criteria were set as studies:
- 101 1. Conducted with a heterogeneous sample (i.e., a mixed sample of ASWPD, DSWPD, and
- 102 other sleep disorders) without reporting individual group findings separately.
- Available as an abstract only (i.e., conference presentations), qualitative, discussion
 paper, commentary, or literature review.

105 3. Not available in English.

106 Search strategy.

107 Researchers systematically searched three electronic databases: PubMed-Medline, EBScoHost 108 and Web of Science. Medical subject heading (MeSH) terms included: sleep-wake schedule 109 disorder* OR sleep-wake schedule disorder* OR sleep-wake cycle disorder* OR Sleep-wake 110 cycle disorder* OR circadian rhythm sleep disorder* OR advanced sleep phase syndrome* OR 111 advanced sleep-phase syndrome* OR advanced sleep-wake phase disorder* OR delayed sleep 112 phase syndrome* OR delayed sleep-wake phase disorder* OR delayed sleep-phase syndrome* 113 OR familial advanced sleep-wake phase disorder* AND Diagnos* OR Examination* OR 114 assessment* OR sign* OR treatment* AND Human AND relevant exclusions (see 115 Supplementary File S2). A secondary search of the reference lists of included articles and hand 116 searching in Google Scholar were performed. Further articles the authors were aware of relating 117 to the topic were added to the search results. Duplicate articles were removed from the 118 combined searches. Article screening and selection utilized the online tool CADIMA.¹²

Two reviewers screened the articles independently (LK, EA). Full texts of articles were retrieved, and a second independent screening was undertaken by the same two reviewers. Any conflicts were resolved through discussion and consensus between reviewers. A third reviewer (JL) served as the tie-breaking vote.

125 Data extraction

To implement artificial intelligence for data extraction and summarization, ChatGTP was tested for accuracy and to refine the prompts. To accomplish this, data from two publications was manually extracted. A list of prompts was generated to extract data using ChatGTP from the test

129 publications. Each publication was entered into ChatGTP and a list of prompts was used to 130 extract data testing for accuracy. Prompts were then iteratively revised until ChatGTP data 131 extraction prompts and accuracy had been improved. Following this process, data from the 132 remaining 47 articles was extracted. Extracted data included: participant details (number, age, gender), study design, sample size, diagnosis (ASWPD or DSWPD), treatment or intervention, 133 134 population group (children: 0-12 years old, youth/adolescent: 13-17 years old, or adult: 18-100 135 years old), and diagnosis tool (polysomnography, actigraphy or sleep log or combination 136 thereof).

138 **Quality Assessment and risk of bias**

139 Studies were reviewed for the quality assessment and risk of bias using a modified Downs and 140 Black tool¹³ (see Supplementary S3). This was done by three reviewers (LK, EO, JL) 141 independently scoring the articles and then discussing differences to reach an agreed final 142 score for each article. The same reviewers determined the level of evidence using the Oxford Centre for Evidence-Based Medicine (OCEBM, 2009).¹⁴ The articles fell into two main 143 144 categories: Observational studies of the diagnoses of ASWPD or DSWPD; or Interventional 145 studies where the treatment outcome was determined in response to the intervention, with or 146 without control groups. The OCEBM level of evidence was graded using the criteria for a 147 Symptom Prevalence Study for the observational studies based on the degree of follow up for 148 prospective studies as level 1b for good follow-up and level 3b for non-consecutive cohort 149 studies, and level 2b for retrospective studies. The intervention studies were graded using the 150 Therapy/Prevention studies criteria of level 1b for randomized control trials (RCTs) with narrow 151 confidence intervals and level 2b for the non-RCT studies.

- 153 Results
- 154 Literature search

A total of 1770 studies were identified in the core collection databases and additional sources for screening, after duplicates were removed. Figure 1 (PRISMA flow diagram) summarizes the study selection process and reasons for excluding studies. The full texts of 121 articles were assessed for eligibility, 72 were excluded and 49 were included.

160 Quality assessment

161 The quality assessment of the 49 studies using the modified Downs and Black score¹³ is shown in Supplementary File S3. The quality assessment showed that two studies^{15,16} (4%) was scored 162 as fair (score 6-8), nine studies¹⁷⁻²³ (18%) were scored 'good' (score 9-10), 39 studies (78%) 163 were scored 'excellent' (score 11-13). Using the OCEBM scale for observational studies,¹⁴ 22 164 studies (44.9 %) were rated as 1b level of evidence. 7 studies^{7,24-29} (14.3 %) were rated as 2b 165 166 level of evidence, and 20 studies (40.8 %) were rated as 3b level of evidence (Supplementary 167 File S3). There were only nine interventional studies included (18.4 %) of which five were RCTs with narrow confidence intervals^{16,25,30-34} rated as level 1b and the other four studies were non-168 169 RCT^{24,25,29} rated as level 2b.

171 Characteristics of included studies

The characteristics of the 49 studies are presented in Table 1. The age range of participants included in this review was 7 to 65 years. The 49 studies had a total of 81,119 participants (range: 3 to 50,054), including 32,575 (40.16%) males, 48,509 (59.8%) females, and 35 (0.04%) unspecified sex. Studies were conducted across 10 different countries and four different continents. Fifty percent of the studies in this review were conducted in Australia (N=12) and Japan (N=12). Eighteen studies (37%) had a focus on diagnoses only, 17 studies (35%) focused on treatment only, and 14 studies (29%) focused on both diagnoses and treatment.

180 **Diagnosis of ASWPD and DSWPD**

Of the 49 studies, two studies (4.1%) investigated ASWPD, two studies (4.1%) investigated both 181 ASWPD and DSWPD³⁵ and 45 studies (91.2%) investigated DSWPD (Figure 1A). Thirty-three 182 183 studies focused on the diagnosis of individuals with ASWPD/DSWPD. Of the 33 studies (Figure 184 1D), nine studies (26.4%) used a combination of actigraphy, DLMO and validated surveys 185 reviewed by a clinician, eight studies (23.5%) used a combination of DLMO, actigraphy and 186 sleep logs or diaries, seven studies (20.6%) used sleep logs or validated questionnaires, four 187 studies (11.8%) used sleep logs and validated questionnaires reviewed by a clinician, three 188 studies (8.8%) used a combination of PSG, DLMO, actigraphy, sleep logs and validated 189 surveys, with one of these studies reviewed by a clinician. Lastly, in two studies (5.9%) participants were diagnosed using PSG^{26,36} only and in one study (2.9%)³⁵ participants were 190 191 diagnosed based on self-reporting only (Figure 1D).

192

Of the validated questionnaires used the Morningness-Eveningness Questionnaire and Munich Chronotype Questionnaire (n=20, 35.7%), Pittsburgh Sleep Quality Index (n=10, 17.9%) and the Epworth Sleepiness Scale (n=9, 16.1%) were the most frequently used (Figure 1C). The least used questionnaire included Karolinska^{29,33,37} (n=3, 5.4%) Insomnia Severity Index^{30,38} (n=2, 3.6%), DSWPD-STQ^{22,24,39} (n=3, 5.4%), Hospital Depression and Anxiety Scale^{33,38} (n=2, 3.6%) and the Depression, Anxiety and Stress Scale^{39,40} (n=2, 3.6%, Figure 1C)

200 Treatment options for ASWPD and DSWPD.

Of the 49 studies, 17 studies (34.7%) investigated treatment options for individuals with ASWPD/DSWPD. The treatment options are presented in Figure 1B. Melatonin (n=14, 37.8%), light therapy (n=11, 29.7%), and Cognitive and behavioral therapy (CBT, n=8, 21.6%) were the most used treatment options. More specifically, six studies (35.3%) used melatonin only, three studies (17.6%) used a combination of melatonin, light therapy, and CBT, two studies (11.8%)

used melatonin, chrono- and light therapy, one study (5.9%) used melatonin and light therapy,
three studies (17.6%) used CBT and light therapy, with the remaining two studies using
ramelteon¹⁵ (5.9%) and CBT (5.9%) only (Figure 1B).

211 CHATGTP and CRSWD data extraction

212 The initial data extraction from a subset of articles (n=4) achieved an accuracy and relevance 213 rate of 80%. This prompted revisions to refine the extraction criteria, which subsequently 214 enhanced the precision and relevance of the extracted information. By optimizing the extraction 215 parameters, we reduced irrelevant wording and increased the specificity of the queries, ensuring 216 a closer match to the original article. Following these refinements, blind extraction conducted 217 independently by two reviewers showed consistent reproducibility across all four studies during 218 the second stage of review. The accuracy of the extracted data, including critical details such as 219 study population demographics (age and gender), was meticulously verified against the original 220 articles. This verification process confirmed a 92% accuracy rate in the extracted data, ensuring 221 both completeness and reliability. Standardized extraction parameters proved effective across a 222 diverse range of studies, facilitating consistency in data extraction. This standardization enabled 223 automation of the 49 studies, significantly expediting the data extraction process and enhancing 224 overall efficiency.

226 **Discussion**

This systematic review aimed to summarize the diagnostic themes and treatment options for ASWPD and DSWPD as reported in the literature, to assess consistency and inform future research. Additionally, we evaluated ChatGTP's effectiveness in expediting data extraction and summarization process for CRSWD from studies. Specifically, it sought to present a

comprehensive overview of the current evidence regarding the diagnosis and treatment of ASWPD and DSWPD across diverse populations and age groups. DSWPD emerged as the most frequently reported CRSWD in both diagnostic and treatment contexts, with only two studies^{9,35} addressing ASWPD diagnoses and treatment. The discussion within this systematic review centers on three key areas of interest: 1) diagnostic strategies; 2) treatment modalities available for individuals affected by both ASWPD and DSWPD and 3) an evaluation of ChatGPT's capability to expedite and accurately summarize study criteria.

239 Diagnostic approaches for ASWPD and DSWPD

Forty-five of the reviewed studies focused on DSWPD, while two addressed ASWPD,^{9,41} and an 240 241 additional two studies³⁵ covered both ASWPD and DSWPD. The findings from this review 242 revealed a notably higher prevalence of DSWPD compared to ASWPD within the studied population, aligning with existing research indicating that DSWPD is more prevalent.^{7,38,42} This 243 244 observation is likely due to most participants being adolescents and young adults (16-35 years 245 old), who have shown a prevalence of mostly environmentally induced DSWPD ranging from 3.3% to 4.6%.⁴² Young adults and adolescents deal with various social and lifestyle pressures, 246 247 such as academic demands and extracurricular activities and have relatively lose social 248 constraints, which frequently disrupt their sleep patterns. Factors like increased electronic 249 device usage, irregular sleep schedules, and late-night engagements such as studying or 250 socializing further contribute to delays in sleep onset.

251

Moreover, during adolescence and early adulthood, a delay in circadian phase preference, influenced in part by genetic factors, has been identified.⁴² This delay leads to sleep onset insomnia, difficulty waking up at the desired time, and associated daytime dysfunction. Additionally, heightened exposure to light in the evening can suppress melatonin production, further delaying sleep onset. Consequently, a combination of biological, social, and

environmental factors renders adolescents and young adults particularly susceptible to experiencing DSWPD. Understanding these multifaceted influences is crucial for developing tailored prevention and management strategies for this population group.

261 Of the 49 studies included in this review, 33 studies centered on diagnosing individuals with 262 ASWPD/DSWPD utilized a combination of actigraphy, sleep logs or diaries, DLMO, and 263 validated surveys reviewed by a clinician. These diagnosing approaches offer a comprehensive 264 assessment of various aspects related to circadian rhythm and sleep patterns. For example, 265 DLMO provides a direct measure of an individual's circadian phase, while actigraphy allows for 266 objective monitoring of sleep-wake patterns over an extended period. Sleep logs or diaries 267 provide subjective data on sleep habits and quality, complementing the objective measures 268 obtained from DLMO and actigraphy. Utilization of these approaches seeks to balance patient 269 and clinician burden and cost.

270

271 The literature on the diagnosis and treatment of CRSWDs generally aligns with the DSM 272 diagnostic criteria in recognizing the importance of assessing sleep patterns, circadian rhythms, 273 and the impact on daily functioning. Both sources emphasize the necessity of a thorough clinical 274 evaluation, including sleep history and objective sleep measurements. However, the literature 275 often highlights a broader range of treatment options, including chronotherapy³² and light therapy,^{20,37} which are not prominently featured in the DSM guidelines. Additionally, the 276 277 literature underscores the role of genetic factors more explicitly than the DSM, indicating a 278 potential area for further integration. Moving forward, establishing a consensus between the 279 diagnostic criteria and treatment options outlined in the literature and those highlighted in the 280 DSM is essential to enhance the well-being of individuals suffering from CRSWDs.

281

The Morningness-Eveningness Questionnaire⁴³ and Munich Chronotype Questionnaires, along 282 with the Pittsburgh Sleep Quality Index⁴⁴ and the Epworth Sleepiness Scale,⁴⁵ were the most 283 284 frequently utilized questionnaires in diagnosing ASWPD and DSWPD. Conversely, the 285 Depression Anxiety Stress Scales,⁴⁶ Hypersomnia Diagnostic Assessment Scale, Insomnia 286 Severity Index, Karolinska Sleepiness Scale, and DSWPD Sleep Timing Questionnaire were 287 less commonly employed. Depression Anxiety Stress Scales, Hypersomnia Diagnostic 288 Assessment Scale, Insomnia Severity Index, Karolinska Sleepiness Scale, and DSWPD Sleep 289 Timing Questionnaire are not frequently used in the diagnosis of CRSWDs because they 290 primarily assess other aspects of sleep such as depression, anxiety, stress, hypersomnia, 291 insomnia severity, and sleepiness levels rather than directly evaluating circadian rhythm 292 disturbances.

293

The former set of tools, including the MEQ, ESS, PSQI, and MCQ, are favored for their ability to comprehensively assess an individual's circadian rhythm and sleep patterns, essential in determining the severity of ASWPD and DSWPD. Finally, having these assessments reviewed by a clinician ensures thorough interpretation and integration of the data, leading to a more accurate diagnosis and personalized treatment approach tailored to the individual's needs.

300 Treatment options for ASWPD and DSWPD.

Seventeen studies investigated treatment options for individuals with ASWPD/DSWPD. The significant proportion of studies investigating treatment options for individuals with ASWPD and DSWPD highlights the growing interest in developing effective interventions to manage these CRSWD. Among the various treatment modalities explored, melatonin emerged as the most frequently utilized option, reflecting its role in regulating the sleep-wake cycle and its efficacy in addressing circadian rhythm disruptions. Moreover, the substantial utilization of light therapy

³⁰⁷ underscores its importance in synchronizing the circadian rhythm with the external light-dark ³⁰⁸ cycle, particularly beneficial for individuals experiencing delayed sleep-wake phase. Light ³⁰⁹ therapy⁴⁷ offers a non-pharmacological approach to resetting the circadian clock and promoting ³¹⁰ earlier sleep onset and wake-up times. CBT¹⁶ also garnered attention as a treatment option, ³¹¹ highlighting the recognition of the psychological and behavioral factors that influence sleep ³¹² patterns. CBT interventions aim to address maladaptive sleep behaviors and thought patterns, ³¹³ promoting healthy sleep habits and enhancing overall sleep guality.

314 The combination of melatonin, light therapy, and CBT in some studies reflects the adoption of a 315 multi-modal approach to treatment, leveraging the synergistic effects of these interventions to 316 address various aspects of circadian-aligned ASWPD and DSWPD disturbances. Additionally, 317 using other pharmacological agents such as ramelteon underscores the ongoing exploration of 318 novel treatment options for ASWPD and DSWPD and the need for further pharmaceuticals 319 aimed at treatment of circadian disruption. Overall, the diverse array of treatment modalities 320 investigated underscores the complexity of CRSWD and the need for individualized approaches 321 to management. Further research is warranted to elucidate the comparative efficacy and long-322 term outcomes of these interventions, ultimately improving the quality of care for individuals 323 affected by ASWPD and DSWPD.

The ChatGTP findings highlight the effectiveness of refining data extraction criteria, resulting in a significant increase in accuracy and relevance of the extracted data, with accuracy improving from 80% to over 90%. The use of standardized extraction parameters not only ensured consistency across various studies but also allowed for successful automation of the extraction process, thereby enhancing efficiency. The reproducibility of data extracted by independent reviewers further validated the robustness of the revised extraction methodology. Thus, using Al for performing literature reviews in the CRSWD space significantly enhances efficiency,

331 comprehensiveness, and accuracy. It can swiftly scan and analyze extensive literature, 332 automating searches across various articles, which greatly reduces the time required for 333 traditional reviews. It integrates both structured (Text) and unstructured (Tables and Figures) 334 data, ensuring a comprehensive review that incorporates multiple data streams

By applying consistent criteria for evaluating literature, ChatGPT minimizes human errors and biases, leading to more reliable and accurate systematic reviews. Its customizable searches and ability to handle large data volumes make it ideal for extensive reviews. Moreover, ChatGPT's cost-effectiveness and scalability save resources, making the literature review process in the CRSWD space more accessible and efficient for researchers, ultimately leading to higher-quality research outcomes.

343 Limitations

344 The lack of demographic data concerning race, ethnicity, and income levels in some reviewed 345 studies poses a limitation to the generalizability of these findings. The gender bias and 346 predominant focus on adults in the reviewed literature may inadvertently neglect the specific 347 needs of other demographic groups. Furthermore, the reliance on self-reported surveys in 348 certain studies introduces the potential for bias in diagnosis. These factors underscore the 349 importance of considering diverse demographic factors and employing objective assessment 350 methods to ensure the comprehensive understanding and accurate diagnosis of circadian 351 rhythm sleep disorders. A limitation of these findings is that the reliance on automated data 352 extraction and standardized parameters may overlook context-specific nuances, potentially 353 leading to missed or misinterpreted information that requires manual review to fully capture. 354 This review assessed only diagnostic and treatment options published in English.

356 We may have excluded some studies which did not meet strict inclusion criteria, potentially 357 omitting important evidence. based on our inclusion criteria. We faced challenges in combining 358 data from different studies due to differences in study design or measurement tools. Challenges 359 were also encountered in combining data from different studies due to variations in study design 360 and measurement tools, which prohibited our ability to conduct a meaningful meta-analysis or 361 draw cohesive conclusions on treatment and diagnostic criteria. The reviewed studies may not 362 be generalizable to other populations or settings, such as those in Africa and developing 363 countries, where no studies on CRSWD were found. Consequently, the review findings might be 364 limited primarily to individuals of European descent.

366 **Conclusion**

This systematic review comprehensively summarized and identified various diagnostic criteria and treatment options currently employed in different clinical and study settings. Additionally, it evaluated ChatGTP's effectiveness in data extraction and summarization for ASWPD and DSWPD. DSWPD emerged as the predominant focus for many studies, reflecting its higher prevalence compared to ASWPD. Diagnostic strategies primarily involved a combination of objective measures such as actigraphy and DLMO, complemented by subjective assessments like validated questionnaires.

Treatment modalities predominantly included melatonin, light therapy, and CBT, with some studies exploring multi-modal approaches. These findings underscore the complexity of CRSWDs and the need for individualized, multi-faceted treatment approaches to effectively manage ASWPD and DSWPD. It also highlights the need to establish a consensus between the diagnostic criteria and treatment options outlined in the literature and those highlighted in the DSM to enhance the well-being of individuals suffering from CRSWDs. Further research is warranted to refine diagnostic techniques and explore additional therapeutic interventions to

improve outcomes for affected individuals. Lastly, while ChatGPT is an effective tool for expediting data extraction and summarization, human oversight is necessary to ensure improved accuracy and relevance.
