48 ABSTRACT

49 Background: Rates of prenatal alcohol use in Sub-Saharan Africa (SSA) are increasing, despite 50 regulatory bodies urging pregnant women to abstain from alcohol. Tanzania has minimal policies, 51 interventions, and young female education addressing alcohol consumption during pregnancy (ACDP), 52 leading to a considerable number of pregnancies being exposed to alcohol and consequent health 53 consequences like fetal alcohol spectrum disorder (FASD). Research investigating the prevalence of 54 ACDP in SSA — specifically in Tanzania— is abundant. In Tanzania, there is a limited understanding of 55 alcohol use practices among pregnant women who consume alcohol (PWCA), as well as community 56 knowledge, attitudes, and cultural beliefs related to ACDP. Methods: A total of 655 individuals were 57 enrolled in this sequential, explanatory mixed-methods study using systematic random sampling between 58 October 2021 and May 2022. Quantitative survey data from 533 female patients presenting for care at 59 KCMC ED or RHC were analyzed to compare sociodemographic factors and alcohol use practices among 60 pregnant, younger non-pregnant, and older non-pregnant women using descriptive frequencies in 61 RStudio. Nineteen participants were purposively selected based on quantitative survey data for qualitative 62 semi-structured IDIs exploring knowledge, attitudes, and cultural beliefs surrounding ACDP. A grounded 63 theory approach was used to analyze in-depth interviews (IDIs) in NVivo. Results: A large percent of 64 pregnant women reported alcohol consumption of at least once per week (42.2%). Older non-pregnant 65 women had the highest rates of alcohol use per week (66.0%) and were more likely to believe alcohol use 66 was acceptable during pregnancy. Younger non-pregnant women reported the highest weekly alcohol 67 expenses and held the highest prevalence of harmful or hazardous drinking (HHD) (16.4%). Average 68 [SD] AUDIT scores were 1.70 [3.28] for pregnant women, 2.94 [4.79] for younger non-pregnant women, 69 and 2.51 [4.36] for older non-pregnant women. Older non-pregnant women exhibited the highest 70 prevalence of depression (31.4%). Average [SD] PHQ-9 scores were 4.71 [3.12] for pregnant women, 71 5.85 [4.80] for younger non-pregnant women, and 7.29 [5.55] for older non-pregnant women. Qualitative 72 analyses demonstrated that (1) cultural beliefs are intricately tied to perceived benefits of ACDP, (2) a 73 history of alcohol use preceding pregnancy largely influences ACDP, and (3) community views of PWCA 74 are negative. Significance: Our findings demonstrate a concerning trend of ACDP in Moshi, Tanzania.

- 75 Cultural and community beliefs, along with limited knowledge of ACDP, among women of all ages
- 76 appear to influence ACDP and community views of PWCA. Consequently, community-wide education
- initiatives and pre-pregnancy interventions highlighting the dangers of ACDP are necessary. Holistic
- result of the support services may help curb alcohol use and improve birth experiences. Further research is needed to
- replace a form of self-medication for depression, fear, anxiety, and pain in pregnant women in
- 80 SSA.

86 **1 INTRODUCTION**

As alcohol use increases globally, so do the number of alcohol-related health consequences,
including death and disability ^{1,2}. In a 2020 global risk assessment, alcohol consumption ranked among
the top ten factors impacting overall health, and served as a major risk factor for communicable, maternal,
perinatal, and nutritional diseases ².

91 A notable, well-established alcohol-related harm is the detrimental effect on pregnancy $^{2-4}$. 92 Alcohol use during this time period can cause an increased risk of birth defects, developmental 93 disabilities, miscarriage, intrauterine growth restriction, spontaneous abortion, preterm labor, and 94 stillbirth ^{3,4}. Global estimates from 1984 to 2014 indicated that approximately 9.8% of pregnant women 95 worldwide consumed alcohol⁵. Particularly prevalent in low- and middle-income countries, rates of 96 alcohol consumption during pregnancy (ACDP) can range from 2.5% in Nigeria to as high as 32.5% in 97 the Democratic Republic of the Congo (Popova et al., 2016). Fetal alcohol spectrum disorder (FASD) —a 98 congenital syndrome caused by intrauterine fetal alcohol expose and characterized by growth retardation, 99 facial dysmorphology, cognitive dysfunction, and neurobehavioral disabilities in the fetus— has an 100 estimated prevalence of 14.8% in Africa, further highlighting alarming rates of ACDP in the region ^{5,7,8}. 101 The WHO African region was found to have the highest prevalence of binge drinking, defined as having 102 four or more drinks on a single occasion, during pregnancy, estimated at 3.1%⁹. This is increasingly 103 concerning as populations with high rates of binge drinking have been linked to similarly high rates of 104 FASD 10-12.

105 Existing literature emphasizes the profound health consequences of ACDP in sub-Saharan Africa 106 (SSA), necessitating increased awareness and robust intervention strategies. The World Health 107 Organization (WHO) urges pregnant women to abstain from alcohol use due to the health risks for the 108 mother and fetus ¹³. However, countries such as Tanzania have minimal policy and health system work 109 addressing ACDP. Further, the findings regarding the association between alcohol use and perinatal harm 110 are not always communicated to pregnant women. The lack of intervention and young female education 111 contributes to a considerable number of pregnancies in Tanzania being subject to alcohol exposure, with 112 nearly 20% in Northern Tanzania and 15% in Dodoma, the capital of Tanzania¹⁴. In Moshi, Tanzania,

113 rates of alcohol use are 2.5 times higher than the national average, which raises concerns that similar 114 patterns of alcohol consumption likely extend to pregnant women, warranting further investigation¹⁵. 115 Cultural practices and beliefs are intricately linked to ACDP in SSA, impacting pregnant 116 women's decision to alcohol consumption. Cultural traditions and values are passed down through 117 generations and constitute knowledge that effectively shapes pregnant individuals' alcohol use practices, 118 complicating some education efforts. Comprehending the extent and depth of cultural influences on 119 ACDP is critical to developing culturally appropriate interventions aimed at preventing alcohol use 120 among pregnant women. 121 Research investigating the prevalence of ACDP in SSA is abundant ^{6,9,14,16}. However, there is a 122 limited understanding of alcohol use practices, the knowledge and attitudes related to ACDP, and the 123 ways these impact cultural beliefs among both pregnant women and women of child-bearing age. This 124 information is needed to inform future intervention design and policy efforts, as well as bolstering 125 education efforts for women of childbearing age, with the ultimate goal of better supporting pregnant 126 women and reducing alcohol-related pregnancy complications. This study aims to address this gap by 127 providing a more comprehensive understanding of the sociocultural factors, such as knowledge and 128 attitudes, influencing alcohol use practices among pregnant women presenting to either the Kilimanjaro 129 Christian Medical Centre (KCMC) Emergency Department (ED) or Reproductive Health Center (RHC). 130 The objectives of this study are to (1) evaluate the proportion of pregnant women who consume alcohol 131 (PWCA), (2) investigate consumption patterns and alcohol use practices of pregnant women and non-132 pregnant women, accounting for child-bearing age (3) assess community knowledge, attitudes, and 133 cultural beliefs on ACDP.

134 **2 METHODS**

135 Study Design Overview

136 This analysis originates from a sequential, explanatory mixed-methods study conducted in Moshi, 137 Tanzania —an urban town with over 200,000 residents—focused on exploring unhealthy alcohol 138 consumption at the KCMC ED and RHC. The high concentration of injury patients at KCMC's ED and 139 the large female patient population at the RHC provide ideal settings to study risky alcohol use behaviors, 140 particularly among pregnant women. Participants were prospectively recruited for this study starting in 141 October 2021 and ending in May 2022. Quantitative surveys and qualitative semi-structured in-depth 142 interviews (IDIs) were conducted, with surveys used to guide purposeful qualitative data sampling. A 143 total of 541 women were enrolled in this study, with 533 providing complete survey data. In addition to 144 women, men were included in in-depth interviews (IDIs) to provide a broader community perspective on 145 ACDP, totaling 10 female and 9 male IDI participants. A thorough overview of the methods has been 146 previously published ¹⁷.

147 Exclusion Criteria

Those eligible for study participation had sought medical care at the KCMC ED or the KCMC RHC¹⁸, were over the age of 18, not prisoners, fluent in Kiswahili, and able to provide informed consent. Ability to provide consent was defined as being clinically sober, medically stabilized, and physically able to complete the survey verbally. Pregnant females were defined as women who had a confirmed in-utero pregnancy, based on self-report. Literature defines the reproductive lifespan of women as 45 years and below⁴⁵. This criterion was used as the cut-off value to distinguish between childbearing age (\leq 45 years; e.g., younger) and non-childbearing age (46+ years; e.g., older) among non-pregnant women.

155 **Quantitative Data**

156 Procedures

Using intake triage registries from the ED and the RHC, a systematic random sampling approach
was used to approach every third patient seeking care. Gender-matched Tanzanian research assistants
proficient in Kiswahili provided a comprehensive overview of the study to participants in a quiet and
private clinic space, only after the patient had achieved medically stability and clinical sobriety. Patients

were given the opportunity to inquire about the study, decline participation, or express interest. For those
willing to participate, a detailed discussion regarding the study, including potential risks and benefits,
took place. Written informed consent was then obtained. Patients who were illiterate marked their initials
or a cross mark. Survey questions were read aloud to encourage participation across different literacy

165 levels.

166 Instruments

167 Quantitative surveys were the primary instruments, assessing baseline sociodemographic factors, 168 self-reported alcohol use, Alcohol Use Disorder Identification Test (AUDIT) scores, Drinker's Inventory 169 of Consequences (DrInC) scores, and Patient Health Questionnaire (PHQ-9) depression scores. The 170 Tanzanian research team translated, reviewed, revised, and pilot-tested all survey questions on 171 sociodemographic data and self-reported alcohol use prior to data collection. Participants were asked to 172 report their alcohol consumption quantity in terms of standard drinks, per WHO guidelines where one 173 standard drink contains 10 grams of pure ethanol ¹⁹.

To comprehensively assess alcohol consumption and unhealthy alcohol-related behaviors among pregnant women, the AUDIT survey tool —with scores ranging from 0 to 40— was employed 20,21 . An AUDIT score of 8 or above indicates clinically significant harmful or hazardous drinking (HHD), in both global and study settings $^{20,22-25}$. Patients with HHD (AUDIT \geq 8) were identified, as their alcohol consumption places them at risk for serious health consequences, necessitating additional alcohol-related treatment and social support 26 .

180 The DrInC survey quantitatively evaluates alcohol-related consequences, with higher scores 181 indicating greater consequences. It includes 50 yes-or-no questions across five domains: physical, intrapersonal, social responsibility, interpersonal, and impulse control ^{27–29}. The DrInC tool does not 182 183 measure severity or frequency of alcohol-related consequences, and no clinically relevant cut-off score 184 exists. This survey was cross-culturally adapted and clinically tested at KCMC before use in this study ²⁹. 185 The PHO-9 tool is globally recognized for diagnosing depression, scaled from 0 to 27. It includes 186 9 items assessing depressive symptoms such as appetite changes, sleep patterns, and thoughts of selfharm, with responses to each item scored from 0 to 3^{30-32} . Higher scores indicate more severe depression. 187

188 Translated into Kiswahili and validated in Tanzania, a score of 9 is the optimal cut-off for identifying

189 major depressive episodes (MDD), classifying patients into depression (PHQ- $9 \ge 9$) and non-depression

- 190 (PHQ-9 < 9) groups $^{30,31,33-36}$.
- 191 Analysis

192 Descriptive frequencies and statistics were used to compare sociodemographic factors and 193 alcohol use between pregnant women, non-pregnant women of childbearing age (≤45 years), and non-194 pregnant women not of childbearing age (>45 years). Quantitative measures, including AUDIT, DrInC, 195 and PHQ-9 scores, were also compared between pregnant and non-pregnant women. Continuous and 196 categorical data were compared using Analysis of Variance (ANOVA) type 3 sum of squares, and 197 Pearson's chi-square test, respectively. Data analyses were performed using user-tested packages in

198RStudio (version 1.4).

199 **Qualitative Data**

200 Sampling

201 Individuals from the quantitative survey were purposefully sampled to participate in semi-202 structured IDIs, ensuring a diverse range of demographic backgrounds like age, marital status, education 203 level, occupation, tribe, and religion. Those considered for IDIs were individuals reporting neutral or 204 positive past experiences with alcohol, former alcohol users who are currently abstinent, patients with 205 close friends or family members who consume alcohol heavily, and those who suffered adverse 206 consequences from their own drinking. This methodological approach aimed to capture a wide range of 207 perspectives on ACDP. To further ensure a holistic view of community knowledge and personal 208 perspectives on ACDP, a gender-balanced approach was used. That is, we aimed to interview ten males and ten females since data saturation is typically reached around 20 interviews ^{37–39}. However, saturation 209 210 was reached with 19 IDIs, comprising nine males and ten females

211 *Procedures*

Upon completion of the quantitative survey, research assistants identified suitable candidates forIDIs using their professional judgment, with monthly reviews of sociodemographic and alcohol-use-

214 related data conducted to ensure diverse representation of participants. Consenting participants provided

their phone numbers to schedule interviews.

Interviewers were fluent in Kiswahili, gender- matched, and had previously established rapport
with the patients during the survey phase to foster open and candid discussions, especially on sensitive and
stigmatized topics. Prior to starting the one-on-one interviews, the study goals were communicated, and
participants received 5,000 TSH (~2 USD) to cover transportation costs. All interviews were audiorecorded, typically lasting 60 to 100 minutes, and included a break with snacks. These semi-structured
IDIs were assigned unique identification numbers, ranging from IDI #1 to IDI #19, of which were
known only to the research team.

223 Instrument

The interview guide utilized for IDIs included open-ended questions —originally created in English, and then translated into Kiswahili— with probes built in for additional questioning when the subject matter was ambiguous, vague, interesting, or inconsistent. Cultural appropriateness and relevancy were ensured during pilot testing. The standardized interview guide and related probes (Supporting File 1/Appendix) were used for all participants to assess community knowledge, views, and perspectives on ACDP.

230 Analysis

231 Qualitative data was analyzed using an applied, thematic, grounded theory approach, where IDI 232 responses were collected and analyzed without pre-existing theoretical frameworks ^{40,41}. Considering 233 research on pregnant female drinking behavior is limited in Moshi, the grounded theory approach was 234 well-suited to capture emerging themes. The Tanzanian research team was trained on qualitative analysis 235 and interview coding using NVivo 12. An iterative development process using inductive and deductive 236 coding schemes resulted in an initial codebook. To facilitate an ongoing synthesis of data and maintain a 237 dynamic codebook, content memos were created with each emerging theme, and subsequent code. To 238 enhance content validity and cultural accuracy, the final analysis was discussed between the entire 239 research team.

240 **Ethics Statement**

- 241 Prior to data collection, ethical approval for this study was obtained from the Duke University
- 242 Institutional Review Board, the Kilimanjaro Christian Medical University College Ethical Review Board,

- and the Tanzanian National Institute of Medical Research. Written consent was formally obtained from
- all participants. Personal health information used during screening and enrollment was de-identified for
- 245 confidentiality throughout data collection, storage, analysis, and sharing. Data was only shared in
- accordance with a data sharing agreement.

247 **3 RESULTS**

248 *Quantitative*

249 The study sample consisted predominantly of women who self-identified as Christian (81.2%), 250 and were affiliated with the Chagga tribe (50.0%), with ages spanning 17 to 95 years. On average, 251 pregnant women were 29.1 years younger than non-pregnant women, with over half of pregnant women 252 between the ages of 25 to 34 years (Table 1). Notable differences in marital status were also observed 253 between pregnant women and non-pregnant women. For women of childbearing age, those who were 254 more pregnant were more likely to be living with a partner in either a registered (61.2% vs 42.2% in non-255 pregnant women) or unregistered marriage (29.3% vs 12.9% in non-pregnant women). In comparison, 256 those not pregnant were more likely to be single (39.7% vs 8.6% among pregnant women) or divorced 257 (3.4% vs 0.9% among pregnant women). Younger women (pregnant or non-pregnant) were also more 258 likely to have attained a college-level education (51.7% and 50.8% vs 9.2%), be employed (72.4% and 259 62.1% vs 47.6%), and have higher personal and household incomes than older, non-childbearing women. 260 These values and others can be seen in Table 1.

342	pregnancy" (IDI #11, Male) and "they understand the effects of alcohol" (IDI #5, Male)

346	Perceived cultural benefits of ACDP and delivery
347	Cultural beliefs surrounding ACDP had both tribal and cultural origins. For example, nearly a
348	quarter of participants highlighted that members of the Chagga tribe encouraged moderate alcohol
349	consumption before, during, and after delivery. These norms encouraged pregnant women to "sip a small
350	amount of alcohol," (IDI #8, Male), as this was thought to provide benefit to the pregnant female and
351	unborn child. Specifically, it was thought that alcohol would "help the baby [to] grow big and become
352	active," (IDI #11, Male) with participants encouraging alcohol use "at the middle of pregnancy" because
353	"at that stage, the baby should grow and be strong before delivery" (IDI #8, Male)
354	Participants likewise highlighted numerous perceived benefits of alcohol use during labor,
355	including providing the mother with "increased power" (IDI #7, Female, Past Pregnancy) to push the baby
356	through the birth canal, alleviating stress, "[reducing] labor pain" (IDI #14, Male) and "abdominal
357	cramps" (IDI #12, Male), and "increase milk production for my baby to breastfeed" (IDI #7, Female, Past
358	Pregnancy). One female interviewee elaborated on milk production, recounting that:
359	"There is a notion where I live that taking alcohol during and after delivery increases milk
360	production and eventually the baby gets enough milk to breastfeedafter my third delivery where

361	my grandmother insisted for me to take it in order to increase milk production for my baby to
362	breastfeed." (IDI #7, Female, Past Pregnancy)
363	These beliefs, however, were not characteristic of all parts of Moshi. One participant highlights a
364	distinct discrepancy between village views and town views concerning PWCA, explaining that ACDP is
365	prevalent and accepted only in certain cultural contexts:
366	"The community views [PWCA] differently. If you ask people from the village, they would say its
367	right, but in town, because people are aware of the effect of alcohol, you may find few of them
368	who drink " (IDI #14, Male)
369	These results highlight the underlying cultural beliefs on the benefits of consuming alcohol during
370	pregnancy that may be influencing consumption patterns.
371 372	Perceived harms of ACDP
373	While cultural influence may support the use of alcohol during pregnancy, many participants
374	noted substantial harms of ACDP on the developing fetus, including premature birth, fetal anomalies, and
375	nutritional deficiencies. Additionally, respondents also expressed these harms extend to the mother,
376	including a detrimental impact on mental health and motor functioning. One respondent notes:
377	"The baby may be born with some abnormalities such as blindness, mental problems or born
378	prematurely. I have seen one female who was drinking during pregnancy, and she end up
379	delivering a premature baby." (IDI #11, Male)
380	Several participants also reported that ACDP contributed to the development of blindness,
381	neurological, cognitive, and motor disabilities. Of equal concern, a handful of participants suggested that
382	alcohol-induced appetite loss in expectant mothers could lead to nutritional deficiencies hindering proper
383	fetal development.
384	"Alcohol sometimes causes someone to lose appetite, it depends on the type of alcohol you drink.
385	You may drink alcohol and fail to eat properly, and harm the baby or the mother can get
386	anemia." (IDI #9, Female, Past Pregnancy)

387 The impact of alcohol use was seen to extend into the postnatal period. About a quarter of interviewees

388 cautioned against alcohol use during breastfeeding, noting that "*it will have impact on child*'s mental and

389 motor development and eventually restricts normal and proper growth of that child" (IDI #7, Female, Past

390 Pregnancy).

391 These risks extended to the mother as well, with a fifth of interviewees asserting that ACDP can

have a detrimental impact on female health, including engaging in unsafe sexual behaviors or disrupting

393 motor function, where an intoxicated pregnant women may "fall down and injure the stomach...[with] a

394 *possibility of terminating pregnancy*" (IDI #14, Male). As one interviewee explained:

- 395 *"In general, alcohol consumption during pregnancy is not good for a pregnant woman to drink*
- 396 too much alcohol. When got drunkard she can do unprotected sex with someone she does not
- 397 know and put herself at risk of sexual transmitted infections or AIDS during pregnancy." (IDI #9,
- **398** Female, Past Pregnancy)
- 399 Finally, a few interviewees emphasized the importance of adequate education on the detrimental
- 400 effects of ACDP, noting that "[Women] are always ready to try their best when they are given right
- 401 knowledge and education about the consequences of alcohol to themselves until delivery time and to their
- 402 *unborn babies*" (IDI #16, Female, Never Pregnant).
- 403 Community attitudes regarding PWCA

404 Negative community views of ACDP

405 Generally, community perspectives cast PWCA in a negative light. Most IDI participants claimed

that ACDP was prohibited and engaging in such behaviors would quickly attract social disapproval. To

407 avoid censure, one respondents specifically mentioned that PWCA tended to "drink privately" (IDI #8,

- 408 Male). Interviewees described that PWCA are viewed as incapable of suppressing alcoholic urges and of
- 409 making sacrifices for the sake of her child. This shared community attitude was epitomized by the
- 410 language used by respondents to describe PWCA who "does not wish good for her baby" (IDI #3, Female,
- 411 Never Pregnant). Participants claimed that the community views PWCA as "foolish" (IDI #10, Female,

412	Never Pregnant) and "taboo," (IDI #9, Female, Past Pregnancy) whereby alcohol consumption while
413	pregnant is "careless" (IDI #3, Female, Never Pregnant). Additionally, one participant stated, "The
414	community perceive them as 'risk taker', 'don't care' they can even be isolated in the community," (IDI
415	#4, Male) thereby demonstrating the profound influence of these adverse community perceptions on
416	PWCA.
417	Several participants compared PWCA to non-pregnant women who consume alcohol, implying
418	that PWCA are viewed particularly poorly. Specifically, participants posited that since pregnant women
419	actively "agreed to conceive," (IDI #9, Female, Past Pregnancy) they and their partner bore the
420	responsibility of ensuring the well-being and health of themselves, and of the unborn child. For example,
421	participants remarked that "whether she is educated or not education, a pregnant woman drinking alcohol
422	will seem it is it so wrong" (IDI #9, Female, Past Pregnancy) and when a woman drinks while pregnant,
423	"[the community] normally does some traditional ritual to her" (IDI #11, Male).
424	Rationalizations for why pregnant women consume alcohol
425	Several factors, collectively, were rationalized by participants to cause a pregnant woman to
426	either increase, decrease, or altogether abstain from alcohol consumption during pregnancy. First, nearly
427	half of the interviewees associated ACDP with an inability to stop consumption due to pre-existing

437	Moreover, participants held the belief that pregnant women are likely to increase alcohol consumption if
438	they experienced an unexpected pregnancy while unmarried. Such situations were thought to induce stress
439	and societal pressures for these expectant mothers, as elucidated by one participant's remark:
440	"We have one problem in our community, most men run away once they have [kids]. So due to
441	stress, this women start or increase the amount of drinking alcohol" (IDI #18, Male)
442	Second, over a quarter of participants believed that pregnancy hormones may cause a "strong
443	desire and cravings" (IDI #3, Female, Never Pregnant) for certain foods and drinks, including alcohol. For
444	example, one participant explained how pregnancy cravings may influence alcohol use:
445	"There are quite a number of pregnant women who take alcohol. Depending on their desires and
446	pregnancy cravings, some drink a lot, others due to pregnancy don't even want to smell
447	[alcohol], others remain using as they were before" (IDI #7, Female, Past Pregnancy)
448	While generally condoned, continued reasons for ACDP remain complex and multi-faceted.

449 **4 DISCUSSION**

450 This study aimed to explore perceptions and assess current rates of alcohol use among pregnant 451 women in Moshi. To the best of our knowledge, this is one of the first studies using a mixed-methods 452 approach to closely examine community attitudes around ACDP in Moshi, Tanzania-Our analysis found 453 that rates of alcohol use among pregnant women in Moshi remain high, with the biggest predictor of 454 ACDP being pre-pregnancy alcohol use. While overall, the community held negative views around 455 cultural beliefs and believed women should not drink at any point in their pregnancy, some sociocultural 456 beliefs encouraged ACDP. The high rates of alcohol use and complex factors influencing use point to the 457 need for robust community-wide health messaging coupled with patient-level, pre-pregnancy education 458 and holistic support in order to reduce this generational harm.

ACDP in Moshi remains notably elevated. We found that 42% of pregnant women attending
KCMC's ED and RHC consume alcohol weekly, drinking 1 to 2 standard drinks of alcohol per sitting,
with previous alcohol use being most associated with use during pregnancy. Our qualitative results

462 supported the commonality of ACDP, with this behavior noted to be frequently observed in local 463 communities, spurred by a lack of observed consequences. These rates are significantly higher than 464 previous, nearby studies that found ACDP to be 20% in Northern Tanzania and 15% in neighboring 465 Dodoma ^{14,16}. These findings, particularly the ubiquitousness of ACDP, are cause for concern given 466 existing recommendations that pregnant women should abstain from alcohol entirely ¹³. Populations 467 exhibiting high rates of alcohol consumption are typically associated with a high prevalence of FASD 9-12; 468 however, within Tanzania, like most of SSA, the true prevalence of FASD is not well understood and 469 corresponding literature is rare⁴². FASD and other alcohol-related congenital anomalies typically develop 470 early in pregnancy, often before women realize they are pregnant. Importantly, alcohol use behaviors 471 before pregnancy were identified as predicting ACDP as revealed in IDIs, with several participants noting 472 pre-pregnancy alcohol habits to be the primary reason for continued alcohol use. This is especially 473 important to consider as young women who are currently not, but may become pregnant, exhibited higher 474 levels of alcohol use (AUDIT = 2.94) and alcohol-related consequences (DrInC = 6.73), than other female 475 subgroups. Previous studies have identified pre-pregnancy alcohol use among young women to be a 476 significant predictor of alcohol use during pregnancy^{14,43}, with literature noting that the minimization of 477 these habits are key in reducing ACDP¹⁴.

478 In both our quantitative and qualitative analysis, ACDP was generally censured, however, 479 sociocultural and community observations and beliefs underlied continued alcohol use during pregnancy. 480 Survey data revealed that 70% of participants found any amount of alcohol to be unsafe at any point 481 during pregnancy, a finding qualitatively supported by the general negative community views of PWCA 482 and notable mentioned harms of this behavior. The observed societal stigma towards women who drink, 483 regardless of pregnancy, warrants further investigation to determine if this stigma is more profound in 484 pregnancy, or applies generally to all women. Aside from previous alcohol use, IDI responses provided a 485 more nuanced understanding of why ACDP continued within Moshi, mentioning stress, addiction, and 486 observations of other women who drank and gave birth to healthy children. It is imperative to note that 487 accessing mental health support is challenging in Moshi, Tanzania, particularly for women; only a small

488 percentage of women (9.4%) sought psychiatric treatment programs, despite a high prevalence of 489 depression (23.8%). Marlow et al. similarly found cultural beliefs played a role in alcohol use among 490 pregnant women in Lesotho and echoed the sentiment of alcohol as protective for the unborn baby⁴⁴. 491 Previous literature has also found stress and depression to be highly prevalent in women from SSA both during and after pregnancy 45-47, with stress also linked to increased alcohol consumption both in this 492 493 region and worldwide ⁴⁸⁻⁵¹. The influence of stress and addiction underlying ACDP points to a need for 494 future programming to incorporate components of mental healthcare, including improved availability and 495 access to mental healthcare, and the minimization of alcohol use among both pregnant and non-pregnant 496 women of childbearing age 49,52-55.

497 These factors illustrate the necessity of increased community-wide health messaging centered 498 around the dangers of ACDP, coupled with patient-level, pre-pregnancy education and holistic support for 499 women of childbearing age. For example, our analysis found that persistent beliefs, painting ACDP as 500 beneficial exist, illustrating that a gap remains in community education and practice. This call to action 501 joins other literature, which similarly has identified high rates of alcohol use during pregnancy in SSA, to 502 put greater focus on developing and implementing behavioral interventions ⁵⁶. Interventions to reduce 503 ACDP have been tried and tested worldwide, with formats being primarily medical-, psychosocial-, and 504 education-centered ⁵⁷. The most effective interventions for pregnant women were psychosocial-based, 505 specifically brief interventions (BIs), which is a focused, motivational interview delivered directly to the 506 patient and can be readily incorporated into prenatal care visits ⁵⁸. This intervention type may be 507 especially useful in Moshi, as BIs have been shown to be particularly effective in resource-constrained 508 settings, requiring little cost to operate and can be performed by lay healthcare workers ⁵⁹. Future 509 programming in this region should incorporate both increased community messaging while also 510 delivering effective education and support directly to expectant mothers.

511 Local policy efforts should be aware of the high rates of alcohol use still present in Moshi and re-512 focus health priorities on mitigating this preventable harm. Additionally, to better inform the creation of 513 appropriate interventions and programming, future studies should investigate the extent of current

alcohol-related fetal harm in Tanzania to ensure the most impactful prevention strategies are utilized.

515 Through these strategies, alcohol-related harm can be mitigated, with improved health outcomes for

516 present and future generations.

517 Strengths and Limitations

The primary limitations of this study include selection bias, as the population was recruited solely from one health facility in Moshi, which may not adequately represent the broader Moshi community, and recall bias, as alcohol use behaviors were self-reported through surveys. That being said, this one hospital evaluation will serve as a contextual framework for an implementation study and further literature about barriers to alcohol harm reduction in low resource settings. Additionally, it is important to acknowledge the uncertainty surrounding the observed prevalence of pregnant women who consume alcohol (42.5%) given the limited size of our sample of pregnant women (n = 116).

525 **5 CONCLUSION**

526 Our study highlights both current high rates of alcohol consumption among pregnant women in 527 Moshi, a behavior shaped in part by cultural beliefs and practices, alongside negative community attitudes 528 towards these individuals. Stress coping, existing alcohol dependency, and pregnancy-related cravings 529 constitute additional motivations for alcohol consumption among pregnant women. These findings stress 530 the need for future supportive, education-based programming for young women of childbearing age. 531 More holistic pregnancy-related healthcare services and infrastructure in this region may be the solution 532 to curbing alcohol use and improving health outcomes within the Moshi community.
