Abstract Introduction: Vascular surgery has been directed towards endovascular approaches; however, not all patients qualify for these procedures. Open vascular surgery remains crucial, demanding a steep learning curve. Exposure to these procedures has declined, resulting in a need for more standardization in acquiring open vascular surgery skills and potentially contributing to poorer outcomes. Simulation offers a solution, yet the evidence for structured programs in open vascular surgery is limited. This study aims to compare the efficacy of technical skill acquisition between a structured, progressive simulation-based training program and traditional experience-based training in open vascular surgery. Methods: A randomized, single-blinded, triple-arm educational clinical trial will be conducted. A control and intervention phases of three groups with different exposure levels to the simulation program are proposed. Group 1: open abdominal aortic repair, Group 2: vascular anastomosis and open abdominal aortic repair, and Group 3: specific surgical skills, vascular anastomosis, and open abdominal aortic repair. The 3D-printed models from AngioCT will be used for the open abdominal aortic repair simulation. Surgical residents of general, vascular, or cardiothoracic surgery programs will be included. Sample size calculation resulted in 45 participants, 15 per group. Single blinding will involve external evaluators. Randomization will occur as a stratified randomization. Discussion: We expect that the structured and progressive simulation-based training program would enhance technical surgical skills. Based on the progression through different modules within the program, we aim to evaluate differences in the acquisition of technical surgical skills. We hypothesize that 3D-printed patient-specific models can enhance participants' vascular surgery training and provide optimal simulated scenarios while prioritizing patient safety. We hope this initiative will impact the formation of future vascular surgeons, shape future training programs, and ensure comprehensive preparation for open vascular surgery. **Trial registration:** This study protocol was registered in clinicaltrials gov with the NCT-ID: NCT06452901. Manuscript body Introduction: Technological and scientific advancements in vascular surgical procedures have significantly shifted toward endovascular surgery (1). The most notable case is the management of Abdominal Aortic Aneurysms (AAA). where Endovascular Aneurysm Repair (EVAR) has revolutionized treatment by avoiding aortic clamping, reducing bleeding rates, shortening lower limb ischemia time, and minimizing changes in cardiac indexes and silent ischemic events (2,3). These advantages result in lower in-hospital mortality, shorter hospital stays, and faster recovery (4). Consequently, the use of EVAR for unruptured AAAs increased from 45% in 2004 to 83% in 2015 in the USA (5). However, not all patients are candidates for EVAR, resulting in the continued use of Abdominal Aortic Aneurysm Open Repair (AAOR) as the preferred treatment option in such cases (1,4). Performing an AAOR requires effective teamwork and a vascular surgeon with highly specific surgical skills (6). There is an inversely proportional relationship between the mortality of this procedure and the volume of patients managed by the institution and the surgeon (7). Interestingly, the mortality rate for AAOR increased from 3.2% to 4.1% between 2005-2009 and 2010-2013 (p = 0.008)(6). This increase in mortality rates can be partially attributed to the decreasing exposure to open vascular surgery (OVS) due to several factors, including the adoption of endovascular techniques, reduced working hours, and improved patient safety protocols (7). Globally, these factors have been noted to hinder the acquisition of technical surgical skills in OVS through experience-based learning (8). Consequently, the lack of standardized training and competencies due to inequitable opportunities to assist in OVS could be one of the multiple factors affecting surgical outcomes in AAOR (8). To address this issue, simulation-based training has emerged as a crucial tool for acquiring surgical technical skills, positioning itself as essential in training various surgical specialties (9.10). The traditional educational model of "See one, Do one, Teach one" is being replaced by "Do many on a simulator, attain competency, then perform under supervision in the operating room"(8).

In OVS, only isolated interventions such as simulations of vascular anastomoses (VA), AAOR, or carotid endarterectomies have been implemented, showing high efficacy in acquiring technical surgical skills (7,11,12). However, the evidence primarily consists of heterogeneous observational studies conducted by North American and European trainees (7). Despite their validity, these methodologies are based on individual learning structures and do not encompass comprehensive training programs (10). This shows the need for a structured, progressive, simulationbased program in OVS. Methods/Design: Aims of the study: The primary objective is to compare the efficacy of a progressive, structured simulation-based training program versus traditional experience-based training in acquiring technical surgical skills in OVS among residents in general, vascular, and cardiothoracic surgery. Secondary objectives include designing and implementing a micro-curriculum for progressive structured simulationbased training in OVS; assessing technical surgical skills in OVS before and after the implementation of the structured training program; analyzing differences in skill acquisition attributed to the varying levels of simulation exposure among different groups within the program; and evaluating the reaction and satisfaction of residents with the structured, progressive simulation-based training program in OVS. Study setting: The study will be conducted at the advanced simulation center of the Universidad del Rosario in Bogotá, DC., Colombia. Participants will include residents from any year of general, vascular, and cardiothoracic surgical programs from various institutions in Bogotá. Study design: An experimental, three-arm, randomized, single-blinded clinical trial will be conducted. The SPIRIT guidelines were followed (Fig 1 and S1 Appendix)(13). Due to its educational nature, a control and intervention phase will be conducted in all three arms (Figure 2). This allows all participants to have access to the potential benefits derived from the intervention.

Fig 2. Graphic representation of the methodological design of the study. In the control phase, participants will continue with experience-based traditional training and will not receive any simulation-based training intervention. A theoretical module will be provided in the intervention phase to ensure the minimum required knowledge. The simulation-based training program in OVS consists of three courses: specific surgical skills, isolated surgical skills (VA), and a complex surgical procedure (AAOR). Participants will be randomized into 3 groups with different exposure to the simulation-based program. Group I will only receive the AAOR training module. Group II will receive the VA and AAOR training modules. Group III will receive precise motor skills, VA, and AAOR training modules (Fig 2.) Each training module will consist of 2 practical sessions of simulation-based training per participant with a total of 6 hours. The sessions are organized according to the model established by Kopta et al. The first session is cognitive and integrative, where participants will observe an expert vascular surgeon performing the procedures, ask questions, and seek guidance. The remaining sessions will be autonomous (14). Sample Size Calculation: The minimum number of participants to achieve a significance estimate was made with the formula described by wang et al. $n = \frac{[(Z\alpha/2 + Z\beta)/(d-\delta))^2}{[(p^2(1-p^2)/k + p^2(1-p^2)]}$, were n represents the sample size per group (intervention and control)(15). $Z\alpha/2 = 1.28$ is the critical z-value for the desired significance level (e.g., for a significance level of 10%). $Z\beta = 0.8$ is the critical z-value for the desired power (e.g., for a power of 80%). $\delta =$ 16% margin of superiority, d = p1-p2 is the difference between the actual response rates of the intervention group. A superiority of 60% against 40% is expected. k = 1, same size between groups. Subsequently, we substitute into the formula that at least 39 participants (13 per group) would be needed. Additionally, 10% of enrolled participants are expected to drop out due to any circumstances that may arise and, therefore, not be analyzable. Thus, approximately 45 participants (15 per group) are needed.

Participant selection: Participants will be selected from residents in general, vascular, and cardiothoracic surgery, considered related specialties that potentially benefit from the intervention (16,17). Participants must be in good health and free from conditions that could interfere with study participation. Severe illnesses, known allergies to intervention components, or medical conditions that hinder study compliance may lead to exclusion. Individuals unable to provide informed consent due to cognitive or legal incapacity will also be excluded. Additionally, those with prior experience in structured open vascular surgery simulations will be excluded to avoid bias from pre-existing familiarity. The medical education department at Fundación Cardioinfantil-laCardio will disseminate the study through institutional emails to partner schools. Additionally, the study will be promoted on social media platforms such as LinkedIn, Instagram, and X. Potential participants will receive information about the study, its overall design, objectives, and expected benefits. Emphasis will be placed on the voluntary nature of participation. Only those who express a willingness to participate will be considered and provided with further information on the next steps. The process for expressing interest includes: (1) Completing an interest survey; (2) Receiving an email with more information, including informed consent, confidentiality agreement, and personal data consent form; (3) Responding to the email to confirm interest and submitting signed documents; and (4) Scheduling for randomization and a pretest. Participants will not be excluded under any circumstances based on sex, race, socioeconomic status, sexual orientation, university offering the residency program, or current level of training in medical residency. The invitation will not be sent or designed to include the name of a professor or person of authority so that communication is implemented neutrally and there is no influence from authority figures in the recruitment process. The disclosure process will be done through the official communication channels of the collaborating institutions involved in this study. Participant retention: When possible, program directors of the enrolled participants will be contacted to help reserve time frames. A schedule with the required time frames will be sent out from the beginning so that participants can adjust accordingly. A logistics team will frequently contact the participants to remind them of their session times, depending on the group they are allocated. "Make-up" days will be available for participants who are unable to attend a session, allowing them to complete it at an alternative time frame.

Informed consent: Each participant will be asked to give written informed consent before participating in the study. Researchers will provide detailed information about the study's objectives, procedures, potential risks, and benefits. Participation will be emphasized as voluntary, with the freedom to withdraw at any time without negative consequences (S2 Appendix). Randomization: Participants will be randomly allocated into one of the three groups using stratified randomization. Participants will be stratified based on two factors: their residency level (from first to fourth year) and their residency type (General vs. Vascular or Cardiothoracic surgery). Initially, participants will be categorized into subgroups according to their year of residency. Within each residency level subgroup, participants will further be divided into their type of residency. After establishing these strata, participants within each stratum will be randomly assigned to one of the three study arms. This approach ensures a balanced representation of residency levels and types across all groups, enhancing the reliability and validity of the trial results. The allocation sequence will be implemented using sealed envelopes and the randomization will be conducted in a single session after all participants have been enrolled. The sequence will be computer-generated using the application randomization.com. Each participant will receive their assignment through sequentially numbered, opaque, sealed envelopes, ensuring that the allocation sequence remains concealed until the interventions are assigned. Blinding: Evaluators responsible for assessing the efficacy of the different interventions will undergo a single blinding procedure. These evaluators will be external and independent from the researchers and unaware of the participants' group assignments. Privacy regarding participants' group assignments will be maintained through coding and presentation of de-identified data. Data will be presented as a videotape without voices, with glove usage, and image distortion to prevent the identification of personal details such as gender, race, or other characteristics. Under no circumstances will the identity of the participants be revealed to the evaluators. Simulation models: A 3D printed AAOR simulation model is being developed (Fig 3 A and B). We aim to create 3D printed models from AngioCT images of three patients with unruptured AAA requiring AAOR at our institution.

Before using the diagnostic images, patients will be informed of the purpose of the study, ensuring that it does not affect their medical or surgical treatment. Patients must understand, accept, and sign an informed consent form to use their images in the creation of 3D models for research use only and anonymize the metadata of the DICOM files. Fig 3. Preliminary simulation models. (A-B) AngioCT 3D-printed models of a real-life patient with unruptured AAA (C) VA models using wooden platforms suspended by clamps at adjustable distances. (D) Specific micro-surgical skills simulation models will incorporate tools like elongated cherry tomatoes, prolene 6.0, and basic surgical instruments. The most suitable AngioCT images will be selected based on criteria such as image quality (including slice thickness, number, and spacing of slices) and the patient's clinical case, focusing on an unruptured AAA. This collaborative effort involves vascular surgeons and engineers using specialized software, Mimics Innovation Suite 25.0 (Materialise, Belgium), for medical image processing. Following image selection, the infrarenal abdominal aorta segmentation employs semi-automated threshold-based methods to isolate the blood volume. A 3D reconstruction is conducted, and the resulting file is exported in STL format. Subsequently, the aortic wall thickness is determined, set between 1.25 - 2.1 mm, based on the population's average abdominal aortic wall thickness to ensure a realistic feel for suturing in the 3D printed mode (18,19). It is assumed that the wall thickness throughout the model will be uniform. The 3D reconstruction model of the abdominal agrta will be divided into three segments: 1) the region of the aneurysm, 2) the region above the aneurysm, and 3) the region below the aneurysm. This division is intended for 3D printing of the model. Segments 2 and 3 (the regions above and below the aneurysm) will be printed in rigid material, while segment 1 (the aneurysm region) will be printed in flexible and elastic material. This approach optimizes resources since the aneurysm region will constantly change during practice. For 3D printing of segment 1 (the aneurysm region), PolyJet and LCD technology with Agilus30 (Stratasys, Ltd., USA) and flexible UV170TR (Photocentric, UK) photopolymer resins will be used, respectively, to obtain models with elastic and flexible material to allow suturing.

For segments 2 and 3, PolyJet technology with rigid VeroBlue material (Stratasys, Ltd., MN, USA) will be used (Fig **4**). Fig 4. Graphical representation of the models' selection process, reconstruction, and 3D segmentation. VA simulation models will be constructed using wooden platforms suspended by clamps at adjustable distances. This approach requires minimal material for the VA (Fig 3C). Specific micro-surgical skills simulation models will require tools facilitating the development of expected competencies, including elongated cherry tomatoes, prolene 6.0, and basic surgical instruments. (Fig 3D). Evaluation instruments: A range of tools previously validated for assessing surgical skills in OVS will be utilized. These tools include standardized grading rubrics and will involve external evaluators. The OPEn aortic aneurysm Repair Assessment of Technical Expertise (OPERATE) tool, developed and validated by Nayahangan et al., is a structured assessment instrument designed to ensure competency in AAOR (11,20). The assessment is divided into distinct domains: patient positioning, incision and exposure, proximal and distal control, aneurysm sac preparation, graft implantation, and closure. Each domain consists of tasks rated on a numerical scale (1-3-5), with higher scores indicating better performance. The validation demonstrated that the tool effectively distinguishes between varying levels of expertise, making it a reliable and robust method for assessing surgical competence in the AAOR (11). The Objective Structured Assessment of Technical Skills (OSATS) tool is widely recognized for evaluating surgical trainees' technical skills, including those in the vascular surgery (21,22). Each task is rated using a numerical scale and task-specific checklists, ensuring a comprehensive evaluation. According to Lladó Grove et al., the OSATS tool includes criteria such as respect for tissue, time and motion efficiency, instrument handling, procedure knowledge, operation flow, and use of assistants (21). These criteria are rated on a Likert scale, typically 1, 3, or 5, where higher scores indicate better performance. Sidhu et al. further expanded on the tool's utility by integrating it into a

advantageous as it aligns with current evidence supporting the benefits of medical simulation in the training process of surgical residents (16,17). This structure provides a robust framework for evaluating the differential impacts of the intervention but also ensures that every participant is provided with potentially valuable training opportunities. Also, following the Messick validation framework is critical in ensuring the robustness and credibility of simulationbased training programs, particularly in the context of OVS (7). According to Lawaetz et al., this framework provides a comprehensive approach to validating educational interventions (7). By adhering to it, our study aims to ensure that OVS's structured, progressive simulation-based training program is rigorously evaluated for its efficacy, fairness, and applicability. This approach enhances the reliability of the findings and supports the standardization of surgical training. Given the design and nature of this study, multiple biases may arise, necessitating effective identification and control strategies. Learning bias is a significant concern, with participants potentially experiencing period effects caused by changes in participants' conditions, such as varying exposure to surgical practices or self-learning, which will be controlled through pre-session surveys to identify confounding factors and ensure adequate randomization among the intervention groups. Sequence effects, influenced by the order of study periods, will be managed by adopting a logical phase based on the difficulty of "unlearning" acquired knowledge, thus providing a natural progression for the learning process. Integrating cognitive and technical lessons through a blended learning methodology is essential in modern surgical education. Jayakumar et al. highlight the significant benefits of e-learning in surgical education, noting that it allows for flexible, self-paced learning while providing access to a wide range of resources and interactive content (26). Additionally, Malas et al. emphasize the importance of visualization in simulation training for VA (14). Their findings indicate that visual learning aids, such as detailed anatomical models and procedural simulations, significantly improve trainees' technical skills. Combining cognitive lessons delivered through blended learning with hands-on technical training in a simulated environment creates a comprehensive educational experience that enhances understanding and practical proficiency.

The data audit team will minimize labeling bias, which results from systematic errors in participant classification, by carefully reviewing and verifying labels. Attrition bias, which arises if dropouts differ systematically from remaining participants, will be addressed by calculating additional sample size to ensure sufficient participant numbers at the study's conclusion. Measurement bias will be controlled using blinded evaluators and standardized evaluation instruments, with thorough training provided to ensure consistency and accuracy.

Despite the meticulous design, several limitations must be considered when interpreting the results. One significant limitation is the inability to blind researchers and participants who conduct and supervise the simulation courses, potentially introducing unconscious biases. The sequential and educational nature of the study presents a confounding variable, as it is impossible to "unlearn" previously acquired knowledge. Additionally, the study is designed to measure short-term learning impacts (Kirkpatrick levels 1 and 2) but does not assess longer-term outcomes (Kirkpatrick levels 3 and 4), which involve patient interactions and follow-up assessments (7). Financial considerations also pose a limitation, as acquiring high-quality simulators and implementing courses can incur substantial costs, potentially affecting the program's scalability in budget-constrained settings. Various funding avenues and cost-reduction strategies are proposed to address these challenges. However, the protocol has been designed to address these concerns effectively, ensuring the validity and reliability of the findings.






