Priority Setting for Multicenter Research Among Adults with Cerebral Palsy: A Qualitative Study

18 Abstract:

- 19 **Purpose:** Identify priorities for adult cerebral palsy (CP) research by engaging
- 20 individuals with lived experience, clinical investigators, and community leaders.
- 21
- 22 Materials and Methods: Qualitative descriptive study using iterative focus groups,
- 23 followed by inductive thematic analysis. Participants included adults with CP and
- 24 caregivers, clinical investigators, and community leaders in the CP and disability
- 25 spaces. We explored research priorities among three research areas identified a priori-
- bone health, kidney health, and preventive care.
- 27
- 28 **Results:** We conducted four focus groups (20 participants with lived experience; 10
- 29 clinical investigators; 9 community leaders). Most participants felt all topic areas were
- 30 very important, though preventive care emerged as the top priority. We identified three
- 31 overarching themes that cut across the various research areas discussed: patient and
- 32 provider knowledge gaps; a precision medicine approach for adult CP care; and the
- 33 need to address ableism.
- 34
- 35 **Conclusions:** Adults with CP face unique healthcare needs and risks as they age, and
- 36 the evidence base to guide their care lags significantly behind. Our study identified
- 37 preventive care as the top research priority for the adult CP research agenda. Next
- 38 steps in this line of research should focus on interventions to facilitate primary and
- 39 preventive care interactions for adults with CP.

41 Introduction

42

43 The lifespan for people with cerebral palsy (CP) is increasing, and the population of 44 aging adults with CP is commensurately growing.¹ Up to 90% of individuals with CP will 45 reach adulthood, and with medical and technological advances, the greatest gains are in those with severe CP.¹ Adults with CP have unique health needs and risks, with 46 47 higher rates of chronic conditions at younger ages than the general population.²⁻⁸ 48 However, adults with CP face fragmented care, difficulty finding comfortable or knowledgeable providers, and often feel like they guide their own care without sufficient 49 50 resources, particularly after leaving the pediatric healthcare system.⁹⁻¹¹ Prior 51 epidemiological studies have used population health services data to establish risk for chronic disease, condition severity, and factors associated with mortality.^{5,7,12-14} Kidney 52 53 disease, bone health, and primary and preventive care are all major areas of concern.¹⁵⁻ 54 ²⁰ Regarding bone health, fractures are common in both men and women with CP and lead to both increased morbidity and mortality.²¹ Improved screening and initiation of 55 treatment for adults with CP at high risk for fracture could reduce the risk of fracture and 56 57 associated sequelae. Adults with CP also have an increased risk of chronic kidney disease compared to adults without CP.^{17,18} However, early diagnosis and initiation of 58 59 treatment is complicated by low muscle mass and lower baseline creatinine levels in adults with CP, which may result in delays in diagnosis.²² Given these risks facing 60 adults with CP, in addition to greater risks of many other chronic illnesses, primary care 61 and preventive screening can facilitate earlier detection and treatment of many chronic 62 conditions. However, adults with disabilities, including CP, receive lower rates of many 63 preventive screenings than the general population.²³⁻²⁵ However, studies from large 64 data only identify problems; addressing them requires a different approach. 65 66 Collaboration between individuals with CP, clinical investigators, and community leaders 67 is necessary to advance scientific and clinical knowledge to move toward improving 68 69 health outcomes.²⁶ Engaging individuals with lived experience in all stages of the 70 research process facilitates the production of knowledge that is relevant and important 71 to those with lived experience, including individuals with lifespan disabilities.^{27,28} The 72 Cerebral Palsy Research Network (CPRN) is a learning health network for CP 73 consisting of more than 30 clinical sites and bringing together clinicians, researchers, 74 and persons with lived experience (i.e., individuals with CP, family members, 75 caregivers) to improve health outcomes for people with CP.²⁹ Leveraging the CPRN infrastructure can facilitate both the co-creation of an adult CP research agenda and the 76 77 development of a multicenter research program focused on adults and aging with CP. 78 With the overall goal of addressing negative health outcomes in adults with CP, the 79 objective of this study was to identify priorities for the adult CP research agenda by 80 engaging individuals with lived experience, clinical investigators, and community 81 leaders. 82

- 83 Materials and Methods
- 84
- 85 Study Design
- 86

87 This qualitative descriptive study used iterative focus groups to gather input from people

with lived experience, community organizations, clinicians, and researchers regarding

89 priorities for this research agenda. The Colorado Multiple Institutional Review Board

90 determined our study to be exempt from review (Protocol #23-1653). We report our

91 qualitative methods and findings in accordance with the Standards for Reporting

92 Qualitative Research.³⁰

94 *Participants and Procedures*

95

96 We conducted three rounds of focus groups that included knowledge sharing and 97 education related to potential research areas, followed by participant input on 98 recruitment, prioritization, and implementation. The first round of focus groups included 99 adults with CP and caregivers of adults with CP; the second round of focus groups 100 included clinical investigators; and the third round of focus groups included community 101 leaders, with details of focus group composition and eligibility criteria detailed in table 1. 102 We used purposeful sampling,³¹⁻³³ including maximum variation and snowball sampling 103 approaches for diversity of participant background based on characteristics in table 1. In 104 maximum variation sampling, key variables are selected by the research team and then 105 cases that vary from each other as much as possible are identified, allowing us to identify meaningful patterns from a diverse sample.³³ In snowball sampling, the study 106 team seeks information from key informants about other information-rich cases or 107

- 108 participants.³³
- 109

The study team developed the focus group guides based on the study objectives, prior 110 research, and input from CPRN clinicians and community members during webinars 111 112 detailing this study's proposed methods. Focus groups took place over Zoom 113 videoconferencing, lasted approximately 90 minutes, and were facilitated by a non-114 clinician member of the study team who is an adult with CP (JC) to minimize the 115 potential bias of having a clinician facilitator. Verbal consent was obtained at the start of 116 each focus group. Within each group, the study team first shared knowledge about 117 three potential research areas related to adults with CP (bone health and fracture risk, 118 renal function impairment, and primary care and preventive care gaps). These areas 119 were selected by the research team as high need, high potential impact areas for the 120 reasons described above, as well the ability to leverage CPRN's multisite network for future interventional studies in these areas. Then, the facilitator guided conversation to 121 122 glean participant perspectives on prioritization of these research areas, potential 123 barriers and facilitators to each area's implementation, and recruitment strategies. In the 124 second and third rounds of focus groups, results from the prior focus groups were 125 summarized and shared to iteratively build upon prior discussions. During focus groups with participants with lived experience and clinical investigators, we also assessed 126 127 perceived importance and ranked prioritization of these research areas via Zoom polling 128 function. Focus groups were audio-recorded with permission from participants and 129 professionally transcribed (Landmark Associates; Phoenix, AZ). Transcripts were de-130 identified prior to analysis. Participants also entered self-reported demographic data into 131 a secure REDCap electronic database hosted at the University of Colorado Anschutz 132 ahead of the focus groups.³⁴

134 Data Analysis

135

136 We used a qualitative descriptive approach that allowed us to explore, understand, and

- describe the varied perspectives of participants.³⁵⁻³⁷ The study team (CS, MG, EH)
- 138 coded transcripts inductively, creating codes based on emergent data.³⁸ The team met
- 139 regularly to reconcile and calibrate coded transcripts until a final codebook was
- 140 developed.³⁹ All transcripts were double coded by at least two of the three coding team
- members. We then categorized and grouped together all the responses and dialogue of
- the participants in the focus group. Using traditional thematic analysis, we reviewed and
- summarized quotations and identified salient themes.^{39,40}
- 144

145Results

- 146
- 147 We conducted four focus groups (20 participants with lived experience; 10 clinical
- 148 investigators; 9 community leaders). Demographic characteristics of participants are
- 149 listed in tables 2-4. Participants with lived experience had diverse levels of mobility
- 150 function, clinical investigators represented a variety of specialties, and community
- 151 organization leaders served both CP-specific and broader disability communities across
- the country.
- 153

154 Those who participated in the lived experience and clinical investigator focus groups

- 155 were asked to rate the importance of each of the three discussed research areas (bone
- 156 health, kidney health, preventive care) on a scale from 1-5 (1 = not important; 5 =
- 157 extremely important) and then to rank these areas from highest to lowest priority for the
- adult CP research agenda. Overall, all three topic areas were felt to be very important to
- 159 most participants who voted (figure 1). However, most participants ranked preventive
- 160 care as the highest priority (n=15/29, 52%; figure 2) with bone health also ranked highly
- 161 (n=11/29 ranked bone health highest, 38%).
- 162
- 163 From our thematic analysis, we identified three overarching themes that cut across the
- various research areas discussed: patient and provider knowledge gaps; a precision
- 165 medicine approach for adult CP care; and the need to address ableism. Table 5
- 166 presents each theme with illustrative quotes.
- 167

168 **Theme 1: Patient and Provider Knowledge Gaps**

- 169
- 170 Participants across focus groups discussed provider's simultaneous lack of awareness
- of and discomfort with the unique risks adults with CP face. Many participants with lived
- experience also shared during their focus group that they themselves were learning
- about these risks for the first time. Participants emphasized the need for education to increase provider awareness, but also to educate adults with CP directly to empower
- 174 Increase provider awareness, but also to educate adults with CP directly to empower 175 them to be advocates in their care. One participant clearly articulated the challenge as
- an adult with CP, since CP is often viewed as a childhood disability. This participant,
- along with several others, highlighted the need to educate individuals with CP about
- 178 these risks:

179	
180	I think most people feel like [CP is] just a childhood thing. It's not. It's a lifelong
181	condition, and the lack of providers in the adult world to take care of us and to
182	really know and understand what we're going through on a day-to-day [basis] is
183	really, really frustrating All these other complex things that we just talked about,
184	like the bone health and the kidney stuff and all the preventative screening, that
185	we're at a higher risk for all of those because of our CP, nobody told us any of
186	that. How are we supposed to know to advocate for ourselves, not just as an
187	adult getting older in age but as an adult with CP who are now at a higher risk for
188	all of these other things?
189	– Participant 4, adult with CP
190	
191	Several participants with lived experience as well as clinical investigators expressed
192	that improving medical and allied health professional training could be a way to not only
193	combat knowledge gaps, but also improved provider comfort in treating adults with CP
194	and other disabilities. As one participant shared:
195	
196	This is so incredibly important, this whole preventive medicine, preventive care
197	for adults with disabilities and particularly that piece about individuals not being
198	able to find a primary care physician that really understands cerebral palsy and is
199	willing to take time with the individual to discuss what their issues are. That leads
200	back into the training.
201	Participant 32, community leader
202	
203	A clinical investigator participant agreed, sharing:
204	
205	The way we set up our trainings out of primary care doctors for adults, they never
206	see childhood or rarely see childhood disabilities and so it's a huge problem.
207	Participant 22, clinical investigator
208	
209	In addition to training for medical students, training for physicians in residency and
210	fellowship was another identified area in need of significant improvement by clinicians.
211	One participant reflected on how separated pediatric and adult training for many
212	specialties is, and how this contributes to lack of provider knowledge and disparities in
213	care for adults with lifelong disabilities. Participants cited increased funding for and
214	changes to the requirements of residency training to incorporate lifelong disability care
215	as potential opportunities to improve residency training.
216	
217	Theme 2: A Precision Medicine Approach for Adult CP Care
218	
219	Participants expressed the need for a "precision medicine" approach to adult CP care,
220	or CP-specific care guidelines that take into account an individual's risk factors
221	(runctional level, age, sex, medical co-morbidities, etc.) to guide prevention, screening,
222	and treatment decisions. One participant wondered how mobility function (based on
223	Gross Motor Function Classification System (GMECS) levels) affected bone density and

the need for screening:

I was just wondering, have you guys talked about considering the GMFCS I was just wondering, have you guys talked about considering the GMFCS levels? I'm a pretty high functioning level one, and so I'm up and moving a lot. Obviously, that's way different than a level four or five. Is that somethin' that you guys are considering when you're talking about who to scan and who to think about this? Obviously, that's gonna affect—my bone density's gonna be a little bit different than somebody who's a three or a four or a five. I was just curious about

that.'

234 235 Examples of a precision medicine approach came out across all research topics. For 236 instance, regarding bone density screening, how can an individual's age, sex, mobility 237 status, medication history, fall risk, etc., be factored in to determine how often they 238 should undergo screening? Regarding kidney disease, how does one's medication use 239 and medical history (including bowel and bladder issues) affect their risk of renal 240 disease, and how does their muscle mass and mobility status impact interpretation of 241 markers of renal disease like creatinine? All of these questions, and more, affect 242 primary care and preventive screening. As such, a call for comprehensive, CP-specific 243 care guidelines was made by participants across focus groups. However, in lieu of CPspecific guidelines, participants expressed that at a minimum, adults with CP should 244 245 consistently receive the screenings and management recommended for the general 246 population.

248 Theme 3: The Need to Address Ableism

Unfortunately, several participants also noted ableism as a barrier to care. Oneparticipant elaborated:

A lotta times, doctors don't wanna even deal — this is a horrible, horrible reality, but a lotta times, doctors don't wanna deal with people with CP because they don't understand the way that we move. They don't understand us when we talk. -- Participant 1, adult with CP

A couple of participants with lived experience were concerned that their communication impairments, such as dysarthria, impacted provider-patient relationships, and one was concerned their speech may cause a provider to assume they are "drunk" (Participant 19, adult with CP). Several community leaders shared that barriers to care include ableist assumptions, like people with disabilities are not sexually active or won't have children.

264

265Then there's some practitioners that put up barriers saying that well, this person266doesn't need this [preventive] care because they're not going to child bear or267they're not—they don't have sex, those kinds of things. I think part of it is268dispelling those—a lot of it is dispelling those ableist attitudes.

Several clinical investigators also highlighted ableism as an urgent issue, citing
enhanced medical and health profession training as a potential way to mitigate this for
future generations of clinicians, as detailed above.

274 275

276 While these three themes emerged across focus groups and topic areas, they were

informed by participant experiences and perspectives that arose during discussion of

the following three potential research topics. Participant perspectives related to each of

these topic areas are discussed below, with participant-identified research questions

- related to these topics listed in table 6.
- 281

282 Bone Health

283

Many participants with lived experience had personal experience with bone health issues, and many clinicians found these issues extremely relevant to their practice. Community leaders also felt that these issues were important to both themselves and members of their communities. Despite experiencing multiple fractures, fractures from minor trauma, and low bone mineral density, those with lived experience also shared difficulty finding providers knowledgeable about and comfortable with their needs.

289 290

Since providers were unaware of the bone health risks facing adults with CP, they were unable to provide anticipatory guidance or lead screening, evaluation, or management

293 interventions to detect and/or treat bone health issues. Clinician participants expressed

uncertainty regarding best practices for bone health screening — for example, when to

get a bone density scan, how often, and if/when to initiate medications for bone health.

Furthermore, adults with CP shared that they, too, were unaware of these risks until

they had already experienced a fracture. For example, one participant broke her shoulder, requiring her to be in the hospital for three weeks and then in a long-term care

facility for a month. Prior to this accident, bone health had never been discussed.

300

301 *Kidney Health*

302

The increased risk of chronic kidney disease was new information for many participants with lived experience, and they consequently felt that increasing awareness among the community as well as providers was critical. A couple of adults with CP reported personal experience with renal issues, including nephrolithiasis and congenital kidney disease. Several clinical investigators shared that they saw issues like nephrolithiasis and bladder issues (e.g., urinary retention, chronic infections) more frequently than frank renal disease.

310

311 Interestingly, several participants brought up societal and environmental factors that

312 may influence kidney health. The lack of accessible restrooms and/or assistance to use

the restroom may cause some adults with CP to withhold from urinating, or may even

incentivize some to purposefully underhydrate themselves to avoid needing to urinate in

- 315 public. One of these participants recalled an experience where she did not go the
- bathroom for a whole day in college because of the lack of accessible bathrooms.

- 317 Several clinical investigators also discussed the impact of chronic underhydration on
- 318 renal health in adults with CP, and similarly tied in societal factors.
- 319

320 **Preventive Care**

321

322 Many participants across all focus groups felt that the issues and barriers surrounding

- 323 preventive care resonated with their experiences. Multiple participants in the lived
- 324 experience and community leader groups felt that the transition period between
- 325 pediatrics and adulthood was a particularly challenging time given changes in providers
- 326 and services, and the inaccurate view of CP as a static, childhood condition.
- 327 Participants again highlighted lack of provider awareness as a barrier to comprehensive
- 328 care and emphasized the importance of educating healthcare professionals as well as
- 329 the CP community about the unique health needs and risks of adults with CP.
- 330 Community awareness can help facilitate advocacy with providers who may be
- 331 unfamiliar with CP.
- 332
- 333 Several participants highlighted the significant accessibility barriers to preventive care,
- 334 particularly when it comes to women's health (e.g., mammograms and pelvic exams). In
- 335 this case, even if the PCP orders the appropriate screening test, if the healthcare facility
- 336 itself is inaccessible, then the test cannot be completed. Participants noted other
- 337 barriers to preventive care, including the time pressure of short preventive care visits, 338
- insurance barriers, access to a primary care provider (PCP). Clinical investigators also
- 339 found these barriers and challenges relevant to their clinical practice, and noted 340
- particular challenges for adults with CP in accessing dental care, nutritional counseling,
- 341 and sexual and reproductive healthcare.

343 Discussion

- 344
- 345 We sought to explore stakeholder experiences and identify research priorities for the 346 adult cerebral palsy (CP) research agenda to co-create a multicenter research program 347
- focused on adults and aging with CP. Using the infrastructure of the Cerebral Palsy 348 Research Network (CPRN), we conducted iterative focus groups with adults with CP,
- 349 caregivers, clinical investigators, and community leaders using a qualitative descriptive
- 350 approach. Participants identified issues related to preventive care as the top priority,
- 351 though also found bone and kidney health to be important issues. Through thematic
- 352 analysis of data, we identified themes that cut across these various research areas
- 353 related to patient and provider knowledge gaps, a precision medicine approach for adult
- 354 CP care, and the need to address ableism.
- 355
- Adults with CP face unique health risks, including greater risk of stroke and myelopathy; 356
- high rates of chronic fatigue and chronic pain; and high prevalence of many 357
- 358 cardiovascular, metabolic, respiratory, musculoskeletal, and psychological chronic
- conditions, as well as multimorbidity.²⁻⁸ Additionally, compared to adults without CP, 359
- adults with CP have higher healthcare utilization across all settings and 154% higher all-360
- 361 cause healthcare costs.⁴¹ However, despite this high burden of chronic disease and
- 362 healthcare utilization, the vast majority of clinical services, interventions, funding, and

363 research studies are focused on children, and CP in adulthood has been the focus of only 4% of all CP-related National Institutes of Health funding.⁴²⁻⁴⁴ In 2018, the CPRN 364 365 set a patient-centered research agenda for CP, including consumers, clinicians, and 366 researchers in the process, and identified issues related to aging with CP as the top research priority.⁴⁵ Our study built upon and expanded this top priority by exploring 367 specific topic areas related to aging with CP (bone health, kidney health, and preventive 368 369 care) and is the first to engage the adult CP community in doing so. Preventive care 370 emerged as the top priority among those discussed in our study, and improvements in 371 preventive care can facilitate the earlier identification and treatment of many chronic 372 diseases.

373

374 Participants throughout all focus groups in our study cited a lack of provider - and 375 patient – knowledge as a significant barrier to appropriate care. Many participants with 376 lived experience were learning of these unique health risks for the first time during our 377 study, and many also recalled having to educate their providers about CP. Prior studies 378 have also found a lack of knowledgeable providers to be a barrier to adult CP care.^{10,11} 379 In addition to lack of disability-specific knowledge, multiple studies have also found a 380 lack of adult provider *comfort* with developmental disabilities to be a major barrier to age-appropriate care.⁴⁶⁻⁴⁸ Our participants supported these findings, recounting clinical 381 382 encounters with providers who did not feel comfortable with their needs but also with 383 providers who were willing to engage and support them despite a lack of CP "expertise". 384 While there have been many educational programs designed to improve training of 385 medical and health professional students in caring for persons with disabilities, and 386 intellectual and developmental disabilities (IDD), in particular, many barriers to 387 instituting mandated disability education and training requirements persist (e.g., overfull curriculums, inadequate resources, lack of faculty champions).^{47,49-52} One study that 388 389 audited the IDD content of Australian universities' medical training found particularly low 390 presence of curricula on preventive health, sexual health, and women's health, which 391 reflected the care gaps noted by our participants. Interestingly, participants in our study, 392 particularly adults with CP, also emphasized the need to educate patients themselves 393 on the unique risks and needs facing adults with CP. Many adults with CP shared that 394 they are often their own best advocate in their care and desire CP-specific knowledge to 395 continue to advocate with their care teams. Empowering patients to self-advocate can 396 improve communication and enhance patient-centered care, goal-concordant care, and both patient and provider experience.^{53,54} Therefore, educational efforts should be 397 bidirectional, with efforts geared towards both health professionals and persons with 398 399 lived experience.

400

401 CP is an extremely heterogeneous condition, and individuals with CP can have multiple types and severities of functional impairments and medical comorbidities.⁵⁵⁻⁵⁸ Given this 402 heterogeneity, participants in our study highlighted the importance of a precision 403 404 medicine approach to care for adults with CP, taking into account an individual's risk 405 factors when making preventive, screening, and treatment recommendations. While 406 precision medicine is often used in reference to genomics and biomarkers, its definition 407 more broadly speaks to "individualizing the health-care process to the uniquely evolving health status of each patient."⁵⁹ And while the use of genomics and/or biomarkers to 408

409 guide CP care may be a long-term future goal, participants spoke to consideration of 410 variables like functional level, age, sex, medical history, and medication use in tailoring 411 an individual's care, thereby providing more effective and efficient care. In disability 412 healthcare and rehabilitation, precision rehabilitation focuses on delivering the "right intervention, at the right time, to the right individual" to maintain and optimize function.⁶⁰ 413 414 Similar frameworks have been described to tailor rehabilitation interventions to the 415 individual in spinal cord injury and traumatic brain injury and to guide physical therapy 416 interventions.⁶¹⁻⁶³ An example discussed by our participants focused on personalized approaches to bone density screening (e.g., using age, sex, mobility status, fracture 417 418 history, fall risk to guide initiation and frequency of screening). However, such an 419 individualized screening pathway would require large sample sizes and likely long-term 420 follow up. Near-term future studies should focus on exploring likely high-yield risk 421 factors to guide care, with the long-term goal of a more detailed, personalized approach. 422 Ableism influences many of the complex, multifactorial barriers to equitable healthcare 423 424 that people with disabilities, including CP, face.⁶⁴⁻⁶⁷ Indeed, adults with CP have lower 425 rates of annual wellness visits; experience fractured, inconsistent care; and have 426 healthcare teams largely driven by availability of providers rather than expertise or comfort.^{9,10,24,25,68} Prior studies have shown that most physicians believe that people 427 428 with significant disability have worse quality of life than those without disabilities; less 429 than half of physicians were very confident in their ability to provide equal care to 430 persons with disabilities; and physicians often feel overwhelmed by the demands of providing care to people with disabilities.^{64,65} In addition to the lack of provider 431 432 knowledge discussed above, our participants discussed the lack of adequate time in clinical visits to discuss their needs and concerns adequately, ableist assumptions 433 434 about sexual and reproductive health, and concerning communication challenges (e.g., 435 fear that clinicians would assume a patient is "drunk" due to speech difficulties). Some of these barriers may be particularly impactful in the primary care setting, where lack of 436 437 time, poor reimbursement, and care coordination burdens particularly impede access for patients with disabilities.⁶⁹ And while participants acknowledged these factors, several 438 439 also emphasized the importance of facilitating comprehensive primary care for adults 440 with CP, rather than delegating CP care to specialists, since primary care is frequently 441 the gateway to specialty care.

443 Study Limitations

444

This study has several important limitations. Participants were recruited from CP- and 445 446 disability-focused networks, and therefore our findings may not be transferable to the 447 general community, specifically to people who are less connected with and less active in CP research and advocacy efforts.⁷⁰ Similarly, while we were able to recruit 448 449 participants with lived experience who were non-White and Hispanic, the majority of 450 lived experience participants were White and non-Hispanic. While it is important to 451 amplify the voices of adults with CP in this type of research, our lived experience focus 452 groups only included one caregiver; therefore, the perspectives of a larger group of 453 caregivers, who often care for individuals with more severe disability, may differ. We 454 successfully recruited adults with CP with varying GMFCS levels; however, we did not

have sufficient numbers of participants within each GMFCS level to directly compare
 between subgroups. Future research could evaluate whether or not research priorities

457 vary based on one's functional mobility level.

458

459 **Conclusions**

460

461 Adults with CP face unique healthcare needs and risks as they age, and the evidence 462 base to guide their care lags significantly behind. Individuals with lived experience, 463 clinical investigators, and community leaders in our study identified preventive care as the top research priority for the adult CP research agenda. Knowledge gaps among 464 465 patients and providers alike, the desire for a precision medicine approach to guide care 466 for adults with CP, and the impact of ableism on care impacted all potential research 467 areas discussed. Next steps in this line of research should focus on interventions to 468 facilitate primary and preventive care interactions for adults with CP while continuing to 469 engage stakeholders in the research process. The research goals and design should 470 directly attend to the insights gained in this study. Participants also felt that bone health 471 was a significant issue, and future research should focus on delineating who is most at 472 risk for fractures and low bone mineral density to guide appropriate screening 473 measures. 474 475 Acknowledgements: This work was supported by the Cerebral Palsy Alliance Research Foundation (CPARF) who funded an Accelerator Award for work within the 476 477 Cerebral Palsy Research Network.
