

1 **Application of chaos and systems theories to explore health workforce re-organisation**
2 **following district splitting in Uganda**

16 **Abstract**

17 **Background**

18 District splitting (DS) began in 1962 and intensified in 1997 during implementation of
19 decentralization. This legislative process focuses on geographical demarcation. The health
20 system, organized along local government structures, was re-organized as a result of DS.
21 However, this study explored how the health workforce, as a component of the local government
22 health system, re-organized following district splitting.

23 **Methods**

24 Conducted between June and December 2018, the qualitative study involved 22 key informant
25 interviews in eight districts, representing four broader regions (North, Western, Eastern and
26 Central) of Uganda. Participants included district political leaders, local government staff, district
27 service commission members, district health team officials, and district senior management. Data
28 was collected using an interview guide and four themes were identified for deductive thematic
29 analysis.

30 **Results**

31 Findings reveal that district splitting led to an involuntary division of the health system between
32 old and new districts, triggering multidirectional reorganization of the health workforce. Health
33 workers were systematically allocated to districts based on the geographical location of their
34 health facilities during the splitting process. Subsequently, inter-district migration occurred
35 through health workforce secondment or appointment, while intra-health system migration
36 involved vertical movement of health workers within districts during recruitment. This
37 reorganization resulted in workforce shortages in health facilities vacated by migrating health
38 workers.

39 **Conclusions** NOTE: This preprint reports new research that has not been certified by peer review and should not be used to guide clinical practice.

40 The study concludes that district splitting caused unintended consequences as a result of chaotic
41 occurrences that led to reorganization of the health workforce in both new and old districts, and
42 caused gaps in service delivery capabilities. Adopting a systems and chaos perspective, the study
43 emphasizes the importance of considering frontline service delivery systems as subsystems of
44 the overall district system when evaluating the impact of district splitting. Such an approach
45 provides a comprehensive framework for understanding the disruptive effects of district splitting
46 on health system organization and service delivery.

74 **1.0 Introduction**

75 Decentralized administrative units are crucial for effective service delivery worldwide (Walker &
76 Andrews, 2015). In Uganda, the current local government structures can be traced back to 1948,
77 with district demarcation beginning in 1959. District splitting and subsequent, creation of new
78 districts, is part of decentralization efforts to bring services closer to citizens (Ojambo, 2012).
79 Between 1990 and 2019, Uganda saw a rapid increase in districts from 39 to 140 (Green, 2008;
80 Mutebi et al., 2019). Despite its advantages in bringing services (e.g. outpatient health services,
81 maternal and child health services, inpatient health services etc) close to people, district splitting
82 has also negatively impacted service delivery capabilities, especially in health, by disrupting
83 health system structures and creating new administrative burdens (Kuuml & Jane, 2014). Despite
84 claims that splitting enhances service proximity, studies conducted elsewhere appear to suggest
85 that it mainly serves political interests (Awortwi & Bert Helmsing, 2014). The consequences of
86 such splits on health systems, particularly on workforce organization, remain underexplored.

87 In Uganda, health system decentralization paralleled political decentralization, devolving health
88 system functions to local governments (Ojambo, 2012). This shift empowered district service
89 commissions to manage human resources, including health workforce recruitment (Mangwi
90 Ayiasi et al., 2019; Mansour et al., 2022; Uganda government, 1997). The tiered district health
91 system, aligned with administrative structures, comprises various levels of health service
92 provisions and mandates which corresponds to the workforce structures.

93 **The district health system structure and health workforce**

94 The health workforce is intricately linked to the hierarchical decentralized political system, with
95 each administrative unit having attached to the tiered healthcare levels and staffing norms
96 (Green, 2008; Ramadhan, 2014) See table 1. District splitting directly affects the subnational
97 health workforce structure and functionality, yet research primarily focuses on decentralization's
98 overall impacts (Bossert & Mitchell, 2011). This study aimed at using the chaos and systems
99 theories to explore how the health workforce as a building block of the district health system re-
100 organised itself following district splitting in Uganda.

101 **Theoretical Framework:**

102 The study utilized Chaos and Systems theories to examine the impact of district splitting on the
103 subnational health workforce. Systems theory views organizations as interconnected
104 subsystems, emphasizing holistic understanding (Chikere & Nwoka, 2015). Districts, comprising
105 various subsystems including health, experience destabilization and subsequent system
106 responses post-split.

107 Chaos theory suggests that system responses are nonlinear and unpredictable, characterized by
108 self-organization and feedback loops (Levy, 1994; Rickles et al., 2007). This leads to disruptions
109 and reorganization within health subsystems (Harrington & Voehl, 2016). Systems theory
110 informed the conceptualization of health workforce organization, while chaos theory analyzed
111 system response patterns post-split. The major components of chaos theory include;
112 interconnectedness, feedback loops, and self-organization, evident in informal feedback
113 processes and meetings facilitating efficient task performance and results attainment. These were
114 applied to guide the analysis of the study.

115 **Study design**

116 This was a cross-sectional exploratory study that used qualitative research methods with both
117 deductive and inductive thematic analysis.

118 **Study sites**

119 The study was conducted in four broader regions of Uganda i.e. Northern, Western, Eastern and
120 Central. Within each of these regions, two districts were selected for inclusion into the study.
121 Table two shows the eight districts selected for the study i.e. four old districts that existed before
122 the split i.e. Lira, Pallisa, Mukono and Mbarara from which the new districts of Dokolo, Kibuku,
123 Buikwe and Ibanda were carved out during the 2010 split. At least two districts i.e., an old and
124 new were selected from each region hence representation from four regions of the country. The
125 selection criteria of the four old districts were based on the Ministry of Finance and Economic
126 Planning (MOFEP) and Development Social Economic Status (SES) (GoU, 2010; Heller et al., 2010;
127 Kavuma Richard, 2009) where upon two districts were perceived to be performing well and the
128 other two perceived to be performing poorly.

129 **Study participants**

130 The study included a purposive sample of 22 participants: four elected district political leaders,
131 five local government staff, four district service commission members, four district health team
132 officials, and five district senior management members. Participants were selected based on their
133 involvement in health workforce organization before and after district splitting, ensuring they
134 were employed in the district during and after the split. Only those in leadership roles or
135 governing committees responsible for health workforce organization were included, with equal
136 representation from old and new districts. They were chosen for their strategic roles in health
137 workforce planning and management.

138 **Data collection methods**

139 **Key informant interviews**

140 Interviews were conducted in December 2018, and the information elicited covered respondent's
141 experiences spanning fourteen years from 2005 to 2018. These were conducted with senior
142 district officials involved in the recruitment process during district splitting. Participants were
143 selected from various categories: District Service Commission (DSC) members (Administrative),
144 DSC technical members (Administrative), District Health Managers (Technical), District Technical
145 Leaders (Administrative local government), and District political leaders (Politicians). These
146 categories were chosen for their critical roles in district planning and health workforce
147 leadership. Participants from both old and new districts were included to enable comparison.

148 Experienced interviewers with master's degrees conducted the interviews using a specially
149 developed guide covering the major themes from the research questions. Each interview lasted
150 about 45 minutes and was recorded digitally. Interviews took place at respondents' preferred
151 locations, usually their workplaces. The study also involved reviewing documents to understand
152 local government policies and decentralization regarding DS. Key documents reviewed included
153 the Public Service Standing Orders and the Human Resource for Health Policy in Uganda, which
154 informed recruitment and deployment processes.

155 **Data analysis**

156 Interview data were transcribed verbatim from audio recordings into Microsoft office word with
157 transcripts were coded deductively following the applied framework domains in Atlas.ti version
158 7 where the codebook was developed and the codes reflected the chaos theories as an analytic
159 framework, four themes were identified for deductive thematic analysis which included;;
160 Systemic assignment of health workers based on location during DS, inter-district health worker
161 migration (on secondment or appointment), intra-district health worker migration (within the

162 district), and health workforce shortages (due to vertical and horizontal migration). These
163 themes were analyzed to provide interpretive explanations, comparing data between old and new
164 districts and different healthcare system levels at the subnational level.

165 The first author and a social scientist independently reviewed and coded interviews using a
166 deductive thematic approach based on the key themes and later inductively following emerging
167 insights from the datasets. They discussed individual matrices, focusing on coding differences
168 until when variations were resolved. This process enhanced the quality, depth, and interpretation
169 of results.

170 **Ethical considerations**

171 The study was approved by the Institutional Review Board at Makerere University School of
172 Public Health (HDREC 140) and the Uganda National Council of Science and Technology (SS
173 2678). Administrative clearances were obtained from district political and health sector leaders
174 before conducting interviews. Respondents were informed about the study's objectives,
175 procedures, risks, and benefits. Interviewers had no prior contact with respondents. Interviews
176 were conducted only after obtaining written informed consent and a separate consent for
177 recording. They were conducted in quiet, secure locations chosen by respondents, interviews
178 ensured privacy and confidentiality. All identifying information was anonymized and replaced
179 with pseudonyms.

199 Results

200 Overall, twenty-two respondents were selected from the eight districts with an average of three
201 per district. The selection took into consideration the five types of cadre identified for interview.

203 Out of the 22 respondents interviewed, those 64 years and above group (36.4%) had the highest
204 number of respondents followed by those below 45 years (18.2%), 45-49 years (13.6%) and 60-
205 64 years (13.6%) respectively. Age was generally balanced between old and new districts with
206 almost equal numbers in each age group. There was only one female among the 22 respondents
207 interviewed, which could be a sign that the most dominant top leadership positions are held by
208 males. Using systems and chaos theory, the study examined the impacts of district splitting. Four
209 themes emerged: random health worker assignment, inter-district migration, intra-district
210 movement, and resulting shortages. Splitting the health system caused workforce reorganization,
211 random worker allocation, and exacerbated shortages. This affected all administrative levels,
212 disrupting operations and service delivery, and causing overall disruption, disorganization, and
213 delayed stability in both old and new districts.

214 Emergence of district health workforce management structures after reorganisation

215 Systemic assignment of health workers

216 District splitting occurred along geographical boundaries defined by the local government act.
217 Before splitting, health workers were attached to particular health facilities by the district health
218 officer and chief administrative officer. Post-splitting, health workers were systemically assigned
219 to new districts based on their location at the time of the split. Most workers remained at their
220 stations, with few moving to support new districts. Those who moved left gaps, prompting self-
221 organization to fill them. Staff mostly stayed put, with only seconded workers relocating, some
222 later choosing to move permanently.

223 *Most of our staff remained at their work stations after the districts split. It's only*
224 *those that were seconded to support the new district that moved, though some*
225 *later made up their mind to move on to the new district (CAO 3).*

226 Inter-district migration of health workers

227 During district splitting, old districts seconded health workers to new ones as per MOLG/PSC
228 requirements. Both old and new districts began appointing staff to fill vacancies. Seconded staff,
229 officially sent by old districts to new ones, started work while recruitment progressed. This led
230 to gaps in old districts, necessitating redeployment. Meanwhile, seconded staff were free to apply
231 for relocation or higher positions. Old districts retained key personnel, often senior staff,
232 influencing new district staffing. Tensions arose when new districts rejected non-native staff,
233 requiring higher authority intervention. Informal negotiations and lobbying formed to resolve
234 disputes, promoting self-organization. Over time, tensions eased through reconciliation,
235 showcasing the interconnectedness and power of dialogue among involved parties.

236 *We in the old district had the advantage of choosing who goes to the new district*
237 *especially when it came to setting it off, but still HWs who wanted to move due to*
238 *varying reasons, still moved on whether we accepted or not and we could not stop*
239 *them from moving. So those were struggles under the carpet that were agreed on*
240 *just like that (LC V Chair 1).*

241 *Seconding health workers was not an easy task because either district wanted*
242 *the best. I remember how the new district rejected the person we sent them and*
243 *demanding for another person. To me a beggar has no choice. You either take*
244 *what is available or leave (CAO 3).*

245 During the secondment process, friction arose as districts competed to attract senior or highly
246 qualified health workers. Some districts resisted releasing staff, while new districts offered
247 attractive terms of engagement/deployment, leading to unauthorized staff movements and chaos.
248 Individual decisions escalated, involving district leadership and triggering the "butterfly effect".
249 In some instances, reconciliation efforts, with support from Health Service Commission (HSC)
250 members and local opinion leaders, restored order through reorganization and return to sanity
251 within the districts.

252 *"You know time came when we competed for the good health workers we knew.*
253 *We had to offer better terms than our competitors so that the health worker is*
254 *convinced to join our district. This is allowed in this new arrangement of*
255 *decentralisation" but in most cases there was a lot of unofficial agreements*
256 *between the administration and staff (CAO 2)*

257 *We witnessed a lot of behind the screens moves as some health workers were*
258 *lobbying for movement to another district, and others were negotiating for*
259 *promotion even before being appointed. But because we are not technical, we let*
260 *them do the negotiation and the technical personnel handled that (LC V Chair 2).*

261 The secondment and appointment process received utmost attention across districts, with
262 District Service Commissions (DSCs) resisting any external influence. However, districts
263 prioritized qualified natives over "external" professionals with similar qualifications, causing
264 tension among leaders and necessitating crisis meetings. Feedback and consultations between
265 political and technical leadership arms, along with involvement of Health Service Commission
266 (HSC) or Public Service Commission (PSC), led to consensus on the way forward, restoring
267 normalcy.

268 *Let me tell you, the decision to retain and refer HWs created a lot of tension with*
269 *a lot of lobbying by both district councillors, HWs and the technocrats. At one*
270 *point we were in a planning meeting and some members started accusing each*
271 *other of influencing the screening to the extent of almost exchanging blows (DSC*
272 *Chair 3).*

273 *You know these district councillors thought they could force me into appointing*
274 *people without the right qualifications, I refused and assured them I was not*
275 *willing to face the inspector general of government because of corrupt tendencies*
276 *in the recruitment. I even asked them to put it in writing and I forward it to our*
277 *seniors in the ministry. That's when they all went silent (CAO 5).*

278 In new districts, District Health Officers (DHOs) served in acting capacities after being seconded
279 from old districts or appointed by the public service commission to initiate district health offices.

280 Many seconded health workers assumed automatic recruitment leading to preferential treatment
281 of health workers from old district which could have led to not following recommended
282 procedures when recruiting staff. This disorganized relations between workers and leaders,
283 impacting inter-district cooperation. Negotiations, mostly informal, resolved disagreements, but
284 in cases of irreconcilable differences, health workers returned to previous districts or sought
285 employment elsewhere.

286 *“When I was seconded to the new district, I thought it was obvious they were*
287 *going to recruit me because I had all the qualifications but surprisingly, I started*
288 *hearing talk from some colleagues that I was not a son of the soil. Meaning that*
289 *because I was not born in the district, the DSC had some other person they*
290 *preferred. I was only saved by the HSC representative who insisted that the*
291 *person they had fronted did not qualify for the post.” (DHO 2)*

292 The final task of appointing and deploying after secondment faced disruptions and interference
293 from various leaders. District Service Commissions (DSCs) and District Health Officers (DHOs),
294 guided by acting Chief Administrative Officers (CAOs), were responsible. Interference affected
295 DHOs, as health workers requested deployment near their homes or towns. DHOs would
296 occasionally hold informal meetings before releasing deployment schedules, involving district
297 leaders and technocrats to maintain good relations. Acting positions in new districts made
298 technical leaders vulnerable to political pressure, affecting decision-making. Appointments often
299 occurred in the presence of a Health Service Commission (HSC) member, providing support to
300 technical personnel.

301 *In my district we had several qualified health workers who had been in the same*
302 *positions for several years without being promoted due to lack of opportunities.*
303 *We therefore considered them during the recruitment process and appointed*
304 *them on probation in new positions as a way of motivation. (CAO 3).*

305 Many seconded staff from old districts were appointed on probation in their new districts, while
306 some acting staff not meeting requirements were advised to return to their previous districts or
307 accept lower positions, causing distress and disorganization. Those seeking official transfers but
308 not accepted faced dilemmas, as returning to previous districts was often not feasible, forcing
309 them to seek employment elsewhere. There was different treatment/handling of health workers
310 on a case by case basis which is reflective of lack or abuse of standard operating procedure for
311 managing human resource for health.

312 *“I didn’t like the way some of the seconded staff were treated by the DSC just*
313 *because they preferred candidates that were born in this district. We lost a*
314 *chance of getting very experienced and qualified staff because the DSC wanted*
315 *people born in the district “son of the soil”. (DSC Sec 2)*

316 **Intra district migration of health workers**

317 Following district splitting, health worker movement occurred within both old and new districts
318 due to gaps left by those on secondment or seeking new appointments elsewhere. Both districts
319 identified gaps, advertised vacancies, conducted interviews, and appointed new staff to fill the
320 gaps. Meanwhile, reorganization of available workforce ensured continued service delivery
321 despite gaps. District Health Officers (DHOs) redeployed staff to facilities with vacancies, facing
322 challenges as some workers resisted relocation. Meetings between health workers and their
323 leadership were held to resolve disputes, sometimes involving Chief Administrative Officers
324 (CAOs). Redeployment occurred in all districts post-splitting to address workforce gaps. After

325 probationary appointments, district health offices reorganized staff at all levels to maintain
326 quality healthcare services.

327 *Immediately after DS occurred, we had to do reallocation of health workers to fill*
328 *some of the key positions that had been created due to seconded staff. Then we*
329 *also reorganised the workforce after the final appointment of new staff (CAO 1).*

330 **Health workforce shortages**

331 Throughout the various forms of reorganization, the existing health workforce was distributed
332 across districts, creating gaps in each district, doubling the pre-splitting workload. Recruitment
333 efforts failed to fill all gaps, leading to further disruptions. Emergent gaps due to seconded or
334 unauthorized departures required reorganization and advertising of vacancies, exacerbating
335 understaffing and disrupting health facility operations. Districts already grappling with
336 understaffing pre-splitting faced worsened conditions. Filling vacancies awaited confirmation
337 from the Ministry of Finance, Planning, and Economic Development (MOFPED) on the wage bill.
338 Constant feedback meetings among affected district leaders facilitated secondments and
339 redeployments, achieving workforce balance across districts before addressing persisting gaps
340 through advertisement and recruitment.

341 **Discussion**

342 This study aimed at using the chaos and systems theories to explore how the health workforce as
343 a building block of the district health system re-organised itself following district splitting in
344 Uganda. This qualitative study examines the reorganization of the health workforce following
345 district splitting in Uganda, revealing its impact on both new and old districts. It explores how
346 reorganization within and between districts results in multidirectional workforce arrangements,
347 such as systematic assignment of health workers, inter-district migration of health workers, intra
348 district migration of health workers and health workforce shortages. Subsequently, these will be
349 elaborated on further in the sections that follow. The study offers fresh insights into the
350 interconnectedness of the health workforce and district systems, shedding light on the
351 complexities of their reorganization after district splitting.

352 The study also critiques broad discussions on decentralization, urging for a deeper understanding
353 of local government systems and their subsystems(Zaidi et al., 2019) to inform health worker
354 allocation following district splitting. It stresses the importance of policymakers comprehension
355 of these subsystems' interactions and formations to address the positive and negative impacts of
356 district splitting effectively(Abimbola et al., 2019). Despite challenges like respondent recall, the
357 study utilizes triangulation of data sources to mitigate these issues, enhancing the reliability of its
358 findings(Beesley et al., 2011; Durham et al., 2015). Detailed discussions about the results
359 following themes from the applied framework follows here next;

360 **Systematic assignment of health workforce**

361 Before district splitting, the decentralisation policy through the local government act gave
362 districts autonomous powers to advertise, interview and recruit health workers. These health
363 workers were already stationed across health facilities in all the selected districts. However, after
364 the splitting, most health workers remained at their original workstations based the district
365 appointment and deployment plans under their local government demarcations. Many avoided
366 moving due to observed disruptions and chaotic scenarios. Some were content with their current
367 stations, while others were reluctant to undergo the rigorous process of switching districts, which
368 involved either secondment by the Chief Administrative Officer (CAO) or applying through the

369 standard District Service Commission procedures. Another study conducted in Kampala city
370 showed that those who have lived in rural areas were less likely to report wanting to
371 emigrate(Nguyen et al., 2008).

372 **Inter-district migration of health workers**

373 After district splitting, some health workers were seconded to new districts by Chief
374 Administrative Officers (CAOs) to kickstart operations, causing disruptions in the old districts.
375 This led to gaps due to staff departures on secondment or appointment. New positions were
376 created at different levels in the health system structures of both new and old districts. However,
377 the movement of health workers between districts was not smooth, disrupting both subsystems
378 and the entire district structure. Disagreements arose on how to share available human
379 resources, affecting recruitment components interconnected within the system. In other studies
380 it was noted that these disruptions triggered emergent behaviours and took time to reorganize,
381 mainly due to political and technical differences between districts(Chen et al., 2021; Nalukwago
382 et al., 2019).

383 In this study, negotiations and rule bending occurred during secondments and appointments,
384 breaking some rules in order to facilitate recruitment. In a similar study the tension between rule
385 makers and breakers influenced the ecology of the field(Dzansi et al., 2016). Similar findings from
386 another study showed that negotiations, bargaining, and conflicts between district leaders,
387 technocrats, and health workers ensued, leading to disorganization within and between
388 districts(Parrish, 2022). However, through feedback negotiations, the chaos was eventually
389 normalized into a reorganized state(Renn, 2022; Schein, 2004).

390 In this study, a lot of negotiations during this period of splitting brought out the
391 interconnectedness of different players and self-organization which made it possible for
392 agreements to be reached. This chaotic period highlights the dynamics between rule breakers and
393 makers, shaping both tight and loose cultures within organizations(Lithwick, 2012). While chaos
394 presents challenges, it also leads to innovative solutions(Gelfand, 2019; Parrish, 2022). Studies in
395 Kenya have shown recruitment strategies focusing on geographic areas to minimize staff
396 transfers(Adano, 2008).

397 **Intra-district migration of health workers**

398 The recruitment process faced internal and external disruptions, delaying the process in most
399 districts. Suspected ulterior motives among committee members led to delays, requiring
400 extensive discussions and informal meetings for resolution. Respondents considered these to be
401 a result of political interference by different players which later resulted into several informal
402 meetings and consensus was reached by all concerned parties. Therefore, the formal process was
403 compromised, prompting management to adopt informal transparency measures, settling
404 disputes and allowing work to proceed. In another study it was seen that the decision-making in
405 behaviour change is often quantum rather than linear, with changes being conceptualized as
406 deterministic processes(Kenneth Resnicow, 2008). It was also observed that small issues during
407 redeployment caused friction among leaders but were resolved through formal and informal
408 discussions, reaching consensus. Some behaviour change events may be linear, while others may
409 be complex and nonlinear, requiring a chaos lens for understanding(Ken Resnicow & Vaughan,
410 2011; Kenneth Resnicow, 2008).

411 **Health workforce shortages**

412 After the completion of secondment, appointment, and redeployment across all districts, new
413 gaps emerged due to unauthorized departures, requiring reorganization and advertising of

414 vacant posts. These unforeseen movements disrupted work at health facilities, worsening
415 understaffing and posing challenges in transferring recently deployed workers. Time constraints
416 and financial implications compounded the urgency to fill vacancies before the end of the financial
417 year. The complex and chaotic nature of health worker behaviour change can be integrated into
418 public health interventions, offering insights into how individuals and organizations
419 adapt(Gardner et al., 2021). Despite completing the recruitment process, new gaps arose from
420 unauthorized departures, further disrupting the system. A complementary approach is
421 suggested, encouraging the incorporation of nonlinear concepts into intervention design and
422 analysis(Bien, 2004; C’De Baca & Wilbourne, 2004; Miller, William R C’de Baca, 2001; Miller,
423 2004). The solutions of yesterday had now become the problems of today (Agyepong et al., 2012).
424 Support from Chief Administrative Officers (CAOs) is crucial for District Health Officers (DHOs)
425 during deployment to mitigate complaints and discontent among health workers.

426 The study underscores the implications for reconceptualizing workforce management in
427 decentralized settings post-district splitting to enhance service delivery efficiency at sub-national
428 levels, especially in human resource for health organization. It challenges the instrumentalist
429 view of district creation as merely bringing services closer to the population, revealing
430 unintended chaos in health workforce distribution. By employing a chaos lens, the study
431 highlights non-linear disruptions and disorganization within the health workforce subsystems,
432 emphasizing the need for a more systematic approach to decentralization and district splitting to
433 achieve efficiency goals(Zanin & Martínez, 2022).

435 **Strengths and limitations of the study**

436 This paper is informed by district leaders and health workers perspectives of what happened
437 with the reorganisation processes after districts were split. Their views inform our conclusions
438 about the effect of district splitting human resources for health management focusing on the
439 reorganisation processes. All findings are from people who were present and directly
440 participated in these processes, the study brings first-hand experiences of what transpired, while
441 the systems and chaos theories show us the unforeseen inefficiencies that occurred in the
442 reorganisation process after splits had occurred. Its conclusions can reliably be assumed in
443 respect of other districts that have experienced district splitting. There could have been some
444 social-desirable bias given the area under study. It’s possible that there was some recall bias given
445 that the study was conducted some years after district splitting of 2010. It’s also possible that
446 there was social desirability and not wanting to talk about bad things about the district and its
447 human resource by some respondents. Due to the cross-sectional nature of the research, it was
448 unable to observe and provide for analysis of trends over time. Findings from the few study
449 districts are hard to generalise as experiences may have varied in other districts hence impeding
450 generalisability.

451 **Conclusions**

452 District splitting affected all district systems right through the physical divide along geographical
453 boundaries, through the whole district administrative structure, splitting the district councils,
454 district local government (all departments including health), DSCs etc. The health system was
455 generally affected as it aligns with the district local government structure from top to bottom, and
456 is categorised into four sub systems. These subsystems are interconnected, interrelated, and
457 interdependent, working together to produce optimal outcomes while collectively striving to
458 reorganize the health workforce to deliver quality healthcare.

459 We see how the formal system with linear thinking is disrupted and disorganised by political and
460 technical interference before it can reorganise itself back to normal. Even when the districts think
461 they are done with the reorganisation, and gaps have been filled, then they realise that some
462 health workers left their stations without official release. Then the process of reorganisation
463 continues on, meaning that the solutions of yesterday become the problems of today.

464 Findings suggest that without considering the consequences of underlying patterns,
465 interconnected actions, continuous feedback loops, and self-organizing mechanisms after
466 splitting, systems and subsystems do not perform as expected. Unexpected small errors can arise,
467 leading to a significant negative impact on the health workforce reorganization process.

468 The chaotic nature involves disorder, disruption and disorganisation of systems including the
469 health workforce. But then the process of reorganisation that follows chaotic happens, introduces
470 enabling conditions that include innovation, creativity and flexibility. These introduce an
471 environment of understanding among the different district leaders and health workers. If these
472 are considered during the planning and implementation of district splitting processes, they are
473 likely to benefit both parties and reduce the tension or chaos that is caused by the splitting.
