## Short-term and Long-Term Healthcare Costs Attributable to diagnosed COVID-19 in Ontario; Canada: A Population-Based Matched Cohort Study

#### Abstract

**Objectives:** Estimates of health system costs due to COVID-19, especially for long-term disability (post COVID-19 condition [PCC]) are key to health system planning, but attributable cost data remain scarce. We characterized COVID-19-attributable costs from the health system perspective.

**Methods:** Population-based matched cohort study in Ontario, Canada, using health administrative data. To assign attribution to COVID-19, individuals, defined as exposed (positive SARS-CoV-2 PCR test, 01/2020-12/2020) were matched 1:1 to an unexposed individuals (01/2016-12/2018). Historical matching was used to reduce biases due to overall reductions in healthcare during the pandemic and contamination bias. The index date was defined as the first occurrence of positive SARS-CoV-2 PCR test. We used phase-of-care costing to calculate mean attributable per-person costs (2023 CAD), standardized to 10 days, during four phases of illness: pre-index date, acute care, post-acute care (suggestive of PCC), and terminal phase (stratified by early and late deaths). Finally, we estimated total costs at 360 days by combining costs with survival estimates.

**Results:** Of 165,838 exposed individuals, 159,817 were matched (mean age 40±20 years, 51% female). Mean (95%CI) attributable 10-day costs per person were \$1 (\$-4, \$6) pre-index, \$240 (\$231, \$249) during acute care, and \$18 (\$14, \$21) during post-acute phases. During the terminal phase, mean attributable costs were \$3,928 (\$3,471, \$4,384) for early deaths and \$1,781 (\$1,182, \$2,380) for late deaths. Hospitalizations accounted for 42% to 100% of total costs. Compared to males, costs among females were lower during the acute care phase, but higher during the post-acute care phase. Mean cumulative per-person cost at 360 days was \$2,553 (\$2,348, \$2,756); females had lower costs (\$2,194 [\$1,945, \$2,446]) than males (\$2,921 [\$2,602, \$3,241]).

**Conclusions:** SARS-CoV-2 infection is associated with substantial long-term healthcare costs, consistent with our understanding of the PCC. Understanding phase-specific costs can inform health sector budget planning, future economic evaluations, and pandemic planning.

## Background

Although only recently emerged, SARS-CoV-2 has quickly become a leading burden to the Canadian healthcare system [1]. The health impact of SARS-CoV-2 ranges from asymptomatic to long-term disability due to the post COVID-19 condition (PCC), with the potential to cause substantial long-term costs to health systems [2, 3]. PCC is characterized by the continuation or occurrence of new symptoms three months following the initial SARS-CoV-2 infection, with these symptoms persisting for at least two months without any other explanation [4]. The US Household Pulse Survey reported that 31% of US adults with a history of SARS-COV-2 infection experienced PCC, and the Canadian COVID-19 Antibody and Health Survey reported a 15% prevalence of PCC among Canadian adults with a history of SARS-CoV-2 infection [5, 6]. Emerging data suggest an association between PCC and increased health service utilization for individuals requiring both outpatient and inpatient care [3, 7-9]. A US study found that over a period of seven months, overall healthcare costs nearly doubled for patients with PCC compared to those without it, with costs anticipated to rise further with extended follow-up [10]. Given the high prevalence of people who have been infected with SARS-CoV-2 (83% of Ontario adults by January 2024 [11]), evidence of long-term effects of COVID-19 and its impact on health services utilization is vital for health systems to understand the costs of caring for individuals with PCC across different sectors of the health system.

Previous studies that sought to characterize costs associated with COVID-19 were either focused on inpatient costs [12], the acute period [13], or the post-acute period only [14, 15]. These studies potentially underestimate the overall financial impact of COVID-19 as they did not comprehensively assess the healthcare costs beyond these periods. The importance of considering a longer time horizon is evident in recent studies documenting the long-term health [2, 3] and resource use [7, 8] impact of the PCC. Understanding the economic burden of COVID-19 at different stages of a disease allows for effective resource allocation and planning tailored to each phase.

The purpose of our study was to characterize acute and long-term COVID-19-attributable healthcare costs from the Ontario health system perspective among individuals who tested

positive for SARS-CoV-2 compared to matched unexposed individuals, using a phase-of-care approach.

## Methods

We report our study following the RECORD statement for observational studies [16].

#### Study design, setting, and population

We conducted an incidence-based matched cohort study to measure the attributable healthcare costs associated with COVID-19 among people registered in the publicly funded Ontario Health Insurance Plan (OHIP). Ontario is Canada's most populous province, with 40% of the country's population, and OHIP covers most residents. We used population-based, health administrative datasets that contain information about all publicly funded healthcare encounters covered by OHIP. COVID-19-related information included data on all COVID-19 clinical encounters, publicly funded polymerase chain reaction (PCR) tests, vaccinations provided, and public health case and contact management records. Area-based demographic information such as neighbourhood income quintile was obtained from Census data. All these datasets were linked using unique encoded identifiers and analyzed at ICES, an independent, non-profit research institute. **Table S1**, contains a description of all datasets used in this study.

*Exposed individuals:* We identified individuals as exposed if they tested positive for SARS-CoV-2 by polymerase chain reaction (PCR) between January 1, 2020 and December 31, 2020. This time period allowed for one year of follow-up of individuals classified as exposed, while limiting potential biases due to the emergence of variants of concern in December 2020 and vaccination starting in December 2020 [17]. Index date was defined as the first occurrence of a positive SARS-CoV-2 PCR test for an individual, based on the earliest of symptom onset date recorded in Ontario's Public Health Case and Contact Management Solution (CCM), specimen collection date, observation date or reporting date recorded in the Ontario Laboratories Information System (OLIS), or case report date in CCM. We excluded individuals with hospital-acquired SARS-CoV-2 infection, defined as follows: those who tested positive on day eight or later after admission, or up to two days after discharge, given a length of stay (LOS) of at least 8

days, or those who were readmitted with a positive test within eight days after discharge from the hospital [18-20].

**Unexposed individuals:** We identified unexposed individuals by taking a 50% random sample of the OHIP-registered population between January 1, 2016, and December 31, 2018. We chose a historical unexposed cohort because: (1) health service use declined by 27%-43% during the pandemic compared to pre-pandemic years, due to system, structural, and behavioural factors [21-23]; and (2) to avoid potential contamination bias because not all individuals with SARS-CoV-2 infection would have had a PCR test for a variety of reasons, such as being ineligible for PCR testing, lacking access to or desire for testing, or being asymptomatic, which ranged from 20-62% [22, 24, 25]. Unexposed individuals were assigned a pseudo-index date at random. Individuals with death dates prior to their pseudo-index dates were excluded from the study. Individuals assigned to the historical unexposed cohort were excluded from the exposed cohort.

Exclusion criteria applying to both groups included: not residing in Ontario, having invalid or missing sex, birthdate, or income quintile information, being aged  $\geq$ 65 years and not having any healthcare system interactions for the three years prior to the study start date (January 1, 2020, for the exposed group; January 1, 2016, for the unexposed group), being younger than 65 years and not having any healthcare system interactions for the ten years prior to the study start date, being older than 110 years, and residing in long-term care. All individuals were followed for one year from their index/pseudo-index date.

*Matching:* We used a combination of hard and propensity score matching on selected baseline covariates. Each exposed individual was matched to one unexposed individual using nearest-neighbour matching without replacement on index date (day and month) +/- 60 days, sex, age category (10-year range for adults, 2–7-year ranges for children and youth), resource utilization band, with a 2-year look-back window, and the logit of the propensity score using a caliper distance of 0.2 standard deviations [26, 27]. Resource utilization band were derived from the Johns Hopkins Adjusted Clinical Groups® (ACGs) System Version 11, and categorizes comorbidity into six groupings from non-utilizer to high complexity of illness [28, 29].

The propensity score included the following baseline measures: public health unit (PHU) of residence, rural/urban residence, census tract of residence (which are not contiguous with the boundaries of local public health units), frailty, high-risk occupation neighbourhood concentration quintile, immigrant status (yes/no), and Ontario Marginalization Index [30] quintiles for age and labour force, material resources, racialized and newcomer populations, and households and dwellings. Frailty was defined using Johns Hopkins ACGs [31]. High-risk occupation neighbourhood concentration quintile was based on the proportion of residents in a census dissemination area (DA) employed as essential workers in the following industries: Sales and Service, Trades, Transport, Equipment Operation, Manufacturing and Utilities, Resources, Agriculture, and Production.

Since healthcare utilization and associated costs tend to increase before death [32], we examined attributable cost prior to death by re-matching exposed individuals who died to unexposed individuals who also died during the observation period on their death dates (day and month) +/- 30 days, sex, income quintile, recent immigrant and the logit of the propensity score using a caliper distance of 0.2 standard deviations [26, 27]. The propensity score included the following baseline measures: PHU of residence, rural/urban residence, census tract of residence (not contiguous with the boundaries of the PHUs), high-risk occupation neighbourhood concentration quintile, and Ontario Marginalization Index quintiles [30] for age and labor force, material resources, racialized and newcomer populations, and households and dwellings. Balance for all matches was assessed using standardized differences with a threshold of 0.10 [26, 27].

#### Outcomes

The outcome was healthcare costs adjusted for survival over a one-year period following the index date. Costs in 2023 Canadian Dollars were calculated from the Ontario health system perspective (i.e., OHIP), and included all publicly funded health services: inpatient hospitalizations, outpatient hospital visits (same-day surgeries, outpatient cancer therapies and dialyses), emergency department visits, publicly funded drugs (for everyone aged ≥65 years and

select younger individuals based on means) physician services, rehabilitation services, complex care, homecare, long-term care, and other (e.g., laboratory tests/services, OHIP-covered non-physician services, assistive devices).

#### Analyses

To calculate survival-adjusted costs, we first estimated healthcare costs, standardized to 10 days, by dividing each patient's total cost by the number of follow-up days, from the index date to the end of follow-up or death and multiplying by 10, using ICES person-level costing methods [33]. Next, we used the phase-of-care costing approach to assign 10-day costs to phases of care along the natural history of disease trajectory [34]. Phase-of-care lengths were determined based on clinical expertise (JK, SM), WHO's definition of the PCC [4] and joinpoint analysis, identifying the best-fitting points where statistically significant changes occurred in the trend of mean 10-day costs [35]. We defined four phases of care: pre-diagnosis (30 days prior to index date), acute care (80 days post index date), post-acute care (time between acute care phase and terminal phase follow-up), and terminal (60 days prior to death date) phase. We further stratified deaths as "early", if death occurred within 60 days of index date, and "late" if death occurred more than 60 days following index date. We calculated mean attributable phase-ofcare-specific costs (standardized to 10 days) and 95% confidence intervals (CIs) using a generalized estimating equation (GEE) model. Lastly, we combined attributable phase-of-carespecific costs with crude survival data to determine 1-year costs adjusted for survival as described by Yabroff et al [34].

We stratified analyses by age (<2 years, 2-4 years, 5-11 years, 12-17 years, 18-29 years, 30-49 years, 50-69 years, and  $\geq$ 70 years), sex, income quintile, and resource utilization band quintile. To understand the impact of phase length on COVID-19-attributable costs, we conducted sensitivity analyses where we varied the lengths of the pre-diagnosis (120 days prior to index date), acute care (30 days post index date), post-acute care (time between acute care phase and terminal phase follow-up) phases.

We used SAS Enterprise Guide 7.15 (SAS Institute, Inc.) for all statistical analyses.

### Results

#### Study cohort

Between January 1, 2020, and December 31, 2020, we identified 181,979 Ontario residents who tested positive for SARS-CoV-2 (**Figure 1**). Among them, 165,838 met eligibility criteria for the exposed cohort with a mean age of  $40.4 \pm 19.7$  years and 50.7% were female. There were 6,641,074 unexposed individuals residing in Ontario between January 1, 2016, and December 31, 2018 who were eligible for matching, with a mean age of  $40.5 \pm 22.8$  years and 50.6% were female (**Table 1**). Prior to matching, compared to unexposed individuals, exposed individuals were more likely to be immigrants, and live in urban areas and neighbourhoods with a higher proportion of the population having lower material resources, a higher proportion of racialized and newcomer populations, a higher proportion of essential workers, and lower household incomes.

Most exposed individuals (96.0%) were matched to an unexposed individual. The matched cohort consisted of 319,634 individuals (159,817 exposed and 159,817 unexposed), with an average age of 40.4 ± 19.8 years, 50.7% were female, 24.5% lived in neighbourhoods with the lowest income levels, 20.7% had high or very high resource utilization, and 2.3% were frail (mean ACG score 4.9) (**Table 1**). The matched cohort was well-balanced, with no standardized differences above 0.1. Unmatched exposed individuals were more likely to live in lower income neighbourhoods, more likely to live in urban areas, had a higher mean ACG score, and were more likely to be frail at index date compared to matched exposed individuals (**Table 1**).

**Table S2** displays the demographic characteristics of the study cohort in the terminal phase. We identified 3,357 exposed individuals in the terminal phase and successfully matched 93.0% (N=3,114) of them to achieve balanced matches. The mean age of the matched cohort in the terminal phase was 76.9  $\pm$  14.6 years, with 55.1% being female and 23.1% being immigrants. Unmatched individuals tended to be older, more likely to be frail, and more likely to be immigrants.

Within 14 days of the index date, 5.1% of the matched exposed cohort were hospitalized, and 26.5% of those were admitted to an intensive care unit (ICU). Overall, during the follow-up, 2% of the matched cohort died, including 20.1% of those who were hospitalized within 14 days of the index date without ICU admission and 39.1% of those admitted to an ICU.

### **COVID-19-attributable healthcare costs**

Mean (median) lengths of acute, post-acute, and terminal phases were 77 (79), 274 (280), and 35 (30) days for matched exposed. **Table 2** summarizes healthcare costs by phase of care. In the pre-index phase, the mean (95%CI) 10-day healthcare costs were similar for exposed and unexposed individuals (\$107 (\$103; \$110) vs \$106 (\$103; \$109) per person, respectively), resulting in \$1 (\$-4; \$6) of COVID-19-attributable costs.

During the acute phase, the mean 10-day health costs were \$334 (\$325; \$343) per person for exposed and \$94 (\$92; \$97) for unexposed individuals, resulting in \$240 (\$231; \$249) of COVID-19-attributable costs. Most acute phase costs were due to inpatient care (77%), followed by emergency department visits (6%) and rehabilitation services (3%) (**Figure 2**).

During the post-acute phase, the mean 10-day health costs were \$112 (\$109; \$115) per person for exposed and \$95 (\$93; \$97) for unexposed individuals, resulting in \$18 (\$14; \$21) of COVID-19-attributable costs. Most post-acute phase costs were due to inpatient care (42%), followed by outpatient services (18%) and complex care (11%) (**Figure 2**).

During the terminal phase, among individuals with early deaths, the mean 10-day health costs were \$8,724 (\$8,328; \$9,119) per person for exposed and \$4,796 (\$4,551; \$5,041) for unexposed individuals, resulting in \$3,928 (\$3,471; \$4,384) of COVID-19-attributable costs. Among individuals with late deaths, the mean 10-day health costs were \$6,709 (\$6,194; \$7,224) per person for exposed and \$4,928 (\$4,603; \$5,253) for unexposed individuals, resulting in \$1,781 (\$1,182; \$2,380) of COVID-19-attributable costs. Most terminal phase costs were due to inpatient care for both early (100%) and late deaths (>87%) (**Figure 2**).

Mean (95%CI) attributable 10-day COVID-19 costs were lower for females than males for the acute care phase at \$193 (\$182, \$204) vs. \$289 (\$274, \$304), but higher for females than males in the post-acute care phase \$21 (\$16, \$26) vs. \$14 (\$9, \$19). Total mean attributable costs in both acute and post-acute care phases were higher among older age groups, among those in the lower income quintiles, and in the two highest resource utilization bands (**Tables S3-S6**).

Healthcare costs were not sensitive to variations in the pre-index phase length. However, compared to the phase lengths in the main analysis, costs doubled for the acute and post-acute phases, when we considered shorter duration (30 days) for acute phase, with inpatient care remaining the main cost driver (**Table S7**). This occurred because costs initially captured under the acute phase were now shifted to the post-acute phase (**Figure 3**). Finally, mean cumulative costs adjusted for survival at 360 days were \$2,553 (\$2,348; \$2,756) with lower costs for females at \$2,194 (\$1,945; \$2,446) vs. males at \$2,921 (\$2,602; \$3,241) (**Table 3**).

Healthcare costs of individuals who were hospitalized within 14 days of the index date with or without ICU admission are summarized in **Table S8**.

## Discussion

We sought to characterize the acute and long-term healthcare costs attributable to COVID-19 in Ontario, Canada, among individuals who tested positive for SARS-CoV-2, compared to a group of individuals who were unexposed to SARS-CoV-2.

Exposed individuals had higher costs than unexposed individuals post index date, with the largest difference occurring during the acute phase. While the cost differential (attributable cost) was reduced in the post-acute phase, mean costs remained greater among exposed individuals compared to unexposed individuals until the end of follow-up at 1 year post index date.

The relative contributions of specific cost categories to COVID-19-attributable costs varied by phase. The leading cost category in COVID-19-attributable cost across all phases was inpatient care, contributing 77% in the acute phase and 42% during the post-acute phase. This is

consistent with descriptions of the natural history of SARS-CoV-2 acute infections and subsequent PCC. Acute infection often requires care to address acute symptoms, including potential respiratory distress, that would be best addressed in hospital depending on severity, while the PCC consists of several linked syndromic conditions that are more likely to require complex care, rehabilitation, and outpatient visits [36].

We found the duration of acute illness to be longer than reported in other studies. Using joinpoint regression analysis, we determined the acute phase length to be 80 days. This is longer than the 30 days used to define the onset of a post-acute period by Sagy et al.[14], but lends further empirical support to a growing global consensus that PCC is defined by symptoms that persist more than 12 weeks after infection onset [37-39].

The mean cumulative cost at 360 days for COVID-19 was \$2,553 per person tested positive for SARS-CoV-2, which translates to \$408M for the entire exposed cohort of 159,817 individuals. Meanwhile, the estimated cost for PCC (\$18 attributable cost in the post-acute phase per person, per 10 days), would amount to about \$75M for the entire exposed cohort over a year.

Our findings are comparable to those of a previous COVID-19 costing study in Canada. Tsui et al. estimated healthcare costs associated with COVID-19 during the first wave of the pandemic in two Canadian provinces, British Columbia and Ontario [40]. The authors stratified costs based on the level of initial care required, including community, long-term care, hospital, and ICU settings. In Ontario, the net costs (in 2020 CAD) during the first 30 days of diagnosis were \$15,750 for individuals who were hospitalized and \$56,088 for those admitted to the ICU. The cumulative 120-day costs were \$28,329 and \$96,308, respectively. In our study, after stratifying by the level of initial care received (**Table S8**), the net cost over 360-day period were \$30,147 and \$105,677 for individuals who were hospitalized and admitted to ICU, respectively. The higher costs in our study, due to the longer time horizon, suggest the ongoing impact of PCC, particularly among those with initially severe disease. Further, we found that even after matching for comorbidities, frailty, and other factors, healthcare costs remained higher for lower-income quintiles. This finding aligns with a study conducted in Ontario, showing that lowerincome individuals have a higher mortality risk, a factor that likely contributes to their increased end-oflife healthcare costs [41].

Our study has several limitations. Consistent with the health system perspective, outcome data are limited to OHIP administrative data, and therefore do not include healthcare-related costs not covered by Ontario's public insurance system, such as private caregivers, medications for most individuals under 65 years, copayments for medications, costs covered by private insurance, or community-level services such as supportive housing. Also, while the vast majority (96%) of exposed individuals were matched to unexposed individuals, unmatched exposed individuals were more likely to live in lower income neighbourhoods, more likely to live in urban areas, had higher mean ACG score and were more likely to be frail at index date compared to the matched exposed, making findings less generalizable to individuals with these characteristics. Finally, our study reflects early pandemic experiences, when the likelihood of severe illness requiring hospitalization was higher, leading to increased healthcare costs. COVID-19 and associated healthcare costs may differ in contemporary times with the emergence of novel variants, vaccinations, treatments, and changes in clinical practice which were not assessed in this study.

Our study has important strengths. First, because Ontario has a single public payer system, most of the community dwelling population was eligible for this study. The cohort was well matched across various clinical and demographic variables. Notably, the absence of COVID-19attributable costs at baseline suggested minimal residual confounding. Furthermore, matching to historic controls ensured that changes in healthcare delivery during the pandemic did not affect the unexposed group, which could bias attributable cost estimates for COVID-19. Second, the use of several linked administrative databases allowed for the characterization of COVID-19-attributable costs across a broad range of cost categories. Our analysis goes beyond inpatient costs, providing a comprehensive view of COVID-19 healthcare costs. Finally, a phaseof-care approach enabled a comparison of acute versus post-acute costs and the use of joinpoint regression allowed for a data-driven approach to defining phase length.

Our findings offer insights into clinically relevant phase-specific costs, which can inform budget planning to ensure each healthcare sector is appropriately resourced. Inpatient care emerges as a major cost category, emphasizing the need for hospital resources. Policymakers can use these

findings to prioritize investments as well as to assess the value of COVID-19 interventions to support current policy decision-making and pandemic planning.

### Conclusion

Our study found that SARS-CoV-2 infection is associated with increased healthcare costs in the year following onset, with differential cost patterns in the acute and post-acute phases, consistent with the evolving clinical understanding of the PCC. Our findings have important implications for stakeholders responding to the PCC at the health system level.
