

Correlates of COVID-19 conspiracy theory beliefs in Japan: A nationally-representative cross-sectional survey

1 **Abstract**

2 **Background:** The COVID-19 pandemic was associated with an increase in conspiracy
3 theories worldwide. However, the prevalence of COVID-19 conspiracy beliefs among
4 Japanese has remained unclear. This study aimed to estimate the prevalence and correlates of
5 COVID-19 conspiracy beliefs in Japan using a nationwide survey of 28,175 residents aged
6 16–81 years old.

7 **Methods:** A nationally representative, cross-sectional self-administered survey was
8 conducted from September to October 2021. To assess the number of COVID-19 conspiracy
9 beliefs, we used three questions from the Oxford Coronavirus Explanations, Attitudes, and
10 Narratives Survey. Independent variables included general vaccine conspiracy beliefs,
11 sociodemographic variables, information sources for COVID-19, trust in authorities, and fear
12 of COVID-19.

13 **Results:** After applying sampling weights and imputation, the estimated prevalence of
14 holding at least one COVID-19 conspiracy belief was 24.4%. From a linear regression model,
15 several factors were independently associated with conspiracy beliefs. Notably, people with
16 the lowest level of education (lower secondary school) endorsed fewer COVID-19 conspiracy
17 beliefs (B -0.089, vs. upper secondary school). Furthermore, higher socioeconomic
18 backgrounds—such as higher income, higher wealth, and regular employment—were associated
19 with endorsing conspiracy beliefs. Additionally, only 37.3% of respondents trusted the
20 government of Japan, but paradoxically, trust in the government was positively associated
21 with conspiracy beliefs (B 0.175, vs. distrust).

22 **Conclusions:** Conspiracy beliefs about COVID-19 were prevalent in about a quarter of the
23 Japanese population. Certain groups are more likely to endorse conspiracy beliefs, and
24 targeting interventions towards these groups might be efficient in stemming the spread of
25 conspiracy beliefs.

26 INTRODUCTION

27 A simple definition of conspiracy theory is “an explanation that a significant event has
28 resulted from a small group of powerful actors engaging in malevolent activities, which is not
29 officially recognised as a salient cause” [1–5]. Beliefs in conspiracy theories have
30 proliferated; especially, social crises stimulate and increase the prevalence [6,7]. Since late
31 December 2019, misinformation and conspiracy theories about the coronavirus disease
32 (COVID-19) pandemic have been spreading [6,8]. For example, there are various conspiracy
33 theories about COVID-19: the virus was created to reduce the global population;
34 pharmaceutical companies created and spread the virus to gain profit [9]. The worldwide
35 prevalence of different types of conspiracy beliefs about COVID-19 varied from 5.0% to
36 39.0% [9,10]. Most of the studies were from the US and European countries, but there were
37 no studies on the prevalence of conspiracy beliefs about COVID-19 in Japan. Conspiracy
38 theories about COVID-19 have undermined public health measures and induced a threat to
39 people's health. Previous studies indicated that people who believe in conspiracy theories
40 tended to be reluctant to get vaccinated and to disregard guidelines, such as social distancing,
41 hand washing, and wearing a face mask [10–14]. The World Health Organization (WHO) has
42 called for active steps to combat the “infodemic” [6,8].

43 Accumulated evidence has shed light on predictors of conspiracy beliefs about
44 COVID-19 [10,12,14–16]. Prior research has indicated that belief in one conspiracy theory
45 predicts holding other conspiracy beliefs simultaneously even if they are contradictory [17–
46 20]. The reasons are considered to be a conspiratorial mindset, which is defined as a tendency
47 to favour conspiracy explanations due to a bias against powerful actors and authorities [17–
48 20]. Demographic variables, such as age and sex, are associated with the endorsement of
49 COVID-19 conspiracy beliefs, but prior studies show conflicting results [10,14]. The
50 variation might be due to cultural backgrounds [14]. Socioeconomic status, such as income

51 and education levels, predict conspiracy beliefs well [10,14]. In particular, individuals with
52 lower educational attainment are more likely to believe the COVID-19 conspiracy theory
53 [21]. The associations might be mediated through the interplay of thinking style and feelings
54 of control [21]. Furthermore, exposure to low-level information might also be one of the
55 explanation factors [14]. Conspiracy beliefs regarding COVID-19 are abundant on the
56 internet, especially on social media. People shared conspiracy theories on a variety of media
57 forms, such as YouTube, Instagram, and Twitter (currently known as X), and conspiracy
58 theories were reinforced and amplified [6,15]. Social media is considered one source of
59 conspiracy theories going viral [10,14,15], including Japan [22]. Furthermore, distrust in
60 authorities hampers scientific communication. Scientific information is not directly
61 transmitted from scientists, but relayed by governments and national health institutions. Trust
62 in authorities can play an important role [10,14]. Feelings of fear and anxiety were associated
63 with beliefs in conspiracy theories [10,14], because conspiracy theories can be interpreted as
64 expressions of people's fear and anxieties [16]. Further, experiencing discrimination based on
65 infections of COVID-19 can facilitate endorsing conspiracy beliefs. Indeed, in cases of HIV,
66 British White gay men who experienced discrimination tended to hold HIV conspiracy
67 theories [12,23].

68 As in other countries, COVID-19 conspiracy theories have proliferated in Japan. A
69 Trump-inspired party (Sansei to), which advanced conspiracy theories about COVID-19 (e.g.
70 laboratory origin narrative and big Pharma plot narratives), secured a seat in the House of
71 Councillors in 2022 [24]. Conspiracy theories appear to be gaining popularity in Japan.
72 However, the prevalence of conspiracy theories about COVID-19 has remained unclear. In
73 addition, Japan has a different situation from other countries. Previous studies have found that
74 individuals who rely on traditional media tend to be less inclined to believe in conspiracy
75 theories [25,26]. However, even in traditional media such as TV news and newspapers, there

76 is a history of biased health reporting in Japan. For example, Japan's human papillomavirus
77 vaccination rate is low, due to excessive reports of false side effects by traditional media [27].
78 This situation might have facilitated distrust in government officials, healthcare professionals,
79 and scientists. Indeed, Japan had relatively low trust in the government in 2020 among OECD
80 countries [28]. However, there is a scarcity of research conducted in Japan focusing on
81 correlates of conspiracy beliefs in COVID-19. This study aimed to estimate the prevalence of
82 conspiracy beliefs about COVID-19 and explore factors associated with holding conspiracy
83 beliefs about COVID-19 among a Japanese nationally representative sample.

84 **METHODS**

85 **Ethics approval and consent to participate**

86 The study protocol was reviewed and approved by the Research Ethics Committee of the
87 Osaka International Cancer Institute (approved on June 19, 2020; approval number 20084).
88 The authors assert that all procedures contributing to this work comply with the ethical
89 standards of the relevant national and institutional committees on human experimentation and
90 with the Helsinki Declaration of 1975, as revised in 2008. All participants provided written
91 informed consent online before responding to the questionnaire. Participants received
92 Rakuten points as a reward, which can be used for online shopping. The exact number of
93 points is not disclosed at the request of an internet research agency (Rakuten Insight, Inc.,
94 Tokyo, Japan).

95 **Study design, data sources, and participants**

96 This cross-sectional study used a dataset from the Japan COVID-19 and Society Internet
97 Survey (JACSIS) (<https://jacsis-study.jp/>), which is a nationally representative web-based
98 self-administered questionnaire survey. The JACSIS conducts a survey annually and targets
99 approximately 2 million panellists, registering with an internet research agency (Rakuten
100 Insight, Inc., Tokyo, Japan). In the JACSIS, the target population was individuals aged 15–79
101 years who lived in Japan at a survey. The survey in this study was launched on 27 September
102 2021 and concluded on 29 October 2021. Of all previous respondents of the previous wave of
103 the JACSIS, an Internet research agency followed up with 33,081 individuals who were
104 available to respond. From 27 September to 29 October 2021, a follow-up survey was
105 conducted among them, resulting in responses from 22,838 individuals (response rate = 69%).
106 Additionally, to achieve a total of 31,000 participants, an additional survey using the same
107 questionnaire was conducted from 23 to 28 October 2021. Consequently, an extra 8,162

108 responses were collected.

109 Participants who provided fraudulent responses were excluded to ensure the quality
110 of the data. Three exclusion criteria were employed to identify fraudulent responses: an
111 incorrect answer to an attention check question ("Please select the second last option from the
112 following choices."), straight-line responses regarding drug use, and regarding comorbidities,
113 leading to the exclusion of 2,825 respondents. Thus, the Analytic population was 28,175.

114 **Dependent variable: The number of conspiracy beliefs regarding** 115 **COVID-19**

116 To assess conspiracy beliefs about COVID-19, we used three questions from the Oxford
117 Coronavirus Explanations, Attitudes, and Narratives Survey (OCEANS) [29]. The questions
118 were as follows: big Pharma created COVID-19 to profit from the vaccines; COVID-19 was
119 created to force everyone to get vaccinated; the vaccine will be used to carry out mass
120 sterilisation. The available response options were "1. Strongly agree", "2. Somewhat agree",
121 "3. Neither agree nor disagree", "4. Somewhat disagree", and "5. Strongly disagree". We
122 defined the first and second options as believing in conspiracy theories about COVID-19
123 vaccines. The Cronbach's alpha was 0.889 and the Pearson's correlation matrix of the measure
124 is shown in Appendix Table 1.

125 **Independent variables**

126 Based on previous studies [10,12,14–16], we selected variables potentially associated with
127 COVID-19 conspiracy beliefs: general vaccine conspiracy beliefs, sociodemographic
128 variables, information sources for COVID-19, trust in authorities, fear of COVID-19, and
129 others.

130 **1. General vaccine conspiracy beliefs**

131 We calculated the number of conspiracy beliefs about general vaccines using a Vaccine

132 Conspiracy Beliefs Scale (VCBS) involving 7 items [30]. The questions of VCBS were
133 below: vaccine safety data is often fabricated; immunizing children is harmful and this fact is
134 covered up; pharmaceutical companies cover up the dangers of vaccines; people are deceived
135 about vaccine efficacy; vaccine efficacy data is often fabricated; people are deceived about
136 vaccine safety; the government is trying to cover up the link between vaccines and autism.
137 Potential responses were a 7-point scale that ranged from "1. strongly disagree" to "7. strongly
138 agree". We defined the fifth to seventh options as believing conspiracy theories about general
139 vaccines. The Cronbach's alpha was 0.947 and the Pearson's correlation matrix of the measure
140 is shown in Appendix Table 2.

141 **2. Sociodemographic variables**

142 We included age (16–19, 20–24, 25–29, 30–34, 35–39, 40–44, 45–49, 50–54, 55–59, 60–64,
143 65–69, 70–74, and 75–81 years), sex (men and women), marital status (married, unmarried,
144 widowed, and divorced), educational attainment (lower secondary school, upper secondary
145 school, specialised training college [post-secondary courses], junior college and college of
146 technology, university, and master's or doctor's degree), employment status (regular
147 employee, temporary employee, self-employed, employer, student, unemployed or retired,
148 housekeeper, and others), annual household income (0 to <2, 2 to <4, 4 to <5, 5 to <8, and \geq 8
149 million yen), household financial assets (0 to <1, 1 to <4, 4 to <9, 9 to <20, and \geq 20 million
150 yen), and household indebtedness (none, >0 to <2, and \geq 2 million yen).

151 **3. Information sources for COVID-19**

152 As for sources of information about COVID-19, we targeted the following 14 information
153 sources: websites of government agencies, websites of research institutions, video sharing
154 platforms (e.g. YouTube), LINE, Twitter, Facebook, Instagram, web news, newspapers,
155 magazines, books, TV news, and tabloid TV shows. Sources of information for COVID-19
156 were assessed by the following question: "Have you obtained medical information about

157 health topics, including COVID-19, from each of the following sources?" The options
158 available for each source were "Yes" and "No". If respondents chose "Yes", they were asked
159 that "How much do you trust the source of information you selected in the previous
160 question?" The possible options were "1. Very trust", "2. Trust", "3. Somewhat trust", "4.
161 Somewhat distrust", "5. Distrust", and "6. Distrust at all". We defined the first to third options
162 as "trusted", and the fourth to sixth as "distrusted". Combining the former and latter questions,
163 we defined three categories: "Not use", "Use but distrust", and "Use and trust".

164 **4. Trust in authorities**

165 To measure the level of trust in authorities, we targeted the following 3 authorities: the
166 government of Japan, prefectural administrations, and municipal administrations. Trust in
167 authorities was measured using the following questions: the government is trustworthy; the
168 administration of the municipality in which you currently live is trustworthy; the
169 administration of the prefecture in which you currently live is trustworthy. The response
170 options were "1. Agree", "2. Somewhat agree", "3. Somewhat disagree", and "4. Disagree".
171 We defined the first and second options as "Trust", and the third and fourth as "Distrust".

172 **5. Fear of COVID-19**

173 We used the Japanese Version of the Fear of Coronavirus Disease 2019 Scale (FCV-19S)
174 [31]. This scale involves 7 items with a scale of 1 (strongly disagree) to 5 (strongly agree)
175 points. The range of the scale was from 7 to 35 points. We adopted ≥ 21 of a cut-off point to
176 identify psychological distress or difficulties in daily living due to the fear of COVID-19 [32].
177 The Cronbach's alpha was 0.836 and the Pearson's correlation matrix of the measure is shown
178 in Appendix Table 3.

179 **6. Other covariates**

180 Experiencing discrimination regarding COVID-19 was obtained using a question: "In the last
181 two months, have you experienced any of the following events? Felt discrimination related to

182 COVID-19." Available options were "1. Yes (experienced for the first time in the last two
183 months)", "2. Yes (and had happened before)", "3. Never (but had happened before)", and "4.
184 Never happened before". We defined the first to third options as "Experienced", and the last
185 option as "Never". Additionally, we obtained a medical history of depression, other mental
186 disorders, and coronavirus infections.

187 **Statistical analysis**

188 We employed linear regression analysis with a robust error variance to estimate the
189 unstandardised coefficients (Bs) of the number of conspiracy beliefs regarding COVID-19.
190 Although the distribution of a dependent variable is right-skewed, linear regression models
191 can provide valid estimations [33]. A positive coefficient means holding more conspiracy
192 theories while a negative coefficient means holding fewer conspiracy theories. We created
193 two models: a crude model and a fully adjusted model using the simultaneous forced-entry
194 method. The fully adjusted model included all independent variables simultaneously. To
195 confirm the validity of the results from linear regression models, we also conducted a Poisson
196 regression analysis with a robust error variance to estimate prevalence ratios for holding at
197 least one conspiracy belief in COVID-19 [34].

198 To impute missing values, we used a k-nearest neighbour imputation (the R package
199 "VIM") [35]. After the imputation, sampling weights were calculated using the raking method
200 from the R package "anesrake" to match the proportions of age, sex, prefecture of residence,
201 marital status, annual household income, and educational attainment from census data.
202 Detailed information on the sampling weights has been described in Appendix Table 4. A P-
203 value <0.05 (2-tailed) was considered statistically significant. All analyses were conducted in
204 R (ver. 4.3.0; R Foundation for Statistical Computing, Vienna, Austria).

205 RESULTS

206 Table 1 shows basic participant characteristics. The median age of respondents was 50,
207 ranging from 16 to 81. The proportion of women was 50.8%. After imputation and weighting,
208 10.6% (95% confidence interval [CI] 10.1, 11.1) of the participants believed in one
209 conspiracy theory regarding COVID-19 (OCEANS), 6.5% (95%CI 6.1, 6.9) in two, and 7.3%
210 (95%CI 7.0, 7.8) in three. The prevalence of holding at least one conspiracy theory about
211 COVID-19 was 24.4% (95%CI 23.7, 25.1). The detailed results of the original categories for
212 three questions on COVID-19 conspiracy beliefs are shown in Appendix Table 5. On the
213 other hand, participants who believed in at least one conspiracy theory regarding general
214 vaccines (VCBS) constituted 33.6% (detailed results are shown in Appendix Table 6). The
215 main source of COVID-19 information was TV news, trusted by 67.9% of the participants.
216 Web news, the second source, garnered 48.0% trust. Distrust in the Japanese government was
217 expressed by 62.7% of the participants.

218 Table 2 presents the weighted mean and proportions of the number of conspiracy
219 beliefs regarding COVID-19. Among age groups, participants aged 16–19 years had the
220 highest mean of conspiracy beliefs regarding COVID-19 (the weighted mean was 0.56),
221 followed by 20–24 years (0.53) and 75–81 years (0.51). Women had a lesser number of
222 conspiracy beliefs than men (0.39 vs 0.52). Participants who used and trusted TV news had a
223 smaller number of conspiracy beliefs (0.43) than ones who did not use (0.54) and distrusted
224 (0.48). Participants who trusted web news had a smaller number of conspiracy beliefs (-0.44)
225 than those who did not use it (0.50), but a larger number than those who distrusted it.
226 Paradoxically, participants who distrusted the Japanese government endorsed fewer
227 conspiracy beliefs (0.40) compared to those who trusted the government (0.56). By contrast,
228 there was no difference in the number of conspiracy beliefs between participants who trusted
229 versus distrusted their prefectural and municipal administrations, respectively (prefectural

230 administration: trust 0.42, distrust 0.42; municipal administration: trust 0.42, distrust 0.42).

231 Table 3 shows the results of the crude and multivariable linear regression models
232 with sampling weights after imputation. In the multivariable adjusted model, socioeconomic
233 status was associated with harboring conspiracy theories about COVID-19. Lower secondary
234 education and a master's or doctor's degree were associated with endorsing fewer conspiracy
235 theories about COVID-19 compared with upper secondary education (lower secondary
236 education: B -0.089, 95%CI -0.172, -0.006; master's or doctor's degree: B -0.066, 95%CI -
237 0.126, -0.006). Temporary employees (B -0.051, 95%CI -0.095, -0.007), the self-employed (B
238 -0.102, 95%CI -0.162, -0.042), the unemployed or retired (B -0.078, 95%CI -0.131, -0.025),
239 and housekeepers (B -0.086, 95%CI -0.135, -0.037) held fewer conspiracy theories than
240 regular employees. In addition, higher household income and assets were also associated with
241 endorsing more conspiracy theories (annual household income of ≥ 8 million yen: B 0.069,
242 95%CI 0.020, 0.117 vs. 4 to <5 million yen; household financial assets of 9 to <20 million
243 yen: B 0.060, 95%CI 0.010, 0.109 vs. 0 to <1 million yen).

244 Information sources for COVID-19 were associated with holding conspiracy theories
245 about COVID-19. Participants who used and trusted the websites of government agencies had
246 fewer conspiracy beliefs than those who did not use the websites of government (B -0.109,
247 95%CI -0.139, -0.079). On the other hand, participants who used and trusted video sharing
248 platforms (e.g. YouTube) (B 0.089, 95%CI 0.038, 0.139), LINE (B 0.053, 95%CI 0.009,
249 0.097), Facebook (B 0.089, 95%CI 0.000, 0.178), and Instagram (B 0.093, 95%CI 0.008,
250 0.178) endorsed more conspiracy theories than those who did not use them. Participants who
251 used and trusted, or distrusted web news held fewer conspiracy theories compared with those
252 who did not use web news (use but distrust: B -0.080, 95%CI -0.123, -0.037; use and trust: B
253 -0.068, 95%CI -0.102, -0.034). Participants who trusted the information from books held
254 more conspiracy beliefs than those who did not use books (B 0.136, 95%CI 0.068, 0.204).

255 While participants who trusted TV news held fewer conspiracy theories (B -0.081, 95%CI -
256 0.128, -0.035 vs. not used), those who trusted tabloid TV shows held more conspiracy
257 theories (B 0.051, 95%CI 0.015, 0.087 vs. not used).

258 Trust in authorities was associated with endorsing conspiracy beliefs about COVID-
259 19. Trust in the government of Japan was associated with holding more conspiracy theories
260 (B 0.175, 95%CI 0.139, 0.211), compared to distrust. Trust in other authorities (the
261 administration of the municipality and prefecture in which participants currently live) was not
262 associated with holding conspiracy theories about COVID-19.

263 Feeling fear of COVID-19 was associated with holding more conspiracy beliefs
264 about COVID-19 (B 0.145, 95%CI 0.115, 0.175 vs. none). A larger number of conspiracy
265 theory beliefs regarding general vaccines were associated with holding more conspiracy
266 theories about COVID-19. Participants who experienced discrimination against related to
267 COVID-19 endorsed more conspiracy theories about COVID-19 (B 0.088, 95%CI 0.025,
268 0.151 vs. none). Having a medical history of COVID-19 was associated with holding more
269 conspiracy theories (diagnosed within the past year: 0.187, 95%CI 0.011, 0.363, and
270 diagnosed before the past year: 0.169, 95%CI 0.024, 0.314).

271 Results from Poisson regression models with a robust error variance were consistent
272 with the results from linear regression models (see Appendix Table 7).

273 **DISCUSSION**

274 From a nationwide survey involving 28,175 residents, we estimate that 24.4% of individuals
275 in Japan held at least one conspiracy theory about COVID-19. Surprisingly, we found that the
276 characteristics of respondents endorsing conspiracy beliefs were often the opposite of those
277 reported in studies from western contexts. For example, people from higher socioeconomic
278 backgrounds—such as higher income, higher wealth, and regular employment—were more
279 likely to endorse conspiracy beliefs about COVID-19. Furthermore, 62.7% of respondents
280 distrusted the government of Japan but they tended to hold fewer conspiracy theories about
281 COVID-19.

282 **Interpretations of the results**

283 In our study, individuals who trusted the government were more likely to believe in
284 conspiracy theories. This finding is in contrast to previous research in other countries [10,14]
285 and is therefore unique. A prior study from JACSIS suggests that individuals with high trust
286 in the government of Japan tended to practice preventive measures more often than those with
287 low trust [36]. Our supplemental analysis also found that trust in the government of Japan
288 were associated with low vaccine hesitancy (shown in Appendix Table 8). Therefore, we
289 expected that individuals with high trust in the government would also disbelieve conspiracy
290 theories. However, our results suggest the opposite—individuals sceptical of the government
291 might have been more rational and critical about conspiracy theories, but not necessarily
292 about preventive measures. In addition, we found that holding more COVID-19 conspiracy
293 beliefs was associated with LOWER vaccine hesitancy (Appendix Table 8). This suggests
294 that individuals who believed in conspiracy theories about COVID-19 were more likely to
295 follow COVID-19 measures and trust the government. It indicates that COVID-19 conspiracy
296 beliefs might reflect not only a conspiratorial mindset but also fear of COVID-19. Indeed, fear
297 of COVID-19 was significantly correlated with COVID-19 conspiracy beliefs (Table 3).

298 However, if respondents simultaneously endorsed more general vaccine and COVID-19
299 conspiracy beliefs, holding more COVID-19 conspiracy beliefs was associated with vaccine
300 hesitancy (Appendix Table 9). This suggests that the Japanese government will not succeed in
301 increasing vaccine uptake by combating conspiracy beliefs about COVID-19 alone. A broader
302 range of conspiracy theories needs to be considered, including conspiracy theories about
303 vaccines.

304 Prior studies also suggest that individuals with high socioeconomic status are more
305 likely to disbelieve conspiracy theories [10,14]. Indeed, our results suggest that the highest
306 educational attainment (a master's or doctor's degree) was associated with holding fewer
307 conspiracy theories about COVID-19 compared with the middle educational attainment
308 (upper secondary school, which is the most standard educational attainment in Japan).
309 However, individuals with the lowest educational attainment (lower secondary school) also
310 endorsed fewer conspiracy theories than those with middle educational attainment. In
311 addition, higher socioeconomic position—based on higher income, higher wealth, and regular
312 employment—were associated with endorsing more conspiracy theories about COVID-19.
313 This may reflect the nature of Japanese society. In Japanese society, it has been previously
314 noted that conspiracy beliefs often attract people from higher socioeconomic backgrounds
315 [37]. For example, the religious cult, Aum Shinrikyo (responsible for the 1995 Tokyo subway
316 sarin attack) promulgated antisemitic conspiracy theories, claiming that the government of
317 Japan was secretly manipulated by Jews and Freemasons [38]. Members of the cult who
318 planned and participated in the sarin gas attack were drawn from the elite including those with
319 expertise in medicine, biology, chemistry, physics, and engineering [39]. Future research must
320 identify the mechanisms behind this unique Japanese result.

321 The results regarding information sources in this study, as well as those of previous
322 research [10,14,15], indicated that individuals trusting social media (Twitter, Facebook, and

323 Instagram) were more likely to believe in conspiracy theories while those who believed in
324 mainstream sources such as government and traditional media news tended to endorse fewer
325 conspiracy theories. This finding may be attributed to the proliferation of conspiracy theories
326 on social media also in Japan [40]. However, it's important to note that the causal relationship
327 between social media use and conspiracy beliefs is still controversial [5,15]. Regarding TV
328 programs in Japan, trusting TV news was associated with disbelief in conspiracy theories.
329 Although TV news has provided biased reports on vaccines; however, in the COVID-19 case,
330 they seem to reflect the opinions of the government, authorities, and expert groups [41].
331 However, tabloid TV shows featured celebrities, critics, journalists, and experts who were
332 unfamiliar with public health [42]. Therefore, the observed difference between TV news and
333 tabloid TV shows could be due to these features. Believing in information from books was
334 associated with endorsing conspiracy theories about COVID-19. Misinformation, especially
335 about healthcare, thrives on books in Japan [43–45]. Because these books were bestsellers,
336 some people might have purchased and believed them. On the other hand, individuals who
337 believe in conspiracy theories may have actively purchased books supporting their beliefs.
338 The correlation between books and endorsing conspiracy theories might be attributed to the
339 proliferation of books containing misinformation.

340 Younger and older people believed more conspiracy theories about COVID-19. We
341 also observed sex differences in believing conspiracy theories. Experiencing discrimination
342 related to COVID-19 was associated with belief in conspiracy theories. In a study of gay men
343 in the UK, experiences of discrimination led to beliefs in conspiracy theories [12,23]. It's
344 possible that in this case, experiencing discrimination makes individuals more likely to
345 believe conspiracy theories. However, it could also be that those who believe in conspiracy
346 theories simply over-reported instances of discrimination related to COVID-19. The diagnosis
347 of COVID-19 was also associated with conspiracy beliefs. People who believe in conspiracy

348 theories tend to engage in higher-risk behaviours and report not following government
349 guidelines [10–14]. Consequently, a higher proportion of COVID-19 patients could have been
350 found to believe in conspiracy theories, suggesting an observed association.

351 **Strengths and limitations**

352 The limitations of this study should be noted. First, this study was cross-sectional, which
353 means that a temporal relationship between the independent variables and the outcome
354 remains unclear. Second, our examination of conspiracy theories about COVID-19 relied on
355 three questions. The estimated prevalence of conspiracy beliefs about COVID-19 may be
356 underestimated. However, the estimated prevalence was relatively similar to results from
357 previous systematic reviews [9,10]. This study also has strengths. Unlike many previous
358 studies with sample sizes over 200 [14], our study included 28,175 participants. In addition,
359 the data includes a diverse range of Japanese residents, especially those with low
360 socioeconomic status, employing sampling weights to improve external validity. Moreover,
361 this study examined numerous potential associated factors, enabling a comprehensive
362 assessment of the characteristics of individuals in Japan who hold conspiracy theories about
363 COVID-19 and the results can be applied to the general population in Japan.

364 **Conclusions**

365 Conspiracy theories are a global problem and pose a public health risk. This study reported
366 the prevalence of conspiracy beliefs about COVID-19 and associated factors in Japan. Some
367 of the results were different, while some replicated findings from Western countries. Similar
368 to findings from previous research, individuals who used social media as a source of
369 information endorsed conspiracy theories. However, contrary to the results from Western
370 countries, individuals with the lowest level of education were less likely to believe in
371 conspiracy theories. Furthermore, higher socioeconomic Japanese—higher income, higher
372 wealth, and regular employment—are more likely to endorse conspiracy beliefs about COVID-

373 19. Those who trusted the government were more likely to hold conspiracy beliefs. Our
374 findings might support that combating the spread of conspiracy theories requires interventions
375 that take into account cultural contexts.
