55 Abstract

56 Disentangling direct and indirect genetic pathways underlying the intergenerational 57 transmission of emotional problems could guide preventative strategies and further the 58 understanding of the role of parental mental health in children's outcomes. This study aimed 59 to estimate the extent to which genetic pathways that are *direct* (via child genotype) and 60 indirect (e.g., via parental phenotype) explain the well-established association between 61 parent and child emotional problems. We leveraged data from seven European cohort 62 studies with a combined population of Ntrios=15,475. Polygenic scores were calculated for 63 parental and offspring neuroticism, as it represents a dispositional trait underlying emotional 64 problems. Emotional problems in offspring were measured using validated scales across 65 various developmental stages from early childhood to adulthood. We used neuroticism 66 polygenic scores within a structural equation modelling framework to distinguish between 67 direct genetic pathways from parental genotype to offspring outcome (acting through 68 offspring genotype), and indirect genetic pathways (acting through parental phenotype and 69 associated environment). Standard errors for direct genetic, indirect genetic and total effects 70 were bootstrapped and meta-analyses pooled effect estimates at three developmental 71 stages (childhood: 3-4 years, adolescence: 11-13 years, adulthood: 18+ years). We found 72 evidence suggesting an indirect genetic pathway between mothers and child emotional 73 problems during early childhood (pooled estimate, mean difference in standardised child 74 emotional problems score per 1SD increase in maternal PGS for neuroticism=0.04, 95% CI: 75 0.01, 0.07). This association attenuated over child development, while direct genetic 76 pathways strengthened. High attrition rates, measurement error and low variance explained 77 by polygenic scores may have altered precision of the estimates, influencing the 78 interpretation of the results. However, we provide the first multi-cohort study to provide 79 evidence for an *indirect* genetic pathway from maternal neuroticism to early child emotional 80 problems. This suggests that there are likely processes other than direct genetic pathways 81 involved in the intergenerational transmission of emotional problems, highlighting the 82 importance of timely support to prevent and reduce emotional issues in mothers as a 83 preventative strategy for emotional difficulties.

87 Introduction

The prevalence of emotional problems, such as depression and anxiety(1), is increasing, particularly among young adults(2,3). Despite decades of research into 'causal' risk factors, policy changes, and intervention development, the burden of mental health disease has risen(4), with mental illness now being a leading cause of disability worldwide(5). Developing effective preventive interventions for emotional difficulties could have major societal and economic benefits by improving population health.

94 There is a well-established association between parent and child emotional 95 problems. Family history of mental health problems for instance is considered one of the 96 most important risk factors for the onset and maintenance of psychiatric disorders(6,7). In 97 the UK, children with parents experiencing high levels of psychological distress are five 98 times more likely to suffer from emotional disorders(8). This intergenerational risk is 99 transmitted through both genetic and environmental mechanisms, as well as a likely 100 interplay among the two. A key question is to identify potentially modifiable pathways to this 101 intergenerational transmission of poor mental health, as different mechanisms of 102 transmission will inform different preventative strategies.

103 Beyond an individuals' genetic predisposition to a specific disorder (i.e., transmitted 104 by the parents - direct genetic effect), non-transmitted parental genes can act as risk factors 105 for the onset of emotional problems (also known as indirect genetic effect, "genetic nurture", 106 or familial effects(9)) by influencing aspects of the environment that are likely to contribute to 107 child psychopathology and/or moderate the association between the child's own genetic 108 liability and mental health outcomes. Recent observational evidence and meta-analyses of 109 genetically informed studies, including twin and adoption studies, have highlighted a clear 110 role, albeit relatively small (12-20% of the variance), for the familiar environment in the 111 development of psychopathology(10.11). A comprehensive review of genetically informative 112 study designs, examining the association between parental and offspring emotional 113 problems, reported strong evidence of both genetic and environmental transmission of 114 parental depression to emotional problems across childhood, adolescence, and 115 adulthood(12). Genetically informed studies can thus help to ascertain whether the 116 associations between parental risk factors and offspring emotional outcomes are influenced 117 by direct environmental effects or shared genetic factors. These designs offer improvements 118 in accounting for genetic and shared environmental confounding factors compared to 119 traditional observational studies(13,14).

120 Neuroticism is a personality trait indicating an individual's tendency in experience 121 negative emotions more frequently and intensely after exposure to stressors(15,16). It has

122 also been conceptualised as a dispositional risk trait for emotional problems(16), including 123 depression and anxiety, and its utility in research and clinical applications has been 124 discussed elsewhere(17–19). Recent research shows that a genetic liability to neuroticism 125 (proxied by a polygenic score – PGS) associates with emotional problems and depressive 126 symptoms from infancy to young adulthood(20,21). Because neuroticism associates with 127 both depression and anxiety, we decided to examine genetic liability to neuroticism as a 128 common susceptibility to emotional problems. Using a genetic liability to a continuous 129 personality trait as compared to a clinical disorder may be most useful when investigating 130 symptom levels within general populations(22,23).

Attempting to isolate the role of parental phenotype is important because if parents' emotional difficulties influence offspring via non-genetic paths, timely treatment of parental mental health symptoms *alone* could reduce the risk in the child. However, if there is only evidence for direct genetic pathways, this could suggest that focusing solely on parental mental health might not be as effective in prevention of child mental health risk as those including the child or with a specific focus on child's mental health.

The aim of the current study is to estimate the extent to which the association between parent and child emotional problems is influenced by indirect genetic pathways and direct genetic pathways(9). Indirect genetic pathways, such as those mediated through parental phenotype, offer an opportunity to distinguish pathways operating through parental characteristics, distinct from pathways involving direct transmission of genetic information to the child (Figure 1).

143 To address this aim, we used polygenic scores (PGS) for neuroticism, obtained from 144 mother-father-offspring trios, and a pathway approach disentangling direct genetic and 145 indirect genetic pathways to emotional disorders in offspring in childhood, adolescence, and 146 adulthood (Figure 2). While previous studies using similar methods have identified indirect 147 genetic pathways in educational outcomes(24), this study aims to extend our current 148 understanding to mental health outcomes(25) by aggregating data from seven cohorts to 149 enhance statistical power and to balance different sources of bias (i.e., different cohorts 150 have different attrition patterns and reporting of emotional problems)(26)

151 Understanding the potential contribution of direct and indirect pathways may help 152 guiding future strategies to prevent intergenerational cycles of emotional difficulties and 153 improve child mental health in those who have a parent with emotional difficulties.

159 Samples and methods

160 Participants and genotyped data

161 This study used data from seven cohort studies across five countries, constituting the 162 recently established Genetic and Environmental Mental health INtergenerational 163 Investigation (GEMINI) consortium. We included all cohorts with both genetic and phenotypic 164 data on the family trio. Detailed information for each cohort is provided in the Supplementary 165 Information. In brief, this study combined information from the Avon Longitudinal Study of 166 Parents and Children (ALSPAC)(27-29), Millenium Cohort Study (MCS)(30), Generation 167 Scotland (GS)(31), the Norwegian Mother, Father and Child Cohort Study (MoBa)(32), 168 FinnBrain (FB)(33), CHILD-SLEEP (CS)(34), and the Pre-, Peri-, and Postnatal Stress: 169 Epigenetic Impact on Depression study (POSEIDON)(35,36). Please note that the ALSPAC 170 website contains details of all the data that is available through a fully searchable data 171 dictionary and variable search tool (http://www.bristol.ac.uk/alspac/researchers/our-data/).

173 Measures

174 Offspring emotional problems and depressive symptoms were measured using 175 different scales across development (validated for children's ages) and reported by different 176 assessors (i.e., parents and children - self-reported). Emotional problem scores were based 177 on the following measures (STable 1) and standardised prior use in analyses to facilitate 178 comparison and interpretability. Childhood emotional problems were measured using the 179 Brief Infant-Toddler Social and Emotional Assessment (BITSEA)(37), the Child Behaviours 180 Checklist (CBCL)(38), and Strengths and Difficulties Questionnaire (SDQ)(39). Adolescent 181 emotional problems were measured using the Strengths and Difficulties Questionnaire 182 (SDQ)(39) and the Short Moods and Feelings Questionnaire (SMFQ)(40). Finally, adult 183 depressive symptoms were measured using The Clinical Interview Schedule-Revised (CIS-184 R)(41), General Health Questionnaire (GHQ)(42), and the Patient Health Questionnaire-2 185 (PHQ2)(43)

187 Polygenic scores indexing parental and offspring neuroticism

188 Information on genotyping in each cohort is available in Supplementary Information. 189 SNPs were filtered on minor allele frequency (>1%) and imputation info score (>0.8). In each 190 cohort, PGS for neuroticism were derived based on publicly available summary statistics 191 from a genome-wide association study by Luciano et al. (44). This study analysed over 192 329,000 individuals of self-described white British ancestry in the UK Biobank Study (46.3% 193 male). Neuroticism was measured using a 12-item scale from the Eysenck Personality 194 Questionnaire-Revised (EPQ-R). Neuroticism scores were adjusted for age, sex, genotyping

195 batch, genotyping array, assessment centre and 40 principal components of ancestry prior to 196 analysis. PGS were derived in each of the cohorts using PRSice2 with default clumping 197 options (clumping correlated SNPs within a 250kb window at a r2 threshold of 0.1) and 198 based on a p-value threshold of p<0.05. This threshold was chosen to maximise the variance explained by the PGS while minimising noise. All scores were standardised as z-199 200 scores prior to use in analyses. Betas (β) indicate a unit difference increase or reduction in 201 the standardised outcome score for each 1SD increase in the exposure (i.e., PGS for 202 neuroticism of child, mother, or father).

204 Data analysis

206 Descriptive analyses and missing data

We calculated medians and interquartile ranges (IQR) or frequencies and percentages for basic demographic characteristics of the participants across cohort studies and reported these data for mothers, fathers, children and trios with genetic data available (that were included in analyses because had the outcome), and those with missing genetic and outcome data (STable 2).

213 Primary analyses

214 In each cohort we used neuroticism PGS from the mothers, fathers, and offspring 215 within a SEM (Structural Equation Modelling) path analysis using Stata v16(45) (ALSPAC, 216 MCS) or lavaan package in R (GS, MoBa, FinnBrain, ChildSleep, POSEIDON) (see 217 supplementary file for exact coding) to separate out the direct genetic pathways of parental 218 genotype (which acts via offspring genotype) on offspring emotional problems from the 219 indirect genetic pathway that could act via maternal phenotype and environment (Figure 2). 220 More specifically maternal and paternal PGS scores were regressed on child PGS scores 221 and in turn child emotional outcomes and on child emotional outcomes directly. Because we 222 included all pathways (both direct and indirect) from maternal and paternal PGS in a 223 simultaneous model the path estimates allow us to deconstruct direct and indirect 224 contributions. Among cohorts where population structure is more varied and thus more likely 225 to introduce issues due to confounding by population stratification (e.g. GS, MCS), we 226 accounted for 10 principal components of ancestry.

227 Standard errors were bootstrapped in each cohort and the effect estimates and 95% 228 confidence intervals for the indirect and direct effects of maternal and paternal PRS were 229 pooled in a random effects meta-analysis at three separate time points (childhood: age 2-4 230 years, adolescence: 11-13 years, adulthood: 18-99 years).

The measures were also combined according to rater (self-report or parent-report) across all time points in a random effects meta-analysis. This study follows STROBE reporting guidelines (STable 3).

235 Results

236 Samples descriptives

Sample demographic characteristics are summarised in Table 2. In ALSPAC, mothers with genetic data were more likely to be married or co-habiting, and were less likely to have ever smoked compared to mothers for whom genetic data was missing. In ALSPAC, MoBa, and GS, individuals with completed trio genetic data were more likely to have mothers with higher educational qualifications as compared to the full sample, while this is not the case for MCS(46,47). These descriptive results are summarised in STable 2 and reported in more details here(48).

Our pooled sample was 15,475 in the childhood analysis (aged 2-4 years), 4,507 in the adolescent analysis (11-13 years), and 4,244 in the adult analysis (18-99 years).

246 Direct and indirect genetic effects on childhood emotional problems in six cohorts

247 In childhood, data on parent-reported emotional problems in childhood was available 248 from 6 of the cohorts (i.e., ALSPAC, Child Sleep, FinnBrain, MCS, MoBa, Poseidon). 249 Evidence was strongest for an association between the maternal indirect genetic association 250 (0.04SD difference in emotional problems per 1 standard deviation (SD) in maternal 251 neuroticism PGS (95% CI: 0.01, 0.07), p=0.018) and child emotional problems. The effect 252 estimates for direct genetic associations and paternal indirect genetic associations were in 253 the same direction, but evidence was weaker for these effects (Figure 3, STable 4). 254 However, the CIs for each of the estimates overlapped. We found some evidence of both 255 maternal and paternal total effects.

256 Direct and indirect genetic effects on adolescent emotional problems and depressive257 symptoms in two cohorts

258 In adolescence, data on offspring emotional problems were available from ALSPAC 259 and MCS cohorts (N=4,507). Here, we found some evidence of an association between both 260 maternal and paternal direct genetic pathways and offspring emotional problems (Figure 4, 261 STable 4). The direction of this association was consistent with that observed during 262 childhood. For maternal direct genetic effects there was a 0.04SD difference in emotional 263 problems per 1SD increase in maternal neuroticism PGS ((95% CI: 0.01, 0.06), p=0.010), 264 while for paternal direct genetic effects there was a 0.03SD in difference in offspring 265 emotional problems per 1SD increase in paternal neuroticism PGS (95% CI: 0.01, 0.06;

p=0.006). While the direct genetic effect estimates are consistent between ALSPAC and MCS, the indirect genetic effect estimates appear to be in conflicting directions. In a similar way to early childhood, the CIs for all pathways overlap and the evidence for a total effect is less clear.

270 Direct and indirect genetic effects on adulthood depressive symptoms in three cohorts

271 In adulthood, self-reported depressive symptoms data were available from ALSPAC, 272 GS, and MCS cohorts (N=4,210). We found strong evidence for an association between 273 both maternal and paternal direct genetic effects and offspring emotional problems (Figure 5, 274 STable 4). For maternal direct genetic effects there was a 0.05SD difference in emotional 275 problems per 1SD increase in maternal neuroticism PGS (95% CI: 0.02, 0.08; p<0.001), 276 while for paternal direct genetic effects there was a 0.05SD in difference in offspring 277 depressive symptoms per 1SD increase in paternal neuroticism PGS (95% CI: 0.02, 0.07; 278 p<0.001). We found no evidence of an association between indirect genetic effects and 279 offspring depressive symptoms. Confidence intervals, in particular for the maternal effects, 280 were overlapping across pathways, and evidence of total effects was unclear, particularly for 281 paternal effects on offspring depressive symptoms in adulthood.

There were modest positive associations reflective of maternal and paternal potentially modifiable phenotypes and as well as both parent genetic inheritance. This was strongest for maternal phenotype (0.04SD difference in emotional problems per 1SD in maternal neuroticism PGS (95%CI: 0.01, 0.07)) and weakest in magnitude for maternal and paternal genetic inheritance (both 0.01 SD per 1SD PGS (-0.01, 0.03)). All pooled estimates were imprecise.

289 Discussion

290 This study leveraged data from seven cohort studies across five countries to 291 elucidate the association between parental genetic predisposition to neuroticism and child 292 emotional problems and depressive symptoms through both direct and indirect genetic 293 pathways. Using a genetically informed approach and integrated polygenic scores within a 294 structural equation model, we disentangled the influence of direct and indirect genetic 295 pathways on this association. We also investigated whether this association persisted from 296 early childhood to adulthood by performing a meta-analysis of emotional problems in early 297 childhood (age 2-4 years), adolescence (11-13 years), and adulthood (18 years and over).

298 Overall, our pooled results report suggestive evidence of an association between 299 indirect genetic maternal pathways and child emotional problems during early childhood 300 (n=15,475). The indirect maternal genetic effects diminished over time while direct genetic

301 effects intensified across the life course (in more than 4,000 individuals). The strength of the 302 evidence supporting an indirect genetic pathway drastically reduced in adolescence and 303 adulthood, with the magnitude of the effect size halving from childhood to adolescence and 304 from adolescence to adulthood for the maternal indirect effect, and with inconsistent 305 direction of the effect estimate for the paternal indirect effect. Studies with genetics data, 306 including twins and children-of-twin studies, have suggested that familiar influences and 307 indirect genetic effects may play a greater role on offspring phenotypes in early ages as 308 compared to adolescence and adulthood where the effect of the own genetic liability is more 309 likely to contribute to the phenotype(49-52). These hypotheses are also supported by 310 evidence genetic heritability for several traits, including mental health related traits, 311 increases over the lifespan(11,53).

Alternatively, it is possible that we observed stronger evidence for an indirect pathway in early childhood because of the use of parent vs self-reported measures at these time points, which may have induced differential biases in the reporting child emotional symptoms associated to maternal mental health characteristics. Nevertheless, some of these biases have been explored in other studies, even in ALSPAC, reporting often negligible effects(20,54) (see in limitations).

Unlike the direct genetic effects which show a consistent direction of association, the effect estimates for the indirect genetic pathway also appear to be in conflicting directions across ALSPAC and MCS in adolescence. The variability of the indirect pathway could suggest that the environment captured by the indirect genetic component is likely to differ across studies (e.g., ALSPAC participants were recruited a decade earlier and from a select region of the UK, while MCS was sampled from across the entire UK), thus being explained by differences specific to each cohort (e.g., measures, drop-out rates, selection processes).

325 The context within the literature

326 The estimates for direct genetic pathways become stronger in magnitude and 327 strength of evidence during adolescence and adulthood. This may be potentially due to a 328 diminishing role of the parental environment, as captured by the genetic component, in 329 shaping the offspring's environment during these developmental stages. An alternative 330 explanation could be due to the use of polygenic scores derived from adult GWAS summary 331 statistics in our analysis. These scores may therefore explain more of the variation in the 332 phenotype as cohort members reach adulthood(55). However, previous work has shown that 333 even at younger ages the neuroticism polygenic scores are still associated with the 334 phenotypes(20).

335 *Implications for intergenerational psychiatry*

336 Our findings suggest that direct genetic pathways more strongly explain the 337 associations between parental neuroticism and their children's emotional difficulties in 338 adolescence and adulthood. Contrarily, indirect genetic pathways, especially via maternal 339 'genetic nurturing', more strongly explain the association with child emotional problems in 340 early childhood. These findings have separate potential implications for preventative 341 interventions (Figure 6). In the case of direct genetic pathways, delivering preventative 342 interventions exclusively targeting parental mental health is unlikely to have beneficial effects 343 on child emotional problems in adolescence and adulthood. This, however, contrasts with 344 trial evidence (56) that targeting parental mental health or parenting skills in parents with 345 mental health disorders have modest effects in reducing internalising disorders in children 346 regardless of their age (effects were observed in both childhood and adolescence). 347 However, the magnitude of the effects is relatively small and interventions directly supporting 348 child resilience, emotional regulation or parenting interventions with active involvement of the 349 child may be more effective in reducing emotional problems. Such findings align though with 350 meta-analyses of trials that found that parenting interventions with an active inclusion of the 351 child and focus on the relationship are more effective in reducing internalising problems as 352 interventions that involved parents only(57,58).

In the case of genetic nurture, the effects of interventions targeting parental mental health
 (especially maternal) would be expected to have beneficial downstream effects on child
 emotional problems as experienced in early childhood.

356 Limitations

357 This study may be subject to several limitations which should be considered when 358 evaluating its findings. First, despite being the largest study of its kind, limitations persist due 359 to sample size constraints. The need for genetic data from mothers, fathers, and offspring 360 has restricted the available sample, as many studies only offer genetic data for parent-361 offspring pairs. However, combining data across multiple cohorts has maximised the sample 362 size, especially in early childhood, where statistical power is greater as compared to the 363 other timepoints. Nevertheless, missing genetic information data and severe attrition over 364 time may have introduced bias into estimates, as those providing genetic information and 365 remaining in the cohort were more likely to come from more socio-economically advantaged 366 families, especially in ALSPAC, CHILD-SLEEP, MoBa, and GS (see STable 2). This pattern 367 of missingness could have influenced our findings, most likely biasing them toward the null 368 as it known that higher education moderates the effects of poor maternal mental health on 369 offspring emotional and behavioural difficulties (47). Future studies should aim to employ 370 methods such as parental genetic imputation (59), inverse probability weighting(61) or 371 multiple imputation (62) to minimise these issues. In addition, we have used data from five

European countries therefore limiting the generalisability to this study to non-European participants.

Second, despite the increase in sample size of GWAS, they are still limited in estimating all the phenotypic variance explained by common variants, often resulting in these scores explaining only a small portion of the phenotypic variance. Consequently, when the estimates are used as weights in the construction of the polygenic score, they introduce noise(9). This noise can lead to observed null associations between the resulting polygenic scores and outcomes of interest, potentially reflecting false negatives where a true association exists but remains undetected.

381 Third, depression or emotional problems were primarily collected by a single reporter 382 within each study and at a single time point which is likely to increase measurement error. 383 Different reporters of internalising problems lead, for example, to different heritability 384 estimates(63). To address potential reporting biases, having multiple raters assessing the 385 phenotype would have been beneficial. However, this is challenging in childhood due to 386 limited validation of child or teacher reports. Moreover, subjective ratings of mental health 387 difficulties present inherent limitations regardless of the reporter. According to the 'distortion 388 model'(64–66), the mental health characteristics of the reporters may systematically bias the 389 ratings of mental health questionnaires, with implications for assessing causality in genetic 390 studies (9). However, previous investigations into such biases have found limited support for 391 dependent differential misclassification or measurement of outcomes (20,54).

Finally, we cannot rule out possible bias due to assortative mating or population stratification, even though we have likely accounted for the latter by including a large number of principal components of genetic ancestry.

395 Conclusions and direction for future research

396 In conclusion, our findings suggest that indirect genetic processes, such as the 397 environment provided by the parent, are most strongly associated with offspring mental 398 health in early life. Conversely, pathway estimates for directly transmitted genetic information 399 become larger during adolescence and adulthood, although the individual reporting on 400 emotional problems may play a role in this. This insight holds potential for refining 401 intervention strategies aimed at mitigating the impact on offspring mental health and 402 importantly the potential role of including both parent and child from as early as possible. 403 The magnitude of the association was larger for the maternal indirect pathways as compared 404 to the paternal indirect genetic pathways which may indicate the degree of parental 405 involvement. Indeed, variation in parental involvement in children's upbringing, such as time 406 spent at home and involvement after separation, may also moderate the effects of indirect

genetic effects on offspring phenotype with potentially more pronounced effects for the more
involved parents. However, actual parental involvement was not explored in our study, and
we recommend this for future investigations.
