### 28 Abstract

29 Introduction: The interplay between neuroinflammation and Parkinson's disease (PD) is still unclear, although several studies suggest that neuroinflammation plays an 30 31 important role in the pathophysiological pathways of neurodegenerative disorders. 32 Dance-based movement therapy has been studied as an adjuvant treatment for PD 33 symptoms by modulating some inflammatory interleukins and improving the overall 34 effect of pharmacological treatments. 35 **Objective:** To evaluate the levels of Interleukin 4, Interleukin 1 $\alpha$ , cortisol hormone, and 36 blood cell total numbers in PD subjects undergoing dance-based movement therapy. 37 Methods: Twenty-five participants were selected for this study. Seventeen subjects 38 diagnosed with PD were divided into two groups: PD group (n=8) and PD+dance group 39 (n=9). Another group was composed of age-matched healthy controls (n=8). The dancebased movement therapy was performed twice a week for 50-60 minutes/session over 40 six months. 41 42 **Results:** The serum IL-4 levels were significantly lower in the PD group when compared 43 to the healthy group, while the PD+Dance group showed similar levels to the healthy 44 group. The levels of IL-1 $\alpha$ , cortisol, and blood cell count showed no statistical differences 45 between groups. 46 **Conclusion:** Our results suggest that regular practice of dance-based movement therapy 47 may induce a neuroprotective effect by modulating the levels of IL-4 in people with PD 48 similarly to healthy participants. 49 50 **Keywords:** Parkinson's Disease; Dance-based Movement Therapy; Interleukins; Cortisol; 51 Blood Cells. 52 53 Trial registration: The study was registered in the Brazilian registry of clinical trials: RBR-54 3bhbrb5. 55 56 **Short title:** Dance-based movement therapy as adjuvant treatment for Parkinson's 57 disease 58

### 59 Introduction

60	The interplay between inflammation and Parkinson's disease (PD) is still unclear,
61	although inflammation plays an important role in neurodegenerative disorders[1] and
62	may help promote neuronal death and involve blood cell abnormalities[2].
63	The effects of physical exercise on motor and non-motor symptoms in people
64	with PD effectively modulate the inflammatory process[3], promoting neuronal survival
65	by increasing the production of neurotrophic factors, releasing neurotransmitters, and
66	improving neurogenesis, angiogenesis, modulating inflammatory cytokines, and cortisol
67	hormone expression[3,4].
68	Thus, therapy based on dance movements may be a physical activity alternative
69	to improve PD treatment [5], once dance involves motor skills such as motion planning,
70	rhythm, motor memory, proprioception, imitation[5–7], emotional aspects, and
71	visuospatial information, in addition to increasing body balance, integrating brain areas,
72	decreasing cortisol hormone, and improving neuroplasticity [5,6,8,9].
73	To this date, no study has analyzed the serum levels of inflammatory cytokines,
74	the stress hormone (cortisol), and the blood cell number in people with PD undergoing
75	dance-based movement therapy. Therefore, the present study evaluated the serum
76	levels of Interleukin 4 (IL-4), Interleukin 1 $lpha$ (IL-1 $lpha$ ), cortisol hormone, and total blood cell
77	numbers in people with Parkinson's disease undergoing physical activity based on dance
78	movements.

80 Methods

# 81 Study design and Participants

82 We performed a longitudinal study aiming to analyze the effects of physical 83 activity based on dance movements using the "Baila Parkinson" method as a 84 complementary therapy for Parkinson's disease [10].

85 We submitted this study to the ethical committee of the Federal University of 86 Pará (CEP: 3.965.311/ CAAE: 27811119.4.0000.0018) and registered it in the Brazilian 87 Registry of Clinical Trials (ReBEC RBR-3bhbrb5, UTN code: U1111-1275-6679). The 88 research was developed from July to December 2019, the participants were recruited through social media announcements, the follow-up was until march 2020, and the 89 90 inclusion criteria were: 1) a diagnosis of PD according to the UK Parkinson's Disease 91 Society Brain Bank (UKPDSBB); 2) Hoehn and Yahr stages I to III under pharmacological 92 treatment for at least 3 years; and 3) the ability to walk independently. Exclusion criteria: 93 1) presence of other neurologic or neuropsychiatric conditions; 2) comorbid 94 inflammatory disease; or 3) severe cardiopulmonary disease. This study was conducted 95 in accordance with the Declaration of the World Medical Association and all participants 96 provided written informed consent.

97 The study included 25 subjects. Seventeen (n=17) subjects with Parkinson's 98 disease, and eight (n=8) healthy controls (Healthy Group - HG) were selected. Demographic and clinical parameters were documented. Among the subjects with PD, 99 100 eight received their PD medical treatment as usual (PD Group, n=8), whereas the other 101 nine subjects with PD received medical treatment associated to dance therapy 102 (PD+Dance, n=9). All PD subjects were submitted to evaluation of disease progression 103 through the Unified Parkinson Disease Rating Scale (UPDRS), and fulfilled UKPDSBB 104 clinical criteria for idiopathic PD (H&Y Scale 1,88 ± 0,33; UPDRS III 30,55 ± 13,60; UPDRS 105 Total 48,77 ± 19,63).

### 106 Intervention: Dance-based movement therapy

- 107 The dance-based movement therapy was performed twice a week, 50-60 108 minutes per session for six months following a protocol based on the "Baila Parkinson" 109 method [10].

### **Data Collection and Statistical Analysis**

We collected the peripheral blood of all participants (10 mL through peripheral vein puncture; at 8-9 am after 8h of fasting) and centrifuged it at 3500 g for 10 min. The serum was removed and stored at -80 °C (Sanyo VIP Plus -80°C Freezer) until analysis.

The levels of IL-4, IL-1 $\alpha$ , and cortisol were measured using the Enzyme-Linked 115 116 Immunosorbent Assay - ELISA (Invitrogen®) method. The blood cell number was 117 calculated using impedance and colorimetric measurements (Medical Laboratory 118 Equipment Blood Test CBC). The results were analyzed using GraphPad Prism<sup>®</sup> 8.0 119 Software. We tested the data for normality (Kolmogorov-Smirnov) and homogeneity (Levine test). The data were analyzed using a one-way analysis of variance (ANOVA) 120 121 corrected by the Tukey intergroup post-test or Kruskal-Wallis test for non-parametric 122 data. Statistical significance was p<0.05, and all data are presented as mean ± standard 123 deviation (M±SD).

### 125 **Results**

126 The present study aimed to the serum levels of Interleukin 4 (IL-4), Interleukin 127  $1\alpha$  (IL-1 $\alpha$ ), cortisol hormone, and total blood cell numbers in people with Parkinson's

128	disease undergoing physical activity based on dance movements. Peripheral blood was
129	collected once and IL-1 $\alpha$ , IL-4, cortisol levels and blood cell count were measured.
130	Twenty-five individuals enrolled in this study which eight were healthy and
131	seventeen were with idiopathic PD. Nine individuals with idiopathic PD were selected to
132	attend the therapeutic sessions (Fig 1). were selected to attend the therapeutic sessions
133	(Fig 1). The demographic and clinical parameters of the three subjects' groups are shown
134	in Table 1. There were no statistically significant differences in age or gender among the
135	three groups.

## 142 **Pro and Anti-Inflammatory Cytokine Levels**

Serum blood levels of IL-4 in the PD group were significantly lower when
compared to the healthy group (HG) while the PD+Dance group had IL-4 serum levels
similar to the healthy group (HG: 0.37± 0.05; PD: 0.1280±0.02; PD+Dance: 0.2300± 0.08;
p=0,0079). Regarding the levels of IL-1 $\alpha$ , there was no statistically significant difference
between the groups, but the concentration of IL-1 $lpha$ in the PD+Dance subjects was lower
in relation to the PD group (HG: 0.008±0.004; PD group: 0.022±0.02; PD+Dance group:
0.01±0.01; p=0,5051), see Figure 2 A and B.
Serum Cortisol Levels
The serum blood level of cortisol hormone did not show statistically significant
differences among the three groups analyzed (HG: 12.40±3.86; PD Group: 11.57±5.31;
PD + Dance Group: 10.32± 2.75; ANOVA p=0,56), see Figure 2C.

### 165 Blood Cells Count

166	The blood cell counts did not show statistical differences among the three groups
167	(p>0.05), see Table 2. However, two participants of the PD group that underwent dance-
168	based movement therapy (PD+Dance) had changes in red cell numbers, which may
169	indicate anemia and positive microcytosis (see Table 2). There was also one case with
170	erythrocytosis, one with hypochromic, another with thrombocytopenia, and the last
171	with atypical lymphocytes (Table S1).

### 178 **Discussion**

179 The participants in the PD group presented lower blood levels of IL-4 when 180 compared to the HG group. The PD+Dance group had IL-4 concentration levels similar 181 to those of the HG. This finding is relevant given the importance of IL-4 as a regulator 182 for the inflammation process and its relationship with normal neuronal function which 183 is damaged in neurodegenerative diseases[11]. Once physical activity may regulate 184 different kinds of inflammatory cytokines, inhibiting neuroinflammatory responses via 185 the upregulation of interleukins [12], our results suggest that dance-based movement 186 therapy modulated neuroprotective mechanisms across the increasing IL-4 blood serum 187 concentrations in the PD+Dance group (Figure 2A). However, it is necessary to evaluate 188 the cellular and molecular mechanisms involved in the effects of regular therapy based 189 on dance movements.

190 There was no difference among the three groups for IL-1 $\alpha$  serum blood levels. 191 However, the IL-1 $\alpha$  blood serum levels of the PD+Dance group showed lower absolute 192 values compared to the PD group (Figure 2B). Once the cell death is directly related to 193 the regulation of IL-1 $\alpha$  processing and release, conceivably the neurodegenerative and 194 chronic character of Parkinson's disease must be inducing cell death across the constant 195 release of IL-1 $\alpha$ [1,12].

There was no difference among the three participants' groups regarding serum cortisol blood levels (Figure 2C). Although our results were not statistically significant, our work demonstrated that therapy based on dance movements was able to conserve cortisol levels in people with PD.

200 There was no statistically significant difference among the three experimental 201 groups regarding the total number of blood cells. For the parameters of blood cell 202 counting, see Table 2. However, the proportion of red blood cells and the platelet count 203 of both the PD+Dance Group and the PD Group showed alterations in some cases, such 204 as anemia and microcytosis (Table S1). The number of red blood cells, leukocytes, and hematocrit values were not affected by the experimental conditions and were similar to 205 206 a previous study that supports the association between low hemoglobin levels and PD 207 [13] [14].

### 209 Conclusion

210 Dance-based movement therapy reduced blood serum levels of IL-4, suggesting 211 that its regular practice may modulate neuroprotective effective action to delay the 212 progression of Parkinson's disease.




