## 12 ABSTRACT

- 13 Context: Although considerable cross-sectional evidence exists regarding the association
- 14 between sport specialization and injury, sport-specific, prospective research is lacking.
- 15 Similarly, sport specialization is associated with impairments in sleep and subjective well-being
- 16 in youth athletes, but it is unknown whether this increases the risk of illness.
- 17 Objective: To determine the relationship between sport specialization status and in-season injury
- 18 and illness risk in elite female adolescent soccer players.
- 19 Design: Prospective Cohort Study

20 Setting: Pre-season evaluation of maximal aerobic capacity (VO<sub>2max</sub>) and sport specialization,

21 and in-season self-reporting of daily training load (session-rating of perceived exertion), injury

and illness resulting in lost sport participation time.

23 Participants: 80 female youth soccer players (ages 13-18) from a local youth soccer organization.

24 Main outcome measures: Sport specialization status, injury and illness incidence during two 4-

25 month competitive soccer seasons. Athletes were considered specialized if they participated in

soccer exclusively versus multiple sports during the year. Mixed effects logistic regression

27 models were used to individual injury and illness (yes/no) during the study period, using sport

specialization, age, and training load as fixed effects and individual athlete as a random effect.

29 Results: Specialized (n=46) athletes did not differ from non-specialized (n=34) athletes with

30 respect to age, preseason physical activity,  $VO_{2max}$  or in-season training load (all p>0.05). No

31 difference was seen in the proportion of individuals from each group that reported an in-season

32 injury (specialized = 19% v 17%, p=0.83) or illness (40% v 38%, p=0.82). After adjusting for

age and training load, the individual injuries (OR= 0.86 [0.26, 2.8], p=0.81) and illnesses were

not significantly predicted by specialization (OR= 1.06 [0.45, 2.5], p=0.89).

48 The association between sport specialization and overuse injury has been widely reported 49 among youth athletes. The majority of this research has been cross-sectional, however, and 50 typically failed to account for the potentially confounding role of training load. Specialized 51 athletes may be subjected to higher TL than non-specialized athletes, and increases in TL have 52 been associated with an increased risk of injury.<sup>1</sup> In a prospective study among high school 53 athletes from multiple sports, after controlling for in-season competition volume, McGuine et al. 54 found that high school athletes reporting moderate and high levels of sport specialization had an 55 increased risk of in-season lower extremity injury compared to athletes with low levels of 56 specialization. Notably, this was entirely due to the association of specialization with chronic 57 lower extremity injuries, as no association was identified with acute lower extremity injuries. 58 Although it has been suggested that the relationship between specialization and injury is 59 likely sport-specific, little prospective research has attempted to evaluate these relationships. In a 60 single prospective study of youth basketball players, Post et al. found no statistically significant 61 association between sport specialization and injury incidence in a prospective study of youth 62 basketball athletes. Notably, Post et al. had previously identified a significant association 63 between specialization and injury in a cross-sectional study of youth basketball athletes, 64 suggesting that relationships from retrospective, cross-sectional research may not translate into sport-specific prospective injury risk.<sup>2</sup> It remains unclear whether the associations between 65 66 specialization and injury risk differ across sports that may have different levels of specialization, 67 different physical demands, and different types of injuries. 68 Similarly, several guidelines and policy statements have suggested that athletes who

69 choose to specialize in a single sport at an early age may be at risk of increased stress,

70 overtraining, and burnout.<sup>3-6</sup> A prior prospective study found that specialized female youth

71 athletes demonstrated greater impairments in fatigue, mood, stress and sleep quality during the 72 season compared to their non-specialized counterparts, even after adjusting for training load (TL).<sup>7</sup> In adult athletes, higher volumes of exercise have been shown to be associated with an 73 increased susceptibility to viral infections,<sup>8,9</sup> and increased weekly TL is associated with an 74 75 increased illness risk.<sup>9,10</sup> A study of 15-18 year old male soccer players found that higher training duration was predictive of in-season illness,<sup>11</sup> and we have previously found that higher 76 77 weekly and monthly TL was predictive of in-season illness risk among adolescent female soccer players.<sup>12</sup> Poor sleep and increased psychosocial stress have been suggested as risk factors for 78 illness in athletes,<sup>11,13,14</sup> but it is unknown whether youth athletes who specialize in one sport are 79 80 at an increased risk of in-season illness compared to youth athletes who participate in other 81 sports during the off-season.

82 In 2019, the American Medical Society for Sports Medicine hosted a research summit on 83 youth early sports specialization, identifying a need for prospective, sport-specific research to 84 evaluate the association between sport specialization and outcomes that controls for the 85 confounding effects of training load. Unfortunately, since that time, well-controlled, sport-86 specific, prospective research in this area has been minimal. Despite the popularity of youth 87 soccer throughout the world, however, we are not aware of research since that time which has 88 prospectively evaluated the relationship between sport specialization, injury and illness in youth 89 soccer athletes. In a single cross-sectional study of male youth soccer athletes, specialization was not found to be associated with an increased risk of injury,<sup>15</sup> but no prior research has been 90 91 conducted in female youth soccer athletes. Therefore, the purpose of this study was to determine 92 the relationship between sport specialization and in-season injury and illness among female 93 youth soccer players, while adjusting for the important influence of TL.

# 95 **METHODS**

## 96 Study Design

97 All procedures performed in this study were approved by the Institutional Review Board of the 98 University of Wisconsin-Madison. Female athletes ages 13-18 were recruited through 99 participation in a local youth soccer organization. Interested participants were asked to provide 100 information regarding medications or significant cardiac or pulmonary disease that could impact 101 cardiovascular function or performance (stimulants, congenital cardiac disease, uncontrolled 102 hypertension, uncontrolled asthma, e.g.). Written, informed assent was provided by minor 103 participants, and written, informed consent was provided by adult participants and parents of 104 minor participants.

105 Prior to the start of two consecutive, 13-week fall club soccer seasons, participants 106 completed a questionnaire regarding demographic information, sport participation history, and 107 hours of weekly moderate-vigorous physical activity during the prior 4 weeks. As all of the 108 athletes identified soccer as their primary sport and participated in soccer exclusively during the 109 fall club season and for more than 8 months of the year, players were considered specialized if 110 they participated in soccer exclusively throughout the year and had previously quit another sport 111 to focus on soccer, and non-specialized if they also participated in other sports during the 112 remainder of the year outside of the soccer season. This is similar to the categorization reported in a previously published study of specialization, well-being and sleep.<sup>16</sup> 113

Following completion of the questionnaire, participants were familiarized with the laboratory testing equipment. Height was measured with a stadiometer to the nearest 0.25 cm and body mass with a calibrated balance beam scale to the nearest 0.1 kg. Each participant then

117 performed a progressive, maximal exercise test on an electronically braked cycle ergometer 118 (Racermate, Seattle, WA). Subjects were familiarized with the exercise testing equipment, after 119 which they were asked to pedal in an upright position at a cadence of 70 rpm with an initial load 120 of 85W and incremental loads of 35W applied at 3-min intervals to the point of exhaustion, 121 defined as the point when the pedal cadence can no longer be maintained despite strong verbal 122 encouragement. During the test, total ventilation, oxygen consumption  $(VO_2)$ , and carbon 123 dioxide (VCO<sub>2</sub>) were measured, and respiratory exchange ratio (RER;  $VCO_2/VO_2$ ) was 124 calculated, in a continuous, breath-by-breath manner by a metabolic cart (Cosmed, Chicago, IL). 125 To account for variations in breath-by-breath measurement, these values were expressed as a 30-126 second rolling average. VO<sub>2max</sub> was defined as the highest value obtained during the test, and 127 recorded along with time to exhaustion  $(T_{max})$ . VO<sub>2max</sub> was expressed relative to body mass 128 (ml/kg/min). A test was considered maximal if the athlete satisfied at least 2 of the following 3 129 objective criteria: (1) maximal heart rate >90% of the predicted maximal heart rate; (2) RER 130 >1.1; (3) a plateau in oxygen consumption, defined as a change of <2 ml/kg/min in O<sub>2</sub> 131 consumption over the last 60 seconds of the test. All of the fitness testing was conducted by a 132 primary care sports medicine physician and an exercise physiologist with several years of prior 133 testing experience.

Immediately following all physical activity, participants provided the duration (minutes) and perceived intensity (1 to 10) of the session using an online software program (fitfor90.com), which were multiplied to yield a unitless session-rating of perceived exertion (sRPE) value as a measure of internal TL.<sup>10,17</sup> Throughout each season, participants were asked to report any injuries that resulted in restriction from participation in soccer events, including the date of onset, injury location, injury type, injury mechanism (acute, chronic) and diagnosis. Similarly, athletes

140	were asked to report any illnesses that resulted in restriction from participation, including the
141	date of onset, predominant symptoms, and diagnosis, using the same online software program.
142	Follow-up interviews were conducted by the study team in any instances in which the details of
143	the injury or illness were unclear. Compliance with the completion of daily TL, injury and
144	illness reporting was encouraged periodically throughout the study period by coaching staff. This
145	approach has been reported previously in prior studies of the predictors of in-season injury and
146	illness among youth soccer athletes. <sup>18,19</sup>

### 148 Statistical Analysis

149 Data were initially evaluated for normality using descriptive statistics and histogram 150 analysis. Age group was determined based on birth year in accordance with the current 151 classification by U.S. Soccer. Age, BMI, preseason physical activity, years of soccer experience, 152 and fitness (VO<sub>2max</sub>, T<sub>max</sub>) were compared between specialization groups with Wilcoxon Rank 153 Sum Tests and across age groups (U14, U15, U16, U17, U18) using Kruskal-Wallis tests with 154 post-hoc pairwise Wilcoxon Rank Sum Tests adjusted for multiple comparisons. The proportion 155 of individuals who suffered an in-season injury or illness were compared across age groups 156 (U14, U15, U16, U17, U18) using a chi-square test. Separate mixed effects logistic regression 157 models were used to predict 1) in-season injury (yes, no) and 2) in-season illness (yes, no) for 158 each individual using sport specialization, age, and TL as fixed effects. Individual was included 159 as a random effect since some participants participated in multiple seasons. Finally, separate 160 survival analyses were conducted to compare 1) time to injury and 2) time to illness between the 161 specialized and non-specialized athletes, with comparisons using the Likelihood Ratio Test from 162 similarly adjusted Cox proportional hazards models. In the comparisons between specialization

groups and in the mixed effects model, age at the start of the season was included as a
continuous variable, rather than age group. The participants in this study represent a
convenience sample of athletes from a single soccer club who were interested in participation
during two consecutive years and does not represent a sample size based on an *a priori* power
analysis. Significance level was determined *a priori* at the 0.05 level and all tests were 2-tailed.
All statistical analyses were performed in R.<sup>20</sup>

# 170 **RESULTS**

171 Eighty female youth soccer athletes  $(15.2 \pm 1.5 \text{ years})$  participated in the study, with 46 172 specialized and 34 non-specialized athletes. 56 athletes (37 specialized) participated in the first 173 year, while 52 (31 specialized) participated in the second year, 28 of whom participated in both 174 years (22 specialized), resulting in 108 person-years over the two seasons. There were no 175 differences between groups with respect to age, years of experience, pre-season physical activity, 176 or fitness level (Table 1). The proportion of athletes categorized as specialized differed 177 significantly across age groups, with older age groups demonstrating higher rates of 178 specialization (Figure 1). Total in-season TL during the two seasons did not differ between 179 specialized and non-specialized athletes (417  $\pm$  101 v 393  $\pm$  100 arbitrary units, p=0.31). 180 Twenty-eight time-loss injuries were reported, of which 3 (11%) were chronic and knee, 181 ankle and upper leg were the most common injury locations (Table 2). The proportion of athletes 182 that suffered an in-season injury during the study period did not differ between specialized and 183 non-specialized groups (19% v 17%, p=0.83). In the mixed effects logistic regression model, 184 in-season injury was not independently predicted by specialization (odds ratio (OR) = 0.86 [95% 185 CI = 0.26 - 2.8, p=0.81), training load (OR = 0.61 [0.30 - 1.23], p=0.18), or age (OR = 1.1)

186	[0.71–1.7], p=0.68). In the survival analysis, no significant differences were identified between
187	specialized and non-specialized athletes with respect to time to injury (p=0.16; Figure 2).
188	Fifty-nine illnesses were reported, with the most common being upper respiratory
189	illnesses, followed by gastrointestinal illnesses (Table 3). The proportion of athletes that
190	suffered an in-season illness during the study period did not differ between specialized and non-
191	specialized groups (40% v 38%, p=0.82). In the mixed effects logistic regression model, in-
192	season illness was not independently predicted by specialization (OR= $1.06 [0.45 - 2.5]$ ,
193	p=0.89), training load (OR= 1.4 [0.92 - 2.1], p=0.12), or age (OR= 1.13 [0.83 - 1.5], p=0.44).
194	Similarly, no significant difference was found in the survival analysis between specialized and
195	non-specialized athletes with respect to time to illness ( $p=0.81$ ; Figure 3).

210 In addition, we found no increased incidence of illness among specialized athletes 211 compared to their non-specialized teammates. Interestingly, sport specialization among female 212 adolescent athletes has been found to be associated with impairments in sleep quality, mood, and fatigue,<sup>7</sup> all of which can lead to increased illness risk.<sup>24-26</sup> Given that higher incidence of illness 213 214 among adolescent male soccer players has been found to be associated with increases in psychosocial stress,<sup>11</sup> we sought to determine whether participating in other sports outside of the 215 216 main competitive soccer season could have an influence on illness risk in elite female adolescent 217 soccer players. Our results are similar to those recently reported in younger athletes, ages 10-14, that similarly found that sport specialization was not associated with increased illness risk.<sup>27</sup> In 218 219 fact, that study found that decreased sleep and lower physical activity were the primary 220 predictors of in-season illness. Given the rich data in support of the positive long-term benefits of physical activity among youth and adolescents,<sup>28</sup> our findings suggest that sport participation 221 222 does not increase risk of illness in adolescent elite female soccer players, regardless of sport 223 specialization status.

224 There are several variables which can potentially influence the relationships between 225 sport specialization and health outcomes of athletes. TL is associated with injury risk, and it has been suggested that increased TL may be a predictor of in-season illness in athletes.<sup>12,29</sup>. Higher 226 227 TL is often considered a potentially important confounder in comparisons of specialized and 228 non-specialized athletes, as it is assumed that specialized athletes may have a higher TL which 229 may be the true driver of adverse outcomes such as injury or illness. In fact, a recent review 230 found that of the five included studies that attempted to evaluate the association between 231 specialization and injury independent of training load, two studies found that the association was

no longer significant, while three found that the relationship persisted. In order to account for this, we specifically recruited a group of athletes from within a single organization that would have comparable in-season TL, identified the specialized and non-specialized players, and adjusted for TL within our statistical models. As expected, we did find very similar in-season TL between the groups, but even after accounting for any differences we did not find any association between specialization and either injuries or illnesses during the season.

238 A rapid change in physical activity or training load may also impact risk of both injury 239 and illness.<sup>25</sup> where specialized athletes could potentially be at greater risk if their pre-season 240 physical activity levels were significantly lower than the athletes participating in other sports. 241 Similarly, we have previously found that lower levels of preseason fitness are associated with an increased risk of subsequent in-season injury and illness in youth soccer athletes.<sup>19</sup> In the present 242 243 study, however, we found no significant difference in  $VO_{2max}$  or pre-season vigorous physical 244 activity between the specialized and non-specialized groups, suggesting that specialization status 245 did not influence aerobic fitness or activity level in the soccer off-season.

246 This study has several limitations. Without randomization of individuals to specialization 247 groups, it is not possible to determine whether between-group differences can be attributed to 248 specialization itself, or some other coincident attributes of the groups that could be associated 249 with specialization. Compliance with data collection of TL was ~80% and as a result there was 250 data missing. We did not identify any obvious relationship between compliance and date, 251 specific individuals, or specialization group, and consequently chose to analyze the raw data without imputation, similar to prior work using a similar data collection mechanism.<sup>7,16,18,19</sup> This 252 253 study also used a commercially available software program rather than a previously utilized 254 questionnaire regarding injury and illness reporting. Nonetheless, this approach has been used

previously to identify relationships between TL, subjective well-being, injury and illness,<sup>12</sup> and 255 256 was felt to represent a more cost-effective and feasible method to collect large amounts of daily, 257 individual data over a significant period of time than traditional questionnaires. A proportion of 258 the participants participated in both years of the study, of whom a greater number were from the 259 specialized group. While it is possible that this could skew the results, we have attempted to 260 account for this by utilizing a mixed effects regression model to evaluate the relationships 261 between specialization, injury and illness and included each individual as a random effect. As 262 above, the sample size in the study was based on a convenience sample rather than an *a priori* 263 power analysis, which could result in a failure to identify significant differences in group 264 comparisons. Lastly, this study included only adolescent female soccer players from a single 265 club and a single sport and may not be generalizable to other populations.

In conclusion, we did not find any association between sport specialization and in-season injury or in-season illness incidence among adolescent female soccer players. Similarly, we found no difference in the time to injury or illness between specialized and non-specialized athletes. This suggests that the relationships between sport specialization and health outcomes may be sport-specific, and further prospective research is warranted to determine whether this relationship exists in other populations of youth athletes.
