1 **ABSTRACT**

2

3 The Food, Activity, Screens, and Teens (FAST) Study was a school-based prospective cohort study, aiming

4 to identify mechanisms of peer influence on weight-related behaviors (WRBs) among early adolescents.

5 In 2017-18, FAST investigators conducted focus group interviews and field observations of sixth grade

6 students at four ethnoracially diverse urban middle schools, then administered pilot surveys in two of

7 the schools. In Fall 2018, investigators recruited a cohort of sixth graders in the same four schools for a

8 three-year panel study, with four waves per year. Each wave measured height and weight, demographic

9 characteristics, WRBs (physical activity, screen time, and dietary patterns), classes and activities, and

10 social networks among peers. Peer network measures included friendship, social sentiments

11 (liking/disliking), online and face to face interaction, kinship, cohabiting, and shared WRBs. The

12 pandemic school closure in March 2020 interrupted fieldwork after wave 6, and the next five waves

13 employed online and mail surveys while schools operated remotely. In Spring 2022, after schools

14 reopened, investigators followed a subset of students into high school to collect a twelfth wave of data.

19 INTRODUCTION

20 Overweight/obesity is often clustered among friends and there is growing evidence for social
21 influences on adolescent weight status [1-10]; If there is an apparent social contagion underlying the
22 epidemic of overweight/obesity, it presumably operates through antecedent weight related behaviors
23 (WRBs), such as poor dietary choices [11], low levels of physical activity [12] and high levels of screen
24 media use [13, 14]. These behaviors are initially shaped by parent and sibling modeling [15-17], and may
25 then be modified by the increasing influence of peers[18] in the broader context of health lifestyles [19].
26 Prior findings of social causation for WRBs have been inconsistent given vexing inferential challenges,
27 however [18, 20-22]. For example, clustering of friends with similar WRBs could be due to peer *influence*
28 on behaviors, but may also be due to *selection* of friends with similar WRBs, or exposure of friends to
29 similar external *contexts* affecting WRBs, and may be partly a byproduct of triad *closure*, the tendency
30 for friends of friends to become friends [23]. Application of experimental methods to identify these
31 interdependent forces has been challenging due to an inability to randomly assign friends and friends'
32 WRBs within empirical contexts and on time scales where these processes naturally operate.

33 The Food, Activity, Screens, and Teens (FAST) Study was a prospective cohort study that collected
34 longitudinal data on demographics, weight-related behaviors (physical activity, screen time, dietary
35 patterns), height and weight, classes and extracurricular activities, as well as social relationships and
36 social interaction among adolescents over an extended period. We aimed to deliver insights into the
37 interplay between health behaviors, weight status, and peer relationships over time in a racially and
38 ethnically diverse sample of youth in four urban middle schools.

39 Earlier work on youth relationships and health behavior in schools largely examined friendships [18,
40 20, 24-28], but recent work [29] has criticized this concept as ambiguous and argued that it conflates the
41 role relation of friendship with alternative concepts such as interpersonal sentiments (e.g., liking) and
42 social interaction (sharing social time and activities, including WRBs). The FAST Study goes beyond

43 earlier work to distinctly measure role relations (e.g., friendship and kinship), interpersonal sentiments
44 (from disliking to liking), general measures of interaction (e.g., spending time together, online and face-
45 to-face), and more specific forms of interaction that involve shared WRBs (e.g., shared eating, physical
46 activity, and screen time). This distinction will allow unique insight into the mechanisms of peer effects
47 through modeling the underlying selection and influence processes on adolescent overweight/obesity
48 and antecedent WRBs [21, 28, 30].

50 **METHODS**

51 **Design**

52 The FAST Study enrolled longitudinal, observational cohorts of youth in four middle schools,
53 partnering with school and district leadership. Data collections were planned four times each school
54 year (September, December, March, June) for three years (6th grade [September 2018] to 8th grade [June
55 2021]). The large number of waves and high frequency of data collection (approximately every three
56 months) offered additional information for identifying the interplay between peer effects and several
57 contextual and psychosocial factors on WRBs over time. Importantly, the measurement timing coincided
58 with largely exogenous changes in the environment (return from summer vacation, class schedule
59 changes, athletic seasons) that influence interaction opportunities among school-aged peers. These
60 shifts in opportunities for interaction and activity may indirectly affect interpersonal relationships and
61 WRBs.

62 At the midpoint of the study, the COVID-19 pandemic resulted in closure of schools, clubs, gyms,
63 and restaurants, and led to widespread social distancing. Although the closures and distancing in 2020
64 proved challenging for our data collection, they also offered a substantial exogenous intervention to
65 social interaction networks, allowing us to examine pandemic effects on friendships, sentiments, shared
66 activities, and WRBs.

67 Due to the COVID-19 pandemic closure, data collection was temporarily halted in March 2020, days
68 before scheduled administration of wave 7. This resulted in a missed survey for March of 2020, which
69 was made up with a remote survey (both a web survey and paper survey sent by mail) administered in
70 August, 2020. Although late, wave 7 used a retrospective period of self-reported interaction and health
71 behavior for January 2 until the school closure, March 13, 2020, closely matching the period originally
72 intended for wave 7. Due to school closures, wave 8 was another remote survey (again both a web
73 survey and a mailed paper survey) in October 2020, with a retrospective period of self-reported
74 interaction and health behavior for the entire period when schools were closed from March 13, 2020,
75 until the start of school in September, 2020. Wave 8 thus matches the period originally intended for
76 waves 8 (Spring) and 9 (Summer). The next three waves (waves 9, 10, and 11) were implemented on
77 schedule for Fall, Winter, and Spring of the students' 8th grade year. These surveys were administered
78 online and by mail during the period of remote schooling. As schools were beginning to reopen during
79 wave 11, surveys were also administered in-person for some students at one school. A twelfth wave was
80 implemented in-person a year later (June of 9th grade) for participants who could be reached in high
81 school (Figure 1).

85 **Schools and Student Participants**

86

87 To protect the privacy of participants and schools, specific locations are not provided and school
88 names have been changed. All study procedures were approved by the university Institutional Review
89 Board and by the partnering school district. The school district, located in the Northeast region of the
90 United States, is predominantly low income (all students received free breakfast and most received free
91 lunch) and non-White (Hispanic/Latino and Black/African American). Four public middle schools (6th to

92 8th grade) participated in this study. The demographics at the four partnering schools are provided in
93 Table 1. The smallest cohort was at an arts-focused magnet school (ARTS, N = 55 at wave 1) and had a
94 majority female (72%) population. The largest cohort was at a magnet school with a focus on science
95 and technology (TECH, N = 99 at wave 1, 43% female). The third cohort was at a college-preparation
96 focused magnet school (PREP, N = 92 at wave 1, 54% female). The fourth cohort was at a traditional
97 neighborhood school serving a specific geographic area of the city (EAST, N = 71, 50% female).

101 **Formative Work and Pilot Study**

102 Formative work lasted from January 2017 to March 2018. During this period, we interviewed
103 school administrators to learn about the school's policies, practices, and infrastructure. Direct
104 observation of students provided general information on culture and norms at each school. Focus
105 groups were used primarily to develop, test, and revise survey questions. At least two focus groups
106 involving, on average, four students per group were conducted at each school, in both English and
107 Spanish, segregated by gender. Focus group participants went through an active written informed
108 parental/guardian permission process and students provided their written assent at the beginning of the
109 group sessions (February to March 2018).

110 From May to June 2018, the Pilot Study was conducted at two of the four participating schools;
111 the traditional neighborhood school (EAST) and one of the larger magnet schools (PREP). We measured
112 height and weight, and administered our draft survey, encouraging students to ask clarifying questions.
113 We revised the survey based on participant questions and detailed field notes so that the survey plus
114 height and weight measurements could be completed within a 50-minute classroom period. The

115 students for the formative work and pilot study were in the 6th grade in 2017- 2018, and thus were
116 different from the students enrolled in the prospective cohort study.

117 The formative work (i.e., observations, focus groups, and interviews) was crucial in helping us
118 develop and revise survey questions, but also later aids in interpreting responses and identifying
119 anomalies.

120

121 **Consent and Assent Processes**

122 In September 2018 we invited all 6th graders at the four partnering schools to participate in the
123 study. To achieve the high response rate needed for meaningful network analysis [31], participants were
124 recruited using a written passive informed consent process, where parents/guardians were notified by
125 letter and all students in each cohort were allowed to participate unless their parent/guardian replied
126 with a refusal. The school district agreed to the passive consent process with the understanding that
127 survey questions would not involve potentially sensitive topics (e.g., child abuse, alcohol or drug use,
128 sexual activity, disordered eating, bullying and teasing, body image, mental health).

129 In addition to the consent process, students provided their written assent to participate in the
130 study at the beginning of each wave of data collection. Each data collection session began with a brief
131 description of the study and review of the assent form prior to beginning the survey or having their
132 height or weight measured. Students could assent and complete the survey but refuse to have their
133 height and weight measured. If new students joined the school during the duration of the study
134 (September 2018 to June 2021), but after this initial recruitment, the same procedures for
135 parental/guardian permission and student participant assent were followed.

136 Students whose parents opted them out of the study (n = 15, 4.7%) and those that refused
137 assent in a given wave were instructed to read or work on material provided by the teacher. Sample
138 sizes at each data collection wave are presented in Table 2. Lower participation rates in waves 8 through

139 11 are due to remote survey administration during the pandemic, and in wave 12 due to inability to
140 access students at some high schools (9th grade year). All recruitment, consent, and assent procedures
141 were approved by the university's Institutional Review Board and the participating school district.

145 **Measures**

146 **Sociometric Constructs**

147 Previous work on adolescent social networks has focused primarily on *friendship* networks,
148 interpreting friendship networks as synonymous with networks of social interaction or sentiments [29].
149 Our focus groups revealed that adolescents in this population defined friendship primarily in terms of
150 normative obligations, and derived a set of 11 descriptors that our subjects use to define the friendship
151 concept. Throughout the study, the electronic survey allowed respondents to rank those 11 descriptors
152 (presented in initially random order) in importance for defining friendship. Analysis of pilot study data
153 [32] confirmed that friendship is primarily a normative concept, and found that girls and boys use the
154 term differently. Our pilot study also showed that direct measures of social *interaction* (spending time
155 together in person or online), social *sentiments* (liking or disliking), and *access* to one another (shared
156 classes, neighborhoods, clubs) produce networks that are quite distinct from networks of *role relations*
157 like friendship or kinship. Even questions about different forms of interaction (e.g., face to face vs.
158 online interaction, lunch cafeteria partners, physical activity partners) elicited clearly distinct networks.
159 Therefore, the FAST Study network measures captured these four distinct network concepts [33] rather
160 than merely measuring friendships.

161 We operationally defined *access* as the participants' class schedules and residential proximity to
162 each other, using data provided by the school district, and measured cohabiting and shared club or team

163 membership using our survey. The remaining network measures were derived from our survey. We
164 measured *role relations* as self-reported friendship or kinship around the time of the survey. We
165 measured *sentiments* around the time of the survey on a 5-point scale from Strongly Dislike to Strongly
166 Like, with neutral as the default choice. Our *General Interaction* questions assessed whether the
167 participants spent time together (face to face or online) at least once per *week* during the recall period
168 of each wave (normally three months). Our *Health Behavior Interaction* questions assessed interaction
169 specifically related to the target health behaviors – physical activity, screen time, eating – which are
170 explained in the survey. These behaviors are a narrower subset of total interaction, so we used a more
171 liberal interaction threshold (at least once per *month* during the recall period of each wave). We also
172 asked respondents to report with whom they regularly sit in the cafeteria. The key wording for the 10
173 network questions is summarized in Table 3 and full wording for all questions is provided in Appendix A.

177 For each network question, the content of the question was followed by a roster containing the
178 names of all same-grade students. Respondents could select, “There is no one on this list that I want to
179 select” to allow us to differentiate a non-response from a lack of ties. Importantly, there was no limit on
180 the number of students that could be nominated for any of the network questions. For the teams and
181 clubs question, a series of follow-up questions aimed to identify the names of teams or clubs that the
182 respondent participated in jointly with each nominated peer. For the “relatives” question, a series of
183 follow up questions aimed to clarify the specific relationship of the nominated peer to the respondent
184 (i.e., sibling, cousin, or housemate).

185 Interaction questions were asked before the friendship question to avoid priming participants to

186 recall just those they consider friends, aiming to capture a broader range of interaction partners.

187 Similarly, general interaction questions were asked before health behavior interactions to avoid priming

188 just those who share health behaviors. Health behavior interaction questions were presented in random
189 order for each subject in the electronic survey. Preliminary analyses [34] revealed no evidence of bias
190 due to the order of names on the roster. Randomization of question order for health behavior
191 interaction questions allowed us to examine question order effects, and preliminary analyses indicate no
192 evidence of question order effects. To assess the extent of student friendship networks outside of
193 cohort peers, the survey also asked about the number of friends in other grades or at other schools.

194
195 **Weight-Related Behaviors**

196 Questions that assessed WRBs of interest (physical activity, screen time, dietary patterns) and
197 sleep patterns were modified from existing validated instruments. Most behavior questions were
198 retrospective to the period since the previous survey (typically 3-4 months). See Appendix A for question
199 wording.

200 *Physical Activity* questions were modified from the 3-item Godin-Shepard Physical Activity
201 Survey [35] that has been previously used in middle and high school students [18, 36, 37]. Prior to any
202 physical activity question (including the social interaction question related to physical activity), a
203 definition was provided to ensure that respondents were considering all physical activity, not just
204 organized sports. Questions asked about vigorous, moderate, and light intensity physical activity with
205 relevant examples for each, derived from the focus groups and pilot testing.

206 *Screen time* was assessed with five items that have previously been used in adolescent
207 populations and, consistent with previous studies, the same questions were asked separately for
208 weekdays and weekends [38, 39]. Participants recalled times when they engaged in these screen
209 behaviors while lying down or sitting, to capture sedentary screen time. The questions reflected new
210 technologies and focused on the types of screen behavior (e.g., TV/Streaming, video games, social
211 media, voice/video communication, web browsing) regardless of the platform used (phone, tablet, or

212 computer). Two additional questions captured whether respondents played active video games, “where
213 you’re standing up, dancing, jumping.”

214 *Dietary patterns* were assessed with a series of questions that focused on frequency, during a
215 regular week, of healthy and unhealthy dietary patterns that have been associated with healthy weight
216 or excess weight gain in youth [38, 40, 41]. Questions included frequency of eating takeout/delivery
217 meals and snacking during a regular week. Frequency of drinking eight types of beverages including:
218 regular soda, diet soda, regular sports drinks, sugar-free sports drinks, other sugar-sweetened
219 beverages, other sugar-free beverages, 100% fruit juice, and water. Breakfast consumption during a
220 regular week was assessed with one question, and two questions assessed frequency of fruit and
221 vegetable consumption during the past week. Lastly, one binary (yes/no) question determined if the
222 participant had “gone on a diet to lose weight” during the wave period.

223 *Sleep patterns* were assessed in waves 10-12, in response to the Covid pandemic, using
224 questions from the Sleep Habits Survey for Adolescents [42]. Questions were asked separately for
225 weekdays and weekends, to determine what time participants usually went to bed in the evening, what
226 time they usually got out of bed in the morning, and how many nights they had trouble falling asleep.

227

228 **Psychosocial Variables**

229 *Social Support (Peers)*. At each wave, the survey assessed the level of social support participants
230 received from their friends for physical activity (three questions) [15, 36]. At the first wave that each
231 participant responded, the survey also asked about the social support participants received from their
232 parents for physical activity (two questions), eating a healthy diet (four questions), and limiting their
233 screen time (two questions), plus social support for physical activity received from older siblings (two
234 questions) [15, 36, 43].

235 *Subjective social status.* A ladder-type question assessed participants' perceived popularity in
236 the school (modified from Goodman et al. [44]), whereas the social network data (e.g., friend and
237 sentiment measures) provided independent measures of participants' popularity within the grade
238 cohort.

239

240 **Demographics**

241 The survey asked participants to report their sex (male or female), birth date and race/ethnicity
242 (*American Indian or Alaska Native, Asian, Black or African American, Hawaiian or Other Pacific Islander,*
243 *Hispanic or Latino, or White*). Multiple race-ethnic categories could be selected. A follow-up question
244 reminded each participant of the full set of their race/ethnicity responses and then invited them to
245 elaborate on or explain their responses in an open text field. Starting in wave 6, participants could
246 choose "Other" and elaborate in an open text field, and an additional question asked about finer-
247 grained identities derived from open text fields in earlier waves (*Brazilian, Dominican, Puerto Rican,*
248 *Salvadorian, Venezuelan*). From wave 7 onward this question was expanded to (*Bahamian, Brazilian,*
249 *Cuban, Dominican, Guatemalan, Jamaican, Mexican, Panamanian, Peruvian, Puerto Rican, Salvadorian,*
250 *Venezuelan*) and the option "*Hispanic or Latino*" was broken into 2 choices: "*Hispanic*" and "*Latino.*"
251 From wave 10 onward, participants were asked in a separate question if they identified as "*Multiracial*
252 *or Mixed Race.*" Starting in wave 4, participants indicated all languages they speak and the language
253 they speak most often at home.

254

255 **Onset of Puberty**

256 To assess onset of puberty, girls were asked about age at menarche and boys were asked about
257 age at voice deepening and facial hair growth [45, 46]. The puberty questions were asked at each wave
258 until a student responded in the affirmative.

259

260 **COVID-19 Questions**

261 For the four data collection waves during the 2020-2021 academic year, the survey included
262 additional questions related to participant experiences with COVID-19 (whether they had been
263 diagnosed with or tested positive for COVID-19, had a known exposure to COVID-19, or wished to be
264 vaccinated). An open-ended question asked about how the pandemic was affecting their social lives and
265 WRBs. During these waves, survey questions also asked about participation in online PE classes and
266 working on PE assignments outside of school hours. Given mandates for social distancing during the
267 early pandemic, two questions asked about the *amount of time* spent interacting with others outside of
268 school hours; separate questions were asked for interacting with other cohort members and interacting
269 with students who go to other schools (or are in other grades at their school). Separate questions for
270 face to face and online interactions were also included. During school reopening (wave 10), one
271 question asked if the *number of people* they interacted with face to face had increased, decreased, or
272 stayed the same.

273

274 **Household Characteristics**

275 The survey included questions to capture basic household characteristics, such as household
276 size, number of older and younger siblings, and which relatives and non-relatives lived in the household.
277 To assess youth perceptions of family socioeconomic status, the survey also included the Family
278 Affluence Scale [47, 48] with minor modifications for the contemporary era, asking subjects to report
279 the following about their household: number of bathrooms at home, having one's own bedroom, having
280 a clothes washing machine at home, number of computers, vacation travel, and number of vehicles
281 owned. The Wave 11 and 12 surveys also asked for education and employment status of parents in the
282 subject's primary home (father or stepfather, mother or stepmother). Questions about parental

283 education and employment were not asked earlier due to results from our pilot study indicating that the
284 6th grade students struggled to respond, with just over half the responses being “I don’t know”. Further,
285 heterogeneous family structures complicated measurement of respondents’ family social support,
286 socioeconomic status, parental education and employment, siblings, and who the respondent lived with.
287 We sought to develop questions that would be generally applicable to respondents from diverse
288 households without being overly complicated.

289

290 **Height, Weight**

291 For waves 1 to 6 (before the pandemic school closure), each student’s height and weight were
292 measured by trained research staff to the nearest 0.1 cm and 0.1 kg, respectively, using a portable
293 stadiometer (Weigh and Measure, LLC, Olney, MD) and digital scale (Seca 876, Hanover, MD). Students
294 were measured in a semi-private location away from the survey administration and without shoes,
295 coats, jackets, and heavy sweaters, or sweatshirts. Participants could see the scale display but it was in
296 kilograms, not pounds, and if students inquired about their height or weight they were encouraged to
297 look up the conversion factors online. During waves 9-12 two questions were added to the survey to
298 allow participants to self-report height (in feet and inches) and weight (in pounds). In-person
299 measurement was permitted at one middle school in wave 11 and at two high schools in wave 12. For
300 that subset of the population, both self-report and measured height and weight are available.

301

302 **Data Collection Protocol**

303 The FAST Study survey mode of administration was adapted to the pandemic school closure
304 (March 2020) and subsequent full reopening of schools (September 2021). The survey was administered
305 in school via digital touchscreen tablets (waves 1-6, 12), remotely using web surveys (waves 7-12), or
306 mailed paper surveys with self-addressed stamped envelopes (SASE) (waves 7-11). Both tablet and web

307 surveys employed Qualtrics software (Qualtrics, Provo, UT). Most data were collected during school
308 hours. Data were collected at each school on a single day (with make-up days for absent students). The
309 data collection days for the four schools were scheduled around the same time, at least within a 2-week
310 period for each wave.

311 Trained research staff prepared tablets for survey administration. Desks were spread apart as
312 much as possible to increase privacy and discourage talking during the survey. Tablets had privacy
313 screens to prevent participants from seeing each other's responses. Research staff provided brief
314 scripted instructions followed by the assent. Participants were allowed to work at their own pace and
315 raise their hand if they had a question. Participants could skip questions but, for most questions, were
316 prompted with a pop-up screen with options to complete the question or continue without answering.
317 After the survey and height and weight measurements, participants received a \$10.00 gift card to a
318 national retail store for participating in each data collection session. At least one makeup session was
319 scheduled at each school to collect data from those who were absent on the main day. To encourage
320 continued participation during the pandemic, additional raffles were held in each school for headphones
321 and \$100.00 and \$200.00 gift card prizes. The gift card amount for participation was increased to \$20 for
322 wave 12 to further incentivize participation.

323 For wave 7 (several months after the pandemic closed schools) participants were sent a letter
324 with a link to a web-based version of the survey and a paper copy of the survey with a self-addressed
325 stamped envelope; students chose how they wanted to respond. After classes began operating in virtual
326 classrooms in September, 2020, from wave 8 to wave 11 most students responded to the survey during
327 a synchronous online classroom with a survey link provided in the chat window of the virtual classroom.
328 Students who were absent on the time of survey administration were sent a packet containing an
329 invitation letter with instructions on how to access the web survey, a paper copy of the survey with a
330 SASE for returning the paper survey if they chose this mode. If students did not respond to the survey

331 after two weeks (waves 7-11), they were sent a one-page reminder letter. If there was still no response
332 after another two weeks, a final reminder letter was sent with web survey instructions, paper survey
333 and SASE. The survey was revised as necessary for the hardcopy mail survey, and questions that
334 required the Qualtrics software interface were dropped.

335

336 **Quality Control**

337 Respondents' self-reported date of birth was reconciled across all waves and checked against
338 school district administrative data, then used to compute age at each data collection wave. Respondent
339 sex was reconciled across all waves and checked against school district administrative data. Multiple
340 data checks and identity verifications allowed us to detect and later fix anomalies, such as when
341 participants responded to the survey more than once, selected the wrong name for themselves in the
342 survey, or (in one vexing case) two participants swapped tablets in mid-survey. We were able to identify
343 some low-quality survey responses, such as when a subject selected the same choice for an entire block
344 of questions, or claimed to be friends with everyone, when that claim was not corroborated by other
345 participants and was very inconsistent with observations from other waves.

346 Duplicate survey observations (e.g., when a subject completed a survey twice, responded both
347 to an online and paper survey, or stopped in mid-survey and then started over at a later time) were
348 compared and reconciled. Duplicate measures often included low-quality values, where a participant
349 skipped through questions seen a second time. Thus, for duplicate values on questions employing
350 selection among fixed choices, we took the *first* response value unless it was missing or marked as
351 suspect for other reasons. For questions employing multiple checkboxes (e.g. race identities, network tie
352 nominations), we took the union of responses across duplicate observations.

353 Use of multiple measures and multiple temporal observations also provide information about
354 subjects' response patterns and facilitate identification and interpretation of response errors. For

355 example, repeated measurement and subsequent refinement of demographic questions along with
356 open text fields that allowed participants to explain their answers gave us opportunities to observe,
357 diagnose, and correct reporting errors by respondents in the data cleaning process. We liberally used
358 open text fields to provide context for checkbox responses and identify misunderstandings (e.g.,
359 Caribbean students who once mistakenly checked “Pacific Islander” or Puerto Rican students who once
360 mistakenly checked “American Indian” when they had meant *American*.)

361 Similar to survey responses, anomalies in height and weight measures were reconciled using
362 multiple waves of available data and field notes taken during the data collection sessions. Duplicate
363 measures of height and weight were averaged.

364 Use of multiple measures and multiple observations also allowed for cleaning of the sociometric
365 data. Notably, the interaction questions are symmetric by design (i.e., if subject A has lunch with subject
366 B, then B must also have lunch with A). Measures of whole networks (rather than capturing ego
367 networks for a sample of individuals) enables comparing reports by both partners. This allows diagnostic
368 work [49] to adjust for errors in self-reports of interaction partners, such as egregious over- or under-
369 reporters of network ties.

372 **CONCLUSION**

373 The aim of the FAST Study is to better understand the social network processes that potentially
374 shape WRBs in middle school students. By better understanding these processes, our long-range goal is
375 to improve efficiency and effectiveness of WRB interventions by incorporating social network
376 information into the design and implementation of these interventions.

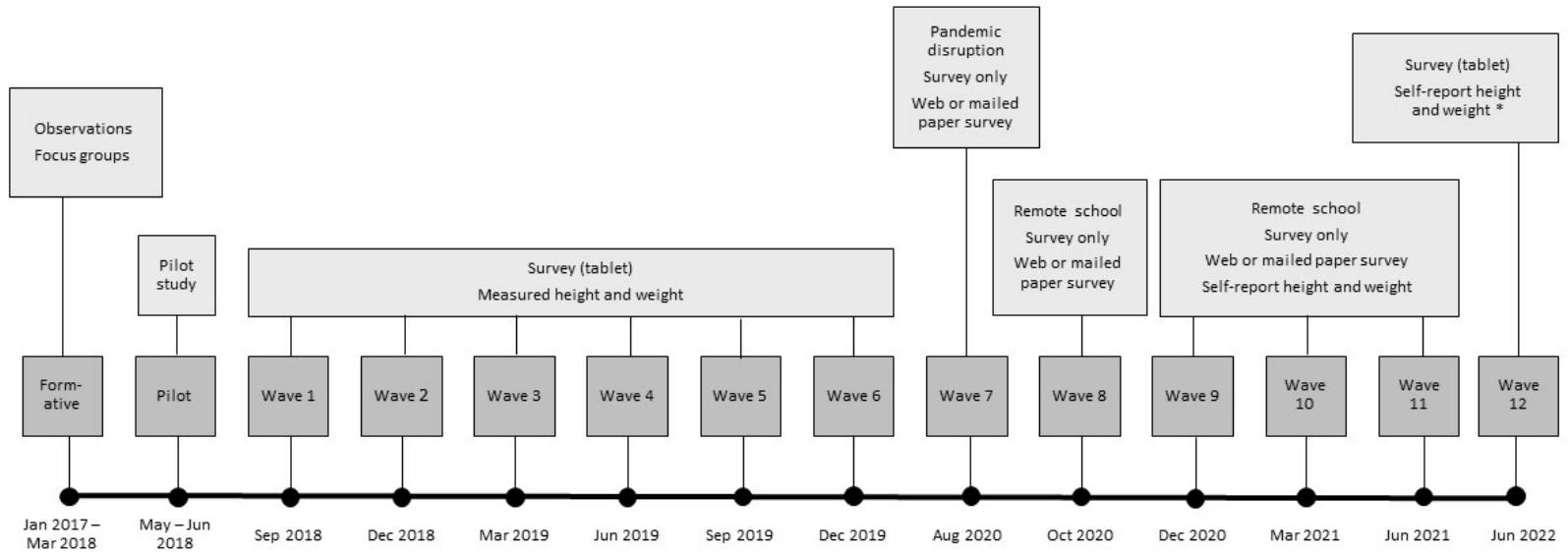


Figure 1: Fast Study timeline
