19 Abstract

Background: Early life adversity (ELA) is associated with altered insulin signaling and altered 20 21 EF behaviors, in a potentially sex-specific manner. Considering the high co-morbidity between altered metabolism and executive function (EF) problems, we hypothesized that the genetic 22 23 background associated with altered fasting insulin (FI) and EF could be shared. Methods: Our 24 study used conjunctional false discovery rate (ConjFDR) to identify the shared genetic 25 architecture between FI and two EFs: impulsivity and attention deficit-hyperactivity disorder 26 (ADHD). We identified the polygenic risk score (PRS) threshold from a FI genome-wide 27 association study (GWAS) that best predicted insulin levels in male and female ALSPAC 28 children [N_{males}=1,901, N_{females}=1,834; $p_{t-intial-males}$ = 0.05 (11,121 SNPs), $p_{t-intial-females}$ = 0.15 29 (27,202 SNPs)], further refining it to only include SNPs significantly associated with insulin 30 levels in children [$N_{SNP-males}$ = 635 SNPs, $N_{SNP-females}$ = 1,449 SNPs]. A phenome-wide association 31 study (PheWAS) was also run to identify EFs associated with the interaction between the refined 32 PRS (rPRS) and early adversity. To investigate the presence of a direct causal relationship 33 between FI and impulsivity in the presence of adversity, we applied mendelian randomization 34 (MR). Results: ConjFDR suggested that environmental factors could be involved in the 35 association between insulin and EFs, as there was no shared genetic background. PheWAS 36 highlighted impulsivity and attention-related outcomes in interaction models between FI rPRS 37 and early adversity. Finally, two-sample MR suggested a causal association between higher fasting insulin levels and impulsive behavior, specifically in females exposed to adversity (p < p38 39 0.001). Overall, a sex-specific impulsivity GWAS demonstrated that *MYT1L* and *TSSC1*, genes 40 that are associated with motor impulsivity, were enriched only in females. Conclusions: Our 41 study solidifies the evidence that the relationship between high FI and EF is not direct, but rather

46 Introduction

Exposure to ELA is a developmental risk factor associated with metabolic and psychiatric phenotypes. ELA leads to alterations in responsivity to stress and alters insulin sensitivity at different ages. Childhood adversity and adult stress exposures have been linked to diabetes and altered glucose regulation, and chronic adulthood stress has been associated with glucose intolerance and metabolic syndrome (Pyykkönen *et al*, 2010). These findings emphasize that ELA impacts insulin regulation and function, making it an important node to investigate.

Insulin is a hormone involved in metabolism regulation in animals, and a neuroregulatory peptide in the central nervous system, including the prefrontal cortex (PFC) (Ghasemi *et al*, 2013). In PFC, insulin modulates the development and expression of different executive function (EF) behaviors (Kullmann *et al*, 2016), such as attention, inhibitory control, and working memory. Insulin reduces activity in the prefrontal areas that control behaviors like the inhibitory control of eating (Heni *et al*, 2015). In Alzheimer's patients, insulin dysregulation has been linked to learning deficits and memory formation impairments (Zhao and Alkon, 2001).

A recent study demonstrated that metabolic syndrome and IR were associated with poorer executive performance in women (Schuur *et al*, 2010), suggesting that insulin could be related to EF in a sex-specific manner. Co-morbidity between metabolic and psychiatric diseases has been established, and, interestingly, among adults with ADHD, there is a 18.7% higher prevalence of type 2 diabetes in males compared to females (Chen *et al*, 2018).

65	We have previously reported (Batra et al, 2021) that a polygenic risk score associated
66	with higher FI interacts with ELA to predict the development of inhibitory control in children at
67	36 months. This reinforced the idea that insulin may moderate the effects of ELA on EF.
68	However, as the effects of ELA are often sex-specific (Barbieri et al, 2009b; Honeycutt et al,
69	2020), a better understanding of sex-specific relationships between ELA, insulin, and the
70	development of EF is needed. Our hypotheses for the current study are 1) the genetic
71	backgrounds associated with high FI and EF share a polygenic architecture; 2) if (1) is rejected,
72	models including the interaction term between the genetic background associated with high FI
73	and childhood adversity exposure could show association with EF across lifespan; 3) if (2) shows
74	significance results, there may be a causal relationship between FI levels and impulsivity in the
75	presence of adversity, which we will inspect through mendelian randomization (MR).

87 <u>Conditional/conjunctional FDR</u>

88 Analyses applied here used false discovery rate (FDR) methods previously established by 89 Andreassen et al (Andreassen et al, 2013b). To evaluate the cross-phenotype polygenic 90 architecture, we produced conditional quantile-quantile (Q-Q) plots. The plots condition FI on impulsivity or ADHD, and vice versa, plotting observed p-values against theoretical quantiles 91 92 under no association. A straight null line indicates no association, whereas deviation indicates systematic association. Each Q-Q plot displays SNP p-values of trait 1, conditional on varying 93 94 associations with trait 2, which allows us to determine a presence of a shared polygenic 95 architecture between the traits.

96 To identify shared loci between FI and impulsivity or ADHD, we applied the conditional 97 FDR (condFDR) and conjunctional FDR (conjFDR) methods (Andreassen et al, 2013a; 98 Andreassen et al, 2014) (Note: both methods assume the p-values for that SNP in both the 99 primary and the conditional traits are lower than the observed p-values). CondFDR employs 100 genetic association summary statistics from a trait of interest (FI) together with those of a 101 conditional trait (impulsivity or ADHD) to estimate the posterior probability that a SNP has no 102 association with the primary trait. This method identifies loci associated with the primary trait by 103 using associations with the conditional traits. The conjFDR statistic is the maximum of the 2 104 mutual condFDR values and is a conservative estimate of the posterior probability that a SNP 105 has no association with either trait. Using conjFDR helps identify loci which are associated with 106 both traits. A conservative FDR level of 0.01 per pairwise comparison was set for 107 condFDR/conjFDR, corresponding to a false positive rate of 1 in 100 reported associations. 108 More details can be found in the original and subsequent publications (Andreassen *et al*, 2013a; 109 Andreassen et al, 2014; Andreassen et al, 2013b; O'Connell et al, 2020).

110 Investigating the interactive effects between polygenic scores for higher fasting insulin and

111 childhood adversity on altered executive function phenotypes in a sex-specific manner

112 *Participants*

113 We used data from five prospective birth cohorts: 1) Avon Longitudinal Study of Parents 114 and Children (ALSPAC) (Boyd et al, 2013; Fraser et al, 2013); 2) Maternal Adversity, 115 Vulnerability, and Neurodevelopment (MAVAN) (O'Donnell et al, 2014); 3) Growing Up in 116 Singapore Towards healthy Outcomes (GUSTO) (Soh et al, 2014); 4) Adolescent Brain Cognitive Development SM Study (ABCD®) (Jernigan et al, 2018); and 5) UK Biobank (UKB) 117 118 (Sudlow et al, 2015) to analyze the gene by environment interaction effects on EF outcomes. 119 Details about recruitment, inclusion criteria for this study and genotyping information on the 120 cohorts can be found in supplementary materials.

121 The Avon Longitudinal Study of Parents and Children (ALSPAC) (Northstone et al. 122 2019): For our analysis, we included children of 8.5 and 9.5 years old (individuals with 123 peripheral insulin levels data), whose mothers had a pregnancy duration between 37 and 42 124 weeks, a maternal age at delivery greater than 18 years, a child birthweight greater than 2 kg, 125 child alive at 1 year of age. We only included singleton pregnancies in the analysis. There were 126 1,901 males and 1,834 females with complete data available for the analyses. Ethics approval for 127 the study was obtained from the ALSPAC Ethics and Law Committee and the local research 128 ethics committees (a full list of the ethics committees that approved different aspects of the 129 ALSPAC studies is available at http://www.bristol.ac.uk/alspac/researchers/research-ethics/). 130 Data were collected during clinic visits or with postal questionnaires. Informed consent for the 131 use of data collected via questionnaires and clinics was obtained from participants following the 132 recommendations of the ALSPAC Ethics and Law Committee at the time.

Maternal Adversity, Vulnerability, and Neurodevelopment (MAVAN) Project (O'Donnell 133 134 et al, 2014): After applying the exclusion criteria, 161 subjects had complete data on the relevant 135 predictors, as described in supplementary Figure S7. Approval for the MAVAN project was 136 obtained by the ethics committees and university affiliates (McGill University and Université de 137 Montréal, the Royal Victoria Hospital, Jewish General Hospital, Centre hospitalier de 138 l'Université de Montréal and Hôpital Maisonneuve-Rosemount) and St. Joseph's Hospital and 139 McMaster University, Hamilton, Ontario, Canada. Informed consent was obtained from all 140 participants.

141 Growing Up in Singapore Towards healthy Outcomes (GUSTO) (Soh et al., 2014) 142 prospective cohort: Study sample was selected based on data availability for each analysis. There 143 were 466 subjects with complete data on the predictors used within this study available for the 144 analyses, as described in supplementary Figure S7. This study was approved by the National 145 University Hospital and KK Women's and Children's Hospital, National Healthcare Group 146 Domain Specific Review Board (NHG DSRB Ref D/09/021) and Sing Health Centralized 147 Institutional Review Board (CIRB Ref 2018/2767). Written informed consent was obtained from 148 mothers and their children.

Adolescent Brain Cognitive DevelopmentSM Study (ABCD®) (Jernigan et al, 2018): There were 7,655 subjects with complete data available for the analyses, as described in *supplementary Figure S7*. The institutional review board of the University of California, San Diego centralized the approval for data collection. The study sites where data were collected also obtained approval from their local institutional review boards. All parents gave written informed consent and children verbal assent.

155 UK Biobank (UKB) (Sudlow et al, 2015): Of the total 502,543 participants in this cohort, 156 71,036 subjects had complete data on the predictors used within this study available for the 157 analyses, as described in *supplementary Figure S7*. This research was conducted using the UK 158 Biobank Resource under Application Number 41975. Approval for the UK Biobank was 159 obtained by the North West Multicentre Research 580 Ethics Committee (REC reference 11/NW/0382; http://www.ukbiobank.ac.uk/ethics/), the National Information Governance Board 160 161 for Health and Social Care and the Community Health Index Advisory Group. Informed consent 162 was obtained from all participants.

163 <u>Refined Polygenic Risk Scores (rPRS)</u>

We sought to identify the optimal high FI PRS threshold to predict FI levels in children from the ALSPAC cohort, in a sex-specific manner (using a sex-specific FI GWAS). We used the refined-PRS (rPRS) method described in our previous study (Batra *et al*, 2021). The rPRS was subsequently applied in four separate cohorts, analyzing males and females seperately, to examine how the interaction between higher FI rPRS and ELA impacts EF behaviors across different age groups.

170 ALSPAC: FI PRSs were calculated using FI GWASs separately for males and females 171 $(N_{males} = 47,806, N_{females} = 50,404)$ from the Meta-Analyses of Glucose and Insulin-related traits 172 Consortium PRSs were calculated at 100 different p-value thresholds for each individual in the 173 ALSPAC cohort as a sum of the risk alleles count, weighted by the effect size described in the 174 GWAS for each SNP. We then utilized Generalized Estimating Equations (GEE) analysis to 175 identify the threshold of PRS at which the model predicting peripheral insulin levels in children 176 at age 8.5-9.5 years best fit to the data, separately in males and females. To further refine the 177 PRS, a process explained in Batra et al (Batra et al, 2021), we ran a GEE analysis for each SNP

within the identified PRS threshold to identify which SNPs were significantly associated with 178 179 peripheral insulin levels separately for males and females $[N_{SNP males} = 635 \text{ SNPs}, N_{SNP females} =$ 180 1,449 SNPs] (Refer to Supplementals).

181 MAVAN, GUSTO, ABCD, and UKB: The SNPs we discovered to associate with 182 peripheral insulin levels in the ALSPAC cohort were used to construct a rPRS in these four 183 cohorts. Because the SNPs were selected in a refinement process of a PRS that was created 184 through conventional means, we refer to this PRS as the refined PRS. The rPRS was calculated 185 similarly to the PRS scores in ALSPAC, as a weighted sum of 635 SNPs for males and 1,449 186 SNPs for females.

187 Early Life Adversity

188 To inspect the interaction effect between the PRS and early life adversity, we calculated 189 adversity exposure using a cumulative score involving different environmental variables for each 190 individual in the cohorts as described by Silveira et al. (Silveira et al. 2017). Details on the 191 components of the scores can be found in supplementary materials.

192 *Executive Function Behavioral Outcomes*

193 To inspect the interaction effect of the PRS and early life adversity on EF, we used all the 194 EF behaviors with available data for each cohort. The MAVAN cohort outcomes consisted of EF 195 behavior data from the Bayley Scales of Infant Development II (Balasundaram and Avulakunta, 196 2021), Child Behavior Checklist (CBCL) (Achenbach and Edelbrock, 1991), School Readiness 197 Test Battery (Gan et al, 2016), Dominique Questionnaire (Kuijpers et al, 2013), Strengths and 198 Difficulties Questionnaire (SDQ) (Bøe et al, 2016), Cambridge Neuropsychological Test 199 Automated Battery (CANTAB) Intra and Extradimentional shift (IED), and Information 200 Sampling Task (IST) (Sahakian and Owen, 1992). The GUSTO cohort outcomes consisted of EF

201 behaviors data from Bayley Scales of Infant Development II (Balasundaram et al, 2021), Child 202 Behavior Checklist (CBCL) (Achenbach et al, 1991), Stop Signal Task (SST) (Chikazoe et al, 203 2009), Snack Delay Task (Silveira et al, 2012), Sticker Delay Task (Silveira et al, 2018). The 204 ABCD cohort outcomes consisted of EF behaviors data from the Child Behavior Checklist 205 (Achenbach et al, 1991), Brief Problem Monitor (BPM) assessment (Achenbach et al, 2011), and 206 UPPS-P Impulsive Behavior Scale (Cyders, 2013). The ABCD Study data repository grows and 207 changes time. The ABCD this over Study data used in report came 208 from https://dx.doi.org/10.15154/1503209. The UKB cohort analysis consisted of psychiatric 209 outcomes related to EF outcomes.

210 Interaction PheWAS

211 We performed a linear regression (for continuous outcomes) and logistic regression (for 212 binary outcomes) analyses for each PheWAS to investigate the interaction effect between the 213 rPRS for FI and postnatal adversity exposure on each EF behavior separately in males and 214 females in MAVAN, GUSTO, ABCD, and UKB, adjusted by population stratification PCs, age 215 and other covariates if they were found to be significantly different between low/high PRS 216 groups (as presented in Tables 1-4). We also used GEE if an outcome was measured several 217 times. Details on the EF behaviors analyzed for each cohort can be found in supplementary 218 materials.

219 Enrichment Analysis

Enrichment analyses for gene ontologies were performed using MetaCoreTM (Clarivate Analytics) on the SNPs that compose the FI rPRS for males and females separately. Furthermore, gene-based enrichment analyses were performed in FUMA (<u>https://fuma.ctglab.nl/</u>) (Aguet *et al*,

223 2019; MacArthur *et al*, 2017; Watanabe *et al*, 2017) after mapping the SNPs composing the FI 224 rPRS to genes with the biomaRt package in R (Durinck *et al*, 2005; Durinck *et al*, 2009).

225 Investigating the causal relationship between high fasting insulin and altered executive

- 226 functions according to early adversity exposure in a sex-specific manner
- 227 <u>Two-Sample Mendelian Randomization Analyses</u>

228 Two-sample MR analyses were performed using R (Durinck et al, 2005; Durinck et al, 229 2009) and the TwoSampleMR package (Hemani et al, 2018b). Exposure and outcome GWAS 230 summary statistics were harmonized as described within the package. To assess horizontal 231 pleiotropy (i.e., an association of the genetic instrument with the outcome independent of the 232 exposure), we used the MR-Egger estimation for genetic instruments. When the pleiotropy 233 assumption was not met, we used a different statistical method robust to pleiotropy: MR pleiotropy residual sum and outlier (MR-PRESSO). MR-PRESSO is able to identify outliers 234 235 with potential horizontal pleiotropy when using multiple genetic variants as an instrument and 236 provides a corrected estimate after removing these outliers (Zhao and Schooling, 2021). We first 237 performed fixed-effects meta-analysis of genetic instruments using inverse-variance weighting 238 (IVW) (Hemani et al, 2018a). Standard errors were computed with the Wald estimator and delta 239 weighting to account for uncertainty in genetic association with the exposure. Then, to assess the 240 robustness of our findings, we performed a simple median MR and weighted median MR. Since 241 we were interested in inspecting the interaction effect between FI and adversity exposure on 242 impulsivity, we separate analysis on males and females: 1) two-sample MR between the FI 243 GWAS and an impulsivity GWAS constructed with data from individuals exposed to adversity; 244 2) two-sample MR between the FI GWAS and an impulsivity GWAS constructed with data from 245 individuals that were not exposed to adversity.

246 **Results**

Investigating the shared genetic background between higher fasting insulin and altered executive function phenotypes (impulsivity and ADHD)

The conditional Q-Q plots did not show enrichment for FI given impulsivity or ADHD as evident in *supplementary Figure S8*. The blue lines in *supplementary Figure S8* are drawn using the FI GWAS including all the SNPs regardless of their association with impulsivity or ADHD. An increasingly leftward deflection from the dashed line of no association was not observed when SNPs with stronger association with impulsivity and ADHD were plotted. To provide a list of shared loci between FI and impulsivity or ADHD, we performed conjFDR analyses where we found no SNPs in common between the genetic datasets.

Summary statistics for the sex-specific impulsivity GWAS generated in this study can be found at <u>https://github.com/SilveiraLab/Sex-Specific_Impulsivity_GWAS</u>. A brief description of the findings from this GWAS can be found in the Supplementals (*Figures S1, S2, S3, S4, S5, and S6*).

Investigating the interactive effects between polygenic risk scores for higher fasting insulin and childhood adversity on altered executive function phenotypes in a sex-specific manner

Baseline comparisons between low and high PRS groups were performed in all four cohorts. In the MAVAN cohort, the only main confounding variable that was significantly different between low and high PRS was birth weight in males (p = 0.034) (*Table 1*). In the GUSTO cohort, ethnicity in females (p = 0.016) was significantly different between the low and high PRS as shown in *Table 2*. In the ABCD cohort, household income in females (p < 0.001), was significantly different between low and high PRS (*Table 3*). In the UKB cohort, there were no significantly different confounding variables between low and high PRS (*Table 4*).

269 PheWAS Analysis

270 We performed linear and logistic regression analyses to investigate the interaction 271 between rPRS for FI and postnatal adversity exposure on EF behavior separately in males and 272 females across MAVAN, GUSTO, ABCD, and UKB cohort. Analyses were adjusted by 273 population stratification PCs, age, and other covariates if they were found to be significantly 274 different between low/high PRS groups (Tables 1-4). Significant interaction effects, presented 275 by nominal p-values in each cohort, are highlighted in *Figure 1*. None of the outcomes remained 276 significantly were associated after adjusting for multiple testing. Results for the enrichment 277 analyses can be found in supplementary materials.

Investigating the interactive effects between polygenic scores for higher fasting insulin and
 childhood adversity on altered executive function phenotypes in a sex-specific manner

280 Mendelian randomization analyses tested potential causal associations between FI and 281 impulsivity. Before running two-sample MR, we used the MR Egger intercept test to verify 282 horizontal pleiotropy. Test results did not reject the hypothesis of horizontal pleiotropy in males 283 exposed to adversity (intercept = -0.00008; standard error = 0.00002; p < 0.001), in males not exposed to adversity (intercept = 0.00009; standard error = 0.00001; p < 0.001), and in females 284 285 not exposed to adversity (intercept = 0.00004; standard error = 0.00001; p = 0.001). Using MR-286 PRESSO, we identified and remove outliers in those three cases and performed MR Egger again. 287 The test could not significantly deny the presence of horizontal pleiotropy in males exposed to 288 adversity (intercept = -0.0001; standard error = 0.00002; p < 0.001), in males not exposed to 289 adversity (intercept = 0.00008; standard error = 0.00001; p < 0.001), and in females not exposed 290 to adversity (intercept = 0.00003; standard error = 0.00001; p = 0.017).

291	Interestingly, the MR Egger intercept test suggested no horizontal pleiotropy in females
292	exposed to adversity (intercept = -0.000006 ; standard error = 0.00002 ; p = 0.766). Therefore,
293	two-sample MR analysis was used to inspect the potential causal association between FI and
294	impulsivity in females exposed to adversity. All MR methods resulted in a significant association
295	between the exposure FI and the outcome impulsivity in females exposed to adversity [IVW $p <$
296	0.001, IVW β = -0.028, IVW 95% CI: -0.032 to -0.023; Simple Median p $<$ 0.001, Simple
297	Median β = -0.035, Simple Median 95% CI: -0.042 to -0.029; Weighted Median p < 0.001,
298	Weighted Median β = -0.022, Weighted Median 95% CI: -0.029 to -0.015].
299	Discussion
300	This study aimed to investigate if FI had a moderating effect on the association between
301	ELA and altered EF in a sex-specific manner, and whether there was a causal relationship
302	between FI and altered EF according to adversity exposure.
303	Previous work from our lab showed that a mesocorticolimbic-specific expression based
304	PRS of insulin receptor (IR-ePRS) was associated with childhood impulsivity in males (Dass et
305	al, 2019). Based on these findings, we expected that insulin and impulsivity would share genetic
306	architecture. However, our study could not confirm this neither in males nor females. CondFDR
307	findings did not indicate a shared genetic architecture between FI and impulsivity, an EF
308	previously associated with the interaction between high FI levels and ELA in (Batra et al, 2021),
309	nor between FI and ADHD, a disorder in which impulsivity is a symptom (Kenemans et al,
310	2005). The lack of shared genetic architecture suggests there may be factor interacting with FI
311	(e.g. ELA) resulting in altered EF behaviors. These findings led us to investigate the interaction
312	between FI and ELA on EF behaviors, including a broad range of outcomes.

313 We demonstrated that the calculation of a rPRS, consisting of SNPs most highly 314 associated with peripheral insulin levels in children and representing the risk for high FI levels 315 early in life, can be derived from the GWAS of FI in adults (Batra et al, 2021). Insulin resistance 316 has been shown to be associated with childhood social relationship problems (Gangel et al, 317 2020), and these may also affect EF development, as observed in our results. Since conduct 318 problems often occur with ADHD (Faraone, 2000) and heritability has been established in 319 molecular genetic studies between both traits (Holmes et al, 2002), it made sense that we 320 observed a significant interaction effects on conduct problems and rule breaking behavior in 321 GUSTO females. While in MAVAN, GUSTO, and ABCD, attention and impulsivity traits were 322 being highlighted through this interaction effect using different measures, in the UKB, the 323 significant interaction effect was seen on psychiatric outcomes, such as addiction to alcohol in 324 males and depression in females. The significant outcomes in the UKB show a trend from 325 childhood to adulthood because impulsivity and attention related problems map to addiction 326 (Kreek et al, 2005) and depression (Granö et al, 2007) in adulthood. Additionally, internalizing 327 problems are significantly associated with symptoms of anxiety and depression (Pedersen *et al*, 328 2021), confirming results that we saw as early as adolescence in ABCD females.

Although none of these interaction effects were significant after adjusting for multiple testing, the trend is present throughout development in both males and females during childhood, as evident through MAVAN and GUSTO. However, is adolescence, this association becomes only significant in females in the ABCD cohort. This may be explained by males exhibiting higher insulin sensitivity at this age, serving as a metabolic corrector (Hoffman *et al*, 2000). When examined in adults, both analyses in males and females showed significant interaction between FI and ELA on psychiatric outcomes, thereby reaffirming the trend of insulin

functioning's association with cognitive functions (Ma *et al*, 2015) in childhood, which has been
shown in literature and in our studies.

The gene ontology enrichment analyses, done through MetaCoreTM, showed that the 338 339 SNPs composing the FI rPRS are associated with nervous system development. Some of the 340 enriched processes should be highlighted, such as dopamine D2 receptor transactivation in males 341 as the dopamine system has been linked to impulsive behavior in animal models and human 342 studies (Dalley and Roiser, 2012; van Gaalen et al, 2006). This finding suggests a potential 343 neurodevelopment pathway to support the relationship between the genetic background linked to 344 insulin, ELA, and dopamine. For example, in previous animal studies from our lab, rats who 345 have experienced ELA display displayed dopamine release in response to palatable food, an 346 effect which is reverted by insulin administration (Laureano et al, 2019). These findings 347 highlight that the relationship between ELA and dopamine is moderated by insulin. Further, 348 enrichment analyses in FUMA revealed that the genes, to which the SNPs composing the FI 349 rPRS map to, were significantly enriched for cognition and ADHD in both males and females for 350 several GWASs, , and for impulsivity in females. These findings align with our executive 351 function results from the interaction analysis.

MR is a powerful tool as it uses Mendel's law to assess the potential causal association between two traits through a naturally occurring randomized clinical trial (Kappelmann *et al*, 2021). In our study, MR showed significant associations between FI and impulsivity in females exposed to adversity. In all other cases, the Egger test and the MR-PRESSO test failed to significantly deny the presence of horizontal pleiotropy. In other words, there may be causal association between FI and impulsivity in those cases, but MR could not be used to determine its presence. These results are consistent with previous studies from our lab where ELA has

359 specifically affected female behavior. Barbieri et al (Barbieri et al, 2009a) showed that women 360 born with severe intrauterine growth (IUGR) displayed a preference for carbohydrates in 361 adulthood compared to those born with normal birth weight, without effects in men (Barbieri et 362 al, 2009a). IUGR has been associated with metabolic stress which can result in altered appetite 363 regulation. Appetite regulation involves the EF inhibition of impulsive behaviors (Gluck et al, 364 2017) explaining the results from Barbieri et al in the context of our study. A similar effect was 365 observed in another study performed by our lab, whereby IUGR girls demonstrated increased 366 impulsivity in the Snack delay task, while there were no effects of IUGR in boys (Silveira et al, 367 2012). Rodent studies done on the topic also demonstrate that ELA leads to learning impairments 368 in female rats, and prepubertal stress leads to compulsive behavior in female rats, an effect that is 369 not observed in males. (Brydges et al, 2015). Overall, we can conclude that there is a causal 370 association between insulin and impulsivity in the context of adversity in females. Additional 371 investigations are needed to exclude the possibility of this causal relationship existing in males.

372 Conclusion

In conclusion, our current findings offer evidence for how FI moderates the long-term effects of ELA on altered EF, specifically impulsivity and attention, in males and females throughout development. High FI also appears to be causally associated with increased impulsivity in females exposed to adversity. This study is impactful in highlighting the mechanisms by which insulin moderated the effects of ELA on EF disorders, and it provides insights into potential mitigating interventions.
