Abstract

27 Background

Solid organ transplantation is the optimal treatment for children and adolescents with end-stage organ failure. However, the biopsychosocial challenges faced jointly by the various types of solid organ recipients have received little attention from a multidimensional and qualitative approach in paediatric populations. This is the first study based on focus groups to identify the unmet care needs perceived by transplanted adolescents and parents throughout the pre-, peri-, and post-surgical phases of various types of solid organ transplantation.

34 Methods

35 Two focus groups were conducted with five adolescent transplant recipients and five parents, 36 respectively, at the Children's Hospital of La Paz University Hospital in Spain. The focus 37 groups followed a biopsychosocial theoretical framework and used a semi-structured 38 moderating guide. Participants were asked open-ended questions about aspects of healthcare 39 that they would have liked to change or improve, followed by specific questions about 40 biomedical, psychological, and social aspects that were not spontaneously addressed. The sessions were conducted using a video call, audio-recorded, and automatically transcribed. 41 42 Thematic framework analysis was used to examine the data, involving familiarisation, 43 identifying a thematic framework, indexing, charting, mapping, and interpretating.

44 **Results**

The findings revealed several unmet care needs, highlighting the importance of addressing social and psychological aspects of care throughout the transplantation process. Key issues common to both informant groups were inconveniences regarding the distance to the hospital and long waiting times for outpatient hospital visits, as well as the importance of peer support, humanised interaction with healthcare personnel, and mental health care during the whole process.

51 Conclusions

These findings will inform the design of future multifaceted prehabilitation interventions to prepare patients and parents for solid organ transplantation. This study highlights the importance of understanding the experiences and unmet needs of adolescent transplant recipients and their families in order to improve healthcare delivery and clinical outcomes.

60 Introduction

Solid organ transplantation is the best treatment option for most children and adolescents with end-stage organ failure [1]. Despite advancements in allograft survival rates in paediatric populations following solid organ transplant, to date, understanding the challenges faced by survivors, such as the impact on biopsychosocial outcomes, has received little attention [2].

By definition, children with end-stage organ failure experience life-threatening illnesses and potentially traumatising circumstances, such as major surgeries, admission to the intensive care unit (ICU), coping with various side effects, attending regular hospital appointments, and undergoing multiple invasive testing. In addition, they experience restricted social interactions with family and friends as well as missing school and other typical normative childhood activities. Consequently, all these factors inevitably affect the quality of life of patients undergoing solid organ transplantation and their families [3].

73 Mental Health Consultation-Liaison teams play key roles in these clinical populations, 74 such as assessing the suitability of living donor candidates; evaluating the recipient's understanding of the transplant process; assessing patients' mental state, functioning, and 75 76 quality of life; treating potential psychopathological comorbidities; and delivering 77 psychological interventions to patients and/or their relatives [4]. However, although 78 quantitative research has contributed to these advances in the clinical assessment and treatment 79 of organ transplant recipients, qualitative investigation is still scarce or is limited exclusively 80 to some type of organ in paediatric populations. In this sense, this study aimed to collect and 81 jointly analyse the subjective experiences of adolescent recipients and parents during the entire 82 process of various types of solid organ transplantation.

83 The Children's Hospital of La Paz University Hospital (Madrid) offers reference
84 healthcare to paediatric patients throughout Spain. In particular, La Paz is the only centre in

Spain that performs all types of paediatric transplants, and is a national reference centre for other complex pathologies. According to data from the National Transplant Organization (ONT, acronym in Spanish) in its annual report, La Paz is the Spanish centre that performed the highest number of paediatric transplants in Spain in 2022, making it a suitable context for collecting clinically relevant data in these paediatric populations [5].

90 To the best of our knowledge, this study is the first to qualitatively identify unmet care 91 needs, utilising focus groups, of paediatric patients and parents throughout the pre-, peri-, and 92 post-surgical phases of diverse solid organ transplants. This qualitative approach contributes 93 to the humanisation of scientific and care activities as it incorporates and integrates the 94 perspectives, preferences, values, and expectations of the recipients of the care process. In this 95 sense, this study follows a family-centred care model [6] and promotes a comprehensive and 96 holistic care process in which patients and their parents are represented, thereby humanising 97 health care by obtaining clinical demands directly from primary stakeholders.

We expect that these findings will provide essential novel information for the design of
future prehabilitation interventions for paediatric transplants (i.e. to prepare the patient to be in
the best possible state before surgery).

102 Materials and Methods

103 Study Design

The focus group method was selected because of its group dynamics, which can generate rich data, particularly in situations where prior knowledge is limited [7]. Focus groups and semi-structured interviews are widely recognised as the primary methods used in qualitative research [8]. Non-quantitative methods have been increasingly used by paediatric psychologists and other researchers to improve the understanding of the scientific community and provide new perspectives in healthcare [9]. These methods examine how children and their

110 families experience and respond to health-related challenges, allowing researchers to better111 understand the phenomenon under study [10].

To ensure the accuracy and transparency of the reporting of this qualitative study, we closely followed the COnsolidated criteria for REporting Qualitative research (COREQ). This involved a 32-item checklist developed specifically for reporting research related to interviews and focus groups [8].

117 *Sample*

118 Focus group participants were recruited by the Mental Health Consultation-Liaison 119 team of the Children's Hospital of La Paz University Hospital (Madrid, Spain), which 120 approached eligible candidates. Suitable candidates for the patient group were adolescents 121 between the ages of 12-18 who had already undergone solid organ transplantation and were 122 able to speak Spanish fluently. To enrich the content of the focus group and ensure greater 123 diversity of experiences, participants who had undergone transplantation of different solid 124 organs were selected deliberately. The patient group consisted of adolescents aged between 13 125 and 18 years (mean = 15.6; SD = 1.95 years) who had undergone transplantation, on average, 126 13.4 months ago (SD = 6.54; range: 6–24 months).

As in the adolescent group, parents of children who had received different solid organ 127 128 transplants were prioritised in the parents' group. The parents chosen were not the parents of 129 the adolescents in the focus group to broaden the spectrum of experiences and perspectives. 130 However, an exception was made for one adolescent who received a lung transplant due to the 131 much smaller sample size of this type of transplant, thus allowing for the joint participation of 132 the mother and child. The second group consisted of parents of patients aged between 8 and 15 133 years (mean = 11.6; SD = 3.05 years) who had undergone transplantation, on average, 14.6 134 months ago (SD = 5.46; range: 10 to 24 months).

In the adolescent group, we included more than one participant who had received a kidney transplant, and in the parent group, we included more than one parent of a heart transplant recipient, as we considered these types of transplants to be the most representative. The characteristics of the participants are listed in Table 1.

142 **Procedure**

The parents of each enlisted participant (or, when applicable, patients of legal age) were contacted by telephone by one of the team researchers to ensure that the participant met the criteria and to explain how the group would be conducted. All the contacted participants wished to participate in the study. Parents of patients (or, when applicable, patients of legal age) who provided written informed consent were scheduled to participate in this study. One person did

not show up to the adolescent group and was contacted later for an individual in-depthinterview following the same format and conditions.

The patients' parents were asked to authorise, in an informed manner, the participation of their children and themselves (when required) in focus group sessions to qualitatively identify unmet care needs during the pre-, peri-, and post-transplant phases. Two group sessions were conducted (one session per participant type: patients and parents), lasting approximately 90 min each, arriving at data saturation (meaning that no new value information was obtained). The groups comprised five participants each (n = 10 in total).

156 The interview guide used in both focus groups followed a biopsychosocial theoretical 157 framework. Specifically, each focus began indicating group group norms 158 (confidentiality/privacy, not interrupting others' turn to speak, and not judging others' 159 comments). Afterwards, the session continued with a first part of open questions about what 160 aspects participants would have changed or improved in health care, both for the patients and 161 parents, during the entire transplantation process. Subsequently, the second part of the focus 162 group posed specific questions about the biomedical, psychological, and social aspects that 163 would have improved throughout the transplantation process and were not spontaneously 164 addressed in the first part of each focus group. The facilitator followed a semi-structured 165 moderating guide, and the questions posed are listed in Table 2.

168 *Directed questions were asked only when participants did not spontaneously address specific aspects of one of
169 the three areas of the biopsychosocial model.

170

171 The sessions were conducted by videocall, audio-recorded, and automatically 172 transcribed, respecting the confidentiality of the information at all times. The sessions were

173 facilitated by a member of the research team and not by the PI of this project (EFJ) to avoid 174 bias (the PI knows most of the patients and parents). The facilitator was a female psychologist with a Master's degree. However, the facilitator was introduced as a researcher and not as a 175 176 psychologist, so as not to bias participants in prioritising mental health aspects to the detriment 177 of biomedical and social domains. In addition, this facilitator worked mainly on another PI's 178 scientific project, focused on a different paediatric clinical population, and did not have any 179 relationship with the participants prior to study commencement, nor did they know of her 180 previously. Furthermore, this facilitator did not participate in any of the subsequent stages of 181 this project: transcription generation, data analysis, data interpretation, writing or reviewing 182 this paper.

Subsequently, the automatically generated transcriptions were reviewed to (1) change the name of the participants using a code and (2) correct any transcription mistakes. The recordings were maintained until it was verified that the transcription process had been performed correctly. The transcripts were not returned to participants for their comments. When needed, in anticipation that more relevant information would be collected, participants were offered the possibility of conducting individual in-depth interviews after the focus group. Interviews were conducted using the same standards mentioned above.

191 The study protocol was registered at clinicaltrials.gov on 1 July 2022 (NCT05441436) [11].

192 Recruitment for this study began on October 21, 2022 and ended on February 8, 2024.

194 *Ethical Considerations*

This study was conducted in accordance with the principles established in the Helsinki declaration, strictly respecting confidentiality and the requirements of Spanish (14/2007, 3 July 2007 on Biomedical Research; and Organic Law 3/2018, 5 December 2018) and European data

protection regulations. This study was approved by the Research Ethics Committee of La Paz
University Hospital (Madrid, Spain) (institutional code: PI-5223). Parents or legal guardians
of patients (or, when applicable, patients of legal age) provided their written informed consent,
for minor patients and for themselves, to participate in this study.

203 Data Analysis

Two coders (JGB and EFJ) independently analysed the data following the steps of the "qualitative framework analysis" [8]. The first step was familiarisation, which involved reading all the transcripts thoroughly, listening to the tapes, and listing key ideas/recurrent themes to identify a thematic framework (immersion in data). A coding frame was developed based on these key themes. This involved entering brief summaries into the coding frame, along with the page numbers of the original data excerpts, facilitating easy retrieval for further analysis.

Subsequently, a biopsychosocial model was systematically applied to all the data (indexing), and the data were rearranged according to the relevant sections of the thematic framework (charting). Charting was performed using columns (participants) and rows (themes). The coders had a meeting with a third researcher with experience in framework analysis (RV) to resolve any coding disagreements. Finally, concepts were defined, and data were interpreted by comparing and contrasting respondents' accounts and searching for explanations of patterns observed in the data (mapping and interpretation) [9].

218 Results

In this section, we present participants' experiences regarding solid organ transplantation and biopsychological factors resulting from the analysis of the transcripts.

227	Biomedical Factors
228	Perception of long hospital admission. Most patients felt that their hospital stay was
229	excessively prolonged. One individual mentioned that it became particularly burdensome once
230	she experienced clinical improvement.
231	"I felt it was overwhelming to be hospitalized for a very long time".
232	"When I started to get better, I got tired of being there [hospital ward] because I was
233	there for a long time".
234	
235	Impact of clinical diagnosis. One adolescent requiring a kidney transplant, described
236	the impact of suddenly and unexpectedly receiving the diagnosis of a chronic renal condition.
237	"Before the transplant, I was diagnosed with renal failure from one day to the next, and
238	I had no symptoms or anything So, I was very shocked by that."
239	
240	Access to medication. Certain individuals mentioned that access to medication could
241	be problematic, as it was intermittently unavailable at local pharmacies.

242	"Sometimes health professionals had trouble getting me certain medications because
243	they were either out of stock or temporarily discontinued".
244	
245	Symptoms. The most common symptoms were fatigue, sickness, and concentration
246	difficulties.
247	"I felt very weak and tired at the hospital and at home, I didn't want to get out of bed
248	I felt a lot of stress".
249	"My immune system was very low and it made it [studying] more difficult (). I could
250	not concentrate, grasp the information well, understand what the teachers were saying".
251	
252	Psychological and Emotional Factors
253	Anxiety. Most participants reported feeling anxious as their predominant emotional
254	state. One adolescent who became a kidney recipient, reported frequent panic attacks following
255	renal graft rejection.
256	"To be honest, I experienced a lot of anxiety after the transplant, especially at the
257	hospital".
258	"I wish the transplant had gone better I had a lot of panic attacks in the ICU because
259	of my rejection."
260	
261	Mental health care. Adolescents rated contact with a mental health professional
262	(clinical psychologist/psychiatrist) as a positive intervention. One adolescent who received a
263	lung transplant, noted that he benefited from psychological assistance to cope with medical
264	tests that caused him anticipatory anxiety.

265 "I value psychologists the most. Before my transplant, I was anxious and stressed. The 266 psychologists helped calm my nerves during that time, because just thinking about the 267 transplant procedure made me anxious."

Another adolescent who underwent a liver transplant, commented: *"The psychologists had to intervene because I was clearly reluctant to undergo the lumbar puncture"*.

270

271 Social Factors

Distance to the hospital. Adolescents who had to travel between cities for medical attention reported some inconveniences, such as transportation and being far from their loved ones.

275 "Transport to medical appointments, that's the only problem (...) the type of vehicle
276 [ambulance] was uncomfortable ...".

277 "Personally, I strongly would have preferred being in my homeland [region of Spain],

278 I missed having friends visit [during hospital admission] because I was in Madrid."

279

Hospital Staff. Satisfaction with humanised interaction. Overall, there was widespread satisfaction with the interpersonal care provided by the hospital staff among the participants, which significantly eased their hospital visits and admissions.

283 "All the efforts made by the nurses, doctors, and orderlies to create a positive 284 experience for us despite the challenges (...). Their efforts ultimately gave me hope for life after 285 the transplant and, at the same time, made my time there a little brighter."

286 Only one adolescent held a more critical view of this matter.

287 "I think I would improve the interaction from the nurses or assistants (...). Sometimes,
288 they would come in with a bit of a bad mood or something like that. That's the only thing I
289 would change."

Hospitalisation ward. One adolescent who was a kidney recipient, expressed discontent with the formal aspects of the hospitalisation ward, particularly the distribution of patients in the rooms.

293 "In other surgeries, such as the catheter dialysis (...) I was in a shared room with a 294 two-month-old baby. Therefore, the truth is that I had a very, very bad time (...). I told my 295 doctors "I want to leave now because I cannot stay here any longer". Because imagine, a two-296 month-old baby girl who would not stop crying all night long."

297

298 **Outpatient care.** Adolescents expressed complaints about their waiting times.

299 "I had to wait for two or three hours for some appointments (...). When I had to go

there every three months, I was like – I do not want to go because I am going to be there for
hours...."

302

303 Limited social interaction. All the adolescents agreed that this was one of the biggest304 challenges.

305 "When I was on dialysis, I had very limited freedom. Travelling, for instance, was quite 306 challenging because of the machine and logistical issues involved. It restricted me during a 307 time when my friends were enjoying more independence and going out at 16-17 years old. This 308 was particularly tough for me."

309

Academic Challenges. All adolescents, particularly those in their final years of high
 school, expressed the negative impact of transplant on their academic performance.

312 "Truth be told, I had a really tough time because I missed a lot more school than usual 313 (four and a half months), and I was really stressed out because I was at risk of repeating a 314 year, which isn't ideal during high school...".

315 "When you return to high school after a transplant, it can be in the middle of the

316 academic year... it can be disorienting because your classmates are further ahead than you".

- 317 Many expressed frustration and despair over losing valuable school time due to the long waiting
- 318 hours for outpatient hospital appointments.
- 319 *"The truth is that I was in my first year of high school and waiting two or three hours*320 *for medical check-ups wasted a lot of my time".*
- 321 One adolescent expressed dissatisfaction with the lack of curricular adaptation.

322 "When I arrived, I had missed most of the first term, and unfortunately, the teachers 323 didn't offer much assistance. They immediately gave me exams without allowing me time to 324 catch up, which caused me to struggle. Now, I find it challenging to keep up with the others."

Finally, some adolescents expressed limitations in receiving educational support either at home or at the hospital, indicating that their assistance was insufficient. One adolescent, who was entitled to the Home Education Support Service, reported not having benefited from this service at all.

329 "They told me that since I was in my final school year I could request home education 330 for when I had to stay home in isolation, to help me keep up and not fall behind. However, the 331 teacher never showed up (...). It really frustrated me, as it has been very noticeable, especially 332 in mathematics which is a subject where a lot of progress is made".

333 *"When I was in the hospital, there were two teachers who came to help (...), but I could* 334 *see that they didn't have enough time because there were too many children, too many* 335 *people...".*

Parent Focus Group

341 Biomedical Factors

342 Medical care/attention. Overall, most parents expressed a high level of satisfaction
343 and gratitude for their children's medical follow-up and care throughout the transplantation
344 process.

345 *"We are very happy and grateful with the medical attention our child received. The*346 *truth is that the doctors were always excellent."*

347 "It seemed very human to us that when our son was undergoing the operation, the 348 surgeons came out to explain what was happening. You are waiting there for many hours, and 349 the fact that they came out to provide us with updates... It seemed to us that we always received 350 information; they always asked you how you were doing and so on...."

351 However, one parent reported a subjective experience in which, on some occasions, medical352 attention seemed excessive.

353 "There are times when you get overwhelmed by all the medical attention. When you 354 think about it rationally, you realise it is good that they are so thorough in attending to him 355 and monitoring his condition. They want to ensure that everything is under control, and that 356 they are doing well. It's just that we spend all day at the hospital, and at first glance, it can feel 357 excessive."

One woman expressed dissatisfaction with the medical attention she received after donating akidney to her son.

360 "In my particular case, I was the donor, and naturally, all the attention was focused on 361 the child, not the parent. However, I had also undergone surgery... In some way, I felt 362 neglected, receiving minimal attention as an adult. This lack of care was concerning, setting 363 aside a more emotional aspect, I could have experienced a medical complication."

365 <u>Psychological and Emotional Factors</u>

366 **Experiences, attitudes, beliefs, and expectations.** Parents shared their experiences 367 and thoughts when undergoing their children's transplantation process.

368 "There were good days and bad days, but I've been very nervous and upset. I did not 369 know what was going to happen, and everything could change in five minutes (...). The worst 370 time for me was the month after the transplant when my daughter was admitted to the ICU. I 371 only noticed the shortcomings of nurses, assistants, and doctors. I just wanted everyone to be 372 with my daughter. I did not want to accept that it was my daughter's body that was sick; instead, 373 I tended to blame others. Now that I am out of that rollercoaster, I look back and can 374 understand it was very difficult, very complicated, and can see that everyone did their best. I 375 am very grateful now and I have come to realise it was my nerves, the tension, the fear...."

376 "I felt a lot of fear, I wanted someone to tell me exactly what a heart transplant was 377 like, what could happen... As time went on and I met more families, I came to understand that 378 the anxiety I had about knowing what would happen couldn't be eased by another parent. I 379 realised that my daughter's transplant would be unique to her. They might have performed fifty 380 transplants before, but I understood that when they transplanted her, she would face her own 381 set of complications, just as other children would face theirs."

382

Wishes and desires. We asked parents if there was anything they wished they could have had or felt they missed during their child's transplant process. One parent expressed that they missed the opportunity to convey gratitude to their son's donor.

386 "There is one part that has always stayed with me, like a thorn in my side. I think it may 387 be dictated by protocols that it cannot be done, but I always feel a debt of gratitude to the 388 donors. It's like you receive the donation, and have not been able to thank them for anything. 389 It is something that makes me feel like I have a debt I cannot repay. I imagine that it probably

390 cannot be done, and so on. But emotionally, if there is one thing I still need to do, it is to thank
391 the donor."

392

393 Mental health care. Parents discussed which stages of the transplant process they 394 believed psychological support was most useful or necessary for their children. Several parents 395 noted that their children began expressing sudden concerns about death in the period leading 396 up to transplantation.

397 "When the idea of the transplant was introduced, she did need psychological treatment.
398 The treatment was not very, very demanding, but we did notice that from then on, she needed
399 it, as she had changed a little bit. She started to be quieter, she started to think more... Anyway,
400 she started asking us things about death... Now, we still go to the psychologist, but she is doing
401 very well."

402 "In the months before the transplant, I noticed my son was very worried about death
403 and related issues. I do not know if it's a normal concern or not at that age, but I think
404 psychological care beforehand could have helped."

405 Another fundamental aspect discussed was the necessity of providing psychological 406 support not only for the child undergoing the transplant but also for other family members, 407 such as siblings, who also experience distress during this period and may feel overlooked.

408 "My eldest daughter had a very bad time and kept quiet about it. I think siblings are 409 also victims in a way, and we only realise this later when everything calms down. When the 410 calm comes after the tsunami, then you start to notice the other little people around you, 411 reminding you that they exist and that the situation has also affected them (...). Psychological 412 care is provided to the parents, but in my case, the siblings are somewhat left in no man's land 413 (...). They are left alone at home with their grandparents or other family members and are 414 often overlooked as the days go by."

415 Social Factors

416	Distance to the hospital. Parents expressed the burden of not being able to receive
417	medical attention in their own city, which forced them to commute to the city where the hospital
418	is located. This situation disrupted their normal lives and resulted in significant economic loss.
419	"Since we are from far away [a Spanish region far from the city where the hospital is
420	located], we had to move and stay in Madrid for the whole time we were in the hospital and
421	for the post-transplant period, as you have to go up to four times a week or several times a day
422	to the hospital. These trips to Madrid have a cost and they do not allow you to make up with
423	overtime at work."
424	"If you live near [the hospital] that's fine, you have it easier, but those who do not live
425	near, have to spend a lot of money on travel, for example, on lodging and that, in the end, og
426	course, is a stress, because you say gee Can I do it? Can I afford it? I think that's a big
427	problem."
428	Finally, some expressed how difficult it was to be far from their loved ones and unable to leave
429	the city while their daughter was on the waitlist for heart transplants.
430	"We were on the waitlist for three years. We have lived in Madrid for nine years since
431	my daughter was born, but our family is in Granada [a region of Spain]. It was a tough three
432	years because we could not leave Madrid."
433	
434	Need of creating a peer/family support network. Parents agreed that it would have
435	been beneficial for them and their children if the hospital had offered a peer/family support
436	network, allowing them to meet other children and families in similar situations.
427	

437 "It would be good for the children, especially in a medical specialty such as lung
438 transplantation, which is not very common as there are few cases and few children who have
439 gone through this process and are alive; to be able to do some kind of activity for them to

interact more, get to know each other, share their experiences. Because in my son's case, he is
now entering adolescence and just two weeks ago, he met another boy who had also received
a lung transplant, and for him, it was something cool – he has gone through the same thing as
me – he said. They need to share that information, they need to hear the opinion of someone
else who went through the same process."

- 445 *"Those three years [waiting for her daughter's heart transplant] I would have liked to*446 *have met more parents in the same situation".*
- 447

448 Caregiver leave at the workplace. One parent, although grateful for the flexibility449 offered at work, wished they had known what the law states about time off in such situations.

450 "At work, they told me to take as many days off as necessary, but I thought maybe in
451 other places there are more limited days of time off, or there is an established protocol...
452 Because especially after the transplant you have to be at the hospital for a long time and I think

453 *it is more than the legal time allowed".*

454

455 **Outpatient care.** Some parents expressed complaints about waiting times.

456 "I don't know what the hospital protocol is like or anything, but you arrive with a child 457 who has been very ill and still is, and you have to wait three hours for an appointment... I do 458 not understand why they do not give them a card or something to help respect the appointment 459 times. If they had to wait forty minutes, okay, but what is not acceptable is three or four hours. 460 And if you have another appointment that day, it means that for two consultations, you could 461 be losing up to five or six hours."

462 Concerns were also voiced about remaining in a crowded waiting room with an ill child who463 was exposed to many other children for extended periods.

464 "When you're in a waiting room with forty other people and you have to stay there for 465 three or four hours, you are putting your daughter at risk of catching anything. They are 466 children who have been transplanted and well, my daughter was also weak before she was 467 transplanted, so, I think that should be improved."

468

469 Balancing/conciliating hospital visits with work and family responsibilities. This
470 aspect was a shared concern among the participants of the group.

471 "There is significant stress for us as parents trying to be in two places at once – work
472 and the hospital. The challenge is even harder if you have more children. We need to make a
473 living but it's hard to balance the fact that you have to dedicate yourself to your son who is in
474 post-operative care, at the same time that you are leaving work and family behind."

475 "In my case, we spent six months in hospital, from the time she was transplanted until
476 she came home. A long time passed and my other children felt in some way abandoned. – Where
477 are my parents? – they must have thought. And of course, you get home, and you need to sleep
478 because you are knackered, and all you really want to do is go back to the hospital because my
479 only obsession was to be in the hospital. My eldest daughter had a bad time because, of course,
480 I could not look after her, my husband could not look after her...We spent most of our time at
481 the hospital."

482

Bureaucratic challenges. There was widespread discontent with how time-consuming
and inefficient bureaucracy can be, especially when you have a child who is ill and needs full
attention.

486 "Paperwork is very slow and time-consuming in general, and even more so for those of
487 us who are parents of children who are ill and need all our time, they need us to be with them

488 100%. We do not have time to be doing all these procedures and going from one place to the
489 other because the children need 100% of the parents' care."

490 "You have to navigate through a lot of bureaucracy. For instance, with my daughter, 491 they approved her dependency status because before her operation, she had only half a heart 492 and needed oxygen. However, it took two and a half years to get that approval. Another 493 frustrating issue is how they assess her disability level; it can change if her condition improves 494 or after surgery, and then you are back to fighting bureaucracy again, all while caring for a 495 sick child at home. It is unpredictable—today they grant you assistance, but tomorrow they 496 might revoke it. For instance, after a successful transplant, she might need a tracheotomy, so 497 the situation keeps changing, and you cannot constantly update the administration about the 498 evolving circumstances."

499

Laws, rights aid, and the information received regarding them. Some parents were disappointed to discover very late, or not at all, certain laws that could have provided crucial support during their child's transplant.

503 "Nobody informed us that there was a law that covered parents with children with 504 serious illnesses and allowed you to reduce your working hours as from 50% up until 100% 505 (...). I found out very late that I could have dedicated myself exclusively to the care of my son 506 and still receive my full salary."

507 They also missed having a reference figure to whom they could direct their questions about508 laws and available social aid.

509 "I missed having a specific figure to inform us about all the regulations, laws, aid, and 510 procedures necessary when you have a child with special needs and requires special attention. 511 There are likely many laws or regulations, whether at the State or community level, that I am 512 unaware of and may only learn about in the future. I miss having a unified figure to guide us.

513 Today, I feel we are excluded from all the help offered by the Country and the community 514 because we simply do not know about it. There is no one to inform us."

515 One woman described feeling misinformed and struggling to understand the processes because

516 she was an immigrant and unfamiliar with many laws and regulations.

517 "I don't know the policies, I don't know the Country's system... I do not know how to get

519 years now, and I do not see that there is an organisation offering help to a parent who does

an appointment to be informed... It has been very hard for me. I have been doing this for three

520 not know or is not from this country. I do not have the degree of Dependency...I have knocked

521 on the doors of the social workers and I have not managed anything."

522 A woman expressed disappointment that psychological support provided by national insurance 523 is not available in her homeland for children who have undergone transplants.

524 "Here in Gran Canaria, psychological support for a transplanted child isn't considered 525 necessary, so we had to pay for private consultations. Unlike getting a prescription for 526 medication, psychological treatment takes time, and sometimes the financial burden is too 527 much to bear. We were told by the national insurance that unless there is something like 528 Attention-Deficit/Hyperactivity Disorder (ADHD), or a condition of the autistic spectrum or a 529 dysfunctional family, that my son was not eligible for psychological therapy."

530

531 **Parents' advocacy for transplanted children to be recognised as a collective.**

532 "My son faces both nephrological and visual challenges. The main issue is that 533 transplanted children are not recognised as a distinct group. For instance, my son receives 534 comprehensive support for his visual impairment from the Department of Education, including 535 a social worker, teachers, and adapted materials, because individuals with visual impairments 536 are recognised as a group. In contrast, transplanted children do not receive similar support— 537 there are no counsellors or social workers available to us. For my son's visual impairment, we

have regular visits, phone calls, appointments, and guidance on aids. However, for his transplant-related needs, there is minimal support and recognition. It is crucial for transplanted children to be acknowledged as a distinct collective group, similar to how other groups such as those with visual impairments or mobility issues are recognised and supported."

544 **Discussion**

545 To the best of our knowledge, this is the first study to qualitatively examine the 546 perceived unmet needs throughout the paediatric organ transplantation process, comparing the 547 subjective perspectives of both adolescent patients and parents regarding several 548 biopsychosocial domains and jointly covering various types of solid organ transplants. This 549 work revealed significant insights into the experiences and perceptions of adolescents and 550 parents concerning medical care, social dynamics, and psychological challenges associated 551 with undergoing a solid organ transplant. We now discuss the findings identified as most 552 relevant from both focus groups and compare these results with the existing body of literature. 553 Furthermore, we conducted a comparative analysis of topics that emerged across the two focus 554 groups.

555 On one hand, a significant finding was the disparity between the focus of parents and 556 teenagers on academic concerns. In particular, parents tended not to mention academics, 557 whereas adolescents frequently expressed overwhelming anxiety regarding their academic 558 performance, which was exacerbated by a perceived lack of educational support and 559 adaptations. Additionally, existing literature suggests that adolescent transplant recipients may 560 exhibit cognitive and neuropsychological impairments [12,13], which may contribute to the 561 aforementioned perceived problems. This underscores the need for more robust academic 562 support systems tailored to adolescents' unique circumstances [14].

563 On the other hand, key issues that emerged for both informants were inconveniences 564 regarding the distance to the hospital, long waiting times for outpatient hospital visits, the need 565 for peer support, satisfaction with the humanised care provided by healthcare workers, and the 566 relevance of mental health support during the transplant process.

567 In particular, the experience of Adolescent 5 underscores a common challenge faced by 568 patients who must travel to another city for transplant procedures because they reside in other 569 regions. In this sense, La Paz University Hospital is a national reference hospital in Spain and 570 is the only hospital to date that performs all paediatric transplants. The logistical complexities 571 of long-distance travel, often via ambulances or planes, add a layer of stress to the already 572 taxing situation. Moreover, distance to the hospital imposes an economic burden on families, 573 who must cover the costs of lodging and related expenses. Being far from loved ones during 574 difficult times can also be emotionally distressing. Peretz et al. [15] examined the psychological 575 and financial challenges associated with long-distance travel for liver transplantation. While 576 patients generally remain confident in their healthcare providers and do not feel that their care 577 is compromised by distance, many, particularly women, expressed dissatisfaction with the 578 limited opportunities to support visits. Additionally, the economic burden of being far from 579 home likely contributed to 70% of patients preferring to undergo the procedure locally. These 580 factors suggest a need for more localised transplant services or improved support for travel and 581 lodging logistics to reduce the burden on patients and their families.

In addition, extended outpatient waiting times were generally poorly tolerated, and prolonged hospital stays were particularly challenging for the adolescent group. This highlights an area that requires urgent improvement to enhance patient and caregiver satisfaction, as previously noted in the literature on paediatric outpatient care [16].

586 Furthermore, both parents and adolescents identified social issues as their predominant 587 concern over biomedical and psychological issues. This finding is consistent with the current

research, which shows that patients and families face enduring psychosocial risks long after the initial post-transplant phase [17]. Consequently, it is essential to make social support a central component of interventions to address the well-being of patients and their families effectively.

592 Among the topics that emerged at a social level, participants conveyed that they would 593 have greatly valued the opportunity to engage in peer and family support groups. In particular, 594 the adolescent group in this study expressed being particularly affected by periods of limited 595 social interaction due to hospital admissions and necessary isolation protocols. Social isolation 596 can be distressing, emphasising the importance of creating robust communication channels and 597 support systems to mitigate the impact of isolation on patients' mental health [18]. This is 598 consistent with the work of Anthony et al. [19], who emphasised the significant benefits that 599 adolescents gain from peer support programs, reporting the satisfaction perceived among 600 participants in an online mentorship program designed for paediatric transplant patients. Such 601 peer groups provide critical emotional support and a sense of community, which can 602 significantly improve the coping mechanisms of both patients and their families.

603 Furthermore, one of the notable social-level suggestions highlighted by participants in 604 the parent group was the potential benefit of having a unified reference figure from Social 605 Work to assist with bureaucratic procedures systematically rather than reactively. This would 606 alleviate the administrative burden on families, allowing them to focus on emotional and 607 psychological aspects of care. There was a strong desire for a dedicated reference person who 608 could provide expert guidance on complex laws and regulations related to medical care, 609 economic aid, and work-leave entitlements. For instance, in Spain, Compensation for Leave to 610 Care for Children with Cancer or Serious Illnesses (CUME, acronym in Spanish) [20] allows 611 working parents to take leave to care for children undergoing serious medical treatment, with 612 financial support provided during their absence. However, one parent noted that they only

613 learned about this social aid during the focus group discussion of this project and wished that614 they had been informed earlier.

615 The difficulty of balancing family responsibilities with work commitments has also 616 been highlighted as a significant challenge. This difficulty aligns with the existing literature, 617 which categorises the challenges faced by parents of children with chronic illnesses into three 618 domains: work, family, and personal. Workplace challenges commonly include securing 619 flexible work arrangements, managing absenteeism, and encountering unsupportive employer 620 attitudes. Family-related issues involve finding suitable childcare facilities, managing time 621 constraints, supporting ill children, and fulfilling overall family duties. On a personal level, 622 parents frequently experience stress, uncertainty about the future, and the feeling of "having to 623 do it all" [21]. This calls for more flexible support systems to assist families in effectively 624 managing their dual responsibilities.

Additionally, addressing the needs of siblings was another critical point. Existing literature indicates that siblings of children with chronic conditions face unique challenges that affect their health-related quality of life, including negative emotions, separation anxiety, increased responsibilities, and feelings of exclusion [22]. Feelings of abandonment among siblings must be mitigated by including them in the entire care process and offering psychological support, as necessary. This holistic approach ensures that the emotional needs of the family are met, thereby promoting a more cohesive support system.

It is possible that all of these perceived needs could be partially addressed by the suggestions made by one of the parents during the focus group. They proposed that children undergoing transplantation should be legally categorised as a distinct group regarding disability recognition. This recognition would streamline access to the necessary support services for these children and ensure that parents receive accurate and timely information.

637 Finally, humanised interaction by healthcare personnel was highly valued by both 638 patients and parents, underscoring the importance of empathy and compassion in medical care 639 [23]. Additionally, both groups agreed that mental health support was beneficial throughout 640 the transplantation process. In particular, this study highlights the pressing need to address 641 thoughts of death and the associated psychological impact among these patients. Consequently, 642 it is imperative to improve mental health interventions to provide comprehensive support. 643 Accordingly, the mental health profiles of diverse paediatric organ transplant recipients are 644 being increasingly investigated to ensure the provision of holistic care for these clinical 645 populations [2,11,24].

647 Strengths and Limitations

648 Regarding the limitations of this study, it included a modest sample size from a single 649 hospital. Nevertheless, the participants were selected purposively to encompass a 650 representative view of the diverse potential circumstances surrounding the paediatric transplant 651 process in accordance with sociodemographic and clinical criteria (organ type, sex, and 652 socioeconomic status). Furthermore, despite the potential for conformity processes among 653 participants in the focus group methodology, members in both groups conducted for this study 654 expressed divergent perspectives and nuanced opinions, demonstrating their willingness to 655 articulate discrepancies with other participants.

657 Conclusions

In conclusion, despite these limitations, this study suggests several key areas for improvement in the care and support of adolescent transplant patients and their families. Enhancing academic support, reducing outpatient waiting times, the humanised interaction by healthcare personnel, providing mental health and comprehensive family support are critical

662	steps towards improving the overall care experience and represent key areas for future research.
663	Additionally, the establishment of a unified Social Work figure to assist bureaucratic processes
664	is also considered essential in addressing the multifaceted needs of these patients and their
665	families. These findings will inform the design of future multifaceted prehabilitation
666	interventions for the entire paediatric transplant process.
