

25 Aedes-borne viruses, chikungunya showed the highest prevalence (10%; 95% CI: 4–24%; 26 I²=99%), followed by dengue (6%; 95% CI: 3–11%; I²=98%) and YF (5%; 95% CI: 2–11%; 27 I²=97%), with the highest prevalence in Busia and Kwale. West Nile virus prevalence in 28 humans was also estimated at 9% (95% CI:  $5-14\%$ ;  $I^2=93\%$ ). Overall, the Coast, Western, 29 and Rift Valley regions were the most affected. Multiple arboviruses have historically 30 circulated Kenya, and with the increasing pressures of climate change, urbanization, and 31 global connectivity, the risk of outbreaks, particularly from Aedes-borne viruses, is 32 escalating. Proactive, sustained surveillance as well as integrated public health strategies 33 through a One Health lens are needed to mitigate these threats and protect vulnerable 34 populations.

### 36 **Author Summary**

37 Infections like Rift Valley fever, dengue, chikungunya, yellow fever, and West Nile virus are 38 major neglected tropical diseases that pose significant public health threats both in Kenya and 39 globally. Given the conducive conditions in Kenya and the absence of a comprehensive 40 routine surveillance system, many areas remain under-monitored, increasing the risk of 41 undetected transmission and delayed responses, which leaves vulnerable populations at 42 greater risk. It is therefore imperative to conduct a thorough assessment of baseline 43 prevalence for these diseases through a systematic review and meta-analysis that consolidates 44 and analyses existing evidence for improved public health planning. Our study provides a 45 detailed review of historical IgG prevalence data for 14 of these diseases in Kenya, 46 illustrating their long-standing circulation in human, livestock, and wildlife populations, as 47 well as the heightened risk of outbreaks driven by climate change and urbanization. We 48 emphasize the urgent need for ongoing surveillance and integrated public health strategies

49 tailored to Kenya's unique context, such as those supported by the GAI initiative, to 50 effectively protect vulnerable populations from future outbreaks, nationally and regionally.

#### 52 **Introduction**

53 Vector-borne diseases constitute *approximately* 17% of the estimated global burden of 54 infectious diseases and cause >700,000 deaths annually (1,2). Arthropod-borne viruses 55 (arboviruses) contribute substantially to this burden, with dengue virus (DENV) alone 56 responsible for >6.5 million human infections and >7300 deaths in 2023 (3). With severe 57 associated complications like dengue shock syndrome and long-term chikungunya disability, 58 potential epidemiological shifts due to changes in climate and vector distribution, in addition 59 to urbanisation, there is an urgent need for increased arboviral research and management 60 (2,4–7). In response, WHO launched the Global Arbovirus Initiative (GAI) to build a 61 coalition of countries and strategic multisectoral partners, to improve surveillance, 62 prevention, and control through an integrated and coordinated approach for maximum impact 63 in high-burden and at-risk areas (8,9). The GAI's first pillar, *'monitor risk and anticipate*' 64 emphasizes developing a robust surveillance system that integrates current and historical data 65 to establish baselines, and mapping risks to identify vulnerable areas. Studies on IgG exposure 66 support these priority actions by contributing to establishing local historical baselines and 67 improving data quality to identify areas at risk, allocate resources efficiently, and formulate 68 innovative targeted mitigation strategies (9).

69 In Kenya, like many tropical countries, human and animal populations are vulnerable to 70 arboviruses owing to the optimal climate that supports a wide range of vector species able to 71 transmit arboviruses (10). Several arboviruses, both well-established and emerging, including 72 DENV, chikungunya (CHIKV), West Nile (WNV), Rift Valley fever (RVFV), Ngari (NV)

73 and yellow fever (YFV) have been documented in the country (10–13)**.** Furthermore, Kenya's 74 proximity to countries reporting recurring arboviral outbreaks like Uganda, Sudan, Tanzania, 75 and Somalia may exacerbate the risk of arboviral importation into the country through 76 transboundary movements (14,15)Despite these irrefutable risks, Kenya lacks a 77 comprehensive routine surveillance system to actively monitor arboviral activity across the 78 country for timely intervention (15,16)**.** Existing surveillance efforts in Kenya are reactive, 79 intensifying once outbreaks are underway or through interepidemic investigations, often 80 focusing on high-profile arboviruses and identified hotspots (17)**.** Consequently, large parts of 81 the country may be under-monitored, increasing the potential for undetected transmission and 82 delayed responses, leaving vulnerable populations at greater risk. Considering the healthcare 83 burden they and other vector-borne diseases exert, alongside their impoverishing 84 socioeconomic ramifications (18,19), the urgency for a thorough assessment of their baseline 85 prevalences in the country per WHO-GAIV goals cannot be overemphasised. Here, we report 86 the findings of a systematic review and meta-analysis of IgG seroprevalence in humans, 87 livestock, and wildlife, consolidating and analysing existing evidence on arboviral exposure 88 across Kenya. Given Kenya's position as a regional trading, transportation and healthcare 89 hub, our findings will contribute to national research and control efforts in addition to regional 90 strategies for arboviral disease mitigation.

# 91 **Methods**

92 Our systematic review and meta-analysis protocol was registered in advance in the 93 PROSPERO International Prospective Register of Systematic Reviews (CRD42023407963) 94 and was reported according to the Preferred Reporting Items for Systematic Reviews and 95 Meta-analyses guidelines (S1 File) (20).

## 96 **Systematic search of the literature**

97 We conducted a systematic search in PubMed (since 1946), Web of Science (since 1900), and 98 Global Health (since 1973) databases from their inceptions to  $15<sup>th</sup>$  March 2023. Our search 99 syntax (S2 File) was based on keywords from the Medical Subject Headings (MeSH) 100 database and was designed to capture all published studies reporting prevalence data for 101 arboviral families, including *Togaviridae* (CHIKV, ONNV, Sindbis virus (SINV)), 102 *Flaviviridae* (DENV, WNV, YFV, ZIKV, TBEV), *Bunyaviridae* (Orthobunyavirus, NV, RVFV, 103 CCHFV), and other related viruses in Kenya. All selected articles were collated and uploaded 104 into Rayyan QCRI (21) and filtered for duplicate records.

105 We considered cross-sectional studies, both community- and hospital-based, before, during 106 and after reported arboviral outbreaks in Kenya. We included studies that reported prevalence 107 of arboviruses in human, livestock and/ or wildlife populations based on serological detection 108 of immunoglobin G or M (IgG, IgM), viral isolation or reverse transcription–polymerase 109 chain reaction (RT-PCR). We excluded all studies conducted outside Kenya, and any 110 comments, conference notes, reviews and meta-analyses, case reports, and non-peer-reviewed 111 manuscripts (21) Two (L.J.K., R.N.) reviewers independently and blindly screened the 112 remaining articles in two stages: primary screening of the titles and abstracts, and secondary 113 screening of full-text articles, recording reasons for exclusions (21). Disagreements were 114 resolved by discussing with two additional independent reviewers (H.A., J.L.).

115 **Evaluation of the quality of studies** 

116 Two reviewers (L.J.K., R.N.) independently assessed each included study's quality using the 117 Joanna Briggs Institute System for the Unified Management, Assessment and Review of 118 Information (JBI SUMARI) critical appraisal tool (S3 File) (22). Specifically, this appraisal 119 was done against nine criteria encompassing elements related to sampling, population 120 representativeness and description, sample size determination, diagnostics coverage and

121 availability, statistical analysis, and addressing low response rates (23). Disagreements were 122 resolved by discussing with two additional independent reviewers (H.A., J.A.). Study quality 123 was scored as high (7-10), moderate (4-6), or low (0-3), with studies rated as high and 124 moderate considered suitable for inclusion in the meta-analysis (24–26).

## 126 **Data extraction**

127 Three reviewers (L.J.K., R.N., E.K.) extracted data from included studies, to a single 128 predefined summary Excel sheet  $(S4$  File). These data included the first author, publication 129 year, study design, sampling method (probabilistic, non-probabilistic), sample size, arbovirus, 130 study setting (rural, urban, peri-urban), study period, transmission period (during or between 131 outbreaks), geographical location (county, region), population, human participant recruitment 132 (community, health facilities), human clinical status (apparently health, febrile illness), 133 detection assay, confirmatory test if any, and proportion of positives per total numbers tested. 134 In publications reporting seroprevalence studies from more than one arbovirus, population, 135 and/ or geographic locations (counties or regions), each was considered as a separate study/ 136 row of data.

#### 137 **Meta-analysis of prevalence**

138 For each study where IgG data were available, we calculated IgG prevalence estimates and 139 their corresponding 95% confidence intervals using the exact binomial method (28). We then 140 conducted a meta-analysis of prevalence for each arbovirus using R statistical software 141 (version 4.2.0), using the 'meta' package. We estimated the pooled prevalence for each 142 arbovirus and host population using a random intercept logistic regression model with a logit 143 link function**.** The magnitude of heterogeneity between studies was assessed using Cochran's 144 Q and quantified using the  $I^2$  statistic; with an  $I^2$  of more than 75% indicating substantial

170 Among 184 human population studies, 64.7% (n=119) sampled apparent healthy individuals, 171 while 31.5% (58) sampled those presenting in health facilities with febrile illnesses that were 172 confirmed as arboviruses: DENV (17), WNV (11), TBEV (7), CCHFV (5), CHIKV (5), 173 RVFV (4), YFV (4), ZIKV (4), and Orthobunyaviruses (1). Seven (3.8%) studies were carried 174 out in both settings. Most of the studies were cross-sectional (97.2%, 239), with the 175 remainder being cohort (1.6%, 4) and longitudinal (1.2%, 3). Additionally, 64.2% (158/246) 176 carried out between outbreaks with human participants recruited from either the community 177 (119/184, 64.7%) or health facilities (65/184, 35.3%). All eight regions in Kenya were 178 represented by at least one study (Fig. 2). Coast and Rift Valley regions region had the highest 179 number of studies while Nairobi and Central regions had the least.

183 Of the 246 studies, IgG antibodies were the most tested (41.1%, 101/246), followed by 184 combinations of IgG and IgM (27.6%, 68/246), unspecified antibodies (15.4%, 38/246), IgM 185 and viral RNA (4.9%, 12/246), IgG/IgM (4.5%, 11/246), IgG/IgM and viral RNA (1.2%, 186 3/246), IgA, IgM, and IgG (1.6%, 4/246), IgM (1.6%, 4/246), and arboviral RNA (1.6%, 187 4/246). Most arboviral diagnostic assays across the studies were serological such as ELISA 188 (50.8%, 125/246), hemagglutination inhibition (HI; 11.4%, 28/246), plaque reduction 189 neutralization test (PRNT; 6.9%, 17/246), and indirect immunofluorescence assay (IIFA; 190 1.2%, 3/246) while some used molecular tests including RT-PCR (2.4%, 6/246) and 191 sequencing (5.7%, 14/246). A few studies combined both methods, such as ELISA and PRNT 192 (4.5%, 11/246), ELISA, PRNT, and IIFA (0.8%, 2/246), RT-PCR and sequencing (0.4%, 193 1/246), ELISA and RT-PCR (9.8%, 24/246), and ELISA, RT-PCR, and sequencing (4.9%,

194 12/246). Among these, 22.8% (56/246) carried out further confirmatory testing: PRNT 195 (42/246; 17.1%), virus neutralization test (VNT; 10/246; 4.1%), FRNT (3/246; 1.2%) and 196 ELISA (1/246; 0.4%) (S6 File).

197 The studies included in our analysis were undertaken between 1966 and 2021, with the 198 earliest eligible study published in 1970, followed by studies in 1982, 1983, and 1992, 199 totalling to 28 studies. These studies focused on RVFV, CHIKV, CCHFV, SINV, BUNV, 200 ZIKV, YFV, BANV and WNV. Post-2000, the next eligible study was published in 2002  $201$  (n=1) and then 2007 (n=11), all focusing on RVFV. There was an increase in published 202 studies from 2007 onwards, peaking in 2010 (n=28), 2015 (n=45) and 2020 (n=37), which 203 coincided with RVFV and DENV outbreaks (Fig. 3)**.** Overall, RVFV was the most 204 consistently studied arbovirus during this entire period, with publications in all identified 205 years except 1970 and 2012. Other arboviruses most frequently studied were CHIKV, DENV, 206 WNV, and YFV (S6 File**)**.

211 **Reported IgG prevalence of arboviruses in Kenya** 

212 **RVFV** 

213 We calculated a pooled IgG seroprevalence of 7% (95% CI: 4 - 11%;  $I^2$ : 98%, number of 214 studies: 33) and a prediction interval of 0- 62%, reflecting substantial heterogeneity among 215 the studies in humans. Prevalence ranged from zero in Uasin Gishu (Rift Valley) in 1996 and 216 Kilifi (Coast) in 2004 to a 40% in Nakuru (Rift Valley) in 1989 (Fig. 4A). In livestock, 217 twenty-seven studies reported a pooled prevalence of 10% (95% CI: 8 - 13%; I²: 90%) (Fig.

218 4B). The prediction interval ranged from 3% to 30%, with the highest prevalence observed in 219 Garissa (North Eastern) in 2015 at 30% and the lowest in Samburu (Rift Valley) and Meru 220 (Eastern), both at 2% in 2006. We observed an IgG seroprevalence of 16% (95% CI: 11 - 221 24%;  $I^2$ : 70%, n=15) in wildlife, with a prevalence range from 5% in Taita Taveta and Tana 222 River (both in Coast) in 2007 and 2008, respectively, to 57% in Garissa (North Eastern) in 223 2007, and a prediction interval of 4% to 51% (Fig. 4C). The most frequently sampled species 224 were buffaloes, warthogs, oryx, waterbuck and impala.

### 233 *Aedes***-borne viruses**

234 Of 21 studies focusing on humans, the pooled IgG seroprevalence for DENV was 6% (95% 235 CI: 3–11%;  $I^2 = 98\%$ ), with a prevalence range from zero in Busia (Western) in 2004 to 67% in 236 Kwale (Coast) in 2000 and 60% in Coastal counties in 2007, and a prediction interval of zero to 237 67% (Fig. 5A). In wildlife, specifically *Papio* (baboon) species, a pooled prevalence of 27% 238 (95% CI: 12-49;  $I^2 = 81\%$ ) was estimated from two studies, with a prediction interval of 239 8-61%, the highest prevalence being in Kwale (Coast) at 47% and the lowest in Kakamega 240 (Western) at 15%, both reported in 2014. 241 We reviewed 15 studies reporting CHIKV IgG seroprevalence in humans, showing a pooled

242 prevalence of 10% (95% CI: 4-24%;  $I^2 = 15$ ), and a prediction interval of 4-24%. Prevalence

243 ranged from 72% in Lamu (Coast) in 2004 and 67% in Busia (Western) in 2010, to a low of 1% 244 in Nairobi (2008), Central (2007), and Kwale (Coast) in 2009 (Fig. 5B). There was an overall 245 IgG prevalence of 5% (95% CI: 2-11%;  $I^2 = 97\%$ , n = 9) for YFV in human populations. The 246 prediction interval was 4-24%, with a prevalence range from a high of 42% in Kwale (Coast) 247 in 2000 to a low of 1% in Kilifi (Coast) and Samburu (Rift Valley), both reported in 2004 248 (Fig. 5C). The pooled prevalence of IgG ZIKV in humans, from four studies was 2% (95% 249 CI: 1-3%;  $I^2=0\%$ ; prediction interval: 0-5%). Reported prevalences ranged from 3% in 250 Kisumu (Nyanza) in 2011 to 1% in Nairobi and Kisumu (Nyanza) in 2009.

# 259 **Other mosquito-borne viruses**

260 Pooling data from seventeen studies on WNV IgG, we report a pooled prevalence rate of 9% 261 (95% CI: 5-14%; I²=93%), with a prediction interval of 1-51%. The highest prevalence rates 262 were in Tana River in 2009 (34%) and Kwale in 2000 (29%), both in Coast and the lowest in 263 Samburu (Rift Valley) (1%) and Kilifi (Coast) (2%), both reported in 2020. For ONNV, an 264 overall prevalence of 3% (95% CI: 1 - 9%;  $I^2 = 76\%$ ; n=7) was observed, with a prediction 265 interval of 0- 40%, the highest prevalence being in Lamu (Coast) at 20% in 2008 and the lowest 266 in Nairobi at 1% in 2008. From the only two studies in Rift Valley region in 2022 reporting 267 IgG Ngari in livestock, a pooled prevalence of 38% (95% CI: 31- 46%) with a moderate

268 heterogeneity ( $I^2 = 30\%$ ) was observed. The prediction interval was 31-46%, with individual 269 prevalence rates of 31% in Kajiado and 24% in Baringo.

#### 271 **Tick-borne viruses**

272 An overall human IgG TBEV prevalence of 7% (95% CI:  $5 - 10\%$ ;  $I^2 = 79\%$ ) was estimated 273 from ten studies, with a prediction interval of 2-20%, indicating moderate heterogeneity. 274 Prevalence rates ranged from 16% in Kwale (Coast) and 11% in Baringo (Rift Valley) counties 275 in 2000 and 2020, respectively, to 3% in Nandi (Rift Valley) in 2000. For CCHFV, pooled 276 estimates of IgG seroprevalence in humans were 15% (95% CI: 6–33%;  $I^2=97\%$ ; n=5), with a 277 prediction interval of zero to 90%. The highest prevalence was reported in Baringo (Rift 278 Valley) in 2009 at 35%, while the lowest was 3% in a nationwide study in 2020. In livestock 279 and wildlife, we report pooled CCHFV prevalence rates of 28% (95% CI: 21–36%;  $I^2=0\%$ ; 280  $n=1$ ) in Laikipia and Narok counties in Rift Valley, and 75% (95% CI: 69–81%;  $I^2=0$ %; n=1) 281 in Meru (Eastern) and Laikipia, Narok, Nakuru counties in Rift Valley, all reported in 2007.

#### 283 **Discussion**

284 Our systematic review and meta-analysis, provide insights into the historical occurrence of 14 285 arboviruses in humans and animals. We focus on RVFV, DENV, CHIKV, YFV, and WNV due 286 to their substantial prevalence and prioritization in key global initiatives like the WHO 287 Blueprint for Prioritized Diseases.

288 Our findings indicate widespread RVFV seropositivity across humans, livestock and wildlife 289 that is potentially associated with presence of competent vectors, including *Aedes*, *Culex*, 290 *Mansonia*, and *Anopheles* spp. (10,30), alongside livestock movements related to intensive 291 pastoralism, commercial and sociocultural practices (31–34). The higher seroprevalences in

292 livestock and wildlife than humans are as expected due to more frequent 293 livestock-vector-wildlife transmission, with less common spillover to humans, but still of 294 concern (35). A One Health approach remains vital for monitoring these dynamics and 295 mitigating accordingly. We note that the majority of studies have been concentrated in North 296 Eastern (Garissa, Wajir), Coast (Tana River, Kilifi, Kwale, Taita Taveta), and Rift Valley 297 (Nakuru, Baringo). This focus likely reflects targeted research in "at-risk" areas rather than 298 limited risk elsewhere, thus a need to expand surveillance to under-studied areas to fully 299 capture the national risk (36) For DENV and CHIKV in humans, we report overlapping 300 geographic distributions in Nairobi, Nyanza, Western, and coastal counties (10,30), and 301 indicating risks of cocirculation/ coinfection, particularly in areas with abundant *Aedes aegypti* 302 mosquitoes. High frequency of outdoor livelihood activities, including pastoralism, farming, 303 and fishing, across much of the country could further increase exposure risk to the day-feeding 304 vector, supporting our findings (37,38). Wildlife may play an important role in DENV 305 transmission in forested areas such as Kwale and Kakamega, either through spillback from 306 humans to nearby *Papio* species (16,38–40) or via enzootic transmission driven by sylvatic 307 *Aedes aegypti formosus* (41–43). YFV's relatively low seroprevalence herein was unexpected, 308 especially given Kenya's designation by WHO as a high-risk country and routine mass 309 vaccination campaigns albeit only in high-risk counties (44,45). With Kenya's human YFV 310 vaccination coverage estimated at just 7%, far below WHO-recommended 80% for herd 311 immunity (10,45,46), undetected YFV circulation in susceptible populations alongside 312 competent *Aedes* spp. (10,30) may explain our findings. However, since the most recent 313 data in our study is from 2017, and dynamics may have shifted, especially after the 2022 314 outbreak, reassessing YFV prevalence is key in light of current trends. Finally, with no 315 documented outbreaks, WNV substantial seroprevalence in humans suggests sporadic 316 transmission likely linked to migratory birds at convergence zones or local mosquito vectors,

317 including *Culex, Mansonia* and *Aedes* spp (10,30,47,48).

318 Our findings illustrate a persistent, widespread risk of arboviral transmission in Kenya, one 319 that we expect to escalate due to evolving environmental and socioeconomic conditions, 320 including climate change, globalization, urbanization, and rapid population growth (7,49–52). 321 With respect to climate change, heavy rainfall and flooding events influence RVFV (53–57), 322 warmer temperatures and altered precipitation patterns for *Ae. aegypti*-mediated DENV, 323 CHIKV, and YFV (58–62), and prolonged dry spans and droughts necessitating water storage 324 in containers for DENV and CHIKV (62–64). As climate change intensifies these weather 325 patterns, permissive vectors may expand their geographical range and transmission seasons, 326 potentially exacerbating arboviral threats (49,65). Under the latest IPCC projections, Kenya 327 and much of East Africa is expected to experience mean annual temperature increases of up to 328 2.1°C (57) with intensified heavy rainfall events (57,66–69) and sustained or reduced drought 329 frequency (70–73). Consequently, extensive outbreaks in established hotspots could worsen, 330 and previously unaffected or less affected regions in Kenya may emerge as new hotspots. 331 Mordecai et al. suggest that climate-driven shifts could create complex changes in the 332 incidence of arboviruses and malaria, with warmer temperatures potentially favoring one over 333 the other depending on the region (51). In Kenya, this could worsen the dual burden of 334 arboviruses and malaria, additionally straining the health system and complicating public 335 health efforts. Rapid, often unplanned urbanization, characterized by mushrooming slums, 336 overcrowding and poor sanitation, provides conducive breeding conditions for *Ae. aegypti* 337 and *Culex pipiens*, which could facilitate the rapid spread of DENV, CHIKV, ZIKV and 338 WNV (7,74–76). This is reflected in our findings of considerable prevalence of Aedes-borne 339 viruses in urban centers like Nairobi, Mombasa, Kisumu, Busia, and Malindi. This 340 transmission risk may be further compounded by the urban heat island effect in Nairobi, and

341 other cities that could enhance mosquito survival and reproduction, while the urban sprawl 342 could potentially hamper vector control measures like larval source management (77–79). As 343 Kenya's cities and towns continue to expand and with more than 50% of Kenyans projected 344 to live in urban centres by 2030 (80,81), the threat of urban arbovirus outbreaks in the 345 country is significant. Further, *Ae. albopictus*, a highly adaptable species, was recorded in 346 Kenya's neighbors nearly a decade ago (7,49–52) and could already be in Kenya undetected 347 (82), raising concerns about its potential to facilitate the spread of arboviruses in both urban 348 and rural settings, further complicating control efforts.

349 Beyond expansion of urban and peri-urban centres, deforestation, intensive pastoralism, 350 land-use change and encroachment of human settlements into previously uninhabited areas 351 could

352 also increase arbovirus risk by disrupting natural ecosystems and increasing human-sylvatic

353 vector interactions (83,84). Additionally, globalization—through increased international 354 travel, tourism and trade—compounds these risks by facilitating the movement of infected 355 people and livestock across borders, potentially introducing new strains of arboviruses into 356 Kenya and triggering outbreaks in previously unaffected regions (85–88). Our findings 357 support this, with substantial representation of Aedes-borne viruses in the trade and 358 tourism-intensive coastal counties of Mombasa, Kwale, Kilifi, and Lamu.This is particularly 359 concerning for viruses like DENV and CHIKV, which have a propensity for rapid spread in 360 new environments (89–91), and is especially relevant for coastal counties like Mombasa, 361 where high volumes of international goods importation and tourism could also introduce 362 invasive mosquito species like *Ae. albopictus*.

363 Mitigating these projected surging arboviral threats in Kenya requires aligning national 364 efforts with global frameworks like the GAI, Global Vector Control Response (GVCR), and

365 WHO Regional Framework for monitoring invasive species (92–94)Kenya's surveillance 366 infrastructure, particularly the Integrated Disease Surveillance and Response (IDSR) system, 367 has traditionally relied on passive surveillance methods with marked successes in detecting 368 outbreaks like cholera and malaria (95,96). It is, however, often limited by underreporting 369 and delays, limiting its capacity to fully monitor arboviral activity across the country (97) 370 Further, deficiencies in diagnostic capacities, data integration across human, animal, vector 371 and environmental health sectors, and insufficient personnel training have emerged as 372 limiting factors in Kenya's capacity for arboviral surveillance and control (98). To bridge 373 these gaps, Kenya needs to incorporate more active surveillance methods within a One Health 374 framework including expanding entomological surveillance, streamlining reporting 375 mechanisms, and leveraging geographic information systems and remote sensing 376 technologies that could improve Kenya's ability to monitor vector populations and predict 377 outbreak hotspots before they escalate (92,99) More focus on arbovirus co-infections and 378 their clinical outcomes is needed in Kenya, as most included studies examined single viruses 379 at a time, despite many vectors like *Aedes* and *Culex* spp. often harbouring multiple viruses 380 simultaneously (100). Future research should also prioritize longitudinal studies across 381 diverse ecological zones to comprehensively assess arbovirus circulation and transmission 382 dynamics across the country. Further, diagnostic challenges such as overlapping clinical 383 symptoms, cross-reactivity, and persistence of antibodies among many arboviruses limit the 384 ability of laboratories in the region to generate accurate exposure data. Incorporating more 385 specific case definitions, along with expanding the diagnostic capabilities — accurate 386 point-of-care diagnostics especially in remote, resource-limited settings — is key for timely 387 outbreak detection and management (51,101).

388 With no vaccines available for most arboviruses, integrated vector management (IVM) 389 remains the most viable approach for outbreak prevention and response (89). In Kenya,

390 existing vector control efforts, including larval source management (LSM), 391 insecticide-treated nets (ITNs), and indoor residual spraying (IRS), were primarily developed 392 to combat malaria and have successfully reduced its burden (102,103). Yet, this focus has left 393 arboviruses largely neglected. To correct this imbalance while maximizing resource efficiency, 394 Kenya can leverage these existing infrastructure and resources to control arboviruses, 395 adopting them to specific vector needs (89). For example, while LSM and larvicides may 396 apply across *Anopheles* (malaria) and some *Aedes* species, ITNs may be less effective due to 397 vector biology and behavior differences (89,104)Further, given Kenya's dual burden, these 398 arbovirus interventions should complement and not detract from malaria control achievable, 399 for instance, by training malaria control experts in arbovirus management and securing 400 funding agreements to prevent resource diversion from the already underfunded malaria 401 programs (89,105) Tailoring these interventions to local contexts and scaling up through 402 community-based approaches, including health education and promotion, environmental 403 cleanup, and leveraging the role of gender dynamics in household-level vector control, is also 404 critical for ensuring their sustainability and success (51,93,104,106) Additionally, 405 strengthening these strategies through multisectoral collaboration across agriculture, 406 environment, urban planning, education and public health, would foster a more holistic and 407 coordinated approach to arboviral threats nationwide (106).

408 To reinforce Kenya's response to arboviral outbreaks, developing and refining targeted 409 contingency plans is essential. Kenya has made some progress in this regard with the RVFV 410 contingency plan, which has been periodically updated to focus on high-risk areas such as 411 Isiolo and Wajir (107). These plans should be further adapted by pre-positioning resources in 412 these regions, training healthcare workers in rapid response protocols, and ensuring the IDSR 413 system is fully equipped to handle the nuances of arboviral outbreaks (108,109). Kenya can

414 also capitalize our findings to contribute to a national dedicated arbovirus dashboard— per 415 GAI's priority actions—as a comprehensive tool for real-time monitoring, optimal resource 416 allocation and improved coordination during outbreaks(7,9)Further, multicountry 417 collaborations through regional networks like the East African Community and African 418 Union, alongside global partners through the GAI, could provide Kenya with additional 419 resources, expertise and data to strengthen its capacity to manage local and cross-border 420 threats, while also supporting continent-level early warning systems (7,93).

421 Our findings may however be limited by substantial heterogeneity, as sources of 422 heterogeneity, such as varying methodologies, population characteristics, and confirmation 423 cut-offs were not reported in many studies and could not be assessed. Additionally, our 424 county-level data, based on sampled areas, may not fully represent local ecological and 425 climatic diversity, necessitating caution in extrapolating findings to entire counties. 426 Ascertainment bias may also be present, as included studies predominantly focused in 427 identified "hotspot" areas, potentially overrepresenting them. Finally, reliance on ELISA 428 without PRNT or RT-PCR confirmation across most studies raises concerns on results 429 accuracy and reliability. Nonetheless, our study reveals an extensive longstanding history of 430 arboviral circulation in Kenya, with future risks projected to increase due to ecological, 431 environmental, and socioeconomic factors. For effective mitigation, strengthening 432 surveillance, enhancing integrated vector management, and improving outbreak response and 433 prevention efforts are key. By addressing these key areas through targeted interventions and 434 regional cooperation, Kenya can better position itself to effectively manage the growing risk 435 of arboviral diseases.
