# Exploring social determinants of childhood vaccination based on the National Immunization Surveys Data

## 10 Abstract

9

11 Ensuring children receive vaccinations is essential for their health and community well-being, preventing serious 12 diseases and fostering overall immunity. Nevertheless, the impact of social determinants of health on vaccination access underscores the urgent need for targeted interventions to address disparities and ensure equitable 13 14 healthcare delivery for all children. This study investigates the impact of several social determinants on childhood 15 vaccination in the United States using data from the National Immunization Surveys from 2010-2022. As a simple 16 approach, ordinal logistic mixed-effect models is used to analyze vaccination patterns among children aged 19-17 35 months as reported by parents or guardians. The study findings highlight associations between vaccination 18 and key social factors, including the child's age group, parents' or guardians' education level, and vaccination 19 awareness due to the child being the firstborn. The results from this basic study provide insights into the nuanced 20 relationships that influence vaccination practices.

## 25 1. INTRODUCTION

Childhood vaccination programs have played a pivotal role in public health by significantly reducing the burden of
vaccine-preventable diseases worldwide [1]. Vaccinations during early childhood are crucial for protecting
individuals against a myriad of infectious diseases, thereby contributing to the overall well-being of children and
communities. Despite the remarkable success of vaccination initiatives, achieving optimal vaccination coverage
remains a persistent challenge, particularly due to emerging infectious threats and vaccine hesitancy concerns
[2]. Understanding the factors influencing vaccination uptake is essential for devising targeted interventions and
policies aimed at promoting equitable access to vaccines and sustaining high vaccination coverage rates [3].

34 Social determinants of health (SDoH) have garnered increasing attention in recent years as critical factors of 35 health outcomes and healthcare utilization [4,5]. These determinants, encompassing socioeconomic status, 36 education, employment, housing, social support networks, cultural norms, and healthcare access, have effects on 37 vaccination behavior and coverage rates [6,7]. Disparities in vaccination coverage persist among different 38 demographic groups, highlighting the intricate interplay between socioeconomic factors and vaccine accessibility 39 [8]. Furthermore, the impact of SDoH on vaccination decisions extends beyond individual-level factors to 40 encompass broader societal and structural determinants, underscoring the multifaceted nature of vaccination 41 disparities [9,10]. These SDoH influence health behaviors, healthcare utilization patterns, and overall health 42 status, shaping health outcomes across the lifespan [11-13].

By recognizing the impact of SDoH on health outcomes, researchers can develop more comprehensive and
holistic approaches to health promotion and disease prevention. Addressing disparities in SDoH not only
mitigates health inequities but also enhances the effectiveness of healthcare interventions and health policies
[14,15]. Moreover, integrating SDoH into health research enables the identification of modifiable risk factors and
the development of targeted interventions to address underlying social determinants, thereby promoting health
equity and improving population health outcomes [12,13,16]. Incorporating SDoH into health research also

emphasizes the importance of adopting an interdisciplinary and collaborative approach to address complex health
challenges. Collaborations between researchers, policymakers, healthcare providers, community organizations,
and other stakeholders are essential for implementing multifaceted interventions that target the root causes of
health disparities and promote health equity [17,18].

55 This work presents a simple analysis examining the relationship between SDoH and childhood vaccination using 56 data from the National Immunization Surveys. The study aims to identify potential influences of various SDoH, 57 such as socioeconomic status, education, and geographic location, on the reported number of vaccinations 58 among children aged 19-35 months, and how these associations change over time. An ordinal logistic mixed-59 effects model is employed to investigate how these social factors affect vaccination, considering the ordinal 60 nature of the vaccination variables (0, 1, 2, 3+ vaccinations). The findings are expected to provide insights into the interplay between social determinants and childhood vaccination patterns, aiming to inform targeted interventions 61 62 to improve vaccination uptake and address disparities in immunization. 63

## 64 2. MATERIALS AND METHODS

## 66 **2.1. Data**

67 The National Immunization Surveys (NIS) for Children (NIS-Child) focuses on children aged 19-35 months 68 residing in the United States, capturing a representative sample of this population for vaccination coverage 69 assessment. The data collected serve as a crucial tool in monitoring the prevalence of recommended 70 vaccinations among 2-vear-old children at national, state, and selected local levels, as well as in U.S. territories. 71 The survey encompasses a comprehensive assessment of coverage for key vaccinations, including Diphtheria 72 and Tetanus Toxoids and Acellular Pertussis vaccine (DTaP/DT/DTP), Poliovirus vaccine (Polio), Measles or 73 Measles-Mumps-Rubella vaccine (MMR), Haemophilus Influenzae type b vaccine (Hib), Hepatitis B vaccine 74 (HepB), Varicella Zoster (chickenpox) vaccine (VAR), Pneumococcal Conjugate vaccine (PCV), Rotavirus 75 vaccine (ROT), Hepatitis A vaccine (HepA), and Influenza vaccine (Flu), leading to a total of ten (10) 76 recommended vaccine administration by age 2, where doses vary by schedule. This study investigates the impact 77 of several social determinants on childhood vaccination in the United States using NIS-Child data from 2010-78 2022.

## 80 2.1.1.Social Determinants of Health

While the primary objective of the survey is to assess immunization status, it inherently reflects several social 81 82 determinants of health (SDoH) that could influence vaccination patterns. Demographic information, including socioeconomic status such as income and education levels, is implicitly embedded in the data and may influence 83 84 access to healthcare services, including vaccinations. Additionally, the survey's multi-level approach, collecting 85 data at national, state, and selected local levels, provides insights into potential geographic and regional 86 disparities in vaccination coverage. Furthermore, the inclusion of demographic variables like race and ethnicity 87 offers a glimpse into disparities that may exist among different racial and ethnic groups. Indirect indicators of 88 healthcare access, such as health insurance coverage and the availability of healthcare facilities, can be inferred 89 from the dataset. Moreover, maternal and child health practices, encompassing factors like breastfeeding and prenatal care, may indirectly impact the likelihood of children receiving recommended vaccinations. While the 90 91 NIS-Child primarily focuses on vaccination coverage, it offers a valuable lens through which researchers can 92 explore the intersection of immunization and various SDoH, contributing to a more comprehensive understanding 93 of public health dynamics among young children, which is exactly the focus of this study.

## 95 2.1.2.Health Outcome

For this study, the number of vaccines received by the child is used as the health outcome of interest. It is important to note that this number can vary based on various factors, including parental choices, access to healthcare, and adherence to vaccination schedules. According to data from the NIS, coverage rates for recommended vaccinations among children by age 2 are regularly assessed. Thus, NIS aims to capture the percentage of children who have received specific vaccines according to the recommended schedules. In addition, parents' reports are a critical component of assessing vaccine coverage, but it is also important to note

102 that the accuracy of these reports can be influenced by factors such as recall bias, understanding of vaccine 103 schedules, and other individual or cultural considerations. Public health initiatives often emphasize the importance

104 of accurate reporting and maintaining up-to-date immunization records. To facilitate the understanding and

105 interpretation of the model being implemented and the results obtained, a categorical variable (with name

106 vaccination group and denoted by V) is constructed to represent the grouped number of vaccinations reported by

107 parents or guardians. The variable is constructed as shown in Equation 1, where *i* represents a child aged 19-35 108 months and t the survey year.

#### 110 2.2. Analysis

111 The ordinal logistic mixed-effects model expresses the cumulative probability of an ordinal response variable, V 112 as previously described, being in or below category j. The model is defined as follows (Equation 2).

114 Here, V is the ordinal response variable,  $X_1, X_2, ..., X_k$  are the SDoH of interest,  $\alpha_i$  is the intercept of the cumulative 115 log-odds at category j,  $b_1$  is the random effect for census region,  $b_2$  a random effect for year, and  $\beta_1, \beta_2, ..., \beta_k$  are

116 the estimated coefficients for the SDoH of interest. This model estimates the cumulative probability of being in or

below category *j* based on the values of the SDoH of interest. The logistic function  $\frac{1}{1 + \exp(-z)}$ , shown in the 117

118 right-hand side of the previous equation, is used to transform the linear combination of predictors into a

119 probability. The coefficients  $\beta_1, \beta_2, \dots, \beta_k$  represent the impact of each predictor variable on the log-odds of the

120 ordinal response variable. A positive coefficient indicates an increase in the log-odds, while a negative coefficient

121 indicates a decrease. The intercepts  $\alpha_i$  represent the cumulative log odds at the baseline level (category 0) and

122 each subsequent category. They determine the starting point of the cumulative probabilities for each category. 123 This model can be applied to investigate the influence of predictor variables on the probabilities of different

124 categories. The model can also be written in its log-odds format as shown in Equation 3.

#### 3. RESULTS 126

127 The goal of this study lies primarily in the assessment of the impact of several the social determinants of health on 128 vaccination coverage by looking at their statistical significance and how this impact has changed over time from 129 2010 to 2022. Tables 1 provides the definition of the SDoH of interest for this study. To help readers with 130 knowledge with the NIS-Child datasets, this table uses the same names (labels) as described on the website. 131 Figure 1 shows the number of children being vaccinated over time, where the 30-35 months category always 132 shows greater coverage compared to the other groups. This graph also shows that coverage trajectories are very 133 similar for the first two age groups.

136 If we look at the census region (Figure 2), the number of 3+ vaccinations is lower compared to other categories. 137 The South region shows the highest number of vaccinated children with 1 or 2 types. Missing values are affecting 138 these trajectories, as shown in the last plot of Figure 2. When looking at the Hispanic origins of the children 139 (Figure 3), more children from non-Hispanic origins showed higher numbers of vaccines from 2010 to 2022. The 140 poverty-to-income ratio is the ratio between the total income of the children's family and the poverty threshold. A 141 ratio of less than 1 means the income is below the poverty level, 1 means the income and poverty level are the

142 same, and greater than 1 means the income is above the poverty level. From the data, we found that poverty-to-

- 143 income ratio patterns look similar over time (Figure 4), with a higher density above the poverty level, but a
- 144 noticeable peak below 1 is of concern as well.

## 172

#### 173 3.1. Year-specific models

174 The first analysis uses Equation 1 with all covariates of interests and a random effect for census region. This 175 model revealed some significant associations between SDoH variables and childhood vaccination. Figure 6 176 illustrates the statistical significance over time of various factors with the vaccination group. The red and blue 177 colors represent if the odds ratios are greater than 1 or not (red = no, blue = yes). In the x-axis, we look at the 178 significance level of the predictor, with names shown in the y-axis. Value 0 means it is not significant, while 1 179 means it is statistically significant. Several SDoH factors significantly influence childhood vaccination behavior. 180 Specifically, the child's age group, parents' or guardians' education level, vaccination awareness due to the child 181 being the firstborn, and the income-to-poverty ratio were found to be significant predictors of vaccination coverage 182 among children aged 19-35 months. Overall, these findings underscore the importance of addressing social 183 determinants such as education and awareness programs in promoting childhood vaccination and reducing 184 disparities in immunization rates.

#### 190 3.2. Full ordinal logistic mixed-effects model

191 In this second model, both random effects for census region and year were included. Among factors that were 192 flagged as positively associated with increased vaccination, we have both older age groups (24-29 months, 30-35 193 months) of the children, the group of children who were breastfed or fed with breast milk, higher education in the 194 mothers, first born child, and Spanish-speaking mothers. All these factors were statistically associated with 195 increased vaccination group membership at the 5% level. On the other hand, among the SDoH factors associated 196 with a decreased vaccination, we have children with Hispanic origin, higher income to poverty ratio, group of 197 mothers older than 30 years old, mother who lives with a partner, children from the Hispanic Black group, 198 indicator that children were not covered by any health insurance. All these factors were statistically associated 199 with a decreased vaccination group membership at the 5% level. Figure 7 summarize these results.

#### 203 4. **DISCUSSION**

204 Moving forward, future research endeavors could expand upon the findings of this study to delve deeper into the 205 mechanisms underlying the observed associations between social determinants of health and childhood 206 vaccination. One avenue for exploration could involve longitudinal studies to track vaccination patterns over time 207 and assess the long-term impact of SDoH on immunization rates. Additionally, gualitative research methods, such 208 as interviews or focus groups with parents and healthcare providers, could provide valuable insights into the 209 barriers and facilitators to vaccination uptake within different demographic groups.

211 Building on the identified disparities in vaccination, potential initiative implementations should aim to address the 212 root causes of these disparities and promote health equity. Community-based interventions, such as mobile 213 vaccination clinics or outreach programs targeting underserved populations, could improve access to vaccinations 214 in areas with low coverage rates. Furthermore, educational campaigns tailored to specific demographic groups 215 could enhance vaccine awareness and address misconceptions about vaccination safety and efficacy. 216

- 217 Incorporating technology and digital health solutions may also play a crucial role in improving vaccination
- 218 coverage. Tools such as reminder systems, telehealth consultations, and mobile applications for vaccine
- 219 scheduling and information dissemination could help overcome logistical barriers and increase vaccine uptake

among children and their families. Collaborative efforts between healthcare providers, public health agencies,
 community organizations, and policymakers will be essential for implementing and evaluating the effectiveness of
 these initiatives. Overall, future research and initiatives should prioritize strategies that promote equitable access
 to vaccinations while addressing the social, economic, and cultural factors that contribute to disparities in
 vaccination coverage. By addressing these challenges, we can work towards achieving higher vaccination rates
 and better overall health outcomes for children and communities.

# 227 5. CONCLUSION

228 This study reveals key social determinants impacting childhood vaccination, identifying factors like age groups, 229 breastfeeding, maternal education, and economic conditions as crucial influences. The disparities observed 230 underscore the urgency of developing strategies that specifically address the unique challenges encountered by 231 vulnerable groups, including children from Hispanic and/or Black groups, uninsured families, and those 232 experiencing economic hardship. Future initiatives should focus on enhancing accessibility through innovative 233 approaches such as community-driven programs, digital health solutions, and culturally sensitive outreach, 234 especially to boost vaccination coverage, ultimately advancing health equity and improving vaccination outcomes 235 for all children. 236







Number of Children Aged 19-35 Months per Vaccination Category



Number of Children Aged 19-35 Months per Vaccination Category and Census Region




