23 Abstract

24 **Background:** Female athlete triad (FAT), a syndrome linking low energy availability (LEA), menstrual dysfunction (MD), and impaired bone health, has serious potential 25 26 consequences for sports performance and health. In this cross-sectional study, we 27 investigated prevalences of each FAT component in female athletes of aesthetic and non-28 aesthetic sports and in non-athlete females, and its association with body image (BI) 29 distortion and eating behaviors. Methods: Google Forms was used to examine self-30 reported height and weight, menstruation conditions, history of stress fractures (HSF), BI, 31 the Eating Attitude Test (EAT)-26 (indicator of eating disorder) scores, and eating behaviors; these attributes were compared between 3 groups (athletes of aesthetic sports 32 33 [rhythmic gymnasts, n=40] and non-esthetic sports [volleyball players, n=46]; other 34 females of the same age group [non-athletes, n=108]). To identify risk factors for each 35 FAT component, multivariate logistic-regression analyses were used. LEA, MD, and HSF 36 were dependent variables; rhythmic gymnasts, distorted BI, and EAT-26 scores were 37 independent variables. Results: Rhythmic gymnasts had a lower body mass index (p < 0.001), higher LEA and MD prevalence (both p < 0.001), and greater percentage of 38 39 participants with ≥ 2 FAT criteria ($p \leq 0.05$) compared with other groups: exhibited higher 40 distorted BI scores (p < 0.05) than volleyball players; and tended to overestimate their body shape. Regarding eating behaviors, rhythmic gymnasts had higher EAT-26 scores 41 42 (p < 0.001) than other groups and significantly tended to skip breakfast (p < 0.05) than nonathletes. Multivariate logistic-regression analysis revealed that rhythmic gymnasts and 43

body-shape overestimation were independently associated with LEA; rhythmic gymnasts
and high EAT-26 scores were independently associated with MD. Conclusions: FAT
prevalence was approximately 1.5 times higher among rhythmic gymnasts than among
volleyball players and non-athletes. These findings suggest that rhythmic gymnasts are at

48 a higher risk of FAT and being an athlete in aesthetic sports, body-shape overestimation,

49 and higher EAT-26 scores are risk factors for FAT.

51 Introduction

52 An increasing number of women are engaging in sports from a young age [1]. 53 However, long-term rigorous training and weight loss to enhance athletic performance may predispose young women to the risk of developing female athlete triad (FAT) [2,3]. 54 55 This term encompasses a range of health-related issues relating to low energy availability (LEA) resulting from an energy deficit when reaching a certain threshold level, leading 56 57 to menstrual dysfunction (MD) and low bone mineral density as a result of reduced bone 58 formation associated with menstrual irregularities during adolescence [2]. LEA is 59 characterized as increased energy expenditure owing to intense training alongside an insufficient energy intake [3]. 60

The prevalence of FAT varies with sport characteristics and is notably high in aesthetic sports such as rhythmic gymnastics and figure skating [2]. We therefore focused on female rhythmic gymnasts, a group with approximately 10,000 participants in Japan, who often continue their competitive careers from elementary school through to high school and university during their growth period [4]. One study involving Japanese female elite athletes [5] reported that the rate of amenorrhea among female rhythmic

gymnasts was significantly higher at 40.9%, when compared with 6.2% and 3.8% in
volleyball and soccer players, respectively. Moreover, the prevalence of stress fractures
was higher among rhythmic gymnasts at 45.5%, when compared with 16.0% and 7.5%
in volleyball and soccer players, respectively.

71 Rhythmic gymnastics is a sport where being physically thin has both competitive and aesthetic value. Athletes in this discipline have been known to often restrict their diets 72 73 to enhance performance [6], leading to a higher prevalence of LEA and resulting in 74 amenorrhea and stress fractures. To protect these athletes, it is crucial to recognize and 75 address FAT-related signs early. In previous research, we showed that the desire to lose 76 weight is linked to a distorted body image (BI) perception among Japanese non-athlete 77 women [7]. This distorted perception may also cause rhythmic gymnasts to pursue 78 excessive thinness, worsening the issues in relation to FAT. Investigating the association 79 between a desire to lose weight and BI in rhythmic gymnasts could help address this issue. 80 To better understand BI and the eating behaviors of rhythmic gymnasts, we compared 81 such gymnasts with female athletes of non-aesthetic sports and with non-athletes. The most appropriate age group for this comparison involves female high school and 82 83 university students, as their menstrual cycles are stabilized and their growth and 84 development are nearing completion.

This study aimed to elucidate the characteristics and prevalence of FAT and BI, eating behaviors, and tendencies toward eating disorder in female rhythmic gymnasts in high school or at university in comparison with female volleyball players and non-athletes of similar age. We investigated the prevalence of each FAT component female athletes of aesthetic and non-esthetic sports and non-athlete females, and its association with distortion and eating behaviors.

Methods 92

Study design and population 93

94 This cross-sectional study was conducted using a web-based survey. Participants 95 included female high school and university students engaged in aesthetic sports (rhythmic 96 gymnasts, n=40), non-aesthetic sports (volleyball players, n=46), and non-athlete female 97 students of the same age (n=108). Rhythmic gymnasts were recruited between 15 April 98 and 1 June 2022, while female volleyball players and non-athletes were recruited between 99 15 June and 16 July 2023 through flyers requesting participation.

100 The rhythmic gymnasts and volleyball players participating in this study performed at a highly competitive level, capable of competing in prefectural and national 101 102 tournaments, practicing their sports almost daily, and engaging in high-intensity exercise. 103 Inclusion criteria comprised women who belonged to high-school or university rhythmic 104 gymnastics or volleyball club, who agreed to participate in the study, and who could 105 complete the questionnaire in Japanese.

106 Non-athlete women included high school students who visited our university's 107 open campus and university students from our university and other nearby universities in 108 Hyogo Prefecture or surrounding prefectures. Exclusion criteria were men, university or 109 vocational school students majoring in nutrition, and non-athlete women with exercise 110 habits. The study's purpose, its anonymity, the voluntary nature of participation, and the 111 condition that completing the web survey would be considered consent to participate in 112 the study were stated in the flyers and at the beginning of the web survey. This information was also explained verbally when distributing the flyers. Written informed 113

consent was obtained from the study participants. Data from all respondents who 114 115 completed the web survey were used for analysis after confirming there were no errors, 116 resulting in a 100% valid response rate. This study was approved by the Research Ethics Committee of the University of 117 118 Hyogo (No. 275, March 10, 2022, No. 314, June 7, 2023). The study procedures were 119 conducted in accordance with the Declaration of Helsinki. 120 Questionnaire 121 122 We developed a self-report questionnaire using Google Forms. Study 123 participants accessed the questionnaire via a flyer with a QR code link. The survey items 124 sought data in relation to basic characteristics, The prevalence of each FAT component, 125 BI, and eating behaviors. 126 127 **Basic characteristics** 128 Participants self-reported their school category, age (years), athletic experience 129 (years), height (cm), and weight (kg). Body mass index (BMI) (kg/m²) was calculated as weight (kg) divided by height squared (m^2) . 130 131 FAT 132 133 LEA was screened using the definition of the American College of Sports 134 Medicine [8], which considers clear signs of low energy status to be a body weight <85% of normal (BMI=22 kg/m²). 135 136 Menstrual abnormalities were determined according to Obstetrics and 6

Gynecology Clinical Practice Guidelines, Outpatient Gynecology Edition, 2020 [9]. Participants reported their current menstrual status either as: (i) a regular menstrual cycle, (ii) oligomenorrhea (cycle of \geq 39 days), (iii) frequent menstruation (cycle of \leq 24 days), (iv) amenorrhea (absence of menstruation \geq 3 months), (v) irregular, or (vi) no menarche. Responses ranging from (ii) to (vi) were categorized as menstrual abnormalities. Participants who responded 'yes' to having a past experience of a stress fracture (response options: yes/no/don't know) were considered to have had an HSF.

145 **BI-related indicators**

146 BI was assessed using the Japanese version of the body image scale (J-BIS) developed and examined for reliability and validity [10], which comprises 10 female 147 148 silhouettes. Participants selected the silhouette they considered best represented their 149 current-BI (C-BI) and their ideal-BI (I-BI). Using the BMI range (mean±standard error) 150 of each silhouette from a previous study [10], the silhouette number corresponding to a 151 participant's BMI was defined as the actual-BI (A-BI). The difference between the C-BI 152 and A-BI was defined as 'BI distortion' (BI distortion: overestimation if >0, 153 underestimation if <0) [11,12].

The survey also included items on weight control behavior based on BI, such as the frequency of weighing (\geq 5 times per week, 3–4 times per week, 1–2 times per week, or never) and weight loss experience (currently attempting to lose weight, not currently but have attempted to lose weight in the past, or neither currently nor in the past).

159 **Eating behaviors**

EDs were assessed using the eating attitudes test (EAT-26), a validated screening tool [13,14] for abnormal eating behaviors [15,16]. This test consists of 26 questions rated on a six-point Likert scale ranging from 0 to 3 (3, always; 2, almost always; 1, frequently; 0, rarely, almost never, or never). Results were analyzed using reverse scoring, with a global score of >20 indicating high risk of an ED.

Additional items included self-evaluation of food intake (response options: consistent with consumption, more than consumption, less than consumption, and don't know), the frequency of skipping breakfast ≥ 3 times a week (yes/no), and eating dinner ≥ 2 h before bedtime ≥ 3 times a week (yes/no). Respondents also reported the frequency of staple food intake, specifying how many times per week they consumed rice (1 bowl per serving), bread (1 slice of a 6-slice loaf per serving), and noodles (1 bowl or 1 plate per serving).

173 Sample size

The sample size was calculated using the "pwr" R package, as no previous studies were available to determine the effect size. Thus, the following parameters were used: number of groups = 3, alpha = 0.05, power = 0.8, and effect size = 0.4 (considered large). Based on these inputs, 22 participants per group were required, resulting in a total of 66 participants.

180 Statistical analysis

181 All analyses were conducted using IBM SPSS Statistics version 28.0 for
182 Microsoft Windows (IBM, Tokyo) software. Normality was assessed using a Shapiro-

183 Wilk test prior to performing statistical analyses. Group comparisons were undertaken 184 using one-way analysis of variance (ANOVA) and a Kruskal-Wallis test, with Bonferroni 185 correction applied in the test thereafter. Chi-square tests were used to examine differences 186 between categorical variables. In logistic regression analysis, the dependent variable was 187 FAT (LEA, MD, and HSF; applicable=1, not applicable=0). The explanatory variables 188 included aesthetics (rhythmic gymnastics), which showed the highest FAT prevalence in 189 the three-group comparison, EDs (previously reported to be associated with FAT), and 190 BI distortion (a key research objective). Non-collinearity of the explanatory variables was 191 confirmed using Spearman's correlation coefficients (all <0.3) and collinearity statistics 192 (variance inflation factor, <10). For comparisons between rhythmic gymnasts and 193 volleyball groups, age and athletic experience were adjusted as potential confounding 194 factors. For comparisons between rhythmic gymnasts and non-athlete groups, only age 195 was adjusted. The significance level was set at <5% (two-sided test).

197 **Results**

198 Participant characteristics

Table 1 summarizes the basic characteristics of the female rhythmic gymnasts, volleyball players, and non-athletes. No significant differences were observed in school type, age, or athletic history among the groups. The rhythmic gymnasts were significantly shorter than the volleyball players (p<0.05) and had a notably lower mean weight (rhythmic gymnasts [46.3 ± 4.6 kg] vs. volleyball players [60.8±5.9 kg] vs. non-athletes [49.8±6.7 kg]), and BMI (rhythmic gymnasts [18.7±1.7 kg/m²] vs. volleyball players [21.0±1.4 kg/m²] vs. non-athletes [19.9±2.4 kg/m²]) (p<0.001).

Prevalence of FAT 214

215 Fig 1A shows the results of a comparison in the prevalence of FAT among the three female groups. The prevalence of LEA (rhythmic gymnasts [51.3%] vs. volleyball 216 players [2.2%] vs. non-athletes [29.0%]) and MD (rhythmic gymnasts [64.1%] vs. 217

218	volleyball players [43.5%] vs. non-athletes [26.2%]) was significantly higher in the
219	rhythmic gymnasts ($p < 0.001$). There was no significant difference in the rate of HSF
220	among the three groups. Fig 1B shows the percentage of participants who met FAT
221	criteria for each number of items. The percentage of participants who met FAT criteria in
222	two items was significantly higher in the group of rhythmic gymnasts than in the other
223	two groups (rhythmic gymnasts [43.6%] vs. volleyball players [13.0%] vs. non-athletes
224	[16.8%], $p < 0.05$), and the percentage of participants who did not meet any FAT criteria
225	was significantly lower in the group of rhythmic gymnasts than in the other two groups
226	(rhythmic gymnasts [15.4%] vs. volleyball players [41.3%] vs. non-athletes [43.0%],
227	<i>p</i> <0.05).

240 Intergroup comparisons for BI and eating behaviors

Table 2 shows a comparison between BI and eating behaviors across the three groups. Significant differences were observed in I-BI scores, with the rhythmic gymnasts reporting a significantly lower score than those in the other two groups (rhythmic gymnasts [2.8±0.9] vs. volleyball players [4.4±0.9] vs. non-athletes [3.8±1.2], p<0.001).

- Additionally, the BI distortion score was significantly higher in the rhythmic gymnasts
- compared with the volleyball players (rhythmic gymnasts [0.7±1.2] vs. volleyball players
- [-1.0 \pm 1.1] vs. non-athletes [0.2 \pm 1.4], p<0.001), indicating that the rhythmic gymnasts
- 248 overestimated their body shape.

260 The proportion of participants who overestimated their body shape was significantly 261 higher in the rhythmic gymnasts (55.0%) than in the volleyball players (6.5%) (p < 0.05) 262 and non-athletes (38.0%) (p<0.05). The proportion of individuals who measured their 263 weight ≥ 5 times a week was significantly higher in the rhythmic gymnasts (87.5%) than 264 in the volleyball players (37.0%) and the non-athletes (22.2%) (p<0.001). Furthermore, 265 the rhythmic gymnasts had a significantly higher percentage of individuals who had 266 experienced weight loss (52.5%) compared with the volleyball players (8.7%) and the 267 non-athletes (23.1%) (*p*=0.005).

In terms of eating behaviors, the rhythmic gymnasts had a significantly higher EAT-26 score than those in the other groups (rhythmic gymnasts [15.7±13.1] vs. volleyball players [8.9±8.3] vs. non-athletes [6.6±6.3], p<0.001). The percentage of participants who self-evaluated their food intake as exceeding their consumption

272 (overeating) was significantly higher in the rhythmic gymnasts (27.5%) compared with 273 the volleyball players (4.3%) (p<0.001). The percentage of participants who skipped 274 breakfast ≥ 3 times a week was also significantly higher in the rhythmic gymnasts (30.0%) 275 compared with the non-athletes (12.0%) (p=0.032). The percentage of participants who 276 ate dinner 2 h before bedtime was significantly higher in both the rhythmic gymnasts 277 (47.5%) and the volleyball players (71.7%) compared with the non-athletes (24.1%) 278 (p < 0.001). The rhythmic gymnasts consumed rice less frequently than those in the other 279 two groups, but this difference did not reach statistical significance (p=0.058).

281 FAT-related factors

282 Table 3 presents the results of the multivariate logistic regression analysis in 283 relation to each FAT component as a dependent variable. In a comparison between 284 rhythmic gymnasts and volleyball players (n=86), LEA was independently associated 285 with being a rhythmic gymnast and with overestimation of body shape. MD was 286 independently associated with high EAT-26 scores. No significant association was found 287 for HSF. In a comparison between rhythmic gymnasts and non-athletes (n=148), LEA 288 was independently associated with being a rhythmic gymnast and with overestimation of 289 body shape. MD was independently associated with being a rhythmic gymnast and with 290 high EAT-26 scores. HSF was independently associated with high EAT-26 scores.

297 **Discussion**

The results of this study showed that female rhythmic gymnasts were thinner 298 299 than both female volleyball players and non-athletes and exhibited a higher prevalence of 300 each FAT component-related sign, particularly LEA and MD. Rhythmic gymnasts, 301 similar to non-athletes, reported a greater overestimation of their own body shape 302 compared with female volleyball players. Furthermore, logistic regression analysis 303 revealed that being a rhythmic gymnast, overestimating body shape, and engaging in 304 eating disorder-related eating behaviors were independently associated with LEA or MD. 305 We identified a significantly higher prevalence of each FAT component, 306 especially LEA and MD, among the rhythmic gymnasts. Approximately 50% of the 307 rhythmic gymnasts met \geq 2 FAT criteria. This finding is consistent with findings reported 308 elsewhere that indicate a higher prevalence of LEA (BMI <17.5 kg/m²) in Japanese 309 university athletes of aesthetic sports (7.2%), which exceeds that of other sports [14] and 310 a greater proportion meeting multiple FAT criteria compared with athletes of other sports 311 [9]. The rigorous training and aesthetic demands of rhythmic gymnastics lead to increased 312 energy expenditure, while the need to maintain a specific BI often leads to insufficient 313 energy intake, thereby resulting in LEA.

The association between LEA and MD has been previously reported [5,17,18]. Irregularities and abnormalities in the menstrual cycle typically occur when energy expenditure from exercise exceeds energy intake over a certain period (relatively long), which is consistent with our findings. However, no significant difference in the prevalence of HSF was observed. Despite the high-impact nature of rhythmic gymnastics, which places substantial stress on joints and bones, it is possible that athletes of such

320 sports have higher bone density compared with those in non-impact sports such as 321 swimming or non-athletes [19,20]. Additionally, the effects on bone may manifest later 322 than concerns such as menstrual abnormalities [21]. Measuring bone density with highprecision equipment such as dual-energy x-ray absorptiometry may be necessary to detect 323 324 these issues. Furthermore, HSF is influenced by factors such as calcium and vitamin D 325 intake [22] and exercise intensity [9]. suggesting that further research is needed to account 326 for these variables. With regard to BI, >50% of the rhythmic gymnasts in this study 327 overestimated their body shape, which was a significantly higher proportion among 328 volleyball players. A previous study reported that Japanese non-athlete females also tend 329 to overestimate their body shape, particularly at a younger age, and that a desire to lose 330 weight among thin women (BMI <18.5 kg/m²) is associated with distorted BI perceptions [7]. Our study findings suggest that, similar to non-athlete women, rhythmic gymnasts' 331 332 overestimation of their body shape may exacerbate their desire to lose weight. 333 Additionally, rhythmic gymnasts had a lower BMI compared with volleyball players and 334 non-athletes, and their ideal body shape was notably slender. They also reported more 335 frequent weight measurement and the highest proportion of individuals currently dieting. 336 with >50% engaged in weight loss efforts. These results align with the findings of Bruin 337 et al. [23] that, despite having a lower BMI than the general population, female athletes 338 of aesthetic sports often have an increased desire to lose weight and engage in dieting 339 more frequently.

Distorted BI, body dissatisfaction, and weight concerns are well-documented risk factors for eating disorder. BI disturbances have been linked to eating disorder and weight loss behaviors in athletes [24,25] and, among athletes of aesthetic spots, the desire to present a "perfect" body shape is known to exacerbate tendencies toward eating

disorder [26]. In this study, rhythmic gymnasts exhibited higher EAT-26 scores, eating
disorder, and reported a higher frequency of skipping breakfast compared to the other two
groups, indicating disordered eating patterns. These findings suggest that the nature of
rhythmic gymnastics contributes to a belief among athletes that weight loss is necessary
for performance enhancement. This distorted BI perception may further intensify their
weight loss efforts, leading to inadequate eating behaviors such as food restriction.

350 Factors associated with the prevalence of each FAT components include 351 participation in rhythmic gymnasts, distorted BI, and eating behaviors linked to eating 352 disorder. Previous studies have identified inappropriate eating behaviors as risk factors 353 for FAT, noting that such behaviors can alter hormone levels, affect the reproductive 354 system, and ultimately disrupt the menstrual cycle, which may negatively affect bone health if not corrected [27]. This study similarly highlights that distorted BI contributes 355 to LEA, a primary factor in FAT. The results imply that rhythmic gymnasts' desire for a 356 357 lean body to enhance competitive performance, coupled with an overestimation of their 358 body shape, may precipitate the development of FAT. These findings underscore the need for targeted support for young female athletes in Japan, particularly rhythmic gymnasts, 359 360 to promote healthy BI and eating behaviors to prevent FAT.

This study had several limitations. We relied on an online survey in which participants reported their menstrual status and HSF without formal medical diagnosis. A detailed dietary survey was not conducted, meaning that energy availability was not quantitatively assessed. Despite these limitations, to the best of our knowledge, this study is the first to examine the prevalence of FAT and its association with BI among young female athletes involved in rhythmic gymnastics and volleyball and among non-athletes.

368 Conclusion

369	The prevalence of FAT (at least one or more components) was approximately
370	1.5 times higher among rhythmic gymnasts than among volleyball players and non-
371	athletes. Logistic regression analysis indicated that FAT-associated factors include
372	participation in rhythmic gymnasts, distorted BI, and eating behaviors linked to eating
373	disorder. These findings suggest that future support for appropriate body image and eating
374	behaviors among Japanese rhythmic gymnasts is required.


