### 70 Summary

What is already known on this topic:

- Cardiovascular diseases (CVDs) are the leading cause of global mortality, with a disproportionate burden in low- and middle-income countries.
- Modifiable risk factors, including diet and physical inactivity, significantly contribute to CVD prevalence.
- Limited research exists on the specific associations between these risk factors and CVDs in older adults in Sierra Leone.

What this study adds:

- This study provides evidence of significant associations between dietary habits, salt intake, physical activity levels, and physiological risk factors for CVD: hypertension, diabetes, and obesity among adults aged 40 and above in Bo District, Sierra Leone.

72 Non-communicable diseases (NCDs), including cardiovascular disease (CVD) are the leading causes of mortality worldwide, accounting for 78% of global deaths, constituting a 73 significant public health challenge <sup>1-4</sup>. foods <sup>9 10 17-21</sup> [10, 11, 20-23]. 145 To accurately reflect the urban-rural population ratio, the study aimed to include 700 urban and 1,300 rural participants. We purposively sampled the only two urban chiefdoms (Bo 146 City and Tikonko). 169 WHO-STEPS methodology provides a standardized framework for collecting, analysing, and

170 disseminating data on non-communicable diseases (NCDs) and their associated risk factors.

171 The household survey incorporated all three steps of the WHO-STEPS approach:

172 1. ### 198 **Demographic Information**

199 Demographic information included geographic area, sex, and age. Geographic area 200 was categorized as either rural or urban. Sex was classified as female or male. Age was 201 recorded both as a continuous variable and presented as a categorical variable, divided into five 202 groups: 40-49 years, 50-59 years, 60-69 years, 70-79 years, and 80+ years.

222 Physical activity levels were assessed based on self-reported hours of activity per week, 223 in accordance with previous studies<sup>21</sup>. Total hours and minutes of activity across work, travel, 224 and leisure domains were aggregated into two categories: less than 150 minutes per week 225 (inadequate moderate and vigorous physical activity (MVPA)) and 150 minutes or more per week (adequate MVPA). Physical inactivity was assessed by asking participants "Excluding 226 227 sleeping, how much time do you usually spend sitting or reclining on a typical day?" College London (reference: HR-17/18–7298). Consent to conduct the study in each area was sought from chiefs in each subdistrict or village prior to data collection. Written informed consent was obtained from all participants, with literate witnesses assisting in cases of illiteracy. Where signatures were not possible, thumbprints were used. Data used in the analysis was anonymized to protect participants' privacy

# 252 Statistical Analysis

Statistical analyses were performed using the Statistical Package for Social Sciences (SPSS) version 27 (IBM Corp., Armonk, NY, USA). Participants with missing data on lifestyle factors, outcome measures, or covariates were excluded from the analysis. Descriptive statistics, including frequencies (proportions) and means with standard deviations (SD), were used to summarize the data. The data were weighted using probability weights based on age and sex distributions from the 2015 Population and Housing Census for Bo District. ### 266 **Results**

267 Summary of population characteristics, cardiovascular conditions, and risk factors

After excluding 93 cases due to missing values, the final sample consisted of 1,978 individuals.
The sociodemographic characteristics of the unweighted and weighted study populations are
presented in Table 1.



274 Among the unweighted study participants, there were 878 men (44.4%) and 1,100 women 275 (55.6%). The majority of participants were between 40-49 years old (34.5%), had no formal 276 education (68.9%), and were married or cohabiting (68.5%). The weighted study population 277 characteristics were similar to those of the unweighted population.

Out of the 1,978 participants, 43.5% had at least one physiological risk factor for CVD, as shown in Table 2. A higher proportion of females (45.9%) compared with males (41.3%) reported having at least one of these conditions. Additionally, fewer rural dwellers (42.6%) had at least one condition compared with urban dwellers (45.0%).

Table 3 shows an increase in the odds of CVD physiological risk factors (Hypertension and Obesity) with an increasing number of behavioural factors; individuals with six behavioural risk factors had a significantly greater risk of hypertension (OR=2.15, 95% CI [1.88-2.44],

#### 334 Discussion

335 This study identified significant associations between various behavioural and 336 physiological risk factors for hypertension, diabetes, and obesity, highlighting important public 337 health implications for Sierra Leone. The findings underscore the necessity of reducing poor 338 dietary habits and increasing physical activity to mitigate the onset of these chronic conditions, 339 which aligns with global and regional health priorities such as Goal 3 of SDGs 2030. 340 Consistent with existing literature, our results underscore the protective role of adequate 341 fruit and vegetable intake. Participants who consumed fewer than five servings of fruits and

342 vegetables daily were found to have a higher likelihood of experiencing hypertension, diabetes,

343 and overweight/obesity. This pattern highlights the significant health risks associated with 344 inadequate fruit and vegetable intake. This finding aligns with prior studies that have demonstrated the association between higher fruit and vegetable consumption and reduced risk 345 346 of CVD, likely due to their high content of dietary fibre, vitamins, and minerals such as potassium and magnesium <sup>28-32</sup>. 347

348 Unexpectedly, our study found that higher salt intake was associated with lower odds 349 of hypertension but higher odds of diabetes and overweight/obesity. This finding contradicts established research. <sup>33</sup>Further research is needed to explore this relationship in the Sierra 350 351 Leonean context. Salt sensitivity is common among people of African descent, which makes it unlikely that this finding is a causal relationship $^{34-36}$ . 352

The association between physical inactivity and increased risk of diabetes and obesity 353 is well-documented <sup>37-42</sup>. Our study supports these findings, showing that participants with two 354 355 physical activity risk factors had higher odds of diabetes and overweight/obesity. This is 356 consistent with studies conducted in West African populations and underscores the need for interventions promoting physical activity to reduce the prevalence of these conditions <sup>38 43 44</sup>. 357

The results also align with Sullivan et al. <sup>45</sup>, who reported that US individuals with two 358 359 physical activity risk factors (sedentary for over three hours daily and low weekly physical activity) had twice the risk of diabetes compared to those with 0-1 physical activity risk factors. 360 361 Together, this suggests low weekly physical activity and daily sedentariness may play a 362 significant role in the onset and establishment of diabetes. Peoples' participation in physical 363 activity could be influenced by the built and natural environment in which they live and by personal factors such as gender, age, ability, and motivation. For Sierra Leoneans to be 364 365 physically active and reduce sedentary time, physical activity programs and interventions must be proposed for urban sector-based jobs while raising awareness of the harmful effects of 366 367 prolonged sitting.

Participants who consumed 2-3 sources of salt intake showed 1.8 times higher risk of obesity. After adjusting for confounders, such as location, sex and age, the current study found that 2-3 sources of salt intake were associated with a 21% higher risk of obesity. The findings agree with the broader literature that suggest high salt intake is associated with obesity <sup>46-49</sup>. In the case of Sierra Leone, it is likely that the drivers behind higher salt intake and obesity could be explained by increased consumption of processed calorie-dense foods, which can lead to excessive sodium intake <sup>46-50</sup>.

Our study contributes valuable insights into the epidemiology of CVD risk factors in sub-Saharan Africa, particularly in Sierra Leone. The findings suggest that urbanization and associated behaviour changes, such as consumption of processed foods and low physical activity, are contributing to the rising burden of CVDs in this region. Given the high prevalence of hypertension, diabetes, and obesity found in this study, targeted public health strategies are urgently needed to address these risk factors.

For Sierra Leone, specific interventions could include public health campaigns to raise awareness about the benefits of fruit and vegetable consumption and the risks associated with high salt intake. Policies to promote physical activity, such as creating exercise facilities and organizing community fitness events, could also be beneficial. Additionally, further research is needed to explore the complex interplay between behavioural, environmental, and genetic factors in the development of CVDs in this context.

### 388 Limitations of Current Research

This study has several limitations that must be acknowledged. First, the cross-sectional design limits our ability to infer causality, as it captures data at a single point in time and prevents establishing temporal relationships between exposure and outcome. Therefore, while associations can be identified, causation cannot be definitively determined.

393 Second, reliance on self-reported dietary and physical activity data introduces potential recall 394 bias and measurement errors. Participants might not accurately remember or report their dietary intake and physical activity levels, leading to misclassification and potential bias in the 395 396 findings. Although efforts were made to minimize these errors, such as using standardized 397 questionnaires and trained data collectors, the inherent limitations of self-report data remain. 398 Third, the study was conducted exclusively among Sierra Leonean adults aged 40 years and 399 above. This age restriction means that the findings may not be generalizable to younger 400 populations or to other regions with different demographic profiles. The focus on an older 401 population was driven by the higher prevalence of CVD risk factors in this age group, but future 402 studies should include a broader age range to enhance generalizability.

Additionally, the study did not account for all possible confounding variables. While key sociodemographic factors were adjusted for, other potential confounders, such as genetic predispositions, environmental exposures, and access to healthcare, were not included. These unmeasured confounders might have influenced the observed associations and should be considered in future research.

Finally, despite efforts to ensure accuracy, the possibility of dietary assessment measurement error by participants exists. Despite these limitations, the study provides important insights into the behavioural and physiological risk factors for CVDs in Sierra Leone and highlights areas for future research and public health interventions.

412 **Conclusion** 

In conclusion, this study reveals significant associations between dietary habits, physical activity levels, and three physiological risk factors for CVD; hypertension, diabetes, and obesity among adults in Bo District, Sierra Leone. The findings emphasize the critical need for targeted public health interventions aimed at promoting healthier dietary practices and increasing physical activity to mitigate the growing burden of CVDs in this region.

418	Addressing these modifiable risk factors through public health campaigns, policy
419	changes, and community-based interventions could significantly reduce the prevalence of
420	CVDs and improve overall population health. Additionally, the study highlights the importance
421	of further research to explore the complex interplay between behavioural, environmental, and
422	genetic factors in the development of CVDs.
423	By understanding and addressing the specific risk factors prevalent in Sierra Leone,
424	effective strategies can be developed to combat CVDs and contribute to the global efforts to
425	reduce the burden of non-communicable diseases. These efforts are crucial not only for
426	improving health outcomes but also for achieving sustainable development goals related to
427	health and well-being in low- and middle-income countries.

### 597 Prevalence of CVD Risk Factors by individual Behavioural factors

598 Participants who consumed fewer than five servings of fruits and vegetables daily 599 exhibited higher prevalence of hypertension (85.8% vs. 14.2%), diabetes (89% vs. 10.4%), and 600 overweight/obesity (84.7% vs. 15.3%) compared with those who met the recommended intake 601 of five servings per day (Table 1).

602 In contrast, participants with higher salt intake, defined as consuming salt from two or 603 three sources, demonstrated a lower prevalence of hypertension (46.1% vs. 53.9%) and overweight/obesity (47.1% vs. 52.9%) but a higher prevalence of diabetes (51.1% vs. 42.9%) 604 605 compared with those with lower salt intake.

606 Physical activity also had a significant association with the prevalence of physiological 607 CVD risk factors. Individuals with at least one physical activity risk factor (e.g., inadequate 608 moderate and vigorous physical activity (MVPA) or high levels of physical inactivity) showed 609 higher prevalence rates of hypertension (42.0% vs. 40.5%), diabetes (40.8% vs. 38.9%), and

610 overweight/obesity (44.4% vs. 41.8%) compared with those with no physical activity risk

611 factors (Table 1).

Sociodemographic characteristics were associated with the prevalence of physiological
CVD risk factors. Rural residents had a higher prevalence of diabetes and overweight/obesity
but a lower prevalence of hypertension compared with urban residents (Table 5). This variation
may reflect differences in behaviour and access to healthcare services between rural and urban
areas.

Sex differences were also apparent, with males exhibiting lower prevalence rates of hypertension (46.2% vs. 53.8%), diabetes (45.9% vs. 54.1%), and overweight/obesity (33.3% vs. 66.7%) compared with females. Age-wise, individuals aged 40-49 years had higher prevalence rates of hypertension (32.4%), diabetes (31.1%), and overweight/obesity (47.9%) compared to older age groups (Table 2). This suggests that middle-aged adults in this cohort may be at greater risk and highlights the need for targeted interventions.

### 632 **Physiological Risk Factors for CVD**

633 The results from the unadjusted regression analysis reveal that individuals consuming fewer

634 than five servings of fruits and vegetables daily had significantly higher odds of hypertension

635 (OR=1.62, 95% CI [1.56-1.69], p<0.001), diabetes (OR=1.82, 95% CI [1.54-2.15], p<0.001),

636 and overweight/obesity (OR=1.17, 95% CI [1.12-1.23], p<0.001) compared with those meeting

637 the recommended intake (Table 3).

638 In terms of salt intake, participants consuming salt from two or three sources had higher odds

of diabetes (OR=1.36, 95% CI [1.23-1.51], p<0.001) and overweight/obesity (OR=1.18, 95% 639

640 CI [1.14-1.22], p<0.001), but lower odds of hypertension (OR=0.94, 95% CI [0.91-0.97],

641 p<0.001) compared with those with lower salt intake. For physical activity, individuals with

642 two physical activity risk factors had significantly higher odds of hypertension (OR=2.40, 95% 643 CI [2.27-2.52], p<0.001), diabetes (OR=2.31, 95% CI [2.01-2.65], p<0.001), and 644 overweight/obesity (OR=1.26, 95% CI [1.19-1.34], p<0.001) compared with those with no 645 physical activity risk factors (Table 3).
