USING QUALITY IMPROVEMENT TOOLS TO REDUCE MACERATED STILLBIRTH BY 50% IN THE VOLTA REGION OF GHANA IN A TWO YEARS PERIOD

Abstract

Stillbirth rate is an indirect measure of the quality of management of pregnancy, labour and

delivery. The loss of a baby due to stillbirth does not only affect pregnant women but also takes a

great toll on family's health and wellbeing. In Ghana, stillbirths account for a large proportion of

perinatal mortalities. We used small multiple graphs to compare the rate of stillbirth in the Volta

region from (2014-2016) to the national target for stillbirth.

Inferences from the graph shows that there was a gap of 10.4 per 1,000 live births between the

national target of 12 per 1,000 live births. Fresh still birth also had a mean of 37.2 per 1000 live

births showing a gap of 25.2 between the national target. The gap between the national target and

macerated still birth is 50.8. This shows significant change in the stillbirth rate in the region and

requires attention. In view of this, this study aims to reduce stillbirth (macerated) by 50% in two

years period.

Stillbirth: is defined by the Ghana Health Service as a baby born with no signs of life at or after

twenty-eight (28) weeks of gestation.

Fresh stillbirth: total number of babies who died in the process of labour.

Macerated stillbirth: total number of babies who died in the uterus more than twelve hours

before delivery with signs of maceration.

Total stillbirth: total number of babies who were delivered without signs of live.

Total live birth: total number of babies born alive.

Neonatal death: babies dying twenty-eight (28) days of life.



Introduction

Stillbirths are a reflection of the quality of care given to women and newborns during antenatal and delivery (GHS annual report, 2016) is defined by the Ghana Health Service as a baby born with no signs of life at or after twenty-eight (28) weeks of gestation. The loss of a baby due to stillbirth takes a great toll on family's health and wellbeing, still birth remains a sad reality for many families (CDC, 2020). Maternal and Child health remains at the core of global health priorities transcending the Millennium Development Goals into the current era of Sustainable Development Goals. Most low and middle-income countries including Ghana are yet to achieve the required levels of reduction in child and maternal mortality (Id et al., 2020). Most stillbirths in LMIC are considered to be preventable through provision of quality care for all mothers and babies.(Aminu et al., 2019). Investing more in maternal care and the care of small and sick newborns during labour and childbirth is perhaps the most important step in saving the lives of mothers and newborns (EMEM guide, 2017). The two types of still birth are fresh and macerated stillbirth. Fresh stillbirth is the intrauterine death of a fetus during labor or delivery while macerated stillbirth is the intrauterine death of a fetus more than twelve hours of delivery with signs of maceration. Macerated stillbirth has many causes ranging from maternal diseases and infections, fetal complications lick problem with umbilical cord and emotional and psychological trauma or stress.

Problem Analysis Using the Pareto Principle

Pareto analysis is a simple technique using a bar graph to select the ideas for change that will have

the greatest overall effect on the problem we want to solve and improve. In using the Pareto

Analysis, we identified the causes that have the greatest impact on our main problem, which

assisted in determining where to focus our improvement efforts. The principle sets out that the

majority of results in any given situation will usually be determined by a small number of causes

(the 'law of the vital few'). Put simply, roughly 80% of results are determined by 20% of the

causes (also called the 80:20 rule).

How We Constructed Our Pareto Chart

We identified the problem and possible causes revealed by the five whys and problem tree QI

tools.

We collected data on the causes we identified by frequency

A table was created and the causes were ranked from largest to smallest.

We constructed a bar graph with the causes along the horizontal axis and the frequency on the

vertical axis.

We made a cumulative frequency graph by stacking the bars on top of each other in order of

frequency, with the most common cause at the bottom and the least common at the top.

We then observed which causes accounted for the majority of the problem by looking for those

that make up approximately 80% of the total number of causes counted.

Table 1 above shows the collated data for the Pareto analysis. Out of a total of 100%, the 'total number of occasions column' shows the percentage occurrence of a cause. The percentage occurrence is assumed for the purpose of the study.

Figure 1.1: A Bar Chart Showing Reasons for Increase in macerated Still birth rate in the eight facilities in the Volta Region





Figure 1.2: Cumulative Bar Chart Showing the Reasons for Increase in macerated Stillbirth Rate in Volta Region



By using the Pareto analysis, we have realized that only four out of the seven root causes are

responsible for 80% of the problem. These four causes are Lack of reproductive health education

in Volta Region, inconsistent visit to ANC, psychological and emotional stress and unhealthy

lifestyle of pregnant women. By focusing much effort and resources solving these four problems,

we would be actually solving 80% of the problem.

Using the Brainstorming and Affinity Grouping QI Tools to Generate Ideas and Solutions

Brainstorming is an idea generation tool designed to produce a large number of ideas through the

interaction of a group of people. An affinity diagram is a way to organize ideas into coherent

patterns or themes, based on their natural relationship. It encourages people to think inventively

and make non-traditional connections between ideas. It is especially useful at stages where you

have generated a large volume of ideas.

Our team brainstormed using brainstorming as a QI tool and came out with strategic solutions to

the various causes of the high increase in the rate of macerated stillbirth in the Volta Region. The

ideas and solutions generated were organized into coherent themes based on their natural

relationships. The organization of ideas was based on the affinity grouping. The diagram is shown

below.

The ideas generated using the brainstorming tool were displayed by posting them in random order

on a table.

Without talking, we sorted the ideas into related groups:

First, we looked for two ideas that seem to be related in some way and placed them in a separate

group.

We continued to sort through the notes, establishing new groups or adding notes to existing groups.

We kept doing this till the process was complete. That is, when all the notes had been assigned to a group.

We created a title for each group that captures the relationship between the ideas contained in the notes.

Once the sorting process had been completed, we reviewed the results together.

The final solutions were decided and their details were put in a table. The table is shown below:








Figure 1.3 above, shows the rate of stillbirth following skilled delivery in the volta region from 2014 to 2018. From the graph, the mean for the rate of still birth in the volta region from 2014 to 2018 was 22.4/1000 livebirth. This means that out of 1000 livebirths, the rate of newborns who died during or before delivery was 22.4 which is above the sustainable development goal's national target of 12/1000 livebirths. Inferences from figure 1.3 shows a gap of 10.4/1000 between the national target and the mean from 2014-2018. The highest rate was recorded in October 2014 and the lowest recorded in June 2017. Aslo, figure 1.4 above, shows the result for the fresh still birth as a percentage of the total stillbirth in the volta region from 2014 to 2018. From the graph, the mean for fresh stillbirth as a percatage of the total stillbrith was 37.2 which suggests that out the total number of babies who died in the eight (8)selected facilities in the volta region, 37.2% of them were fresh (ie, occurred during delivery). This result is far above the sustainable development goal's national target of of 12/1000 livebirths. Inferences from figure 1.4 shows a gap of 25.2 between the national target and the mean from 2014-2018 in the volta region. The hihest percentage was recorded in February 2016 and the lowest percentage in May 2017. Finally, figure 1.5 above, shows the result for macerated stillbirtha as percentage of the total stillbirth in the volta region from 2014-2018. From the graph, the mean for fresh still birth as a percentage of the total stillbirth from 2014-2018 was 62.8 which suggest that between the years of 2014 to 2018 in the eight seleted facilities in the volta region, 62.6% of the total number of babies who died were macerated (ie, occurred before delivery). This result greatly exceeds the sustainable development goal's national target of 12/1000 livebirths. Inferences from the grapg suggest a huge gap of 50.8 between the mean of macerated still bith for volta region between the years odf 2014 to 2018 and

the national target. The highest percentage was recorded in May 2017 and the lowest percentage

in February 2016.

Looking at the three inferences drawn from figure 1,3, 1.4 and 1.5 above, it is clear that the most

problematic indicator in the volta region from 2014 to 2018 was macerated stillbirth. The gap

between the mean of macerated stillbirth (50,8) and the national target (12/1000) was twice the

gap between the mean of mean of fresh stillbirth (25.2) and the national target (12/1000).

In view of this infernces, the group identified macerated stillbirth as the most problematic indicator

and hence decided to develop strategies using PDSA QI tool to reduce the rate of macerated

stillbirth in the volta region by 50% in two years period.







Discussion on Institutional Neonatal Run Charts.

Figure 1.6 above, shows the rate of institutional neonatal death in the Volta Region from 2014 to 2018. From the graph, it can be seen that the mean for institutional neonatal death in the Volta Region from 2014 to 2018 was 11.4 which is below the national target of 12/1000 live birth. If we are to use the national target as of 2021 which was 8.0/1000 live births, the gap between the mean of the institutional neonatal death in the Volta Region from 2014-2018 and the national target will be 3.4. This is not on the bad side as compared to the gap between the national target for macerated stillbirth (12/1000 live births) and the mean in the Volta Region from 2014 to 2018 which is 50.8. Also, figure 1.7 above shows the number of babies referred in the Volta Region between the years of 2014 to 2016. From the graph the mean for babies referred in the stated period was 8.7. This means that between the years of 2104 to 2018 in the Volta Region only 8 babies were referred from the eight (8) selected facilities.



to help reduce the stillbirth rate at marry Lucy Hospital. It consists of two parts; a thinking part

and a doing part. Using the PDSA QI tool, we set our aims, define measurements, find promising

ideas for change, and test those ideas in real work.









Change agents are the ambassadors who can smooth the road by helping staff understand the

benefits of this program. Barriers always occur during a change process; thus, the change agent

needs to be alert and ready to help the staff work through the problems. The change agent also will

work with management to assure needed resources are available and the required approvals are

obtained.

We therefore determined what modifications should be made, mitigated high level risk and decided

to plan our next test.





PHASE 4 (ACT)

Introduction

Implementing any change requires thoughtful planning. People resisting change is a common experience. Implementation of an intervention can be done in variety of ways, including adapting or developing policies and procedures, communication of the standards, conducting training programs, coaching/mentoring, providing supportive supervision and engaging the community to play their part in improving the quality of maternal and newborn health care. Prior to implementing these strategies, steps must be taken to prepare the health facility to make the changes needed to improve the quality of care and services. The intervention implemented in chapter three above, was to help reduce the rate macerated stillbirth by 50% at the selected hospitals in the Volta Region, the success of the intervention will reduce the mean from the initial 62.8 to about 31.4. After the intervention, we were able to reduce it by additional 10% bring the mean down from 31.4 to 21.4. We therefore decided as a group to adapt to this intervention as it will really help reduce macerated stillbirth to a really significant level and if possible, extends this program to the whole Volta Region. People are more likely to accept change if they see the need for the intervention and this result means that the people of the Volta Region saw a need for this intervention and hence accepted it.

The graph below shows the results for the rate of macerated still birth before and after the intervention



Recommendations.

- There should be regular education for ANC clients and relatives on Pregnancy care
- There should be a regular home visit to see how client are doing on Pregnancy care
- There should constant awareness on the effect of psychological and emotional stress on pregnant women.
- All stakeholders should be engaged in the quarterly Health Committee Meetings.

Lessons Learnt

• Most healthcare professionals still need to be train on how to educate mothers who are

unaware of how to live a healthy lifestyle for safe pregnancy.

• Most pregnant women were ignorant about their intake of food and drugs

• Initially thought pregnant women may not adhere to the education but they did.

• Getting funds were very difficult

• Pregnant women and mothers were very pleased with the intervention made

Conclusion

In conclusion the use of the PDSA model helped reduce the rate of macerated still birth from

62.8per 1000 live births to 21.4 per 1000 live births. Implementing any change requires

thoughtful planning. People resisting change is a common experience. Implementation of an

intervention can be done in variety of ways, including adapting or developing policies and

procedures, communication of the standards, engaging the community to play their part in

improving the quality of maternal and newborn health care. A few families and pregnant

women are still adamant and were not ready to change and this accounts to the reason why

we were not able to reduce the rate of macerated stillbirth to the national target of 12/1000

live births or below. For effectiveness of the project a monthly and quarterly evaluation was

done for do a good job. There is a room for improvement.
