# Title: Aeromedical Retrieval of Critically Ill Pulmonary Embolism Patients: A Protocol for a Retrospective Cohort Study of 10 Years in New South Wales

### Abstract:

**Background:** Pulmonary embolism is a common, time critical condition care requiring multidisciplinary care. Interhospital transport is a high-risk period in the patients' care, but offers an opportunity for expedited risk stratification, resuscitation and transport to definitive care. Patients who require interhospital transfer to specialist centres for pulmonary embolism management have worse outcomes. Despite this, literature surrounding the medical retrieval practice and experience of pulmonary embolism is limited.

Methods: A retrospective cohort study over a 10-year period from January 2014-September 2024 from the database of a high-volume aeromedical retrieval service in New South Wales, Australia will be performed. The study aims to describe the experience in this service in the care of critically ill pulmonary embolism patients requiring interhospital transport.

## **Background:**

Pulmonary embolism (PE) is a common and life-threatening condition. PE has had 30day mortality of 17.6%-26.5% reported irrespective of severity of initial illness [1]. In Australia, PE and deep vein thrombosis (DVT) has an annual incidence of 0.83 per 1000 population, with an estimated cost of \$1.7 billion to the Australian community in 2008 [2].

Treatment modalities for PE have expanded rapidly in recent years, ranging from anticoagulation to catheter-based therapies, surgical embolectomy, extracorporeal membrane oxygenation (ECMO) and systemic thrombolysis. Risk stratification is essential in guiding the need for increasingly invasive interventions. Guidelines differ with regards to optimal risk stratification, particularly in the submassive or intermediate cohort, where treatment may differ significantly [3,4]. This increased complexity in what is frequently a time critical condition has led to the introduction of Pulmonary Embolism Response Teams (PERT) in the United States [5]. These teams serve to allow key senior decision makers, including respiratory physicians, emergency physicians, intensivists, haematologists, interventional radiologists, cardiac surgeons and cardiologists to guide care in a rapid and coordinated fashion. Observational data from established services imply a mortality benefit and reduced hospital length of stay associated with well-coordinated PERT teams. These systems have recently begun to be implemented in Australia, with individualised approaches for a large metropolitan Sydney hospital [6] and a regional Queensland hospital [7].

The PERT Consortium has identified the coordination and care of patients with PE requiring interhospital transfer as a high-risk period and an area in need of research [8]. Patients requiring interhospital transfer for the management of their PE are recognised to have a higher mortality than patients that present directly to specialist centres [9]. To date, to the best of our knowledge, no literature exists regarding the clinical experience of the management of critically ill PE patients during interhospital transfer by medical retrieval services. In New South Wales (NSW), aeromedical retrieval teams (NSWA-AO)

transfer patients from a wide range of care facilities across the state to definitive care, including rural, regional and metropolitan interhospital transfers. These referring centres have a wide range of clinical capacities, ranging from rural nurse run clinics to metropolitan intensive care units. This service is frequently the first point of senior critical care contact a patient may have during their healthcare presentation, and therefore represents an opportunity to initiate earlier risk stratification, resuscitation and coordination of PE care, whilst aiming to provide safe transport to definitive care at an appropriate receiving centre. Transport distances by the service varies greatly.

Given the lack of current available literature, and variations in published guidelines, this study will aim to describe the clinical experience of three NSW Aeromedical Retrieval Service bases over the preceding 10 years in caring for critically ill PE patients during their interhospital retrieval.

## Methodology:

This manuscript outlines the protocol for a multi-base retrospective cohort study of NSW Ambulance aeromedical database, AirMaestro (Avinet, Australia), from January 2014 to September 2024. This study will be performed in accordance with the STROBE guidelines [10].

## **Primary Objective:**

1. A descriptive summary of all patients retrieved by NSWA-AO for the primary reason of pulmonary embolism.

## **Secondary Objectives:**

2. Describe the risk stratification of patients with PE requiring intrahospital transport according to the ESC classification of PE severity.

- 3. Describe the pretransfer optimisation provided in patients with PE including anticoagulation, thrombolysis, respiratory support, cardiovascular support and general supportive critical care prior to departure.
- 4. Describe the characteristics of referring and receiving hospitals involved in the interhospital transfer of patients with PE.
- Described the post-retrieval management of these patients, including the need for systemic thrombolysis, ECMO support, interventional radiology-based therapies (e.g., catheter directed thrombolysis, catheter embolectomy, IVC filter) or surgical embolectomy.
- Describe the complications encountered by the medical retrieval team transporting pulmonary embolism patients, including cardiac arrest, bleeding complications, clinically significant hypotension and clinically significant hypoxia.

## **Inclusion Criteria:**

- 1. Pulmonary embolism for interhospital transfer requiring aeromedical retrieval between January 2014-September 2024.
- 2. Retrieval facilitated by Sydney, Orange and Wollongong aeromedical bases.
- 3. Pulmonary embolism representing the primary indication for interhospital transfer, or a diagnosis of acute pulmonary embolism complicating the treatment in an alternative diagnosis.

## **Exclusion Criteria:**

- History of pulmonary embolism not currently contributing to the decision to transfer the patient
- 2. Septic pulmonary embolism because of likely infective endocarditis, being transferred for the primary indication of management of infective endocarditis.
- 3. Low risk pulmonary embolism complicating an alternative diagnosis with no influence on the care required by the patient.
- 4. Retrieval facilitated by bases other than Sydney, Wollongong or Orange.

5. Prehospital cases of pulmonary embolism responded to by medical retrieval team.

#### Ethics

This study was granted ethics approval by the South Western Sydney Local Health District Human Research Ethics Committee (SWSLHD HREC). Ethics approval was granted on 1/11/2024 for as Low and Negligible Risk research with a waiver of consent (2024/ETH02380). A waiver of participant consent was sought as this study is retrospective and non-invasive in that it uses demographic, physiological and patient treatment records which is measured routinely as part of clinical care and analyses the predictive power of these data in relation to later outcomes. This data will not be changed or used in any other way than for the purpose of this study. No other data on the recruited patients will be collected in addition to that used in routine patient assessment and management and routine 24 hours follow up. Once clinical data collected, the patients will be de-identified, and data stored with patients allocated a unique study number.

There is no risk to the rights, privacy or professional reputation of carers, health professionals and/or institutions as the study concerns the care of a common clinical presentation with recognised complexity and common treatment pathways and has no intent to identify individual clinicians or carers, nor to use the data as commentary on the institutions concerned. There is no specific participation required by participants. With patient data being completely de-identified during the analysis there are no specific safety considerations to participants.

#### **Data Collection:**

The AirMaestro database will be searched from January 2014 to September 2024. This database will be searched for all cases that were classified by the diagnostic category 'Pulmonary Embolism'. A secondary search of the database will be performed for any cases including the phrases "pulmonary embolus", "PE", "thrombolysis", and

"submassive". Results will be screened for inclusion and exclusion criteria prior to data extraction.

Anonymised data will be extracted from Air Maestro directly into RedCAP [11,12], including utilising contemporaneous notes, any scanned documents such as observation strips or case sheets, and 24hr follow up on Air Maestro. Table 1 represents the Data Extraction Form, and the ability to add free text will be available for each variable. Where free text is added, two authors will independently review this free text to ensure the extracted variable is accurate and represents the intended data.

All data will be entered and stored using REDCap software. REDCap is a data collection and storage software hosted on the NSW Ambulance internal server and not accessible to persons outside of the organisation. REDCap meets the United States Health Insurance Portability and Accountability Act of 1996 security requirements. REDCap also has a file repository. Any paper records generated by this study will be scanned and uploaded to the REDCap software and hardcopies will be kept in a secure filing cabinet in the Research Governance office. All electronic data and hardcopy files will be kept for a minimum of seven years and then destroyed securely. At the time of writing this protocol there is no foreseen secondary use of these data following study completion.

## **Data Processing and Analysis:**

Data analysis will be limited to simple descriptive and frequentist statistics and performed using STATA 18 [13]. Baseline characteristics and demographics were described using median and interquartile range (IQR) for non-normally distributed

continuous and ordinal variables. Counts and proportions were presented for

dichotomous variables.
