#### Abstract 30

31 The transferability of music education to cognitive and social skills has been explored recently, 32 but its causal effects remain debatable. This guasi-experimental study aimed to examine the 33 impact of a music education program (Guri) on aspects attention, working memory and 34 socioemotional skills in children from underserved communities of São Paulo, Brazil. The music 35 group (n = 38, 5-9 years) was recruited from 10 centers (*polos*) distributed across the 36 metropolitan area of São Paulo and the control group (n = 67) consisted of aged-matched children who attended public schools surrounding the polos. The ABEP SES questionnaire and 37 38 the Raven test were used as control variables, the SDQ questionnaire, the Digit-span subtest 39 from WISC-IV, the PARB-Q questionnaire, and the BPA test were used as subject variables. A 40 significant effect of the intervention in emotional symptoms in the music group as opposed to 41 controls was found (F(1,89) = 4.562, p = 0.035,  $\eta^2 = 0.049$ ), indicating benefits for the music group. Children whose mothers had low levels of education benefited with gains between 0.70 42 43 and 0.95 standard deviations in both groups for divided attention, indicating a significant 44 interaction with maternal education.

#### Introduction 46

#### Music education and executive functions 47

48 The hypothesis of the effects of music education practice on cognitive abilities and 49 brain plasticity, with potential far transferability to other domains, has been the focus of 50 several studies published in the last decade (1-11). While some studies suggest that abilities 51 related to executive functions (EFs) are particularly enhanced by musical training (2-4), others 52 remain inconclusive (11, 12). Yet inhibitory control, one of the central dimensions of EFs, 53 appears to be a consensus in terms of its transferability from music education/music training, 54 especially among preschoolers (12). 55 EFs consist of a set of abilities that promote goal-directed and autonomous behavior, 56 and are crucial to stablish day-to-day goals as well as more complex and long-time planning 57 (13-17). Although validated models of EFs are still controversial (14, 18, 19), there are 58 commonalities among proposed theoretical models, including dimensions such as attention, 59 inhibitory control, working memory (WM), fluid intelligence, problem solving, decision making, 60 and cognitive flexibility.

61	EFs can be classified as <i>hot</i> , or those associated with emotional and social cognitive
62	aspects relevant to decision-making process, or cold, which are linked to mental abilities
63	involved in inhibitory control, WM, short-term memory (STM), reasoning and planning (20,
64	21). Cold EF tasks require mental effort and constant top-down supervision of the pre-frontal
65	cortex (PFC) to prevent automatic actions (16).

66 According to Diamond's model (17), and despite belonging to EF cold domains, attention, a subdomain of inhibitory control, can be affected by emotional and cognitive self-67 68 regulation (22, 23). Attention requires effort and volition and, therefore, can also be involved 69 in both hot and cold EFs depending on the type of stimulus to be inhibited (e.g., self-control in 70 delayed gratification or resistance to a distractor in attentional focus). The two types of 71 attention (*i.e.*, emotional and cognitive) may not necessarily fall under the same factor, but are 72 strongly correlated (17, 24). Petersen and Posner (23) updated their model of attention (22) to 73 include three major networks: alerting, orienting, and executive networks. The latter further 74 includes focal attention and regulation of processing networks.

75 Attention can also be classified according to the type of task at hand: (1) sustained 76 attention/focused (*i.e.*, maintaining focus on a single stimulus/task over time), (2) divided 77 attention (*i.e.*, concentrating on two or more stimuli/tasks simultaneously for a given time), 78 and (3) shifting/alternated attention (*i.e.*, change the focus of the attention to the perceptual 79 attributes of the stimuli under relevant stimulus-response maps rules) (25, 26). Attention also 80 plays an important role in WM, another dimension of cold EF that requires processing and 81 storage, sharing cognitive resources from both (27). Therefore, it is necessary to maintain a 82 focus of attention by inhibiting the preponderant stimulus to prioritize information and allow 83 updates of the environment, and subsequently coordinating them with automated responses 84 in the use of WM. All this happens while new associations are created in STM.

85 A meta-analysis by Talamini et al. (8) found a large musician advantage for STM and 86 WM with tonal stimuli, a moderate effect with verbal stimuli, and a non-significant effect with 87 visuospatial stimuli. The systematic review of Rodriguez-Gomez and Talero-Gutierrez (12) 88 examining the associations between WM and music training revealed three studies among 89 eight that showed improvement in one subdomain (*i.e.*, either visual or spatial) following a music intervention with children. Additionally, in four studies reviewed by the authors, music 90 91 education was found to improve selective attention among children, although only one study 92 showed statistical significance. Furthermore, out of nine studies conducted with preschool-age 93 children, six presented improvements in inhibitory control following music education. From 94 these studies, one can assume that verbal WM may be a strong candidate for music education 95 effects, as seen with selective attention.

### 96 Hot executive functions, social competence, and social skills

97 Hot EFs are far less researched than cold EFs, even though psychometric instruments 98 that consider level of affection, emotion self-regulation, affect decision making, empathy, and 99 delayed gratification are often used in studies (15). One of the reasons for the lower incidence 100 of articles on hot EFs might be the entanglements between the concept of hot EFs and the 101 constructs of social competence, social skills and self-regulation. For Zimmerman et al. (20), 102 "hot executive functions entail cognitive abilities supported by emotional awarness and social 103 perception (e.g. social cognition)." The authors adapted their concept from the models of Chan 104 et al. (28), and McDonald (29), placing social cognition on one side, and emotion cognition and 105 decision making on the other, and subsequently positioning all under the umbrella of hot EFs. 106 Social cognition, in turn, was also further divided into cold (*i.e.*, cognitive empathy and theory 107 of mind) and hot (*i.e.* affective empathy and theory of mind, and emotion recognition) aspects 108 (20). For example, while one person may make decisions based on understanding other

people's cues, others may arrive at decisions based on their *affections*. Unsurprisingly, bothcold and hot social cognition have neural correlates (30-32).

Social competence has been referred to as the ability to maintain positive relationships while persuing personal goals (33). For Hukkelberg et al. (34), whereas social competence is a broad term, social skills can be situated within more specific behaviors, as the latter can be examined through observable variables that compound a social competence factor (35-38).

Both social skills and social competence are positively correlated with academic achievement and problem solving skills (35, 38, 39), and have been associated with positive mental health (35, 38). Social skills can be measured with scales and subscales that address cooperation, self-control, internalizing and externalizing problem behaviors, empathy and hyperactivity (35, 38, 39).

### 120 Social skills and music

Associations between emotion self-regulation, prosocial skills, and music are still under 121 122 scrutiny. While some studies observed effects of musical interventions on prosocial skills in 123 preschoolers and school-aged children (40-42), others found moderate to null effects (11, 43, 124 44). Still other studies found effects of music education only on selected social skills of children 125 and youth. Villanueva et al. (45), for example, found effects of formal music instruction on 126 children's sharing behaviors, theory of mind, and state empathy. Alemán et al. (11), in turn, 127 found a significant improvement in behavioral difficulties detected via parental questionnaires 128 and scales, especially among male children who had experienced violence and had mothers 129 with low levels of formal education. Also using a parental scale, Ilari et al. (46) found a 130 significant effect of four years of music education on children's aggressiveness and 131 hyperactivity. Similarly, Boal-Palheiros and Ilari (38) found effects of one year of music 132 education on externalizing behavioral problems in Portuguese children from underserved

133 communities. Thus, current evidence is mixed and needs further substantiation, and this is

134 particularly true in the case of children from non-WEIRD (i.e., non-White, from English

135 speaking, industrialized, rich and democratic) populations (47) and those at risk for behavioral

136 problems.

### 138 The present study

139 This study aims to contribute towards the area of music education through an 140 examination of its impact on specific cognitive and socioemotional outcomes among children 141 at risk for behavioral problems. This quasi-experimental investigation adds to the body of 142 knowledge derived from cross-sectional and correlational research that found evidence 143 supporting beneficial effects of music education in the target outcomes. Particularly, we focus 144 on aspects of attention (shifting, divided, and sustained) and aggressive behavior, by 145 comparing test results from a group of children who participated in formal music classes to 146 matched controls. 147 As noted, most of the studies examining the associations between music, EFs, and 148 social skills were conducted in the global North, predominantly in North America and Western 149 Europe and with WEIRD populations (47). This study<sup>1</sup> aimed to investigate whether 150 participation in a musical program called Projeto Guri (48) designed to serve low-income 151 communities in the city of São Paulo, Brazil, conferred any benefits to children's cognitive and 152 social skills, including those who were at risk for behavioral problems. 153

### 154 Method

### 155 Ethics

- 156 All research protocols were approved by the local Ethical Committee *Plataforma Brasil*
- 157 n. 15049919.8.0000.5420, and the Rebec n. U1111-1243-8071. Written consent was also
- 158 obtained from the municipality of São Paulo. A Memorandum of Understanding was created
- 159 between the State University of São Paulo (Unesp) and the Guri Program, outlining the
- 160 specifics of the research, expectations, and obligations from all involved parts.

### 161 Sample and recruitment

162 Children and their families were invited to participate in the study through their music

163 programs (Guri polos) and local schools. Due to ethical reasons related to the policies of

164 enrollment in the Guri Program, it was not possible to randomize child participants into music

and control groups.<sup>2</sup> Therefore, we performed an intervention study based on a quasi-

166 experimental design, which took place in 2022 during the Brazilian academic year—February

167 through December.<sup>3</sup> The researchers responsible for the statistical analyzes were blinded to

168 the participants. The examiners were also blinded to those who analyzed the outcomes. The

169 target music group consisted of children aged 5 to 9 years,<sup>4</sup> who were about to start music

- 170 classes for the first time in the Guri Program (48). This Program consists of a network of
- 171 various centers –called *polos* distributed across the metropolitan area of São Paulo, also
- 172 known as Grande São Paulo. Most of the polos are located in the outskirts of the city and
- 173 function within a public system of integrated schools called *Centros Educacionais Unificados*

(Unified Educational Centers) or CEUs. Children in the music group were recruited from 10
different *polos*: 7 from the extreme east part of the city, which is also the most populated, 3
from the extreme south, and 2 from the extreme north. Beginning music classes take place
weekly for one hour through a modality known as *musicalização* (49), a form of general music
that is carried out through collective singing, movement, and performance of rhythms and
melodies, using small percussion instruments, recorders, and Orff xylophones and
metallophones.

181 The control group consisted of aged-matched children who attended regular schools 182 surrounding the Guri polos. Exclusion criteria for sample recruitment in both groups were: 1) 183 children had attended regular school music classes or instrumental/voice lessons before, and 184 2) children had received a diagnosis of ASD (Autism Spectrum Disorders) or ADHD (Attention 185 Deficit Hyperactivity Disorder). Children in the experimental group were recruited at the time 186 of enrollment in the Guri Program, when parents/guardians were informed about the study 187 and given consent forms. After signing consent forms, parents were invited to complete the 188 SDQ-parent version (50, 51) and the ABEP questionnaire (52) that assesses socioeconomic 189 status. This procedure constituted the first screening phase and aimed to identify children who 190 would attend the Guri Program in 2022, and who were at risk for behavioral problems in four 191 of the five areas evaluated by the SDQ, namely, emotional symptoms, conduct problems, 192 hyperactivity, and relationship problems.

193 Recruitment was done upon securing authorization from the school boards to 194 participate in the research. The researchers met with parents at the schools to explain the 195 study, get consent, and subsequently distribute questionnaires. When meeting at schools was 196 not possible, questionnaires were sent home by children and subsequently collected. A total of 197 255 parent protocols were collected at the Guri Program and in schools surrounding the 198 programs for the control group, out of which 137 protocols were excluded. After further 199 screening with the Brazilian version of the Raven's test (53, 54), children at risk for intellectual

200	difficulties were excluded from the sample to avoid confounders (n = 10). One child was
201	excluded for having previous music lessons and another was diagnosed with autism, totaling
202	149 exclusions. The total of participants (n = 106) consisted in the intervention group –music
203	group (n = 45)– and the control group (n = 61). The music group lost 7 children, who dropped
204	out of the music program at the follow up (FUP). Therefore, 38 children remained in the music
205	group. One child was excluded of the control group at the FUP for late autism diagnosis.
206	Baseline data were collected in March and April of 2022, and the FUP tests and questionnaires
207	were taken seven months later <sup>5</sup> . Because children differed significantly in both groups (see
208	Sample Matching below), 35 children from the music group and 57 children from the control
209	group were included in the final statistical analysis after matching (Fig 1).

### 220 Instruments

### 221 Control variables

- Maternal schooling: We used the Brazilian questionnaire of economic classification criteria
- 223 Associação Brasileira de Empresas de Pesquisa (52), created to assess socioeconomic status
- based on samples of households. This questionnaire contains nine items that assess: a)
- 225 possession of durable consumer goods; b) type of water supply system and street paving; c)
- number of residents in the household; d) family composition; and e) level of education of the
- 227 head of the family. The result of the questionnaire is a measure stratified into five
- socioeconomic classes, namely: A (subdivided into A1 and A2), B (also subdivided into B1 and
- B2), C, D and E. For the purpose of this study, we used the mother's years of schooling
- 230 measured by this questionnaire.
- The Raven's Colored Progressive Matrices (CPM)–Special Scale (53, 54). We used this test to

assess non-verbal fluid intelligence, analogical reasoning, and the ability to generate responses

- 233 from non-verbal stimuli in participating children. This test is composed by 36 items
- dichotomously corrected (score of 0 for incorrect and 1 for correct answers), with a total score

of 36. Normative data is given in percentiles, attributed by age group. Children with non-verbal

intelligence falling under percentile 25 were excluded from the sample.

#### 237 Subject variables

• Strengths and Difficulties Questionnaire (SDQ)–parent version (50, 51), Brazilian version

239 (55). The SQD provides an assessment of behavior, emotions, and relationships of children and

adolescents. Questions are grouped into five dimensions: emotional symptoms, conduct

241 problems, hyperactivity/inattention, peer relationship problems, and prosocial behavior. Each

item is scored between 0 to 2, according to respondents' agreement with the statements (e.g.,

- 243 if the mother/parent thinks that the statement "Restless, overactive, cannot stay still for long"
- is certainly true about his/her kid, the item is scored with 2 for the hyperactivity-inattention

245 dimension). Some items present opposite directional relationship with the construct and must 246 be reversed before scoring. Each dimension is scored on a scale of 0-10. The higher the score, 247 the higher the behavioral difficulty or prosocial behavior. Difficulty items are summed up into a 248 difficulty score varying from 0 to 40. For selecting children at behavioral risk, we used the 249 cutoffs of difficulties scores  $\geq$  10, but the prosocial behavior scores varied across the sample. 250 • Digit-span subtest for children from the WISC-IV (56, 57). In this test, children are presented 251 with increasingly long strings of numbers, composed by 2 to 9 items each (e.q., 2-9-7). Upon 252 hearing the sequence, the child must repeat the digits in the same order given (short term 253 memory task) or in inverse order (working memory task). Each sequence size presents two 254 different trials, and the child receives a score of 1 for each sequence correctly uttered. The 255 total score in each task is 16. The test is discontinued when the child makes an error on two 256 trials in a same string of numbers. In this study, we used the span score in reverse order, or the 257 longest sequence numbers kept by the child in memory, as this subtest has been recognized as 258 a robust measure of working memory (58). 259 • Peer Aggressive and Reactive Behaviors Questionnaire (PARB-Q/QCARP) (59), Brazilian 260 version (60). This self-report questionnaire measures behaviors in terms of active and reactive 261 aggressions among pairs (59). This instrument contains 20 questions and contains two scales: 262 the Peer Aggression Scale (PA) and the Reaction to Peer Aggression Scale (RPA). The PA 263 consists of five items that assess proactive (or instrumental) physical and verbal aggression 264 (e.g., kicking or slapping) and three social-desirability bias items that are not scored (e.g.,

telling jokes). The questions begin with "how often do you...," followed by the circumstances

to be answered. The RPA consists of 12 sentences containing different ways reported by

267 children about how they react to aggression from their peers. Questions like "when a

268 colleague of yours...," are followed by statements, which may signal reactive aggression (RA; 6

items, *e.g.*, "hit or push you," "do you hit your colleague?"), seeking teacher support (STS; 3

items, *e.g.*, "hit or push you, do you tell the teacher?"), as well as internalized emotional

271 reactions (IR; 3 items, e.g., "hit or push you, do you cry and sulk?"). Each question is rated on a 272 4-point Likert scale (every day, sometimes, a few times, and never). PA scores range from 0 to 273 15, and RPA scores range from 0-18 in the RA scale and 0-9 in the STS and IR scales. 274 Bateria Psicológica para Avaliação da Atenção (BPA; Psychological Battery for Attention 275 Assessment) (61). The BPA is a pencil-and-paper test divided into three subtests that assess 276 different domains of attention: sustained attention (in one object among distractors), divided attention (focus in three objects among distractors), and alternated attention (alternating 277 278 focus between different objects among distractors).

The entire test battery was completed in 40-50 minutes, depending on each child's
performance. Children were allowed to take breaks during the testing sessions.

### 281 Sample matching

282 For the baseline measures, the groups differed significantly in terms of age, reactive aggression

283 (QCARP), non-verbal intelligence, and mother's years of schooling. As depicted in S1 Table,

children in the music group tended to be older, presented higher levels of reactive aggression

and non-verbal intelligence, and their mothers had higher levels of education. Moreover, even

though sex did not significantly differ between the groups, the proportion of boys was higher

287 in the control group. As the groups differed in terms of these characteristics, comparisons of

the effects of music on children's behavior would be biased. Therefore, we managed the

sample characteristics to match study groups.

Sample matching was carried out based on the removal of children from both groups considering simultaneously the following criteria, respectively, in increasing order of importance: (1) older children from the experimental and younger from the control group; (2) higher levels of reaction to aggression in the experimental group and lower in the control group; (3) superior and average superior performance in the Raven test in the experimental group and lower performance in the Raven test in the control group. Given that mother's years

of education is not a subject variable but rather related to it, we opted for removing children
whose mothers had more years of schooling from the experimental group, and the opposite in
the control group. Following this procedure, we removed 6 children (3 from each group) and
their results in these variables are depicted in S2 Table. With the matching, the final sample
was composed by 92 children (experimental = 35; control = 57). Table 1 shows the comparison
between groups in the baseline measures after matching.

#### 310 Statistical analysis

311 To deal with missing data, imputation was performed. Percent missing for each

312 individual variable varied from 7.1% (times of execution of the Raven's test; not treated here)

from 15.31 (SDQ at the post-test). We replaced missing data using the expectation

314 maximization method with 25 iterations. Little's MCAR test suggested that missing data was at

random ( $\chi^2(147) = 133.214$ , p = 0.786). We paired the groups using pre-test data (before

running the analyses, using data from all children who were paired). By imputing missing data,

317 we did not remove any subjects. Everyone who underwent "treatment" -music classes-,

318 whether absent or present, was part of the clinical group (intention to treat–ITT).

319 Descriptive statistics–means, standard deviations, and mean differences (between FUP

320 and baseline measures) as well as statistical graphic representations are reported. Inferential

analyses are reported by ANOVAS with repeated measures, using group as a fixed factor.

322 Because maternal levels of schooling differed between the groups, it was included as

323 covariate. Interactions between factors, groups, and maternal schooling levels were

324 performed. Data was analyzed using SPSS 23.0 for windows and we consider significant the

results with p <0.05. For effect size,  $\eta^2$  is reported, in which: small ( $\eta^2$  < 0.01), medium ( $\eta^2$ 

between 0.02 and 0.06) and large ( $\eta^2 > 0.14$ ) effects (Cohen, 2013 [1988]).

342	A repeated-measures ANOVA was conducted to verify the impact of the musical
343	intervention on different variables of the study, considering as factor among subjects the
344	group (control, experimental), schooling as covariate, and observing interactions. For SDQ
345	analyzes, difficulties ( <i>i.e.</i> , hyperactivity, relationship problems, conduct problems, emotional
346	symptoms, difficulties in general) and prosocial behavior were considered as dependent
347	variables. A reduction in difficulties and an increase in prosocial behavior were the expected
348	outcomes to verify the impact of music education. Baseline and FUP comparisons (ANOVAS)
349	are shown in Table 3.

As seen in Table 3, the main effect was significant for peer relationship problems, 357 indicating that both groups reduced these symptoms between baseline and FUP testing (see 358 difference means in Table 2). There was a significant interaction between peer relationship

359 problems and maternal schooling levels; the decrease in relationship problems was greater

360 depending on the schooling level of the mother, irrespective of group. Post hoc comparisons

361 showed that children whose mothers had medium to high years of education tended to start

As shown in Table 5, there were significant main effects for divided and 399 400 alternated attention. For both groups, attention scores increased from baseline to 401 FUP. There was a significant interaction between maternal schooling levels and divided 402 attention. Post hoc analyses showed that children with mothers who had low levels of 403 education benefited more from the development of divided attention, with gains 404 varying around 0.70 to 0.95 standard deviations (S4 Table). No other significant interactions emerged for any of the cognitive variables (Fig 4). 405

### 411 Discussion

412 The aim of this guasi-experimental study was to examine the impact of a music 413 education program on aspects of attention—shifting, divided, and sustained—, socioemotional 414 abilities, and reactive and aggressive behaviors in children aged 5-9 from underserved 415 communities of São Paulo. Using standardized tests, we compared results from a group of 416 children who participated in a community-based music program to matched controls at two 417 time points: before the intervention and seven months later. Because maternal education is 418 known to have an effect on children's cognitive and socioemotional development (62-64), we 419 also analyzed maternal education data reported by the children's parents through the ABEP 420 socioeconomic status questionnaire (52). To our knowledge, this is likely the first quantitative 421 study carried out on the impact of sociomusical programs in Brazil. 422 A main finding that emerged from our study was a significant effect of the intervention 423 on the music group in the FUP. Our data revealed a more pronounced decrease in emotional 424 symptoms in the music group as opposed to controls. This finding is consistent with earlier 425 theoretical (65) and empirical studies on the role of music education in children's mood and 426 emotional regulation (66, 67). We also found a developmental effect for emotional symptoms, 427 with children in both groups showing improved scores from baseline to FUP. Emotional

symptoms including depression, anxiety, perceived peer rejection, victimization, and feelings
of loneliness, have been associated with motor competence and to one's ability to move with
rhythm (67-69). It has been established that motor coordination disorders are risk factors for
mental health problems, such as eating disorders (68, 70, 71). Considering that rhythmic

432 training is intrinsic to music education in the Guri's program, we suspect that it may have been433 a protective factor for children's emotional symptoms.

434 In this study, maternal schooling was found to interact with relationship problems and 435 emotional symptoms in different ways. Children of more educated mothers had more 436 relationship problems at the start of the study in both groups, but these balanced out after 7 437 months. Emotional symptoms decreased more markedly in children whose mothers had less 438 education. Why would maternal education impact these two socioemotional areas in such 439 distinct ways? Previous studies (63) have found higher maternal education levels (*i.e.*, at least 440 some college education) to be associated with fewer behavioral problems in children, although 441 earlier comparisons of different levels of maternal education (*i.e.*, without some college 442 education) revealed similar results from those of our study. Maternal education has been 443 linked to numerous practices that grant children cognitive advantages, such as the use of more 444 complex language (63). As socioemotional symptoms were assessed through parental reports, 445 it is possible that children with more educated mothers were also more prone to verbalize the 446 impact of formal learning environments in public schools as opposed to the home 447 environment in the aftermath of the pandemic. Our study took place immediately after the 448 social restrictions imposed by the coronavirus pandemic began to be lifted. In Brazil, there also were marked differences in access to education between families during the COVID-19 449 450 quarantine. This is, of course, speculative. By contrast, the finding of a significant interaction 451 between maternal schooling and children's emotional symptoms is consistent with earlier 452 studies that found a close relationship between maternal education and children's mental 453 health (62). Maternal education has been directly associated with low SES and social status, 454 another factor to have an impact on children's mental health and socioemotional wellbeing 455 (72), particularly in early childhood (62).

456	In terms of cognitive outcomes, divided attention had a developmental effect,
457	increasing equally between groups, from baseline to FUP. We also found divided attention to
458	increase more in children whose mothers had lower levels of education. A possible explanation
459	for this finding is that in formal educational settings, children from our study were more able
460	to learn and retain new information, keeping up with other children's skills. During the
461	pandemic, many children spent long periods of time in front of screens (e.g., TV, tablets,
462	games, and cell phones), which is known to reduce their attention span (73). Furthermore,
463	children from low-SES families in Brazil were often left at home unsupervised (74). Alternated
464	attention, in turn, was higher for the music group, although no causal relationship was
465	observed. Contrary to earlier studies, we did not find effects of music instruction on children's
466	attention, possibly due to our small sample size, the short duration of the intervention ( <i>i.e.</i> , 7
467	months) and music classes ( <i>i.e.</i> , only one hour per week), and the unprecedent pandemic
468	variable.

# 470 Conclusion & Limitations

Parents of the children selected for this study reported high difficulties in the SDQ,
which suggests a risk of exposure to mental health vulnerabilities. The surveys were carried
out in peripheral regions of São Paulo, Brazil, where services such as public security, health,
education, and transportation are scarce and oftentimes precarious where they exist. The
literature indicates such elements as predictors of emotional symptoms, health problems
related to emotional stress, and behavioral problems in children (75).

Given the harmful effect of scarcity on mental health of underserved communities, we
believe it is crucial that public policies pay attention to the potential benefits of music
education on socioemotional symptoms. It is essential that the State, public policy

480	administrators, as well as the third sector represented by social organizations and non-
481	governmental organizations (NGOs), pay attention to the responsibility of expanding the scope
482	of their activities to these vulnerable populations. Access to music education can potentially
483	serve as a protective factor for children exposed to violence and cognitive vulnerabilities.
484	As limitations of this study, the absence of statistically significant interaction between
485	the groups in some cases may be due to the low sample size and short intervention time. Also,
486	a question remains unanswered is: Would different curricular approaches to music education
487	yield different results? Previous studies suggest that curated curricula may yield more
488	substantial findings in terms of both EFs (76) and socioemotional skills (77). Additionally, the
489	length of programs is important; the literature points to the potentiation of long-term
490	exposure to music practice (more than two years) on the impact of behavioral measures and
491	brain structures (3, 8, 78-80). Our study collected data over a school year, which, in practice,
492	had an interval between the baseline and FUP of only about seven months, and included an
493	hour of music class per week, and in the aftermath of a global pandemic. We hope that the
494	tendency observed here can contribute to future research. More studies are obviously needed.
