9 Abstract

- 10 Purpose: To evaluate small incision cataract surgery visual outcomes and associated risk factors
- in a tertiary eye care center in Bhutan.
- 12 Methods: This was a hospital-based prospective longitudinal study. A total of 310 patients who
- 13 met the eligibility criteria were included in the study. Results: The mean age of the patients was
- 14 68.36 (SD: 12.74 years), and 157 (50.6%) were male. 285 (91.94%) of the cataract-operated eyes
- 15 had best-corrected vision greater than 6/60, while
- 16 25 (8.06%) of the eyes had vision less than 6/60. 47 individuals (15.16%) had pre-existing
- 17 ocular co-morbidity. Intraoperative complications were seen in 19 eyes (6%). At the 6-week
- 18 follow-up visit, based on best-corrected visual acuity (BCVA), 90.65% had a good visual
- 19 outcome. Analysis of multiple logistic regression showed that patients with preoperative ocular
- 20 comorbidities (OR 50.92; 95% CI 10.23, 253.37) and those with operative complications (OR
- 21 16.59; 95% CI 3.54, 77.70) were significantly associated with poor visual outcome.

22 Conclusions: This study shows that cataract surgery can restore good visual acuity. However,

23 patients should be followed up on for a longer period, and greater emphasis should be given to

24 monitoring outcomes after cataract surgery.

25 Introduction

26 The World Health Organization (WHO) reports that globally, at least 1 billion people have

27 preventable near or distance vision impairment. Cataract is the leading cause of vision

impairment and blindness in 65.2 million people globally (1). In Southeast Asia, the proportion

of blindness due to cataracts was 44% (2).

30 Bhutan, located in the Eastern Himalayas between India and China, has a population of 7, 35,553

31 (3). The prevalence of visual impairment in Bhutan was 1%, with cataracts contributing as the

32 major cause (48.3%) of preventable blindness.

A cataract is a clouding of the natural intraocular lens and, if not corrected can lead to diminution of vision and irreversible blindness. Small incision cataract surgery (SICS) involves the removal of a cloudy lens and the implantation of an intraocular lens (IOL) (4). It is the most effective method to restore vision.

37 However, the outcome of the cataract surgery determines the vision-related functioning and

improvement in the patient's life, which is measured in terms of visual acuity. WHO

recommends more than 80% of eyes with available correction between discharge and 12 weeks

40 postoperatively should have good visual acuity of 6/6-6/18, and less than 5% of eyes should have

41 poor visual acuity of <6/60 (5).

However, the Rapid Assessment of Avoidable Blindness (RAAB) survey conducted in 2018 42 noted a postoperative good visual outcome of 67.3% for the country, which was found to be 43 below the WHO recommendation (6). 44 45 Studies have shown that increasing patient age is associated with poor visual outcomes following SICS. Studies conducted in Bangladesh showed that the risk for poor visual outcomes was 46 47 increased by 4.63-fold among patients aged 70 years and above (7). Studies in Liberia and India also reported similar findings with older age (8–10). One of the large studies conducted in 4 sites 48 49 in North America and Europe, which included the United States, Spain, Canada, and Denmark, also demonstrated that older age was associated with poor visual outcomes (11). 50 The second RAAB survey conducted in the country in 2018 found that following SICS, the main 51 52 cause of poor visual outcome was ocular comorbidities in 43.6%. These included corneal opacities, glaucoma, and posterior segment diseases such as diabetic retinopathy and age-related 53 macular degeneration (6). The presence of pre-existing ocular pathology is a strong independent 54 predictor of visual outcomes after SICS, as found in a study in India (12). Other studies in India 55 have also shown that poor visual outcomes were due to pre-existing ocular comorbidities 56 impacting the visual functioning of the patients (13, 14). Visual outcomes of SICS in Denmark, 57 the United States, Spain, and Canada showed poorer outcomes with coexisting ocular 58 comorbidities (11). Similar findings have also been noted in studies conducted in Australia and 59 Nigeria where ocular comorbidities affected the final visual outcome of the patients (15–17). A 60 study in Nepal by Hening et al. also demonstrated poor visual outcomes in those patients who 61 had ocular comorbidities (18). 62

The RAAB survey conducted for the country in 2018 noted that surgical complications
amounted to 40.5 %, while postoperative sequelae amounted to 22.2%, which impacted the final

visual outcomes of the patients resulting in the good visual outcomes being below WHO
recommendation for the country (6).

67 Cox JT et al. noted the mean SICS complication rate for all surgeons to be $1.7\pm1.0\%$ for both

68 intraoperative and postoperative complications (9).

69 A study in Nepal demonstrated that postoperative complications, mainly the postoperative

sequelae such as PCO, cause poor visual outcomes in the patients (19). Another study in Nepal

also showed that surgical complications such as posterior capsular rent vitreous loss and

real endophthalmitis that occurred caused poor visual outcomes (20). Ruit S et al. also inferred a

relation between poor visual outcomes and surgical compilations (21).

74 Studies conducted in African countries had good postoperative visual acuity below the WHO

recommended criteria, indicating a similar pattern for developing countries (22, 23). Norregaard

76 JC et al. demonstrated a superior visual outcome following SICS above the WHO

recommendation, which was conducted in the United States, Canada, Denmark, and Spain (11).

A similar outcome has also been noted in studies in India (10). However, there are studies in

79 Bangladesh and Nigeria that reported poor outcomes following cataract surgeries (7, 16).

80 In Bhutan, Jigme Dorji Wangchuck National Referral Hospital (JDWNRH) functions as the only

81 tertiary-level eye care center in the country, and there is a need to routinely monitor the outcome

82 of cataract surgery and to follow standardized cataract surgical protocols and postoperative

83 follow-up care.

The study aimed to evaluate postoperative visual acuity and study factors associated with poor visual outcomes and form the baseline data for the Department of Ophthalmology, JDWNRH.

87 Material and Methods

This is a hospital-based study conducted at the Gyalyum Kesang Choden Wangchuck National 88 Eve Center (GKCWNEC), Jigme Dorji Wangchuck National Referral Hospital (JDWNRH), 89 Bhutan. The study design was a prospective longitudinal study. Patients who had visited the 90 GKCWNEC and had undergone small incision cataract surgery (SICS) from 1st September 2021 91 92 to 30th April 2022 were eligible to be included in this study. The sampling method was census sampling. Patients who were 18 years and above were included. Consequently, congenital 93 cataracts, patients with secondary intraocular (IOL) implantation, and those undergoing 94 95 combined procedures with SICS (e.g., SICS with corneal graft or SICS with trabeculectomy, etc.) were excluded. Due to poor visual prognosis after surgery, these patients were excluded. 96 97 All socio-demographic data were collected from the patients, and the pre-operative and post-98 operative data were collected from the patient's medical record after following up with the 99 patient, which was recorded in the standard cataract surgical record (CSR) form. The standard 100 pre-operative examination included a detailed history, measurements of presenting visual acuity 101 (PVA), and best corrected visual acuity (BCVA) with Snellen charts. Computerized Snellen 102 charts were used to test PVA and BCVA. The visual acuity of each eye was classified according 103 to the WHO-recommended guideline for cataract outcome grading. PVA and BCVA were 104 measured by optometrists in refraction rooms where computerized Snellen charts were used, 105 106 which measured the presenting visual acuity without correction and best corrected visual acuity with pinhole. All these records were directly obtained from the patient's documents which were 107 recorded before SICS and then at day 1, day 7, and 6 weeks post-SICS. Intraocular pressure 108

measurement was done with an Icare (rebound tonometer) as well as applanation tonometrywhere needed.

Patients were assessed by ophthalmologists in different consultation chambers before SICS and 112 then followed up and assessed on day 1, day 7, and 6 weeks post-SICS. The patients had detailed 113 114 slit lamp assessment including anterior segment examination of cornea, anterior chamber, and pupils and dilated examination to assess the lens status which was classified according to Lens 115 Opacity Classification System III. Posterior segment pathology was assessed with a +90D lens. 116 117 Any ocular pathology (anterior or posterior segment) was noted if present. Ocular comorbidities were grouped as corneal scars, old iritis, retinal diseases, glaucoma, and others. All the findings 118 were noted in the patient's documents and were obtained when the patient presented to the pre-119 120 operative chamber. Before the surgery, biometry and sac syringing was done for all the patients and they also underwent blood investigations (viral markers, TPHA (Treponema Pallidum 121 Hemagglutination Assay), RPR (Rapid Plasma Reagin) and random blood sugar). Any findings 122 that were either not clear or missing were directly consulted with the assessing ophthalmologist 123 and recorded in the CSR. Standard Operating Procedures (SOP) and definitions specified in the 124 World Health Organization (WHO) Manual for Monitoring Cataract Surgical Outcomes (MCSO) 125 were followed. For assessment of visual outcome, visual acuities were categorized according to 126 WHO guidelines: good (6/6-6/18), borderline (6/24-6/60), or poor surgical outcomes (<6/60). 127 128 The study questionnaire was coded and a data documentation sheet was prepared. Data were 129

- 132 Denmark). Additional analysis was performed using STATA (version 13.0, licensed by
- 133 KGUMSB, Bhutan). Factors associated with visual acuity (age, ocular morbidity, systemic
- 134 comorbidity, postoperative complications) were tested using unadjusted analysis using logistic
- regression. Those factors with p < 0.1 were included in the final model for adjusted analysis. For
- all statistical analysis, p-value < 0.05 was considered significant.
- 137 The Ethics Committee of the Khesar Gyalpo University of Medical Sciences of Bhutan
- 138 (KGUMSB), Bhutan, approved this study and it was conducted according to the tenets of the
- 139 Declaration of Helsinki.

- 141 **Results**

142 Demographic characteristics

143 From 1st September 2021 to 30th April 2022, 430 patients underwent SICS, out of which 372

144 were included in the study and fulfilled the inclusion criteria. Among that 310 patients completed

the follow-up with a response rate of 83%, while 62 were lost to follow-up. These 62 patients

146 who were lost to follow-up were all living outside Thimphu and did not have their follow-up at

the Department of Ophthalmology, JDWNRH. The remaining 310 patients were then analyzed.

Amongst the 310 patients analyzed in the study, there were 157 male and 153 female patients.

- 149 The mean age among the group was 68.36 (SD 12.74).
- As illustrated in Figure 1, the highest percentage [70.65%, n = 219] of the patients belonged to
- the age group above 65 years followed by the age group of 55 65 years [16.77%, n= 52].
- Amongst the patients analyzed in the study, 74.52% (n=231) had no schooling. Unemployed
- patients accounted for 94.19% (n=292) while patients living outside Thimphu accounted for

According to the occupation of the patients, the maximum were farmers (n=173) followed by housewives (n=107) and the rest were in other categories as depicted in Figure 2.

- 164 Socio-demographic profiles such as age, gender, working status, and occupation associated
- 165 with poor visual outcomes were analyzed and it was found to have no significant association

Among the patients who underwent cataract surgery, nearly 53% (n = 163) had their right eye

173 operated, whereas around 47% (n = 147) had their left eye operated.

Among the patients who underwent cataract surgery, almost 72% (n = 224) had no comorbidities,

175	whereas around 28% had one or more comorbidities (hypertension, diabetes, rheumatoid arthritis,
176	bronchial asthma, syphilis, and chronic obstructive pulmonary disease), as shown in Figure 3.

178	Visual Acuity Outcome
179	The visual outcome has been categorized into presenting visual acuity (PVA) and best
180	corrected visual acuity (BCVA) and measured at postoperative day 1, day 7, and 6 weeks.
181	Figure 4 depicts the total number of patients with BCVA at different post-operative visits.
182	Table 3 shows the BCVA before SICS and 6 weeks post-SICS in line with the WHO
183	monitoring of cataract surgical outcomes.

193	Ocular pathology, Operative complication, and systemic comorbidities
194	Ocular pathology was seen in 15.16% ($n = 47$) of the patients, while 84.84% ($n = 263$) did not
195	have any ocular pathology. These included corneal scars, retinal disease, glaucoma, and others.
196	From the ocular pathology, a majority had retinal disease ($n = 21$), followed by others ($n = 15$),
197	corneal scar ($n = 6$), and glaucoma ($n = 5$). Retinal diseases included age-related macular
198	degeneration (ARMD), macular scars, macular holes, and retinal detachment surgery. Other
199	ocular pathologies included complicated uveitic cataracts, retinitis pigmentosa,
200	pseudoexfoliation, traumatic cataracts, Fuchs heterochromic iridocyclitis, optic atrophy, and
201	vitreous hemorrhage. Poor visual outcome was significantly associated with retinal disease (aOR
202	50.92; 95% CI: 10.23, 253.37), glaucoma (aOR 13.75; 95% CI: 1.26, 150.06), corneal scar (aOR
203	23.55; 95% CI: 3.01, 184.02), and others (aOR 12.14; 95% CI: 2.36, 62.33), as shown in Table 4.

215	Almost 94% ($n = 291$) had no operative complications, while 6% ($n = 19$) had operative
216	complications, which included striate keratopathy $(n = 13)$ and others $(n = 6)$ (capsule rupture
217	without vitreous loss, capsule rupture with vitreous loss, and wound leak). Complications like
218	zonular dehiscence, retained lens matter, and endophthalmitis did not occur. Striate keratopathy
219	was mostly seen in patients $(n = 13)$ who already had ocular pathology, and it persisted over time
220	and impacted the visual acuity. It was found to have a significant association with poor visual
221	outcomes (aOR 16.59; 95% CI: 3.54, 77.70).
222	Systemic comorbidities comprised diabetes, hypertension, and others (such as bronchial asthma,
223	syphilis, chronic obstructive pulmonary disease (COPD), and rheumatoid arthritis). Around
224	72.26% (n = 224) had no comorbidities, while 27.74% (n = 86) had either one or more systemic
225	illnesses, which did not have any significant association with poor visual outcomes.
226	As very few patients who underwent SICS had vision $< 6/60$ (n = 25), the causes were mostly
227	selection, amounting to 64% (n = 16), followed by surgery with almost 28% (n = 7) and 8%
228	(n=2) for sequelae (which included posterior capsular opacification (PCO)).

238 Discussion

- 239 Demographic characteristics
- 240 Age

241 The age distribution was found to be such that the majority were above the age of 65 years, with

a mean age of 68.36 ± 12.74 years. The high percentage of patients belonging to the age group

above 65 years is consistent with the well-established fact that cataracts primarily affect older

individuals (24). In this study, there was no association found between increasing age and the

visual outcomes, which is quite contrary to some of the studies that demonstrated a correlation

246 between the two (25, 26)

248 Gender

In this study, there was no predilection to any gender and it was found to be almost similar with
50.65% male and 49.35% female patients.

251 This study did not find any significant association between gender and final visual outcomes,

which is also consistent with several studies in similar contexts (27, 28). It differed from studies

where there was a significant association between male gender and improved visual outcome.

254 This association aligns with several studies (10, 13, 22, 26). Interestingly, some studies in India

have shown that the female gender significantly improved postoperative visual acuity, which

might be due to improved postoperative self-care among women (29, 30). The relationship

between gender and visual acuity is complex and multifaceted considering various contradictory

258 findings.

261 Employment status, qualification, and present address

262	This study found that most of the patients (74.52%) had no schooling and had undergone cataract
263	surgery. It was comparable to a study in Bangladesh where most of the patients were illiterate
264	and most of them lived in rural areas, similar to our study (7). The fact that a significant portion
265	of patients lived outside Thimphu suggests that people from different regions have access to
266	specialized eye care services in the capital city. It can also be noted that the patients who were
267	lost to follow-up were living outside Thimphu and they were not able to return for a
268	postoperative visit at the Department of Ophthalmology, JDWNRH. Since eye care services are
269	provided throughout the country at referral hospitals as well as at the district hospitals, it could
270	be inferred that those lost to follow-up patients were likely seen at one of the health centers.

283 Retinal disease amounted to about 44.6% (n=21) of the total ocular comorbidities. Retinal

significantly poor visual outcomes. Poor visual outcome was significantly associated with retinal

289 Other ocular pathologies included complicated uveitic cataracts, retinitis pigmentosa,

several studies reporting varying rates of ocular comorbidities among cataract patients (34, 35).

293 It was noted that the ocular pathology contributed to poor visual outcomes despite the surgeons

294 performing good SICS. Studies have also noted similar findings where the final visual outcome

was affected by the ocular pathology (10, 16, 23, 32). Ocular pathology was found to have a

significant effect on the overall visual acuity where it was important to recognize the conditionbefore surgery.

It was similarly noted in the RAAB survey where 43.6% were due to ocular co-morbidities that
caused poor visual outcomes. It was also noted that posterior segment diseases such as glaucoma,
diabetic retinopathy, and age-related macular degeneration contributed to 15.4% of all visual

impairment and 26.1% of blindness (6).

This shows that to detect ocular comorbidities that are likely to affect results, a thorough preoperative eye examination by an ophthalmologist would be required. Then, patients who have ocular comorbidities can be counseled and given a thorough explanation of the outcome of the surgery.

307 Postoperative complications

308	The occurrence of operative complications in 6% of the patients, primarily striate keratopathy,
309	was within the range reported in other studies investigating complications following cataract
310	surgery (13, 36). The study found a significant association between striate keratopathy and visual
311	outcome (aOR 16.59: 95% CI 3.54, 77.70). It was noted that striate keratopathy occurred in all
312	the patients with corneal scar $(n=6)$ demonstrating that the patients with ocular comorbidity such
313	as corneal scar were already at the risk of developing operative complications. So, these patients
314	had poor outcomes which was related to the preexisting ocular pathology. Similar associations
315	were not noted in other studies.
316	Postoperative complications that were noted in this study were also demonstrated in several other
317	studies that had affected the final visual outcome (14, 30, 37).
318	However, the absence of severe complications such as zonular dehiscence, retained lens matter,
319	and endophthalmitis was reassuring and suggested a satisfactory safety profile of SICS in our
320	study population. It would be due to experienced surgeons performing the cataract surgeries
321	instead of the resident doctors. It could also be attributed to the experience of the surgeons
322	managing intra-operative complications. Better operative facilities with proper surgical
323	instruments and well-trained operating assistants were other factors that resulted in fewer
324	complications.
325	
326	Visual outcomes

327 According to the WHO and the International Agency for the Prevention of Blindness (IAPB)

action plan, good postoperative visual acuity should be obtained in >80% with available

329 correction and >90% with the best correction for a vision of 6/6 - 6/18 (5). The preoperative best

330	corrected good and poor visual outcome was 9.68% (n=30) and 50% (n=155) respectively. The
331	study found that a good visual outcome after 6 weeks of SICS was 90.65% (n=281). It was found
332	to be above the WHO recommendation for monitoring cataract outcomes. This was consistent
333	with the expected positive outcomes of cataract surgery in improving vision (38). It was
334	comparable to studies which had conducted in India and other countries (10, 13, 39-41). This
335	was better than the studies conducted in some developing countries where the visual outcomes
336	were below the WHO recommendation (42-45). The improvement was mainly due to well-
337	trained surgeons and operating assistants, better biometry services, and well-trained staff
338	conducting biometry before the surgery.
339	However, poor visual outcome was 8.06% (n=25) 6 weeks post-SICS which was more than the
340	WHO recommendation (<5%). This might have resulted due to ocular morbidities as well as
341	surgical complications that had affected the final visual outcome.
342	It was found that only around 72.7% had good visual outcomes with the best correction in the
343	second RAAB survey, while poor visual outcome was reduced from 15% to 11.5%.
344	The improvement in the good visual outcome compared to 2018 in its RAAB survey, would be
345	likely due to better healthcare infrastructure in the capital with the shifting of the department into
346	a separate well-established National Eye Care Center with improved facilities and availability of
347	specialized services including vitreoretinal services (60).
348	
349	Causes of presenting vision <6/60
350	The causes of vision <6/60 at the postoperative 6 weeks were found to be majority due to

selection (64%, n=16) followed by surgery (28%, n=7) and sequelae (8%, n=2). This indicated

that the selection of cases was an important aspect before the surgery.

Selection as the cause of poor outcomes was high because of the availability of vitro-retinal 353 services. Cases with retinal diseases had cataract surgery mainly for better view during retinal 354 surgeries. This might have been the reason for the higher selection of the cases. The poor 355 outcome was related to surgical complications which occurred either intraoperatively or 356 postoperatively even through the hands of experienced surgeons. 357 358 Postoperative sequelae mainly posterior capsular opacification was the cause in 2 of the patients resulting in poor vision. However, this would be treated subsequently with Nd: YAG 359 (neodymium: yttrium-aluminum-garnet) capsulotomy. The poor visual outcome was noted due to 360 361 surgical complications including the postoperative sequelae amounting to around 62.7% in the second RAAB survey (6). The vision of these patients did not improve with refraction because 362 these patients already had pre-existing ocular pathology which hampered the final visual 363 364 outcome. Therefore, the BCVA remained poor for these patients. The prospective assessment of surgical outcomes probably contributed to better surgical outcomes. Monitoring has enhanced 365 the results of postoperative cataract surgery. The technique of tracking results and providing 366 operating surgeons with feedback guarantees that the standard of postoperative eyesight is at the 367 forefront and is constantly highlighted. The institution's goal of recovering vision is always 368 maintained, even if the operating doctors change, as is typical in any significant institution. 369 Identifying the cases with any ocular pathology before the surgery would help plan and 370 anticipate before surgery and also guide through patient's counseling both preoperatively and 371 372 postoperatively.

The strength of the study was that it was a hospital-based study (only a tertiary eye care center) and data collection was swift and suitable. The study included a large sample size which could

likely be representative of the volume of SICS performed at the hospital and the study used astandard pro forma recommended by WHO.

A few limitations of the study were that it involved all the ophthalmologists at the Department of 379 Ophthalmology who performed SICS and the conclusions from the study were drawn as a whole 380 381 and not for individual surgeons. The study assessed outcomes only at 6 weeks post-SICS, providing insights into short-term outcomes. Longer-term follow-up data would have been 382 valuable to assess the durability of visual improvements, refractive outcomes, and potential long-383 384 term complications. Although a considerable sample size was chosen, it was not representative when compared with other population-based studies. There was a loss in patient follow-up 385 during the study period. The study was conducted at a single tertiary referral hospital, which 386 might have limited the generalizability of the findings to other healthcare settings or populations. 387

389 Conclusions

As a result of cataract surgery, patients with poor vision had improved visual acuity, according to this study. The results also showed how crucial a thorough pre-surgical assessment is to avoiding complications and guaranteeing a successful procedure. A good visual outcome was achieved, better than the WHO recommendation for tracking visual outcomes and in line with studies conducted in the area and other industrialized nations.

The success of cataract surgery should, however, be routinely monitored at hospitals in underdeveloped nations like Bhutan so that any challenges can be found and the proper steps can be made to close the gaps. To fully assess the total effect of cataract surgery on patients' welfare and everyday functioning, this study advises long-term follow-up following cataract surgery.






Figure 2: Occupation of patients who underwent SICS at Jigme Dorji Wangchuck National Referral Hospital, Thimphu, Bhutan from 1st September 2021 to 30th April 2022 (n=310)




Figure 3: Systemic comorbidities among patients who underwent SICS at Jigme Dorji Wangchuck National Referral Hospital, Thimphu, Bhutan from 1st September 2021 to 30th April 2022 (n=310)





Figure 4: Total number of patients with BCVA at different post-operative visits at Jigme Dorji Wangchuck National Referral Hospital, Thimphu, Bhutan from 1st
