# 43 Abstract

#### 44 Background

45 Different regions in Taiwan have varying levels of dengue risk; however, the same

- 46 prevention messages were implemented nationwide for a prolonged period. People in
- areas with different risk levels may perceive the disease risk differently, and these
- 48 perceptions may be linked to message fatigue. Individuals experiencing high levels of
- 49 message fatigue may engage in fewer preventive activities. Although message fatigue has
- 50 been studied concerning many infectious diseases, it has not been extensively researched
- in the context of dengue. Moreover, previous studies primarily focused on the general
- 52 population regardless of risk level or on high-risk populations, with few examining
- 53 message fatigue across areas with varying risk levels. Therefore, this study aimed to
- 54 identify distinct predictors of message fatigue across different dengue-risk areas in
- 55 Taiwan.

#### 56 Methodology/Principal Findings

- 57 The online questionnaire was adapted from the measurement developed by So et al.,
- 58 based on the conceptual definition of message fatigue. Message fatigue has two
- 59 dimensions: message environment (ME) and audience response (AR). A negative
- 60 binomial model was used to examine the association between the demographic variables
- 61 (sex, residency, education, occupation, age, and income) and the perceived variables
- 62 (perceived prevalence, perceived severity, and optimistic bias) with ME and AR
- 63 separately.
- 64 The results showed that in high dengue-risk areas, individuals with an education level of
- high school or below reported significantly higher levels of AR compared to those
- educated higher than high school (1.10, 95% CI = 1.01-1.21). In medium dengue-risk
- areas, individuals in the optimism group were 1.12 times more likely (95% CI = 1.01 -
- 1.25) to report higher levels of ME than those in the realistic group. In low dengue-risk
- areas, younger individuals, males, and those with a high-school education or below
- 70 reported significantly higher levels of AR.

#### 71 Conclusions/Significance

- This study revealed that dengue-message fatigue is associated with different variables across varying risk areas. These findings could inform global health communication strategies by identifying key demographic and perception-based predictors of message fatigue, enabling more targeted and effective public health messaging in regions with
- 75 fatigue, enabling hore targete76 differing risk levels.

# 77 Author summary

- 78 In Taiwan, dengue is a significant public health concern, and different regions face
- varying levels of risk. Despite these differences, the same public health messages about
- 80 dengue prevention are disseminated nationwide. In this study, we explored how people in
- 81 areas with high, medium, and low risk of dengue of Taiwan respond to these messages,

specifically focusing on message fatigue—when individuals tire of repeated health

83 messages and may stop following preventive advice. We found that individuals in high-

risk areas with lower education levels reported more fatigue with these messages, while

those in medium-risk areas who were optimistic about the disease were more likely to

86 experience fatigue. In low-risk areas, younger individuals, males, and those with lower

87 education levels were more likely to experience message fatigue. These findings can help

- 88 global health authorities design better-targeted public health messages by considering
- 89 how different groups respond to repeated health messaging, thereby making dengue
- 90 prevention efforts more effective across various risk areas.

# 92 Introduction

93

Dengue is a significant communicable disease in Taiwan, with all suspected and 94 95 confirmed cases reported to the Taiwan Centers for Disease Control (TW CDC) [1]. The 96 entirety of Taiwan is susceptible to dengue due to two major mosquito vectors, Aedes 97 *aegypti* and *Aedes albopictus* [1]. However, dengue incidence and prevalence vary across 98 regions. The southern region, specifically Tainan, Kaohsiung, and Pingtung, accounted 99 for over 98.6% of indigenous dengue cases between 1998 and 2023, followed by the northern, central, and eastern regions [1]. Studies have shown the highest prevalence 100 101 rates were also in the southern region, while the central region generally had the lowest 102 rates [2] [3]. Therefore, in this study, the southern, northern, and central regions served as proxies for high, medium, and low dengue risks, respectively. Throughout the text, we 103 will refer to these regions as high, medium, and low-risk areas. 104

The current prevention and control strategies were established in 2003 [1]. These are
maintained throughout the year and consist of information, education, and
communication (IEC) activities, as well as routine vector control. The TW CDC conducts
IEC activities, which include health education campaigns through television
advertisements, radio announcements, posters, the Internet, and social media platforms.
These activities are uniform across Taiwan. They aim to increase public awareness of

self-protection measures, symptom recognition, and the management of water-holding

113 containers on private properties. However, dengue continues to occur each year despite 114 year-round IEC activities, suggesting that these efforts may need modification to find

new approaches to motivate people to undertake prevention measures.

116

One reason that may reduce motivation to participate in disease prevention is message 117 fatigue [4-6]. Message fatigue is a psychological state from prolonged exposure to similar 118 or repetitive messages, resulting in negative reactions such as boredom, annoyance, and 119 disengagement [7]. When individuals are overwhelmed with too many messages on the 120 121 same topic, they may become mentally exhausted and bored, leading to message fatigue 122 [8]. This state encompasses perceived overexposure, redundancy, exhaustion, and tedium 123 [4, 7, 8]. Based on So et al.'s study, message fatigue consists of the dimensions of 124 message environment (ME) and audience response (AR). The ME dimension describes a 125 sense of being overwhelmed and frustrated by excessive and repetitive information about the message. The AR dimension indicates boredom and annoyance with continuous and 126 127 uninteresting messages [7].

129 Several demographic factors, such as age, sex, education, job, and income level, have 130 been identified as being associated with message fatigue [9-12]. However, the patterns of 131 these demographic factors are not consistent across studies. For example, Stockman et al. 132 aimed to examine the level of fatigue toward HIV-prevention messages among three 133 high-risk populations: men who have sex with men, heterosexuals, and injection drug users (IDUs). The findings showed that younger IDUs had a higher level of HIV-134 prevention fatigue than older IDUs did [9]. In contrast, Steiner et al. aimed to determine 135 whether the volume of automated text or interactive voice response messages influenced 136 the likelihood of patients opting out of future messages, finding that the senior group 137 138 (aged 55 and older) experienced a higher level of message fatigue than younger individuals (aged 18–34) did [10]. Regarding sex, a Polish study found that women 139 reported significantly greater COVID-19 fatigue, particularly in terms of information 140 141 fatigue [12], while men had higher levels of anti-tobacco message fatigue in the United 142 States [11].

143

144 Message fatigue has been observed in prevention messages for infectious diseases [5, 8, 9, 13-15]. For example, research by Guan et al. examined the impact of COVID-19 145 message fatigue on people's intentions to engage in preventive behaviors [5]. The results 146 147 showed that message fatigue leads to both reactance and inattention, which in turn negatively affect people's intentions to engage in preventive behaviors, mediating the 148 relationship between message fatigue and these behavioral intentions [5]. Regarding HIV 149 150 prevention messages, Stockman et al. aimed to examine HIV-prevention fatigue in community-based samples of three high-risk populations in San Francisco. The study 151 152 found that IDU participants had a higher level of fatigue toward HIV-prevention messages compared to heterosexuals [9]. A report by UNICEF's Eastern and Southern 153 Africa Regional Office showed that a prolonged period of community awareness 154 155 regarding Ebola prevention resulted in message fatigue [15]. However, few studies on message fatigue have been conducted in the context of dengue. 156

157

158 Moreover, most studies on prevention messages for infectious diseases focus on the general population regardless of their risk levels or solely on high-risk populations 159 160 concerning message fatigue. Few studies have evaluated message fatigue across groups with different risk levels, such as individuals residing in various areas but exposed to the 161 same prolonged messaging. Groups with different risk levels may perceive disease risk 162 163 differently, influenced by factors such as psychological and socio-economic conditions 164 [16-18]. Additionally, perceptions of disease risks are associated with message fatigue [7, 8]. Therefore, groups with different risk levels may experience varying levels of fatigue. 165 166 To inform future message designs, this study aimed to identify distinct predictors of 167 168 message fatigue across various dengue-risk areas in Taiwan. The examined predictors

169 included demographic variables such as age, sex, education, and income, as well as

170 perceived risk variables, including optimistic bias, perceived prevalence, and perceived

severity. This study could inform global health communication strategies by identifying

172 key demographic and perception-based predictors of message fatigue, allowing for more

targeted and effective public health messaging in diverse regions at varying risk levels.

# 175 Materials and methods

176

### 177 **Participants and procedure**

The study was part of a larger project involving an online survey on dengue perceptions 178 and dengue-message fatigue. Participation was voluntary, and respondents were assured 179 180 of confidentiality and anonymity. Participants were adults aged 18 and above residing in 181 Taiwan, who reported their demographic information, perceived risks, and responses to questions assessing dengue-message fatigue. The questionnaire was distributed through 182 183 the authors' social media networks, including Facebook and Line. A convenience sampling method was employed. The survey started on October 25, 2023, and ended on 184 November 13, 2023. 185

### **187** Measurements of variables

#### 188 Message fatigue

The online questionnaire was adjusted based on the measurement developed by So et al. 189 according to the conceptual definition of message fatigue [7]. Similar to the study by So 190 et al., message-fatigue measurement included the ME and AR dimensions. Unlike the 191 original study, in this study, the ME dimension consisted of six questions to represent 192 overexposure and redundancy (S1 Table), with a Cronbach's alpha of 0.85. The reduction 193 194 from the original nine questions to six was due to the translation process from English to 195 Chinese, during which it was found that some questions could be combined or simplified without losing their original meaning. Therefore, the number of questions was reduced 196 197 while maintaining the consistency and clarity of the content. For the AR dimension, the number of questions was reduced from seven to five, representing exhaustion and tedium 198 in this study, for the same reason (S1 Table), with a Cronbach's alpha of 0.88. All 199 200 questions were measured on a 5-point Likert scale ranging from 1 (strongly disagree) to 5 201 (strongly agree) [7].

#### 203 Perceived risks

Perceived risks included perceived prevalence, perceived severity, and optimistic bias.
Perceived prevalence was assessed with the question, "Do you think the current dengue
outbreak in Taiwan is severe?" and perceived severity with, "Do you think the likelihood
of death is high once infected with dengue?" Both were measured on 11-point Likert
scales ranging from 0 (strongly disagree) to 10 (strongly agree).

Optimistic bias was evaluated with two questions: "How likely do you think it is that you
will have a dengue infection?" and "How likely do you think it is that others around you
will have a dengue infection?" These two questions were measured on 11-point Likert

scales ranging from 0 (strongly unlikely) to 10 (strongly likely). The score of the first

214 question was subtracted from that of the second to categorize optimistic bias into three

- 215 groups: realistic (score zero), optimistic (positive score), and pessimistic (negative score).

#### 217 **Demographic variables**

218 Sex, residency, education, job, age, and income were the demographic variables. Sex was

219 categorized as male and female. Residency was categorized into five regions: north,

220 central, south, east, and outlying islands. Education was classified into two levels: higher

- than high school and equal to or below high school. Job experience was categorized as no
- job experience in dengue control and relevant job experience. Age and average household

223 monthly income were continuous variables.

# 225 Statistical analysis

The dimensions of ME and AR were assessed separately, as the questions described different feelings. The independent variables were demographic factors and perceived risks. To identify the most suitable model, supervised backward selection with a  $\chi^2$  test at a 0.05 significance level was used with Poisson and negative binomial models. The Akaike Information Criterion (AIC) determined the final model, based on the lowest value. All model selections and tests were in R version 4.2.2 [19, 20].

## 233 Ethics Statement

This study utilized an online questionnaire that was previously reviewed and approved by 234 the Research Ethics Committee (REC) of National Taiwan Normal University under 235 approval number 202312HS019. As this study was conducted anonymously, no personal 236 identifying information was collected through the online platform, ensuring participants' 237 privacy and confidentiality. Participants were informed about the purpose of the research 238 239 at the beginning of the online questionnaire, and their voluntary participation was implied 240 by their completion of the survey. The study adhered to ethical principles for research 241 involving human participants, particularly with respect to anonymity and the protection 242 of data collected through online methods.

# 244 **Results**

245

246 During the survey, 818 individuals completed it and responded validly. Participants under 247 the age of 18 (N = 4) and those residing in the eastern (N = 10) and outlying islands (N = 248 3) were excluded. The exclusions based on residency in the eastern and outlying islands 249 were for statistical considerations. Consequently, the final sample consisted of 801 250 individuals.

251

Among the participants, females (N = 531) were more than males (N = 270). Most respondents had a higher education level than high school (N = 677), while a smaller

portion had an education level equal to or below high school (N = 077), while a smaller portion had an education level equal to or below high school (N = 124). Additionally, a

larger group reported no job experience in dengue control (N = 683) compared to those

- with relevant job experience (N = 118). In terms of residency, participants were
- distributed across the south (N = 466), central (N = 116), and north (N = 219) regions.

The age range of participants was from 18 to 88 years, with an average age of 46.3 years.

- Both perceived prevalence and perceived severity of dengue ranged from 0 to 10, with  $\int \int \int \int \partial f dx$
- 260 mean scores of 6.5 and 5.0, respectively. Regarding the optimism bias variable, the
- majority of respondents were classified as realistic (N = 533), followed by those in the
- optimism (N = 205), and pessimism groups (N = 63).

### 264 High dengue risk (i.e., southern region)

The total number of participants in the high dengue-risk region was 466. More 265 participants were female (N = 310), had a higher education level than high school (N =266 267 365), and lacked job experience in dengue control (N = 384), when compared to males (N = 156), those with an education level equal to or below high school (N = 101), and those 268 with job experience in dengue control (N = 82). Participants' ages ranged from 18 to 83 269 270 years, with an average age of 49.4 years. In terms of perceived risks, both perceived 271 prevalence and perceived severity of dengue ranged from 0 to 10, with mean scores of 6.9 and 5.0, respectively. The optimism bias variable showed that the largest proportion 272 of participants were in the realistic group (N = 308), followed by the optimism (N = 121), 273 274 and pessimism groups (N = 37).

275

For the ME dimension in the southern region, due to a lower AIC, the negative binomial

- model (AIC = 3063.30) was used instead of the Poisson model (AIC = 3257.76) for
- evaluating the associations. By applying the negative binomial model, no specific

significant predictors were identified for the feelings of boredom and annoyance

- associated with dengue messages in southern Taiwan (Table 1).

Given the lower AIC, the negative binomial model (AIC = 2891.50) was chosen over the Poisson model (AIC = 3112.21) to evaluate associations related to message fatigue in the

AR of the southern region. The model indicated that individuals with an education level

equal to or below high school reported significantly higher levels of boredom and

- annoyance compared to those with a higher education level (1.10, 95% CI = 1.01-1.21)in southern Taiwan (Table 1).
- 289

### 290 Medium dengue risk (i.e., northern region)

- 291 The region of medium dengue risk had 219 participants. Among them, females (N = 148)
- outnumbered males (N = 71). A lesser percentage of respondents (N = 7) had education
- levels equal to or below high school, whereas the majority (N = 212) had higher
- education levels. Furthermore, compared to those with relevant job experience (N = 13),

295	a larger group (N = 206) reported no prior experience in dengue control. Participants
296	ranged in age from 18 to 88 years, with an average age of 39.5. With average scores of
297	5.8 and 4.8, respectively, the perceived severity and prevalence of dengue ranged from 0
298	to 10. A large proportion of respondents ( $N = 153$ ) were categorized as realistic regarding
299	the optimism bias variable, followed by those in the optimism $(N = 52)$ and the
300	pessimism groups ( $N = 14$ ).
301	
302	Due to a lower AIC for message fatigue when considering the ME, the negative binomial
303	model (AIC = $1351.00$ ) was applied rather than the Poisson model (AIC = $1392.81$ ) to
304	evaluate the association. The model showed that the optimistic bias variable ( $p = 0.027$ )
305	was the only predictor. The result indicated that the optimism group was 1.122 times
306	more likely (95% CI = $1.011-1.246$ ) to feel frustrated by a large number of dengue
307	messages than the realistic group. However, compared to the realistic group, the
308	pessimism group did not feel significantly more frustrated with the overabundance of
200	dengue massage (Table 2)

Regarding AR, the negative binomial model (AIC = 1306.28) was chosen instead of the Poisson model (AIC = 1390.88). However, applying the negative binomial model did not

identify any significant predictors for message fatigue in the AR of the north region(Table 2).

316

### 317 Low dengue risk (i.e., central region)

In the region with low dengue risk, more participants were female (N = 73), had higher 318 education levels than high school (N = 100), and lacked job experience in dengue control 319 (N = 93), when compared to males (N = 43), those with education levels equal to or 320 below high school (N = 16), and those with job experience in dengue control (N = 23). 321 322 Ages ranged from 18 to 79 years, with an average of 45.8 years. Perceived risks of dengue showed both prevalence and severity ranging from 0 to 10, with mean scores of 323 6.4 and 5.0, respectively. The optimism bias variable indicated that the majority of 324 325 participants fell into the realistic group (N = 72), followed by the optimism group (N = 32), and the pessimism group (N = 12). 326

328 329	For ME in the central region, due to a lower AIC, the negative binomial model was chosen (AIC = $735.75$ ) instead of the Poisson model (AIC = $639.12$ ) for evaluating the
330	associations. Significant predictors were age ( $p = 0.027$ ), sex ( $p = 0.033$ ), and education
331	(p = 0.010). Younger individuals (0.995, 95% CI = 0.991–0.999), males (1.145, 95% CI
332	= 1.010-1.298), and people with education levels equal to or below high school (1.255,
333	95% CI = $1.058-1.489$ ) felt more frustrated with an overabundance of dengue messages
334	compared to older individuals, females, and people with higher education levels (Table
335	3).

It was decided to use the negative binomial model (AIC = 706.53) rather than the Poisson
model (AIC = 759.88) to assess associations related to message fatigue in the AR
dimension due to the lower AIC. However, by applying the negative binomial model, no
significant predictors for message fatigue in the AR of the central region were identified
(Table 3).

# 344 **Discussion**

345

In this cross-sectional study, we assessed the two dimensions of message fatigue across 346 347 different regions, which represented varying levels of dengue risk, and analyzed them in 348 relation to demographic factors and perceived risks. The study found that predictors of message fatigue varied across regions with different levels of dengue risk. In the high 349 dengue-risk region, no significant predictors were identified for the ME dimension, while 350 education was a significant predictor for AR. Combining ME and AR, in the high 351 dengue-risk region, people with an education level equal to or below high school had 352 353 higher message fatigue compared to those with a higher education level (above high school). In the medium dengue-risk region, optimism bias was the only predictor for the 354 ME dimension, and AR had no predictor. This indicates that people in the optimism 355 group were more likely to experience dengue-message fatigue compared to those in the 356

realistic group. In the low dengue-risk region, age, sex, and education were significant
predictors for ME, while no significant predictors were identified for the AR dimension.

359 This means that younger individuals, males, and people with an education level equal to

360 or below high school had a higher level of message fatigue.

361

362 This study showed that individuals with lower education levels had higher denguemessage fatigue in the southern and central regions, which represented high and low 363 dengue risks, respectively. The tendency for individuals with lower education levels to 364 experience higher health-message fatigue could be attributed to several factors. One 365 factor is that individuals with lower education levels may have less prior knowledge or 366 367 experience with health-related topics. According to Cognitive Load Theory [21], the cognitive effort required to process, understand, and integrate new health information is 368 greater for these. This increased cognitive load may limit their ability to fully 369 comprehend and engage with health messages, leading to mental exhaustion, confusion, 370 371 and fatigue [21, 22]. Another factor could be psychological exhaustion. The psychological impact of prolonged exposure to health messages can cause burnout. 372 373 Individuals with low education levels might not have the coping mechanisms [23, 24] or support systems [23, 25] to process ongoing health communications effectively. 374 Therefore, they may experience this fatigue more acutely. To mitigate their fatigue, 375

simple [21], relevant [26], and engaging [27] dengue messages could be considered.

377

378 Younger individuals in low dengue-risk central Taiwan exhibited a higher level of 379 dengue-message fatigue in this study. While this phenomenon has not been specifically 380 observed in dengue messaging, it has been seen in other types of messages, such as anti-381 tobacco [11] and COVID-19 vaccine booster uptake [28]. The tendency of younger 382 individuals to experience greater message fatigue may be because they, especially those active on social media and other digital platforms [29], are often exposed to a higher 383 384 volume of information than older individuals are. Repeated exposure to the same or similar messages, such as those related to dengue, can lead to saturation and fatigue when 385 the messages no longer feel relevant or urgent. Additionally, younger people often 386 perceive themselves as less vulnerable to diseases [30, 31]. If they believe they are not at 387 significant risk, they may view repeated messages as unnecessary or irrelevant, leading to 388 389 disengagement and fatigue. Furthermore, in Taiwan, the way dengue prevention 390 messages are framed or delivered might not resonate well with younger audiences. If the communication does not align with their interests, values, or preferred communication 391 392 channels, it can lead to disinterest and fatigue [32, 33]. Messages could be designed in 393 formats and delivery channels that align with younger people's digital habits and interests 394 [34, 35]. By making the messages feel fresh, relevant, and interactive, the campaign can 395 better combat message fatigue and effectively engage this group [36-39].

396

In addition to younger individuals, males were also identified as predictors of denguemessage fatigue in central Taiwan (i.e., low dengue risk), compared to females. This
finding is interesting because most studies report higher message fatigue in females [12,

400 40, 41], with fewer examples of fatigue in males [11]. In this study, males exhibited a

401 higher level of message fatigue, which could be due to the fact that males are less likely

than females to seek out health information actively in Taiwan [42, 43]. Therefore, when

males are exposed to health messages, they might find them more overwhelming, leading 403 to quicker fatigue. Another possible explanation is that males may not engage with health 404 messages on an emotional level as deeply as females do [44, 45]. This lack of 405 406 engagement could lower the threshold for perceiving messages as repetitive or unimportant, thus increasing fatigue. Males may also be more resistant to certain types of 407 408 health messaging, particularly those that challenge their independence or self-reliance. For example, messages that encourage using mosquito repellents, wearing long sleeves, 409 or using bed nets might be seen as an imposition on their usual routines or as suggesting 410 that they cannot protect themselves without these aids. This resistance can increase 411 fatigue because they might perceive these messages as unnecessary. 412 413 Individuals in the optimism group were more prone to experiencing dengue-message 414 fatigue compared to those in the realistic group in northern Taiwan (i.e., medium dengue 415 risk), according to this study. In the optimism group, people tend to believe they are less 416

likely to be affected by negative outcomes compared to others, such as getting infected 417 with dengue [46, 47]. Therefore, even in areas with high prevalence, they may think, "It 418 won't happen to me," lowering the perception of personal risk. In our sample, people 419 420 living in the northern region had the lowest level of perceived prevalence for dengue compared to other regions, supporting this idea. This optimism bias results in message 421 fatigue because it causes individuals to perceive health messages as irrelevant or 422 423 unnecessary. This perception reduces their engagement with the messages and increases their resistance to the content, leading to fatigue. Another possibility is that optimistic 424 individuals may believe that their actions are sufficient to protect them, leading them to 425 disregard additional advice or warnings. This overconfidence reduces their receptivity to 426 ongoing messages, causing fatigue [48]. For this group, messages framed around 427 potential losses could be more impactful for those who might feel overly optimistic about 428 their situation. In other words, if messages focus on what they could lose, such as their 429 health, well-being, or the safety of their loved ones if they don't act, it could help them 430 431 take the situation more seriously and avoid being too relaxed about it.

This study demonstrated different demographic and perception-based predictors for 432 433 message fatigue across regions with varying risk levels. This implies that messages must be tailored to specific risk regions to achieve effective health communication. However, 434 this study has some limitations. First, while message fatigue was the focus of this study, 435 436 which could reduce motivation to participate in disease prevention, another possibility 437 that could also lower motivation is the boomerang effect. This effect occurs when people 438 believe their freedom is at risk, leading them to resist the advice of a message. Second, 439 this survey used convenience sampling. While convenience sampling is easy to use and inexpensive, making it beneficial in exploratory research, it is a nonprobability sampling 440 technique. Therefore, the samples in this study might not accurately reflect the entire 441 442 population (all Taiwanese citizens aged 18 years or older). Third, the survey was 443 conducted using an online questionnaire. Respondents might misunderstand questions, leading to inaccurate or inconsistent data. To minimize this misunderstanding, various 444 445 individuals pre-tested the questionnaire. Lastly, these findings can identify associations between message fatigue and other variables, but they cannot establish causality. 446
