## 26 Abstract

## 27 Background

COVID-19 resulted in vast disruption to life in the 21<sup>st</sup> century as governments implemented containment measures to quell disease spread. We assessed knowledge of local interventions and household coping strategies used to attenuate the impact of household hardships. We further examined associations between household and community characteristics with household hardships.

## 33 Methods

We conducted a cross-sectional household survey between August and September 2022 through a retrospective questionnaire fielded in the Health and Demographic Surveillance System (HDSS) operating in Bamako, Mali. Logistic regression was used to analyze associations between household characteristics, government interventions, and household hardships during the pandemic.

## 39 **Results**

The most commonly reported hardships were increases in food prices and food insecurity; roughly 18% of households reported experiencing at least 1 hardship. Common coping strategies included asking for help from family or friends (55.6%). Only 2.8% of households reported seeking government assistance. Households headed by younger individuals, males, and unemployed individuals were at greater risk of experiencing hardships. Government closure of businesses was strongly associated with household hardships.

### 47 **Conclusions**

Households in the Bamako HDSS experienced a variety of hardships during the pandemic the most prevalent hardships were increases in local food prices and food insecurity. The association between government closure of businesses and household hardships points to the need for balancing public health measures with socioeconomic considerations. Households headed by individuals with lower education and/or unemployed were at greater risk of experiencing a hardship. Future policies and interventions should target aid to households reflecting these characteristics.

## 58 Introduction

Repercussions from the COVID-19 pandemic extended far beyond direct health 59 consequences.(1) Governmental measures like lockdowns and curfews, implemented to control the 60 61 spread of SARS-CoV-2 (the virus that causes COVID-19), triggered a cascade of social and economic disruptions.(2, 3) These interventions, while helpful for curbing SARS-CoV-2 62 63 transmission, also led to economic strain, restricted access to food and healthcare, and pushed 64 vulnerable populations towards food insecurity and health risks. (4, 5, 6, 7, 8) Businesses, including 65 healthcare providers, were forced to close or limit services, potentially jeopardizing access to 66 essential care and resources (including sources of income) for vulnerable populations in the 67 community. Reduced access could have inadvertently amplified the virus's direct effects by 68 increasing vulnerabilities to undernutrition and other risk factors for severe illness. However, limited 69 population-based surveillance in resource-scarce settings has hampered our understanding of the 70 extent of resource restrictions and hardships experienced during the pandemic. This is particularly the 71 case for Mali, one of the poorest countries in the world with some of the highest levels of child 72 mortality and lowest life expectancy, where there remains a paucity of data on socioeconomic 73 impacts of the pandemic.

74 Vulnerability, broadly defined, is the cumulative effect of cultural, economic, institutional, 75 political, and social processes that amplify socioeconomic differences in the experience of and recovery from hazards.(9, 10) In the context of disasters, it is often not the hazard itself that creates 76 the crisis; rather, the crisis is the impact on individual and community coping patterns and on the 77 78 inputs and outputs of social systems.(11, 12, 13, 14) Social vulnerability is the result of social 79 disparities that shape or influence the susceptibility of different groups to hazards, while also limiting 80 their capacity to respond.(9, 15) Factors often associated with vulnerability include demographic characteristics such as age, ethnicity, race, and sex; socioeconomic status (e.g., income, wealth, 81 82 employment, education); household composition (e.g., presence of children or elderly); and built

environment (housing and transportation).(16) Social vulnerability also involves place disparities
stemming from community characteristics. For example, differential availability of scarce resources
between urban and rural areas may exacerbate vulnerabilities to hazards.(15, 17, 18, 19, 20) To
understand the broader consequences of the pandemic, it is important to consider economic, political,
and social markers of vulnerability at both the individual and community level.(21)

88 The arrival of COVID-19 in Mali, like in many other parts of the world, unleashed a wave of disruptions exceeding the immediate health threat. On March 18<sup>th</sup>, 2020, prior to its first confirmed 89 COVID-19 case, Mali enacted preventative measures like flight suspensions, school closures, and 90 public gathering bans.(22, 23) Following the first cases on March 25<sup>th</sup>, a state of emergency was 91 declared with a curfew implemented.(24) By March 28<sup>th</sup>, with the first death recorded, Mali had 92 restrictions comparable to North America and Western Europe.(22, 23) Mali's pre-existing 93 94 vulnerabilities, including poverty, food insecurity, limited healthcare access, a fragile agricultural 95 sector, climate sensitivity, dependence on regional ports, and ongoing conflict in some regions, likely 96 exacerbated the pandemic's impact.(25, 26) These vulnerabilities were further exacerbated by 97 restrictions on movement and overwhelmed healthcare systems, leading to increased food insecurity 98 and jeopardizing the health of vulnerable groups like children, pregnant women, and mothers. Data 99 limitations hinder a comprehensive understanding of these hardships and their differential effects. 100 Investigating the long-term consequences of these interventions within the context of Mali's unique 101 challenges can inform future pandemic preparedness and response strategies tailored to such settings.

Furthermore, understanding the level of knowledge about COVID-19 prevention measures among Malian households is important for assessing the effectiveness of public health messaging and interventions. Previous studies in sub-Saharan Africa have demonstrated positive associations between knowledge of COVID-19 symptoms, SARS-CoV-2 transmission, and prevention, and the implementation of public health measures like hand hygiene, social distancing, and facemask use.(27, 28) Additionally, knowledge of these measures has been linked to higher vaccination coverage, one

of the most effective strategies for protecting individuals against COVID-19 hospitalization and
 death.(29, 30, 31, 32) Understanding knowledge levels is useful for designing effective public health
 messaging and interventions tailored to the population context and needs.

111 This study leverages data from an existing Health and Demographic Surveillance System 112 (HDSS) in Mali to analyze the prevalence of hardships experienced during the pandemic as well as 113 knowledge about COVID-19 prevention measures held by Malian households. We focus on key areas 114 such as economic insecurity, food insecurity, healthcare access, and education disruptions, along with 115 exploring household responses to these hardships and their association with knowledge levels.(25, 116 26)

#### 118 Methods

119 Study Design

120 This cross-sectional study is part of a larger examination within the Child Health and 121 Mortality Prevention Surveillance (CHAMPS) network to assess implications and potential 122 consequences of pandemic-related measures, including lockdowns, social distancing, and related 123 policies aimed at stemming the transmission of SARS-CoV-2.(6, 7, 8, 33, 34) Specifically, the data 124 were gathered to increase understanding of how these measures may have contributed to broader 125 household socioeconomic challenges. This includes potential impacts on access to healthcare, food 126 availability, and livelihoods, among households, with particular focus on vulnerable groups such as 127 those with children and pregnant women residing in the Bamako HDSS.(35)

129 *Study Setting* 

Mali is a large, predominantly arid country in West Africa, covering over 1,241,238 square kilometers (~479,000 sq. mi) with a population of approximately 21.4 million. The population is predominantly Muslim, with a young age structure (nearly 50% under 15 years), high adult illiteracy

(64.5%), high adolescent fertility, and limited access to healthcare.(36) Mali's development and
health indicators rank among the lowest in the world according to the United Nations index.

In 2002, the Centre pour le Développement des Vaccins du Mali (CVD-Mali) was established 135 136 as a partnership between the Mali Ministry of Health and the University of Maryland, Baltimore, USA. CVD-Mali is a legal government entity working under the Ministry of Health. Since its 137 inception, CVD-Mali has been dedicated to describing the epidemiology of infectious diseases, 138 139 supporting the development of vaccines, and training a team of local researchers. In 2006, CVD-Mali 140 established an HDSS in two quartiers (neighborhoods) in Bamako. One neighborhood, Banconi, is 141 situated in Commune 1 and is in the eastern part of the city, north of the Niger River, and occupies an area of 6.23 km<sup>2</sup>. In 2022, the population was estimated at 153,490. The second neighborhood is 142 Djikoroni-para; it has a surface area of roughly 5 km<sup>2</sup>. It is situated in Commune 4 and is in the 143 144 western part of Bamako. The estimated population was 82,422 in 2022. Both neighborhoods are 145 densely populated, and the population largely subsists on small business activity, government 146 employment, foreign remittances, and trade. The Bamako HDSS generally conducts biannual 147 demographic data collection rounds as part of its surveillance.

#### 149 Participants and Recruitment

150 For this auxiliary study, participants were recruited between August and September 2022. 151 Study participants comprised a qualifying representative (the household head or an adult household 152 member with good knowledge about the household). All households within the Bamako HDSS were 153 eligible for selection into the study, which was implemented during regular HDSS round visits. We used proportion to population stratified random sampling to identify a random sample of 454 154 155 households stratified across the two communities covered by the HDSS. Simple random sampling 156 was executed within the two catchment areas (strata) with the goal of obtaining samples from the two strata that were proportionate to the population of households residing therein—as all households 157

actively participate in broader HDSS activities, we obtained a 100 percent response rate. Ultimately, we collected data from 317 households residing in Banconi and 137 households residing in Djikoroni, representing 69.8% and 30.1% of the sample respectively. The study adopted the definition of households and household members used by the HDSS.

#### 163 *Survey Instrument*

164 The survey instrument was designed following established methods, (37) which included identifying key concepts, framing research questions, conducting literature reviews, and drawing 165 166 from preexisting questionnaires, such as the "High-Frequency Mobile Phone Surveys of Households" 167 to Assess the Impacts of COVID-19" standardized survey instrument prepared by the World Bank for 168 assessing direct and indirect socioeconomic consequences of the COVID-19 pandemic.(38) A 169 standardized survey instrument was prepared in English for implementation across the CHAMPS 170 network, with adaptations for local contexts. The final questionnaire was organized into six sections: 171 respondent identification, SARS-CoV-2 knowledge and practices; histories of symptoms; contacts 172 with people that have COVID-19 symptoms; household economic impacts of COVID-19; and the 173 impacts on healthcare access for household members (see supplementary materials). The instrument 174 did not seek to ascertain COVID-19 cases. The survey prompted participants to reflect on household 175 experiences since March 2020.

# 177 Data Collection and Quality Assurance

Data collection was conducted electronically using tablets programmed with RedCAP,(39) with both English and French translations of the instrument presented at the same time. Communication with study participants was in their preferred language. If a fieldworker could not communicate in the preferred language of the respondent, an interpreter was sought from within the household, or the household was revisited at another time by a fieldworker who could communicate

in the preferred language. Data cleaning adhered to standard procedures for the HDSS;(40, 41) data collectors and supervisors were trained on the study objectives, data confidentiality, and data collection techniques. Data quality concerns such as data inconsistencies, implausible values, or incomplete data were identified and flagged for reconciliation, which was completed by data collectors through return visits to the household.

#### 189 *Statistical Analysis*

190 Measures

The primary outcome variable of interest was a dichotomous indicator for whether a household reported experiencing at least one type of hardship since the onset of the COVID-19 pandemic (i.e., during the 1 to 1 1/2 years since March 2020). Information on these household hardships were gathered from the following survey question: "Has your household been affected by any of these events since mid-March (2020)?" Responses included job loss, business closure, increases in the price of the main food products consumed, increases in the price of agricultural or commercial inputs, and having a household member detained (see Figure 1).

198 Additional descriptive analyses were performed to describe government responses to COVID-199 19 and household coping strategies to experiencing any of the hardships listed above. These 200 variables were based on data collected through the following questions: "What steps has your 201 community/government taken to curb the spread of the coronavirus in your area?" and "How did your household cope with these difficulties [hardships] encountered since mid-March (2020)?" 202 203 Corresponding answers related to government responses included advised citizens to stay home, 204 advised citizens to avoid gatherings, closure of non-essential businesses, closure of schools and 205 universities, curfew/lockdown, disinfection of public places, established isolation centers, 206 sensitization/public awareness, travel restrictions, and other. Responses related to household coping strategies included borrowed from family or friends, delayed payments, generated additional income, 207

208 government help, help from family or friends, NGO help, reduced food consumption, reduced non-209 food consumption, relied on savings, requested a pay advance, sold assets, sold harvest, took out a 210 loan, and other. For each question, data collectors were instructed to select all applicable response 211 categories; each response category was recoded into a unique variable coded as 0 = No (reference), 1 212 = Yes.

213 Right-hand side variables. Head of household variables were age (coded as  $1 = \langle 40 \rangle$ 214 (reference), 2 = 40 to 49, 3 = 50 to 59, 4 = 60+, 5 = Don't Know); sex (coded as Female = 0) 215 (reference) and Male = 1); education (coded as 1 = None (reference), 2 = Primary, 3 =216 Secondary/Post-Secondary, 4 = Don't Know; occupation (coded as 1 = Unemployed (reference), 2 =217 Professional, 3 =Sales, 4 =Manual Labor); ethnicity (coded as 1 =Bambara (reference), 2 =Fula/Malinke/Senufo, 3 = Songhai/Songinke/Tuareg, 4 = Other); and marital status (0 = Not Married 218 219 (reference), 1 = Married; original marital status categories combined in the reference category 220 included divorced, single/never married, widowed, separated, and other). Household variables included household size (coded as 1 = 1-4 (reference), 2 = 5-7, 3 = 8-9, 4 = 10+) and residence 221 222 (coded as 0 = Banconi (reference), 1 = Djicoroni). In preliminary analyses, we also assessed presence 223 of either children under the age of 5 as well as adults older than the age of 65+; however, these 224 variables were not statistically significant in any of the models that they were included in and the 225 models performed better with their exclusion. Government responses to COVID-19 were included as 226 dichotomous variables coded as (0 = No, 1 = Yes) depending on whether a household reported that a 227 given response intervention was implemented in their local neighborhood. Household responses were 228 collected using the following question: "What steps has your community/government taken to curb 229 the spread of the coronavirus in your area?" Interviewers were instructed to read aloud the following 230 list of possible interventions and to select all that applied: None; Advised citizens to stay at home; Advised to avoid gatherings; Restricted travel within country/area; Restricted international travel; 231 Closure of schools and universities; Curfew/lockdown; Closure of non-essential businesses; 232

Sensitization/public awareness; Established isolation centers; Disinfection of public places; Other;
Don't know; and Refused to respond. From these responses, the following variables were generated:
stay home; avoid gatherings; travel restrictions (composite of domestic and international travel
restrictions); school closures; lockdowns; business closures; public awareness; isolation centers; and
disinfection.

#### 239 Analytic Strategy

Data preparation and analysis was completed using R version 4.2.0.(42) Missing values were 240 241 less than one percent of the total observations and addressed through listwise deletion in analytic 242 models. Descriptive statistics were reported for head of household and household characteristics. 243 Cross-tabulations combined with  $\chi^2$  tests of right-hand sided variables with the dependent variable 244 were generated to describe potential relationships between these categorical variables. Unadjusted 245 logistic regression models were executed to further examine associations between characteristics of 246 the head of household, household, and government responses to COVID-19 with the dependent 247 variable household hardships. A final model adjusted association between the dependent variable and 248 right-hand sided variables by controlling for other variables included in the model. Right-hand sided 249 variables were retained in the final adjusted model if their inclusion had theoretical justification 250 based on extant literature; we assessed model fit with a comparison of Akaike Information Criterion 251 (AIC) and Bayesian Information Criterion (BIC) scores-the smallest scores were for the fully 252 adjusted model, indicating that this model had superior fit compared to simpler models. Results from 253 the final logistic regression model are reported as adjusted odds ratios (AOR) with 95% confidence 254 intervals (95% CI) and visualized with forest plots.(43, 44) We explored potential effect modification 255 of association based on location of household residence (Banconi vs. Djicoroni) through modeling 256 interaction effects; these explorations failed to yield statistically significant results and are not 257 reported.

#### 259 **RESULTS**

The median and modal age category of household heads was 50-59 years; most households 260 261 (86.3%) were headed by a male household member and most household heads (87.6%) were married (Table 1). Almost half of household heads had no education and another 28.2% had a primary level 262 263 education. The most common occupation categories were manual labor (34.7%) and sales (24.3%); a 264 little over 1 in 5 household heads were unemployed. Bambara was the most common ethnic group (35.2%); Fula/Malinke/Senufo and Songhai/Songinke/Tuareg represented about 33.0% and 16.7% of 265 266 households respectively. Median household size was 8-9 household members. Roughly 70% of 267 households resided in Banconi with the remaining 30% residing in Djicoroni.

268 The most common hardship reported by households was increases in food prices and food 269 insecurity (Figure 1). However, a little less than 80% of households reported that they did not 270 experience any of the hardships measured during the observation period; roughly 18% reported 271 experiencing at least 1 hardship (Figure 2). The overall pattern of the number of hardships 272 experienced during the pandemic is presented in Figure 3. Among those households that reported 273 experiencing at least one hardship during the pandemic, the coping strategies most frequently 274 reported were to ask for help from family or friends (55.6%) and to borrow from family or friends 275 (47.2%). Only 2.8% of households reported seeking out government assistance and no households 276 reported seeking out assistance from an NGO (Figure 4). Most households reported utilizing only one or two coping strategies; the maximum number of strategies implemented was four (Figure 5). With 277 278 regards to government responses to COVID-19, a majority of households reported local implementation of advisories to avoid gatherings (89.9%), advisories to stay at home (85.2%), travel 279 280 restrictions (64.8%), closures of schools and universities (58.4%), and curfew/lockdowns (56.6%). Less than 20% of households reported business closures (see Figure 6). A visualization of the number 281 of government responses is presented in Figure 7 (see Table 1.1 for additional details). 282

283 After adjusting for other characteristics (see Figure 8), households were more likely to report 284 experiencing at least one hardship during the pandemic if the household head was less than 40 years old (AOR = 3.36, 95% CI [1.23, 9.32]) or between 40 to 49 years old (AOR = 3.06, 95% CI [1.30, 285 286 (AOR = 3.91, 95% CI [1.27, 12.50]) compared to 287 female, was an "Other" ethnic group compared to Bambara (AOR = 4.42, 95% CI [1.88, 10.64]) or if their residence was located in Banconi as compared to a Djicoroni (AOR 6.17, 95% CI [2.13, 288 20.17]). Compared to households with 1 to 4 household members, larger households were more 289 290 likely to have reported experiencing at least one hardship, but these differences were not statistically 291 significant. Finally, after adjusting for other characteristics, households were more likely to have 292 reported experiencing at least one hardship if the government had closed businesses in the local area (AOR = 18.62, 95% CI [8.62, 42.11]). Conversely, households were less likely to report experiencing 293 294 at least one hardship during the pandemic if the household head's occupation was reported as 295 professional (AOR = 0.21, 95% CI [0.06, 0.72]), sales (AOR = 0.40, 95% CI [0.16, 0.97]), or manual 296 labor (AOR = 0.39, 95% CI [0.16, 0.97]). It is noteworthy that in an unadjusted analysis, households 297 were less likely to have reported experiencing at least one hardship if the head of household had 298 either a primary (OR = 0.41, 95% CI [0.23, 0.72]) or secondary/post-secondary (OR = 0.51, 95% CI 299 [0.27, 0.91]) level education compared to no education; however, after adjusting for other variables, 300 this association was no longer statistically significant. Households were also less likely to have 301 reported experiencing at least one hardship if the government had directed citizens in the local area to 302 stay home (AOR = 0.10, 95% CI [0.03, 0.31]) or had taken efforts to disinfect public areas (AOR = 303 0.23, 95% CI [0.10, 0.51]). As noted above, interaction terms included in statistical models to assess 304 potential effect modification of association based on location of household residence (Banconi vs. 305 Djicoroni) did not yield statistically significant results.

## 307 DISCUSSION

308 In this study, we examined the prevalence of households experiencing any of a variety of 309 hardships during the COVID-19 pandemic in Bamako, Mali. We further examined demographic, 310 economic, and social characteristics of individuals and households associated with these hardships. 311 A little less than 20% of households reported experiencing at least one hardship since the 312 onset of the pandemic, the most commonly reported hardship was an increase in local food prices. 313 This is somewhat lower than anticipated compared to similar studies conducted in other countries. (6, 7, 8) This may reflect the degree to which challenging circumstances are already omnipresent in 314 315 Mali; e.g., we found that among households residing in the two Bamako areas almost half of 316 household heads had no education and 1 in 5 reported their occupation as *unemployed*, findings that 317 are consistent with WHO findings that adult illiteracy is approximately 65 percent. (36) Individual-318 level risk factors for experiencing these hardships included head of household characteristics such as 319 younger age, male, and unemployment. At the household level, location of residence was likewise a 320 risk factor. These associations are largely consistent with risk factors reported in studies from other 321 resource-limited countries.(45, 46, 47, 48) Future interventions that seek to mitigate negative 322 consequences associated with pandemic mitigation efforts should anticipate these characteristics as 323 important risk factors and target interventions to aid vulnerable groups.

324 The empirical findings from this study are specific to the community living within the study 325 site; a limitation common to studies using HDSS data.(49) In addition, the relatively low overall 326 prevalence of reported hardships limited the ability to comprehensively explore associations between 327 sociodemographic characteristics and specific hardships experienced by households. However, the 328 pattern of our findings are generally consistent with findings reported in other studies from sub-329 Saharan African countries.(6, 7, 8) As an observational study, other potential limitations include 330 unmeasured variable bias (we did not gather information related to food insecurity beyond increases in local food prices such as severity or duration of food insecurity which might underestimate the true 331 332 impact of hardships; we also did not collect data on potential psychological stress or mental health

333 impacts) or recall bias due to the extended length of time considered in the study (i.e., some 334 respondents may have forgotten hardships that occurred closer to the onset of the pandemic). In preliminary analyses, we considered evaluating additive and Principal Component Analysis (PCA) 335 336 based indices of these household hardships; however, we concluded that the combination of these 337 variables resulted in a poor fit for an index after evaluating the additive index via Cronbach's Alpha 338 scores and the results of the PCA analysis. We cannot draw causal inferences given the cross-339 sectional nature of the study. Results from other studies suggest some hardships associated with the 340 COVID-19 pandemic are ephemeral.(50) Looking forward, scholars could collect and analyze 341 longitudinal data to evaluate hardship events over time to assess the extent to which some hardships 342 may have lingering effects or effects that change over time and explore potential causal relationships. 343 Demographic surveillance systems present an efficient platform for follow-up data collection using 344 the same survey instrument attached to subsequent rounds of regular data collection. Households 345 reported relying almost exclusively on assistance from family and friends as coping mechanism 346 during the pandemic; in future research, scholars could formally explore the role and impact of 347 financial remittances as a specific form of assistance provided across social relationships.

348 Households in the Bamako HDSS reported experiencing a variety of hardships during the 349 COVID-19 pandemic, with the most prevalent hardships being the increase in local food prices, food 350 insecurity, and job loss. Government closure of businesses was strongly associated with households 351 at risk of experiencing a hardship during the observational period-this points to the need for 352 balancing public health measures with economic considerations during pandemics. Households 353 headed by individuals with lower education and/or unemployed were generally at greater risk of 354 experiencing a hardship. Future policies and practices aiming to mitigate the negative consequences 355 of COVID-19 and future disease outbreaks could anticipate households reflecting these 356 characteristics will disproportionately experiencing socioeconomic hardships.

#### 359 **Ethics approval and consent to participate**
