Investigating Nutritional Interventions for Managing Irritable-Bowel Syndrome: A Bibliometric Analysis

### **Abstract:**

**Background:** The bibliometric analysis provides a structured approach for providers and researchers to access clinically relevant information to improve patient care.

**Methods:** We used SCOPUS as our database and made a list of the top 50 most-cited articles from 2002 to 2022. Variables analyzed included

citation count, annual citations, publication year, journal with impact factor, author details, country, institution, and funding.

**Results:** Citations for 50 articles varied from 67 to 919, with a median of 129 and an IQR of 210. Most of the articles (n = 34) were published between 2013 and 2018. The number of authors per article ranged from 3 to 18. Munir J.G. coauthored the most significant number of articles (n = 7). The top countries of origin for the articles were the UK (n = 15), the USA (n = 10), and Australia (n = 7). The dietary interventions discussed in our list included low FODMAP (n = 27), probiotics (n = 6), GFD (n = 4), an Ig4 exclusion diet (n = 3), and other interventions (n = 10). Female authors were the first authors in 30 articles and senior authors in 19 articles, compared to their male counterparts.

**Conclusions:** An analysis of the top 50 cited articles on nutritional interventions in IBS highlights interest and impact trends, aiding policymakers in funding decisions. The predominance of a low-FODMAP diet underscores the focus on efficacy, potentially guiding standardized dietary guidelines.

### **Introduction**

Irritable Bowel Syndrome (IBS) is a gastrointestinal disorder that affects approximately 4% of the world's population, with a two-fold higher prevalence among women [1, 2]. Given that the pathophysiology of the disease is multifactorial and unclear, it is well documented that patients with IBS have limited treatment options and exhibit poor quality of life linked to more frequent use of healthcare services as an additional financial burden [3].

Individuals with IBS often link their symptoms to particular foods, which results in diet restriction that may lead to nutritional deficiencies and malnutrition [4, 5]. Nutritional interventions, especially the dietary restriction of fermentable carbohydrates (commonly termed the 'low FODMAP (fermentable oligosaccharides, disaccharides, monosaccharides, and polyols) diet'), have gained popularity in treating IBS [6–8]. Dietary components significantly impact the gut microbiome composition and can subsequently affect IBS symptoms. Exploring nutritional interventions can also offer valuable insights into how to use this interplay for the treatment of IBS. There have been several publications on the most-cited articles related to IBS [9–14]; however, none of these listings specifically focused on nutritional interventions for IBS, and there is a lack of evidence-based dietary guidelines for the management of IBS. Therefore, our research can help establish standardized nutritional recommendations for patients.

Bibliometric analysis is an easy-to-understand analytical method used to assess the trends and frequency of citations in the published literature. Evidence-based medicine requires practicing physicians to be up-to-date with relevant research in their field to best serve patients, according to the latest guidelines. Bibliometrics provide physicians with a body of knowledge and a collection of the most influential research papers in their field [15]. Citation analysis can help direct medical research funding to specific areas needing increased research activity by

examining research articles' relevance, significance, and impact [16]. To fill the existing gap in knowledge, we have carried out a targeted bibliometric analysis to assess the most significant articles about this area of study.

### **METHODS**

### **Literature Search and Search Strategy:**

We used the Scopus database to retrieve the relevant articles for our bibliometric analysis. Published analyses and comparisons have demonstrated that, in the context of scientific publications, Scopus exhibits a broader scope of coverage than alternatives such as PubMed, Web of Science, and Google Scholar [15, 17]. Two reviewers (Sadaf Iftikhar and Saad Ahmed) independently searched Scopus in December 2023, with a time restriction from 2002 to 2022. Any reviewer discrepancies were resolved by consulting the third reviewer (Faraz Arshad).

The search strategy to obtain articles on IBS and nutritional interventions involved using ((Irritable AND Bowel AND Syndrome) OR (Colitis AND Mucous) OR (Colon AND Irritable)) AND ((Diet OR Disaccharides OR Monosaccharide OR Simple AND Sugars)). All individual search terms and words were searched in the article titles, abstracts, and keywords.

### **Inclusion and Exclusion Criteria:**

The initial compilation of articles retrieved from Scopus consists of those identified under the journal articles category. Two reviewers (Sadaf Iftikhar and Saad Ahmed) separated the original articles from the review studies. Exclusively including original articles allows for more direct analysis of primary research findings, enhancing the study's credibility by minimizing potential biases introduced by interpretations or summaries found in review articles. Studies on non-human subjects, those without abstract availability, and those in languages other than

English were excluded. The selected two-decade period ensures that our study incorporates the latest advancements in research on nutritional interventions for managing irritable bowel syndrome. Additionally, including all journals provides comprehensive coverage of the relevant literature, minimizing the risk of overlooking valuable research from diverse sources.

#### **Data extraction:**

The search yielded 29637 studies in total. The abstracts were then analyzed to assess their relevance to the topic and determine whether they were suitable for inclusion. The articles obtained were consolidated and systematically organized using the 'cited by' option. The final list comprised the 50 most-cited articles. Any reviewer discrepancies were resolved by consulting the third reviewer (Faraz Arshad). The concordance rate between the reviewers was 95%. Citation analysis of the 50 most cited articles was conducted using Scopus, and the chosen articles were manually screened. Data on each publication were extracted, encompassing the total citation count, mean citations per year, trends of articles and citations over the years, publication year, journal name along with its impact factor (IF), author count, author's H-index, gender of first and last author titles, references, keywords, country of origin, institutional affiliation, and funding information. The mean, median, and IQR were computed for the total number of citations and the number of citations per year. Journal impact factors were acquired from Thomson Reuters' Journal Citation Reports. The gender of the first and senior authors was ascertained by reviewing their photographs on institutional websites or noting the pronouns used to address them. It is agreed upon in existing literature that the last authorship position is held by the author with the most significant degree of seniority; for that matter, we reviewed authors in the first and previous positions. When an article had a solitary author, that author was considered the senior author [18].

### **Data Analysis:**

Tables and charts were generated using Microsoft Excel 2016. IBM SPSS Statistics 23.0 was employed to conduct the Spearman correlation test, which assessed the correlation between the journal impact factor and the total number of citations by papers from our 50 list within that journal. A p-value of <0.05 was considered statistically significant.

### **Results**

### Citation Count, Citation Per Year, Citation Trend:




Figure 1: Total Citations of articles in the list each year

Table 1 shows the 50 most cited citations and total citations per year. The number of citations for these 50 articles ranged from 67 to 919, with a median of 129.00 and an interquartile range of 210. The citations for all articles total 10515. The number of citations per year ranged from 4.3 to 102. The median, mean number, and IQR of citations per year were 15.9, 23.3, and 20.2, respectively. Figure 1 shows the trend of the total citations of the 50 articles in the list by year. There was a rapid rise in the total number of citations, starting in 2004, which almost doubled in 2013, followed by a significant drop in 2015, after reaching a maximum in 2017. After a minor drop in 2018, a significant decrease occurred in 2019.

# Journal, institutional affiliation, and Funding Sponsor:

The 50 most-cited articles were published in nine different journals. The top four journals produced over half of the articles. The top 4 journals include Clinical Gastroenterology and Hepatology (n = 8, 16%), followed by Gastroenterology (n = 7, 14%), American Journal of Gastroenterology (n = 5, 10%), and Gut (n = 4, 8%). Table 2 shows journals that have included more than one article in the most cited 50.




Figure 2: Scatter Plot of citations by Impact Factor

The IF of these journals ranged from 3.3 to 29.4. We found a direct and significant association between the journal impact factor and several citations received by articles from our list published in that journal with a p-value of 0.04 using the Spearman correlation test. (Figure 2)




Figure 3: Institutions affiliated with articles

Our list of articles featured a diverse range of affiliations with various institutions. Notably, Monash University led with seven articles. Following closely behind it were the Guys and St Thomas NHS Foundation, the Faculty of Medicine, Nursing, and Health Sciences, with five publications, and Hospital Universitario Vall Hebron, with four publications, as shown in Figure 3.




Figure 4: Sources of Funding

The National Institute of Diabetes and Digestive Kidney Disease and the National Institute of Health have contributed to the funding of three articles and are closely followed by the Faculty of Medicine, Nursing, and Health Sciences at Monash University, Goteborgs University, and the Marianne and Marcus Wallenberg Foundation with two articles, as shown in Figure 4.

## Year of Publication, Origins, and Authorship:




Figure 5: Number of articles in our list each year




Figure 6: Number of articles originating from each country




Figure 7: Number of articles by Top authors

The 50 most cited articles were published between 2002 and 2022. During these 20 years, the most significant number of articles (n = 34,68%) were published in five years, from 2013 to 2018 (Figure 5). The 50 most-cited papers originated from 8 countries, with over 15 articles from the United Kingdom. The three most popular countries of origin were the UK (n = 15,30%), the USA (n = 10,20%), and Australia (n = 10,20%), and Australia 7,14%) (Figure 6). A vast range of 263 authors contributed to 50 articles, and the number of authors per article ranged from 3 to 18. Each paper has a median of 7 authors with an interquartile range of 4. The authors with five or more articles are shown in Figure 7. The most significant number of most-cited articles were coauthored by Munir J.G., numbering (n = 7,14%) articles, followed by Gibson P.R. with (n =6,12%) articles, Irving P.M., Staudacher H.M., and Whelan K, numbering (n = 5,10) articles, as shown in Table 3. The authors' H-index highlights the role of the author in the scientific world as determined by the author-specific citation frequency, which is also included in Table 3. The H-index ranged from 26 to 82, among which Gibson, P.R., had the highest H index of 82.

### **Topical distribution:**

Nutritional interventions discussed in the 50 most cited articles are shown in the last column of Table 1. Among the 50 articles, a low FODMAP diet is discussed in (n = 27,54%), followed by probiotics mentioned in (n = 6,12%) articles, a gluten-free diet in (n = 4,8%) articles, an Ig4 exclusion diet in (n = 3,6%) articles, and other dietary approaches in (n = 10,20%) articles. (Figure 8) Other dietary options include:

- Psyllium.
- Lactose-restricted diet.
- Fructose-restricted diet.
- Ultra-processed food elimination.
- Polyols-restricted diet.
- Short-chain fructooligosaccharide.
- Palmitoylethanolamide/ppolydarin supplement.
- Kiwi fruit.
- Food allergen exclusion.




Figure 8: Nutritional Intervention discussed in articles

### Gender of the senior and first authors

The gender of the first author and the senior author was determined in all 50 articles. Among first authors, females outnumbered males by a ratio of 3:2, with female authors (n = 30, 60%) and male authors (n = 20, 40%). On the other hand, it was the opposite for senior author distribution, with male authors (n = 31,62%) and female authors (n = 19,38%), as shown in Figure 9.




Figure 09: Distributions of authors by Gender

## **Discussion:**

IBS is a chronic functional disorder with recurrent abdominal pain associated with defecation and altered bowel habits [19]. Diagnosing IBS is challenging because it is typically a diagnosis of exclusion, which can prolong the diagnostic process and add to patient stress. As physicians, we must effectively educate our patients about this condition [20]. Understanding the reasons behind their symptoms is essential for patients with IBS, especially when no structural disease is present, as it greatly influences their management and well-being [21].

IBS presents as a heterogenous disorder, and efforts to develop targeted drug treatments have faced challenges due to uncertainties surrounding the nervous system in the gastrointestinal tract and central nervous system mechanisms contributing to visceral hypersensitivity in IBS.

[22-24]. Combining behavioral strategies, dietary adjustments, and appropriate medication regimens maximizes successful treatment chances [25]. The sole purpose of this bibliometric analysis is to provide a comprehensive review of the literature surrounding nutritional interventions for IBS. Dietary therapy has recently gained popularity because research has highlighted that particular foods exacerbate or decrease the symptoms of IBS (26, 27).




Figure 1: Total Citations of articles in the list each year

The citation analysis depicted in Figure 1 indicates that the prime period of research engagement in nutritional interventions in IBS was from 2012–2017; during this timeframe, articles listed in the top 50 were the most frequently cited. This phase of rapid expansion can be analyzed to understand factors contributing to increased interest, such as breakthrough findings or emerging trends. This information can be instrumental for researchers, policymakers, and funding bodies to strategically plan and support ongoing efforts in nutritional intervention for IBS. The subsequent years witnessed fluctuations, with notable minimal citations in 2019. Fluctuations may reflect changes in public health priorities, guiding the development of policies that respond to current needs.

Table 1 includes journals consistently incorporating articles with the highest citation rates. These journals fall under the category of 'core journals' or 'zone 1' journals according to Bradford's Law [28], which states that "zone 1 journals are those that are most frequently cited in the literature of the particular field and so are likely to be of value to researchers within that discipline". Similar to other bibliometric analyses [29, 30, 31], we also identified a pronounced and direct association between the journal's impact factor and the number of articles with the highest citation rate published in that journal. This association emphasizes that a journal's impact factor directly influences the number of citations its articles receive. Publishing in journals with high citation rates increases the visibility of research.

FODMAPs are carbohydrates poorly absorbed in the small intestine and can ferment in the large intestine, leading to symptoms such as bloating, gas, abdominal pain, and altered bowel habits. The mechanisms by which the FODMAP diet causes these symptoms include elevating osmotic pressure in the large intestine, acting as prebiotics for gasproducing Clostridium bacteria, serving as a substrate for bacterial fermentation leading to abdominal distension and discomfort, and interacting with enteroendocrine cells responsible for regulating GI sensation, motility, secretion, and absorption [32]. This leads to GI wall stretches and activates sensory wall receptors, leading to sensations of fullness, distension, and abdominal pain [33]. A low FODMAP diet improves the IBS symptom severity score (IBS-SSS) and the quality of life-related to the traditional diet [34]. Over half of the articles on our list focus on the FODMAP diet, highlighting its predominant importance in managing IBS. It's noteworthy that maintaining a low-FODMAP diet requires detailed meal planning, involves significant expenses, and poses difficulties in adherence over an extended period (36, 37).

Probiotics, GFD, the Ig4 exclusion diet, and other dietary approaches are discussed less frequently, which indicates that these dietary options are an emerging area of research with growing interest but need to be established as low-FODMAP diets. Probiotics are safe and productive and improve gut health through their anti-inflammatory properties. They include Streptococcus thermophilus, the Lactobacillus strain, and Lactobacillus delbrueckii subsp. bulgaricus, and the Bifidobacterium strain [38]. They are efficacious and have gained popularity recently because they decrease bloating [39], decrease bowel movement per day [40], and lead to improvement on a 7-point Likert scale [41]. GFD includes gluten-free cereals like rice, buckwheat, corn, millet, quinoa, and various vegetables and fruits [42]. A recent trial suggests that FODMAP-restricted GFD improves quality of life and anxiety in IBS patients [43]. The elimination diet for IBS involves removing potential trigger foods from the diet and reintroducing them gradually to identify

culprits. This process aims to customize dietary management for individuals with IBS, improving symptom control. (44) The elimination diet and other dietary options, while effective, are less reported in our 50-article list due to their complexity and the individualized approach required to identify specific food triggers for each patient.

Regarding national origin, we noted that the UK generated the most articles in the list of 50 most cited articles. Numerous European countries have pursued the lead set by the UK, with limited participation from Asian countries. Our results indicated the most significant number of most-cited articles were coauthored by Munir J.G., numbering seven, followed by Gibson P.R. with six articles. Considering academic and intellectual demands for recognizing individual impactful involvement, it may be advantageous to pinpoint and distinguish the most remarkable authors from front-runners. Scientists who make meaningful and evident contributions to the knowledge base experience heightened eminence and amplified influence. This influence extends to the publication realm, where editors are more inclined to accept their work and seek opinions on articles [45].

Most principal authors were male, highlighting the scarcity of female representation in senior author positions [46]. This statistic may be influenced by the age discrepancy between male and female colleagues in college faculty, leading to younger female colleagues still being in the initial stages of their professional journey. Our bibliometric analysis revealed a distinguished trend where female authors were more prevalent in the first author position than the senior author. This observation contrasts with findings from other bibliometric analyses (47, 48), which often report different patterns of gender distribution in authorship roles. Our study suggests that the gender of the senior author does not necessarily coincide with that of the first author. While there is a gradual increase in the number of female first and senior authors in gastroenterology, additional steps need to be taken at the grassroots level

to tackle gender discrepancies and ensure better representation of female authors in academic literature [49].

### **Limitations:**

Despite our sincere efforts to limit the bias, it is crucial to acknowledge the obstacles inherent in our bibliometric analysis. Firstly, we extracted articles from only one database, Scopus. It has been discovered that it tends to miss older citations [17, 50]. However, there is evidence that the Scopus database has a broader scope of coverage compared to alternatives such as PubMed, Web of Science, and Google Scholar. Additionally, Scopus's extensive coverage across multidisciplinary fields, compared to PubMed, aligns with the scope of our research [51]. Secondly, issues about the self-citation effect on bibliometric analyses have been raised, especially while a small group of authors dominates high-frequency citations, as glaring in our eyes. Although research has addressed this problem, self-citations may only partially affect bibliometrics [52]. A potential source of bias is the time needed for newly influential articles to accumulate measurable citations. Thus, our list will not consider some currently published excessive-impact articles, despite their future importance [53].

Moreover, quotation counts and H-indices may vary from those received in other competing databases, introducing variability within the evaluation. Finally, the limitation of including only the top 50 articles was due to insufficient literature. This highlights the need for further research to broaden the scope and identify additional trends.

### **Conclusions:**

Analyzing the 50 most-cited articles in Nutritional Intervention in Irritable Bowel Syndrome provides valuable insights. The study of citation counts and trends indicates the level of interest and impact of research in nutritional interventions for IBS over time. Policymakers can use this data to prioritize funding and support for dietary research and

public health initiatives. The predominant focus on low-FODMAP diets among the most cited articles suggests a strong interest in understanding the efficacy of nutritional interventions in managing IBS symptoms. This finding could lead to the development of standardized dietary guidelines for IBS patients. The domain of nutritional intervention for IBS has witnessed fluctuations in attention and acknowledgment over time, marked by phases of rapid expansion, decline, and stability. Assessing these trends can help identify research gaps; understanding these patterns can help policymakers and funding agencies decide where to allocate resources most effectively.
