

1 **“It’s a moving target”: Experiences of pacing to reduce symptom exacerbation among adults living with**
2 **Long COVID – Results from an international community-engaged qualitative research study**

99 **ABSTRACT - Words: 296/300**

100 **Introduction:** Long COVID is a multisystem condition that negatively impacts daily function. Pacing is a self-
101 management strategy to mitigate symptoms. Our aim was to describe experiences of pacing from the
102 perspectives of adults living with Long COVID.

103 **Methods:** We conducted a community-engaged qualitative descriptive study involving one-on-one online
104 interviews with adults living with Long COVID from Canada, Ireland, United Kingdom, and United States to
105 explore experiences of disability. We asked participants about strategies they used to deal with health
106 challenges living with Long COVID. Interviews were audio recorded and transcribed verbatim. We analyzed
107 data using group-based content analytical techniques.

108 **Results:** Among the 40 participants living with Long COVID, the majority were women (n=25; 63%), white
109 (n=29;73%) and heterosexual (n=30;75%). The median age of participants was 39 years (25th, 75th
110 percentile: 32, 49). Most participants (n=37;93%) used pacing to mitigate or prevent symptoms. Participant
111 described experiences of pacing across five main areas: 1) using pacing as a living strategy (pacing to mitigate
112 multidimensional health challenges; applying pacing to many types of activities; process of pacing
113 experienced as a moving target; pacing experienced as a helpful strategy, but not a cure for Long COVID); 2)
114 learning how to pace (acquiring knowledge about pacing; developing strategies and skills to support pacing);
115 3) encountering challenges with pacing (learning how to pace; experiencing inequitable access to pacing;
116 experiencing stigma and judgement; undergoing psychological and emotional adjustment from beliefs of
117 ‘fighting’ or ‘pushing through’ to balancing rest with activity; making sacrifices; and encountering unexpected
118 obstacles); 4) experiencing consequences of not pacing; and 5) conceptualising and describing pacing using
119 analogies or metaphors.

120 **Discussion:** Pacing is a challenging and complex strategy used to mitigate symptoms of Long COVID.
121 Healthcare providers should work collaboratively with patients to further refine and implement this strategy,
122 when appropriate.

124 INTRODUCTION

125 Long COVID, also known as Post-COVID Condition (PCC), is a prevalent and disabling chronic multisystem
126 condition that impacts the health of millions of people (1). The National Academies of Sciences, Engineering,
127 and Medicine (NAEM) defines Long COVID as “an infection-associated chronic condition (IACC) that occurs
128 after a SARS-CoV-2 infection and is present for at least 3 months as a continuous, relapsing and remitting, or
129 progressive disease state that affects one or more organ symptoms” (2). Estimates of the prevalence of Long
130 COVID among people previously infected with SARS-CoV-2 range between 10-35% (2-4). The most common
131 symptoms of Long COVID include extreme exhaustion or fatigue, post-exertional symptom exacerbation
132 (PESE) or post-exertional malaise (PEM), shortness of breath, cognitive impairment (such as memory
133 impairment, difficulty problem solving), and dizziness on sitting or standing (such as orthostatic intolerance)
134 (5). Over 200 symptoms of Long COVID have been identified (6). The majority of people living with Long
135 COVID report that their symptoms negatively impact their daily function and social participation (6, 7).

136 The symptoms and impairments of Long COVID and their impact on daily function represent
137 disability, broadly defined as any physical, cognitive, mental and emotional health challenges, activity
138 limitations, uncertainty about the future, and challenges to social inclusion (including return to work, family
139 life, relationships, and ability to care for others) (8-11). For many individuals living with Long COVID, their
140 health challenges may fluctuate over time, characteristic of episodic disability (8, 11-13). For example, PESE
141 or PEM, the worsening of symptoms after exertion, are common symptoms of Long COVID (14, 15).

142 Fluctuations in disability may be unpredictable for people living with Long COVID, making it difficult to plan
143 for the future and maintain or return to employment (8, 12, 13). Uncertainty is a dimension of disability
144 among people living with Long COVID which may exacerbate symptoms (11). Long COVID poses substantial
145 individual health, workforce, and economic burdens (16).

146 No approved treatment or cure for Long COVID exists (17). In the absence of effective treatments or
147 cures, people living with Long COVID have adopted strategies to help manage and mitigate some of the
148 associated symptoms and disability (18, 19). In the context of episodic disability, the behaviours, attitudes,

149 and beliefs that patients adopt to manage their disability are referred to as living strategies (20). These living
150 strategies include pharmacological treatments (e.g., over-the-counter medications), dietary alterations (e.g.,
151 supplements, eating low-histamine foods), and energy management (8, 21, 22). Often, people living with
152 Long COVID adopt living strategies through their own trial and error, and may be based on advice from
153 others living with disability (18, 19, 23).

154 Pacing is a living strategy that people living with Long COVID can adopt to manage their energy and
155 navigate everyday life (18). Pacing is an approach that balances rest and activities in daily life, to manage
156 symptoms such as fatigue and PESE or PEM (18, 24). Pacing has been utilised by people living with a range of
157 health conditions, such as myalgic encephalomyelitis/chronic fatigue syndrome (ME/CFS), cancer, and
158 arthritis (25). There are multiple potential goals and types of pacing within the context of energy
159 management or conservation (24). For example, quota-contingent pacing is used to gradually increase
160 activities, while symptom-contingent pacing guides activities based on perceived symptom levels to avoid
161 symptom-exacerbation (26, 27). In the context of rehabilitation, it is important to consider and select the
162 most appropriate types of pacing and energy management strategies for the patient population. For
163 example, pacing strategies with the goal to increase activity (such as quota-contingent pacing) may not be
164 safe or appropriate for people with Long COVID (24, 27, 28). Despite existing clinical guidelines, there is
165 significant variability in the implementation of pacing as a living strategy among people living with Long
166 COVID (24, 29).

167 There is a clinical need to understand pacing as a living strategy for people living with Long COVID, and
168 other energy-limiting chronic conditions. It is important to understand the experiences of pacing and
169 strategies used in the context of Long COVID to help inform clinical practice and research to mitigate
170 disability. Our aim was to describe the experiences of pacing from the perspectives of adults living with Long
171 COVID.

172

173 **MATERIALS & METHODS**

174 **Study Design**

175 We analyzed interview data from interviews collected as part of the Long COVID and Episodic Disability
176 study, a community-engaged qualitative descriptive study involving one-on-one online interviews with adults
177 living with Long COVID (8). The primary aim of the parent study was to describe experiences of episodic
178 disability among adults living with Long COVID (8). Detailed methods for the Long COVID and Episodic
179 Disability Study have been previously published (9). The study was approved by the University of Toronto
180 Health Sciences Research Ethics Board (protocol #41749). For this study, we specifically focused our analysis
181 on interview data pertaining to the experiences of pacing.

182

183 **Patient and Public Involvement**

184 The Long COVID and Episodic Disability Study is a community-engaged research study involving over 25
185 persons living with Long COVID, researchers, and clinicians (categories are not mutually exclusive). People
186 with lived experiences with Long COVID were involved in all phases throughout the study including
187 conceptualisation, acquisition of funding and proposal development, recruitment and data collection,
188 analysis and interpretation, and knowledge mobilization. During development of the study proposal, patient
189 advocates from organisations in Canada, Ireland, UK, and US, who were linked to larger networks of people
190 living with Long COVID, were purposefully invited to join the study team. Long COVID community networks
191 and organisations, represented by persons living with Long COVID, were involved in all stages of the
192 research, including: COVID Long Haulers Support Group Canada, Long COVID Ireland, Long COVID Physio,
193 Long Covid Support, and the Patient-Led Research Collaborative (30-34). Team members with lived
194 experiences were provided yearly remuneration for their time and expertise dedicated to the study, either as
195 an individual, or to the community organization which they represented on the study.

196

197 **Participants and Recruitment**

198 Participants included adults (≥ 18 years old) who self-identified as living with Long COVID from Canada,
199 Ireland, United Kingdom (UK) and United States (US), defined as signs and symptoms that develop during or
200 following an infection consistent with COVID which continue for 12 weeks or more and are not explained by
201 an alternative diagnosis (35). Community collaborators recruited participants between December 7, 2021
202 and May 2, 2022 through the five online community support groups and organisations for Long COVID
203 represented on the study team in Canada, Ireland, UK, and US (30-34). Participants in the Long COVID and
204 Episodic Disability study were recruited to represent adults living with Long COVID across the four countries,
205 with diversity in gender, age, and sexual orientation. All participants provided informed written or verbal
206 consent. Participants were offered a CAN\$30/€20/£15/US\$20 electronic gift card for their participation in
207 the study.

208

209 **Data Collection**

210 Online semi-structured interviews were conducted by four members of the research team (KKO, KM, NS, BT)
211 via Zoom between December 2021 and May 2022. We used the Episodic Disability Framework to develop the
212 interview guide which included the following areas of inquiry: dimensions of disability; contextual factors,
213 including living strategies such as pacing; and triggers of disability (36, 37). During the interview, participants
214 were asked, “Did you adopt any other living or coping strategies to help you deal with the health challenges
215 and ups and downs of disability living with Long COVID?” Following the interview, we administered a web-
216 based questionnaire to collect demographic information (including sex, gender, race, sexuality, employment
217 information, and Long COVID symptoms or characteristics). The interviewer followed up with each
218 participant the day after the interview to check in on participants’ wellbeing following the interview and to
219 provide suggestions for support services if appropriate.

220

221 **Data Analysis**

222 We analyzed interview data from the Long COVID and Episodic Disability study that specifically pertained to
223 the construct of pacing. We used a group-based analysis with conventional content analytical techniques (38)
224 with portions of the interview data specific to experiences of pacing. Interview data were analysed
225 collectively as one sample (not by country). We developed a coding framework informed by key words
226 related to pacing (e.g. pacing, energy conservation, rest) through literature review and consultation with
227 team members with lived experiences with Long COVID by one author (KM) while allowing for additional
228 codes to emerge from the data. All transcripts were coded line-by-line using the coding framework. A
229 preliminary coding summary was produced which summarised key concepts, impressions, and reflections
230 from the data. Three team members (DAB, KKO, and KM) met to discuss and refine the preliminary coding
231 summary. Ten team members, including five with lived experiences with Long COVID (AC, SCC, KE, SG, MK,
232 KM, LM, MO, CT, and LT) met to review the coding summary and provide reflections, validation, and
233 interpretation of the findings. We used NVivo software to facilitate data management (39).

234

235 **RESULTS**

236 Forty adults living with Long COVID (10 per country) participated in interviews between December 2021 and
237 May 2022. Participants were mostly female (n=29, 73%), white (n=29, 73%), heterosexual (n=30, 75%), with a
238 median (25th, 75th percentile) age of 39 years (32, 49). Thirty-three participants (83%) were living with Long
239 COVID for a year or longer, and 34 (93%) had experienced at least one relapse in their symptoms. Of the 40
240 participants, 37 (93%) spoke about pacing or concepts related to pacing. Some participants explicitly named
241 pacing (n=30;75%), while others referred to learning to incorporate more balance between rest and activity
242 in their daily lives. See Table 1 for more details on participant characteristics.

246 **Experiences of Pacing**

247 Participants described experiences of pacing across five main areas: 1) using pacing as a living strategy; 2)

248 learning how to pace; 3) encountering challenges with pacing, 4) experiencing consequences of not pacing,

249 and 5) conceptualising and describing pacing using analogies and metaphors. The following sections describe

250 each area in detail, with supporting quotations from the interviews referenced by participant number and

251 country. See Figure 1.

1) Using pacing as a living strategy

256 Participants described pacing as a living strategy to prevent, manage, or mitigate multidimensional health
257 challenges (physical, mental, emotional, cognitive, and social) associated with Long COVID, including PESE
258 and PEM. Pacing involved balancing activity and rest. Pacing helped participants reduce symptom severity or
259 exacerbation, and crashes or relapses. Consistent pacing was required to maintain a lower presence and
260 severity of symptoms. We describe further details of pacing as living strategy below.

261

Pacing to mitigate multidimensional health challenges

263 Participants described different dimensions and factors to be considered when pacing (including emotional,
264 cognitive, and physical exertion). Participants described pacing or limiting social interactions, such as “visits
265 or my phone calls” (P29, Canada); cognitive tasks, like “listening to a podcast” (P26, US); as well as physical
266 tasks (e.g. housekeeping and meal preparation).

267 Many participants explained that they only became aware of the energy required to complete
268 physical, cognitive, social or emotional tasks after they developed Long COVID. One participant explained
269 that it was easy for them to understand how they could pace physical tasks; however, realising that cognitive
270 tasks could also be fatiguing was “like a revelation” (P7, Ireland). Effective pacing required finding a balance
271 between different types of exertion. “It’s like I have to pick one. Either I’m going to go through the mail or I’m
272 going to do chores but I can’t do both.” (P28, US).

273

Applying pacing to many types of activities

275 Participants described pacing many types of activities. For participants experiencing severe impairment, the
276 most essential activities (basic activities of daily living) had to be paced. As one participant reported: “For a
277 while there it was even pacing how often I go to the loo just because of that extra few steps and that little bit
278 more energy. It’s just simple things like that you just take for granted.” (P5, UK). Other participants were

279 pacing day-to-day activities (such as going to appointments or managing paperwork). For example, *“If I drive*
280 *somewhere, even if it’s a short distance like a 15- or 20-minute drive, I’ll have to pull in the car, park and sleep*
281 *or nod off for a while before I have the energy to go the next bit.”* (P36, Ireland).

282 Those who were working at the time of their interview described applying pacing and energy
283 conservation strategies in the workplace. They found they were more successful with slower and more
284 flexible schedules so that they could spread out difficult and energy-intensive tasks. For example:

285 *“If I had a full day [of work] with 14 assessments in it, then it might be a different kettle of fish... If I*
286 *have a day then where there’s not too much happening, that’s okay and I’m able to gain kind of*
287 *energy for the next few days... I think I am pacing quite well.”* – P8, Ireland

288 Participants described that they had to re-learn their energy capacity when it came to the tasks
289 involved in their jobs (e.g., more cognitively demanding vs. more passive), and pace their work days
290 accordingly. This participant incorporated pacing to manage meetings at work:

291 *“...because I get shortness of breath while I’m talking in meetings, I like have someone watch my dog*
292 *because if I have to like take her on walks, I can’t. I won’t be able to like do my meetings. I may ask*
293 *other people to facilitate more of my meetings because I can’t talk and I’ll get shortness of breath... I*
294 *have to make meetings shorter so I can like limit the air and cognitive... I’ll space meetings out as*
295 *much as I can so that I can recover and... so I don’t lose as much of my cognitive functioning.”* – P35,
296 US

297 Social interactions, such as visits with friends or family, and going to a coffee shop, and leisure
298 activities also required pacing. One participant explained they were surprised that colouring could trigger an
299 episode of PESE, likely *“related to having to think about choosing the colours and things like that... what*
300 *colour do I choose and where do I paint it?”* (P30, US). They were excited to have gradually built up to 20-30
301 minutes of colouring at a time. Another participant described resting for two days in order to participate in a
302 drumming class without triggering a crash. Ultimately descriptions of pacing shared by participants spanned
303 all types of activities involving physical, emotional, or cognitive exertion.

304

305 ***Process of pacing experienced as a moving target***

306 Despite the benefits, the process of pacing was experienced as “a moving target” (P24, US); trial and error
307 were required to achieve a successful balance of rest and activity, and to maintain this balance as presence
308 and severity of symptoms changed over time. Pacing did not involve a linear or predictable progression
309 toward less symptom burden. As this participant described, “It’s not like I can just like say okay I rested
310 yesterday, so I’ll be fine today... It’s just that I’d have a better chance of being able to have this chat with
311 you.” (P9, Ireland). Despite ongoing pacing, some participants described they had reached “a plateau” (P24,
312 US) in terms of how much symptom improvement they experienced. They were facing the same energy
313 limitations but had learned how to achieve some function within their limits.

314 *“The couple of hours I have now a day where I’m functioning like now, I’m functioning at a better*
315 *level than I was six months ago or a year ago. But... I’m still very limited in those couple of hours a*
316 *day... I’ve understood more as time’s gone on about pacing... I would say it’s a smoother ride now but*
317 *that’s not because my symptoms are getting better. It’s because I’m understanding more about my*
318 *limitations.” – P19, UK*

319

320 ***Pacing experienced as a helpful living strategy, but not a cure for Long COVID***

321 Rather than eliminate all symptom exacerbation and crashes associated with Long COVID, pacing was
322 experienced as helpful for reducing the frequency or severity of crashes. One participant described that their
323 crashes tended to be shorter “as I’ve gotten better at managing my energy like envelope” and “as long as I
324 go to bed and rest and don’t do anything” once they begin to ‘hit their limit’ of activity (P24, US).

325 Participants were clear that reducing their symptoms and crashes was helpful, but did not result in
326 recovery from Long COVID. As this participant explained:

327 *“People are changing their life and pacing so that their symptoms are lower. You know that’s getting*
328 *better, not like spontaneously healing [from Long COVID]... I think that there’s something going on*

329 *inside of us that's causing ongoing damage and I just really feel like until that stops, you know*
330 *healing [from Long COVID], that's not going to be successful."* – P34, US

331

332 **2) Learning how to pace**

333 Participants described experiences with learning how to pace. They discussed sources of information about
334 pacing, and their successes, failures, and challenges with learning how to pace.

335

336 ***Acquiring knowledge about pacing***

337 Many participants learned about pacing through resources in online community support groups and their
338 own trial and error. As one participant explained, *"it's just been my own research that has helped me to find*
339 *things that help"* (P8, Ireland). This involved reading, watching videos or webinars online, and staying current
340 on research. Many participants recognised that pacing was how *"people have been doing it for years with*
341 *[ME/CFS]"* (P10, Ireland). Participants sought out knowledge about pacing from community support groups
342 or individuals online with other energy-limiting chronic conditions such as ME/CFS or Lupus.

343 Self-directed learning was often undertaken by participants without formal support from healthcare
344 professionals. For some participants, they found online resources on their own before receiving any guidance
345 or support from a health care provider. One person described that their doctor, *"...didn't give me any advice.*
346 *It was just, 'You'll get better with time'. Well, I'm still not better. So, I have had to learn and educate myself."*
347 (P34, US). They went on to say, *"When I finally got to the good Long COVID clinic and they wanted me to see*
348 *someone for physical therapy, you know he was talking about pacing. But at that point I already know. I've*
349 *done the self-education."* (P34, US). They said the resources on ME Action's website (40), *"...really, I think*
350 *saved me from getting a lot worse"* (P34, US).

351 Complex and energy-limiting chronic condition communities and support groups were described as
352 bridging the gap in formal healthcare supports for pacing and other living strategies. As the Long COVID

353 community began to develop, specific support groups for Long COVID emerged and shared resources on
354 pacing.

355 *“My best friend has lupus... So, I found out about Spoon Theory through my friend and that sort of*
356 *became part of our like lexicon of conversation, just in me checking in with her. Then you know just*
357 *finding that in the Long COVID community and the dysautonomia communities and then ME/CFS*
358 *communities.” – P40, US*

359 Although many participants lacked access to healthcare providers who were knowledgeable about
360 pacing, some learned about pacing through specialty Long COVID clinics, fatigue-management programs, or
361 specialised providers. However, some described challenges finding specialised and knowledgeable providers,
362 and wait times were long.

363 *“I’ve been to two Long COVID clinics, one a horrible experience where the doctor at the Long COVID*
364 *clinic told me that my physical pain was due to anxiety when I continually told him I wasn’t*
365 *experiencing any mental health issues. The second Long COVID clinic is fine. So, I’m still seeing them.*
366 *Then yeah, I’m seeing now like a chronic fatigue syndrome and Long COVID like expert. The most*
367 *useful advice that the people who actually know what they’re talking about have is really like just*
368 *pacing.” – P34, US*

369 Types of health providers mentioned as providing helpful information and support for pacing
370 included occupational therapists and physiotherapists. These providers offered individualised support and
371 guidance on pacing.

372 *“I started the therapy and they tried to like space things out because they know it’s taxing on people.*
373 *So that’s why they tend to do like one thing at a time. But I was also... I started working with the*
374 *[occupational therapist] somewhere in there with therapy sessions as well because I needed some*
375 *help around pacing. I expressed that a COVID education group wasn’t enough for me... Like the*
376 *reason why I wanted to go to Integrated Chronic Care Services was because I needed help with pacing*
377 *because I couldn’t figure it out for myself.” – P38, Canada*

378 ***Developing strategies and skills to support pacing***

379 Participants described strategies and skills that they developed to support their success with pacing. For
380 most participants, multiple strategies or skills were implemented together to help manage symptoms living
381 with Long COVID. For example, *“Definitely planning, pacing, resting, being mindful of what I do in my day*
382 *[have helped me manage Long COVID]”* (P20, UK).

383 Effective pacing required high-level planning and prioritisation skills. Participants carefully
384 identified activities that were most important and would break their weeks and days down (‘chunking’) to
385 accomplish those tasks. The remainder of their time was dedicated to rest, which was identified as a priority
386 and itself a meaningful activity. For example, *“If I want to see my friends... I have to plan kind of a rest day, or*
387 *days”* (P32, UK). Basic activities of daily living, like meal preparation, also had to be prioritised and planned:

388 *“If I knew that I was going to be downstairs for most of the day... I take what I need from upstairs. So,*
389 *I’ve got everything laid out for downstairs. I think ahead about what I’m cooking or you know I’d cook*
390 *with little stools so I’m sitting down for all of it. Just little kind of hacks that you could do to make*
391 *your life easier... And I just let go of a lot of things. I was always a person that would do DIY on a*
392 *weekend, do this, do that... I just stopped. I’ve kind of released a lot of things. It took quite a [lot of]*
393 *pressure thinking I had to do this, I had to do that.”* – P1, UK

394 Incorporating rest and reducing energy expenditure while completing priority tasks through the use
395 of equipment and aids was an important strategy involved in pacing. For example, sitting on a stool while
396 cooking, or using mobility aids like canes or wheelchairs. Simple aids could be very useful, like an alarm as a
397 reminder of a scheduled rest break.

398 Participants described developing acceptance and awareness of the energy required to complete an
399 activity, and to notice patterns of symptom exacerbation to guide their pacing strategies. Some described
400 acceptance as coming with time; others found mindfulness was a helpful strategy to cultivate awareness and
401 acceptance. One participant described achieving a better understanding of rest through mindfulness:

402 *“The mindfulness... That just being in the moment and being able to kind of relax your body so your*
403 *body is actually resting, because ... in the beginning, I was feeling like I was resting but I wasn’t*
404 *getting my energy back. But I wasn’t actually resting because I wasn’t kind of focused out. I was*
405 *thinking of other things or I had the television on or something else. So yeah, I find now... that I’ve*
406 *learned that, that I can actually... rest my body and I will feel rested after that. So that’s a bonus,*
407 *yeah. Mindfulness is a big thing, yeah.” – P9, Ireland*

408

409 **3) Encountering challenges with pacing**

410 Participants described challenges with pacing in six areas including: 1) learning how to pace; 2) experiencing
411 inequitable access to pacing; 3) experiencing stigma and judgement; 4) undergoing psychological and
412 emotional adjustment from beliefs of ‘fighting’ or ‘pushing through’ to balancing rest with activity; 5) making
413 sacrifices; and 6) encountering unexpected obstacles.

414

415 ***Learning how to pace***

416 Learning how to pace was difficult as pacing was a new skill for participants that they were learning while
417 experiencing health challenges, often without formal supports. Participants described living with the health-
418 related challenges of Long COVID for some time, experiencing ups and downs in their symptoms, before
419 learning about pacing and being able to achieve some symptom stabilisation. Some participants felt they
420 would have benefited from more support in the process of learning how to pace.

421

422 ***Experiencing inequitable access to pacing***

423 Another challenge was that participants experienced inequitable access to pacing as a living strategy. Some
424 participants described feeling lucky to have the means and the freedom to plan and prioritise rest in their life
425 to enable pacing. In addition to financial supports, access to social supports, such as daycare or help from

426 friends/family, facilitated access to pacing. However, for participants who did not have access to such
427 supports, planning and prioritising rest to facilitate pacing may not have been an option.

428

429 ***Experiencing stigma and judgement***

430 Many participants experienced stigma and judgement related to their efforts to pace. Participants described
431 a lack of support from others (including friends, family, and health care providers) for pacing, stemming from
432 poor understanding of energy limitations associated with Long COVID. Participants identified accepted
433 cultural norms about productivity and ableism that made pacing difficult to adopt since pacing and rest are in
434 conflict with productivity.

435

436 ***Undergoing psychological and emotional adjustment from beliefs of ‘fighting’ or ‘pushing through’ to 437 balancing rest with activity***

438 Undergoing psychological and emotional adjustment from beliefs of ‘fighting’ or ‘pushing through’ to
439 balancing rest with activity was challenging for many participants. Participants were torn between
440 recognising the need for rest and the normal desire to do more in daily life.

441

442 ***Making sacrifices***

443 Participants described that pacing often involves making sacrifices. This included ‘letting go’ of previous
444 roles, responsibilities, leisure activities, and employment, in order to pace. Sacrificing social outings and
445 leisure activities to prioritise basic activities of daily living and essential tasks often led to participants feeling
446 limited and isolated. Sacrifices included decisions about whether to stop working in order to effectively pace;
447 duties involved in work might push participants outside of their energy envelope when factoring in the
448 energy already required for basic activities of daily living and essential roles.

449

450 ***Encountering unexpected obstacles***

451 Encountering unexpected obstacles was another challenge faced when pacing. Participants’ best efforts at
 452 pacing might be derailed by unexpected life events that couldn’t be avoided or delayed. Certain events or
 453 activities were outside of their control or were essential to complete within a certain timeframe.

454

455 See Table 2 for supportive quotes for each of the challenges encountered by participants while pacing.

460 **4) Experiencing consequences of not pacing**

461 Participants described that if they did not or could not pace effectively, they faced consequences. Multiple
462 participants referred to 'suffering' if they were unable to pace, or if they engaged in activities that were
463 beyond their energy capacity. A lack of the ability or resources to pace, could lead to a relapse, crash, or
464 exacerbation of symptoms (which could encompass physical, mental, emotional, and cognitive domains). For
465 example, some participants would experience headaches, nausea, and cognitive challenges.

466 *"If I overdo it now, I would definitely have some sort of a relapse... I think that it shouldn't be that*
467 *hard to change the tire, but I suppose it is when you have something like I have... the pacing is*
468 *working. Like I've rested now the last three weeks, but I'm still not right. I'm still not back to where I*
469 *was three weeks ago... I have the fear now that I will get a relapse. I know I will if I do too much. It's*
470 *just pacing is definitely the way to go... Because if I don't, I suffer and I mean I don't want to suffer*
471 *the way I suffered the last three weeks." – P10, Ireland*

472 Symptoms experienced during a crash led to reduced function. Some participants described that they
473 would be temporarily bed-ridden, or “*physically paralysed*” (P6, Ireland). Participants explained that the
474 decrease in function they experienced during a crash had consequences for their ability to engage in
475 employment and other activities. This was frustrating for participants who wanted to keep busy, or were
476 accustomed to a higher level of activity.

477 *“It just feels like my brain is scrambled, like I can’t get things organised in my head anymore. I have to*
478 *go lay down and not do anything which... I like being productive. I don’t like doing that. It’s like what*
479 *are you supposed to do, just stop and rest? Like, I guess so. Every time I try to get out of it like sooner*
480 *and my body wants to, I could feel it coming back. But the more I rest and not think about anything*
481 *stressful, I think that’s akin to it feels like my mind is like it was inflamed and now it’s like calming*
482 *down type thing. Once I get to a level where it’s low enough in terms of like this so-called*
483 *inflammation in my mind, I’m able to work again. It takes about two to three days.” – P23, US*

484 There was also tangible pressure experienced to continue to engage in employment, as being unable
485 to do so resulted in lost income and financial insecurity.

486 *“I lost like \$10,000 of my salary because of choices I had to make because I had to manage Long*
487 *COVID... So, there’s a pressure to maintain wellness... because I can’t afford to not be well. So that*
488 *can be a bit of a pressure but it also helps to have a bit more discipline and pace in myself to try to*
489 *stay well.” – P1, UK*

490

491 **5) Conceptualising and describing pacing using analogies and metaphors**

492 Participants used a range of analogies and metaphors to conceptualise and to describe the process of pacing.
493 Examples of analogies and metaphors used by participants included Spoon Theory, budgeting energy, staying
494 within an ‘energy envelope’ and ‘stoplight’ (see Figure 2). Some participants articulated the importance of
495 using analogies and metaphors to describe pacing to others. This helped to validate the utility of pacing and

496 to make it more tangible (for themselves and others). For example, “[Spoon Theory is] a really helpful way of
497 just naming what you’re working with.” (P40, US).

499 **Spoon Theory**

500 Spoon Theory is based on the premise that only a finite number of spoons can be allocated to activities
501 throughout the day, and day-to-day the number of spoons available can change (41). Participants who knew
502 about and discussed Spoon Theory recognised its origins from within the community of people living with
503 chronic disability (Figure 2). As this participant eloquently describes, Spoon Theory is a helpful analogy to
504 describe pacing in the context of episodic disability.

505 *“Spoon Theory, I’m going to [forget] the name of the person who came up with it... Anyway, it was*
506 *someone with chronic illness who came up with spoon theory as a way of explaining the need to do*
507 *pacing when it comes to how much energy you have to give and that it isn’t a solid block of energy*
508 *that will be consistent every single day. It’s more like episodic illness where some days you have say a*
509 *bank of 10 spoons to use to get you through your activity and different activities will require more*
510 *spoons or fewer spoons. Say eating is one spoon and driving is three spoons, a conversation on the*
511 *phone is three spoons if it’s social but if it’s the bank for insurance it might be five and so on and so*
512 *forth. So... as you get to be more familiar and more aware with what your energy capacity is and how*
513 *much any given activity takes out of you, you get better over time with planning how much energy to*
514 *use on any given day.” – P25, Canada*

515 Participants communicated important insights about pacing using Spoon Theory. For example, one
516 participant used Spoon Theory to communicate the sacrifices they made about what roles they could take on
517 in life, based on their limited number of spoons:

518 *“Could I work if I wasn’t a single mom? Probably not. But it’s just I only have like say 20 spoons a day.*
519 *The rest is 100. I might have 20 on the most amazing day. Usually, it’s like 10. So, I’m spending eight*

520 *of those on my kid and like life activities. There's just not much left for anything else at the moment*
521 *and I don't have a lot of support too."* – P14, Canada

522

523 **Budgeting energy**

524 Several participants compared pacing and budgeting, *"knowing like how much energy I have, what I want to*
525 *spend it on"* (P40, US), to not end up in an energy deficit or debt. Participants described the process of
526 'saving their energy' through rest, and 'spending their energy' on tasks, emotion or physical exertion (Figure
527 2).

528 *"If you use a lot of emotional energy, there's a lot of stuff going on around you, just your emotions or*
529 *whatever, that can take a lot from you as well. [There are] three prongs to that. But definitely I have*
530 *been better at knowing how to save my energy. It's not like I can just like say okay I rested yesterday,*
531 *so I'll be fine today. That's not the way it is... Whereas if I used up a lot of energy yesterday, if I did...*
532 *like if I went shopping yesterday, you know I might not be as able to do this [interview] today."* – P9,
533 Ireland

534

535 **Energy Envelope**

536 Some participants in this study described pacing in order to remain within the 'energy envelope.' The
537 envelope represented the amount of energy available to someone. Expending more energy than available
538 will exceed the limits of the envelope (Figure 2).

539

540 **Stoplight**

541 One participant described a stoplight system that they used to guide their pacing efforts. They described
542 identifying each given day as a 'red', 'yellow' or 'green' day. Red days represented low energy days; on these
543 days, they would only perform basic necessary activities of daily living to avoid triggering symptom

544 exacerbation. Green days represented higher energy days; on these days, they could engage in higher level
545 functional activities and leisure activities. Yellow days would fall in between (Figure 2).

546

547 ***Other analogies and metaphors***

548 Several other analogies and metaphors were used by participants to conceptualise and describe pacing. For
549 example, participants described having a “*body battery*” (P40, US) that is drained by exertion and charged by
550 rest. One participant described “*living in a land of eggshells*” (P4, UK) where “*I feel like I’ve got to hold myself*
551 *back a little bit, like I’ve got to just slowly step on eggshells*” (P4, UK). This metaphor of walking on eggshells
552 communicated the restraint required for pacing.

553

554 **DISCUSSION**

555 This study set out to describe the experiences of pacing among adults living with Long COVID in Canada,
556 Ireland, UK, and US. Participants experienced pacing as being a helpful living strategy to prevent or reduce
557 symptom exacerbation. Many were knowledgeable, and had learned about pacing through online
558 community support groups for people living with Long COVID or other energy-limiting chronic conditions.
559 However, the experiences of pacing were described as a ‘moving target’, involving many challenges, and
560 requiring time, effort, and trial and error to implement effectively. Participants used analogies and
561 metaphors to conceptualise and describe pacing, such as Spoon Theory, budgeting their energy, and staying
562 within their energy envelope.

563 This study builds on previous work demonstrating that pacing is often a new concept for people
564 living with Long COVID, and that learning to pace is challenging but critical in symptom management (42, 43).
565 Participants in this study, described pacing as requiring extensive trial and error to find and maintain a
566 balance between rest and exertion, adapting to fluctuations in energy levels and the presence and severity of
567 symptoms over time. Participants also described that experiencing social inequities, and stigma or judgment
568 posed substantial challenges to pacing. This points to the need for accessible social and disability supports to
569 reduce barriers and challenges to implementing pacing (44, 45).

570 Findings from this study highlight how community support groups have been instrumental to
571 participants' experiences of learning how to pace, specifically by acquiring knowledge about pacing. Support
572 groups are helping individuals living with Long COVID to learn about pacing and to navigate challenges faced
573 with pacing, while many health and rehabilitation providers remain uninformed about pacing resulting in
574 scarcity of formalised supports for pacing (23). Support and community groups are instrumental in helping
575 people living with Long COVID to learn about and implement pacing (23, 46). People living with Long COVID
576 came together through online platforms and support groups early in the pandemic, before academic and
577 medical attention had moved beyond the acute stages of COVID-19 (47). These platforms have remained
578 valuable for people living with Long COVID; they have driven advocacy efforts and provided educational
579 resources and social and emotional support (46, 48-50). However, some individuals living with Long COVID,
580 particularly those experiencing cognitive impairment, may struggle to navigate the substantial amount
581 information available on support groups, which may trigger feelings of overwhelm (46). Additionally, the
582 onus to maintain and coordinate support groups requires effort and energy on the part of those with lived
583 experiences who are leading the groups (23, 46). It may be particularly challenging for the organizers to
584 attempt to field complex questions about pacing and other living strategies, and to provide individualized
585 information. Despite potential limitations, peer-support groups for Long COVID remain a tremendous and
586 valued resource, particularly as health care providers continue to build capacity and knowledge to more
587 adequately meet the needs of people living with Long COVID (46, 51).

588 Participants described experiencing difficulty accessing health and rehabilitation providers who were
589 knowledgeable about pacing in a timely manner. There is a need to educate health and rehabilitation
590 providers about pacing as a supported self-management or living strategy for Long COVID, to increase access
591 to specialised providers and clinics, and to facilitate access to community support groups (51). Evidence
592 suggests that Long COVID support groups are disproportionately utilized by white people aged 35-55 years
593 (46), resulting in many people living with Long COVID with limited access to information shared in support
594 groups. Participants in this study described that health and rehabilitation professionals are lacking in

595 knowledge about pacing, despite existing guidelines and online resources (29, 50); participants were left
596 waiting for lengthy periods of time to access specialised providers or clinics who could provide tailored
597 guidance on managing Long COVID, echoing previous findings (52). Enhancing education of health and
598 rehabilitation providers on Long COVID and living strategies, such as pacing, could help people living with
599 Long COVID manage their symptoms better and feel more supported in their communities (53). Investing in
600 and expanding access to specialised Long COVID clinics and providers also is important to ensure that people
601 living with Long COVID are able to access more in-depth and tailored support for pacing as needed (52).
602 Given that support groups will continue to fill gaps in knowledge about Long COVID management, including
603 pacing, it is essential that they are engaged in research and knowledge translation efforts related to pacing,
604 and that resources are directed toward these groups to support them in delivering critical information on
605 pacing and other living strategies for people living with Long COVID (46).

606 Results in this study also highlight that the opportunity and ability to implement pacing and prioritise
607 rest as a meaningful activity, are not equal for everyone. To prioritise rest, participants described needing to
608 take time off work or to depend on family, friends, or caregivers to assist them with essential tasks and roles,
609 such as housekeeping and childcare. This is consistent with the results of other research on the impact of
610 Long COVID on employment and pacing (54, 55). If participants were unable to access employment or
611 disability benefits, they were faced with the impossible choice between continuing to struggle with their
612 health versus sacrificing financial stability to take time off work. Not all participants possessed strong social
613 networks to help with childcare and day-to-day activities. Social inequities may influence the ability to
614 prioritise and balance rest with activity, and impact access to healthcare, information and support for living
615 strategies for people with Long COVID, as with other chronic illnesses (56-58). Therefore, some adults living
616 with Long COVID may face greater challenges learning about pacing and accessing support to implement
617 pacing compared to others. It is vital that work accommodations, insurance and disability benefits, and home
618 and community-based services are made accessible to people living with Long COVID to facilitate
619 implementation of pacing as a living strategy to reduce symptom exacerbation (44, 59-61).

620 The analogies and metaphors used by participants in this study to conceptualise pacing and to
621 describe it to others may be powerful communication tools for other people living with Long COVID and
622 other energy-limiting conditions. People living with Long COVID have broadly reported dismissal and
623 invalidation of their symptoms by healthcare providers, friends, and family members (62-65). Validation of
624 symptoms is an important aspect of care that people living with Long COVID are seeking from health
625 providers (66-68). Rest, a meaningful activity required for pacing, is undervalued in the context of
626 contemporary ‘hustle culture’, which prioritises productivity and busyness (69). Therefore, efforts to pace
627 may be dismissed, minimized or criticized by others. This was the case for many of the participants in this
628 study; even participants themselves had to undergo psychological adjustment to embrace pacing. For people
629 living with Long COVID, their healthcare providers, and their communities to understand pacing, it is
630 important to have clear and relatable means of communicating what pacing is and how it works. Analogies
631 and metaphors shared by participants in this study, such as balancing activities and rest, Spoon Theory,
632 budgeting energy, and staying within the energy envelope, are examples of how information about pacing
633 can be effectively communicated with providers and caregivers.

634 Strengths of this study include the inclusion of participants living with Long COVID in four countries,
635 our community-engaged team-based approach, and community-led recruitment with purposive sampling to
636 achieve diversity in gender, sexual orientation, and race. The aim of the parent study was to describe
637 experiences of disability among adults living with Long COVID, and not specifically to explore experiences
638 with pacing (11). However, the amount and the richness of data on the experiences of pacing from 37 out of
639 40 of the participants highlighted the importance and utility of this living strategy. While participants were
640 from Canada, Ireland, UK, and US, our aim was to not compare and contrast between countries; instead we
641 analyzed interview data as one collective dataset. Recruitment through community support groups fostered
642 trust among participants and likely contributed to the richness of interview data. However, as participants
643 were actively engaged in community support groups and networks, they may have been more
644 knowledgeable about Long COVID, pacing, and existing supports than the broader population of persons

645 living with Long COVID. Finally, our study was focused in four high-income settings; results may not be
646 transferable to low- and middle-income settings, but provide important foundations to further explore
647 pacing in other contexts.

648 Future directions for research on pacing should include studies that explore the potential for
649 technology to facilitate pacing for adults living with Long COVID, and studies that assess the co-creation and
650 implementation of pacing strategies and programming into healthcare systems and social support
651 institutions. People living with Long COVID should be engaged in the design and implementation of future
652 research on pacing (68, 70). People living with Long COVID have used smart watches and other technology to
653 guide their pacing efforts (71). Research on pacing as a rehabilitation strategy and intervention and the role
654 of technology to support pacing may help to develop evidence-based guidelines that can be implemented by
655 people living with Long COVID and their health care providers (72). Research should also explore knowledge,
656 experiences, and utility of pacing among populations who are under-represented in this study and other
657 research on pacing, such as adolescents, children, and young people living with Long COVID, people living in
658 low- and middle-income countries, and people from underrepresented racial and sexual and gender groups.

660 **CONCLUSION**

661 Pacing is a critical strategy used by people living with Long COVID to mitigate, manage and stabilize
662 symptoms; however, pacing is experienced as a “moving target” for adults living with Long COVID. Even after
663 learning about pacing, adults living with Long COVID may experiences challenges with pacing as well as
664 consequences of not pacing. Adults living with Long COVID use analogies and metaphors to conceptualise
665 and describe pacing, for enhancing understanding and support for pacing. Health and rehabilitation
666 providers should consider that pacing is challenging and complex, and work collaboratively with patients to
667 implement this strategy, when appropriate.

SPOON THEORY

“I’m timing things so that I’m doing my cooking more on the weeks when I don’t have my kids or I’ll do all the cooking on the weekend and then it’s just getting through the weekday and relying on leftovers. It’s trying to do my pacing and my planning so that I don’t run out of spoons, especially before the week is through and I’m not borrowing from my future self. My future self needs the spoons too.” - P25, Canada



ENERGY ENVELOPE

“[Pacing is] just trying to remain with as few symptoms as possible through pacing, through staying within like what’s called the energy envelope.” - P37, Ireland



BUDGETING ENERGY

“So, if I’m going to an event obviously, I have to conserve energy and pace myself. It’s like I’m putting money in my bank. I’m giving myself 2,000 euros which I wish I had and then I have to take all that out and I only have like -10 [euros]. So, everything is a plan.” - P7, Ireland



STOPLIGHT

“On a red day that would be like a low spoon day you’re only focusing on the most basic things, the feeding yourself, the dressing yourself, you know. If you have a job, to do the job and if you’re a caregiver, you know the basics, the minimum basics of caring for others. If it’s a yellow light day adding in a few more things that are required not just desired and then on a green light day, that would be the highest functioning day. That’s when you have things that you want to do, not just the things that you need to do.” - P40, Canada
