24 Abstract

25 Following the expansion of the World Health Organization's guidelines on eligibility for the seasonal malaria chemoprevention (SMC), the government of Kenya prepared to 26 27 implement SMC for a first time in Turkana Central Sub-County in 2024. To inform design of SMC, we conducted a baseline qualitative and quantitative study. Using a stratified 28 cluster sampling approach, we enrolled 198 households with children 6 months - 5 29 years old, and tested all individuals one year and older using a Rapid Diagnostic Test 30 31 (RDT) and polymerase chain reaction (PCR). We carried out 82 key informant 32 interviews, 31 focus group discussions with community health workers, elders, and 33 caretakers of children, and 60 In-depth interviews with caretakers. Malaria prevalence 34 was 21% [9%-42%] as reported by RDT and 21% [11%-38%] by PCR. Prevalence 35 varied across villages, with the highest positivity of 73% by PCR. While SMC was 36 perceived positively, challenges identified included physical access (households far 37 from village centers, pastoralists, children living in the streets); stigma (children living 38 with disabilities, households with members struggling with alcohol use); and acceptability (traditionalists, highly educated households). This study found that while 39 malaria burden is high in the region, SMC may be a feasible approach to reduce its 40 burden and transmission. However, implementation of SMC should be tailored, with a 41 combination of centralized distribution supplemented by door-to-door and outreach to 42 43 pastoralists and people in the interior. Using existing grassroots structures, such as Tree of Men and religious and group leaders, and intensive mobilization will be critical for 44 success of this intervention. 45

47 Introduction

Malaria is a mosquito-borne disease that can lead to serious complications including 48 death. Despite continuous investment in malaria programs, in 2021, there were an 49 50 estimated 247 million cases and 619 thousand deaths globally, with 95% of cases and 51 96% of deaths occurring in the World Health Organization (WHO) African Region [1]. Most malaria control strategies have relied on a combination of vector control using 52 insecticide-treated nets (ITNs) and indoor residual spraying (IRS), and case 53 54 management to correctly diagnose and treat infections [2,3]. In addition, multiple 55 prevention strategies for particular high-risk groups, such as intermittent preventive 56 treatment of malaria in pregnancy (IPTp) and seasonal malaria chemoprevention (SMC), are deployed [3]. 57

58 Until 2022, SMC was administered according to WHO guidelines released in 2012. 59 Under these older guidelines, the WHO has recommended the use of SMC, which 60 consisted of monthly administration of antimalaria medicines during the season of 61 greatest malaria risk [4], as a part of malaria control in highly seasonal transmission areas of the Sahel sub-region in Africa [2]. In most settings, SMC involved the 62 63 administration of a full treatment course of anti-malaria drugs, most often a combination of sulfadoxine-pyrimethamine plus amodiaguine (SP+AQ), administered at 4-week 64 intervals to all children 3 – 59 months old [2]. This regimen has consistently been shown 65 66 to be safe and effective [5,6]. Many countries implemented four monthly cycles, 67 although additional cycles may be recommended depending on the transmission intensity and duration [2]. How SMC is implemented varies across settings. In some 68 69 contexts, SMC is administered at a central location such as a health facility or school

(called 'fixed-points'), or door-to-door delivery, wherein health personnel, community
health workers, or trained staff bring the drug to the households with eligible population
[7]. Research has demonstrated that the optimal approach for drug distribution may vary
from context to context [7-9].

74 In 2022, the WHO updated its recommendations for SMC to include all children 75 belonging to age groups at high risk of severe malaria in areas of seasonal malaria 76 transmission, thereby not restriction SMC to the Sahel Region, nor restricting the age 77 range and number of recommended monthly cycles to expand who may benefit from these programs [4,8]. Due to this geographic expansion, Turkana County, a semi-arid 78 79 region of Northern Kenya bordering Ethiopia and Uganda, became eligible for SMC. 80 Historically, the environment and climate in Turkana were thought to be unsuitable for 81 malaria transmission, and as a result, there have been limited malaria control measures 82 deployed in this area [9]. However, recent studies demonstrated a high malaria 83 prevalence in the region, with a large proportion of asymptomatic infections and local 84 transmission [10,11]. In 2022, there were over 274,000 confirmed cases of malaria reported in Turkana County, with 61% of cases occurring during four months (July -85 86 October) [12].

Despite the high burden of malaria in Turkana County, the use of insecticide-treated nets and other measures of malaria control is low [10,13,14], with much of the population sleeping outdoors [14]. Turkana is a primarily rural county whose population historically relied on nomadic pastoralism as a main source of livelihood. Although recent years have seen a shift away from pastoralism due to drought, environmental degradation, and population growth, the majority of the county still depends on livestock

[15]. These nomadic and semi-nomadic populations in Turkana historically have lower
access to health resources, with high rates of acute malnutrition and low routine
vaccination coverage [13]. Community based health campaigns, for example for
measles and polio vaccination, have supplemented routine activities [16,17], sometimes
targeting special populations that may be missed otherwise [18].

In 2023, The Turkana County Health Team, in collaboration with Duke and Moi 98 99 Universities, and Catholic Relief Services, was preparing to implement SMC in Turkana 100 Central Sub-county in 2024, with the vision that findings about SMC effectiveness from 101 this phase of implementation would inform the eventual roll-out of SMC in the entirety of 102 Turkana County [19]. Historically, large-scale distribution campaigns, such as mass drug 103 administration for neglected tropical diseases, have documented barriers to access and 104 specialized strategies to reach nomadic and mobile populations [20-23]. To plan and 105 ensure that SMC programs account for population-specific challenges in Turkana 106 Central, we carried out a mixed-methods formative study. We present the baseline, pre-SMC prevalence of malaria in the Sub-county, as well as findings from qualitative 107 research describing the potential challenges and opportunities of SMC. Finally, we 108 109 suggest strategies and adaptations to ensure high coverage and acceptability given the 110 context in Turkana Sub-County.

112 Materials and Methods

113 Study setting

114 This was a mixed methods study conducted in all five wards of Turkana Central Sub-115 County of Turkana County, Kenya (Township, Kanamkemer, Kangatossa, Kerio, and

- 116 Kalokol). Two communities per ward were selected using probability proportional to
- 117 population size (Figure 1).

- 124 Community entry
- 125 Prior to data collection, the research team met with representatives from government
- 126 (the Ministry of Health and Sanitation Services) and non-governmental organizations
- 127 (NGOs) in Lodwar to identify partners with interest and influence in the implementation
- of SMC in Turkana County. During these community visits, the team presented the
- 129 study's objectives to community leaders and health personnel, addressed questions
- about the study, and planned for the logistics of data collection. In addition, the study
- team aimed to understand basic characteristics of the community to inform recruitment
- 132 of qualitative participants, including primary sources of livelihood, religion, and decision-

133 making structures.

135 Participant recruitment

136 For <u>quantitative data collection</u>, within each selected village, a sampling frame of all

households with children between 6 months and 5 years old were compiled using

household registers (MoH 513) which are filled, kept, and updated by Community Heath

- 139 Promotors (CHPs, formerly Community Health Workers or Volunteers). In each village,
- up to 20 households were randomly selected that had children under 5 years old. In
- selected households, a household head or their proxy enumerated household members,

provided information on household demographics, economic activities, recent illnessand malaria prevention measures.

All household members aged 1 year and above were eligible to participate in 144 145 additional survey questions, malaria rapid diagnostic testing (RDT), and dried blood spot (DBS) collection. Individuals 18 years of age or older provided written informed 146 consent. The survey collected data on respondent demographics, practices related to 147 medical history, travel history, and knowledge and attitudes towards malaria and malaria 148 149 prevention practices (questionnaire provided in Supplementary materials Appendix 1). Children under 18 years old participated after written informed consent from a parent or 150 151 guardian. Verbal assent was additionally sought from children 12 years and above. For each household member, a malaria RDT was done and a DBS collected. When a 152 153 household was not available or more than 20% of household members in a village were 154 not contacted, a revisit was conducted. If the household was not available on the 155 second visit, a replacement household was located. Dried blood spots were transported 156 to Webuye, Kenya and tested for the presence of *P. falciparum* and other plasmodium species. Households with malaria positive cases by RDT were given a referral form and 157 provided with transport money to go to the nearest health facility with their RDT results 158 159 to obtain free treatment.

For <u>qualitative data collection</u>, participants aged 18 years or older were selected using a combination of purposive and snowball approaches, using different criteria for each thematic area (Table S1). Recruitment occurred iteratively such that Key Informant Interviews (KIIs) and Focus Group Discussions (FGDs) may have identified important groups for inclusion in additional data collection.

Klls: In each of the ten communities, at least six community leaders were identified for Klls on social and resource mapping. These leaders were chiefs, village, and ward administrators, religious leaders, youth leaders, village elders, and leaders of community groups like fisherfolk. To learn about the community's health profile and challenges in the provision of health services, we interviewed key informants, including heads of health facilities, Community Health Assistants, community health mobilizers, and community health committee members.

In-Depth Interviews (IDIs): Caretakers of children under five were selected to capture different experiences of seeking healthcare and access to community resources. For example, we enrolled caretakers of children living with disabilities, orphaned children, children living far away from the health facility, children who defaulted from nutrition programs or delayed vaccination, and those within families with unhealthy alcohol use.

FGDs: Ranking exercises to understand community member preferences for the mode of SMC administration were done separately with caregivers of children under five and with community elders. FGDs to understand travel, exploring what influenced community members' migration, who they migrated with, and how access to healthcare changed, were carried out with members of the Tree of Men, a group of mature men that act as a decision-making mechanism for pastoralist communities, or with elders in the community. FGDs on CHP experiences were done with CHPs.

Summary of these thematic areas and profile of participants are presented in TableS1.

187 Data collection

For <u>quantitative data collection</u>, interviews were carried out using KoboCollect software in Turkana or Kiswahili. Participants were enrolled from 198 households Turkana Central.

For <u>qualitative data collection</u>, semi-structured guides were created for all KIIs, IDIs, and FGDs, and were translated and back-translated from English to Kiswahili and Ngaturkana. Data collection was carried out in the language choice of participants. The exception was the mass activity domain data that were collected from participants for whom English is the primary work language; as a result, the guides were only available in English, and their interviews were carried out in English.

197 Discussions and interviews were recorded, unless participants did not consent to an 198 audio recording. In these cases, only notes were taken.

In total, 410 participants were enrolled across the ten villages and Lodwar and
 participated in 78 KIIs, 31 FGDs and 60 IDIs.

Quantitative and qualitative data collection was carried out from August to September202 2023.

205 Quantitative data

206 Descriptive statistics for indicators of interest were calculated using *survey* package

207 [24]

in R version 4.4.1 [25] and RStudio 2024.04.2 [26], accounting for study design. At

individual level, we specified stratified selection at Ward level, with three-level sampling

210 (at Village, Household, and Household member level). Probabilities of selection were

calculated at each of the three levels. For household-level variables, only two levels ofselection were specified (Village and Household levels).

214 Qualitative data

215 Debriefings with the qualitative field research team were carried out daily. During the first two weeks of data collection, a study team member read notes from the interviews 216 217 and FGDs to identify emerging key themes and criteria for the selection of participants 218 in the upcoming days. Audio recordings were transcribed and translated directly into 219 English verbatim. Transcripts for KIIs with community leaders and health workers were 220 uploaded and manually coded inductively by NK using ATLAS.ti (v.23.4.0) [27] and 221 NVivo 10 [28]. We used memos to note summary descriptions of findings from all other 222 transcripts and notes, highlight key quotations and synthesize the results. Barriers and 223 anticipated challenges to implementation of SMC were organized around determinants 224 from The Designing for Behavior Change Framework. The framework is based on 225 behavior change theories (i.e., Health Behavior Model and Theory of Reasoned Action) 226 and is used to formalize understanding of determinants, key factors, challenges, and 227 activities for successful design of an intervention for behavior change [29]. In our case, 228 the desired behavior would be the uptake of SMC. The data were organized in a matrix 229 according to the determinants of the Designing for Behavior Change Framework (i.e., 230 perceived self-efficacy, perceived social norms, etc.), along with potential strategies to 231 address the determinant in the implementation of the intervention. Two domains were then identified from the data that represented specific challenges to the implementation, 232 233 delivery and access of SMC that cut across the determinants. Finally specific

242 Results of the quantitative study

243 **Profile of participants in quantitative study**

Twenty households were enrolled in each of the ten villages in Turkana Central Subcounty, with exception of Nasingila village, where 18 households were enrolled. A total
of 983 individuals were enrolled, with enrollment ranging from 72% in Atangi to 90% in
Apetet (Table S2). Percentage of household members who could be found at home and
were interviewed was 79%.
Median age of individuals enrolled was 12 years old [IQR: 5, 26] (Table 1). Majority of
enrollees were female, and most of individuals enrolled were children of the heads of

256 At household level, there was large variability in characteristics such as primary water 257 source and primary source of income. Wards bordering Lake Turkana reported larger 258 reliance on lake water as primary water source (70% of households in Kangatosa ward), 259 with more urban wards reporting higher use of tap water (Township (77%), and 260 Kanamkemer (92%)) (Table S3). Fishing was the primary household source of income 261 for Kangatosa Ward (75%), while small business was the primary source of income for 262 all other wards. Livestock as the primary source of income was most common in Kerio 263 ward (31%) (Table S3).

264 Median household size was 6 people (IQR 5, 8).

266	Prevalence of malaria as reported by PCR and RDT
267	Malaria prevalence was 21% as reported by RDT (95% CI [8.8%-42%]) and 21% by
268	PCR (95% CI [11%-38%]). By both RDT and PCR, malaria prevalence was the highest
269	among individuals 5-19 years old in both sub-counties (Figure 2A).

273 274	Both RDT and PCR positivity varied widely across villages and wards. Kerio Ward
275	had the lowest overall positivity using both PCR and RDT, followed by Township Ward
276	(positivity <20% for both tests) (Figure 2B). However, in Kalokol, Kanamekemer, and
277	Kangatosa, there was wider variability in results; in Kalokol Ward, by PCR, Atangi
278	village had <2% positivity, while Namerisinyen had 73% positivity, although this
279	difference was much smaller by RDT. In Akatorongot and Lokorkor villages, positivity
280	was >50% both using PCR and RDT. While there was some variability in distribution of
281	ages of individuals enrolled across villages and wards (Figure S1), this variability is
282	unlikely to explain all of variability in PCR and RDT positivity.
283	46% and 62% of individuals with positive PCR and RDT results, respectively, did not
284	report any malaria-like symptoms at the day of the survey (reported to be
285	asymptomatic).
286	
287	Knowledge and practices regarding malaria
288	Most individuals believed malaria was present in their area (98%); malaria to be a big
289	problem in their village (98%), and that malaria can be prevented (94%) and cured

290 through treatment (99%) (Table S4). While there was high perception that sleeping 291 under a mosquito net protects against malaria, ownership and use of nets was very low 292 as expected for a region where no mass distribution campaign has occurred. The 293 proportion of households with a net for their sleeping space ranged from 20% in the 294 most rural areas (Kerio Ward) to >50% in more urban township areas (Township and 295 Kanamkemer Ward). Over one-fifth (22%) reported sleeping outside last night; this 296 proportion was highest among individuals 40 years and older (37% [27%-50%]) and 15-297 19 years old (35% [22%-50%]), and the lowest among children under 5 years (11% 298 [8.3%-13%]). However, amongst those who reported having a net available the night 299 before the survey, 99% slept under it. Health education messages about malaria were 300 often received from community health workers, with exception of Township ward, where 301 radio was the most common source of information about malaria (47%) (Table S4). 302 303 Healthcare seeking 304 When asked what the individuals did when they experienced symptoms related to 305 malaria, most reported that they went to the hospital / health facility, although this 306 percentage ranged from 65% in Kerio Ward to 91% in Township Ward (Figure 3). In 307 Kanamkemer Ward, almost half of respondents contacted a CHP indicating that CHPs 308 are already a trusted resource for malaria in these areas.

315 **Profile of participants in qualitative study**

316 Characteristics of individuals participating in FGDs, KIIs, and IDIs are presented in Table 2. In each ward, we enrolled at least ten leaders (five in each village). Profile of 317 318 leaders enrolled was informed by interviews and understanding of the communities; for 319 example, in Kalokol and Kangatossa wards, fishing is an important source of livelihood 320 given proximity of the lake. As a result, in these wards, we carried out interviews with 321 chairpersons of fisherfolk. In each ward, we interviewed at least two religious leaders 322 (enrolling leaders of different religions when present), at least one chief or assistant 323 chief, or another administrative leader in each of the villages (at least two per ward), leaders of women's and youth groups, and other leaders depending on availability and 324 325 relevance. In each ward, we carried out at least two interviews with health facility 326 personnel or chairpersons of the health committee personnel. These were not done in 327 villages where there was no health facility and no active health committee. 328 Seven representatives of government, religious, and non-governmental organizations 329 were interviewed. Furthermore, sixty caretakers participated in IDIs (11-13 per ward). Finally, at least two ranking FGDs were done in each ward; participants included 330 331 caretakers of children under 5, or community elders. In areas with large amount of 332 seasonal movement reported, travel FGDs were carried out either with community 333 members (Township and Kerio wards) or members of the Tree of Men (Kangatossa, 334 Kanamkemer, Kerio wards) (Table 2).

345 Perception of SMC and potential challenges to uptake

- 346 The results are presented by the larger domain that could present challenges to
- reaching high SMC coverage, namely acceptability and reach. In each domain, we
- 348 present findings organized by the relevant themes of the Designing for Behavior
- 349 Change Framework, as presented in Table 3.

355 **Domain 1: Acceptability**

- 356 Community and individual acceptance of SMC will depend on the risk/concern for
- 357 malaria, perceived benefit, and trust with groups implementing SMC.
- 358

359 <u>Perceived severity</u>

- 360 Overall, malaria had a high *perceived severity* as a disease that could result in death,
- 361 with some community members believing it was responsible for many deaths.
- In all KIIs with healthcare workers, malaria was named as a key health issue for the
- 363 community, followed by respiratory infections, diarrhea, cholera and other waterborne
- 364 diseases.
- 365

366 Perceived susceptibility/risk

The targeted population for SMC, namely young children under 5 years old, was

368 seen as consistently susceptible to malaria. However, the *perceived susceptibility/risk*

369 was not exclusive to this group. There were requests that SMC be expanded to include

- other population groups, especially the elderly and pregnant people, or that groups not
- 371 covered by SMC be offered alternative strategies for malaria prevention, such as
- 372 mosquito nets and repellants.
- 373 "What about us? Even if [children's] immunity is low, malaria attacks even adults
- 374 like us. Why can't the government say that even adults should be given [SMC] for
- 375 prevention, even though we are closer to death?" Community leader, Township
- 376

377 <u>Perceived action efficacy</u>

378	The limited population targeted (children under 5 years old) impacted the perceived
379	action efficacy of SMC. In addition, in the Kangatossa ward especially, where Lake
380	Turkana plays a vital role in the livelihood of community members, participants
381	expressed concerns that malaria in their area is not limited to a single season but is
382	present throughout the year.
383	"We will also need [SMC] during the other time because we are affected by
384	malaria even when it is not a rainy season. We are neighboring a river, so there
385	are mosquitos like all the time both during rainy season and during the dry
386	season." – Community leader, Kerio
387	
388	Perceived positive consequences
389	In general, SMC overwhelmingly had perceived positive consequences by all
390	participants. These included improved health outcomes and reduction of mortality from
391	malaria.
392	"It will help the children. It will help them so much. This issue of many deaths will
393	reduce because of late we have been losing a lot of children to malaria. You can
394	give birth to a child and [it] will even die within one day. [] This SMC will help
395	reduce the number of child mortality because of malaria." – Caretaker, Township
396	In addition, participants mentioned that SMC would reduce financial pressure on
397	caretakers of children because of averting malaria, which could further reduce intra-
398	household tensions. The latter advantage was raised often in rural communities outside
399	the Township ward, with participants noting that this would be of particular benefit to
400	less wealthy households, where disposable income was scarce. One participant noted,

401 *"I think [SMC] is good because for some people when their child gets malaria,*

- 402 they don't have the money to take them to hospital. The child just suffers at home
- 403 and sometimes they die." Community leader, Kalokol

404 Furthermore, participants also reported that SMC would help children whose

405 caretakers may not seek care at health facilities for reasons other than cost, such as

406 households with a preference for traditional treatment.

407 Previous Community experience with other mass events, like health campaigns, may

408 ease the acceptability of SMC. For example, the success of campaigns such as polio

409 vaccination may contribute to the positive perception of SMC.

410 "I hope this activity will be good [...], it is like the immunization of polio, because

411 most of our children have been dying of polio, but when the immunization started,

- 412 at least we are seeing it has reduced. People are not more lame now as they
- 413 have been. I think for [SMC] also, although we have not seen it work." Kalokol,

414 community leader

415 Some caretakers described negative experiences with mass events. For example,

416 one caretaker took time off work to attend food distribution; upon arrival at the

417 distribution sites, they found a long queue of individuals that they did not feel met the

418 eligibility criteria for distribution. Despite the wait, the caretaker did not receive food nor

information about future distributions, and felt confused, frustrated, and reticent to

420 attend future mass events, especially those organized by village elders.

421 CHPs were very highly regarded and trusted in most communities. Despite general
422 positive perception of SMC's potential, some participants raised questions about SMC
423 being administered by anybody other than qualified medical personnel. Specifically,

424 some participants expressed distrust of the CHP's ability to provide a correct dose of

425 SMC to the child, stating that they would only accept SMC from nurses or doctors.

426

427 Perceived social norms and culture

428 In addition to the primary caretaker's acceptability of SMC, participants highlighted the importance of interpersonal- and community-level acceptability of SMC, with 429 perceived social norms and culture playing a role in the caretaker's decision on whether 430 their child should take the drugs. Most commonly, when alive, the child's mother was the 431 432 primary decision-maker about health. However, many individuals influenced the mother, including neighbors, family members, community elders, CHPs, religious structures, and 433 434 clans.

435 Community leaders often set and modeled social norms. Their engagement and acceptance of activities were consistently underscored as a major factor in their 436 437 success and a requirement for the implementation of SMC. In addition, households 438 reported being connected through the many religious groups in the area, with leaders playing an important role in healthcare decision-making and beyond. In addition to 439 440 religious leaders, administrative leaders like area chiefs and ward and village 441 administrators have considerable presence and influence in the communities. Together with village elders, these leaders were reported to be the major source of information 442 443 across all wards.

444 Community leaders provided support by organizing barazas (community gatherings) summoned by the chief or village elders) or sharing information about an event and 445 446 sometimes serving as an example by modeling the desired behavior:

447 "My role, one is to mobilize the people, two is to help them have confidence in the activity that is supposed to be undertaken, because sometimes the people 448 might be asking, why, why; like that one of Covid-19 [vaccination]. People had 449 450 many misconceptions. They said, this one will kill, this one will do this. So, you give them the confidence and then you become the first person to be vaccinated, 451 and then they wait for you. They say, let's see if you can die. So, to create trust in 452 them and the confidence, at least you must be the lead." - Community leader. 453 454 Kalokol

Beyond formal leadership and religious leaders, communities had structures that 455 456 linked community members based on livelihood activities or individual characteristics. 457 These included youth groups, fisherfolk groups, women groups, table banking, and 458 others, reinforcing connections between households and individuals. Regardless of the 459 groups' objectives, these also served as a mode of sharing information about community matters, including health. Additional community structures included the 460 461 Nyumba Kumi, or clusters of ten households initially set up as a community policing concept [30] that has since extended to implementation of COVID-19 counter measures 462 among others [31], and kraals among the pastoralists. A positive or a negative view of 463 464 SMC by leaders and other members of these groups was likely to influence their members' view and uptake of SMC. 465

466

467 <u>Perceived negative consequences</u>

There were few *perceived negative consequences* of SMC, although participants did raise questions about the contents of the drug, potential side effects, and risk of

470 overdose to the child. In all wards, participants noted a possibility of misinformation 471 contributing to perceived negative consequences of SMC, especially among community members with lower education levels. In a few communities, leaders noted an increased 472 473 resistance towards medication/drugs; this resistance may extend to SMC. Participants 474 often requested that SMC be accompanied by food and drinks for the children during administration to ensure they were not taking it on an empty stomach. 475 476 **Domain 2: Reach** 477 In this domain, we present challenges classified under the Access determinant, 478 namely hard-to-reach communities, households, and individuals; mobile population; 479 individuals experiencing stigma; and other groups. 480 481 Hard-to-reach communities, households, and individuals 482 In general, access was the most reported challenge to the implementation of SMC. 483 484 First, there are physical components to access that may impact SMC coverage. The

geography poses physical barriers, such as rivers and mountains, limiting access for 485 486 groups outside the Township and Kanamkemer wards. In sparsely populated Turkana Central Sub-County, individuals who live in far, difficult-to-access areas, such as interior 487 rural areas and pastoralist communities, were often identified as at risk of missing SMC. 488 489 Another group was those with less wealth and limited transportation options. In addition, 490 there are multiple populations displaced by conflict, such as communities in Kerio, who regularly lack access to health facilities and CHPs due to the remote location of their 491 492 new settlements. In at least one case, following conflict over cattle, a portion of the

493 population relocated across the river from their original settlement and the health facility,

494 with a small group settling in the mountains where they felt less at risk of future attacks.

495 Strategies to reach this population include outreach and, to a smaller extent, distribution

496 of SMC at central locations in the village during large market dates.

497 In addition to physical barriers to access, there are *access* concerns for school-going

498 children. In Kenya, most children three to five years old attend Early Childhood

499 Development and Education centers for pre-primary education [32], with some children

500 attending madrasa, Islam-centered schools that fall outside the formal education sector.

501 As a result, if SMC is administered while school is in session, many children in the

target group would be absent from households during the day. Some participants

suggested the distribution of SMC through schools by health workers, complemented by

504 community-level or health facility distribution for other children. However, parental

505 consent would have to be obtained before school-level administration, and children's

age eligibility would have to be confirmed. In madrasa schools, in particular, parents

507 may feel strongly about the need to be present during administration, as reported by a

508 religious leader.

509 On the other hand, children whose caretakers are unavailable during the workday 510 would not receive SMC unless someone could provide approval. This was a particular 511 problem in urban communities, especially in Township ward, where many primary 512 caretakers leave home early in the morning and return late at night during the working 513 week. Door-to-door strategies, or fixed-point distribution during workdays, would miss 514 these children.

515	Although there exists a system of registering newly arrived households and
516	individuals in households rosters, this process was reported to take up to six months.
517	During this time, new arrivals may miss out on regular visits from CHPs and from being
518	included in mass events, if the SMC campaign requested registration card prior to
519	administration of SMC drugs.
520	Further, in some communities, participants reported perceived corruption of
521	community elders or other individuals involved with mass events. Respondents
522	suggested engaging women or religious leaders in distribution as a possible mitigation
523	strategy, as the latter were perceived to be less corrupt.
524	
525	Mobile populations
526	Travel and migration may mean that children's access to healthcare is disrupted or
527	changed. Although we identified some instances of short-term travel, such as visits to
528	sick family members, temporary employment, and migration in the fisherfolk community,
529	longer, predominantly seasonal migration by pastoralists is likely to pose a larger
530	challenge to success of SMC. Specifically, we focused on understanding the
531	movements, shift in healthcare seeking, and opportunities to reach pastoralist
532	communities during migration.
533	Whether young children participated in pastoralist travel varied by location and
534	household. It was most common that young and middle-aged men were the ones to
535	migrate with the herd. These men would be accompanied by older children (usually
536	about ten years and older), and women. Some households were divided in two, with the
537	elderly, young children, people living with disabilities, and some women remaining

behind, while others, usually smaller households, would migrate together. Children who
attended school would often be left behind to continue their education. Some polygamist
families would split, with one wife remaining behind, and others migrating. This
complicated our understanding of how many children may actually leave their
communities during migration, and would require additional efforts for mapping and
quantifying how many of these children migrated during SMC.

Planning for reaching migrating children may also be affected by shifting and less 544 545 stable migration periods. Until recently, drought seasons spanned about six months, with one dry season from January to April, and a shorter dry season from August to 546 547 September. However, participants noted that recent shifts in climate made seasonality 548 much less predictable. As a result, pastoralist migration occurs more sporadically, with 549 pastoralists leaving in search of pasture whenever there is a drought. Pastoralists would 550 return to their residence communities under three circumstances: when rains occurred, 551 the pasture in migration destination was depleted, or they encountered insecurity. As 552 SMC is likely to be administered just before and during rainy season, we anticipate that most of the monthly cycles would find pastoralists in their home locations; however, 553 554 unstable rain patterns may result in some children migrating outside their communities 555 during SMC administration.

Linking children to care during migration may be difficult. Often participants reported that travel would take place to an area far from a populated place and lack access to formal health system, except through rare outreach events, organized as mobile clinics brining services to these communities. Although CHPs played an important role in linking community to care, often providing screening and curative services, these

561 connections are disrupted during migration. While some pastoralists reported that they 562 were able to maintain contact with their CHPs by mobile phone, for others, there was no 563 contact. Participants described that they often introduced themselves to the elders in 564 the new location they migrated to, and were then linked to this community's CHPs. However, even after being assigned a new CHP, they reported receiving limited 565 566 services. More often, pastoralists settled in an area outside of formal settlements, and 567 their relationship with the new community was limited. As a result, pastoralists reported 568 that their children often missed vaccination during migration. 569 Rarely, pastoralists reported returning to their residence communities to seek 570 healthcare. However, participants stated that if they received information about a mass 571 event like a vaccination campaign or SMC, they would likely return to their residence 572 community. Often, they recommended using community leaders (as below), or CHPs, to 573 provide this information by mobile phone. Migration decisions were dynamic, and led by a group of initiated elders called the 574 575 Tree of Men (Ekitoe a ng'ikiliok). While the quick initiation of migration may make it difficult to adapt SMC strategies to reach pastoralist children, existing relationships and 576 577 communication strategies between the elders and the Tree of Men could be leveraged to facilitate service delivery during migration. 578 In addition to children who migrated with the pastoralists, we explored whether 579 580 children who remained in their residence communities would experience additional

581 barriers to SMC. Responds assured us that when the head of the household migrates,

the remaining caretaker can make decisions about healthcare. While a young child

usually remains with their mother if possible, extended family members or neighbors

584 sometimes served as primary caretakers. In these cases, the caretaker may consult 585 with elders, Nyumba Kumi (organization of ten households), CHPs, and other community members when making the decision about the child's health. The father may 586 587 become involved only when the child's care requires financial resources outside the 588 remaining caretaker's ability to manage and hence would not impact SMC. 589 Individuals experiencing stigma 590 591 Stigma is an additional barrier to SMC from the perspective of both healthcare 592 providers, including CHPs, and caretakers. There are caretaking groups, such as those struggling with alcohol use, that are negatively perceived by many healthcare providers, 593 community leaders, and other community members. Several respondents mentioned 594 595 that individuals struggling with alcohol use often caused disturbances, were not 596 receptive to information about child's health, and were unable to care for their children. 597 When carrying out their activities, CHPs reported sometimes skipping households that 598 struggled with alcohol use, while others recounted making several attempts to visit the 599 household when the caretaker was not under the influence of alcohol. Children living in 600 these households were reported to have been missed in both door-to-door and central 601 location mass events. 602 There are two additional groups of children, those with disabilities and those living in 603 households with a person living with HIV, that were identified as vulnerable to being 604 missed. Children with physical disabilities, or those with caretakers with limited physical abilities, were often unable to attend distributions outside of the home, especially in rural 605 606 areas. Some caretakers were reported to hide children with physical or mental

disabilities due to shame and stigma and refused to provide access to their children to

608 healthcare personnel, including CHPs. These children had lower access to and uptake

609 of routine preventive and curative health services.

610 "Some mothers especially with disabled children tend to hide these children from

611 CHVs [CHPs] and other community members, so they end up unattended." –

612 Community leader, Kerio

613 While CHPs did not report negative attitudes towards children with disabilities, one

614 community leader reported that some CHPs feel reluctant to work with these children

due to the perception that some are dirty. For children with disabilities, using CHPs to

616 deliver SMC at home was the predominant strategy suggested. However, the

617 involvement of community leaders may be necessary to reduce the reluctance of

618 caretakers to allow people in their homes.

In addition, CHPs reported that some people living with HIV were fearful that their status might be disclosed and, as a result, preferred not to allow CHPs or healthcare personnel into their households, no matter the reason for the visit. Some CHPs said they expected to be met with violence when visiting households with people living with HIV, resulting in a reluctance to visit. For example, when asked about households that

were difficult for CHPs to work with, one CHP replied,

625 "That household where a person is HIV positive, whenever they see you, they will
626 just start abusing you recklessly without any reason." – CHP, Kalokol

627 Community leaders, on the other hand, reported that people living with HIV were less

628 likely to seek services at health facilities, where they were fearful of being systematically

629 tested for HIV. Ensuring clear communication about the objectives of SMC and

630 decoupling it from services that target people living with HIV may reduce the fear of

631 stigma and disclosure.

Finally, children of sex workers were reported to less likely present to health facilities due to their caretakers' fear of being systematically tested for HIV. However, participants did not report significant barriers to access of these children by CHPs in their homes or in locations outside health facilities.

636

637 Approaches to ensuring high coverage with SMC

638 Despite the identified barriers to acceptability and access to SMC, participants

639 identified opportunities and facilitators that can guide the design of the program

640 strategy.

641

642 Sensitization and mobilization are crucial for success of SMC

In most interviews and discussions, participants highlighted the importance of community sensitization and mobilization prior to administering SMC. These were seen as necessary for acceptance and uptake of the event, and **participants linked insufficient sensitization to negative experiences with previous mass events**, contributing to vaccine hesitancy during the COVID-19 campaign and physical scuffles during relief food distribution.

Leaders often noted their desire to be involved in the activities from the early stages of design to the end of the project. Some had felt caught unaware by earlier mass activities done without consultation. Community members also expressed the desire to see community leaders' buy-in. Elders were identified as leaders with close ties to the

community and were often suggested as focal points to ensure accountability during the
 roll-out of SMC and report any issues afterward. Notably, some leaders expected
 remuneration as they engaged in activities.

656 Across all wards, participants reported receiving information through the chief's 657 barazas (organized discussions with community members), through village elders, CHPs and health workers, church, door-to-door, and through word of mouth, primarily 658 659 through friends and neighbors. Less often, participants received information through 660 community groups like women's groups, WhatsApp, radio and public announcements, pamphlets and posters, and loudspeakers. Sharing information by phone has become 661 662 more common over time, which is particularly important to households who live far away 663 in less densely populated areas. These findings highlighted the importance of engaging 664 multiple communication channels when sharing information and mobilizing the 665 community before SMC. Information shared should address concerns raised by 666 community members that led to *perceived negative consequences*. Additionally, 667 respondents asked other questions (Appendix 2); preemptively addressing these during community sensitization may reduce confusion and frustration by community members. 668 669 When possible, SMC should be accompanied by the distribution of mosquito nets, as 670 well as education activities on ways to reduce mosquito habitats and prevent malaria. 671 Less commonly, participants requested mosquito tents and repellents, although these 672 are not items that have previously been distributed through government initiatives. The 673 preference for coupling SMC with other interventions, such as providing food relief or improving water, sanitation, and hygiene, was widespread in rural areas and among 674 675 pastoralists.

676 Modes of SMC delivery

677 In most ranking FGDs, there was not a single strategy for SMC delivery that was preferred by all participants. Rather, combination approaches for rolling out SMC were 678 679 suggested, where a dominant strategy was expected to reach most eligible children, 680 supplemented by an additional approach for hard-to-reach populations. Strategies, 681 including their strengths and limitations, are described in Table S6. In urban and periurban wards, distribution through a central location, namely a health facility, was the 682 683 dominant strategy. However, this approach is likely to miss children as detailed above 684 and the perception that all services at health facilities require payment, also 685 discouraged some participants from selecting this as a dominant strategy. 686 Supplementary strategies to reach these children included door-to-door, use of CHPs, 687 use of a central location in the village for distribution, and distribution in schools. 688 Distribution through stages, or transportation hubs, was suggested to reach mobile 689 populations in urban areas. Distribution through churches on Sunday was suggested to 690 reach well-to-do households that were often resistant or inaccessible to CHPs. 691 In more rural wards, decentralized approaches for distribution were generally 692 selected as dominant strategies, including door-to-door, CHPs, and distribution through 693 churches. Supplementary approaches like outreach to improve access for pastoralists 694 and children who travel with caretakers to the river and the lake for fishing were 695 suggested. Central location distribution strategies and distribution through health 696 facilities were also identified as supplementary strategies. Engaging with the elders and 697 Tree of men would also be necessary for reaching pastoralist children.

698 While CHPs were seen as a crucial component of SMC rollout across all wards, 699 whether by distributing SMC directly, identifying households with children under five 700 years old, or as a part of sensitization and mobilization efforts, serious concerns were 701 raised about support necessary to be provided to the CHPs. CHPs often reported being 702 overwhelmed, with one CHP being responsible for as many as 145 households. Both 703 CHPs and key informants reported competing priorities, and the need for support 704 including transport, water, and increased stipends, in addition to reporting tools and 705 operational supplies like bags and airtime.

706

707 Discussion

708 In this study, we found high prevalence of malaria in Turkana Central Sub-County, 709 with 15% positivity by PCR among young children 6 months -4 years old. With only a 710 guarter of individuals reporting sleeping under a mosquito net the night before the 711 survey, and highly seasonal pattern of malaria cases, strategies like SMC may provide a 712 feasible way to mitigate the burden of malaria in this area. Overall, we found strong 713 support for SMC from community members, including caretakers of young children, 714 community leaders, CHPs, and healthcare personnel. While SMC was largely 715 acceptable, access is likely to be a significant barrier to reaching high coverage. 716 Physical access was challenging in rural and more remote communities due to distance 717 between households, poor or absent roads, and challenging terrain. In urban 718 communities, while households were relatively easy to reach, many caretakers were 719 absent during the day or were inaccessible to CHPs. These findings are consistent with

challenges to access documented in previous SMC distribution campaigns in the Sahel,
especially in rural areas [33].

722 The pastoralist population in Turkana Central Sub-County is likely to face unique 723 challenges in accessing SMC owing in part to changing climate patterns, leading to less 724 predictable migration, and disruption of healthcare access during migration. In this 725 study, participants identified strategies such as outreach and engagement with 726 pastoralist leadership structures, including the Tree of Men, as a feasible approach to 727 reach the pastoralists. Strategies like the One Health strategy, launched in Turkana 728 County in 2023 [34–36], can provide additional opportunities to reach pastoralists 729 through existing collaborations between Ministries, especially if SMC is provided 730 alongside veterinary or water services. Collaboration between various Ministries 731 working with pastoralist populations could facilitate implementation of SMC: for 732 example, information collected by the Ministry of Livestock during the registration of 733 pastoralists can be used to map children during migration. Initiatives like the Community 734 Disease Reporters, which engage pastoralists in animal health surveillance, can be 735 replicated for SMC. Training SMC focal persons among pastoralists who move with the 736 kraals to distribute SMC in those locations may also be advantageous. This is 737 consistent with literature highlighting the importance of training community drug distributors (CDDs) from mobile populations in increasing uptake of mass drug 738 739 administration for diseases like trachoma [22,37]. Similarly, appropriate treatment of 740 malaria and use of nets was significantly higher in nomadic Fulani communities that had 741 trained representatives than those without [38]. However, deploying pastoralist SMC 742 distributors may require more extensive training and supervision than CHPs or

healthcare workers to ensure the community trusts the focal persons' abilitiessufficiently.

745 Caretakers and community leaders preferred a combination of approaches for 746 effective SMC distribution, varying across urban and rural settings. Optimal strategies 747 may rely on a dominant approach supplemented by a complementary secondary 748 distribution strategy informed by the specific access challenges of each community. In 749 more rural, interior areas, a door-to-door approach by CHPs or specialized health 750 personnel is likely to work well, supplemented by well-tailored outreaches to reach 751 pastoralists and people further in the interior. In these rural areas, static distribution 752 through centralized locations like churches and health facilities would provide an 753 alternative for those missed at home or through outreach. In urban areas, door to door 754 efforts may miss those who work outside the home or who prefer to choose their 755 healthcare provider. In this setting, SMC distribution at health facilities may supplement 756 door-to-door or CHP distribution efforts.

757 In Turkana Central Sub-County, engaging with community leadership structures is crucial to SMC's success. Leadership structures include established government 758 759 structures (chiefs, village elders) and religious leaders, but also unique locally instituted 760 networks such as Tree of Men, kraal leaders and irrigation committees. These networks 761 not only have unique insight into community dynamics and broad reach to remote and 762 mobile households, but could also provide accountability of SMC program to the 763 community. Participants highlighted the powerful role that leaders could play as influencers and role models, particularly for new initiatives. Engaging existing leadership 764

structures in planning, sensitization, distribution, monitoring, and follow-up is critical forthe campaign's success.

767 This study has several limitations. While during qualitative data collection, we made 768 efforts to capture the experiences of individuals at different points of the power 769 spectrum, we heavily relied on information from community leaders and CHPs to 770 understand the community structure and identify individuals for qualitative data 771 collection. It is likely that we missed individuals who were excluded from community 772 participation. We were similarly unable to engage with pastoralists and individuals living 773 on the other side of the mountains. This was especially the case in Kerio ward. While 774 our teams made an effort to interview some pastoralists who came from faraway 775 locations to the village on market days and to understand the particular challenges of 776 this community from the Tree of Men and other community leaders, we were unable to 777 obtain this information directly.

778 In the quantitative study, the major limitation was availability of up-to-date sampling 779 frame. For the first stage of sampling, we relied on the list of villages and populations provided by the Ministry of Health; however, it is possible that some of the remote 780 781 villages with little access to CHPs and health facilities were excluded from this frame. 782 Furthermore, older children (>15 years old) and male adults were more often absent from households during time of data collection, as evidenced by larger proportion of 783 784 children and female participants in the sample, compared to expected. Although our 785 teams carried out mop-up to increase enrollment, the results are subject to selection bias. However, very few children under 5 years old were unavailable. 786

787 Despite these limitations, our findings showed that in Turkana Central Sub-County, 788 SMC presents a promising approach for mitigating morbidity and mortality from malaria 789 in a highly-vulnerable group. However, ensuring widespread SMC coverage requires a 790 respectful and inclusive engagement with established community structures, and using 791 context-tailored approaches including combination strategies for SMC delivery for hard-792 to-reach population. SMC offers a chance to integrate supplementary initiatives, such as 793 distributing relief food, mosquito nets, and animal health programs. These identified 794 strategies are transferrable to other contexts as SMC expands beyond the Sahel region. 795
