The Swiss national program for the surveillance of influenza A
viruses in pigs and humans: genetic variability and zoonotic
transmissions from 2010 – 2022

17 Abstract

Influenza A viruses (IAV) are likely candidates for pandemics. This report summarizes the 18 19 results of the Swiss national program for surveillance of influenza viruses in pigs and transmissions to humans between 2010 and 2022. Challenges and optimization options in the 20 21 program are discussed. 22 Nasal swabs or lung tissue samples from pigs with influenza-like signs (e.g. fever, cough) were screened by real-time RT-PCR for swine influenza virus (SIV) genomes, including that of the 23 2009 pandemic strain A(H1N1)pdm09; positive samples were subtyped for H1, N1, H3 and N2 24 by RT-PCR and Sanger sequencing. In parallel, humans with influenza-like symptoms and 25 recent contact with diseased pigs were asked to self-sample themselves with a nasal swab. 26 27 Human swabs were tested for IAV, and positive swabs further subtyped to identify potential cross-species transmission between swine and humans. 28 29 In the pigs, SIV was detected in 375 of 674 farm visits. H1N1 is the only subtype detected in 30 Swiss pigs so far. The (H1N1)pdm09 strain (HA clade 1A) was only detected in seven out of 375 SIV positive farm visits. Phylogenetic analyses from partial hemagglutinin (HA) and 31 32 neuraminidase (NA) genome sequences indicate that the remaining pigs were infected with the Eurasian avian lineage (HA clade 1C), which is predominant in swine in Europe. The Swiss 33 H1N1 strains form distinct clusters within HA clades 1C.2.1 and 1C.2.2 and seem to evolve 34 comparably slowly. Infection of humans with SIV was identified in five cases. Sequence analysis 35 assigned the five viruses to the Eurasian avian lineage (C), clades 1C.2.1 and 1C.2.2. There was 36 37 no evidence for sustained human-to-human transmission. 38 Although no critical IAV variants seem to have emerged so far in Switzerland, further surveillance of influenza viruses at the swine-human interface is of major importance. 39 40

42 Introduction

- 43 Influenza A viruses (IAV, genus Alphainfluenzavirus) belong to the family of
- 44 *Orthomyxoviridae*, a highly heterogenic group of viruses currently comprising nine genera
- 45 (https://ictv.global/taxonomy, accessed August 6, 2024). They are pleomorphic enveloped
- viruses of 80 120 nm in diameter with a segmented single-stranded RNA genome of negative
- 47 polarity of approximately 10 13.5kb in size (Fig. 1).

53 IAVs are highly diverse and classified into subtypes, whose nomenclature is based on the genetic

- and antigenic properties of the two major surface glycoproteins hemagglutinin (HA) and
- neuraminidase (NA) (WHO, 1980). Three characteristics contribute to the rapid evolution and
- high diversity of IAV subtypes (Abdelwhab and Mettenleiter, 2023; Kessler et al., 2021;

The structural proteins HA and NA, which are responsible for attachment to the cell via the
cellular receptor sialic acid (HA) and for mucus degradation in the upper respiratory tract as
well as release of virus progeny from the cell after replication (NA), face strong evolutionary
pressure.
The RNA polymerase of influenza viruses lacks proofreading ability, conferring a more rapid

accumulation of point mutations in the genome. In HA and NA, this process is referred to as
 antigenic drift.

The segmented genome of IAV allows for reassortment, i.e. the reorganization of genome
segments in cells co-infected with different IAVs, which may give rise to progeny viruses
exhibiting markedly altered features. In HA and NA, this phenomenon is known as *antigenic shift*.

To date, 19 HA and 11 NA subtypes have been described (Karakus et al., 2024). With the

exception of H17, H18, N10 and N11, which were recently detected in bats (Tong et al., 2012;

Tong et al., 2013), all 17 HA and 9 NA subtypes have been detected in wild waterfowl (e.g.

ducks, geese, gulls). In theory this translates into 144 different H/N combinations, of which at

rease 110 have been isolated to date (Pippig et al., 2016). Wild aquatic birds are therefore

considered the natural reservoir of IAV (Bourret, 2018; Kessler et al., 2021). In the reservoir

hosts, the virus establishes an enteric, usually asymptomatic infection and is shed via feces

76 (Abdelwhab and Mettenleiter, 2023). Although the majority of these avian strains are host-

specific, from wild waterfowl the virus can be transmitted to a wide range of other species

including humans, horses, pigs, poultry, dogs, cats, ferrets, seals, mink via direct or indirect

79 contact or aerosols (Fig 2). In most of these cross-species transmissions, viral fitness is

80 insufficient in the new host, such that these variants undergo extinction after a few replication

81 cycles. However, in rare cases the virus gradually adapts to the new host by accumulating

82 mutations, allowing it to establish sustained transmission cycles within the species, species-

specific lineages, and pathogenicity (Abdelwhab and Mettenleiter, 2023; Long et al., 2019).

IAVs are circulating worldwide and have a high economic and health-related impact on humans 93 and animals. In humans, pigs and horses, IAVs establish a respiratory infection with fever, 94 headache, myalgia, lethargy, dry cough, sore throat, sneezing and nasal discharge (Kuntz-Simon 95 and Madec, 2009; Vincent et al., 2020). Asymptomatic infection may also occur. The incubation 96 period is between 1 and 3 days. Infection is usually self-limiting with recovery beginning 4-797 days after onset of clinical symptoms (Vincent et al., 2020). However, especially in young and 98 immunocompromised humans and animals severe illness with secondary bacterial infections and 99 pneumonia can develop and eventually lead to death (Abdelwhab and Mettenleiter, 2023; 100 Krammer et al., 2018). The viruses are shed in nasal secretions and transmitted via direct contact 101 102 between infected animals, indirect contact with virus-contaminated fomites, or through 103 inhalation of aerosols (Nguyen et al., 2023). In swine, influenza is considered one of the most important pathogens of the respiratory disease complex, causing high economic losses due to 104 poor performance and prolonged fattening periods (Ma, 2020). 105 In poultry and wild birds, a distinction is made between low (LPAI) and highly pathogenic avian 106 influenza viruses (HPAI). While LPAI can cause mild disease, HPAI carry a specific mutation in 107 the HA gene allowing it to spread systemically and cause a highly lethal disease not only 108 109 affecting the respiratory, but also the gastrointestinal tract and the central nervous system of the 110 birds (Taubenberger, 2019). Continuous zoonotic and reverse zoonotic transmission of IAVs, especially between humans, 111 swine and birds gives rise to endemic/enzootic strains but also to strains with pandemic potential 112 113 (Abdelwhab and Mettenleiter, 2023; Kessler et al., 2021; Rajao et al., 2019). Endemic/enzootic IAV strains usually are the result of *antigenic drift* with subsequent minor changes in virus 114 biology. These strains are constantly present in a confined region or population, at least partially 115 recognized by the host's immune system, and characterized by high morbidity (up to 100%) and 116

117 low mortality (<1%) (Vincent et al., 2020). The predominant endemic/enzootic IAVs currently

circulating in pigs and humans are of the H1N1 and H3N2 subtypes (Fig. 2). However, porcine

119 and human strains are antigenically and genetically distinct from each other (Krammer et al., 2018; Kuntz-Simon and Madec, 2009; Lewis et al., 2016). Pandemic strains, on the other hand, 120 most often emerge upon antigenic shift, which is associated with abrupt changes in the antigenic 121 properties of HA and NA. After infection with these strains, the host immune response is facing 122 new epitopes, which are not or insufficiently covered by the immunological memory. Pandemic 123 strains are characterized by rapid worldwide spread, high morbidity, more severe clinical signs, 124 and potentially increased lethality (Krammer et al., 2018). Due to increasing immunity in the 125 population and antigenic drift, pandemic strains may become endemic and replace the ones that 126 previously circulated seasonally. The most recent example of strain replacement is the 2009 127 128 influenza H1N1 pandemic virus A(H1N1)pdm09 that replaced the former seasonal A(H1N1) in 129 humans (Long et al., 2019). Since the beginning of the 20th century, humanity was struck by four IAV pandemics, three of which were of avian (H1N1 Spanish Flu 1918, H2N2 Asian Flu 130 1957 and H3N2 Hong Kong Flu 1968) and one of porcine origin (H1N1pdm09 2009) (Long et 131 al., 2019, Saunders-Hastings and Krewski, 2016). 132 The cell receptor is a major determinant in host susceptibility to influenza viruses (Abdelwhab 133 and Mettenleiter, 2023; Long et al., 2019). Owing to the location and density of cell receptors 134 and the tropism of IAV, swine are considered a key species of concern in the emergence of 135 136 pandemic strains (Bourret, 2018): human IAV strains have higher binding specificity to host glycoproteins containing sialic acid moieties in $\alpha 2,6$ -galactose-linkage, which are most 137 abundantly expressed in epithelial cells of the human upper respiratory tract. In contrast, avian 138 139 strains preferentially bind to $\alpha 2,3$ -galactose-linked sialic acid, which in avian species is present in the upper and the lower respiratory tract as well as the intestines, in humans, however, in the 140 less accessible lower respiratory tract. Given the presence of both cell receptor types in pigs, it 141 has long been believed that swine take on the role of a mixing vessel for viruses of human and 142 avian origin, giving rise to novel reassorted variants to which humans are immunologically naive 143

144 and highly susceptible. However, considering recent studies on the types and distribution of cell

receptors in other species, the assumption that pigs are unique in expressing both receptor types 145 and thus in being susceptible to infection by both avian and mammalian-adapted influenza 146 strains no longer seems to be valid (Abdelwhab and Mettenleiter, 2023; de Graaf and Fouchier, 147 2014; Kuchipudi et al., 2021; Liu et al., 2023; Long et al., 2019). Instead, it is now hypothesized 148 that additional factors determine receptor-specificity and pathogenesis, e.g. viral proteins NS1, 149 polymerases, NA, and the host immune response (de Graaf and Fouchier, 2014) and that pigs 150 serve as intermediate hosts in which pre-adaptation of avian subtypes to humans occurs (i.e., a 151 gradual shift in IAV binding specificity for $\alpha 2.3$ -gal to $\alpha 2.6$ -gal sialic acid) thereby favoring 152 transmission to humans (Bourret, 2018; Kuntz-Simon and Madec, 2009; Liu et al., 2023; Su et 153 154 al., 2021). Thus, the pigs' key role in IAV evolution is thought to be less related to physiological 155 conditions than to husbandry practices where pigs and wild birds or poultry are kept in close proximity to each other, which increases the risk of interspecies transmissions (Long et al., 156 2019). 157 The risk of the emergence of novel influenza virus strains and global spread has risen 158 significantly in recent decades due to the intensified livestock farming, invasion of wildlife 159 habitats for agricultural use, and increasing transboundary movement of animals, humans, and 160 goods (Kessler et al., 2021; Saunders-Hastings and Krewski, 2016). As a matter of fact, the first 161 infections of HPAI H5N1 in dairy cattle have only recently been reported from the U.S.A. 162 Interestingly, the virus replicates mainly in the mammary gland. Transmission between cattle is 163 therefore thought to occur mainly through the milking process. From the cows, the infection has 164 165 spilled over to humans, cats, rodents and poultry, highlighting the potential public health risk of this current outbreak (Eisfeld et al., 2024). 166

167 Given its potential role as a breeding ground and transmitter of new, potentially pandemic

strains, surveillance of influenza viruses in pigs is of high importance. In the context of the 2009

pandemic caused by the originally porcine influenza virus A(H1N1)pdm09, the influenza virus

170 surveillance in humans and pigs launched in 2001 in Switzerland was intensified. In

- 172 Public Health (FOPH), the Institute of Virology at the Vetsuisse Faculty of the University of
- 173 Zurich, the National Reference Centre of Influenza (NRCI) at the University Hospital in Geneva
- and the Pig Health Service of SUISAG, a national program for surveillance of influenza viruses
- 175 in pigs and in-contact humans was initiated, the aims of which were the following:
- 176 Detection and molecular characterization of IAVs circulating in Swiss pigs and in-contact
- 177 persons showing influenza-like symptoms, with a focus on HA and NA genes
- 178 Where available, comparison of the genome sequences obtained from pigs and in-contact
- 179 humans to identify potential cross-species transmission
- Early identification of the emergence of new IAV subtypes and changes in the epidemiologic
 situation in pigs

- 182 This study aims to present the results of the Swiss national program for the surveillance of
- influenza viruses in pigs and humans from 2010 2022, to discuss challenges in the success of
- 184 national influenza virus surveillance and opportunities for optimization. The study does not
- 185 claim to assess the prevalence of IAV in pigs.

186 Material and methods

187

188 Ethics statement

189 Porcine samples were taken by veterinarians (Pig Health Service, herd or private veterinarians)

190 from clinically ill pigs and possibly contact animals with suspect SIV infection. The farms were

191 located all over Switzerland.

192 The human samples from the target population (persons with influenza-like symptoms and recent

193 contact with diseased pigs) were obtained by self-sampling. Based on an official letter from the

194 Federal Office of Public Health (FOPH) stating that human data and samples were collected in

accordance with the Swiss Epidemics Act (EpG SR 818.101), the cantonal ethics committee of

196 Zurich waived ethical approval for this work (BASEC Req-2024-01630).

197

198 Sampling of pigs and humans

Within the scope of the monitoring program, pig farmers were asked to report pigs with 199 influenza-like signs such as cough and fever to the Pig Health Service. Nasal swabs (UTM 200 201 Universal transport medium; Copan, Brescia, Italy) were then collected from acutely diseased 202 pigs and contact animals by a veterinarian of the Pig Health Service, a herd veterinarian, or a private veterinarian. Persons with influenza-like symptoms and recent contact to these pigs were 203 asked to swab themselves. Consenting individuals were provided with flexible minitip 204 205 FLOQSwabs (Copan) and 3ml UTM tubes for self-sampling. In absence of recent influenza-like symptoms in humans, three (2010 - 2014) or two pigs (2015 - 2022) per farm were sampled. 206 Three pigs were sampled if in-contact humans were symptomatic. In addition to the specimens 207 collected on-site, nasal swabs (UTM, Copan), lung tissue or dry lung swabs from pigs with 208 suspected influenza infection were collected by institutes of veterinary pathology. Porcine 209 210 samples were analyzed at the Institute of Virology, University of Zurich. Human samples were

- 211 analyzed at the National Reference Centre of Influenza (NRCI) in Geneva. The samples were
 - 212 kept at 4°C (short term) or -20°C (long term) (Fig. 3).

220 **Testing of porcine samples**

Until 2018, all porcine swabs were examined separately. From 2019, in case of absence of recent 221 influenza-like symptoms in humans the samples were pooled, yielding a single sample per farm. 222 If human samples were collected due to suspect influenza cases, the porcine samples on the 223 respective farm were always analyzed individually (Fig. 3). The nasal swabs were thoroughly 224 vortexed and centrifuged at 2671 x g (Heraeus Multifuge 3S-R, Thermo Scientific) for 10 min at 225 room temperature (RT). The supernatant of each swab was mixed with antibiotic and 226 antimycotic solution (100X, Sigma-Aldrich, St. Louis, U.S.). For pooling, 80 – 100µl of each 227 supernatant were added to 560µl AVL buffer containing 5.6µl carrier RNA (QIAamp Viral RNA 228 Mini Kit, Qiagen). The mixture was thoroughly vortexed and incubated for at least 10 min at RT. 229 Lung tissue or lung swabs from institutes of veterinary pathology were pooled per farm. The dry 230 231 swabs from lung tissue were immersed in 140µl PBS, thoroughly vortexed and centrifuged for 5 min at 16'000 x g. Lung tissue was subjected to three freeze-thaw cycles, centrifuged and 140µl 232 of supernatant were used for RNA extraction. The supernatants of lung tissue and lung swabs 233 were mixed with 560µl AVL buffer containing 5.6µl carrier RNA. Extraction was carried out 234 235 according to the manufacturer's instructions (QIAamp Viral RNA Mini Kit, Qiagen). If not processed immediately, the RNA was stored at -20°C or -80°C. 236

237

238 Swine Influenza A real-time RT-PCR

For primary SIV detection, the extracted RNA was subjected to real-time RT-PCR targeting the
matrix protein gene of IAV as well as the reference host gene GAPDH (Adiavet SIV Real Time,
Adiagène-BioX Diagnostics, Ploufragan, France). Samples were tested in duplicate, using 20µl
master mix and 5µl RNA. Extracted RNA from SIV positive field samples served as positive
control, nuclease-free water and an extraction control without sample RNA served as negative
control. RT-PCR was performed on a 7900HT Fast (Life Technologies) or a QuantStudio 7 Flex

Real-Time PCR System (Applied Biosystems) using the following cycle protocol: 10 min at 245 246 45°C, 10 min at 95°C, 40 cycles of 15 sec at 95°C and 1 min at 60°C. Samples were considered SIV positive, if they yielded a Ct value ≤ 40 and if an increase in fluorescence signal was 247 observed in the amplification and multicomponent plot. 248 249 250 Influenza A(H1N1)pdm09 real-time RT-PCR All SIV positive samples were tested in duplicate for the pandemic H1N1 strain from 2009 by a 251 specific real-time RT-PCR. The RT-PCR mix consisted of 12.5µl 2x QuantiTect Probe RT-PCR 252 Master Mix (QuantiTect Probe RT-PCR Kit, Qiagen), 1µg bovine serum albumin (1mg/ml; 253 Albumin Bovine Serum Protease Free, VWR, Leuven, Belgium), 400nM of each primer, 200nM 254 255 probe (Schulze et al., 2010), 0.5µl OuantiTect RT Mix and a top-up of 3.5µl nuclease-free water

256 (Supplementary Table 1). Twenty microliters of the PCR mix were distributed onto a 96-well

257 plate and supplemented with 5µl RNA. Positive and negative controls were included, and RT-

258 PCR was performed and interpreted as described above, using the following cycling protocol: 30

259 min at 50°C, 15 min at 95°C, 40 cycles of 15 sec at 95°C and 30 sec at 60° C.

260

261 H1N1 and H3N2 subtyping RT-PCRs and Sanger sequencing

For subtyping, SIV positive samples were subjected to conventional RT-PCR. First, specific

primers for H1 and N1 were used (H1N1 is the only SIV subtype detected in Switzerland so far).

All samples that tested negative against H1 or N1 were subsequently tested for H3 and/or N2.

265 The 25µl RT-PCR mix consisted of 5µl 5x Qiagen OneStep RT-PCR buffer (Qiagen OneStep

- 266 RT-PCR Kit, Qiagen), 400nM of each dNTP (dNTP Mix, 10mM each, Qiagen), 1µl Qiagen
- 267 OneStep RT-PCR Enzyme Mix, 600nM of each primer (Chiapponi et al., 2003), 10µl nuclease-
- 268 free water and 5µl RNA (Supplementary Table 1). All samples, including positive, negative and
- 269 extraction controls were tested in duplicate on a FlexCycler2 (Analytik Jena, Jena, Germany).

270	The cycling protocol included an initial step of 30 min at 48°C, followed by 10 min at 95°C and
271	40 cycles of 1 min at 95°C, 1 min at 50°C and 1 min at 72°C, and a final elongation for 7 min at
272	72°C. PCR products were analyzed in a 1.5% or 2% agarose gel containing GelRed Nucleic Acid
273	Stain (10'000X, Biotium, Hayward, CA, U.S.). Bands of the expected size were excised, and
274	DNA extracted using the QIAquick Gel Extraction Kit (Qiagen). For Sanger sequencing
275	(Microsynth, Balgach, Switzerland), the total DNA concentration was measured by
276	spectrophotometry (Nanodrop, Thermo Fisher Scientific, Kloten, Switzerland), and
277	approximately 45ng DNA were mixed with $20\mu M$ of the respective primer forward and reverse
278	and topped-up with nuclease-free water to a final volume of 15µl. Sequences were analyzed with
279	NCBI nucleotide BLAST (https://blast.ncbi.nlm.nih.gov; Altschul et al., 1990)
280	
281	Sequence analysis and generation of phylogenetic trees
282	Trimming of the ends resulted in HA and NA sequences of up to 392 and 457 nucleotides,
283	respectively. Sanger sequencing traces were processed using <i>Tracy</i> (v0.7.6, Rausch et al., 2020)
284	with default parameters. For samples with a single trace, the basecall module was used, whereas
285	for samples with multiple traces and/or replicates, the assemble subcommand was applied.
286	Subsequently, sequences for each segment were aligned using MAFFT (v7.310, Katoh et al.,
287	2002) with the optionsreorderadjustdirectionaccuratelyop 5. The resulting alignments
288	were manually curated and trimmed. The phylogenetic relationships of the sequences were
289	inferred using the maximum-likelihood nearest-neighbor interchange algorithm implemented in
290	FastTree2 (v2.1.10, Price et al., 2010). The trees were rerooted using the root command from the
291	ape package (v5.8, Paradis et al., 2004) with AB628080/JX138509 and AB628082 used as roots
292	for the HA and NA trees, respectively. Graphical representation of the trees was generated using
293	ggtree (v3.12.0, Yu et al., 2017) and ggnewscale (v0.5.0 Campitelli, 2020).
294	Classification of HA sequences was performed using the online tool Subspecies Classification
295	(with Swine Influenza H1 global classification,

- https://www.bv-brc.org/app/SubspeciesClassification, accessed August 4, 2024). To address
- 297 limitations in NA segment classification, an in-house system was developed. Briefly, the
- aforementioned trimmed alignments were used to calculate a phylogenetic distance matrix using
- FAMSA (v2.2.2, Deorowicz et al., 2016) with the settings -square_matrix -dist_export. The
- 300 dimensionality of the resulting distance matrix was reduced using the classical multidimensional
- scaling (MDS) method, implemented via the cmdscale function in R (v4.4.0, R Core Team,
- 2013). The visible segregation of sequences was ultimately used as an approximation for NA
- 303 segment classification. All utilized scripts are available at
- 304 https://github.com/mwylerCH/SwissSIV.
- 305 All assembled Sanger sequences were deposited on GenBank under the accession numbers
- 306 PQ663270 PQ663585 (Supplementary Table 2).
- 307

Testing of human samples

- Prior to nucleic acid extraction, 200 400µl of nasopharyngeal swab supernatant were spiked
- 310 with 20µl of cell culture supernatant of canine distemper virus (Onderstepoort vaccine strain),
- 311 which served as extraction control and to assess the presence of PCR inhibitors in the samples.
- Viral RNA was then extracted using Nuclisens easyMAG (2010 2017) and EMAG (since
- 2018) magnetic bead systems (BioMérieux, Italy) according to the manufacturer's instructions.
- RNA was recovered in $25 50\mu$ l of NucliSens easyMAG Buffer 3. If not processed
- immediately, the RNA was stored at -80° C.

317 Influenza A and B duplex real-time RT-PCR

- 318 For primary Influenza A (IAV) and B (IBV) detection, the extracted RNA was subjected to
- duplex real-time RT-PCR targeting the matrix protein of IAV and the non-structural protein of
- 320 IBV viruses. Extracted RNA from IAV and IBV reference strains served as extraction and

321	positive controls, and nuclease-free water (Promega, Wisconsin, U.S.) as negative control. The
322	real-time RT-PCR mix consisted of 12.5µl of 2X Reaction Mix with ROX as passive reference
323	(Invitrogen, California, U.S.), 0.5µl SuperScript III/Platinum Taq Mix (Invitrogen), 600nM of
324	each primer, 200nM of each probe (adapted from CDC Realtime RTPCR (rRTPCR) Protocol for
325	Detection and Characterization of Influenza (version 2007)), 4µl of nuclease-free water
326	(Promega) and 5µl RNA (Supplementary Table 1). Real-time RT-PCR was performed on
327	StepOnePlus and QuantStudio 5 Real-Time PCR Systems (Applied Biosystems) using the
328	following cycling protocol: 30 min at 50°C, 2 min at 95°C, 45 cycles of 15 sec at 95°C, and 30
329	sec at 55°C. Samples were considered positive if they yielded a Ct value ≤ 40 and if in the
330	amplification and multicomponent plots an increase in fluorescent signal was be observed.
331	
222	Influenze A subturing and influenze P lineage assessment real time PT PCPs
332	Influenza A subtyping and influenza B fineage assessment fear-time KT-PCKs
333	Currently circulating human seasonal Influenza A subtypes are A(H1N1)pdm09 and A(H3N2).
334	In parallel to IAV and IBV screening, all samples were subtyped using either H1pdm09 and H3
335	specific single plex real-time RT-PCRs ($2010 - 2017$) or a quadruplex real-time RT-PCR
336	targeting H1pdm09 and H3, as well as N1 and N2 genes (since 2018). Lineage (Yamagata and
337	Victoria) was assessed for IBV positive samples (Fig. 3). Extracted RNA from Influenza
338	A(H3N2), A(H1N1)pdm09, Influenza B Yamagata and Victoria reference strains served as
339	positive controls, and nuclease-free water as negative control. The real-time RT-PCR mix
340	consisted of 12.5µl of 2X Reaction Mix with ROX (Invitrogen), 0.5µl SuperScript III/Platinum
341	Taq Mix (Invitrogen), 300 – 1200nM of target specific primers, 200 – 400nM of target specific
342	probe (adapted from CDC Realtime RTPCR (rRTPCR) Protocol for Detection and
343	Characterization of Influenza (Version 2007), Henritzi et al. (2016), Schweiger et al. (2000) and
344	Watzinger et al. (2004)), 1µl of nuclease-free water, and 5µl RNA (Supplementary Table 1).
345	Real-time RT-PCRs were performed as described above.

346	Suspected cases of SIV, i.e. IAV real-time RT-PCR positive or equivocal (after retesting), and
347	H1N1 and H3N2 real-time RT-PCR negative samples were subjected to sequencing.
348	

349 RT-PCR and Sanger sequencing of samples suspected to be positive for zoonotic Influenza A Zoonotic origin of the virus was considered probable when a positive IAV real-time RT-PCR 350 (pan A) and negative H1N1pdm09 and H3N2 subtyping real-time RT-PCRs were observed. In 351 352 these cases, a conventional RT-PCR using universal IAV primers was performed, and positive samples were subjected to Sanger sequencing. In case of low yield for the universal RT-PCR, a 353 sequential PCR using segment-specific IAV primers was attempted. The porcine origin was 354 355 confirmed if by Sanger sequencing a partial or full sequence of at least one viral segment of SIV was obtained. 356 In detail, the extracted RNA (12.5 µl) was reverse transcribed into cDNA. The reaction mix 357 consisted of 10µl of 5X First-Strand Buffer (Invitrogen), 200U of SuperScript II Reverse 358 359 Transcriptase (200U/µl; Invitrogen), 40U of Protector RNase inhibitor (40U/µl; Roche 360 Diagnostics, Mannheim, Germany), 10mM dithiothreitol (0.1M; Invitrogen), 13.5µl nucleasefree water (Promega), 1.5mM dNTP (15mM; Amersham, Buckinghamshire, U.K.), and 1µg IAV 361 universal primer (5' – AGC AAA AGC AGG – 3'; 0.5µg/µl) (Hoffmann et al., 2001). Reverse 362 363 transcription was performed at 42°C for 60 min, followed by 10 min at 95°C. The cDNA tubes were placed on ice and were either immediately processed for PCR or stored at -20° C. 364 The cDNA was used as template for amplification of the eight influenza virus genome segments 365 using segment-specific primers (Supplementary Table 1) (Hoffmann et al., 2001). The PCR mix 366 consisted of 5µl cDNA, 5µl 10X GeneAmp PCR buffer II (Applied Biosystems), 250nM of 367 368 forward and reverse primers, 0.2mM dNTP (2.5mM; Amersham), 1% glycerol (Sigma-Aldrich, Steinheim, Germany), 1.5mM of GeneAmp MgCl₂ (25mM; Applied Biosystems), 1.25ul 369 AmpliTaq DNA Polymerase (5U/µl; Invitrogen), and 14.75µl nuclease-free water (Promega). 370

The first step of the amplification run consisted of a 4 min period at 94 °C and was followed by 372 35 cycles with the following conditions: 20 sec at 94°C, 30 sec at 58°C, and 7 min at 72°C. The 373 program ended with one last cycle at 72 °C for 7 min.

For H1 and N1 genes, the resulting PCR products were sometimes subjected to additional

- segment-specific PCRs (i.e. nested PCR) to increase amplification yield (Supplementary Table
- 1). PCR mix conditions are comparable to those described above but in presence of 3mM of
- 377 GeneAmp MgCl₂ (25mM; Applied Biosystems). For H1, the amplification consisted of a 4 min

period at 94 °C followed by 40 cycles with the following conditions: 15 sec at 94°C, 30 sec at

 50° C, and 1 min at 72°C. The program ended with one last cycle at 72 °C for 5 min. For N1

gene, it consisted of one first cycle of 4 min at 94 °C, 30 sec at 50°C, and 2 min at 72°C,

followed by 39 cycles of 30 sec at 94°C, 30 sec at 50°C, and 2 min at 72°C, followed by one

cycle of 30 sec at 94°C, 30 sec at 50°C, and a final elongation for 10 min at 72°C.

383 Amplicons were purified using a MSB Spin PCRapace kit according to the manufacturer's

instructions (Invitek Molecular GmbH, Berlin, Germany) and sequenced using strain-specific

primers. Sanger sequencing was performed on an ABI 3500xL Genetic Analyzer (Applied

386 Biosystems, Singapore). Sequences were processed and stored in SmartGene's Integrated

387 Database Network System (IDNS) Influenza Module (https://apps.idns-

388 smartgene.com/apps/Apps.po) and submitted to the global initiative on sharing all influenza data

389 (GISAID) database (Shu and McCauley, 2017).

391 **Results**

392

393 Porcine samples

- From 2010 to 2022, a total of 2303 cases of pigs with influenza-like signs were reported from
- approximately 1400 farms in Switzerland (Fig. 4). Over the years, the number of reports of farms
- with pigs showing influenza-like signs has continuously decreased from 320 in 2010 to 105 in
- 397 2022 (Fig. 5) (FSVO, 2023). The number of reports was evenly distributed over the entire area
- with pig husbandry (Fig. 4) and on average was highest in the last quarter of the year (Fig. 6).

The proportion of farms sampled after reporting of influenza-like signs ranged from 20 - 47%(Fig. 5). On average 31% of farms were sampled per year. In total, 674 program-related farm visits took place between 2010 and 2022, in which 1660 porcine nasal swab samples were

407 collected. In the laboratory, 145 pooled nasal swabs and 1515 unpooled nasal swabs were 408 analyzed. In addition, in 107 cases lung material was analyzed. The percentage of farm visits 409 (total n = 674) with positive IAV testing ranged between 32% and 70% (Fig. 5) and was highest 410 in the last quarter of the year (Fig. 6). IAV was detected in a total of 375 (= 56%) farm visits. 411 The IAV detection rate was 44.94% (n = 746) in the nasal swab samples and 25.23% (n = 27) in 412 the lung samples.

According to subtyping RT-PCR, none of the SIV positive samples could be assigned to H3N2 424 425 or H1N2 strains. Influenza A(H1N1)pdm09 was detected by specific real-time RT-PCR in four nasal swab samples in 2011 and three nasal swab samples in 2013. For one of these samples 426 427 (SIV 75 13 H1) a Sanger sequence was obtained, confirming its type (Fig. 7). In the 375 IAV positive farm visits, the H1N1 subtype was detected on 196 occasions by subtyping RT-PCR and 428 Sanger sequencing. In approximately 40 farm visits only H1, in approximately 80 farm visits 429 430 only N1 and in approximately 60 farm visits no subtype was identified. A total of 309 influenza sequences from PCR-amplified regions from pigs and humans were 431 432 obtained after Sanger sequencing: 125 sequences from the HA segment and 184 from the NA segment. The HA sequences could be assigned to clades C.2.1 and C.2.2. The only exception is 433 the one sample (SIV 75 13 H1) from 2013 mentioned above, which belongs to HA clade 434 A.3.3.2 (Fig.7 and 9). Although clades C.2.1 and C.2.2 are also present in various European 435 countries, the Swiss samples form distinct clusters that differ from strains in neighboring 436

countries. This distinction is observed in both the HA segment (Fig. 7) and the NA segment (Fig. 437

438 8).

Given the long-term nature of the national surveillance program, the temporal dynamics of the 451 452 prevalence of SIV genotypes can be assessed (Fig. 9). The beginning of the program was characterized by the predominance of C.2.1 genotypes. Starting from 2015, the occurrence of 453 this clade narrows, and the clade is superseded by clade C.2.2, however, without fully 454 disappearing. By sequencing both HA and NA segments, potential reassortments could be 455 investigated. Sequences for both segments were available for 78 samples (75 porcine samples, 3 456 human samples). Since canonical SIV subtyping into clades is typically performed on the HA 457 gene sequence only, a custom method was developed to categorize the circulating NA genotypes 458 in Switzerland. Similar to previous observations in the HA segment, the Swiss NA sequences 459 460 also form two distinct clusters, here referred to as subclade 1 and subclade 2 (Fig. 8, 461 Supplementary Fig. 1). Interestingly, NA subclade 1 tends to be combined with HA clade C.2.1, while subclade 2 is typically associated with C.2.2. However, six possible reassortments were 462 identified (Fig. 9), in which a clade C.2.1 HA was combined with a subclade 2 NA and a clade 463 C.2.2 HA with a subclade 1 NA. 464

470 Human samples

- 471 Between 2010 and 2022, in association with project-related farm visits (n = 674), a total of 150
- 472 humans on 118 farms reported influenza-like symptoms within ten days prior to the visit (Fig.
- 473 10) (FSVO, 2023). In 64 cases the onset of clinical symptoms was reported 1 3 days, in 86
- 474 cases 4 10 days before the farm visit. On average, 33% of humans with reported influenza-like
- symptoms were sampled per year. Over the years, the number of in-contact humans reporting
- symptoms has decreased from 22 in 2010 to 9 in 2022. In 455 project-related farm visits there
- 477 were no reports of humans showing influenza-like symptoms in the 10 days prior to the farm
- 478 visit, and in 103 visits, no information concerning illness in humans was available (FSVO,
- 479 2023).
- 480 Sixty-one individuals sent a self-collected nasal or nasopharyngeal swab to the NRCI (Fig. 10).
- 481 Of these, 29 persons reported symptom onset 1 3 days, 10 persons 4 10 days, and six persons
- 482 more than 10 days prior to the farm visit. In 16 cases no information on symptom onset was
- 483 available. The most common symptoms reported were cough (60.6%), headache (36.1%),
- 484 myalgia (27.9%), body temperature $> 38^{\circ}$ C, and rhinitis (18%).

501 **Discussion**

- 502 In the course of the Swiss national SIV monitoring program, reports of influenza-like signs in
- 503 pigs and the detection of SIV in the respective farms occurred throughout the year, tending to be
- somewhat more frequent in the cold months. Nevertheless, as reported elsewhere, no seasonality
- of SIV can be inferred from these data (Fig. 6) (Anderson et al., 2021; Pippig et al., 2016;
- 506 Vincent et al., 2020).
- 507 To date, three main subtypes (H1N1, H1N2, H3N2) including three major H1 lineages of SIV
- 508 circulate in pigs in Europe which are distinct from their counterparts in North America and Asia
- 509 (Anderson et al., 2016; Anderson et al., 2021; Bourret, 2018; Chiapponi et al., 2021; de Jong et
- al., 2007; Kessler et al., 2021; Kuntz-Simon and Madec, 2009; Lewis et al., 2016; Pippig et al.,
- 511 2016; Vincent et al., 2020):
- The Eurasian avian lineage (H1avN1, clade HA-1C), which was transmitted from wild ducks
 to pigs and appeared in 1979
- The human-like H3N2 lineage, originating from the reassortment of human-like swine H3N2
 and a H1avN1 in 1984
- 516 The human seasonal lineage (H1huN2, clade HA-1B), which appeared in 1994 after
- reassortment of a human-like H3N2 and a seasonal human H1N1
- 518 The classical swine lineage (H1N1pdm09, clade HA-1A), which circulates in the swine
- population since 2009, and is hypothesized to have arisen upon reassortment of H1avN1 and
- 520 the North American triple reassortant H3N2
- 521 On farm level, H1avN1 is the dominant subtype in Europe, followed by other reassortant strains
- of H1N1 (including H1N1pdm09) and H1N2 subtypes, and H3N2 strains (Chiapponi et al.,
- 523 2021).
- 524 In the present study, according to subtyping PCR none of the SIV positive samples could be
- assigned to H3N2 or H1N2 strains, making H1N1 the only subtype detected so far in the Swiss

pig population (FSVO, 2023). In a small number of SIV positive samples, we found evidence for 526 527 reverse zoonosis in the Swiss pig population: Influenza A(H1N1)pdm09 (HA-1A) was detected in a total of seven pig samples by specific real-time RT-PCR, i.e. four in 2011 and three in 2013. 528 This virus emerged as a result of viral reassortment between two influenza lineages that had been 529 circulating in pigs for years, i.e. a triple-reassortant circulating in North America and the 530 Eurasian avian-like lineage (Smith et al., 2009). It was first detected in humans at the North 531 American-Mexican border in March and April 2009 and, having acquired the ability for efficient 532 human-to-human transmission, was declared a pandemic by the World Health Organization 533 (WHO) by June 2009. By July the virus was reported from 122 countries (Kessler et al., 2021; 534 535 Saunders-Hastings and Krewski, 2016) including Switzerland, where the first human case was 536 detected in April 2009. It rapidly became the predominant IAV variant circulating in humans, with death rates fortunately remaining low (Thomas and Kaiser, 2010). From humans, the virus 537 made its way back into pigs via reverse zoonosis (Rajao et al., 2019; Saunders-Hastings and 538 Krewski, 2016), which is also the presumed route of transmission in the here described seven 539 Swiss pig cases. Whereas formerly circulating human H1N1 strains were completely replaced by 540 the pandemic variant, co-circulation of the pandemic strain with endemic viruses was observed 541 542 in the pig population. However, at farm level H1avN1 (clade HA-1C) remained the predominant 543 subtype in European pigs (Chiapponi et al., 2021; Pippig et al., 2016; Thomas and Kaiser, 2010; Zell et al., 2020). 544

With the exception of the seven A(H1N1)pdm09 (HA-1A) positive samples as per specific realtime RT-PCR, all HA and NA RNA segments sequenced in the present study could be assigned
to the Eurasian avian lineage (HA-1C), which is widespread in pigs in Europe (Anderson et al.,
2016). According to H1 and N1 sequence alignments, the Swiss H1N1 strains cluster into two
HA clades, i.e. C.2.1 and C.2.2. Since 2015, the HA typing has shown a gradual shift from clade

550 C.2.1 to C.2.2 (Fig. 9). However, C.2.1 sequences are still detected. Despite their evolutive

551 capacities, phylogenetic analyses indicate that compared to other countries there is little genetic

30

diversity and that the genome composition of influenza viruses in Swiss pigs remained fairly 552 553 stable over the years (Fig. 7-9). Only six reassortments between H1 clades and N1 subclades were identified (Fig. 9). The absence of H1N2 and H3N2 subtypes, which are circulating in the 554 rest of Europe, and the comparatively low diversity of H1N1 strains can be at least partly 555 attributed to the Swiss pig production system, which is inherently isolated, influenced by low 556 557 animal import levels and subject to strict biosecurity measures (Chiapponi et al., 2021; Lewis et al., 2016). Similar specific genetic clusters were observed for other viruses in Swiss pigs such as 558 hepatitis E virus (Vonlanthen-Specker et al., 2021) and atypical porcine pestivirus (Kaufmann et 559 al., 2019). 560

561 We also found evidence for spillover of influenza virus from pigs to humans: among the 11 562 influenza virus positive swabs of in-contact humans, six tested positive for human strains and five (= 45%) tested positive for SIV (Tab. 1 and 2). Sequence analyses assigned the SIVs to the 563 Eurasian avian lineage of H1N1 and to the HA clade which at that time was most frequently 564 detected in the pigs, i.e. C.2.1 and C.2.2 (Fig. 7 and 9). Given that the five individuals also had 565 symptoms typical for influenza (Tab. 2), it is highly likely that pigs were the source of infection. 566 Antibody testing of convalescent sera would have permitted more conclusive information but 567 was not performed. Since the first well-documented reports in 1958 and 1974, human infections 568 with SIVs (both H1N1 and H3N2) have continued to be reported sporadically worldwide. 569 570 Usually, these infections caused only mild disease resembling human seasonal influenza (Anderson et al., 2021; Freidl et al., 2014; Gregory et al., 2003; Kuntz-Simon and Madec, 2009; 571 572 Rambo-Martin et al., 2020). Sustained human-to-human transmission rarely followed and has not been observed in the present study either. Compared to the number of people directly or 573 574 indirectly involved in pig production, the number of SIV infections detected in humans is low. Yet, considering that in the frame of the Swiss national SIV program 45% of influenza positive 575 human cases tested positive for SIV and that SIV infections are indistinguishable from seasonal 576 577 human influenza, a high number of undetected cases must be expected. This hypothesis is

supported by seroepidemiological studies in which higher seroprevalences of SIV were found in
pig farmers and butchers than in people without occupational contacts to pigs (Borkenhagen et
al., 2020; Krumbholz et al, 2014; Sun et al., 2020).

It is undisputed that national and international monitoring programs in animals and humans with 581 internationally coordinated early warning systems constitute an important pillar in the 582 surveillance of influenza viruses worldwide. However, after more than 15 years since its launch, 583 the Swiss national monitoring program for SIV has brought to light various difficulties and 584 hurdles that need to be addressed in the future: (1) The number of farms reporting pigs with 585 influenza-like signs has continuously decreased from 320 in 2010 to 105 in 2022 (Fig. 5) FSVO, 586 587 2023). Likewise, the number of in-contact humans reporting influenza-like symptoms has 588 decreased from 22 to 9 over the same period (Fig. 10). In 103 cases, no information concerning illness in humans was available. These reduced numbers most likely do not reflect a decrease in 589 590 infections but rather a decline in disease awareness after the 2009 pandemic. In addition, due to the endemic circulation of SIVs and the resulting herd immunity, severe symptoms associated 591 with a high viral load are probably rather rare and mainly seen in co-infections with other 592 pathogens. For the future, all stakeholders including the farmers, veterinarians, meat producers 593 and veterinary authorities should take measures to increase disease awareness. (2) After 594 595 notification of influenza-like symptoms, the rate of farms and individuals sampled remained at a 596 more or less constant low level of approximately 30%. Well-orchestrated reporting, communication and cooperation between stakeholders is required in order to consistently sample 597 598 pigs on reported farms. (3) In the IAV-positive farm visits, the rate of samples in which both HA and NA were successfully subtyped was rather low (196/375 = 52%). In approximately 11% 599 only H1, in 21% only N1 and in 16% of cases no subtype was identified. For a large proportion 600 of IAV positive samples, including human swabs, the Ct value after IAV real-time RT-PCR was 601 rather high, making successful subtyping and sequencing more difficult. High Ct values can 602 603 result from various causes: low viral loads in the sample material, suboptimal sampling, poor

sample quality due to contamination with dirt and bacteria, improper sample handling and/or 604 605 storage, or low-performing assays. In many cases, the clinical signs may only be recognized late, or the nasal swabs may be taken late in the infection cycle, i.e. at a time when maximum virus 606 excretion is already over and virus clearance almost complete. Efficient SIV surveillance 607 programs depend on sensitive and specific diagnostic methods which allow for cost-effective 608 large-scale analysis. To detect circulating strains and new variants, currently several PCR assays 609 are needed, which make the process expensive and time-consuming. Novel methods for high-610 611 throughput whole genome sequencing such as Illumina or Nanopore technologies, which have been extensively developed in recent years and have become more sensitive and affordable, 612 613 could improve the surveillance of SIV and reduce the cost of virus subtyping in the long term 614 (Goecke et al., 2018; Rambo-Martin et al., 2020). From a laboratory perspective, a future main goal of the Swiss national surveillance program is the implementation of a SIV MinION 615 616 Nanopore sequencing protocol (King et al., 2020), that in parallel to the established Illumina whole-genome sequencing protocol (Kubacki et al., 2021) allows for cost-efficient untargeted 617 sequencing of all influenza virus genome segments present in a sample. 618 619
