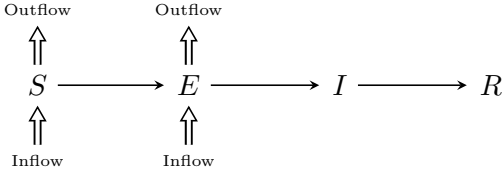
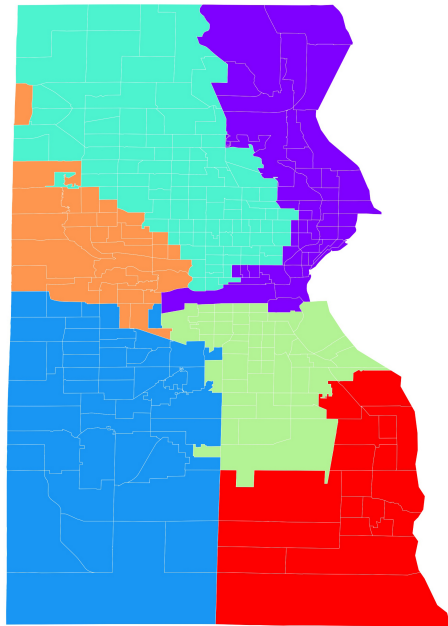
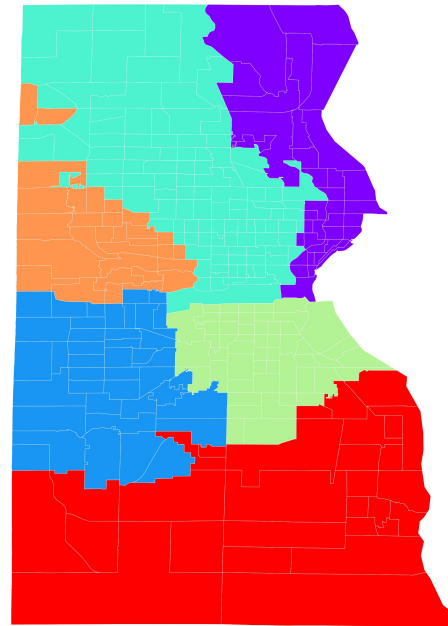


Figure S1: Flowchart of the human mobility flow-augmented stochastic SEIR model.



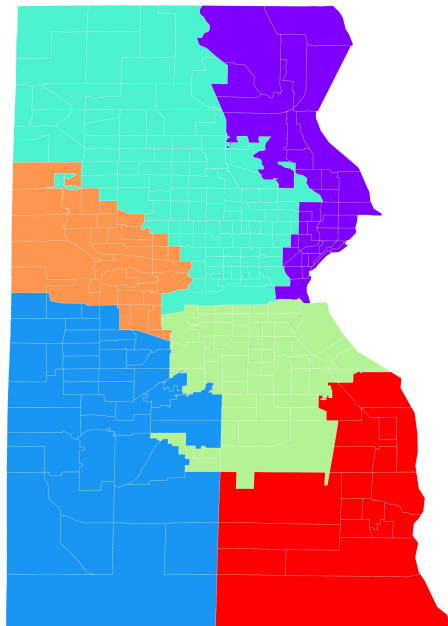

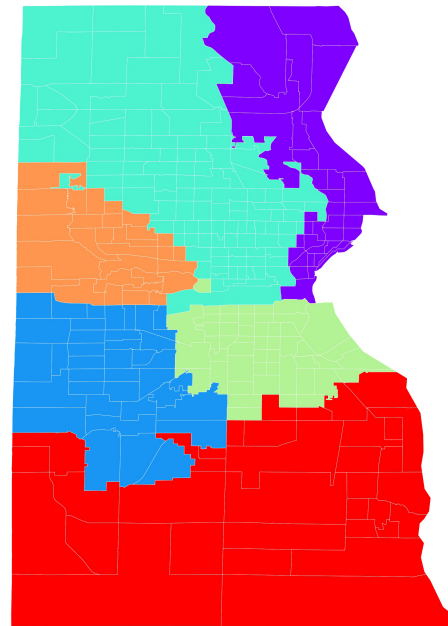

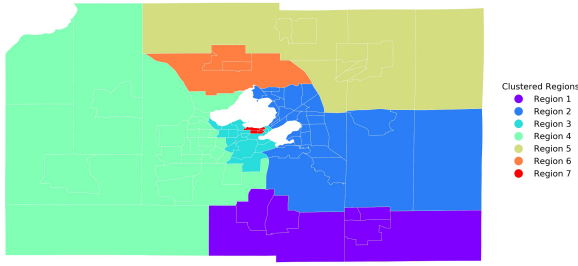

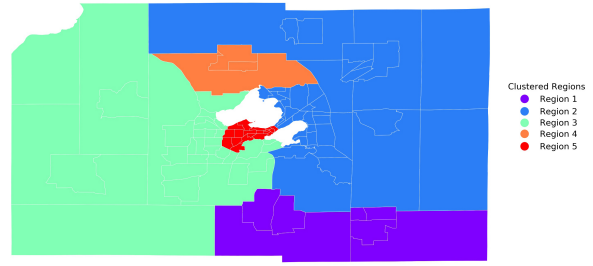

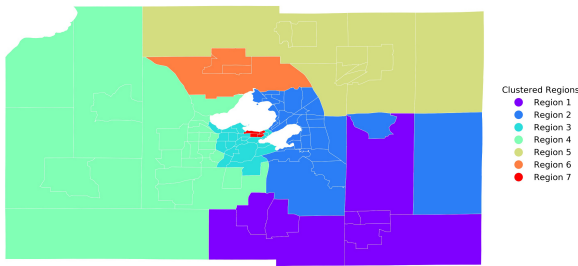
Figure S2: Clustering results of Milwaukee County



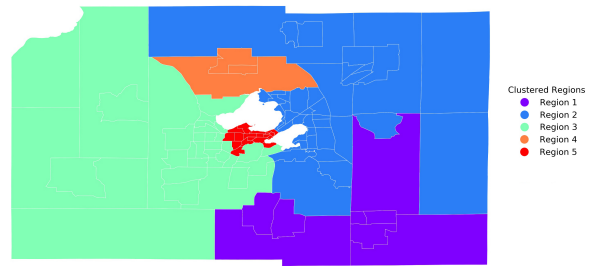

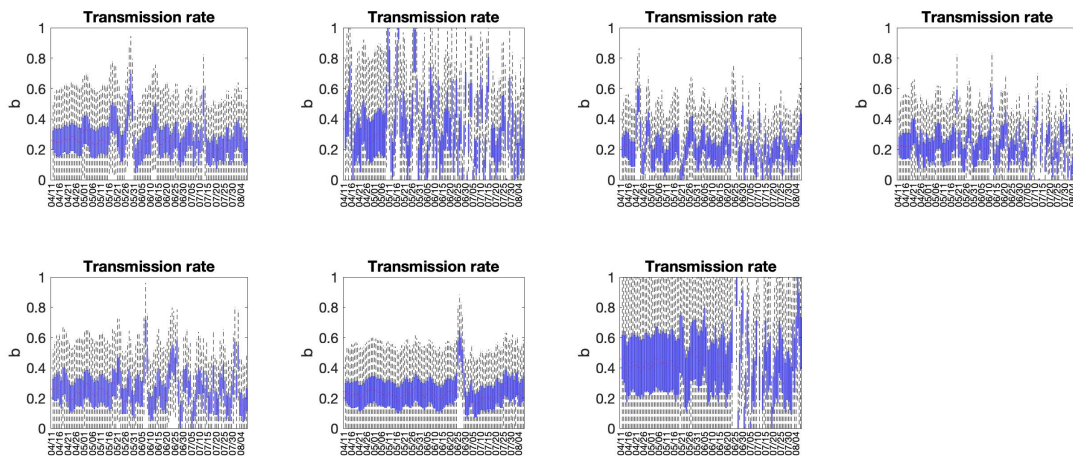


Figure S4: Transmission rate of different regions in Dane County.

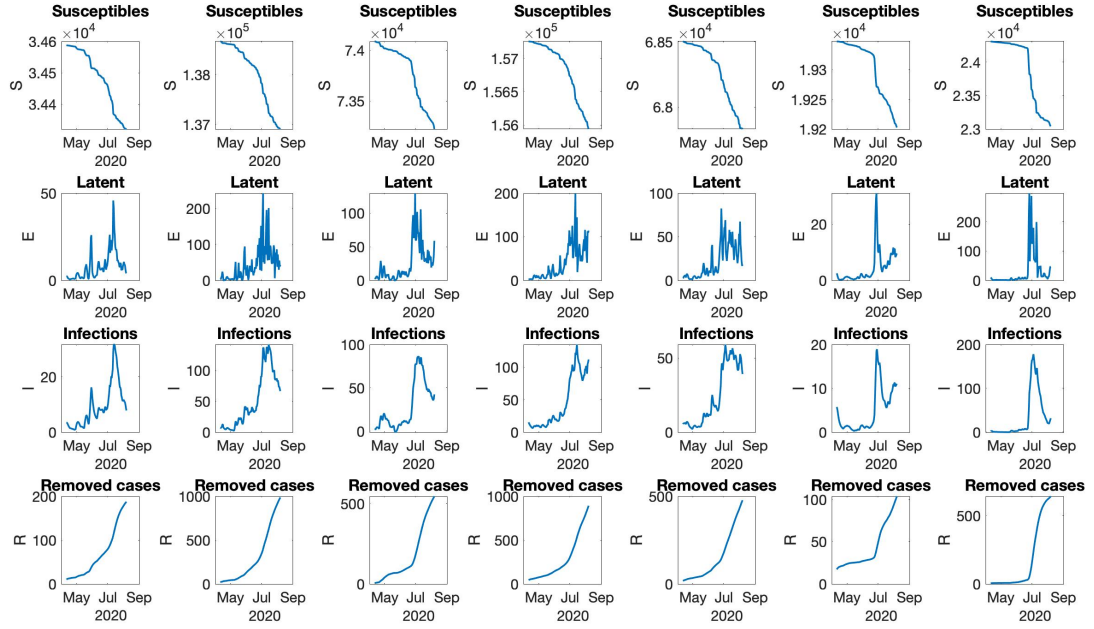

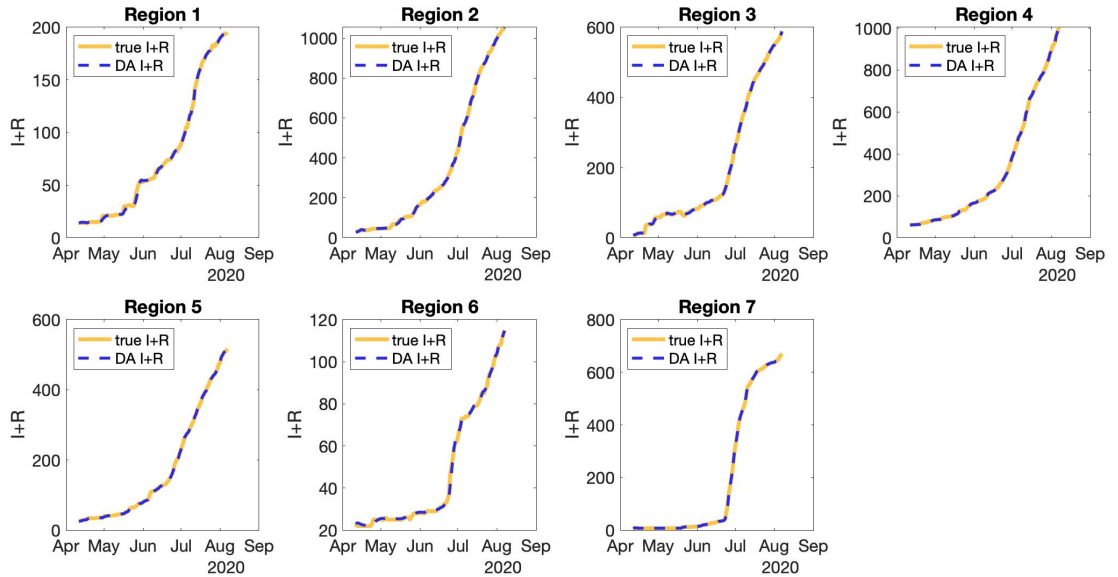


Figure S6: Data assimilation result and true cumulative infection data for Region 1 to Region 7 in Dane County.



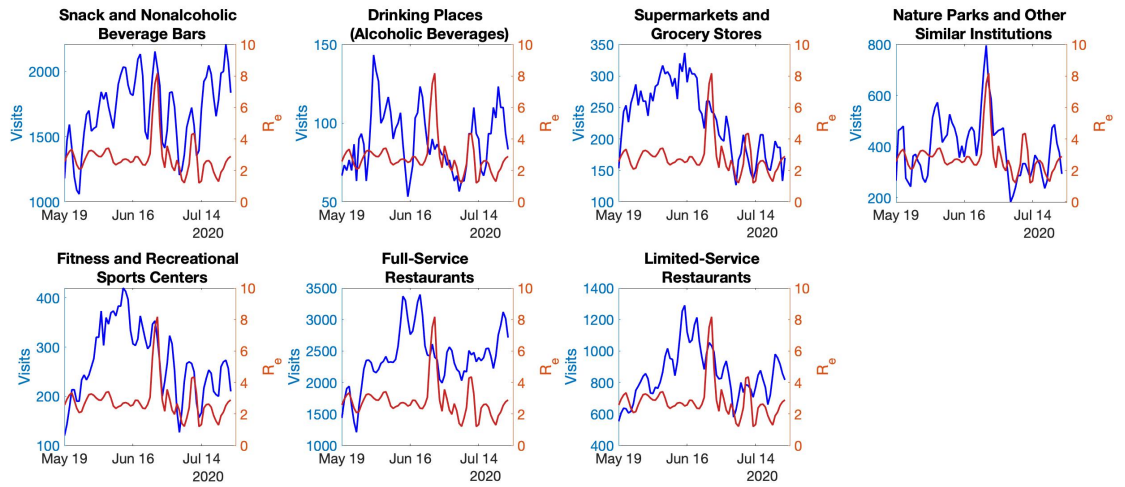

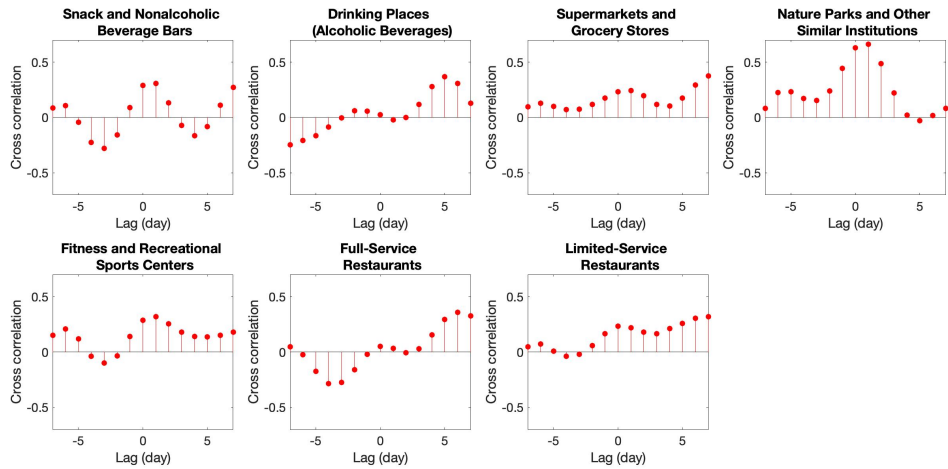

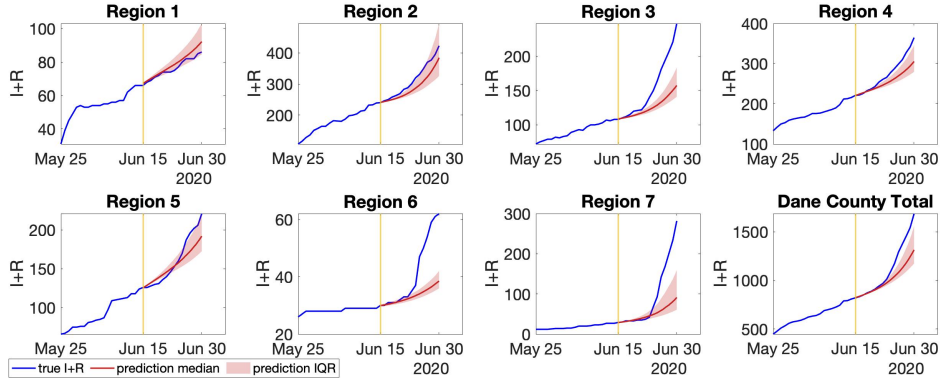


Figure S9: Case 1: prediction of cumulative infections in each region if there was no Phase 2 reopening in Dane County.

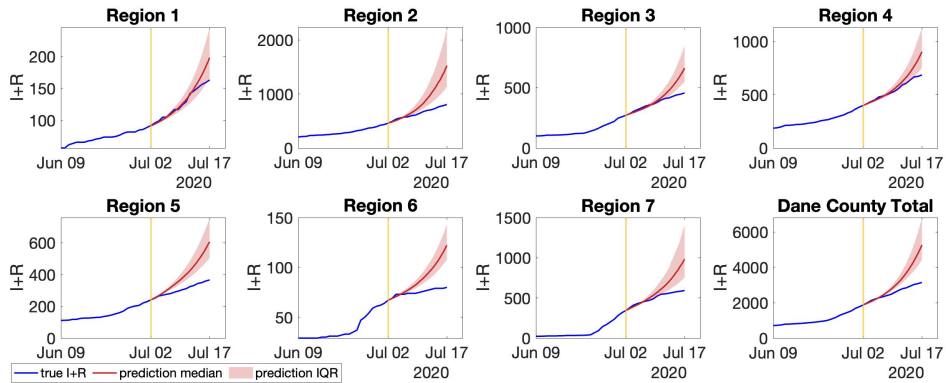
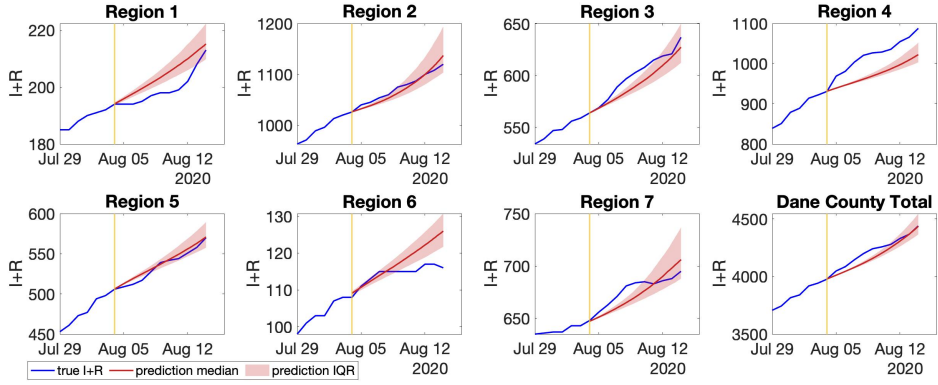
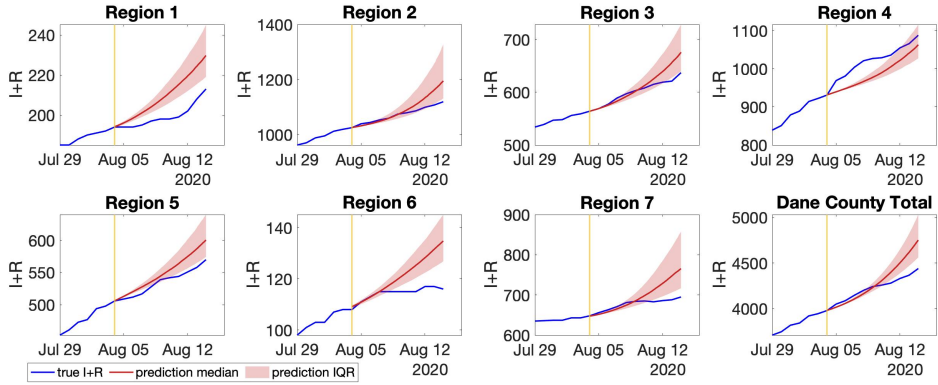


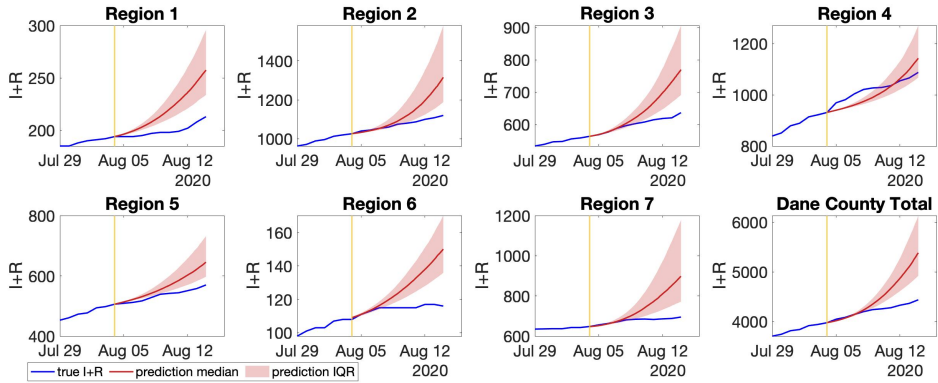
Figure S10: Case 2: prediction of cumulative infections in selected regions if there was no rolling back from Phase 2 reopening in Dane County.

Figure S11: Prediction of cumulative infections if Dane County further reopens.

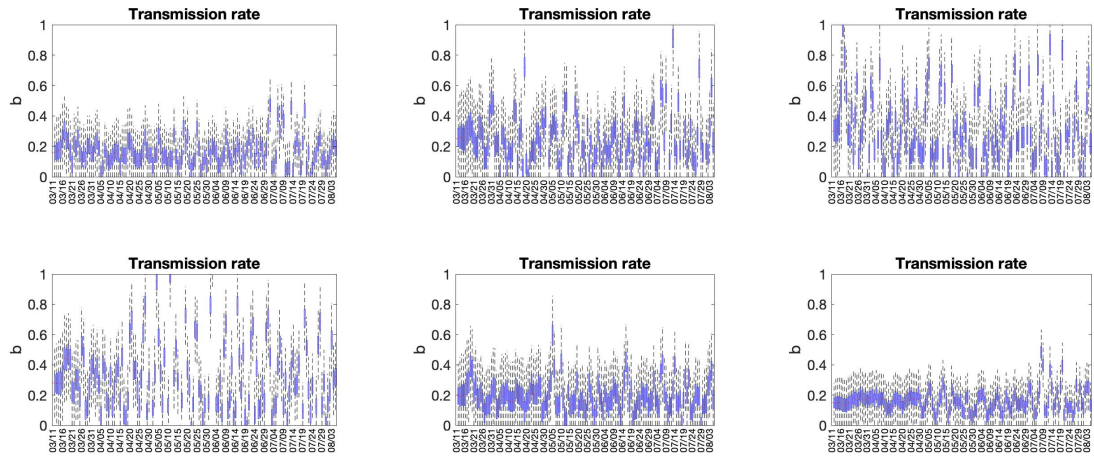


Figure S12: Transmission rate of different regions in Milwaukee County.

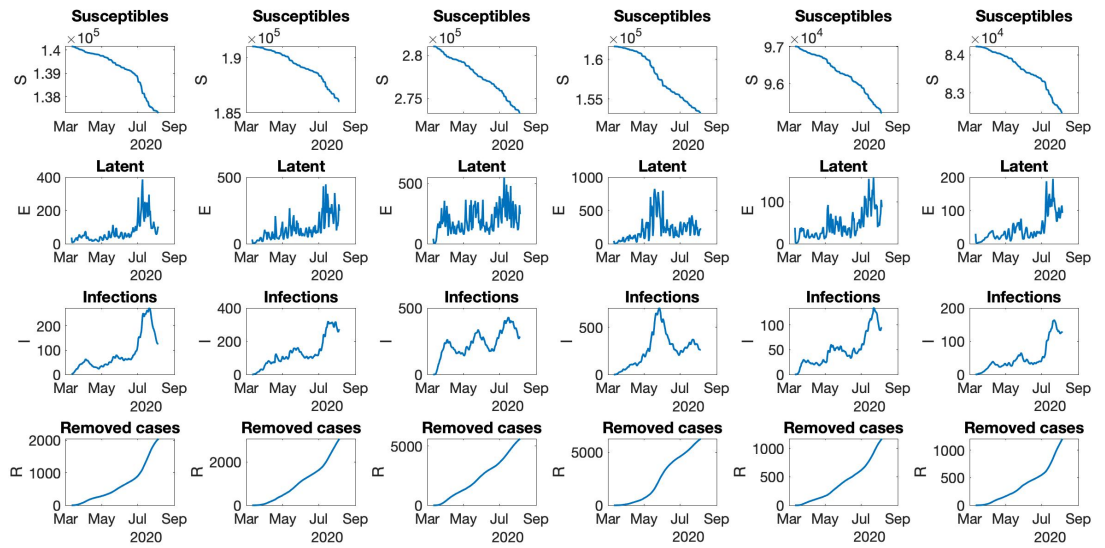

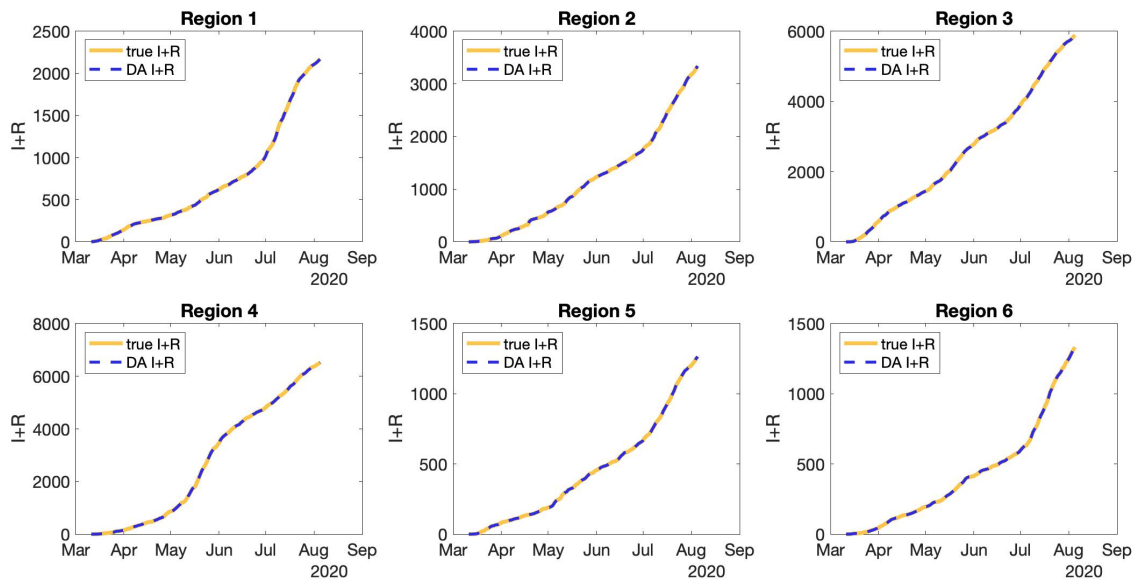


Figure S14: Data assimilation result and true cumulative infection data for Region 1 to Region 6 in Milwaukee County.
