# Mortality among Adults Ages 25-44 in the United States During the COVID-19 Pandemic.

#### Abstract:

Introduction: Coronavirus disease-19 (COVID-19) has caused a marked increase in all-cause deaths in the United States, mostly among adults aged 65 and older. Because younger adults have far lower infection fatality rates, less attention has been focused on the mortality burden of COVID-19 in this demographic.

Methods: We performed an observational cohort study using public data from the National Center for Health Statistics at the United States Centers for Disease Control and Prevention, and CDC Wonder. We analyzed all-cause mortality among adults ages 25-44 during the COVID-19 pandemic in the United States. Further, we compared COVID-19-related deaths in this age group during the pandemic period to all drug overdose deaths and opioid-specific overdose deaths in each of the ten Health and Human Services (HHS) regions during the corresponding period of 2018, the most recent year for which data are available.

Results: As of September 6, 2020, 74,027 all-cause deaths occurred among persons ages 25-44 years during the period from March 1st to July 31st, 2020, 14,155 more than during the same period of 2019, a 23% relative increase (incident rate ratio 1.23; 95% Cl 1.21–1.24), with a peak of 30% occurring in May (IRR 1.30; 95% Cl 1.27-1.33). In HHS Region 2 (New York, New Jersey), HHS Region 6 (Arkansas, Louisiana, New Mexico, Oklahoma, Texas), and HHS Region 9 (Arizona, California, Hawaii, Nevada), COVID-19 deaths exceeded 2018 unintentional opioid overdose deaths during at least one month. Combined, 2,450 COVID-19 deaths were recorded in these three regions during the pandemic period, compared to 2,445 opioid deaths during the same period of 2018.

Meaning: We find that COVID-19 has likely become the leading cause of death—surpassing unintentional overdoses—among young adults aged 25-44 in some areas of the United States during substantial COVID-19 outbreaks.

Note: The data presented here have since been updated. As a result, an additional 1,902 all-cause deaths occurring among US adults ages 25-44 during the period of interest are not accounted for in this manuscript.

Introduction

COVID-19 has caused a marked increase in all-cause deaths in the United States, mostly among adults aged  $\geq 65$ . Because younger adults have far lower case fatality rates, little attention has been focused on the mortality burden of COVID-19 in this demographic.

Accordingly, we sought to identify changes in all-cause mortality (excess deaths) and to determine years of lost life (YLL) among US adults aged 25-44. As the leading cause of death in this demographic prior to COVID-19 was drug overdoses, we compared the monthly incidence rates of COVID-19-specific deaths during the pandemic to unintentional overdose deaths (all drug and opioid-specific) during the corresponding period in 2018 in each of the ten Health and Human Services (HHS) regions.

## Methods

We performed an observational study by assembling the most recent publicly available data for all-cause mortality (2019–2020), unintentional drug overdose deaths (ICD10 X41-X44, Y11-Y15, 2018), unintentional opioid-specific deaths (*ibid* and T40.0-6, 2018), and COVID-19 deaths (ICD10 U071).<sup>3,4</sup> We calculated death incident rates per 100,000 person-month with 95% confidence intervals (SAS 9.4, SAS Institute, Carey, NC).

We computed YLL due to COVID-19 and for all-cause excess mortality occurring from March–July 2020 to assess undetected burdens resulting from COVID-19 undercounting.<sup>5</sup> Excess mortality was defined as deaths in 2020 minus 2019 deaths during the corresponding period. Incident rate ratios were also calculated.

This study was not subject to institutional review approval because it used publicly available data. STROBE reporting guidelines were followed.

## Results

From March–July 2020, 74,027 all-cause deaths occurred among persons ages 25-44 years, 14,155 more than during the same period of 2019, a 23% relative increase (incident rate ratio 1.23; 95% Cl 1.21–1.24), with a peak of 30% occurring in May (IRR 1.30; 95% Cl 1.27-1.33). In HHS Regions 2 (New York, New Jersey), HHS Region 6 (Arkansas, Louisiana, New Mexico, Oklahoma, Texas), and HHS Region 9 (Arizona, California, Hawaii, Nevada), COVID-19 deaths exceeded 2018 unintentional opioid overdose deaths during at least one month (Figure). Combined, 2,450 COVID-19 deaths were recorded in these three regions during the pandemic period, compared to 2,445 opioid deaths during the same period of 2018.

In March-July 2018, opioid overdoses caused 10,347 deaths nationwide, resulting in 472,608 YLL among adults 25-44. During the similar period in 2020, 4,055 recorded COVID-19 deaths in adults 25-44 resulted in 175,631 YLL (Table). Further considering all of the 14,155 excess deaths in 2020, younger adults accounted for 627,872 YLL, exceeding YLL from overdose-related deaths (595,175 YLL) during the corresponding period of 2018 (Table). Among adults 25-44, 28.7% (4,055 of 14,155) of the all-cause excess deaths were attributed to COVID-19.

Discussion

We find that COVID-19 has likely become the leading cause of death—surpassing unintentional

overdoses—among young adults aged 25-44 in some areas of the United States with

substantial COVID-19 outbreaks. In these regions, COVID-19 mortality also resembles that of

the HIV/AIDS epidemic at its apex in the United States (1994-1995).

We also found that a relatively small fraction of the all-cause excess deaths recorded during

the pandemic have been attributed directly to COVID-19. This gap has not yet been explained,

though a combination of inadequate testing and the continuation of pre-existing smaller

increases in all-cause mortality recorded during January-February 2020 may explain a large

fraction of this difference, implying that the mortality of COVID-19 has been substantially

under-detected in the younger adult population.<sup>1</sup>

This study has limitations. The provisional data used represents lower-bound estimates due to

reporting lags. While the magnitude of our findings may increase as COVID-19 spreads among

younger populations, emerging treatments might improve fatality rates.

Together, these data indicate that the mortality of COVID-19 among adults ages 25-44 is

sizeable and should not be discounted by individuals or policymakers.



*Bars*: Unintentional drug overdose deaths (ICD10 X41-X45, Y11-Y15), 2018 (light blue with 95% CI) and opioid-specific drug overdose deaths (ICD10 X41-X45, Y11-Y15 and T40.0-40.6), 2018 (dark blue with 95% CI).

Lines: COVID-19 deaths (ICD10 Uo71), 2020; colors are stratified by regional COVID-19 case incidence per 1,000,000 residents through July 31, 2020 (green <1,050 cases per 100,000 residents; yellow 1,050-1,499 cases per 100,000 residents).

HHS Regions: Region 1: Connecticut, Maine, Massachusetts, New Hampshire, Rhode Island, and Vermont; Region 2: New Jersey and New York; Region 3: Delaware, District of Columbia, Maryland, Pennsylvania, Virginia, and West Virginia; Region 4: Alabama, Florida, Georgia, Kentucky, Mississippi, North Carolina, South Carolina, and Tennessee; Region 5: Illinois, Indiana, Michigan, Minnesota, Ohio, and Wisconsin; Region 6: Arkansas, Louisiana, New Mexico, Oklahoma, and Texas; Region 7: Iowa, Kansas, Missouri, and Nebraska; Region 8: Colorado, Montana, North Dakota, South Dakota, Utah, and Wyoming; Region 9: Arizona, California, Hawaii, and Nevada; Region 10: Alaska, Idaho, Oregon, and Washington.
